[57] CLAIM

The ornamental design for a housing for a desk telephone stand, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design for a housing for a desk telephone stand; FIG. 2 is a top plan view thereof; FIG. 3 is a left elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a front perspective view thereof, presenting substantially an elevation view; and FIG. 6 is a rear elevation view thereof.

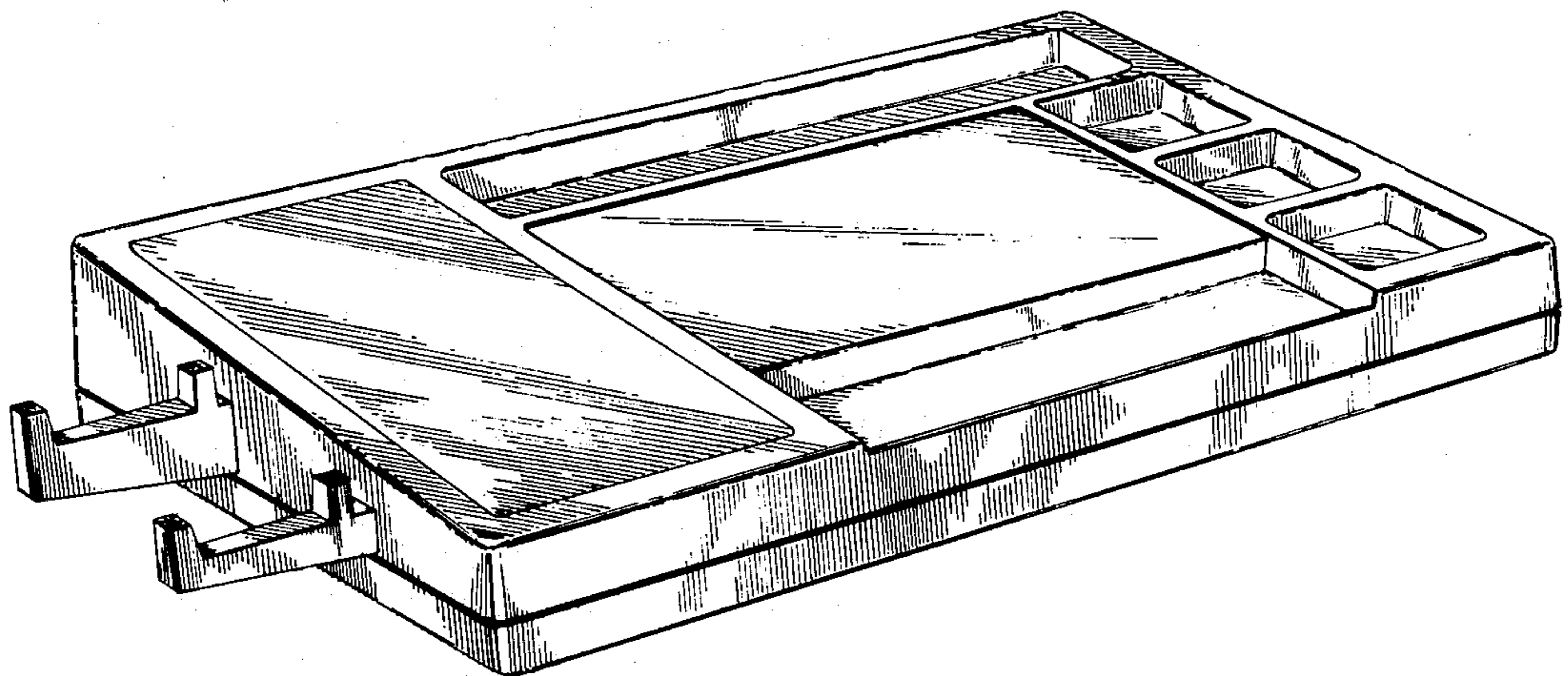

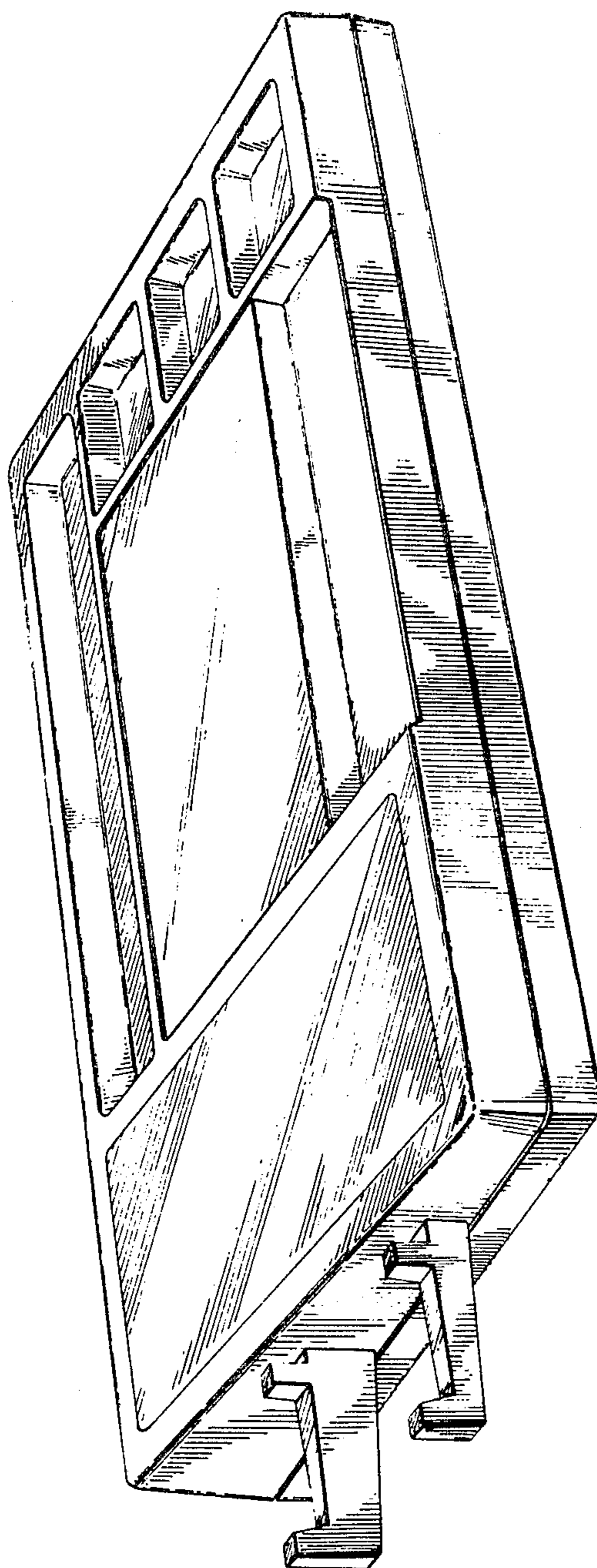

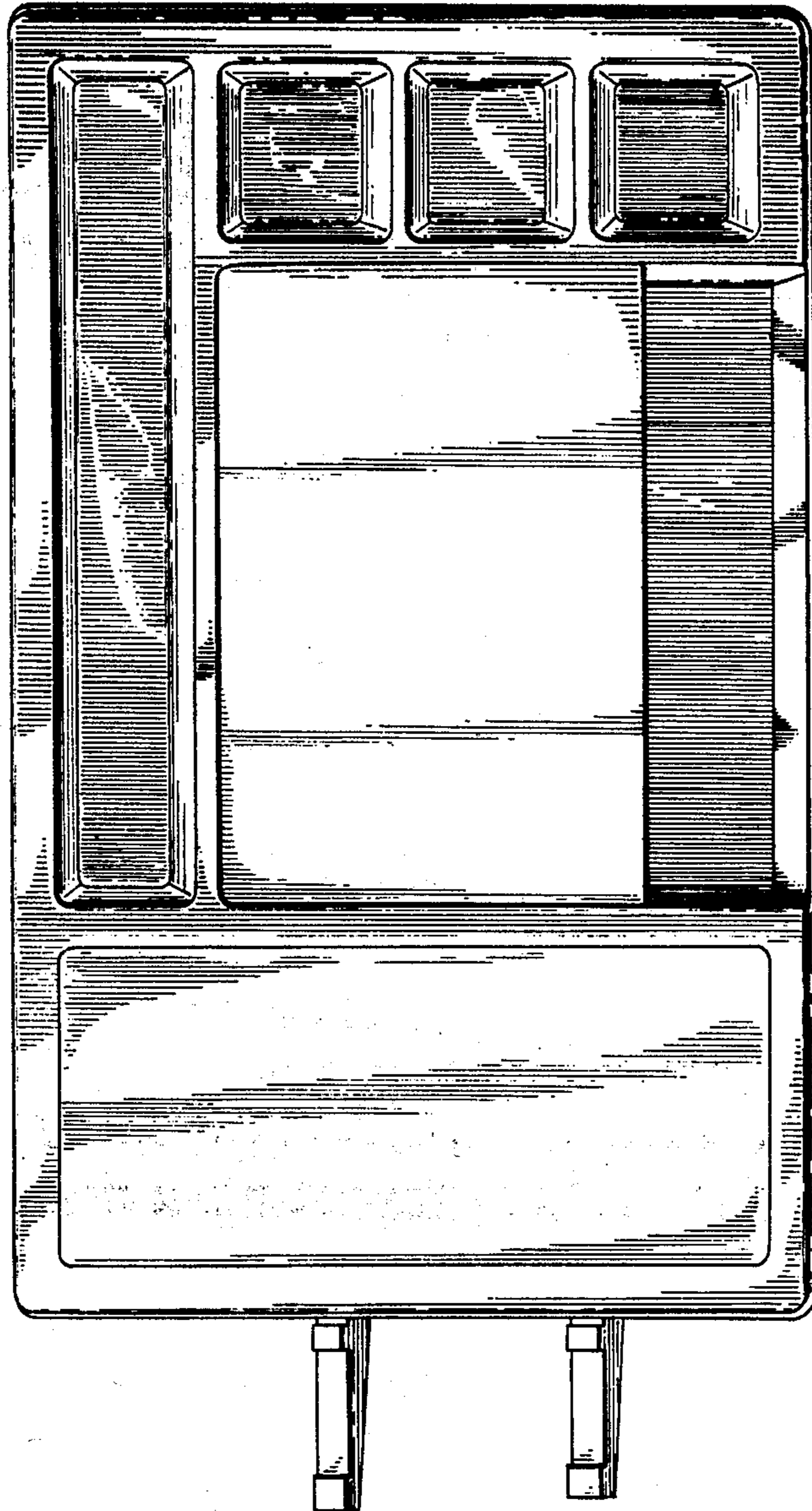

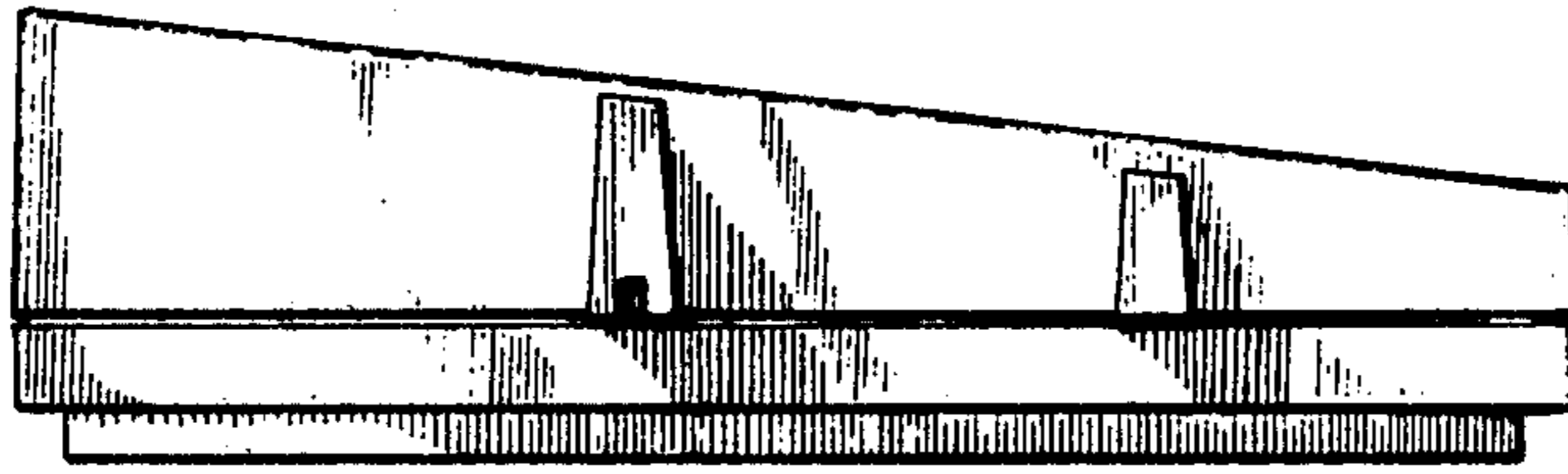

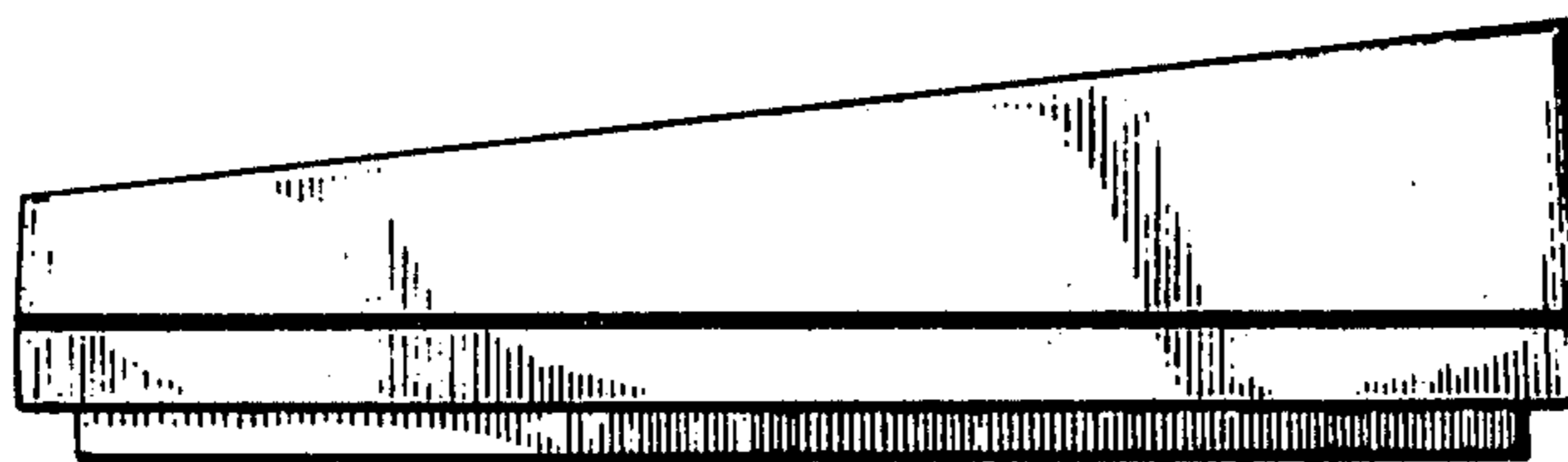

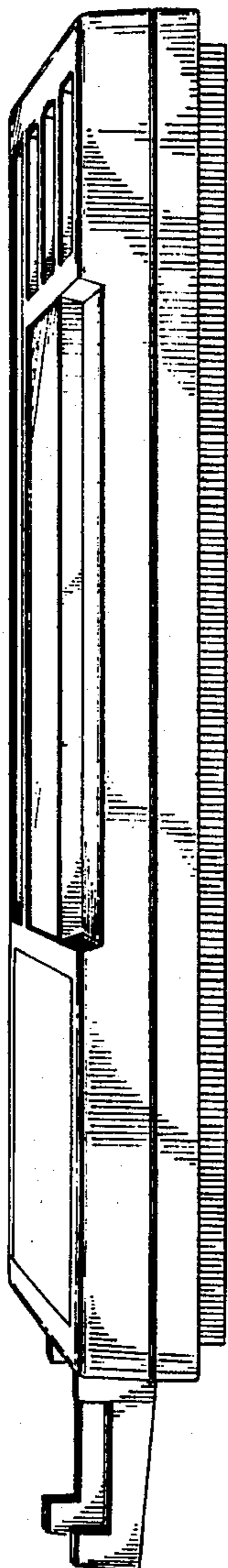
