FIG. 3 is a rear elevational view thereof;

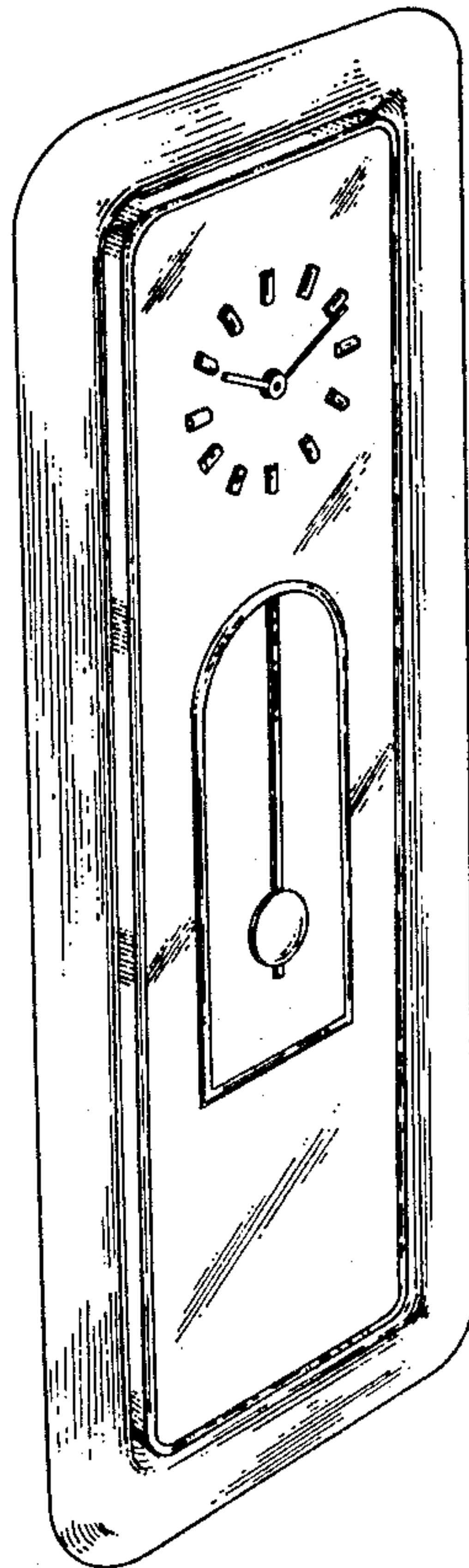
FIG. 4 is a left side elevational view thereof;

FIG. 8 is a cross-sectional view thereof taken along line 8-8 in FIG. 2.



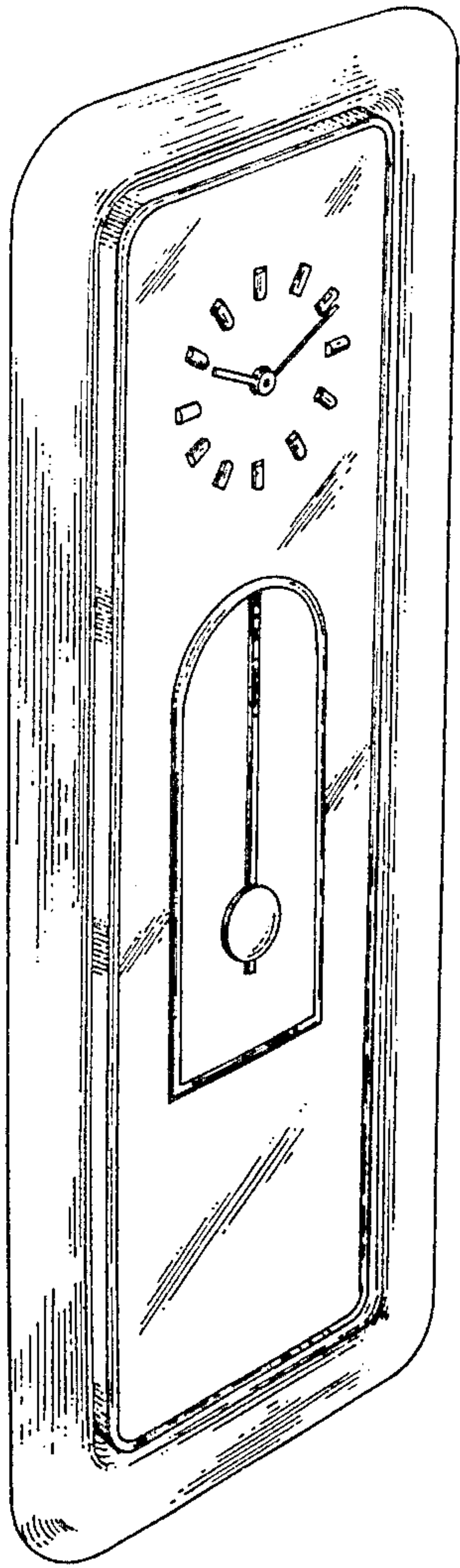

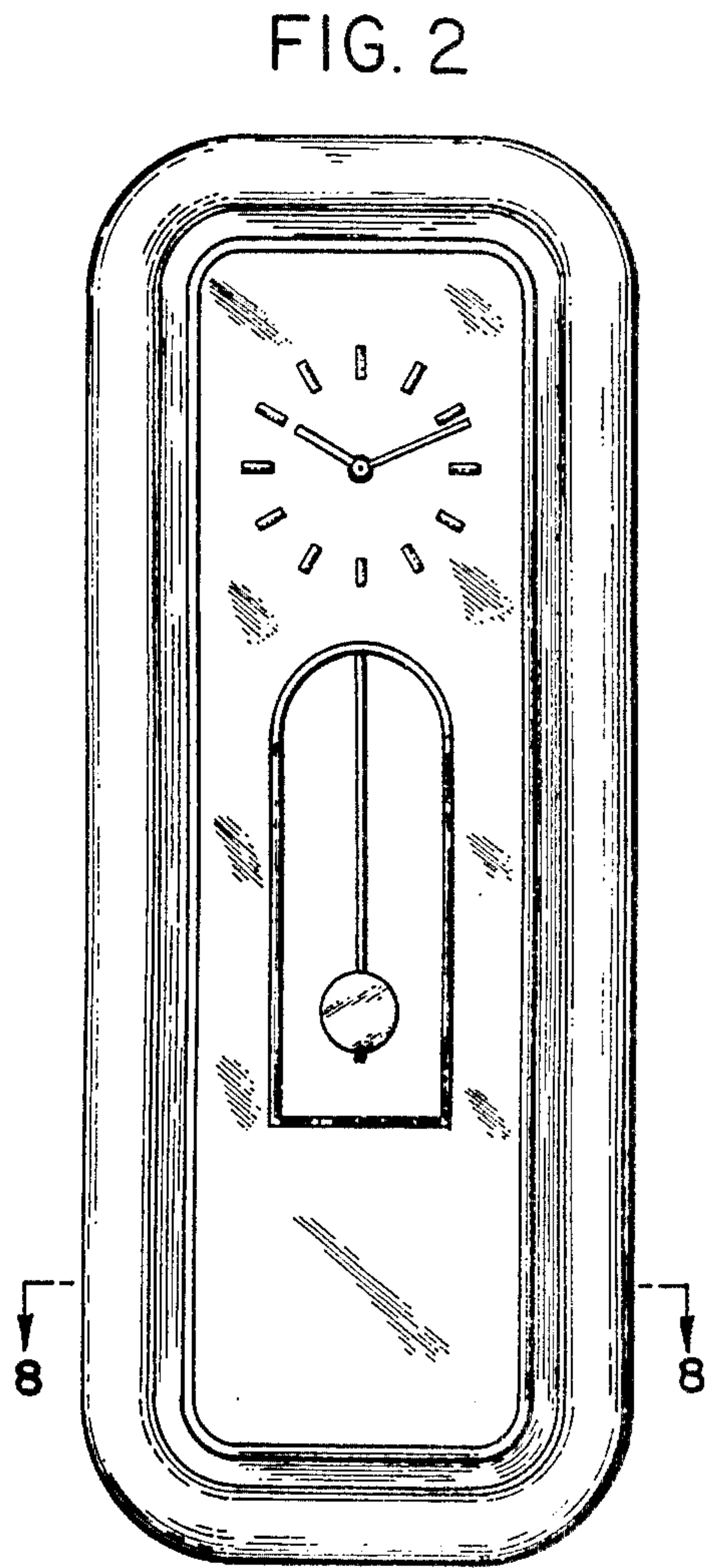

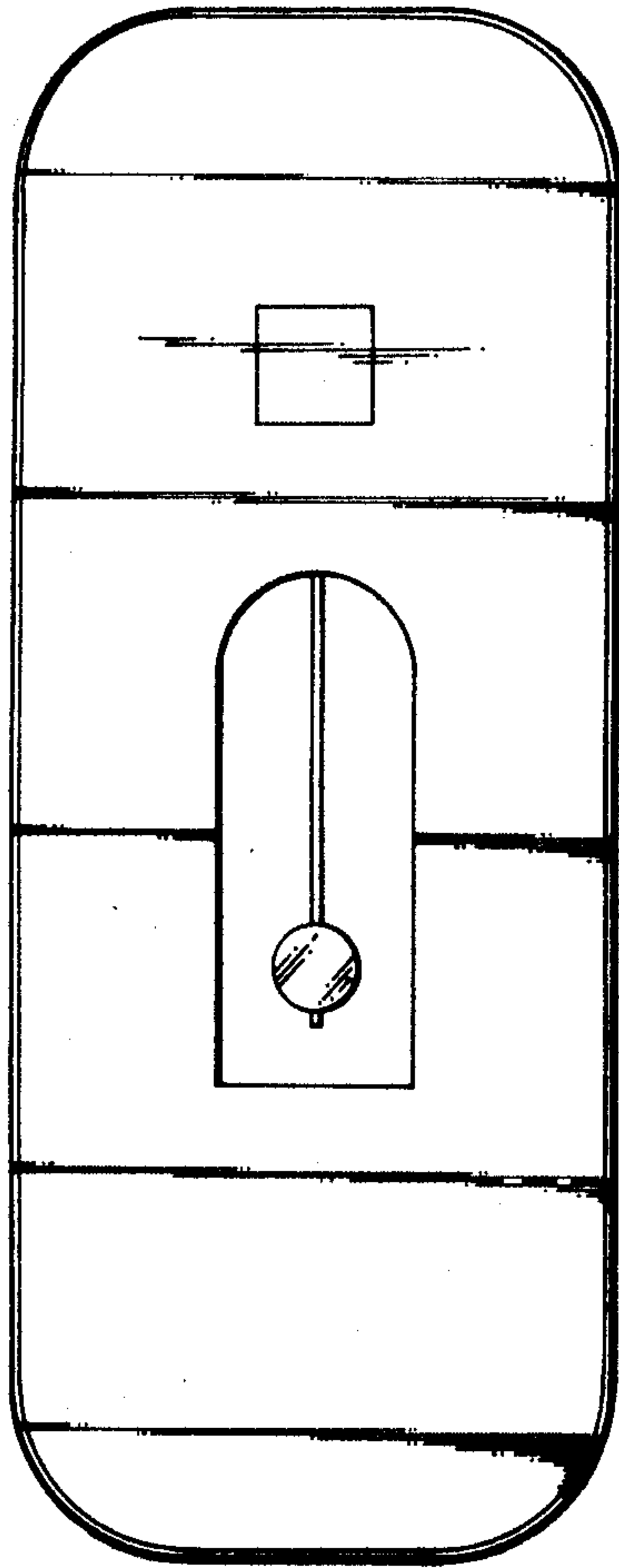

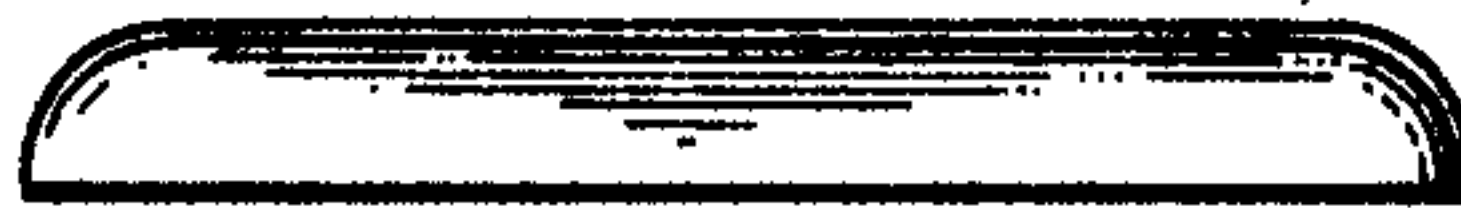
