[57] CLAIM

The ornamental design for a sport shoe, substantially as is shown and described .

DESCRIPTION

FIG. 1 is a perspective view from the upper right of the sport shoes;

FIG. 2 is a perspective view from the upper left of the sport shoes;

FIG. 3 is a rear view of FIG. 1;

FIG. 4 is a left side view of FIG. 1;

FIG. 5 is a plane view of FIG. 1;

FIG. 6 is a perspective bottom view showing the bottom and part of one side of the sport shoe.

The design is characterized by the particular surface ornamentation extending along the sides of the shoe from the lace area to both the sole area and the back of the shoe and defined by the panel formed by the non-intersecting curved arcs and the rearwardly extending band as shown in the several drawing figures. The particular shapes of the shoes shown in the drawings are illustrative only and do not form part of the design invention.

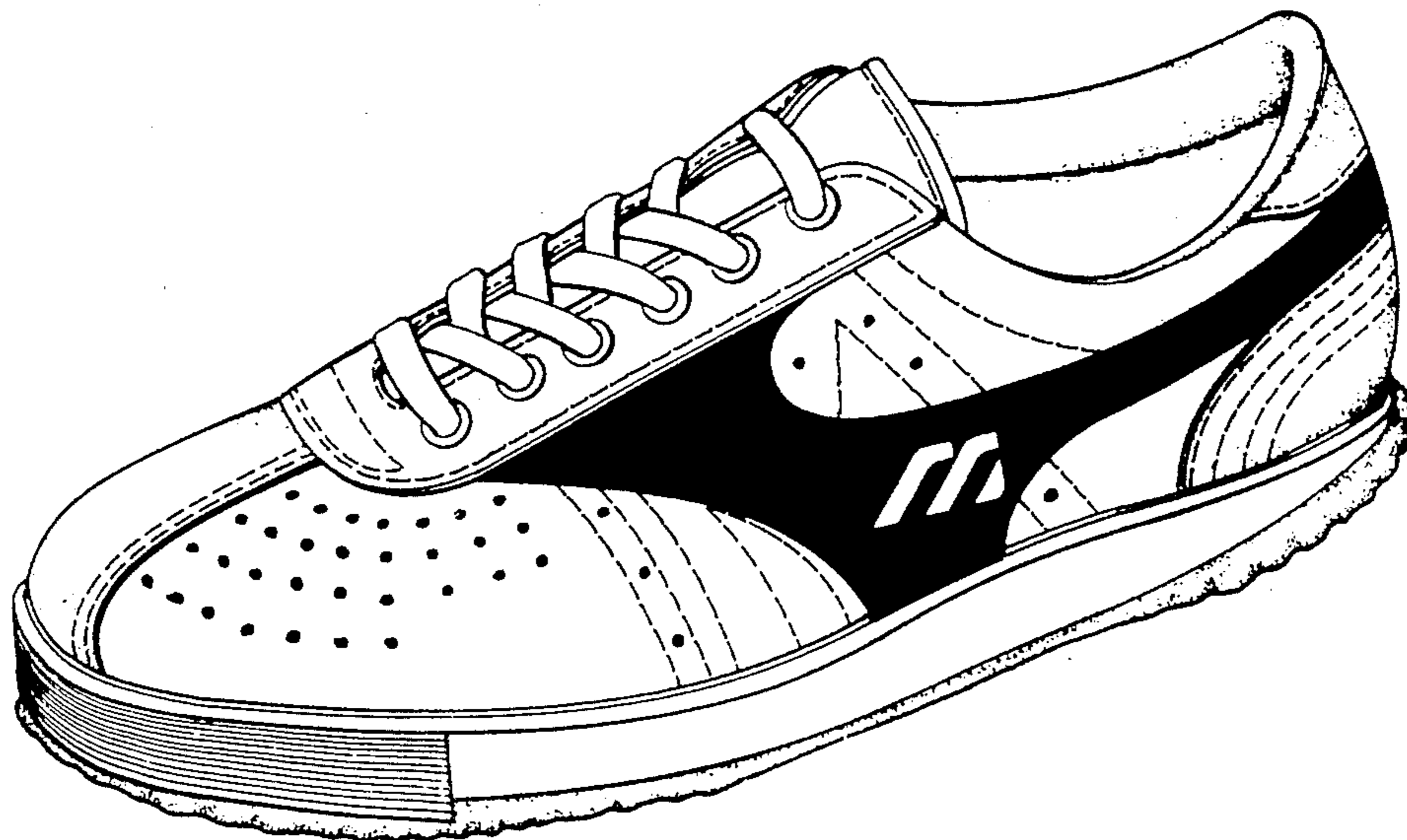

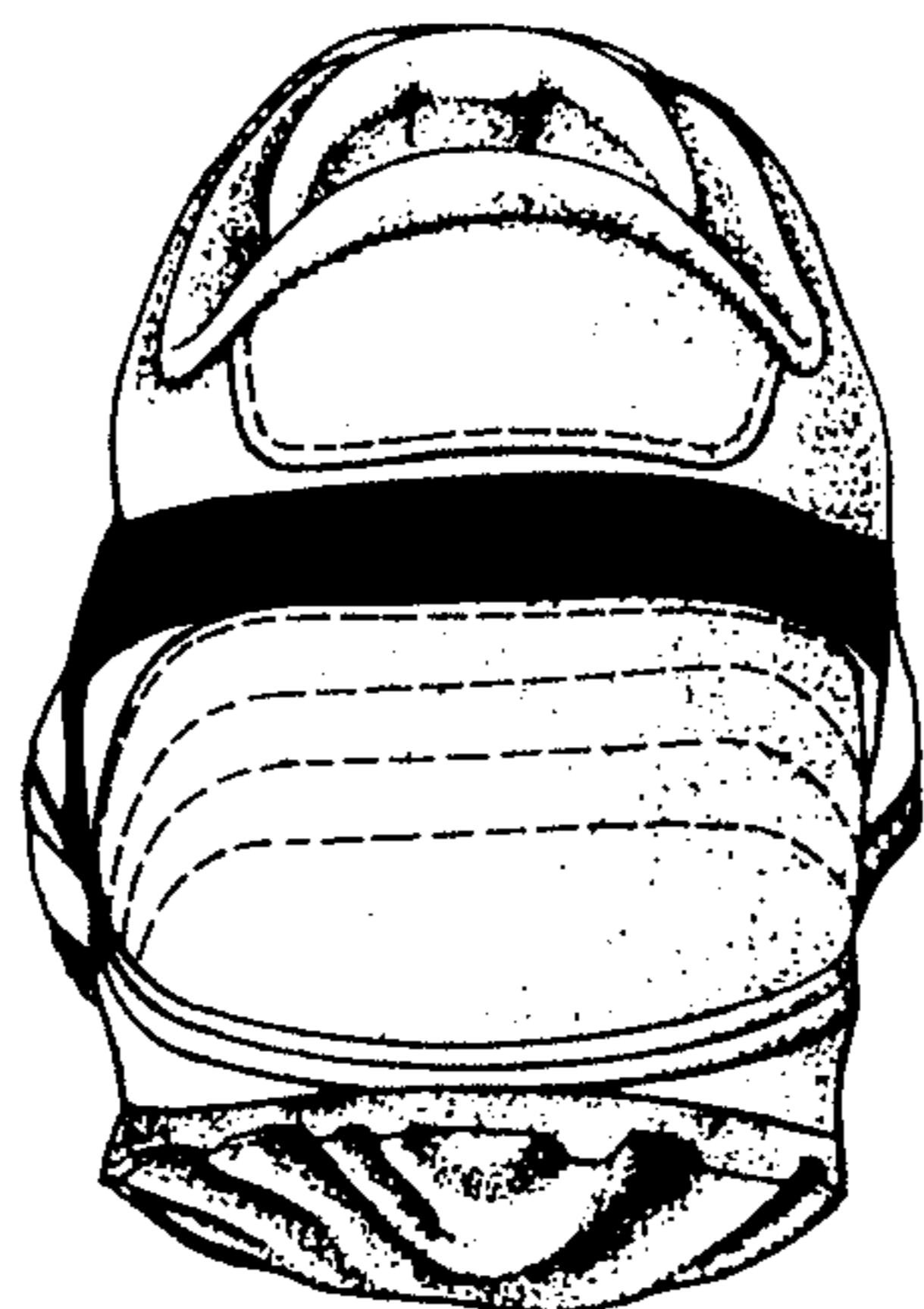

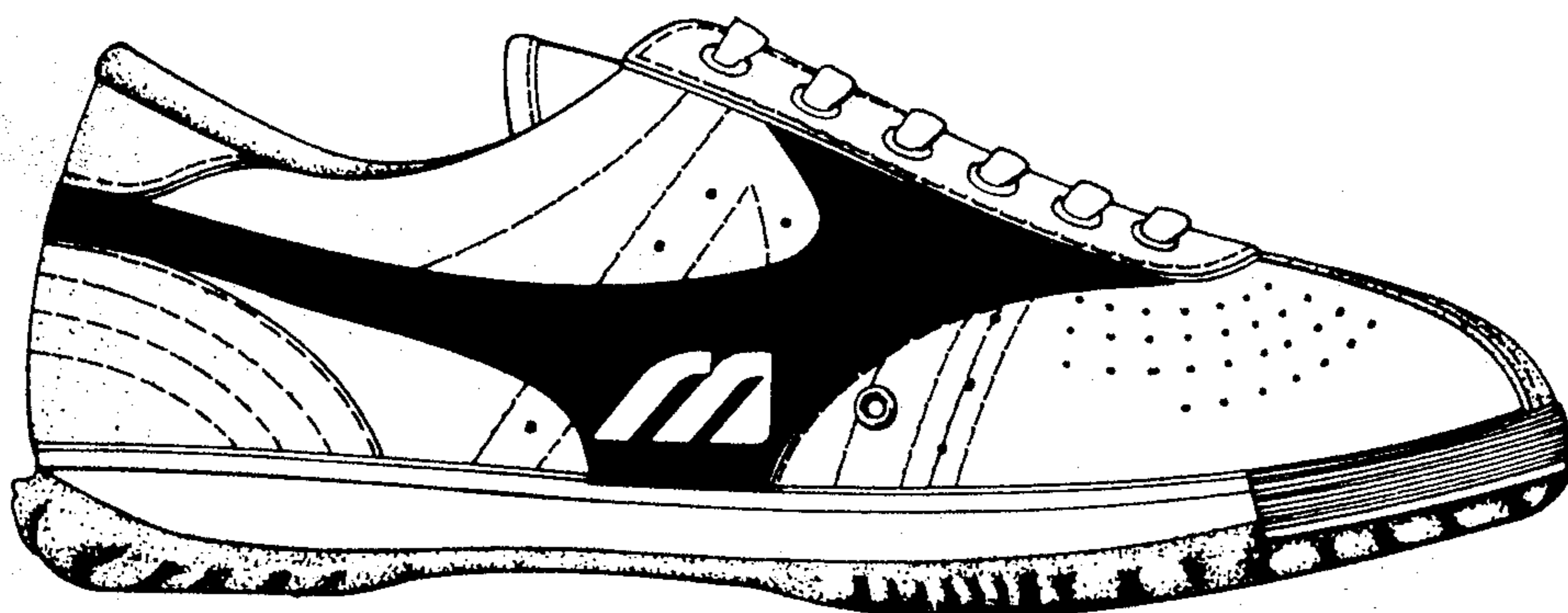

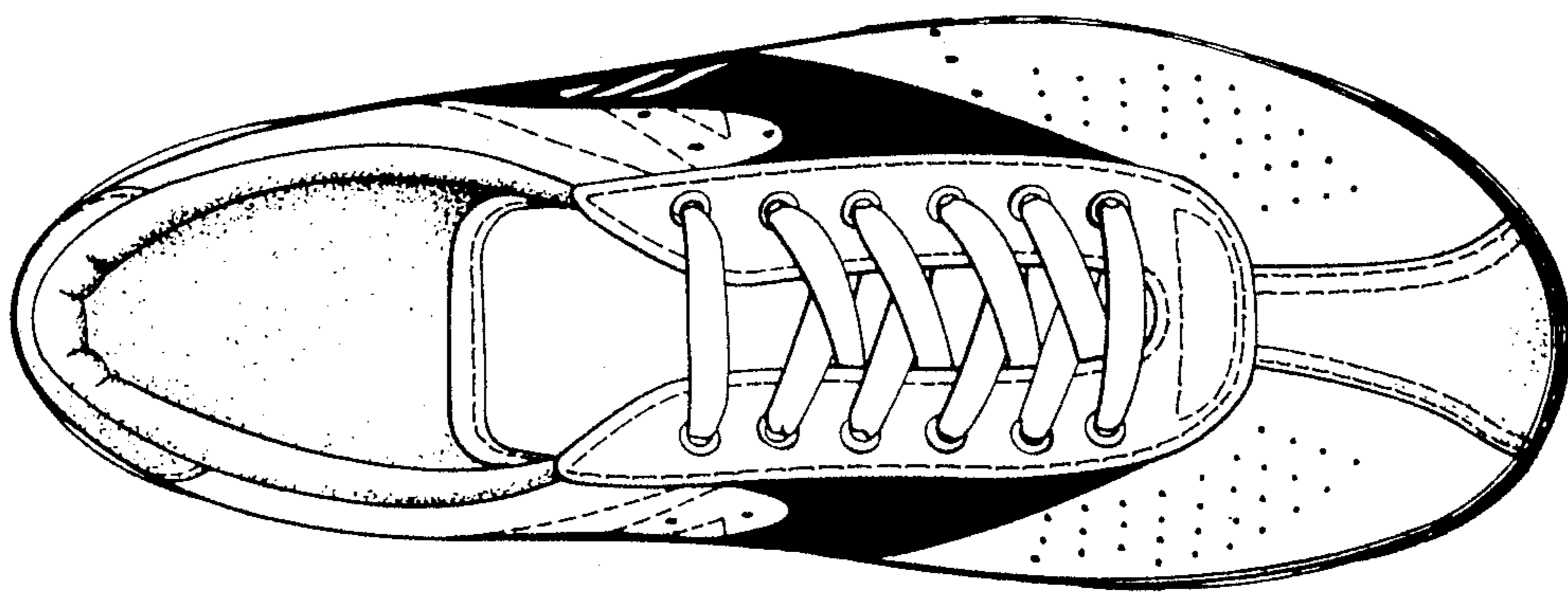
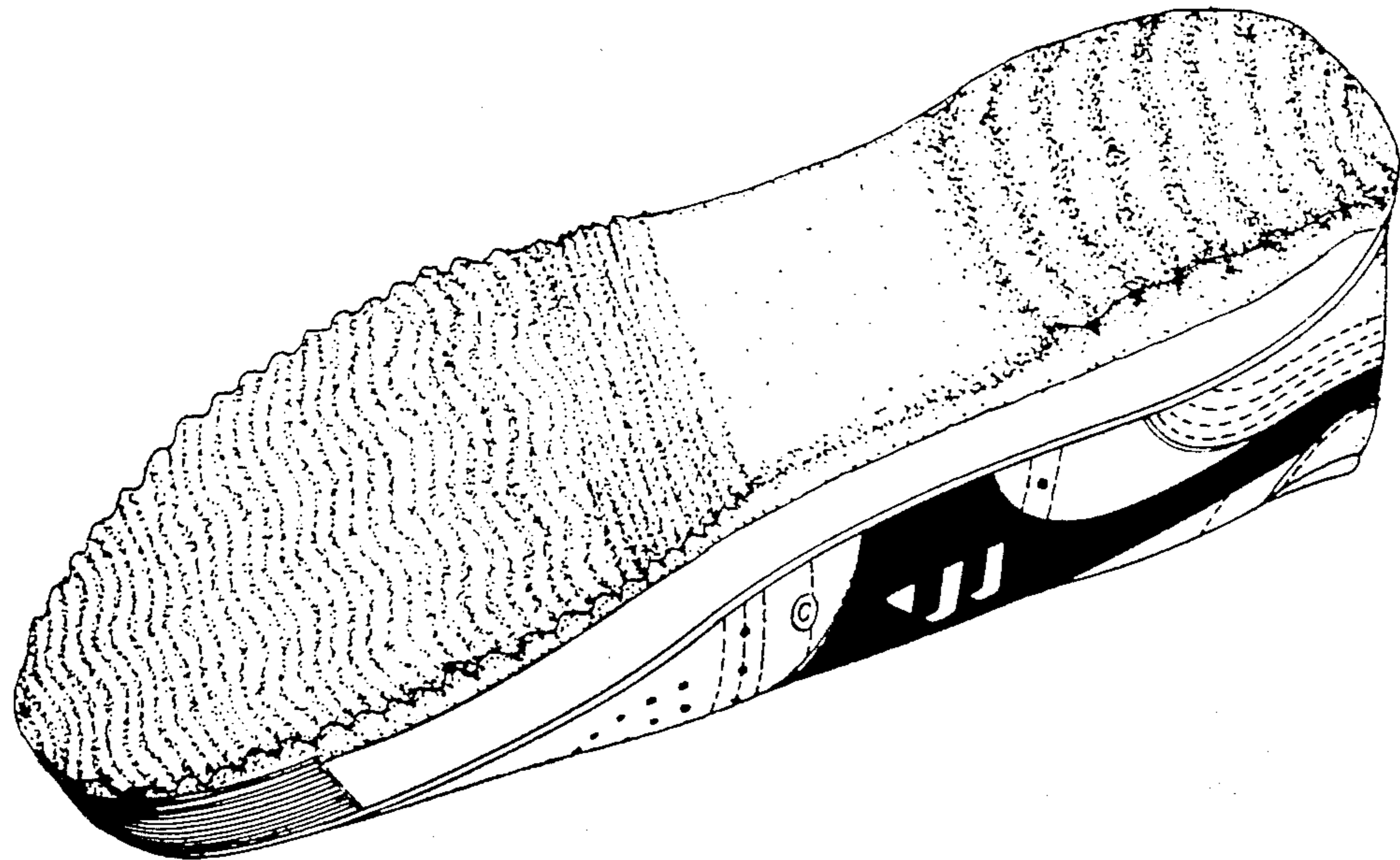
