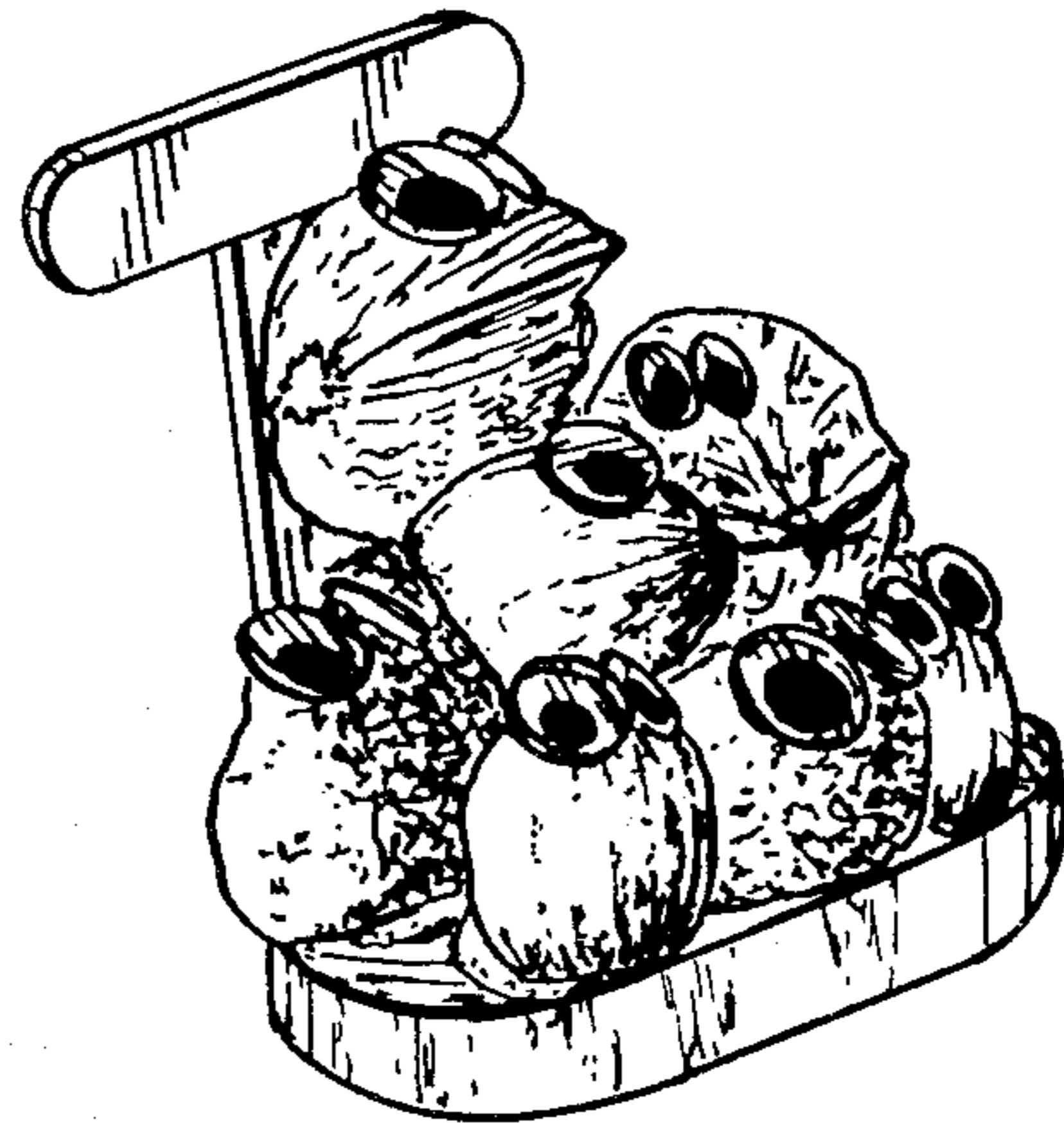
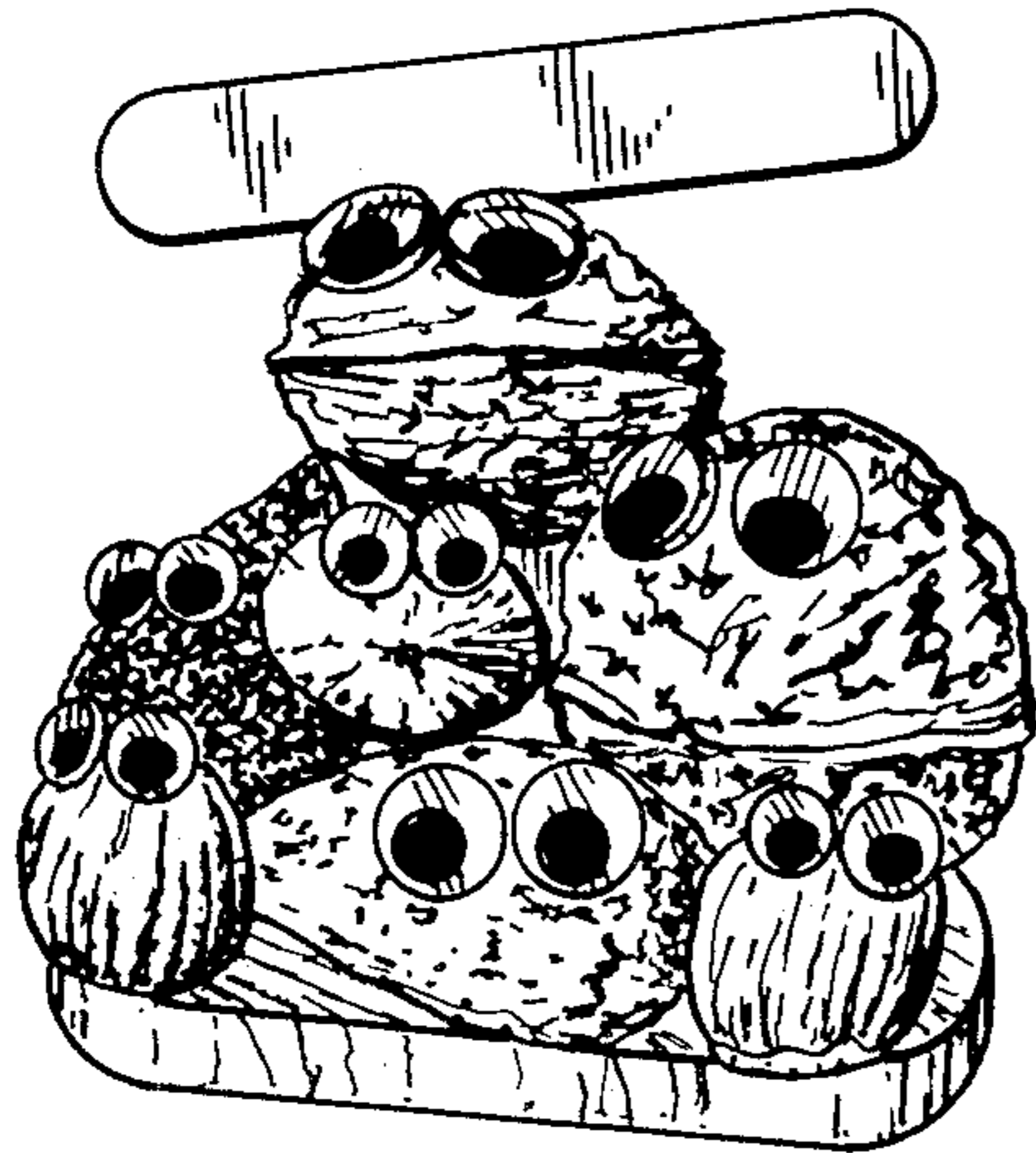

The ornamental design for a table ornament, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of table ornament showing our new design;  
FIG. 2 is a side perspective view thereof;  
FIG. 3 is an elevation of the other side thereof;  
FIG. 4 is a rear elevation thereof;

FIG. 6 is a bottom plan view thereof.



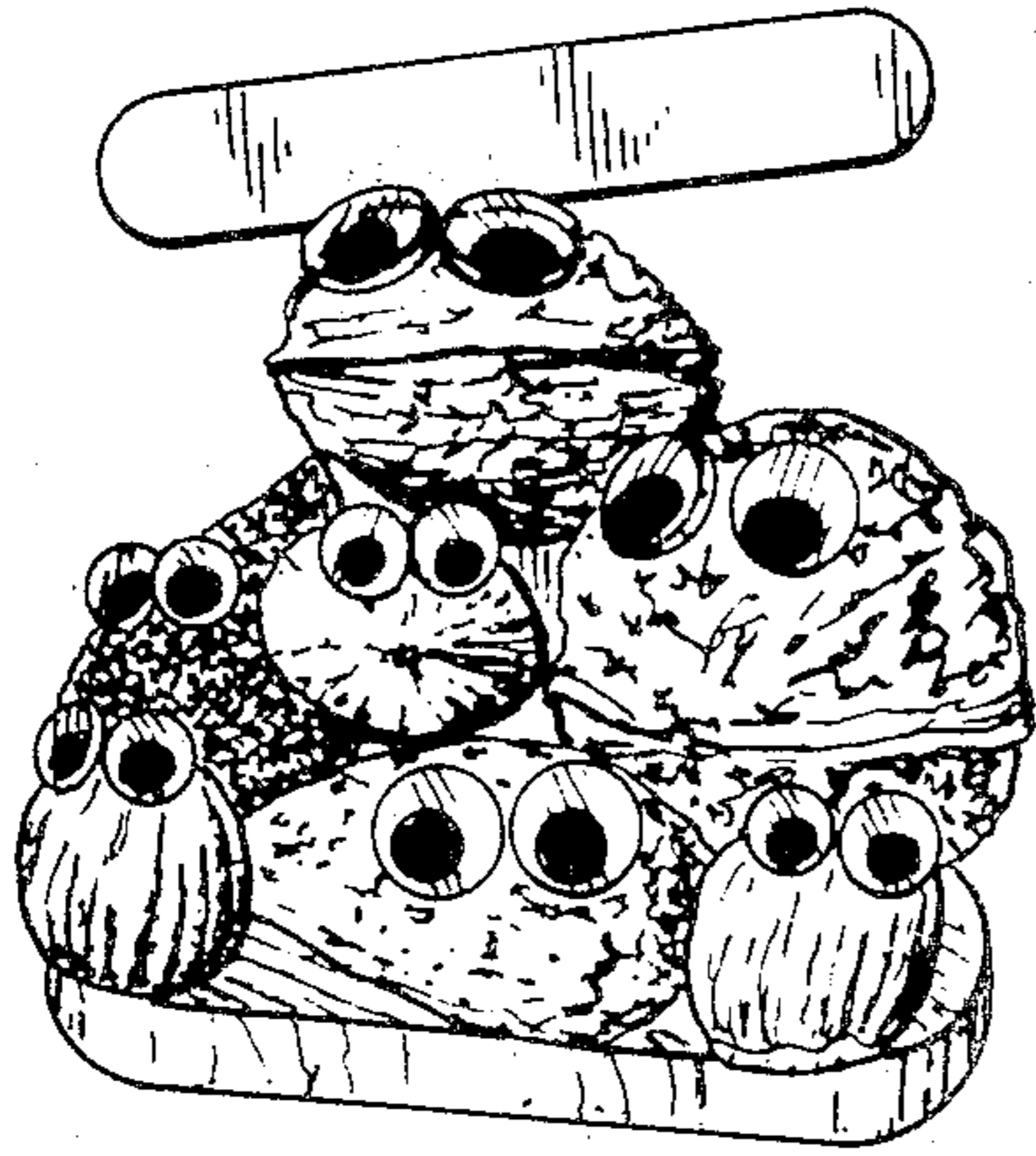

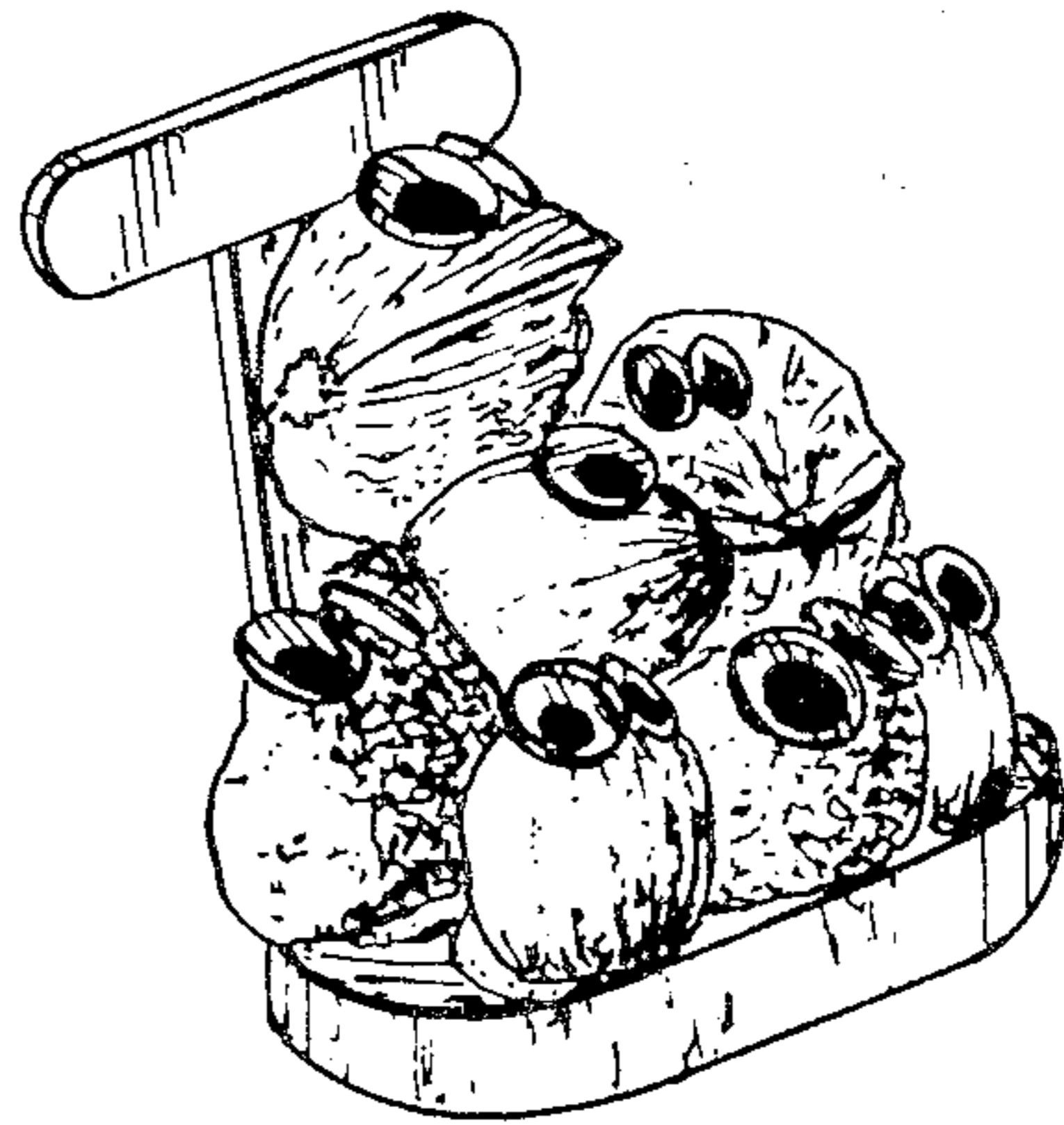

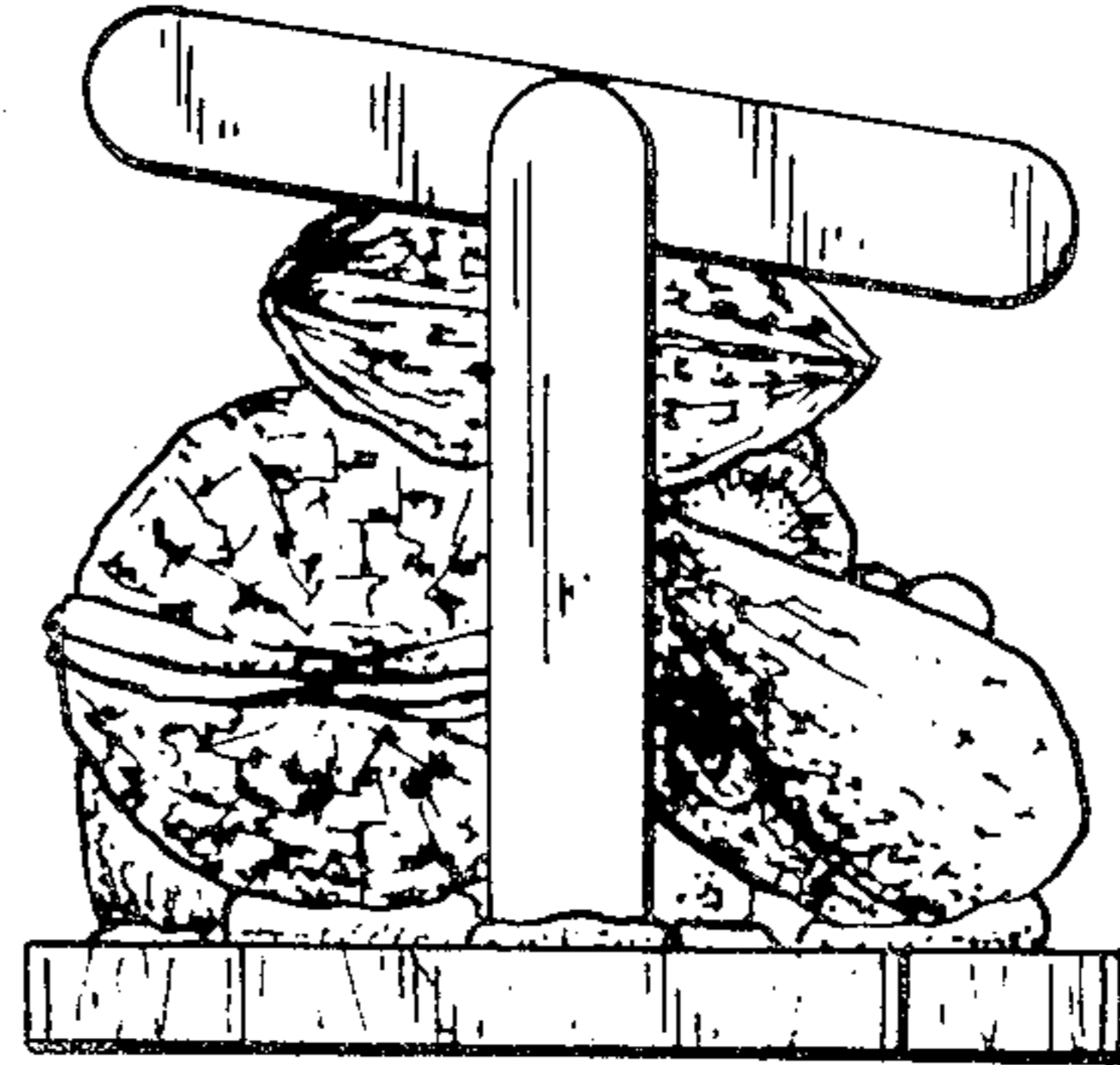

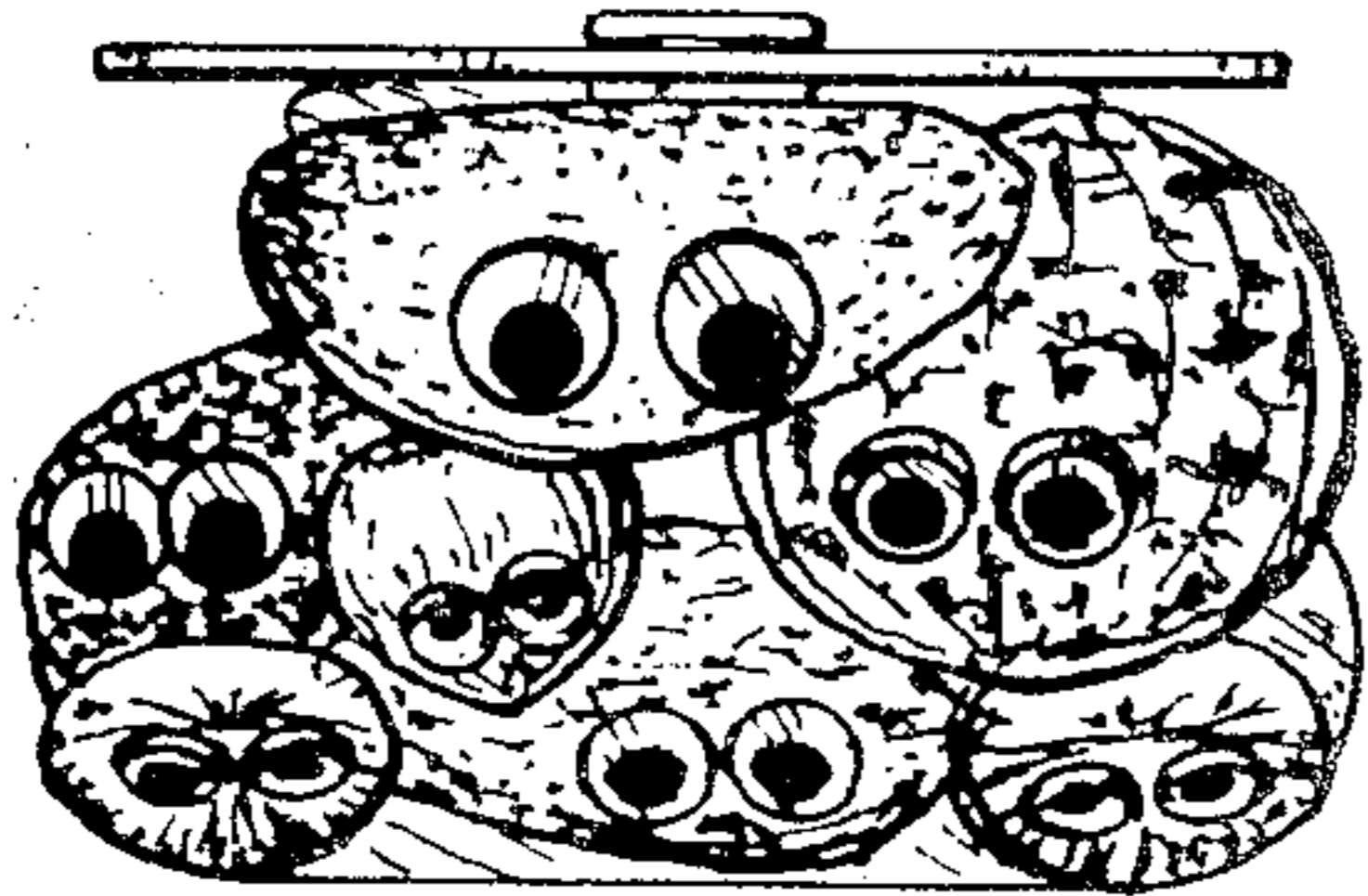

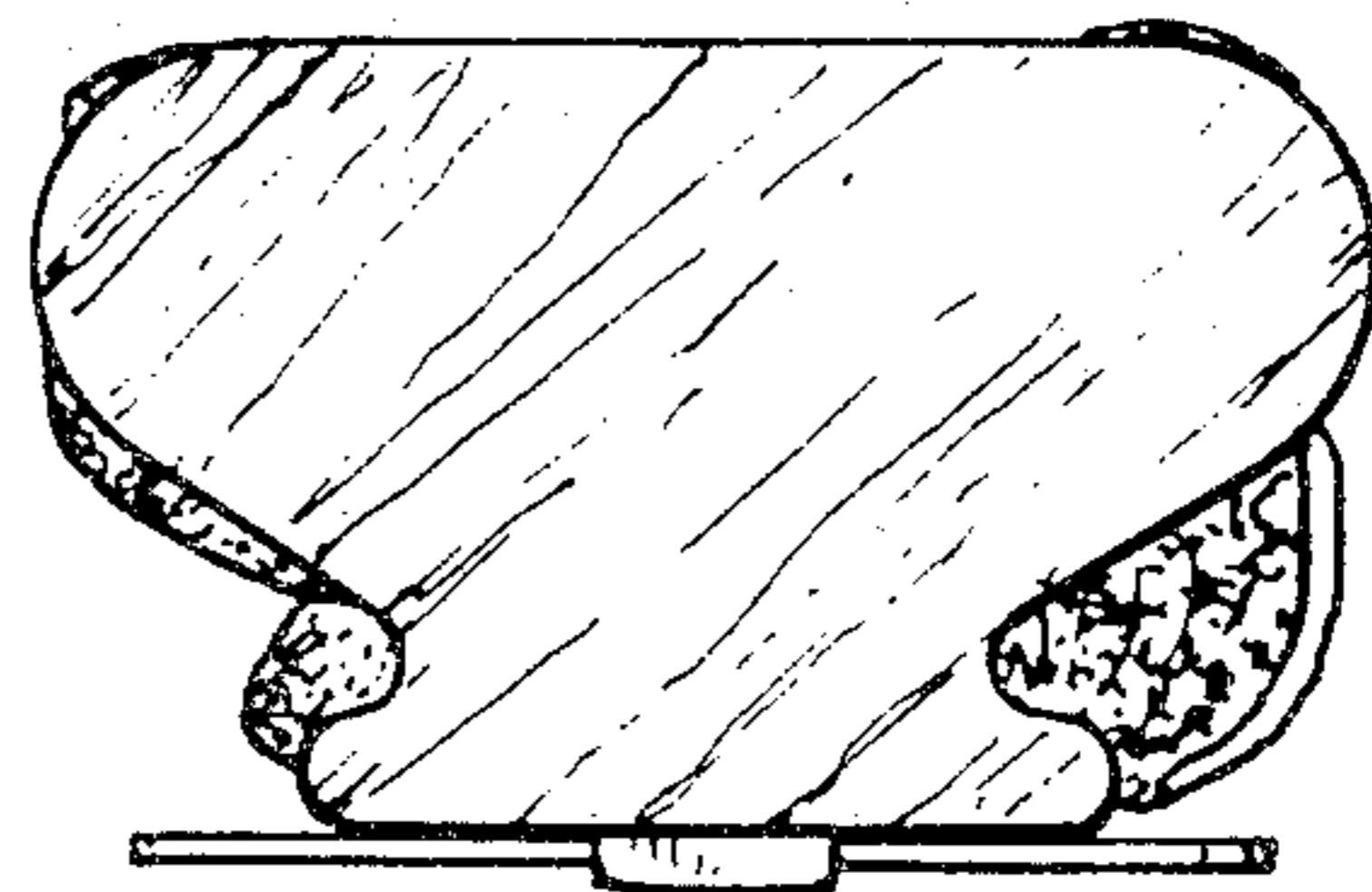
