CLAIM

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a seat showing our new design in the form of a chair;

FIG. 2 is a rear elevational view;

FIG. 3 is a view in side elevation of the seat shown in FIG. 1;

FIG. 4 is a top plan view of the seat shown in FIG. 1; and

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevational view of the design of FIG. 1 shown in the form of a settee;

FIG. 7 is a rear elevational view;







FIG. 8.*FIG. 9.**FIG. 10.*

FIG. 8 is a side elevational view;

FIG. 9 is a top plan view; and

FIG. 10 is a bottom plan view thereof;

FIG. 11 is a front elevational view of the design of FIG. 1 shown in the form of a sofa;

FIG. 12 is a rear elevational view;

FIG. 13 is a side elevational view;

FIG. 14 is a top plan view; and

FIG. 15 is a bottom plan view thereof.

The sides of the seat forms not shown are substantially mirror images of the respective sides shown in FIGS. 3, 8 and 13.






















