FIG. 1 is a front elevational view of a photographic camera with integral cover-handle showing my new design, illustrating the cover-handle in its closed position;

FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front elevational view showing the coverhandle in an open position; FIG. 8 is a top plan view thereof; FIG. 9 is a bottom plan view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a left side elevational view thereof; and FIG. 12 is a rear elevational view theref.
