## [57] CLAIM

The ornamental design for the athletic shoe with counter pocket, as shown and described.

## DESCRIPTION

FIG. 1 is a top plan view of an athletic shoe with counter pocket showing my new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a left-rear perspective view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a rear perspective view of a second embodiment of my new design of FIGS. 1-4;

FIG. 6 is a rear perspective view of a third embodiment of my new design of FIGS. 1-4;

FIG. 7 is a rear perspective view of a fourth embodiment of my new design of FIGS. 1-4;

FIG. 8 is a rear perspective view of a fifth embodiment of my new design of FIGS. 1-4;

FIG. 9 is a rear perspective view of a sixth embodiment of my new design of FIGS. 1-4;

FIG. 10 is a rear perspective view of a seventh embodiment of my new design of FIGS. 1-4;

FIG. 11 is a rear perspective view of an eighth embodiment of my new design of FIGS. 1-4;

FIG. 12 is a rear perspective view of a ninth embodiment of my new design of FIGS. 1-4;


FIG. 13 is a rear perspective view of a tenth embodiment of my new design of FIGS. 1-4;

The top and side views of the second through thirteenth embodiments are substantially like those for FIGS. 1 and 2 except for the slide fastener placement; and, the sole of all the embodiments is substantially plain and unornamented.


































