 FIG. 6 is a right elevational view thereof.

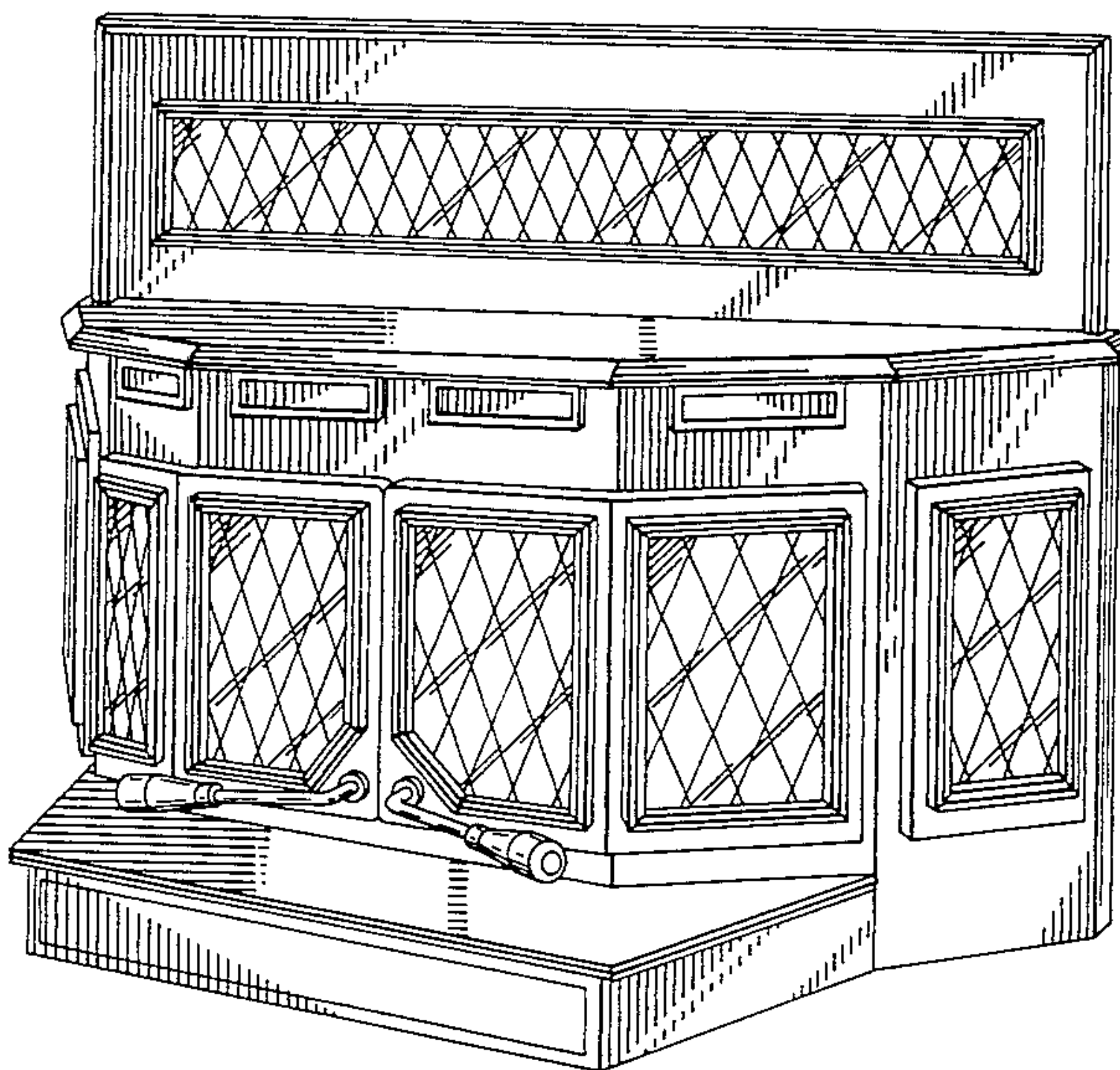

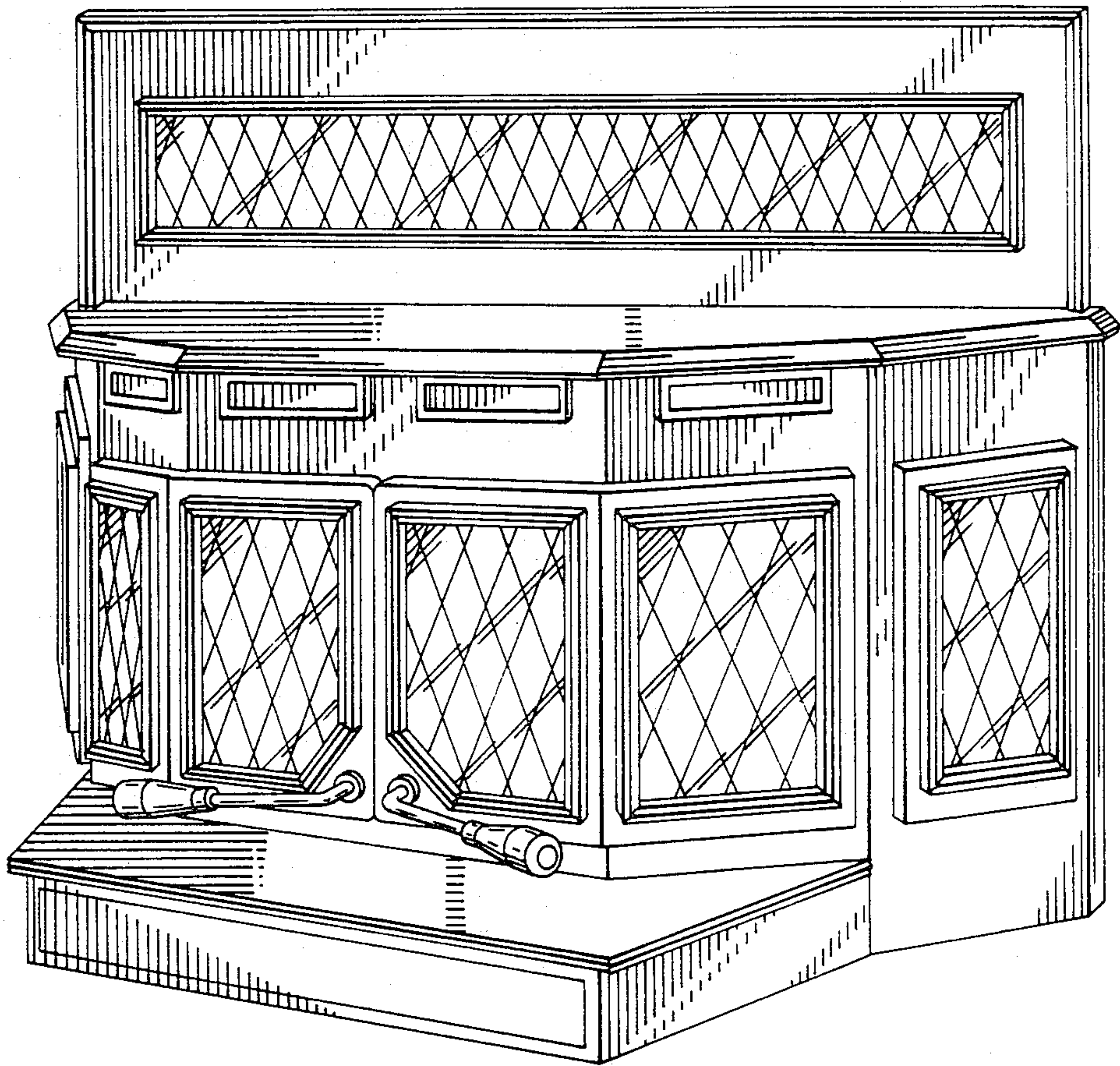
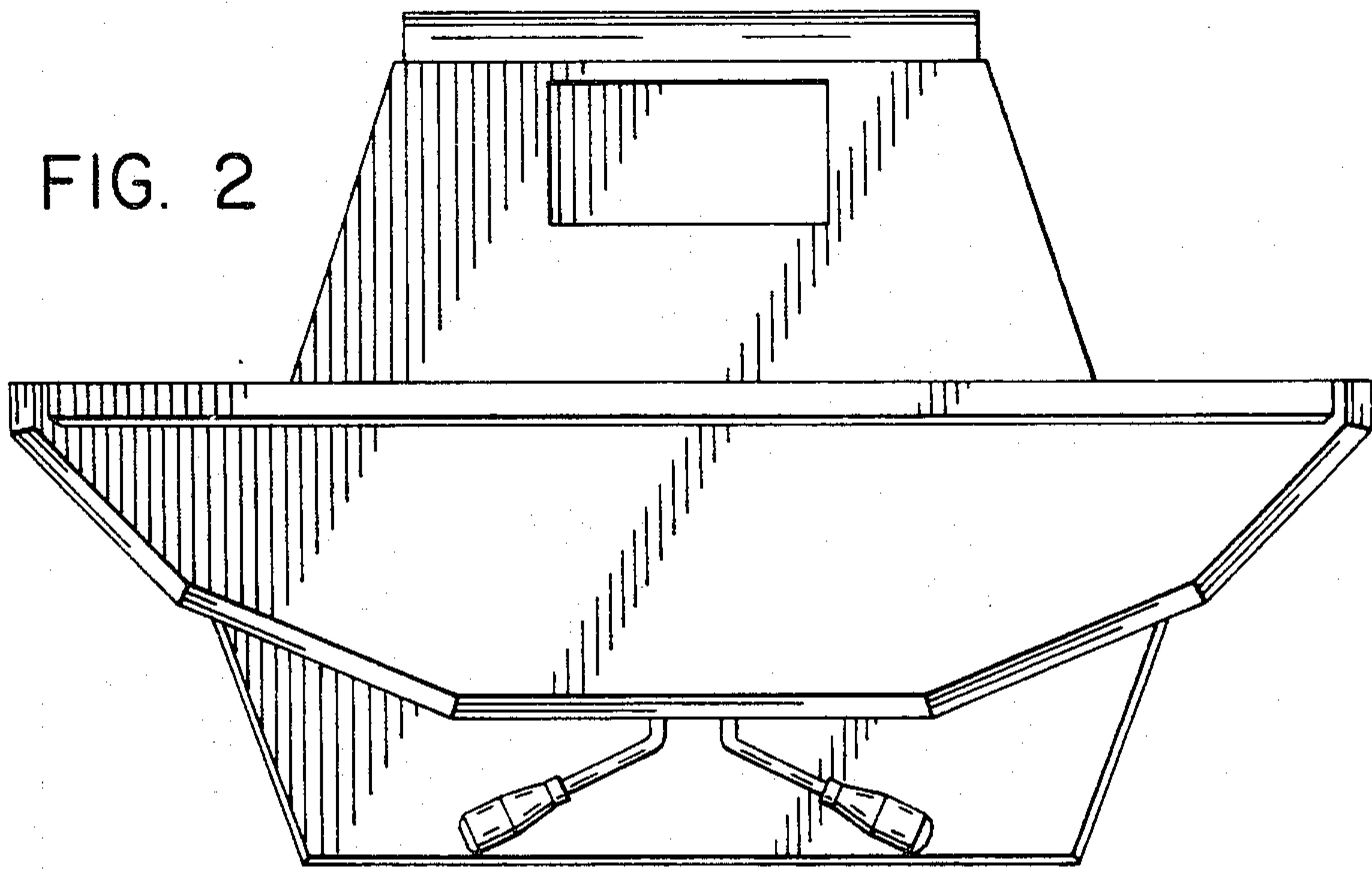

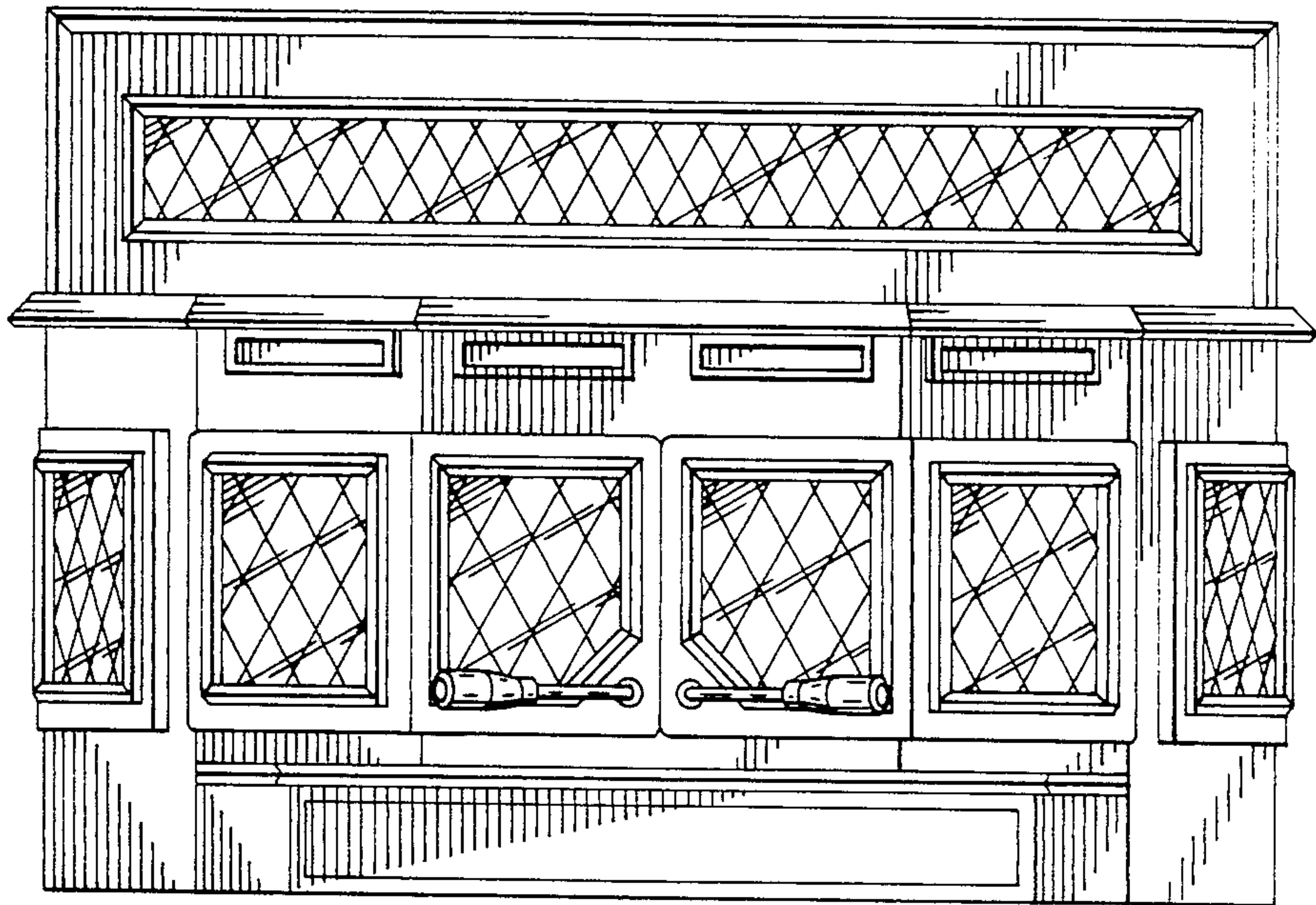

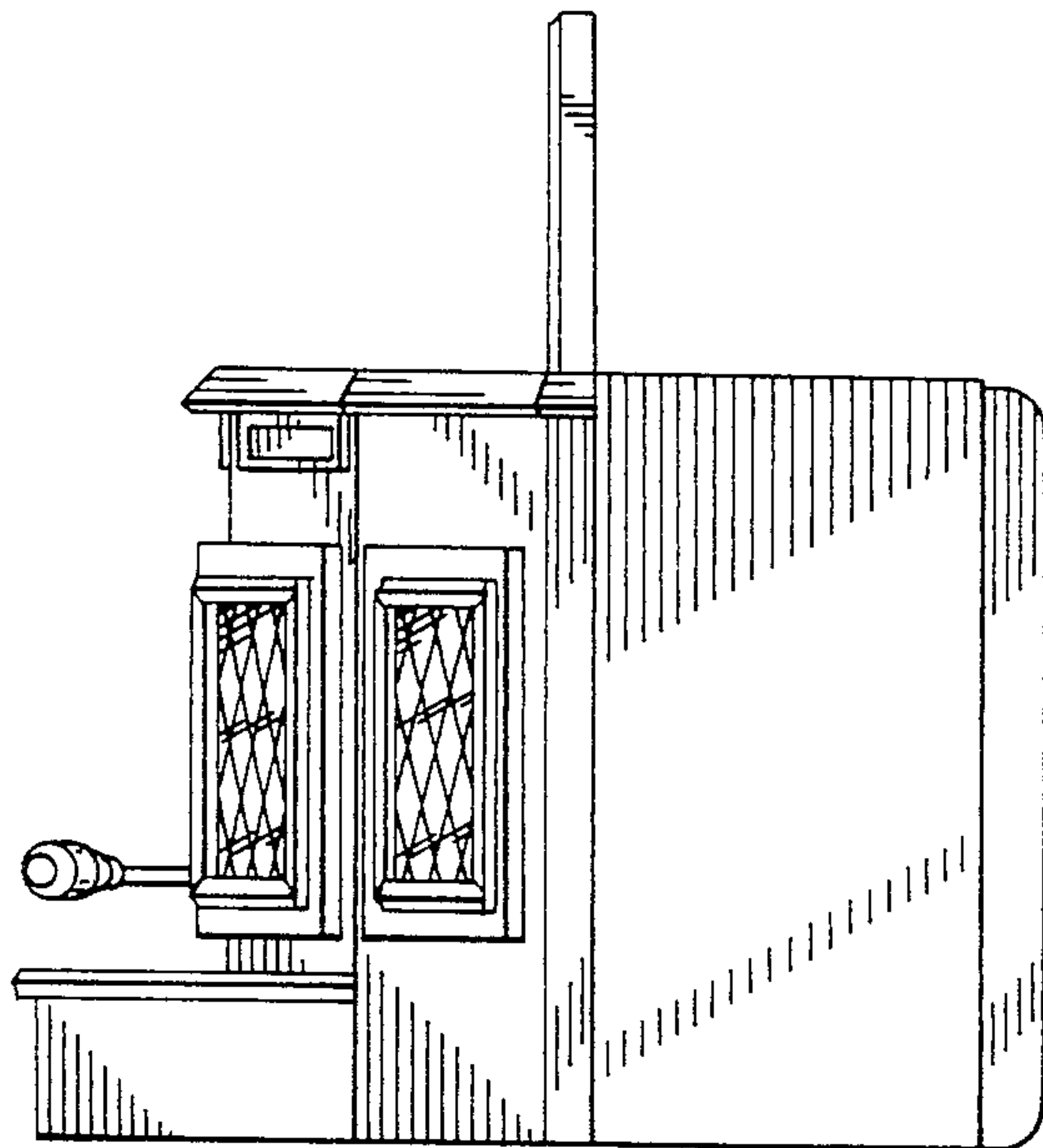

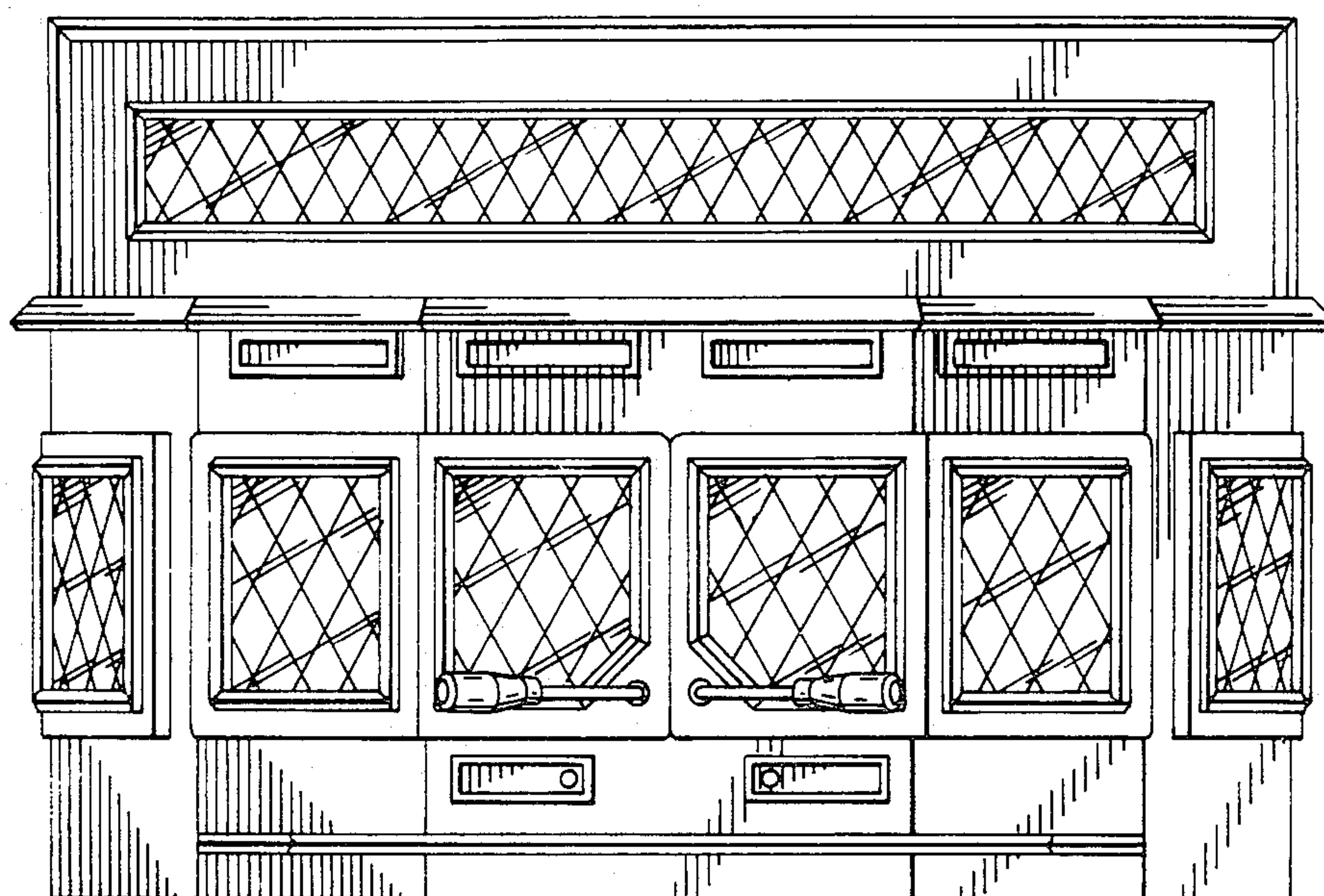

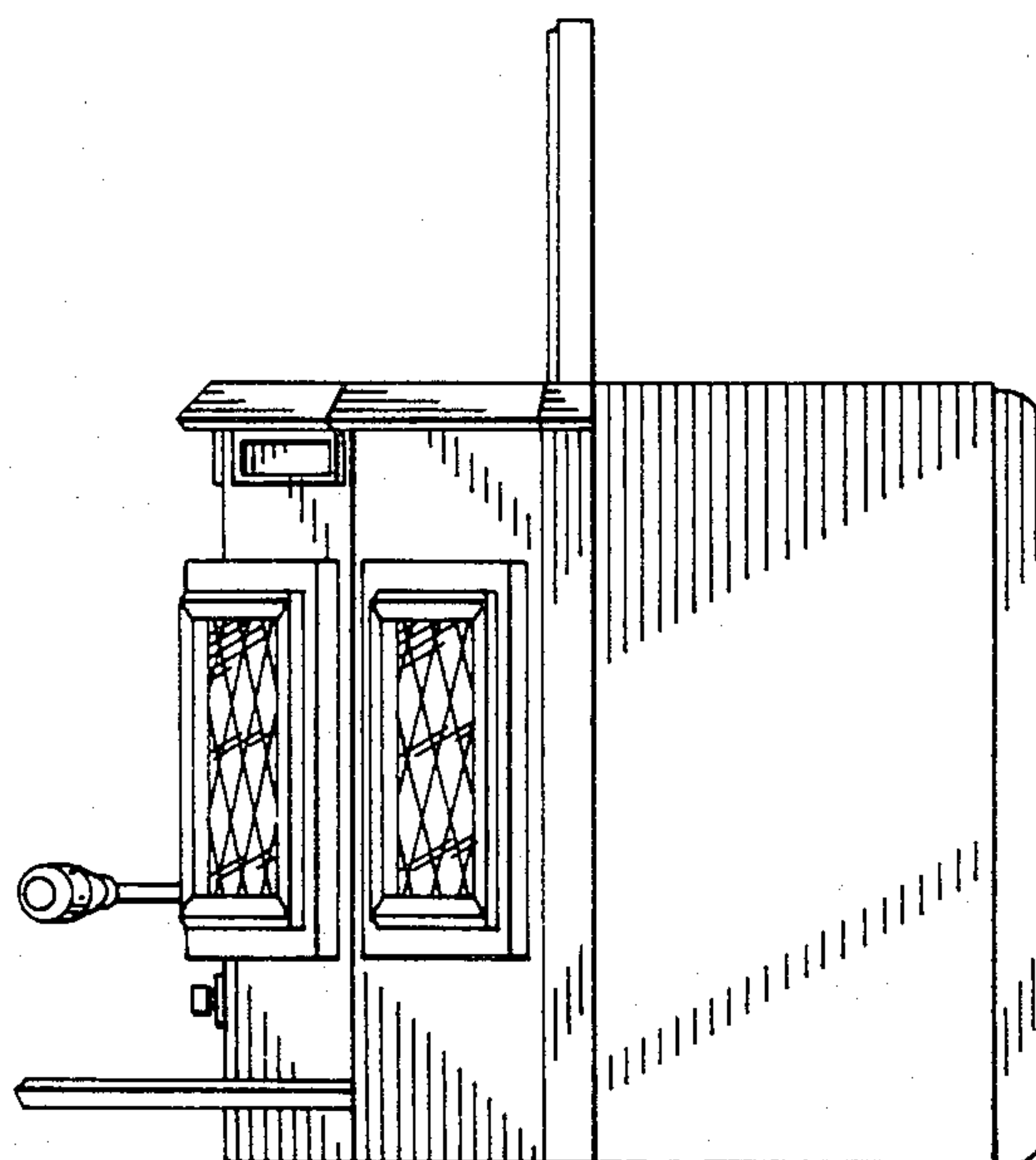
