[57] **CLAIM**

The ornamental design for a printed circuit board component mounting machine, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a printed circuit board component mounting machine showing our new design; FIG. 2 is a front elevational view thereof;

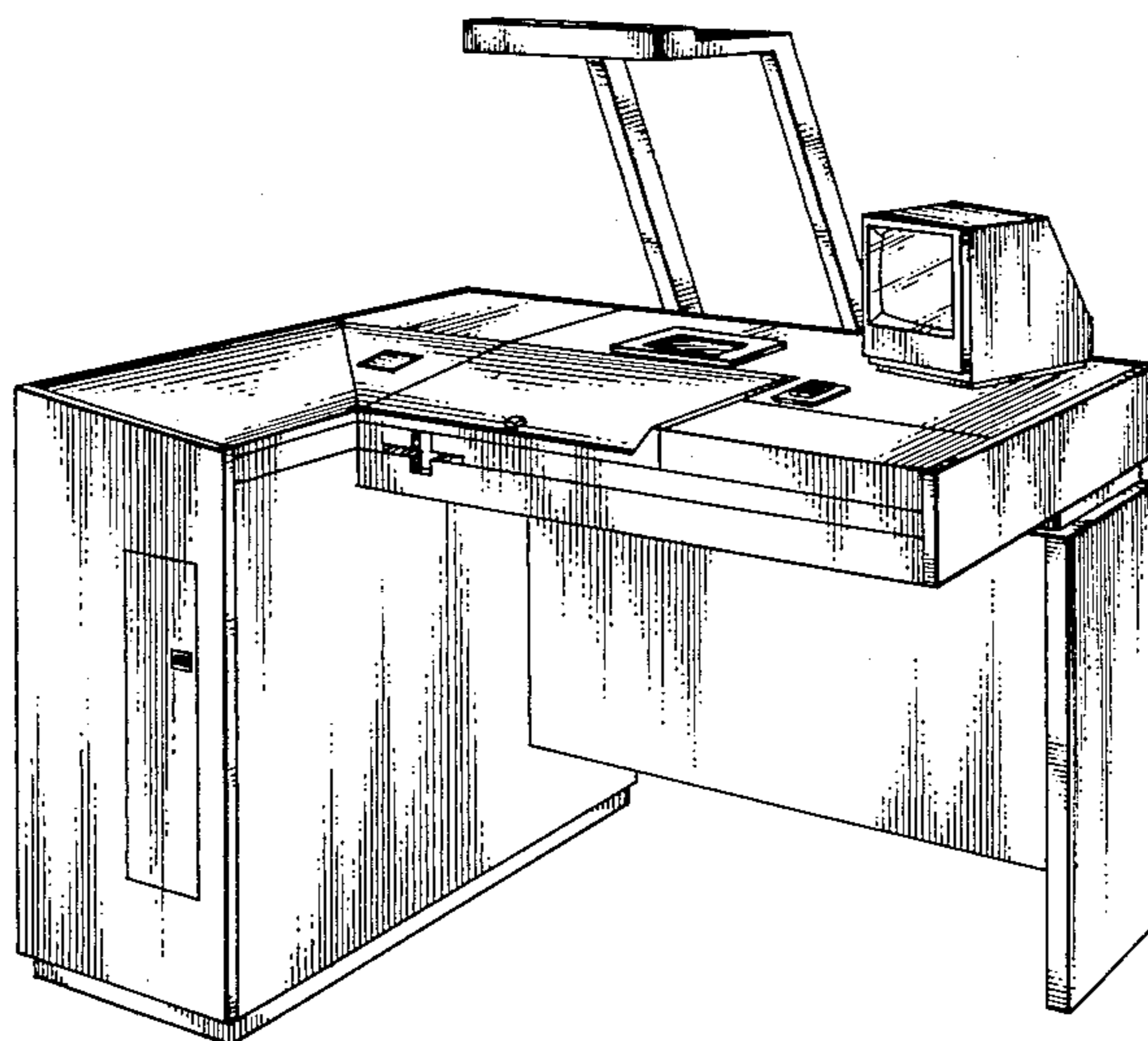
FIG. 3 is a side elevational view taken from the right of FIG. 1;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a side elevational view taken from the left of FIG. 1;

FIG. 6 is a top plan view thereof;

FIG. 7 is a perspective view of a second embodiment of the design of FIG. 1, the only difference being the omission of the video display element.



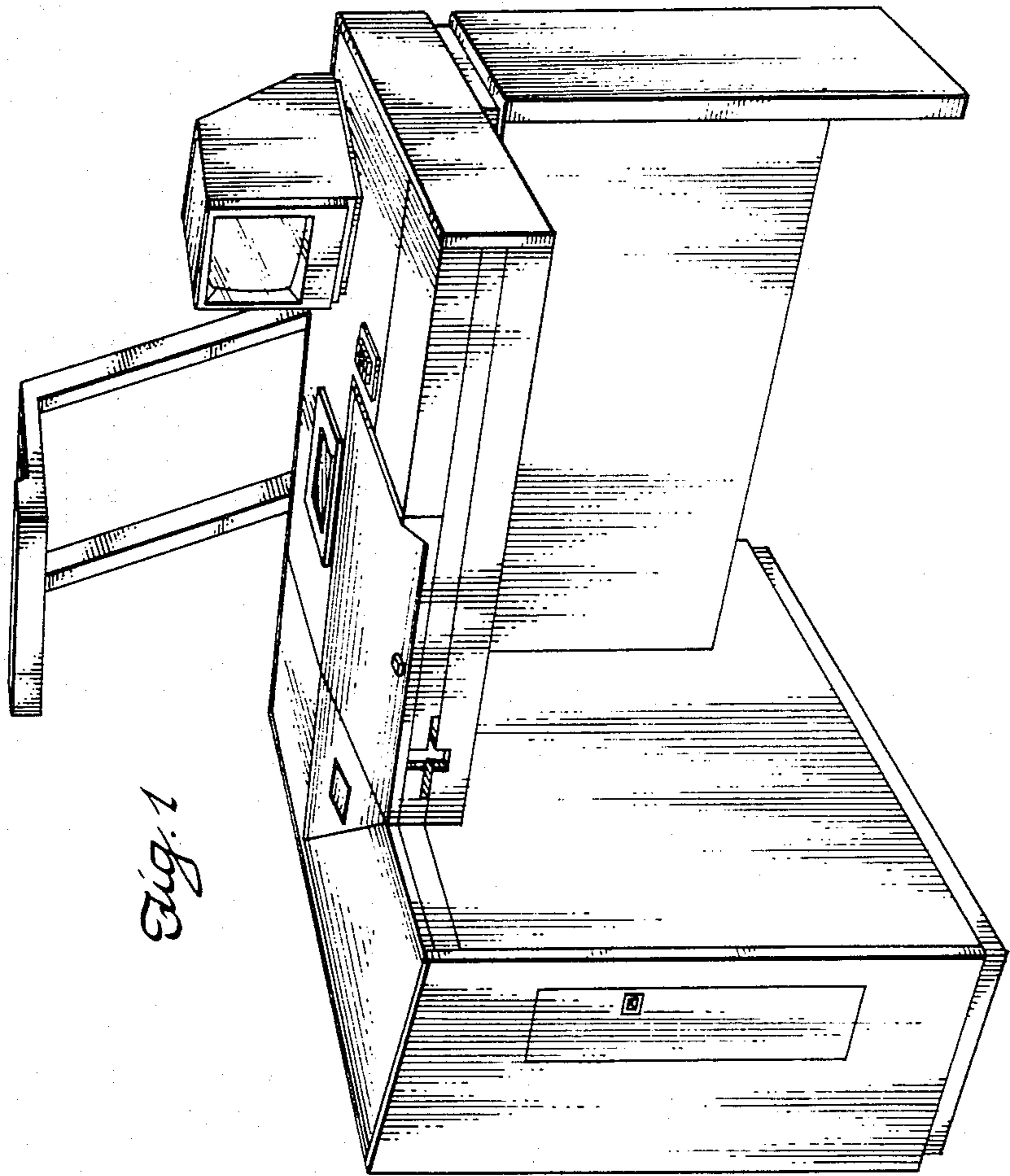

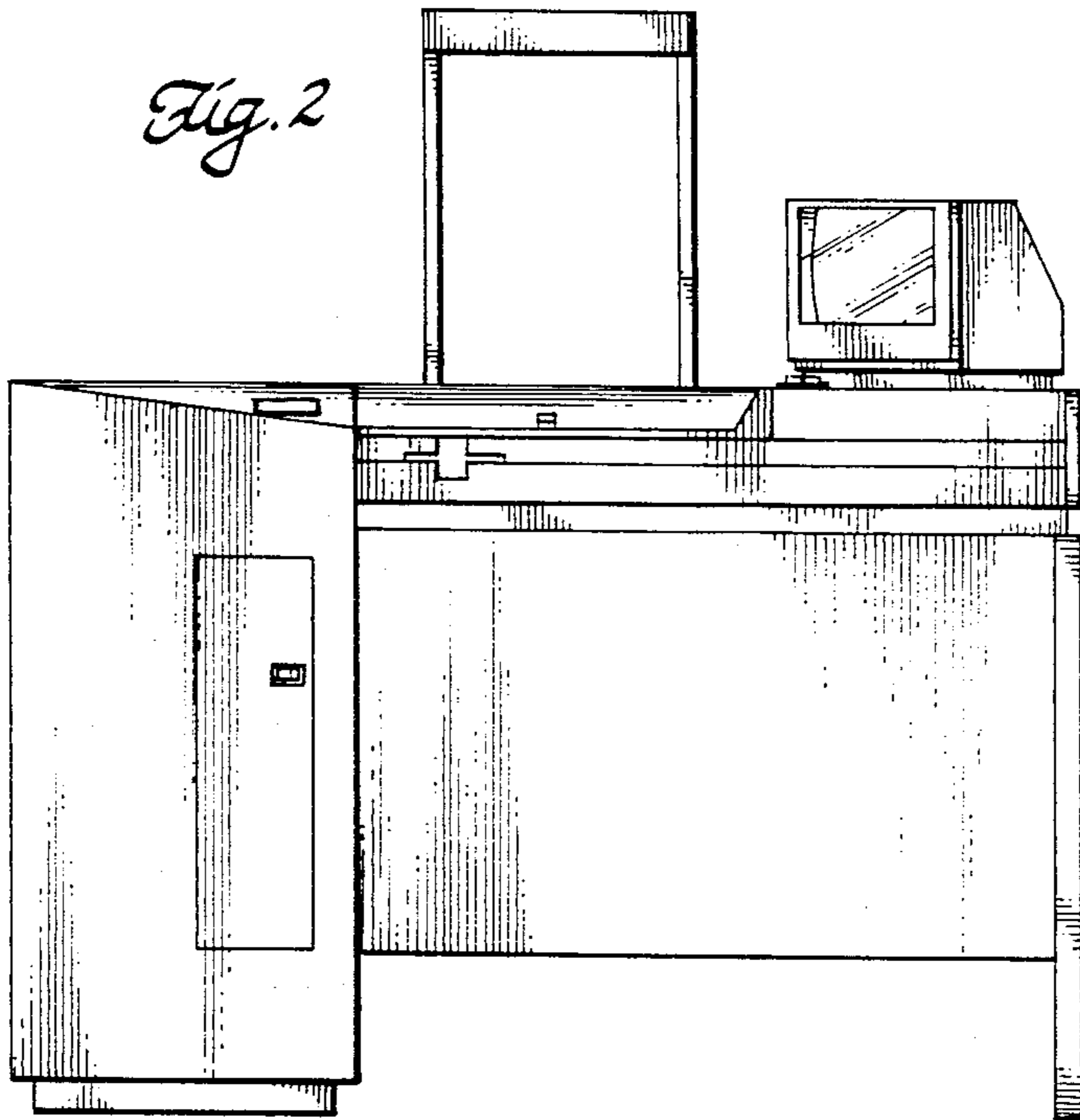
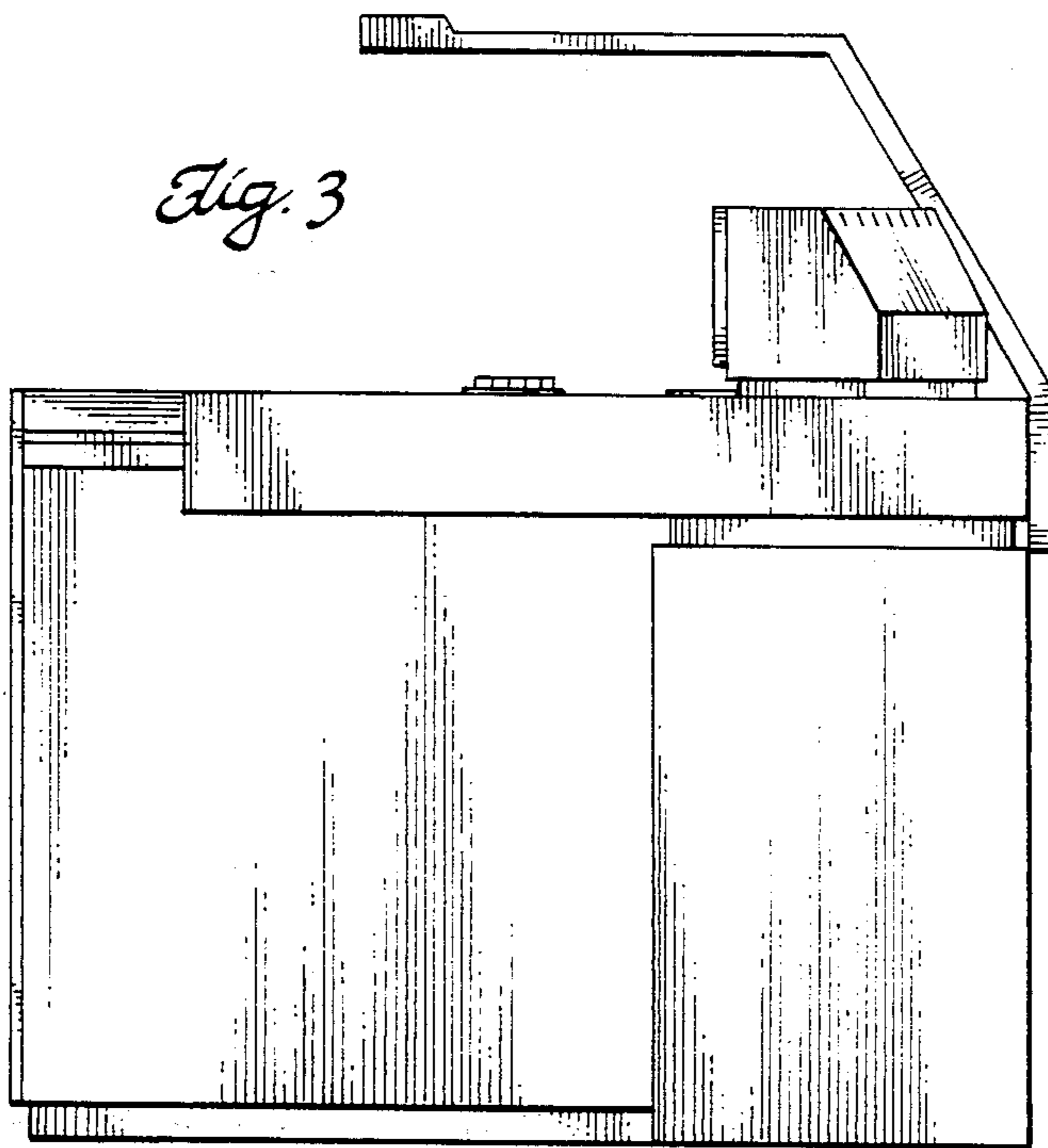

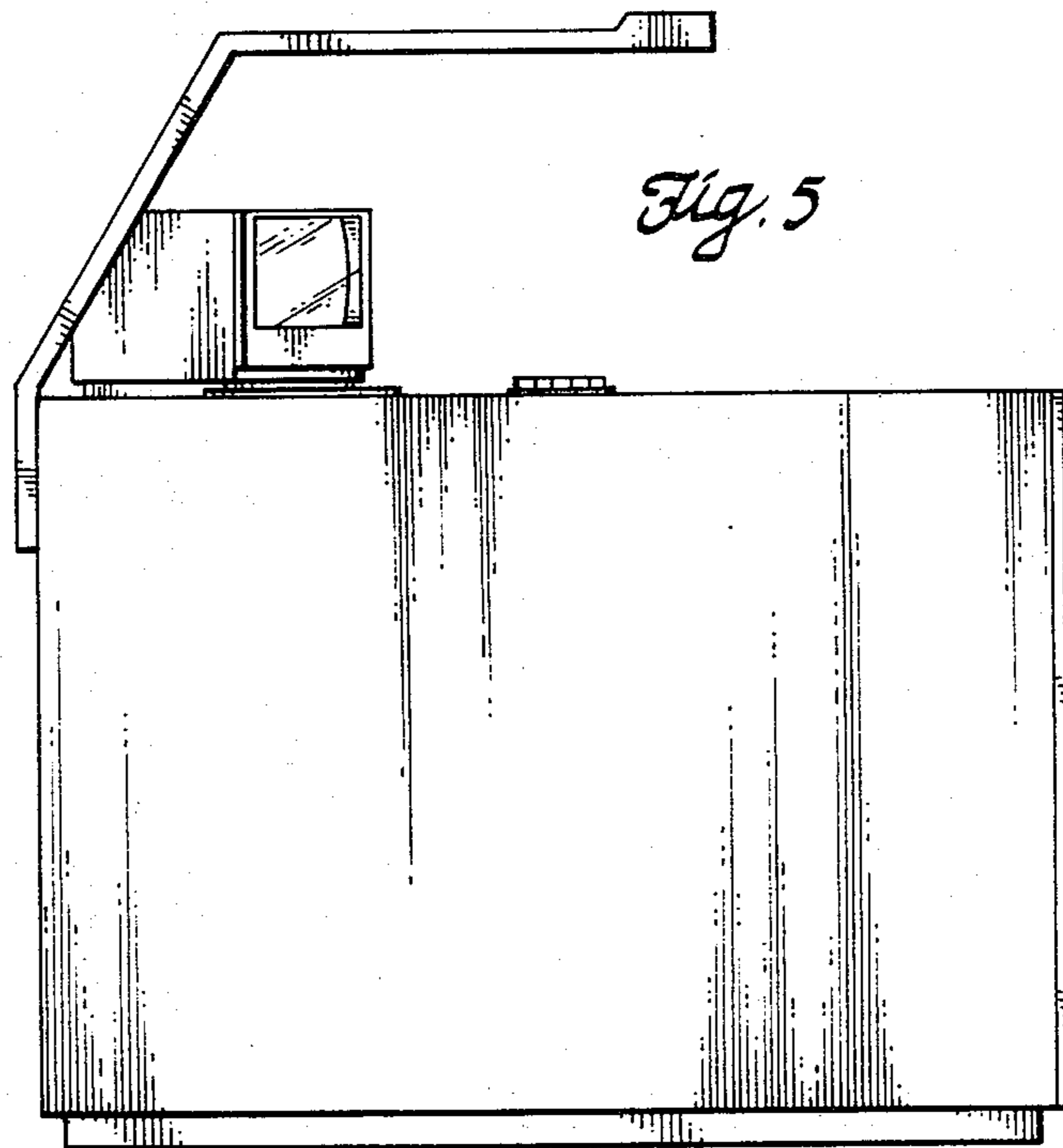
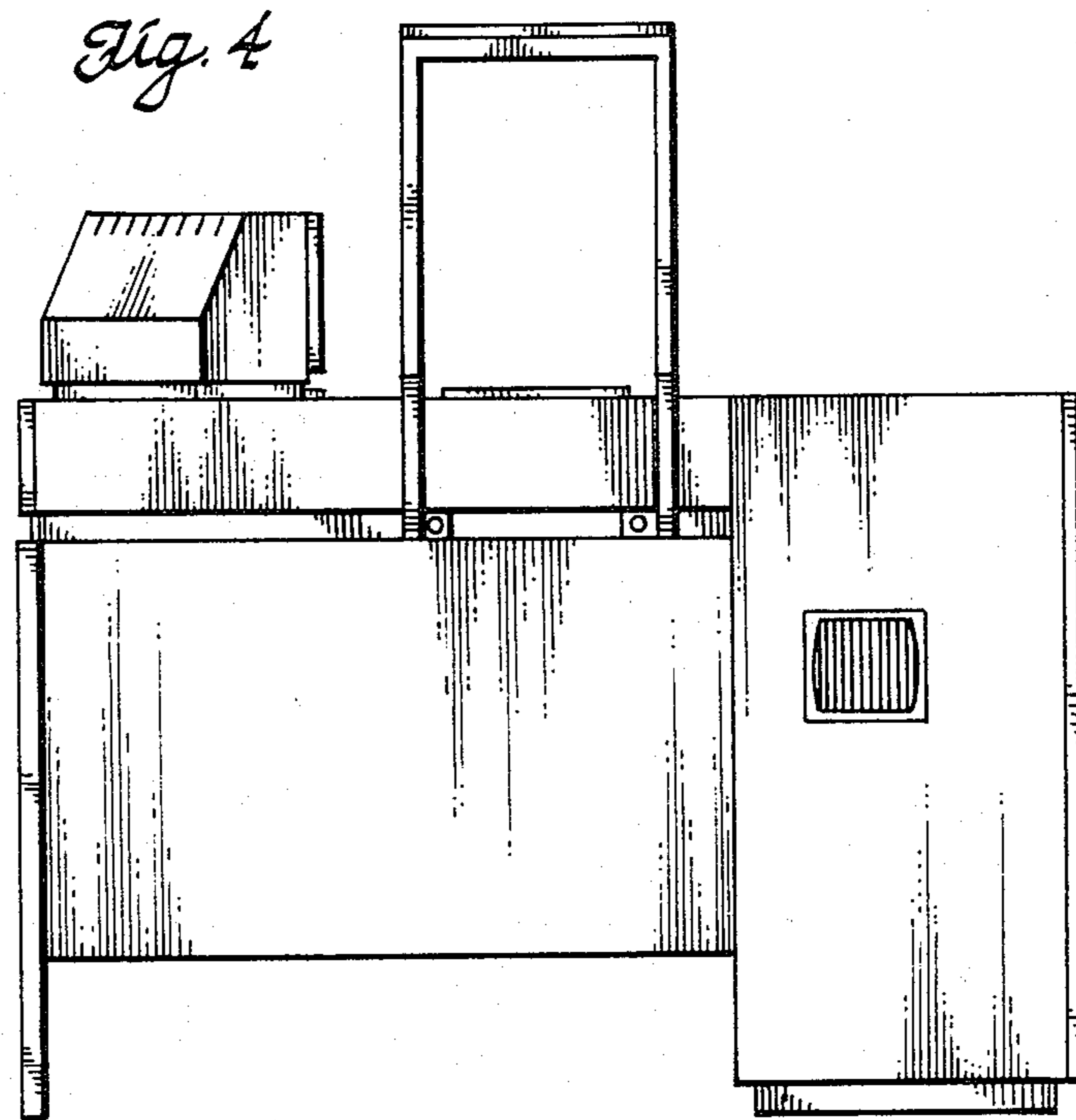

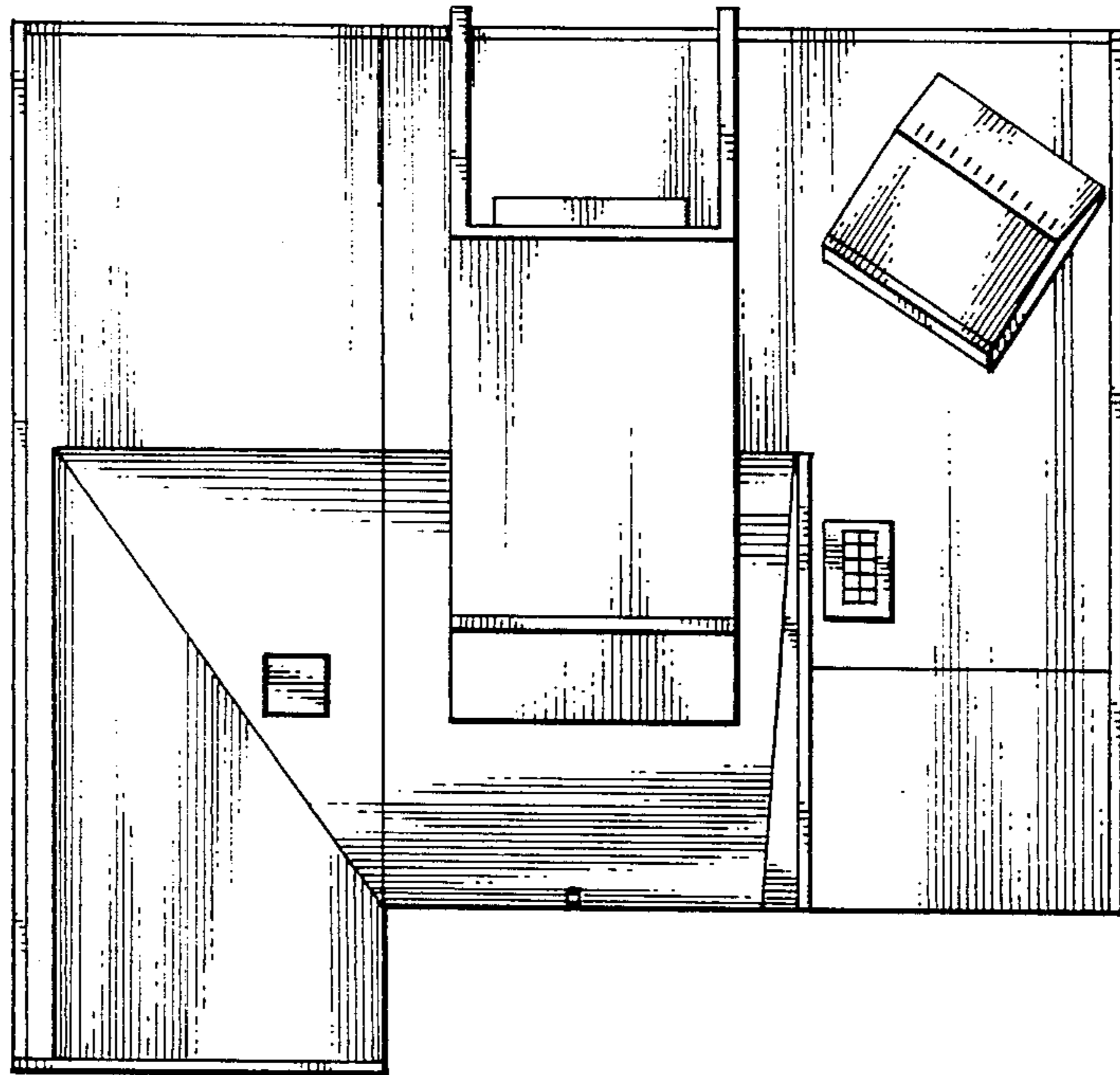
