DESCRIPTION

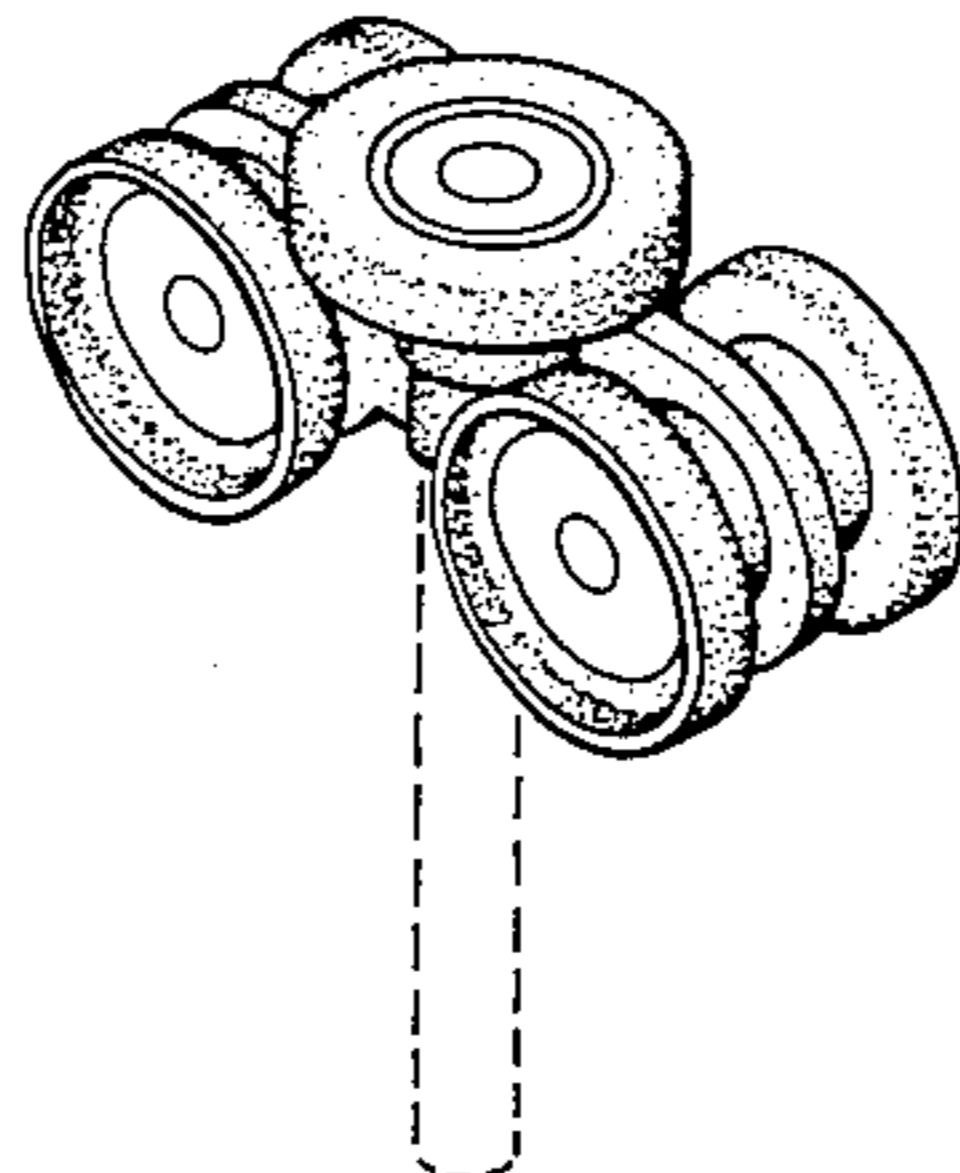
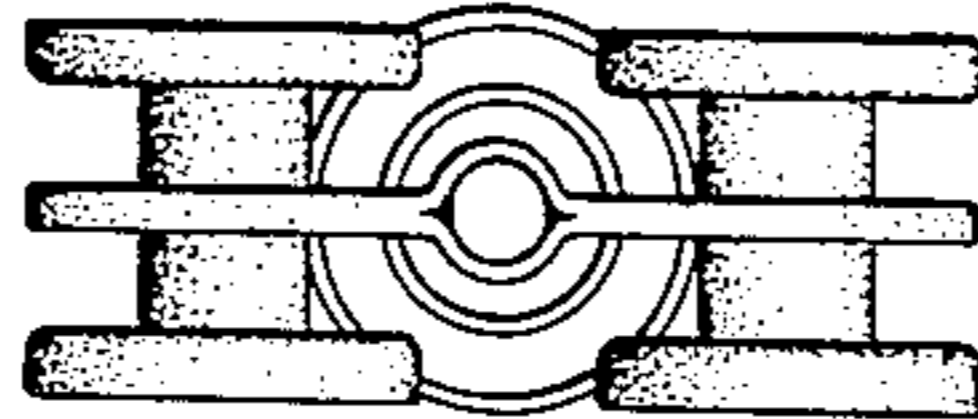
FIG. 1 is a side elevation of a track roller carriage showing my new design with the pendant bolt depicted in broken lines here and in FIGS. 2 and 5 being shown to indicate operative environmental relationship only;

FIG. 5 is a top, front and side perspective view.



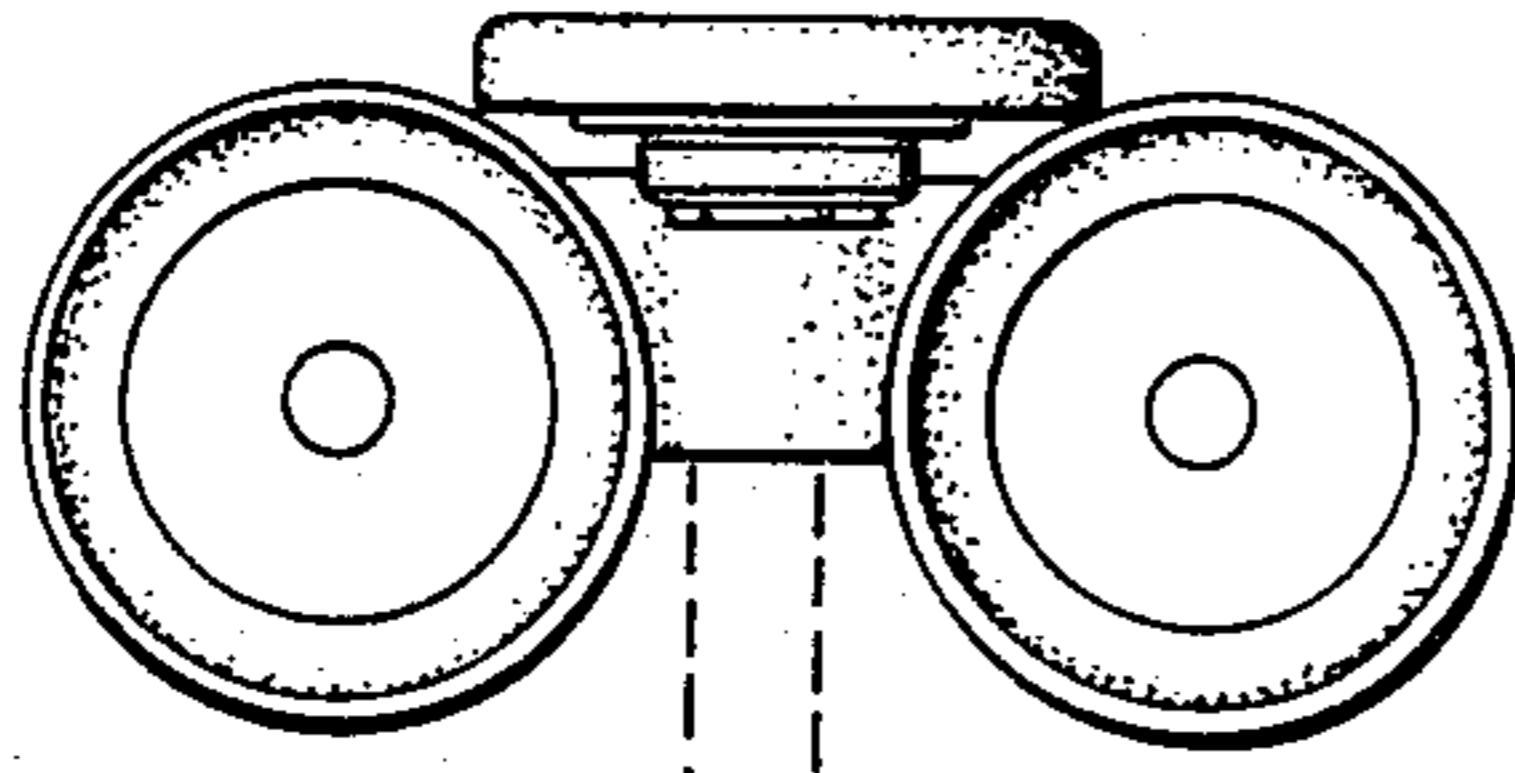

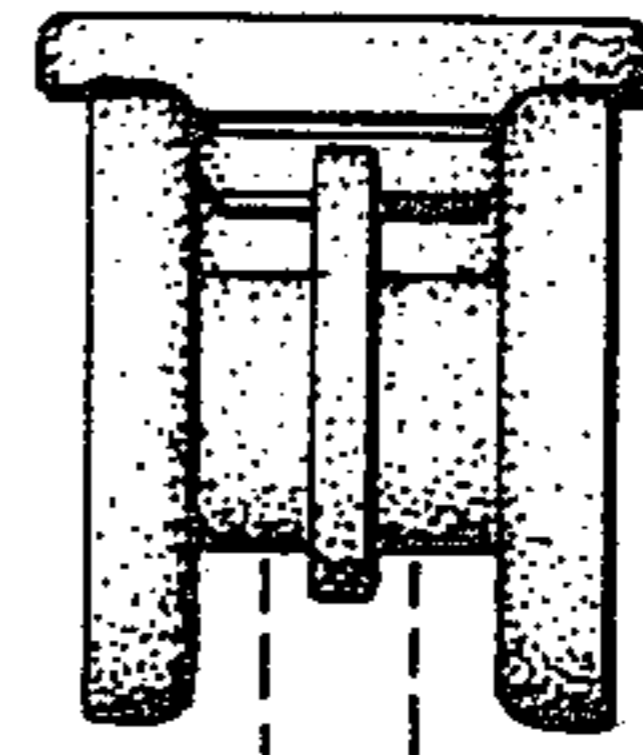

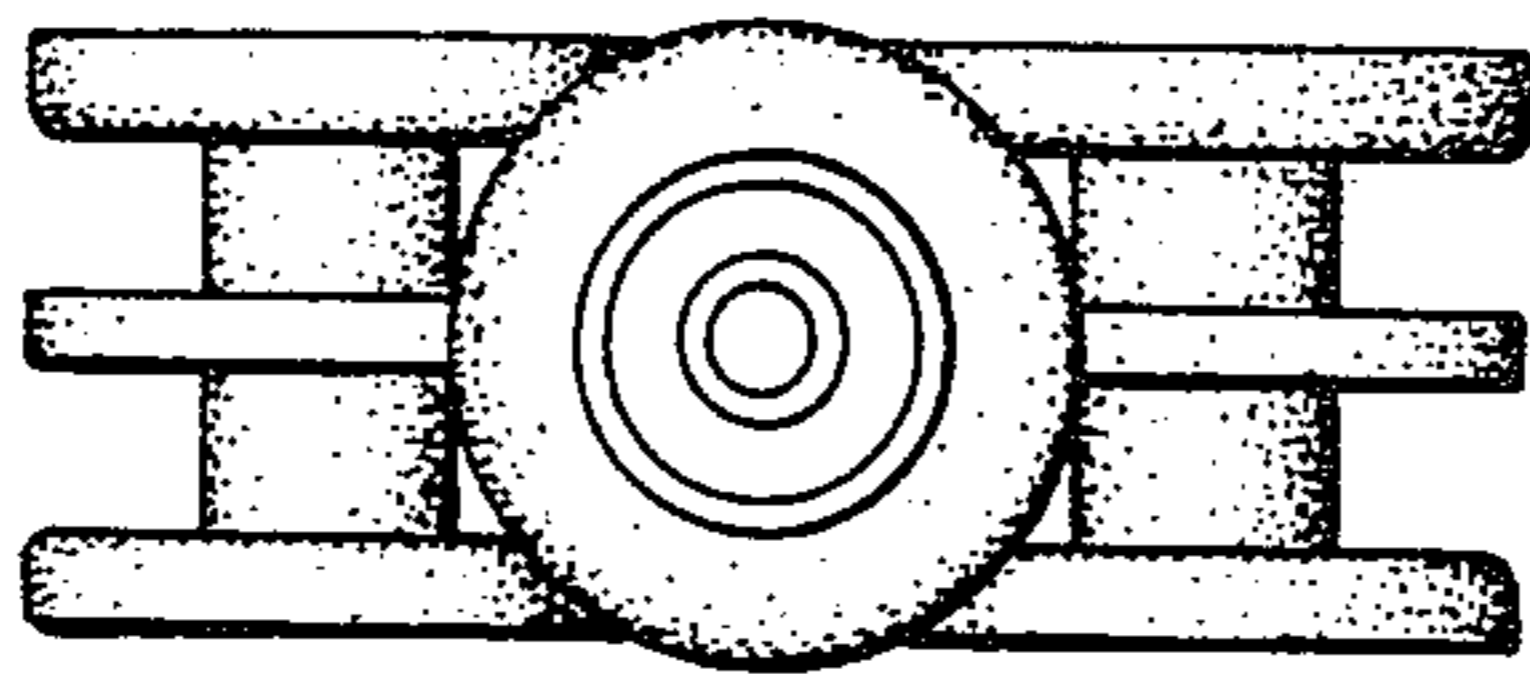

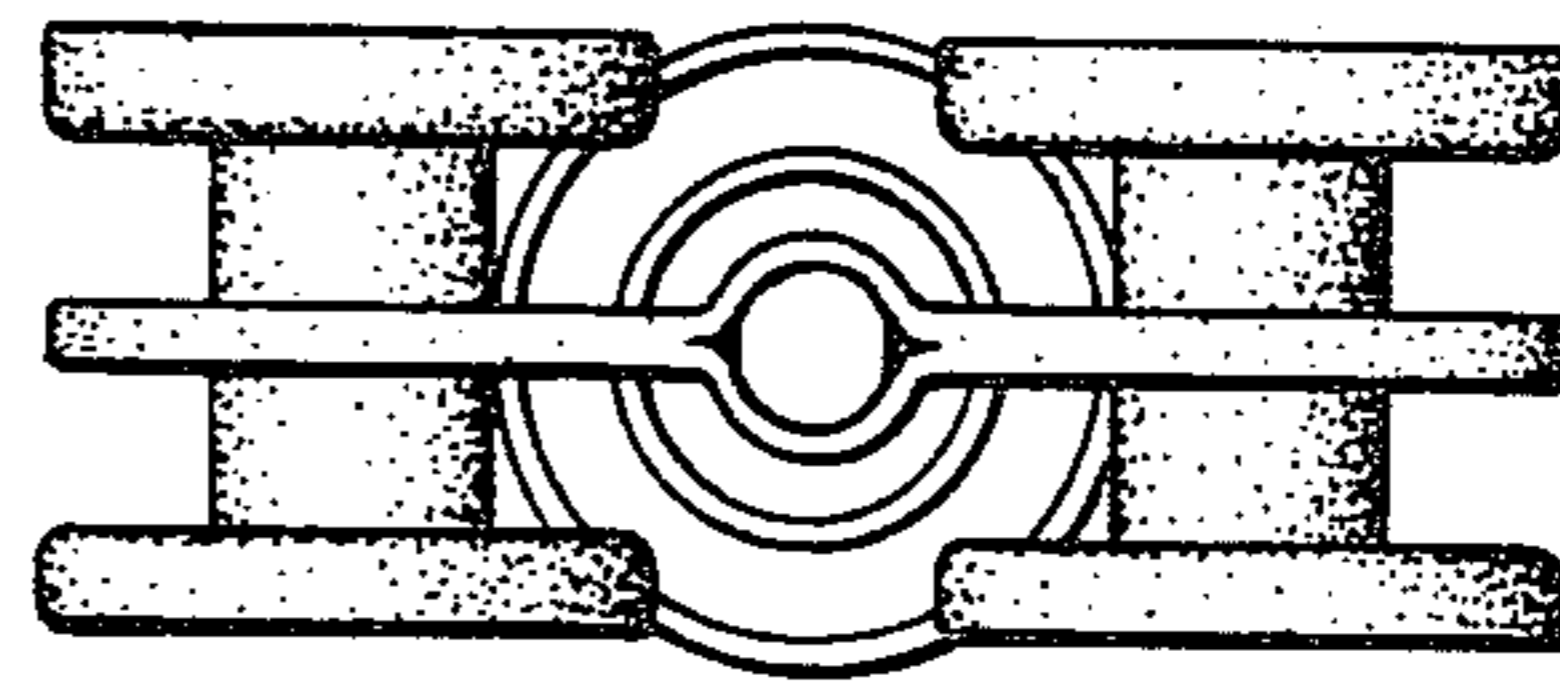

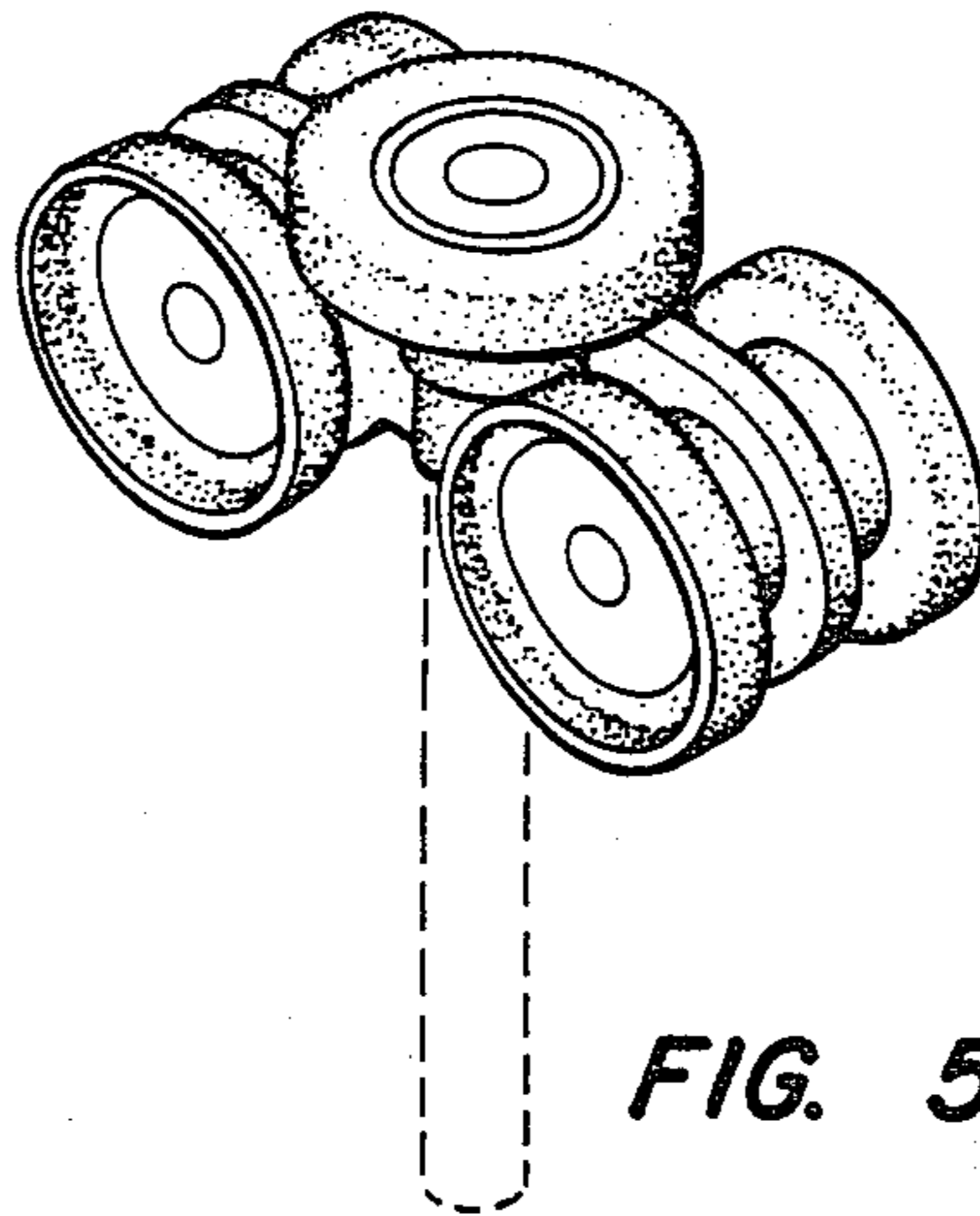
