[57] CLAIM

The ornamental design for a display case for watches or the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right side of a display case for watches or the like showing my new design;

FIG. 2 is a perspective view taken from the bottom, rear and left side thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a cross sectional view taken on line 4—4 of FIG. 3;

FIG. 5 is an enlarged cross sectional view taken on line 5—5 of FIG. 3; and

FIG. 6 is an enlarged front elevational view thereof.

The broken line representation of water and bubbles in FIGS. 5 and 6 are for purposes of illustration only.

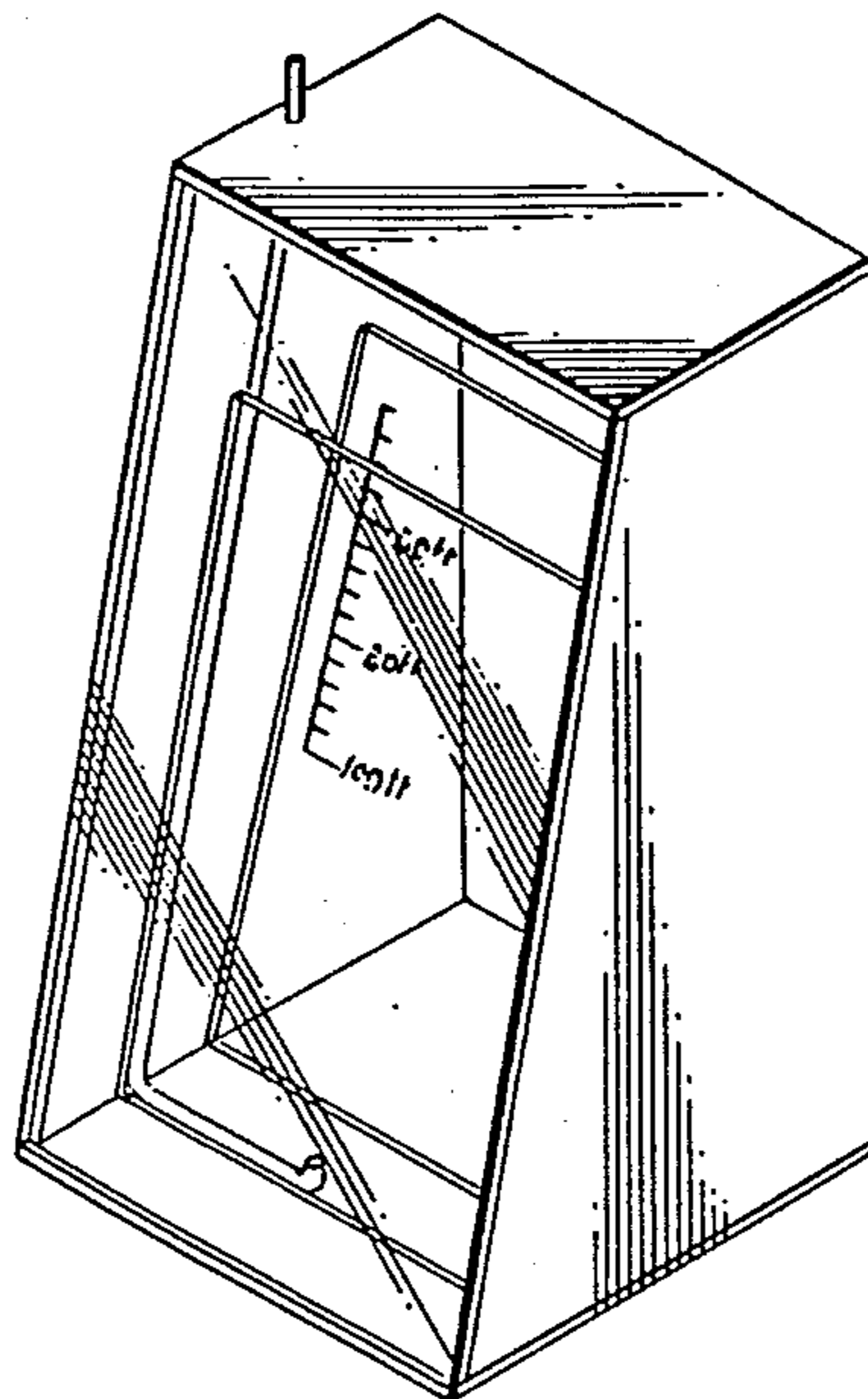

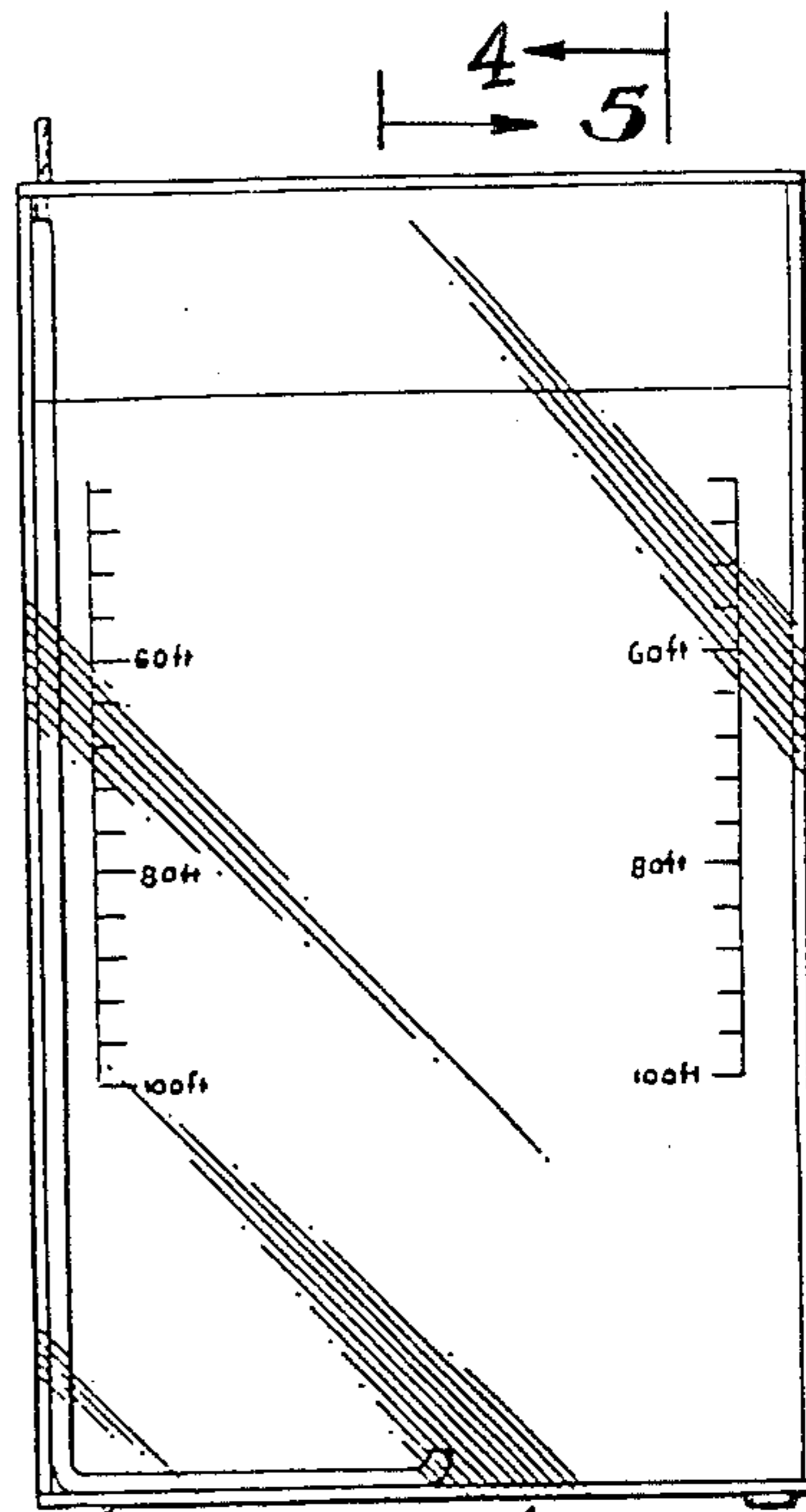
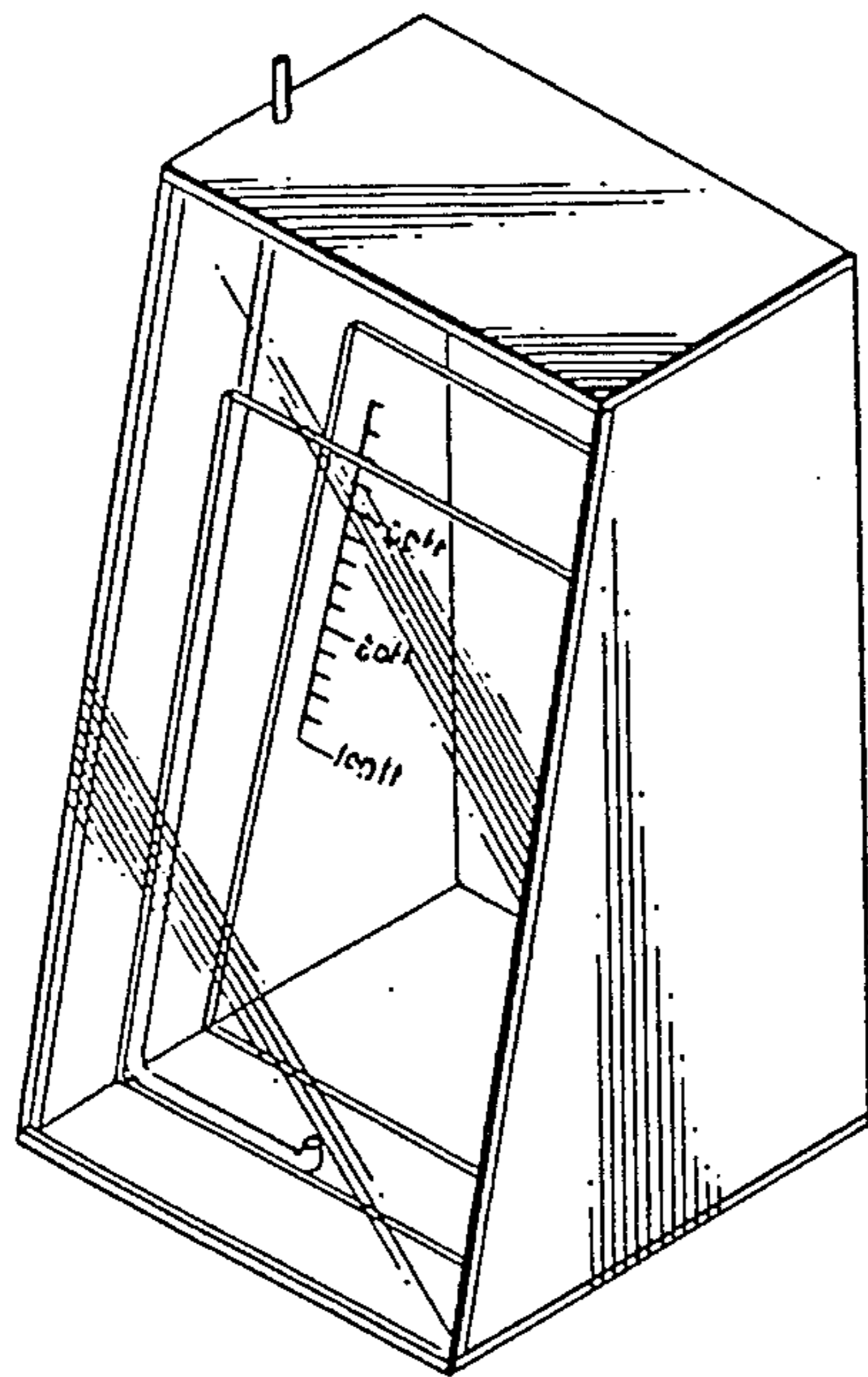

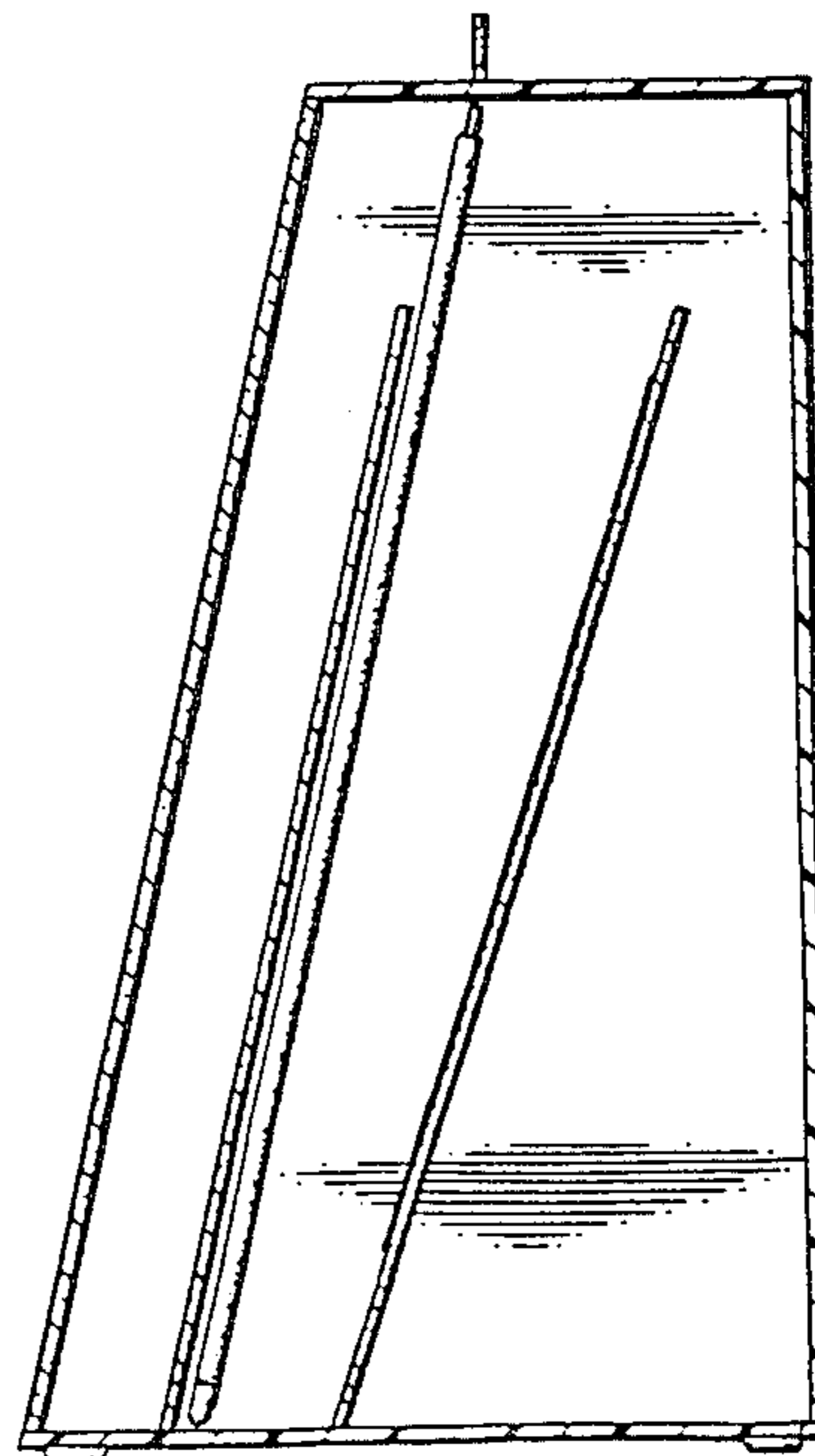
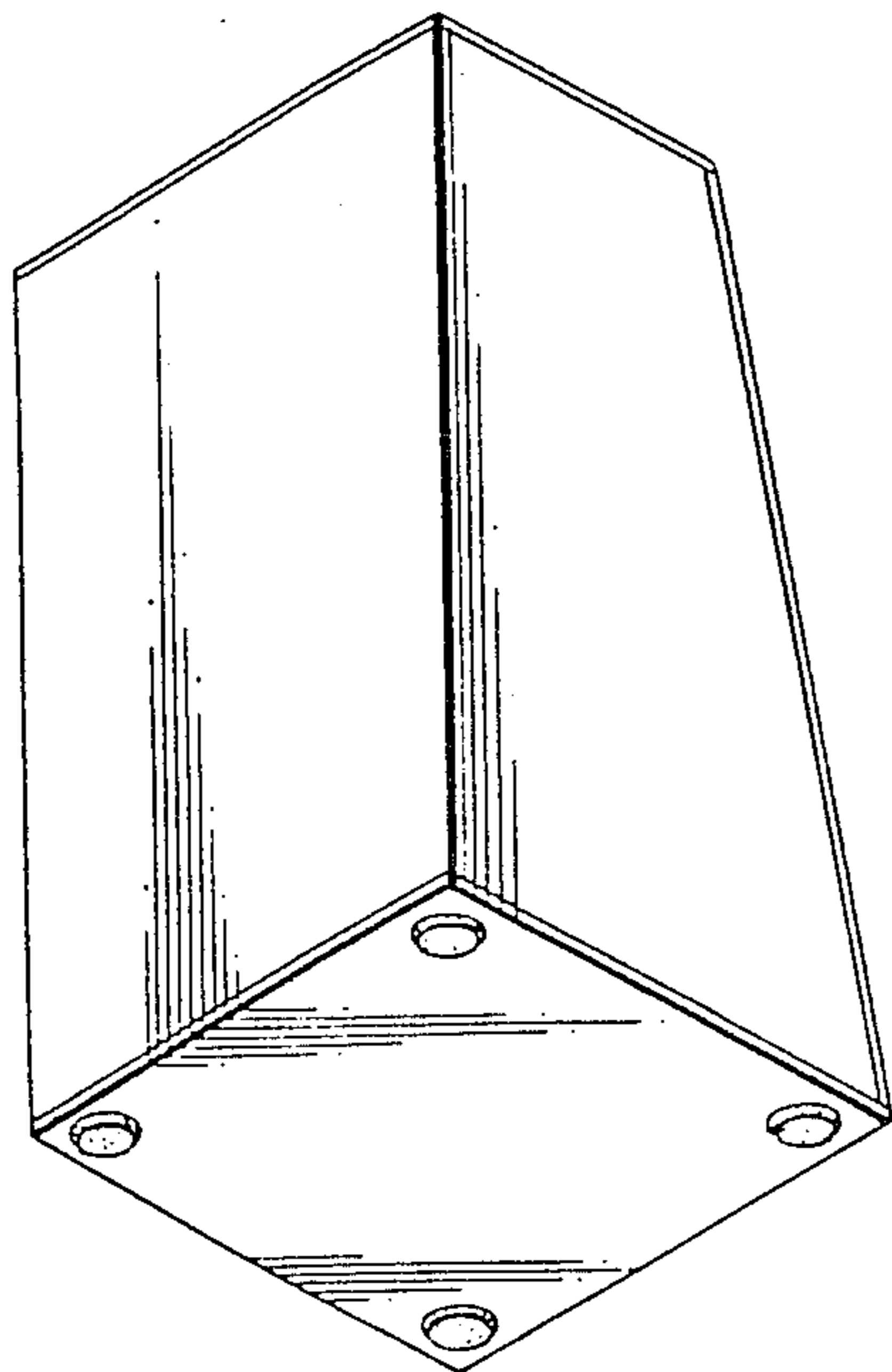
