FIG. 10 is a side view thereof;

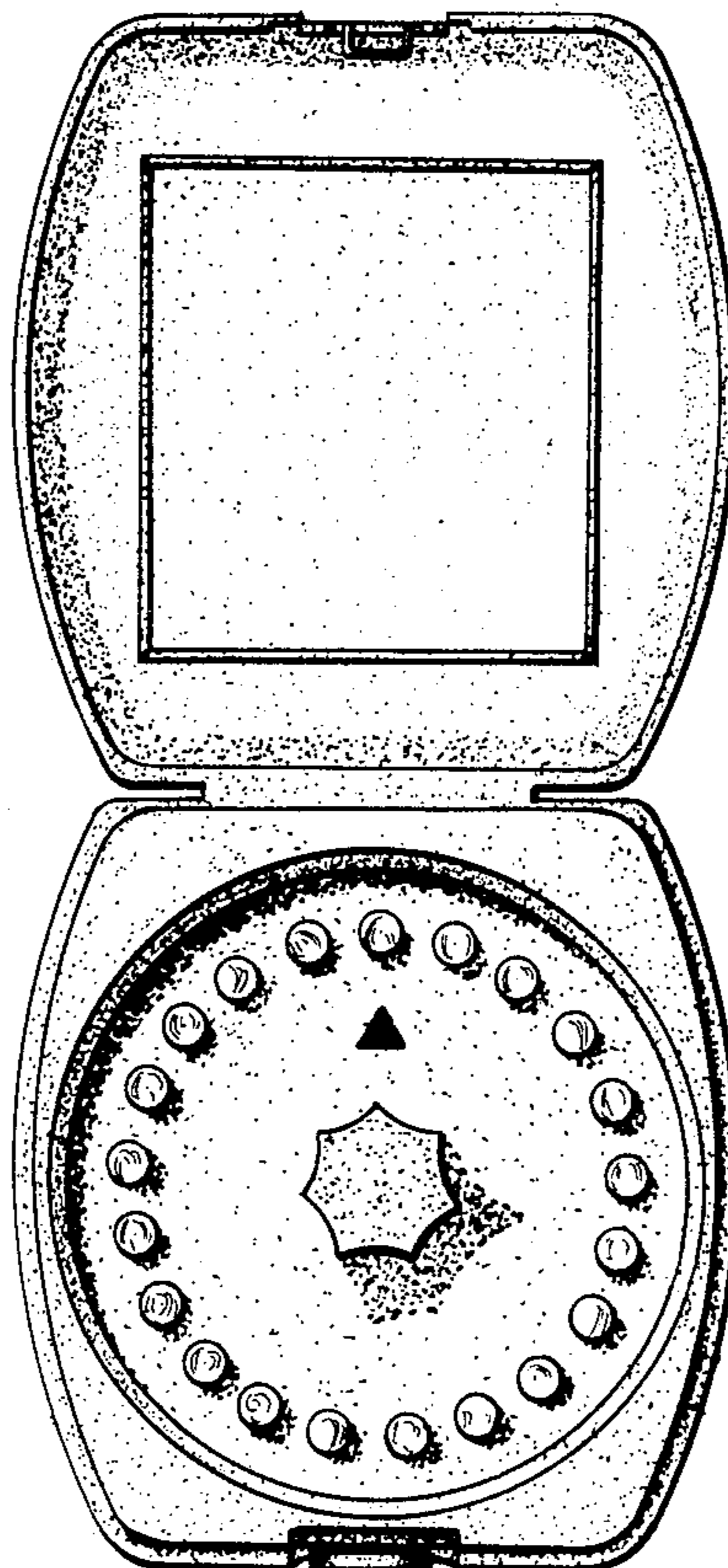
FIG. 11 is a bottom plan view thereof in a closed position;

FIG. 15 is a perspective view of the bottom plan view of the modified form of my new design as shown in FIG. 11.



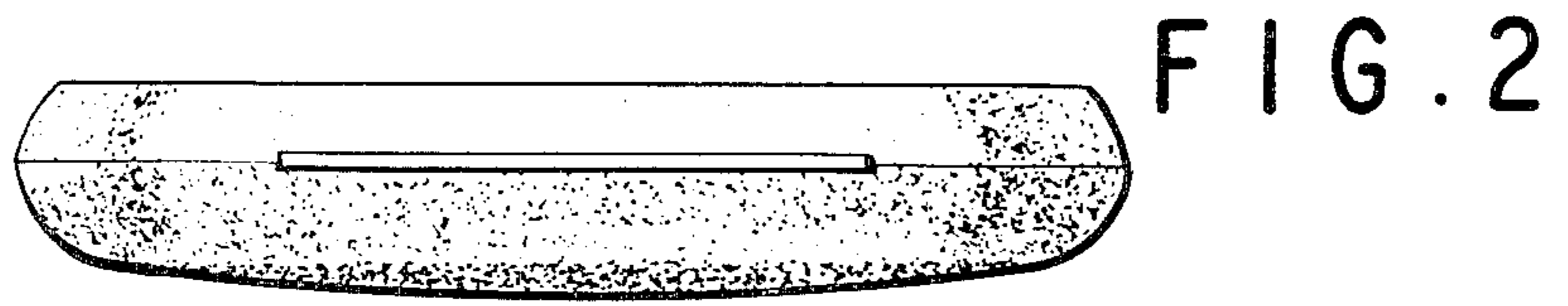

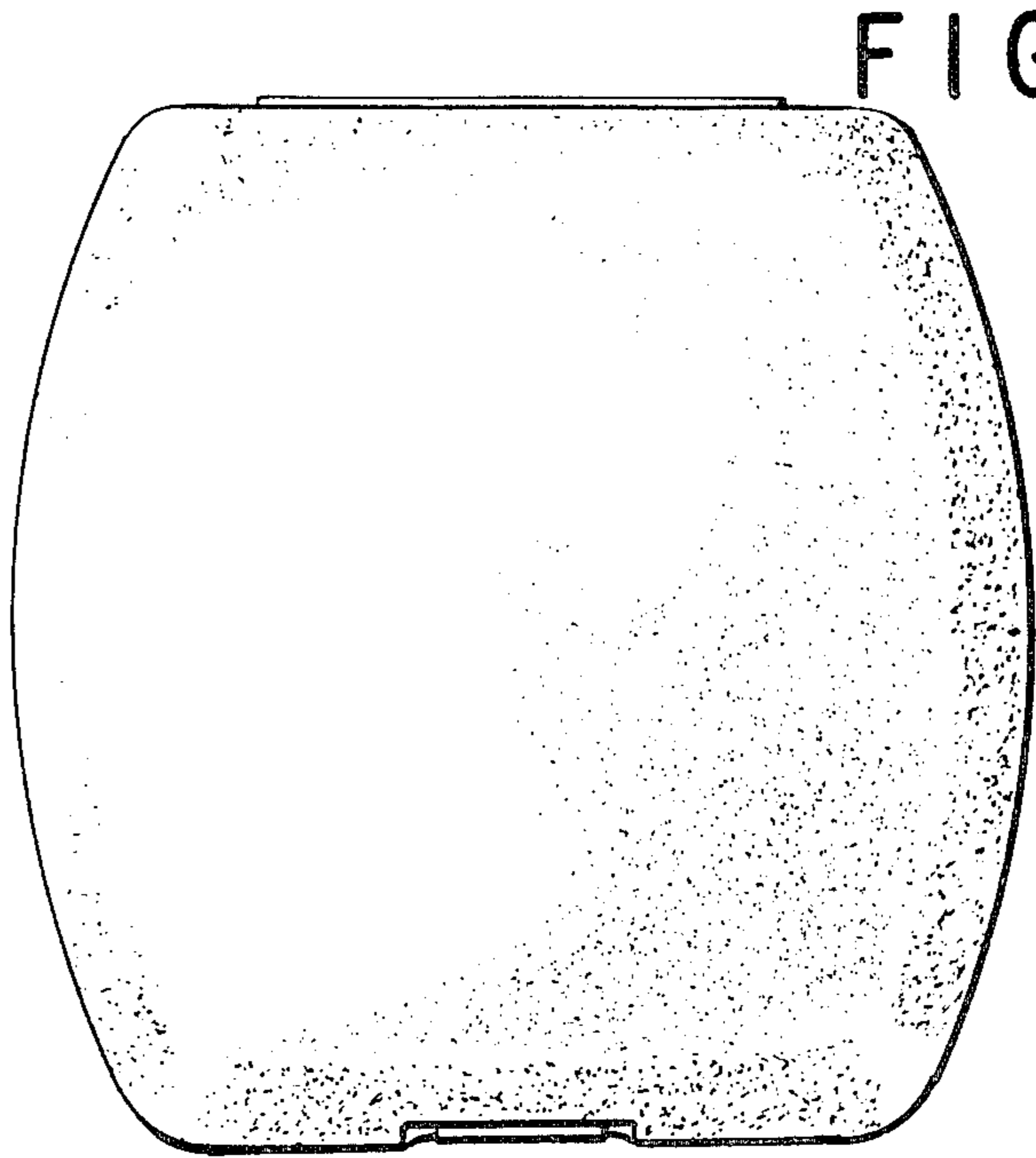

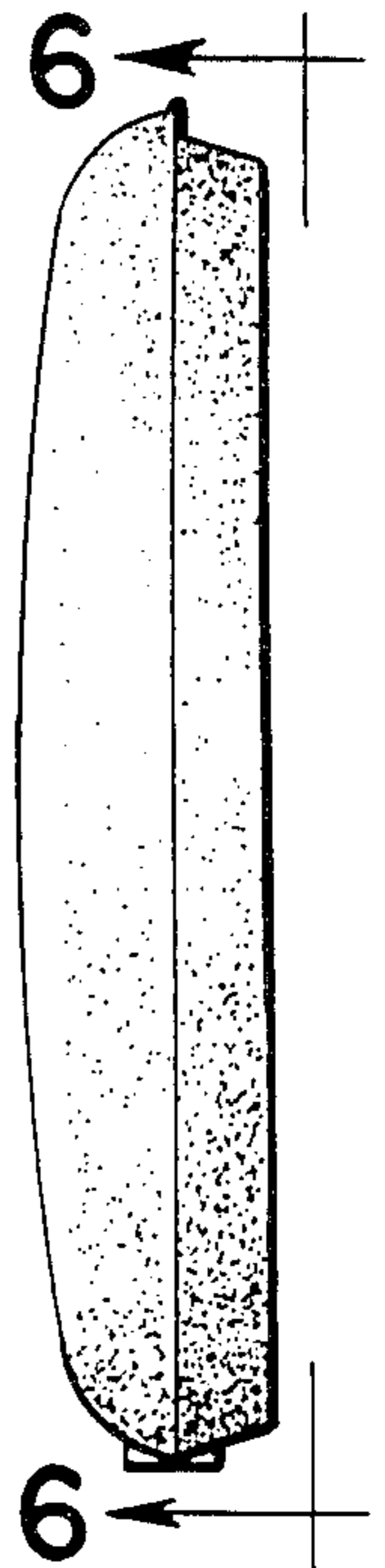

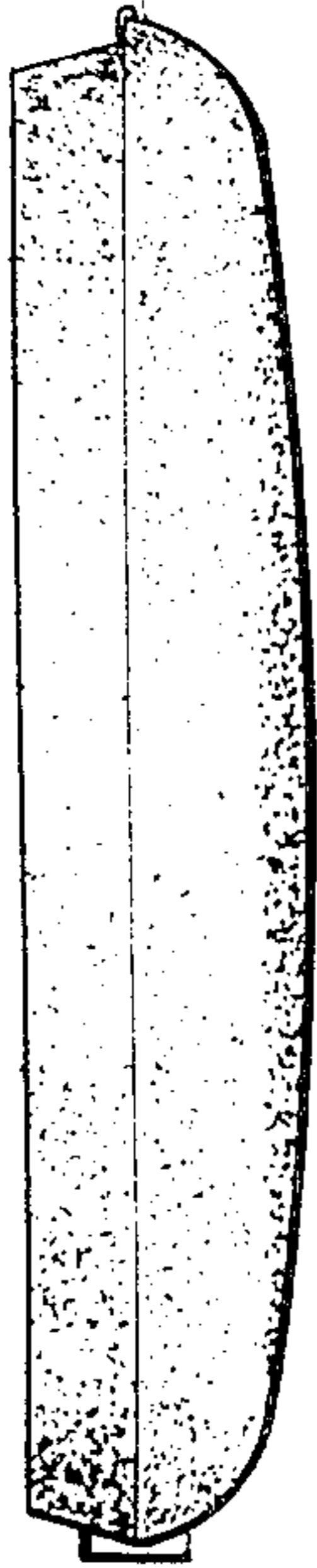

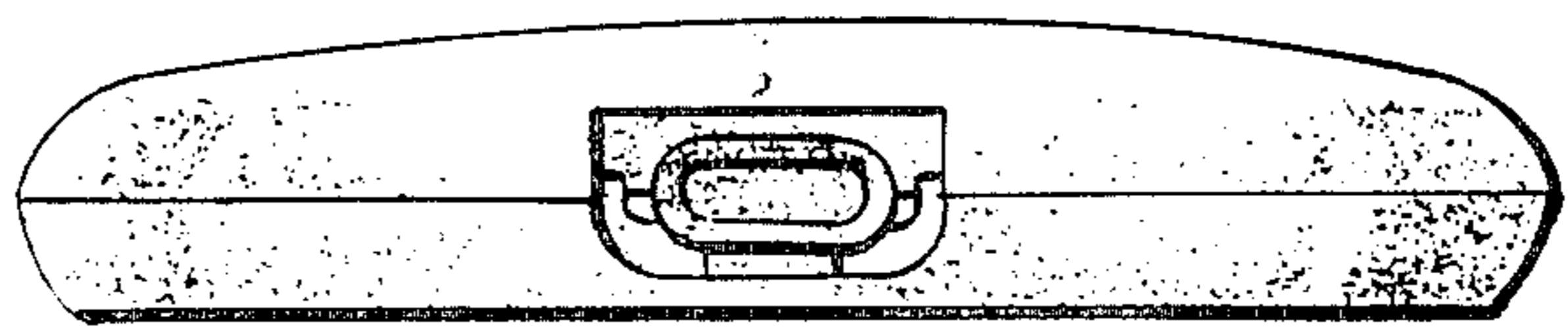

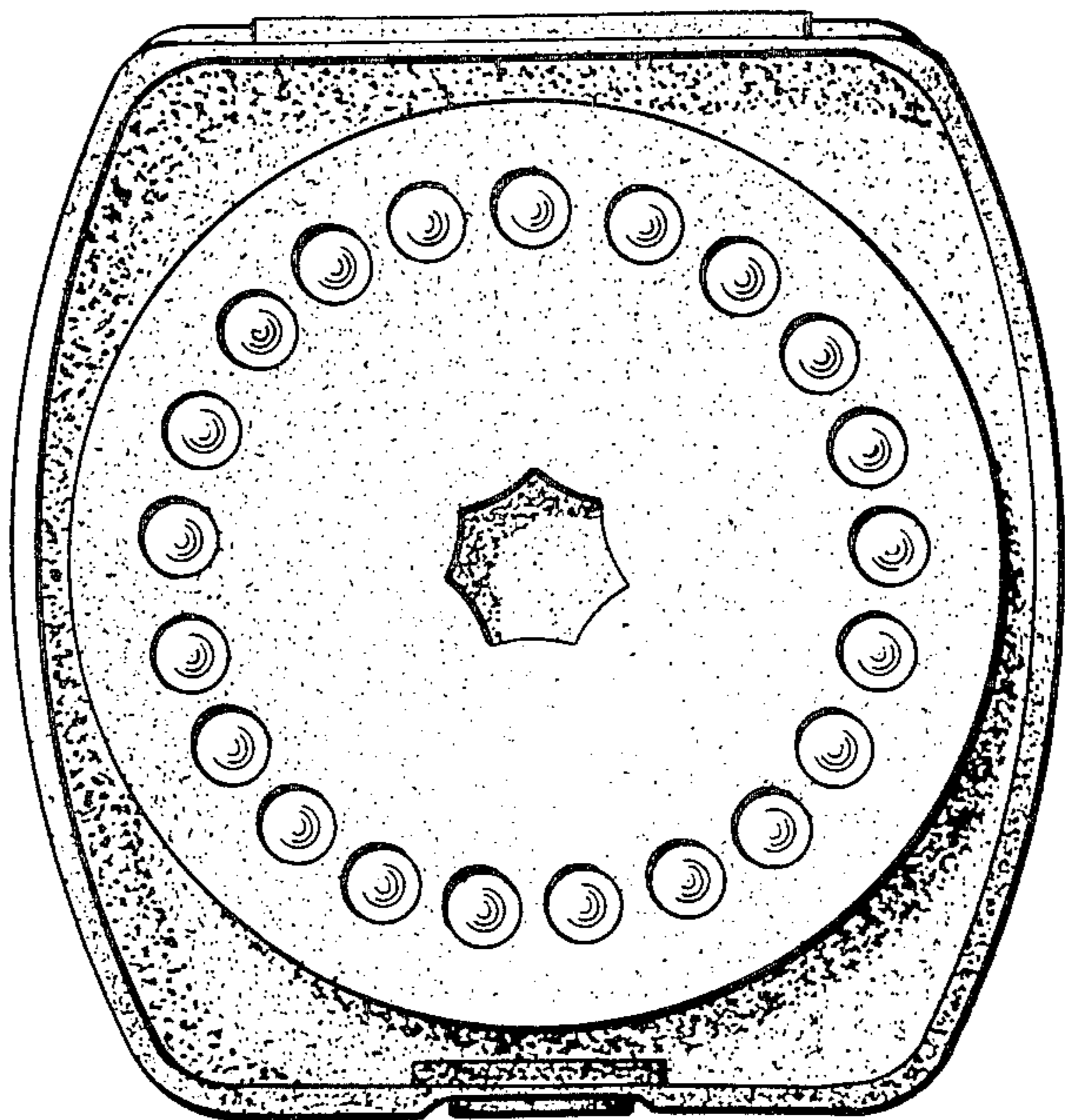

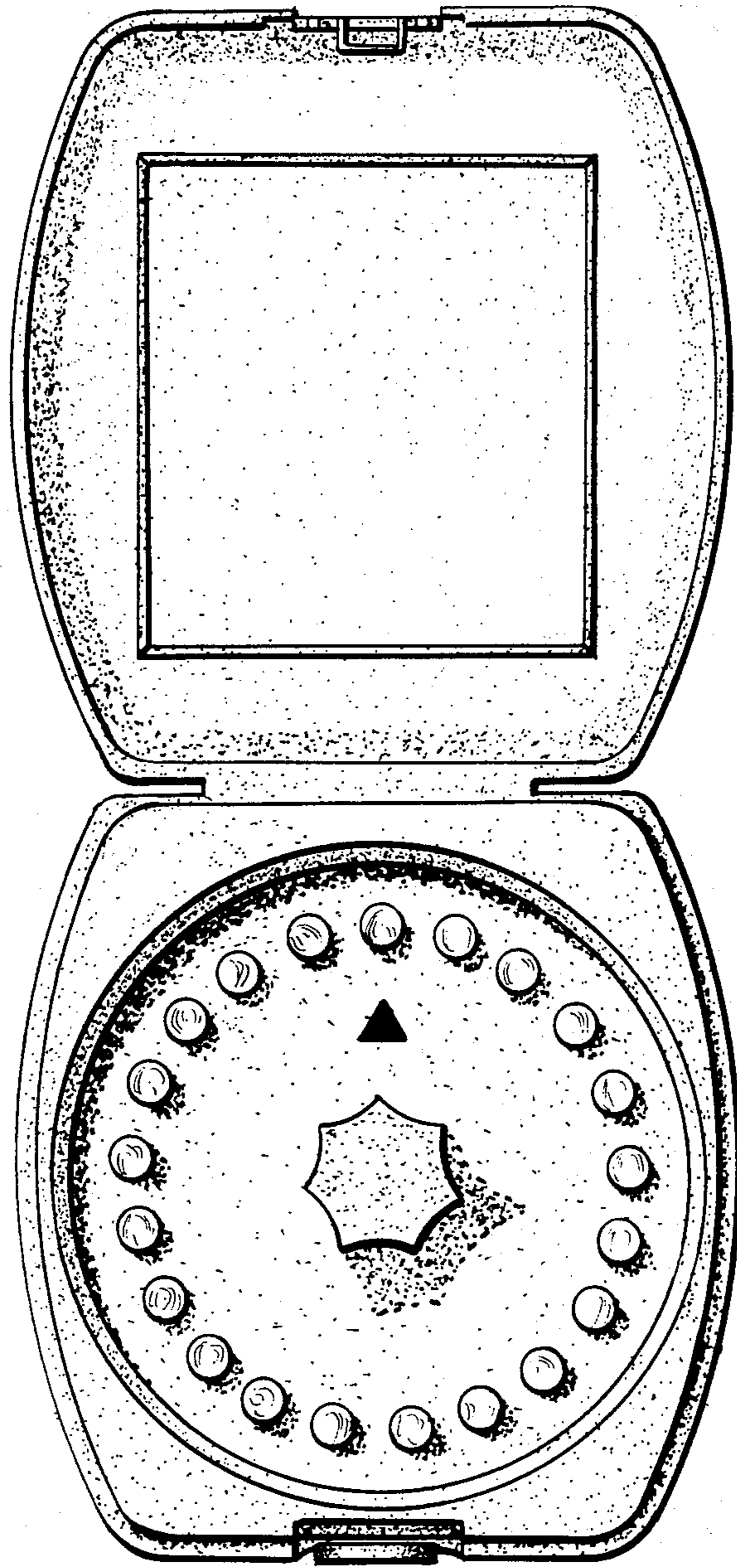

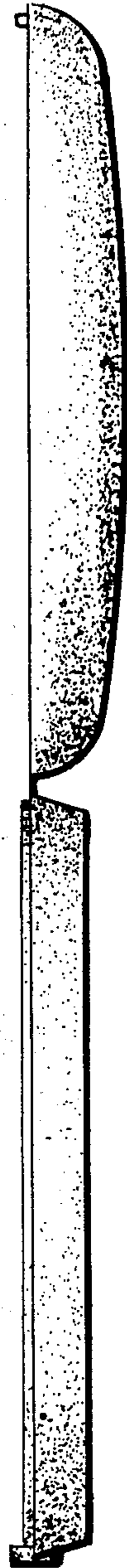

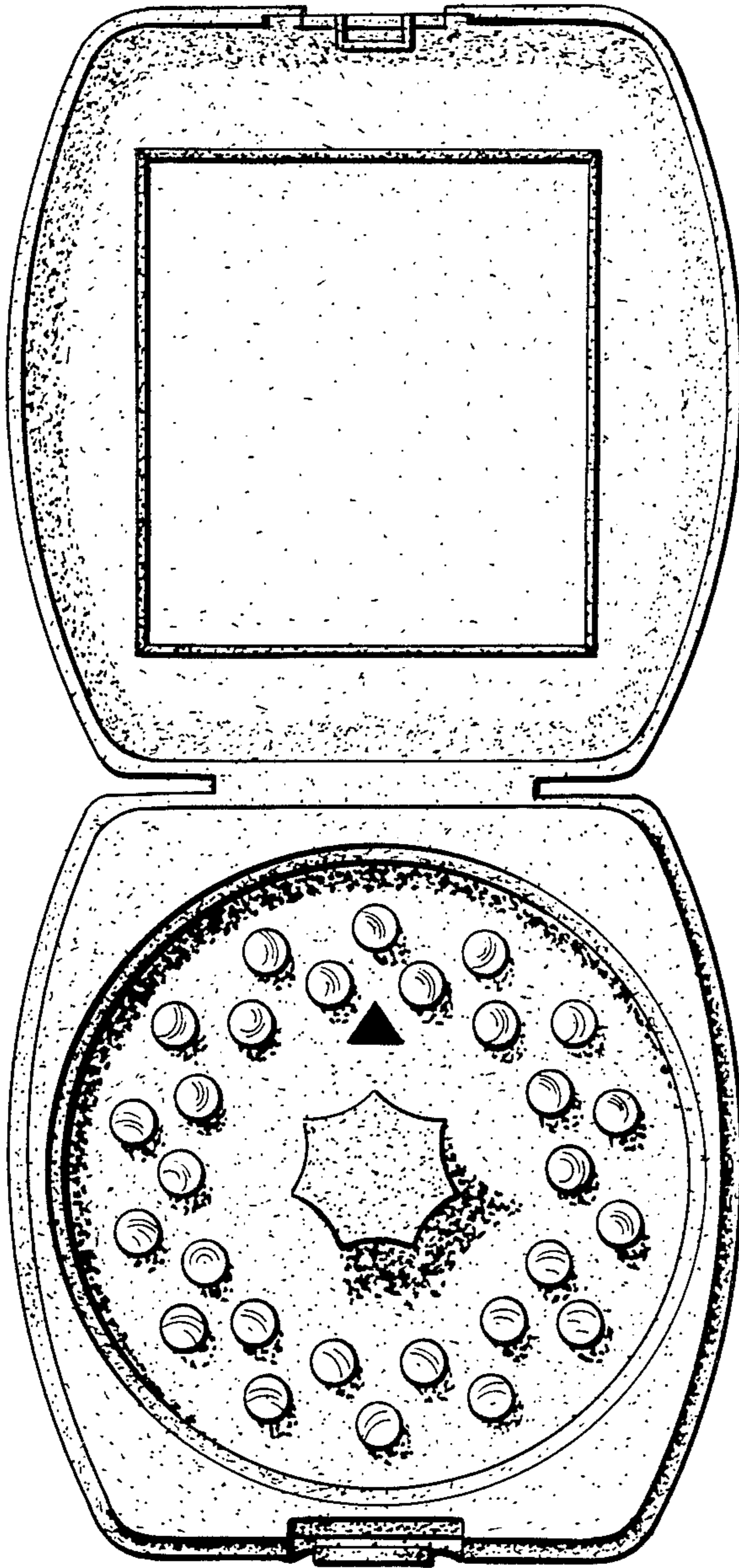

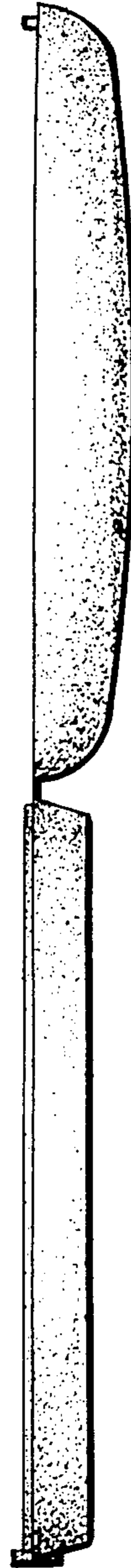

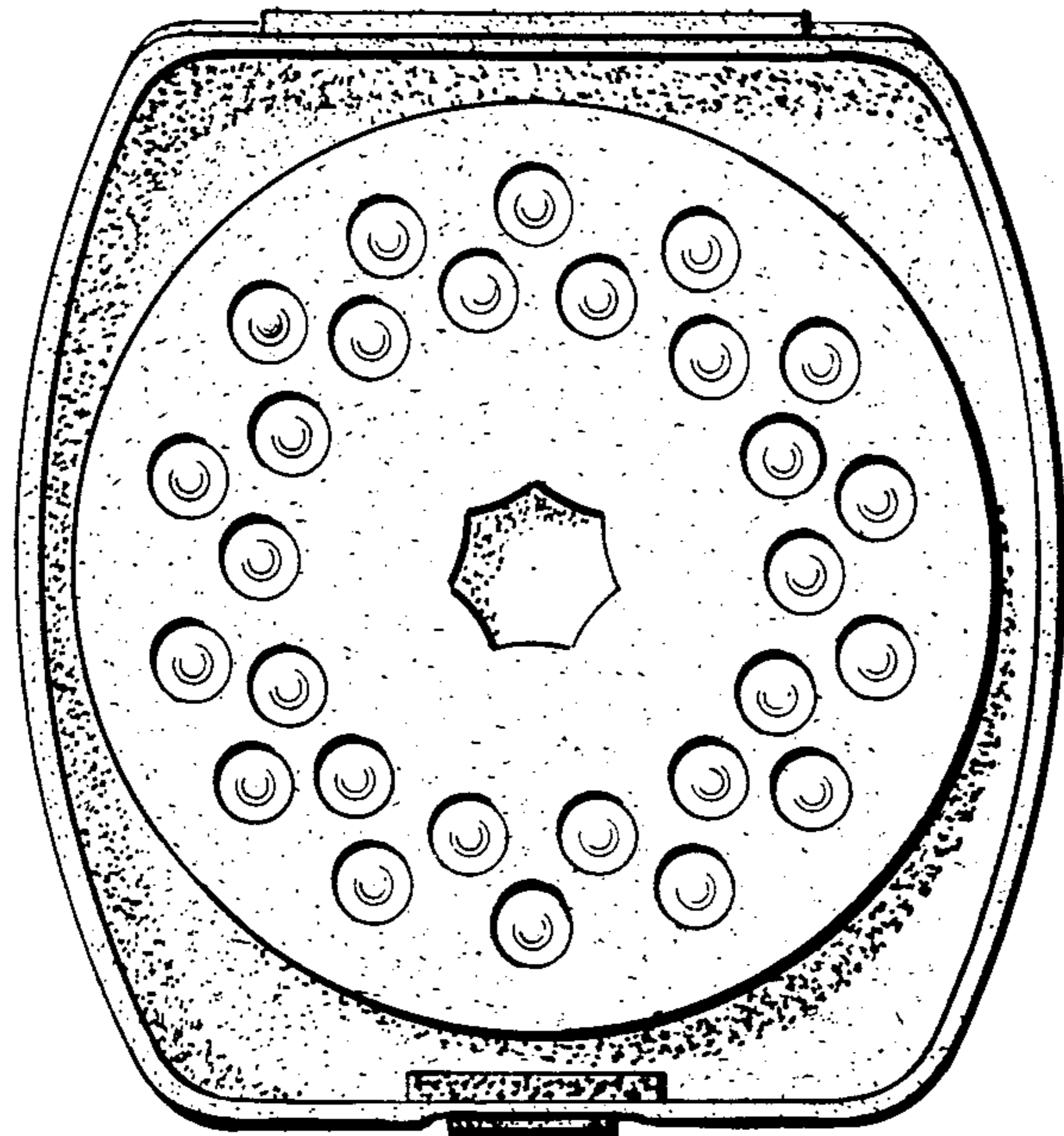

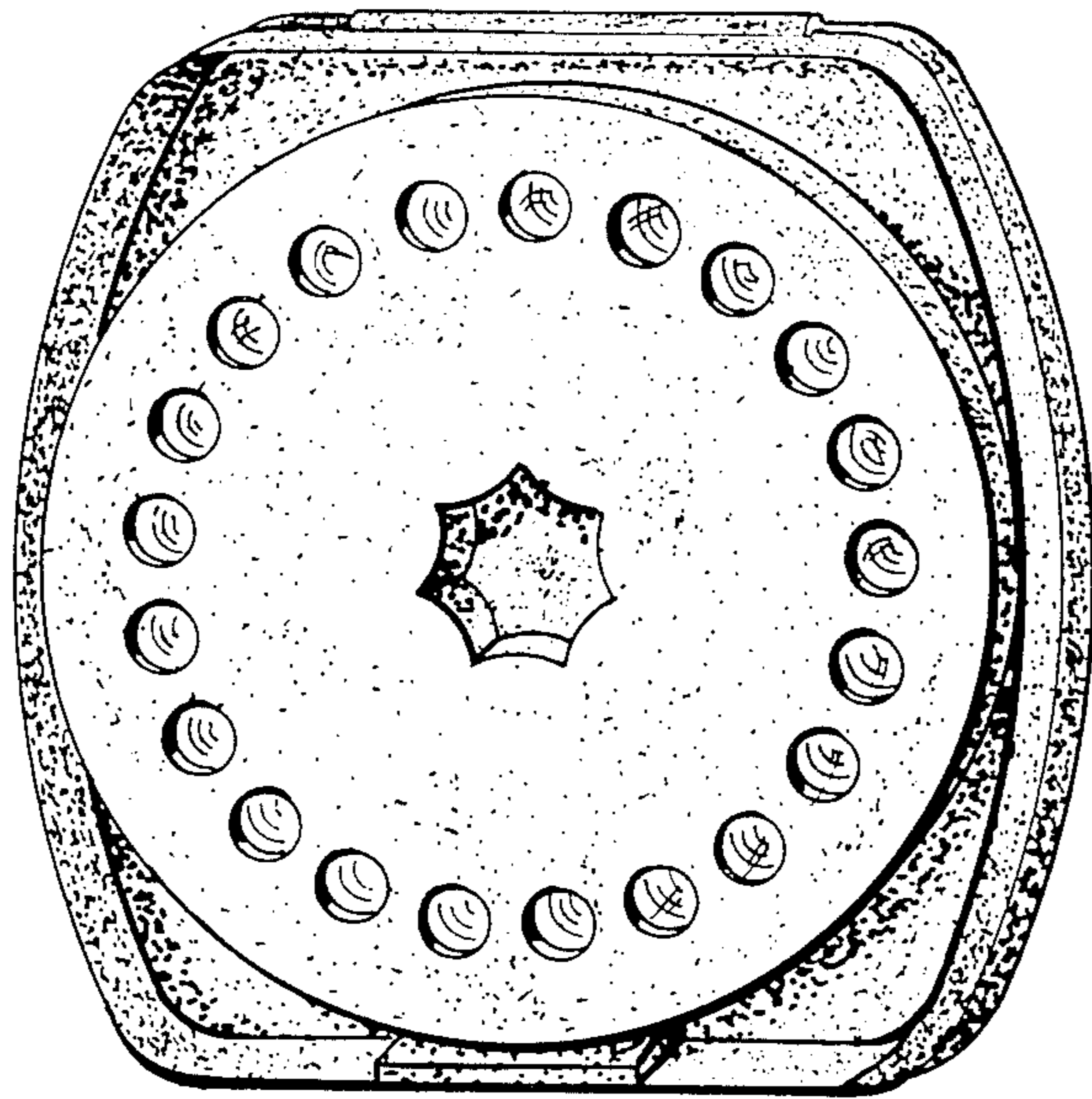

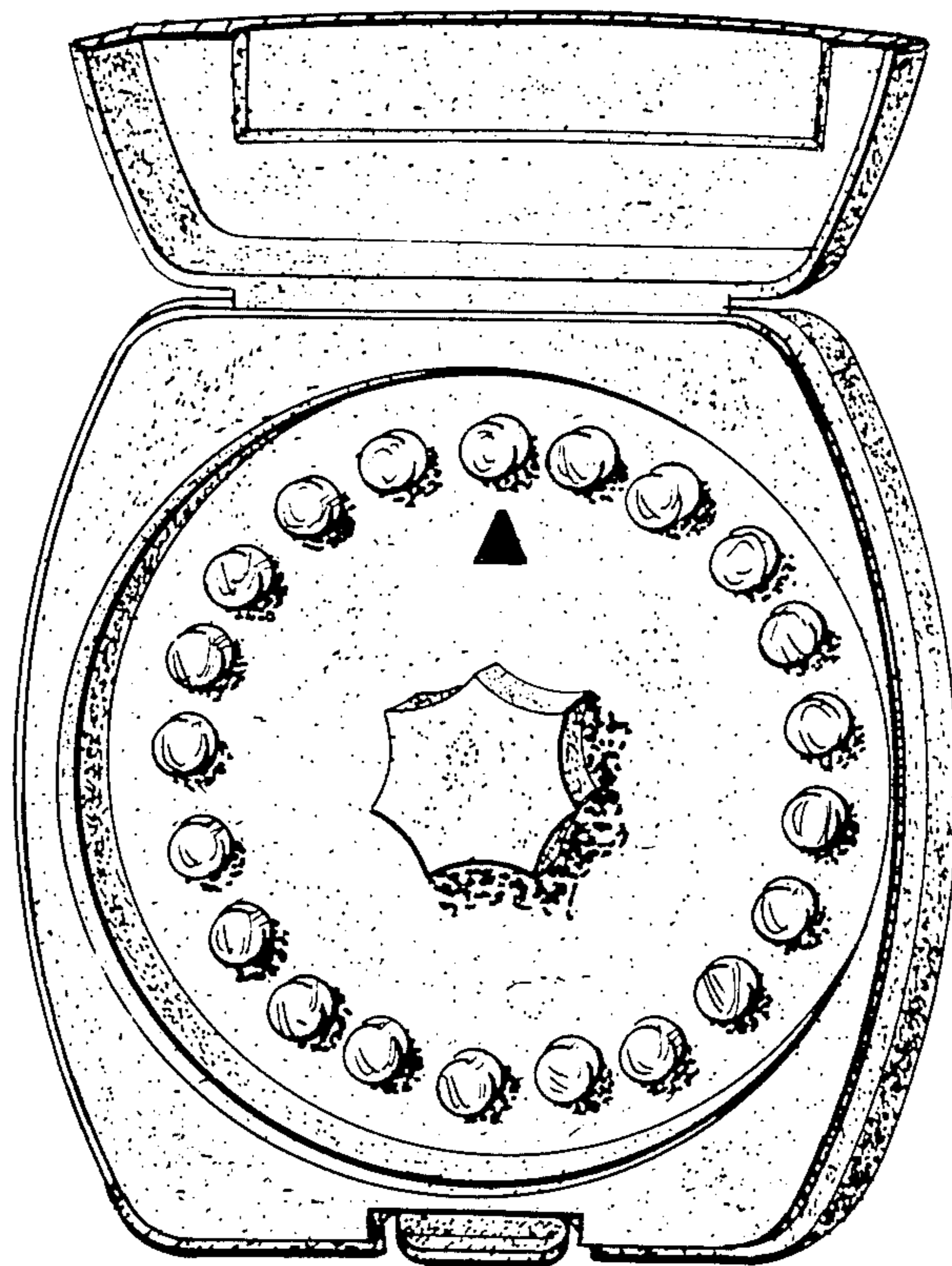

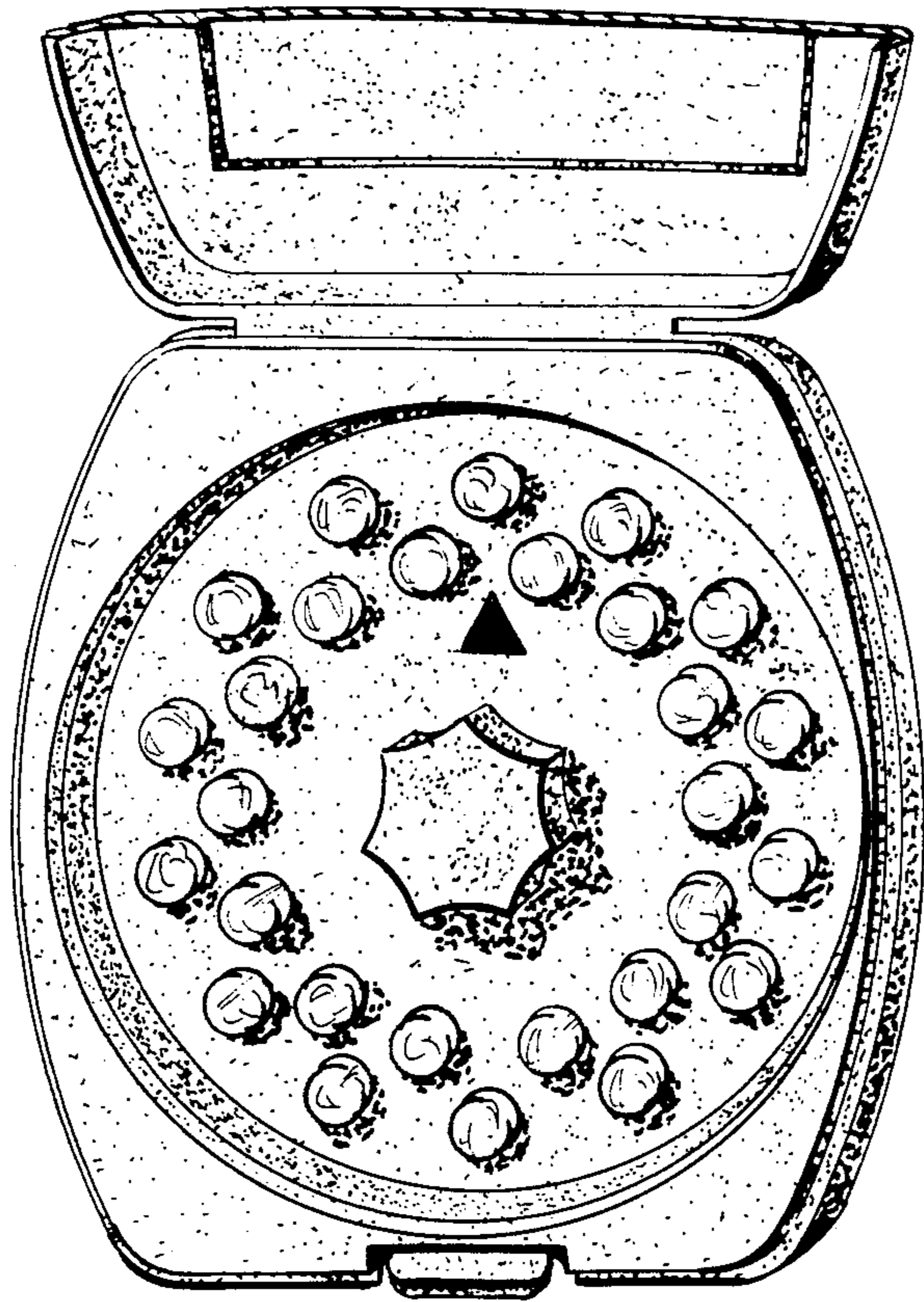

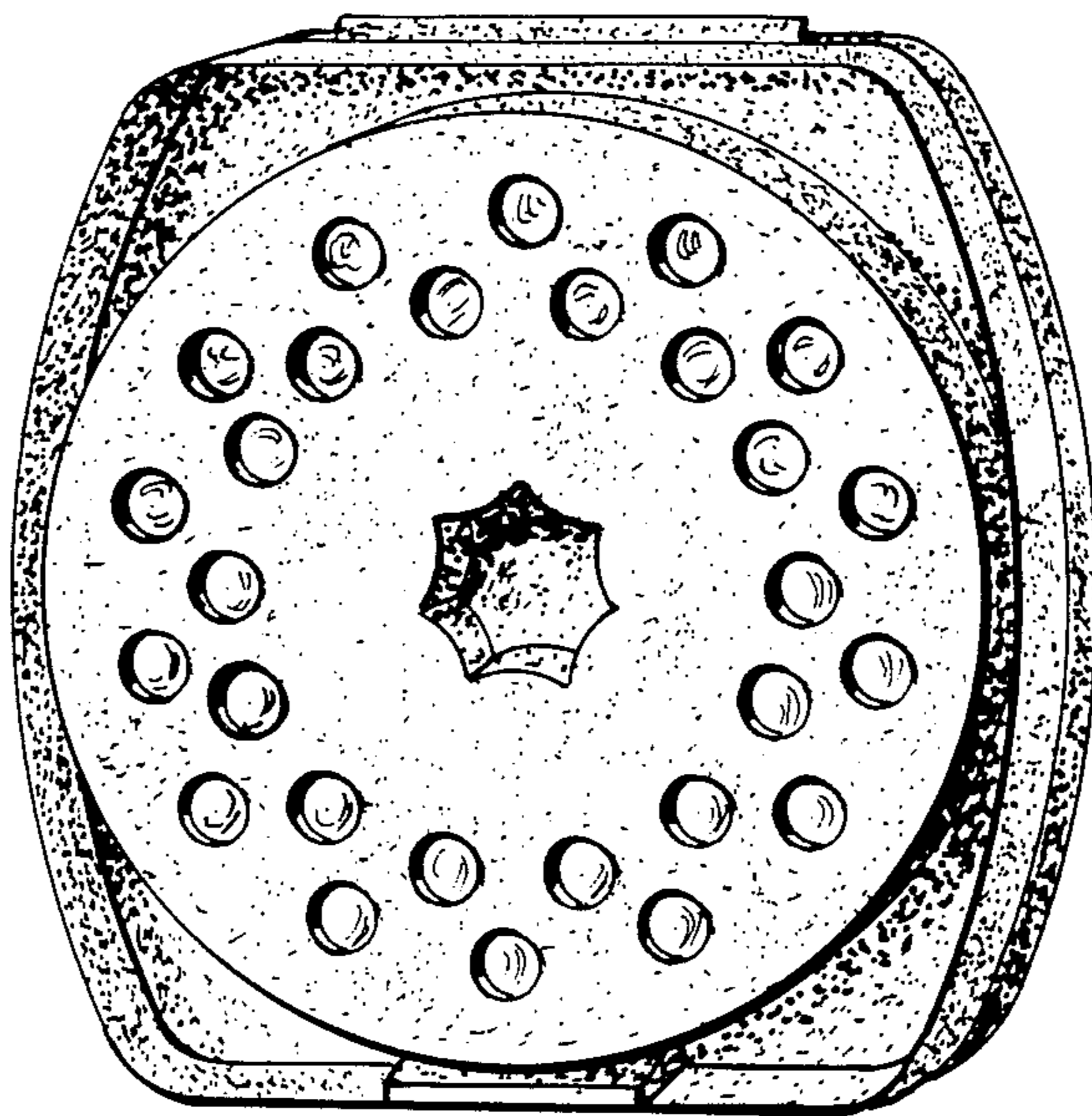
