DESCRIPTION

FIG. 13 is a right side elevational view of a third embodiment of the combined pen and holder therefor showing my new design;

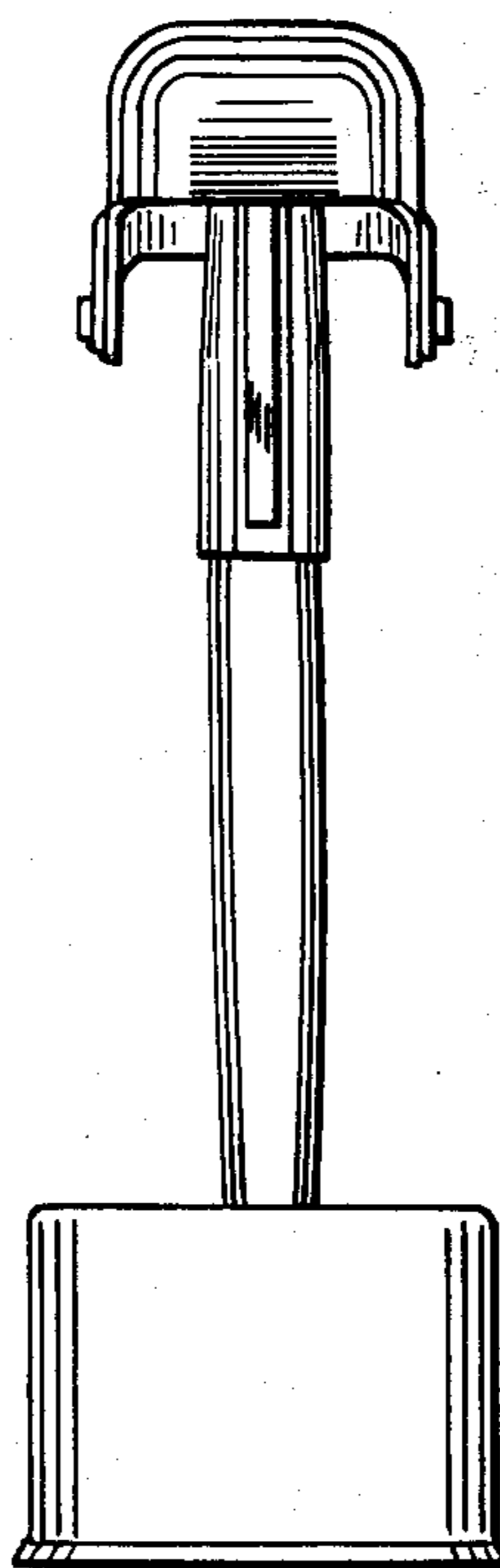
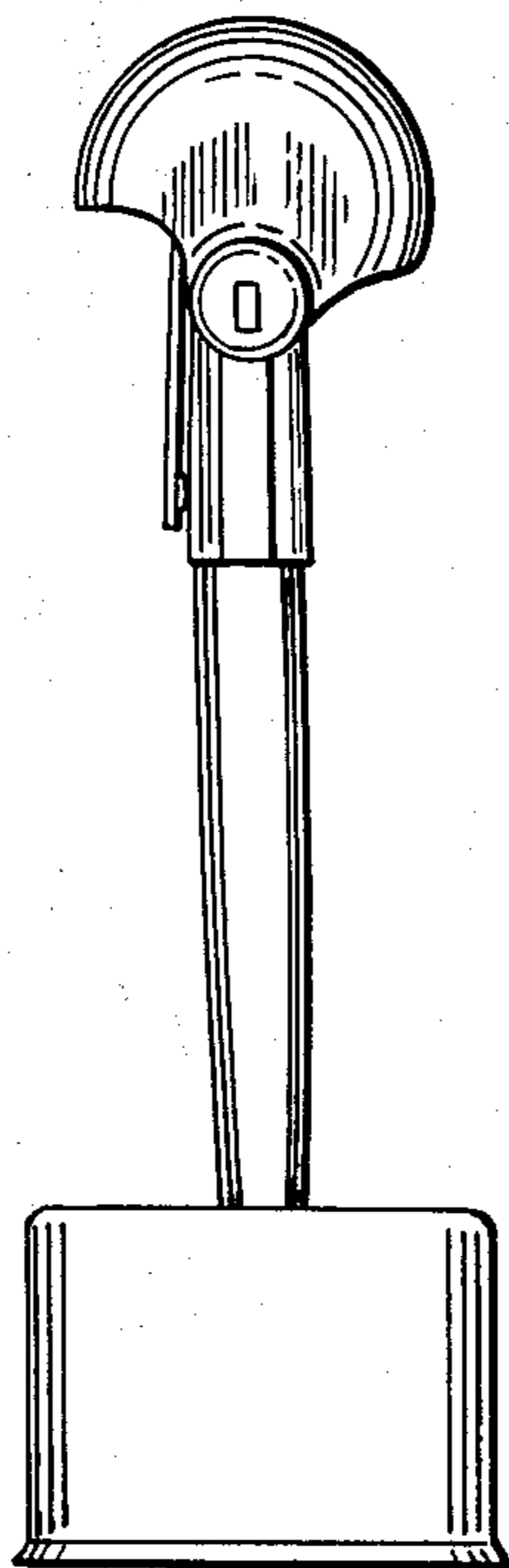
FIG. 14 is a front elevational view of the third embodiment;

FIG. 18 is a bottom plan view of the third embodiment.



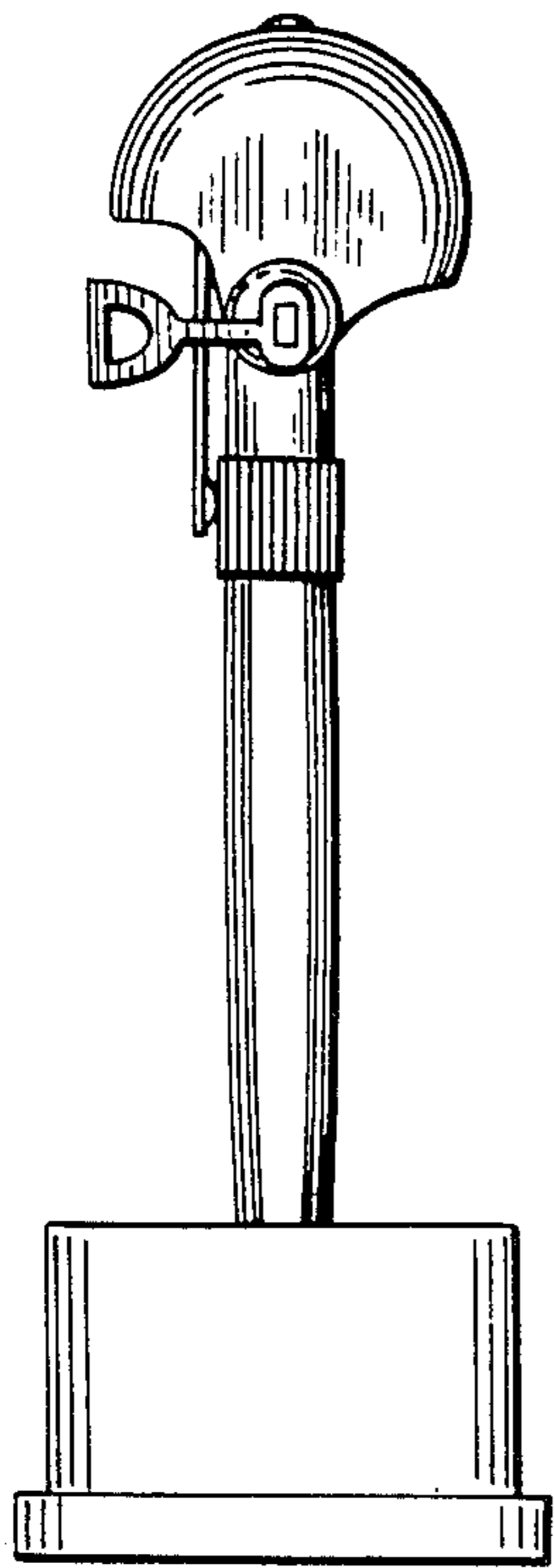

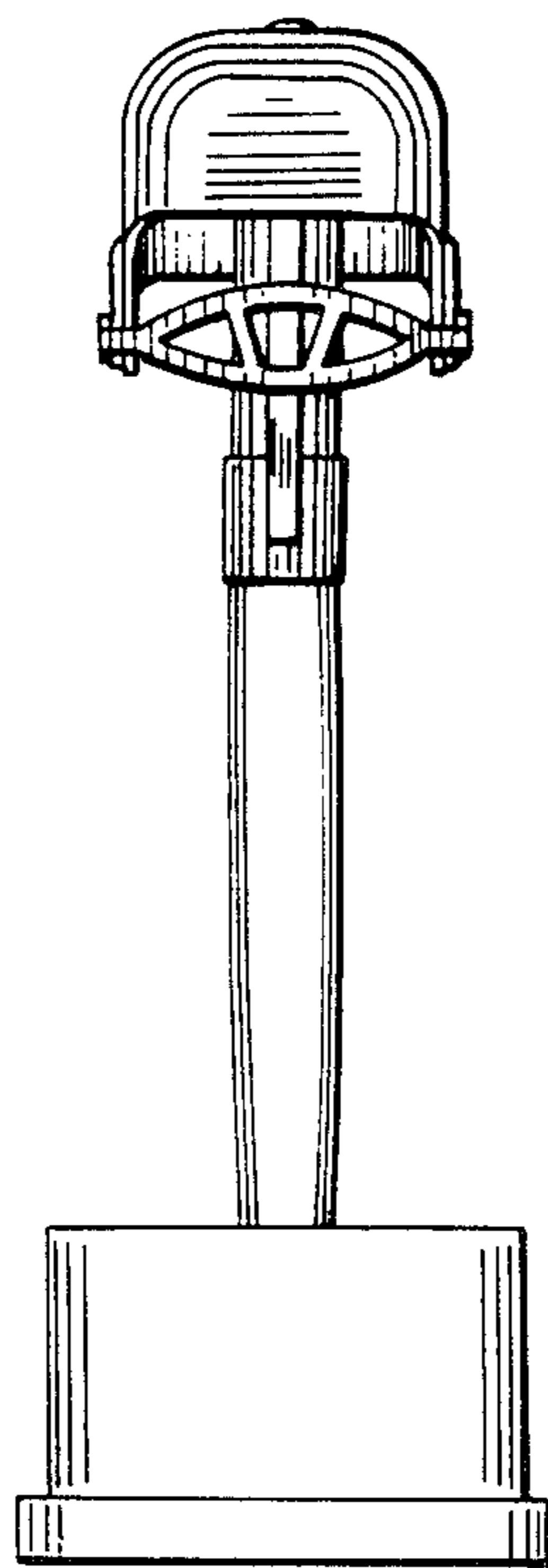

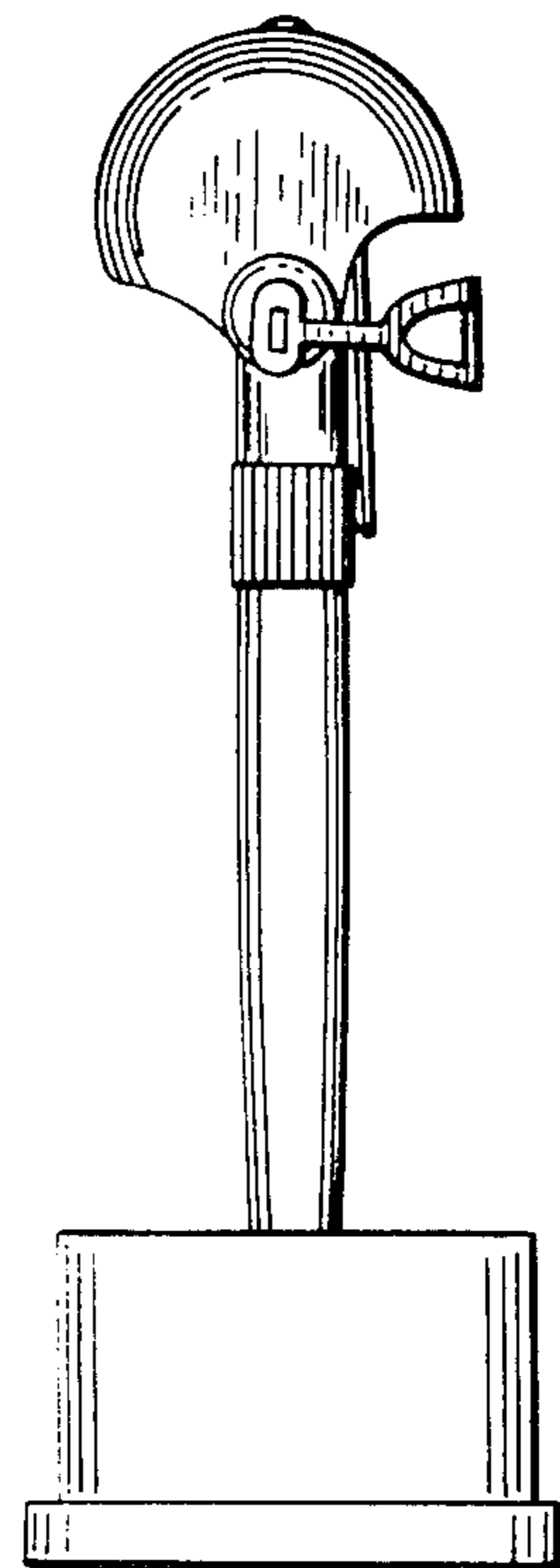

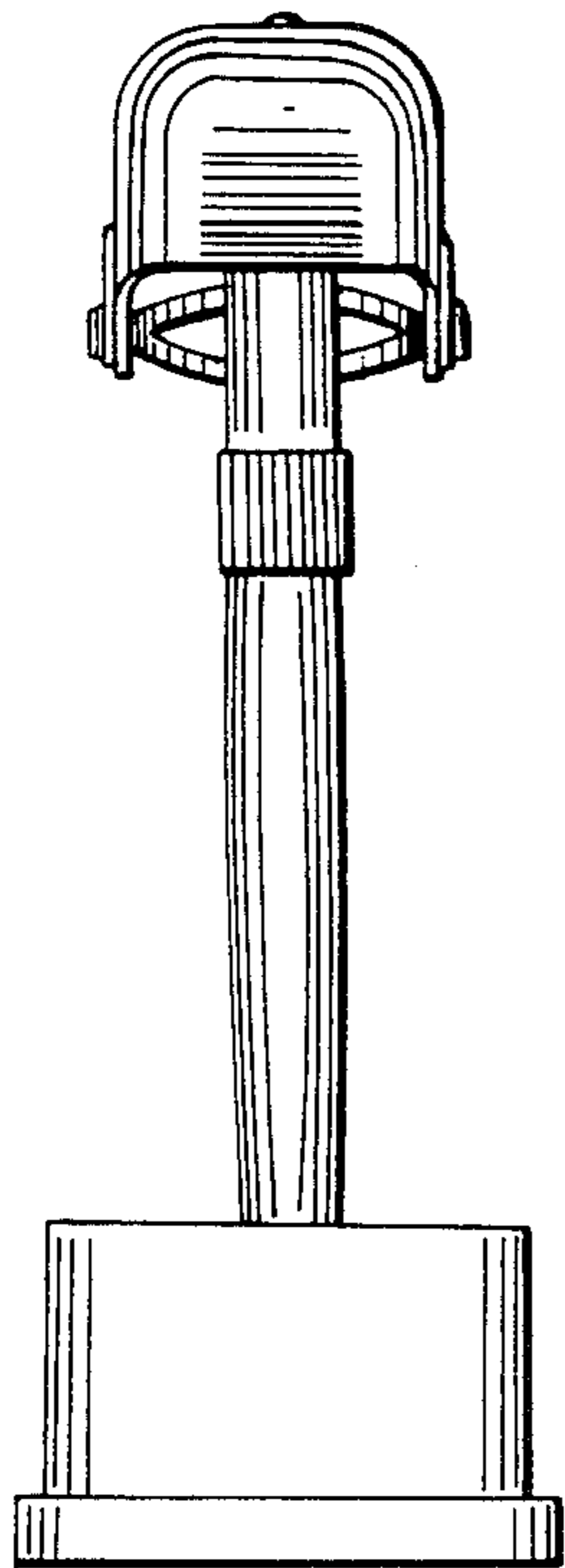

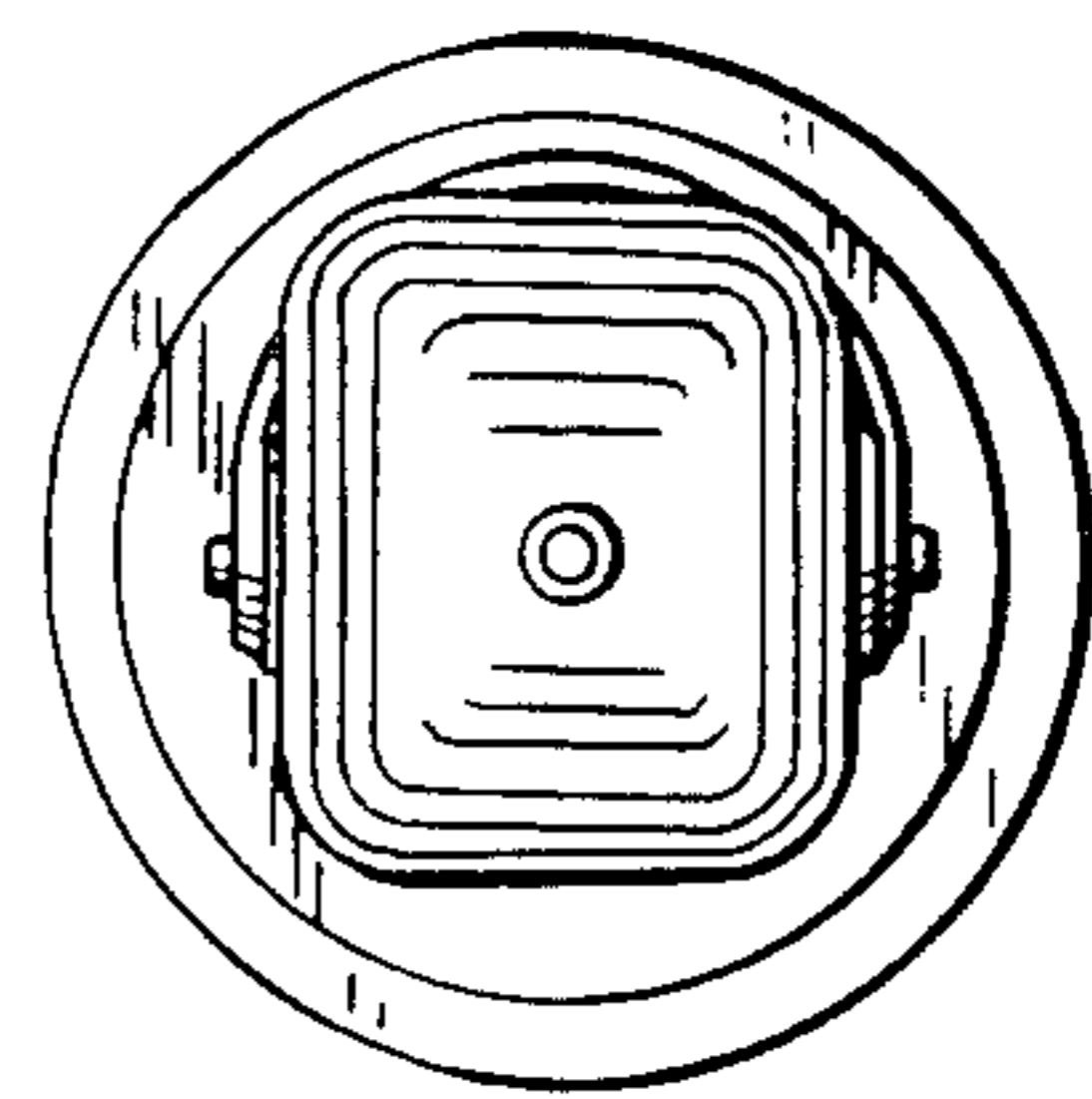

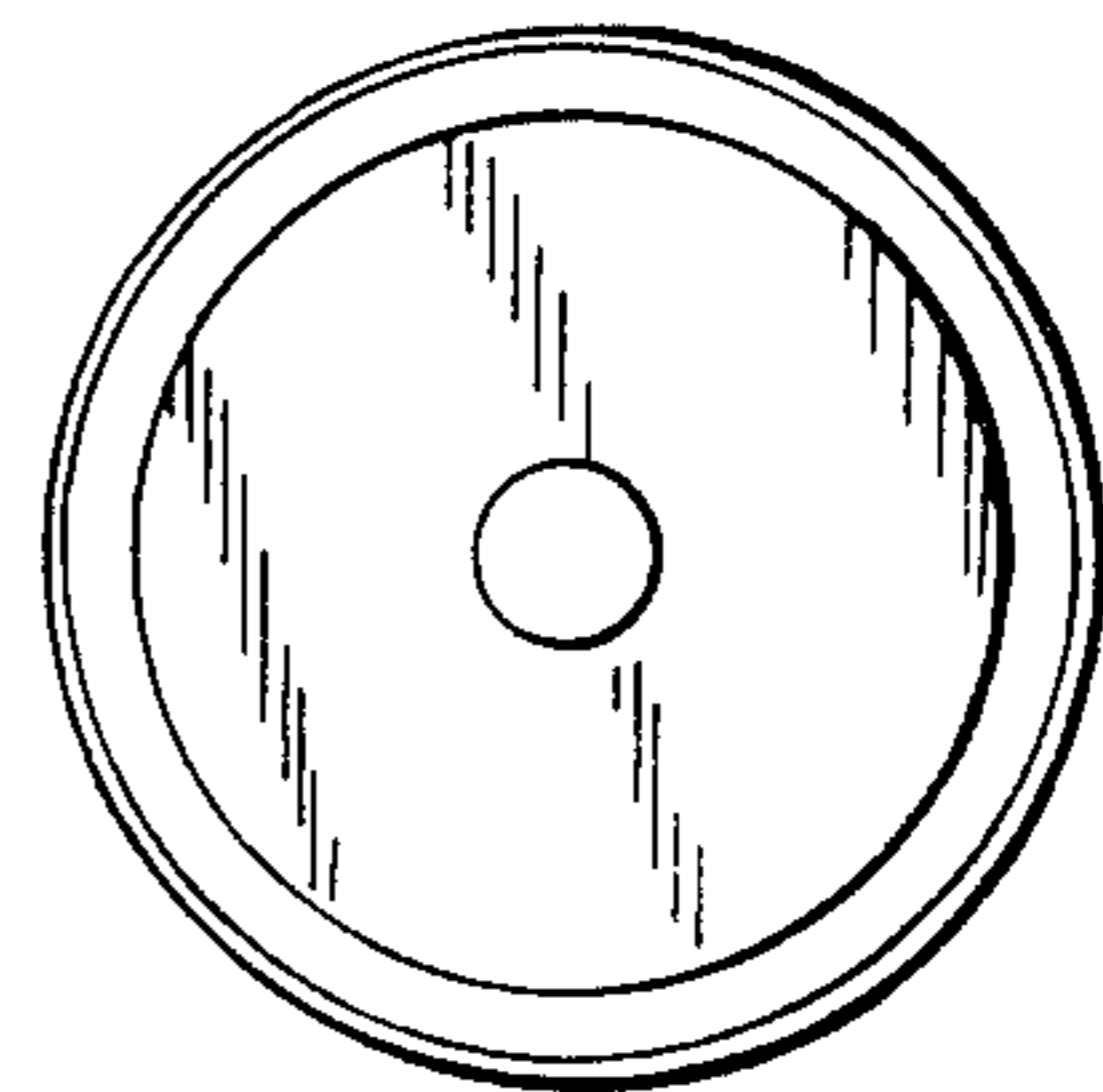

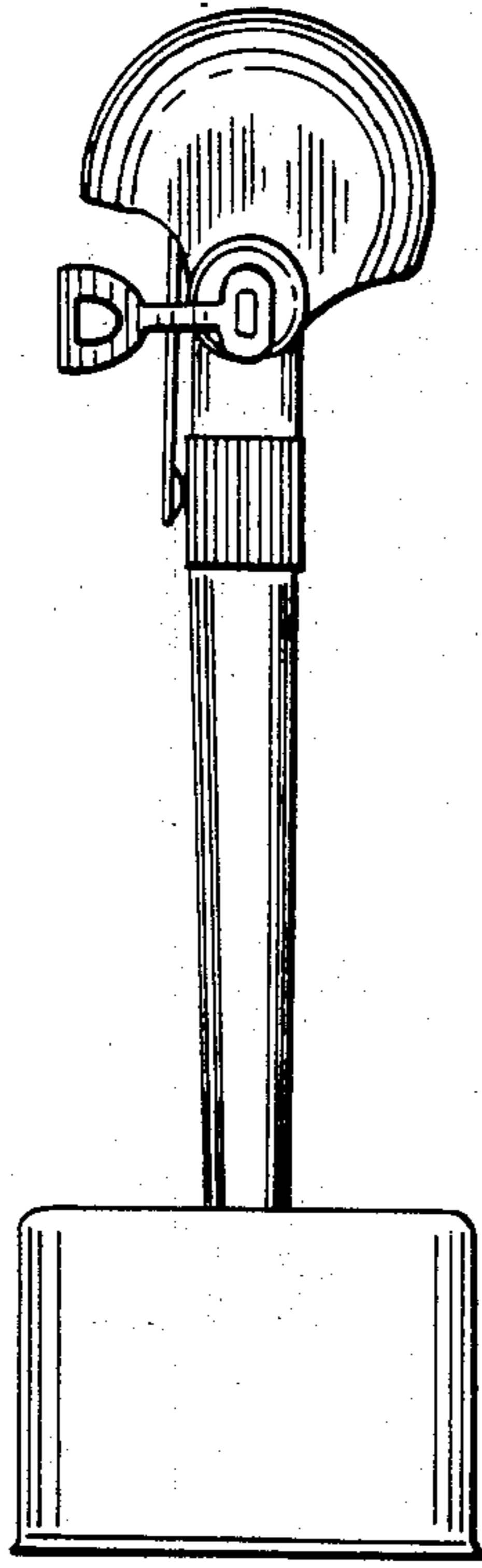

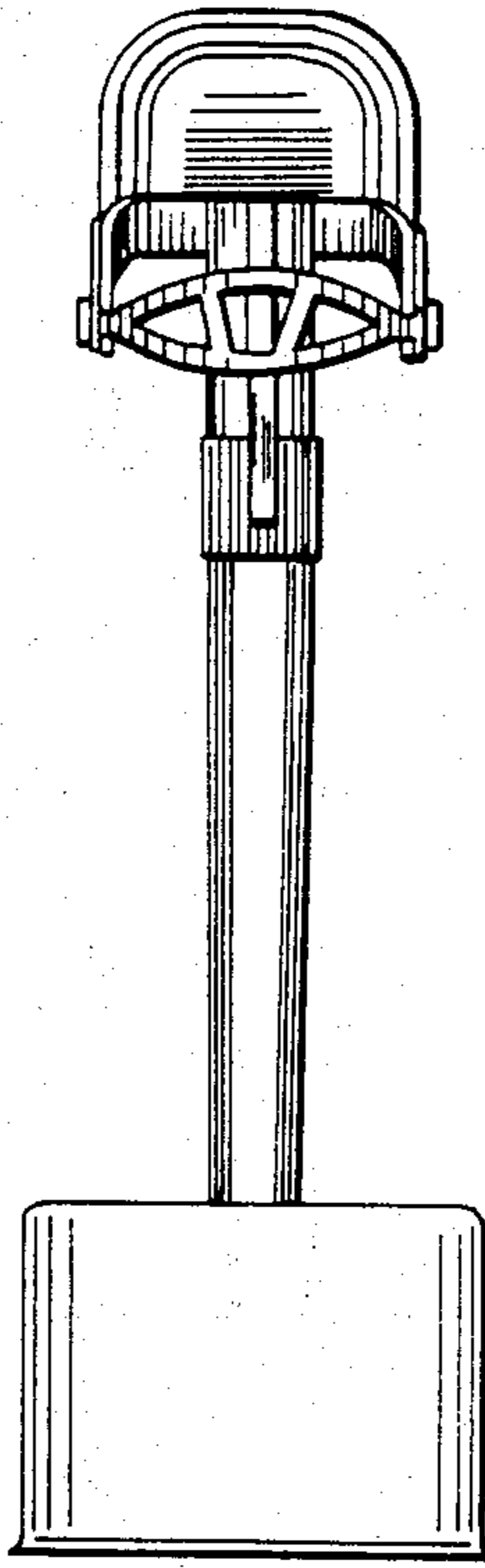

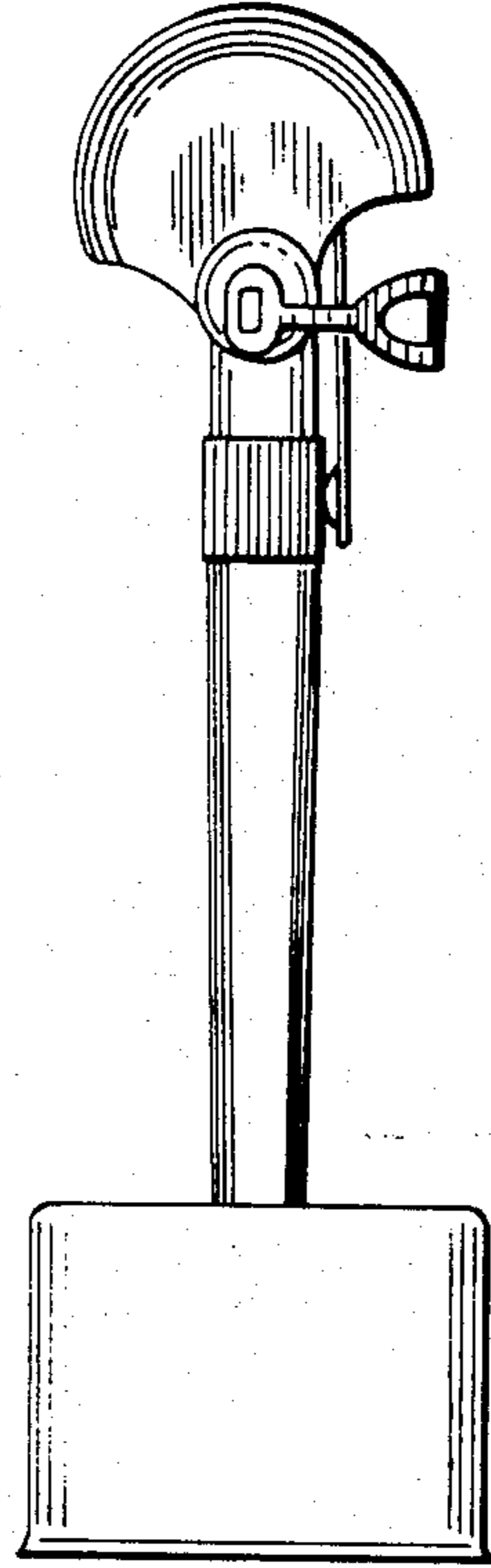

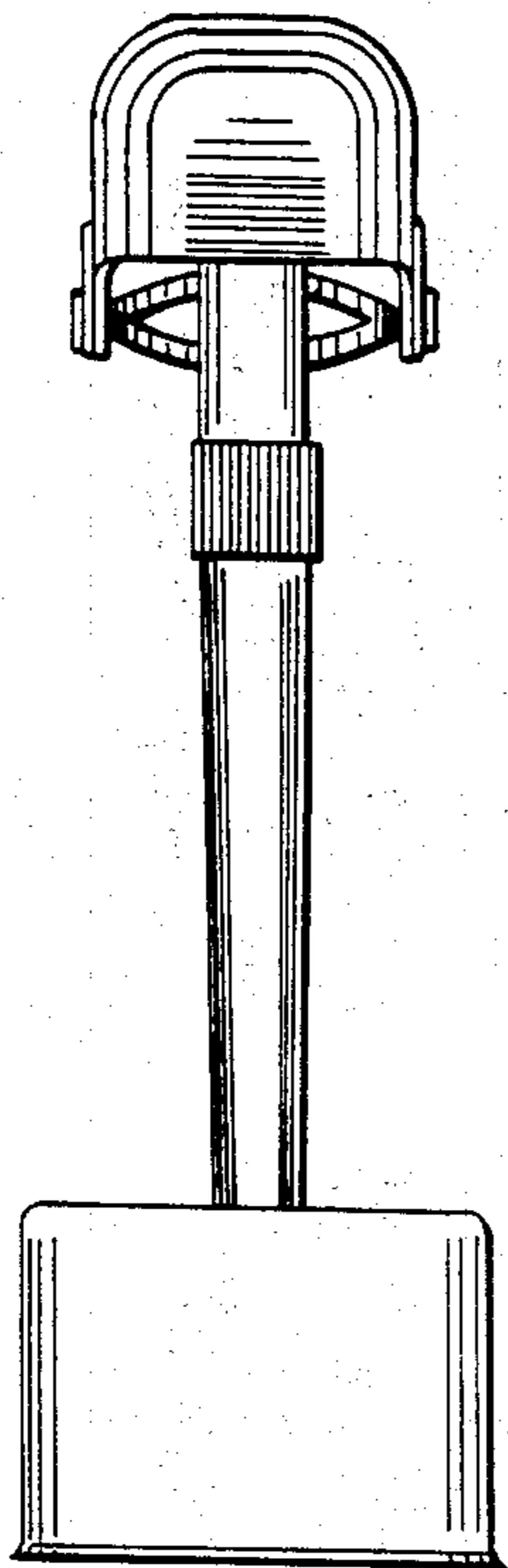

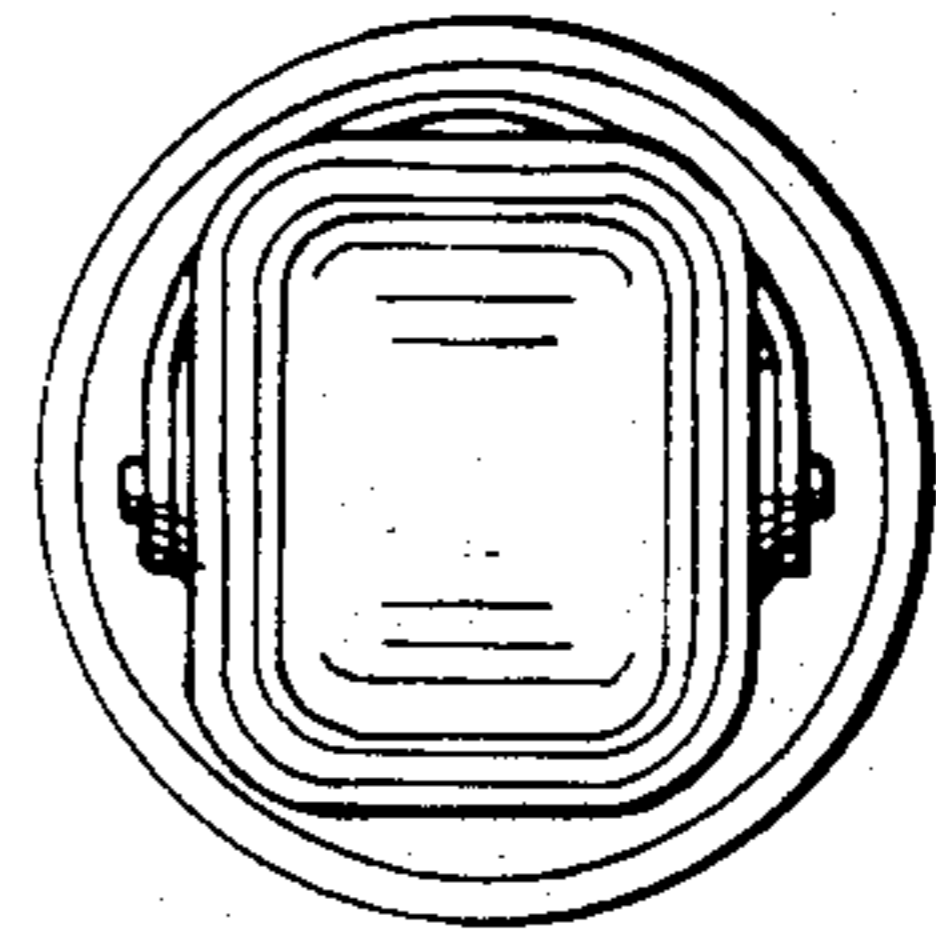

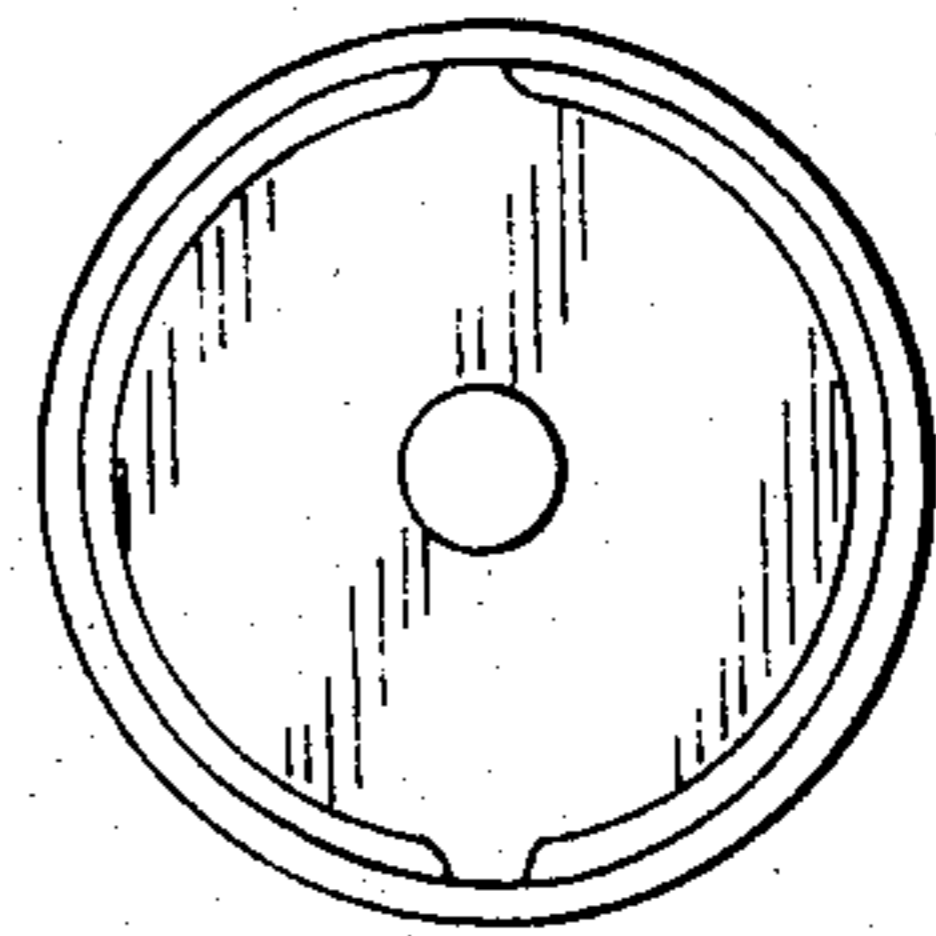

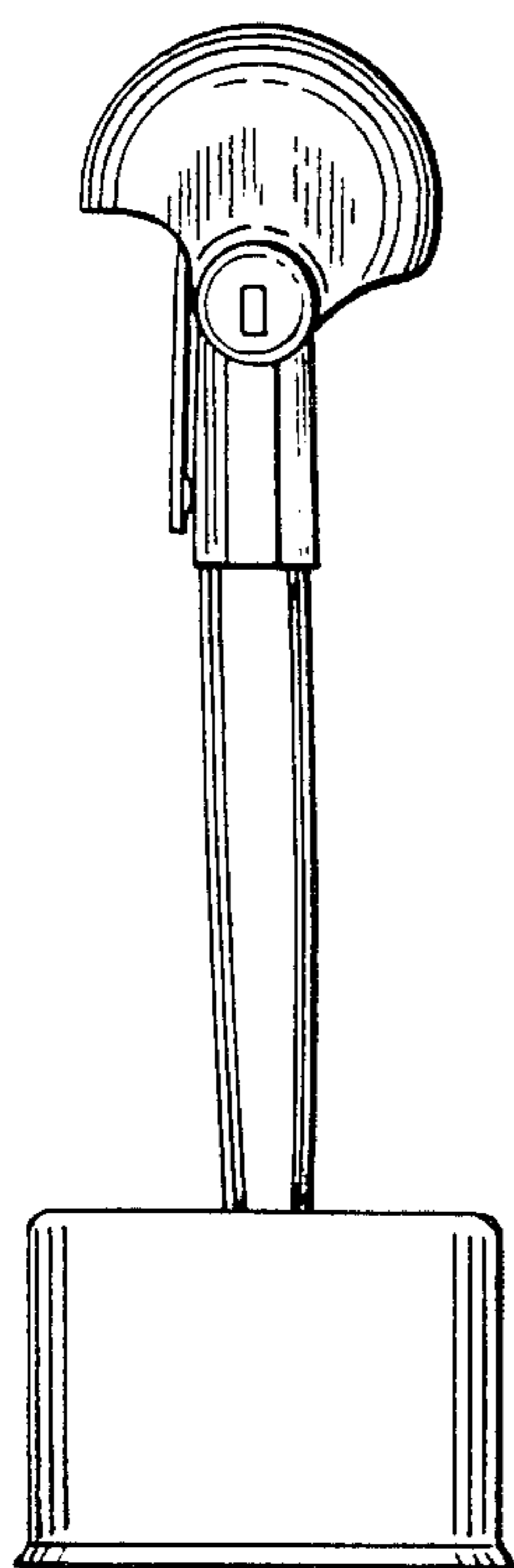

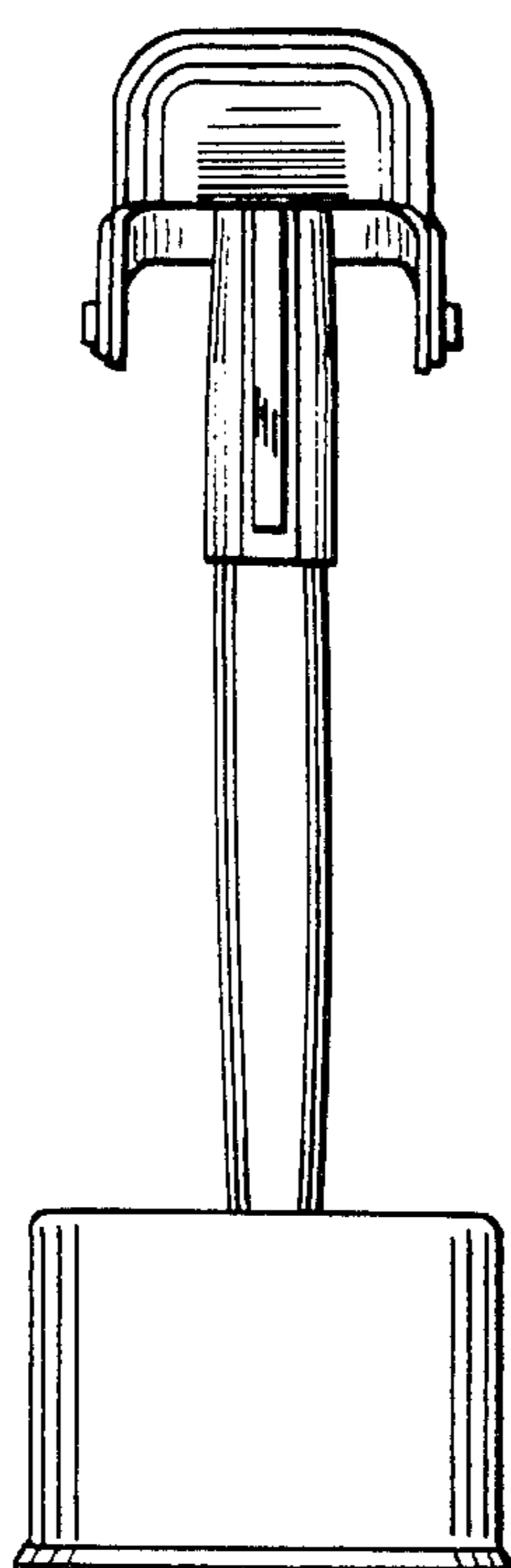

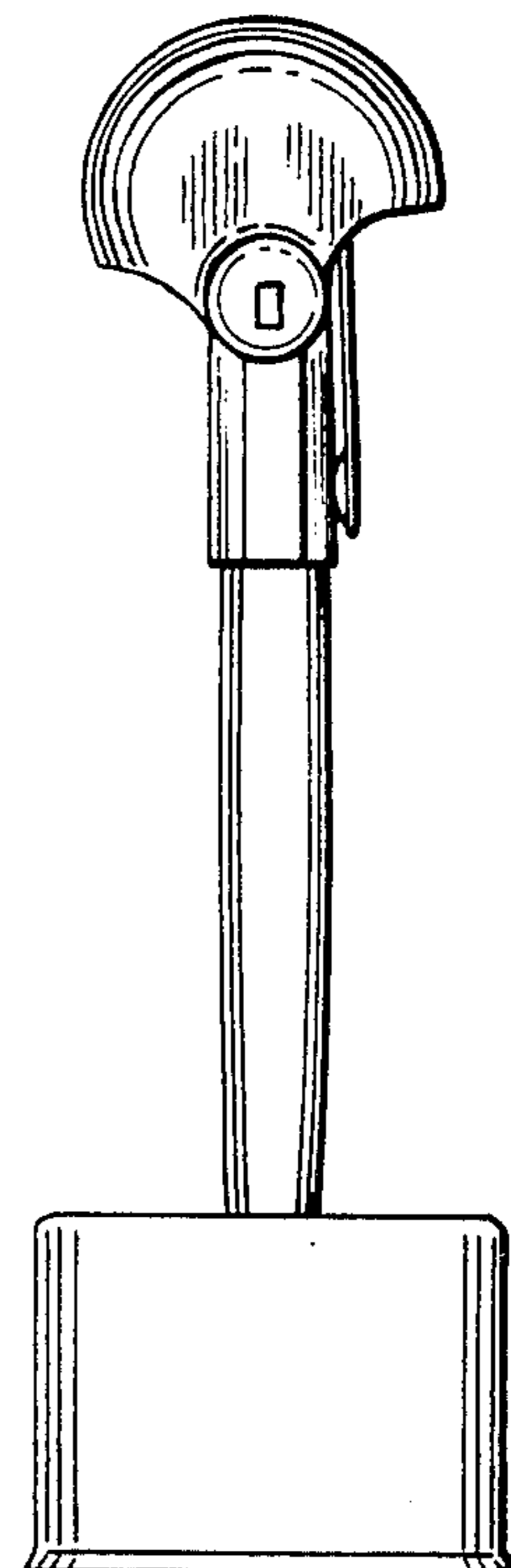

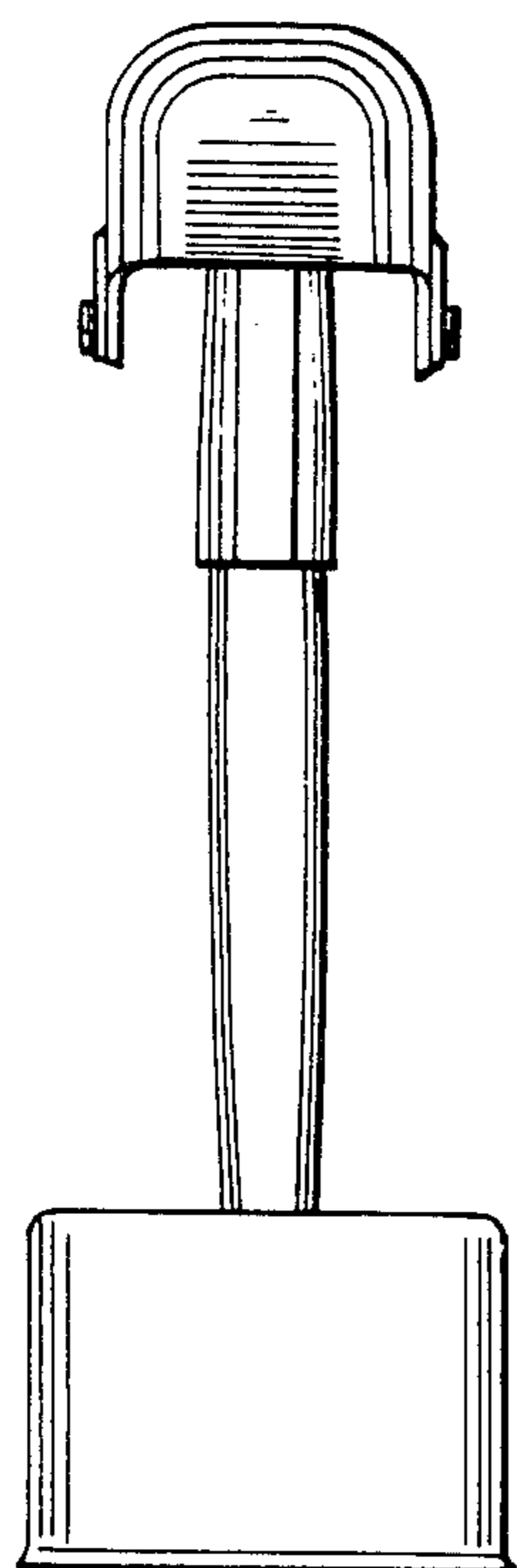

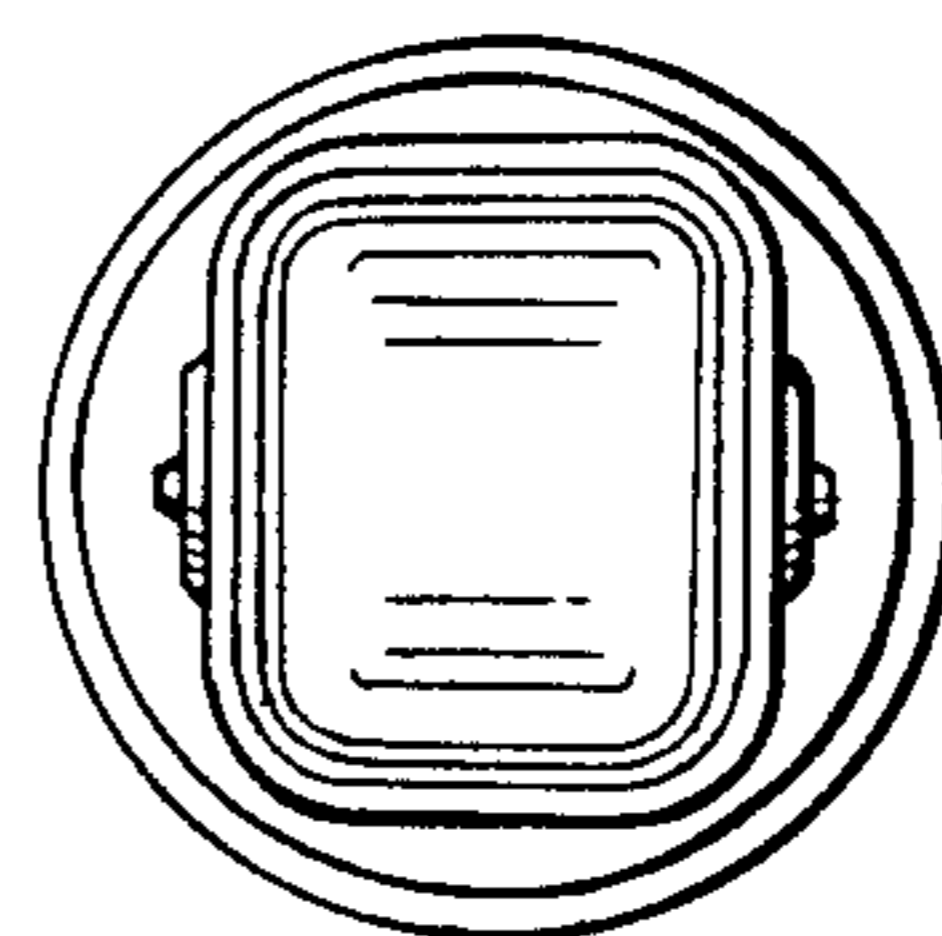

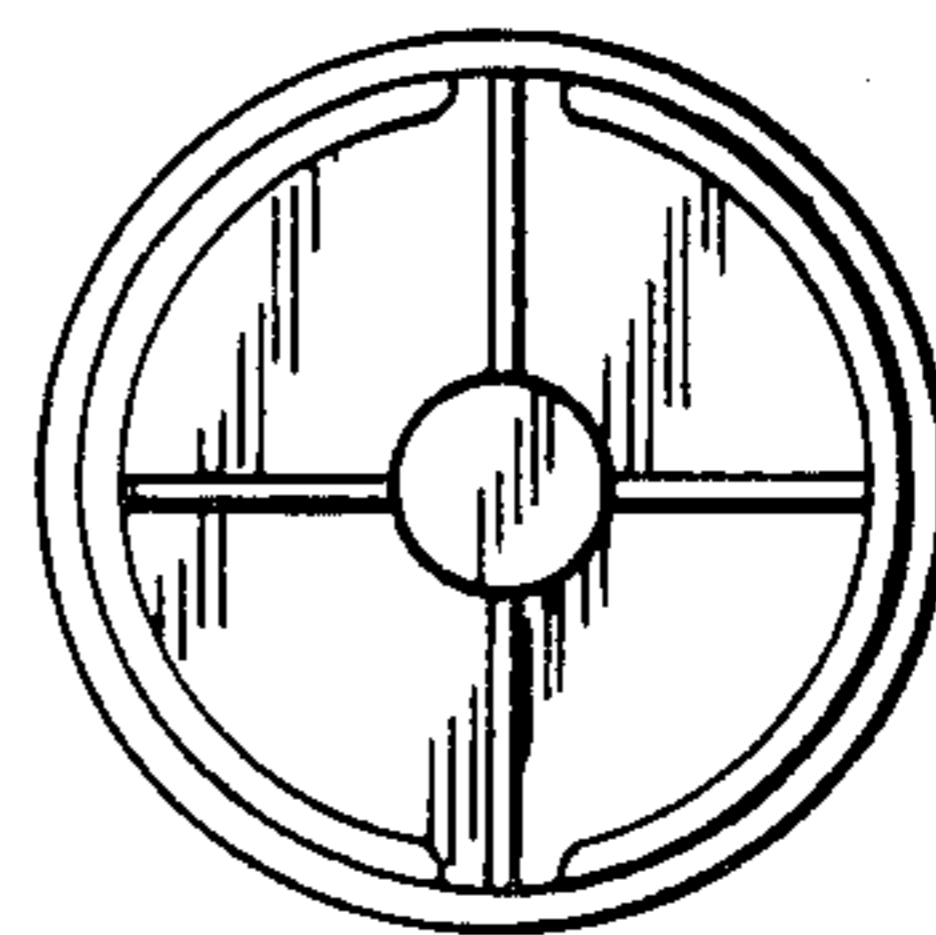
