The ornamental design for a floating seat, as shown.

DESCRIPTION

FIG. 1 is a top perspective view of a floating seat;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a view in section taken along line IV—IV of FIG. 2.
FIG. 5 is a side elevation view thereof looking in the direction of arrow 5 of FIG. 2;
FIG. 6 is a side elevation view thereof looking in the direction of arrow 6 of FIG. 2; and
FIG. 7 is a side elevation view thereof looking in the direction of arrow 7 of FIG. 2.
The broken lines showing of the connecting members in FIGS. 1, 4, 5, 6 and 7 are for illustrative purposes only.

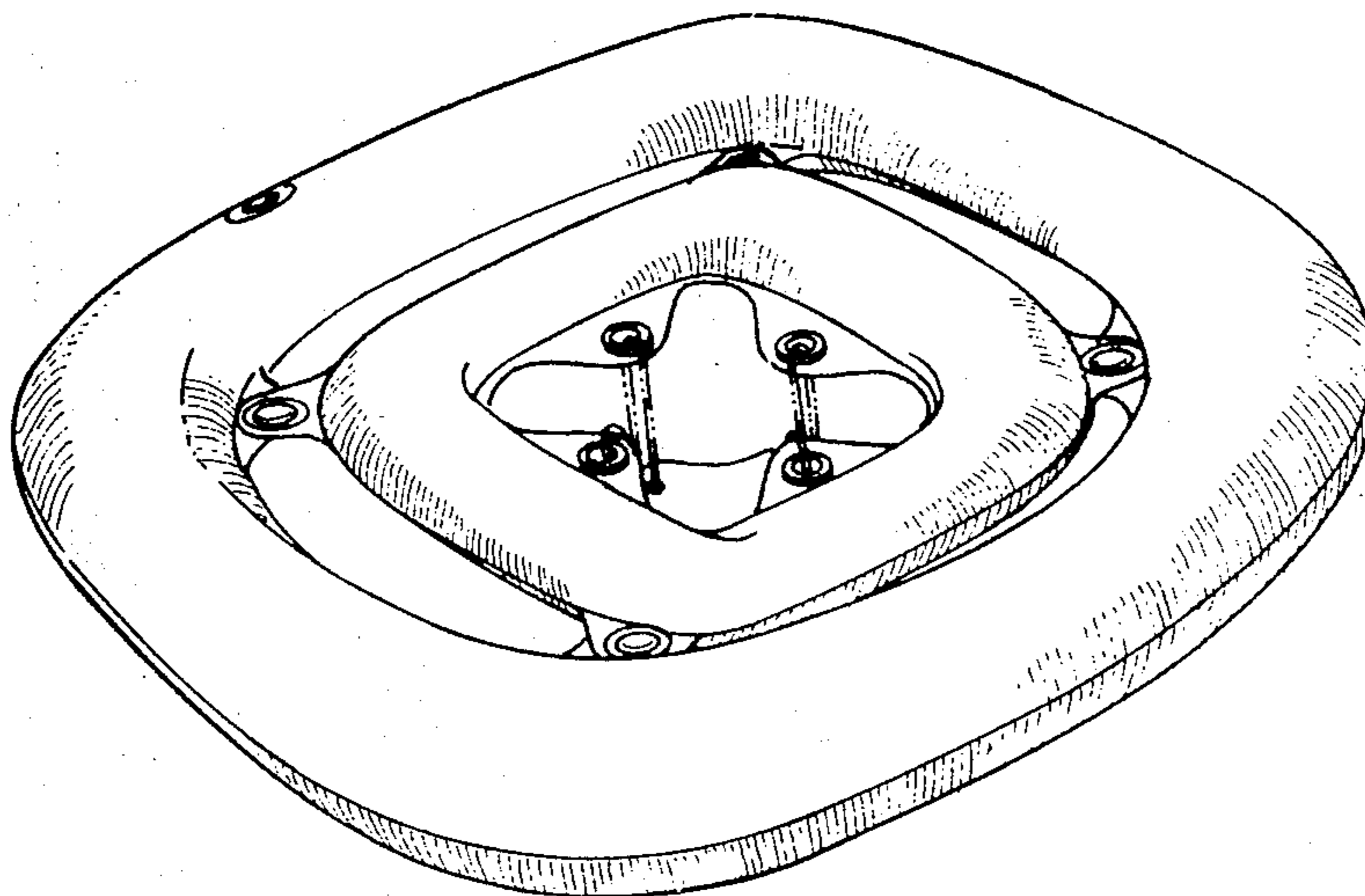

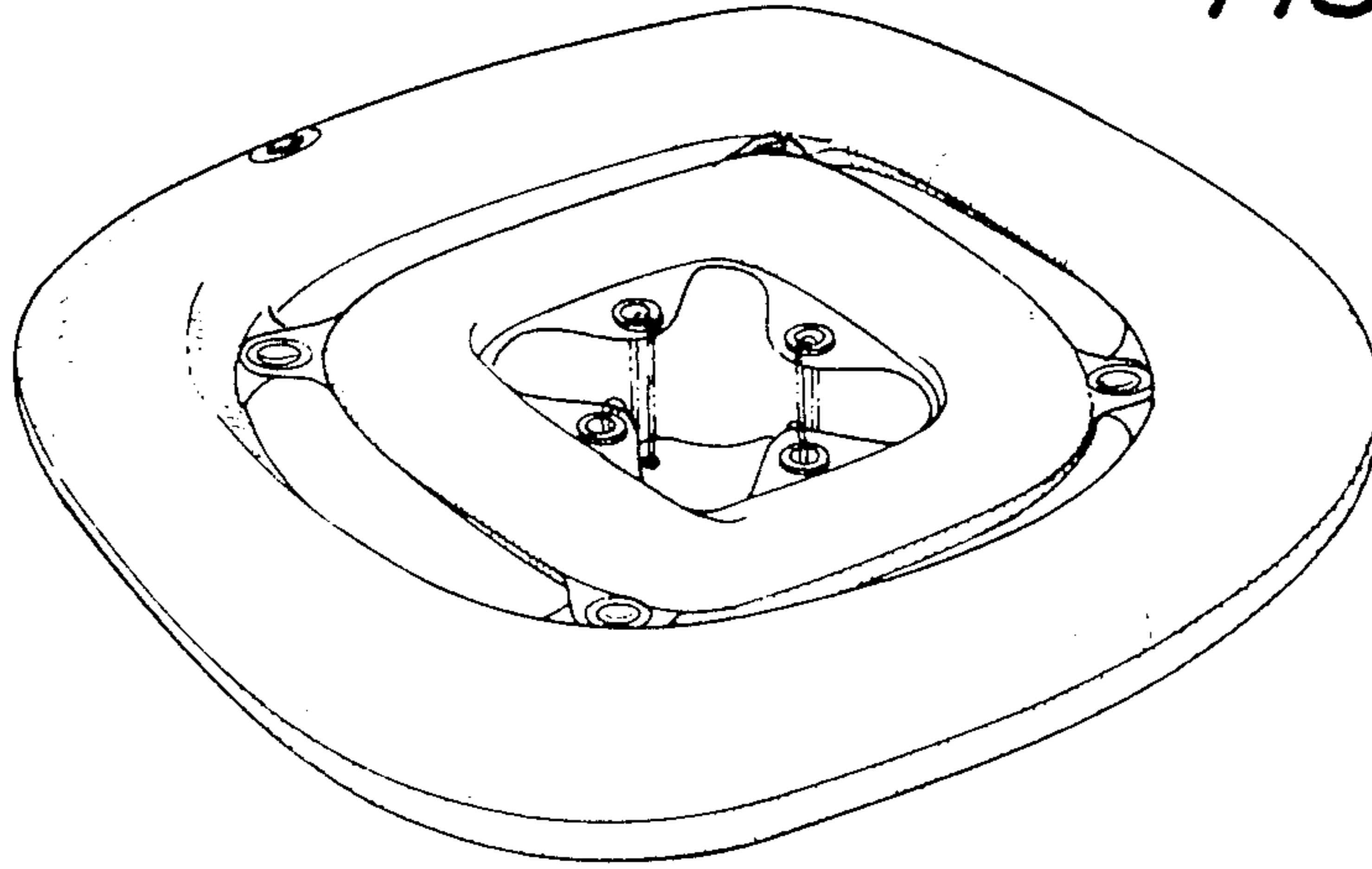
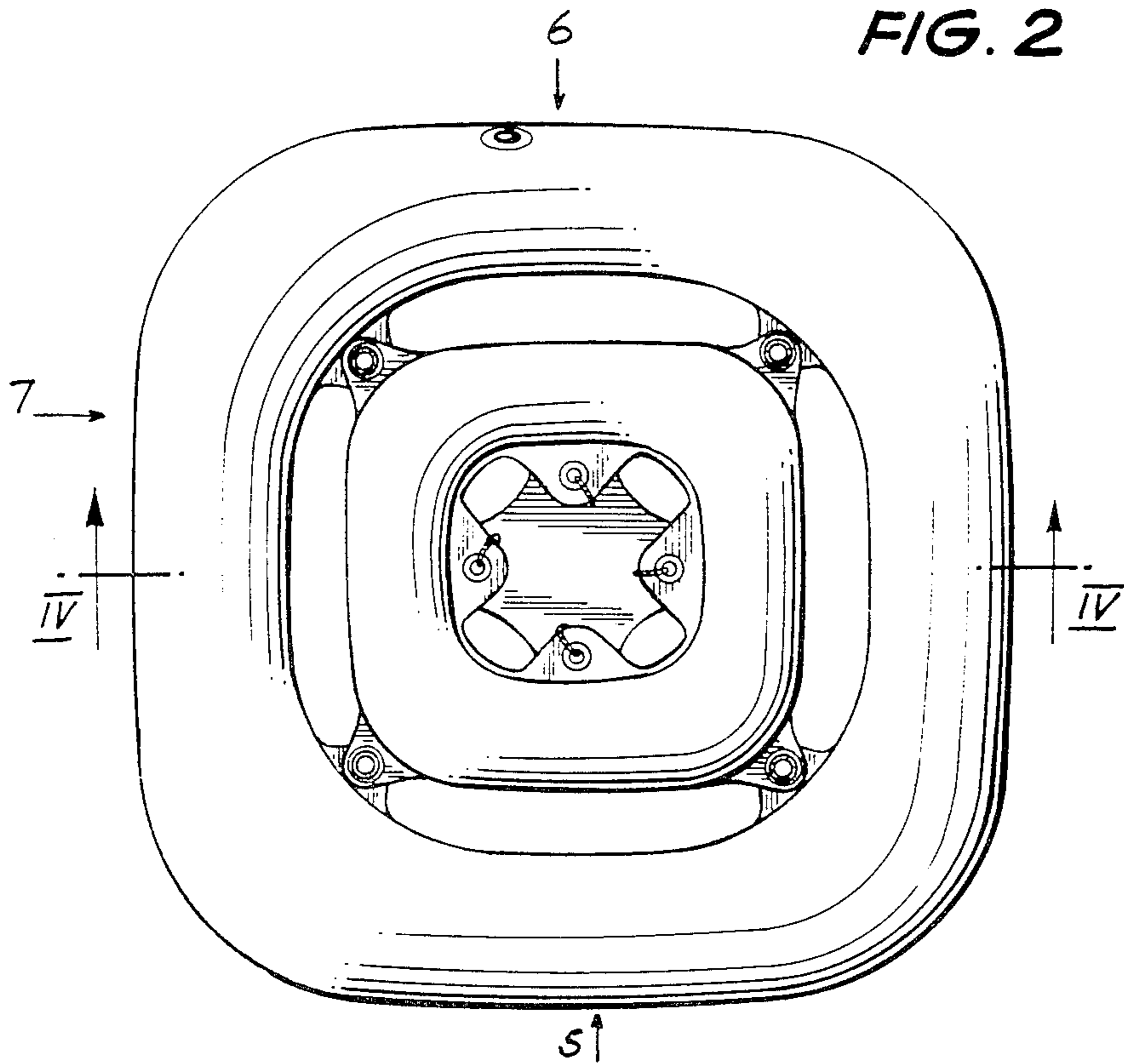

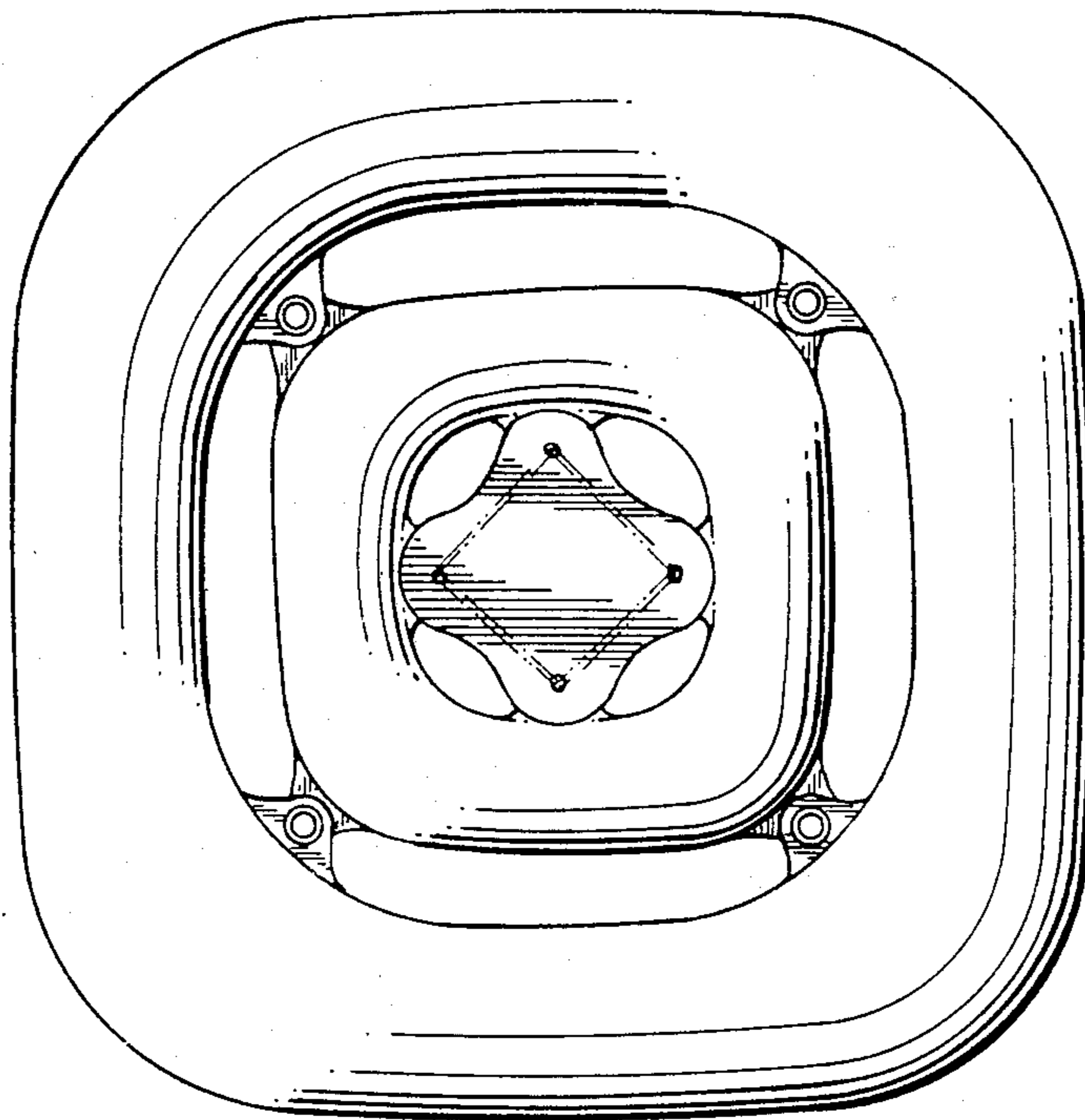
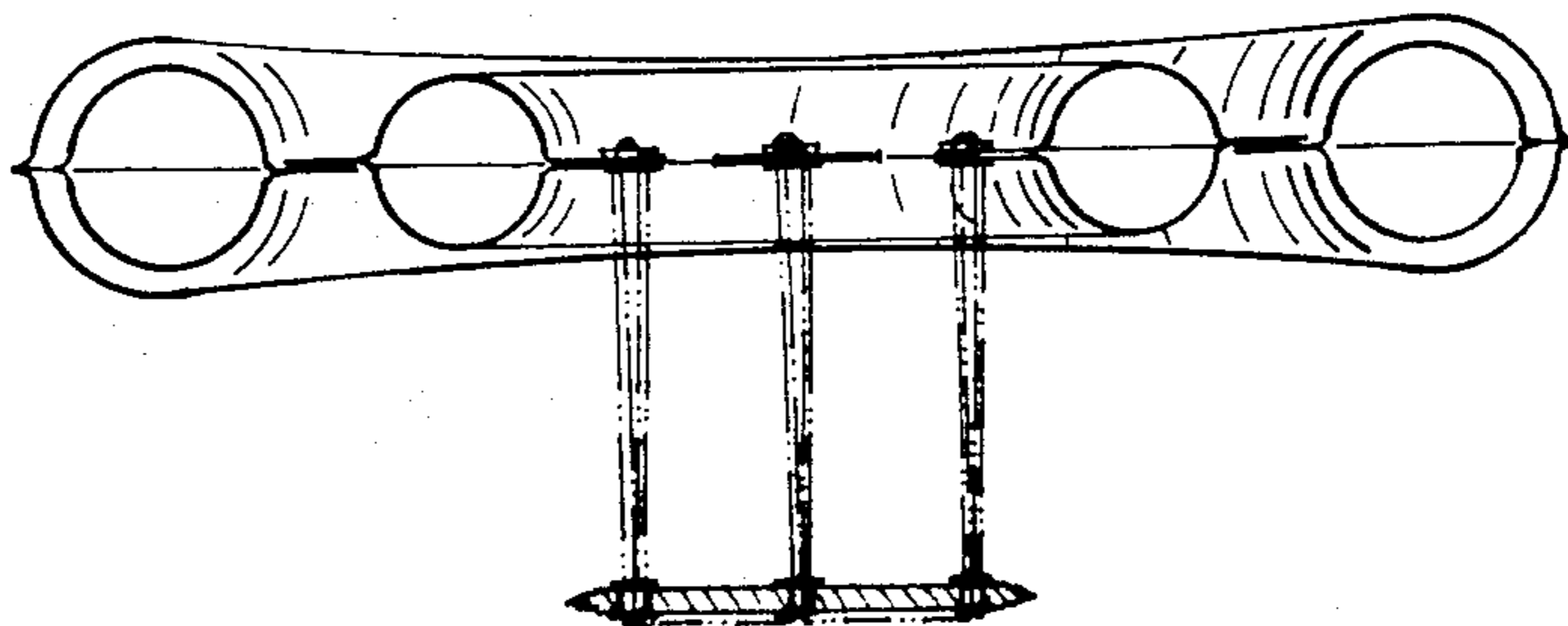

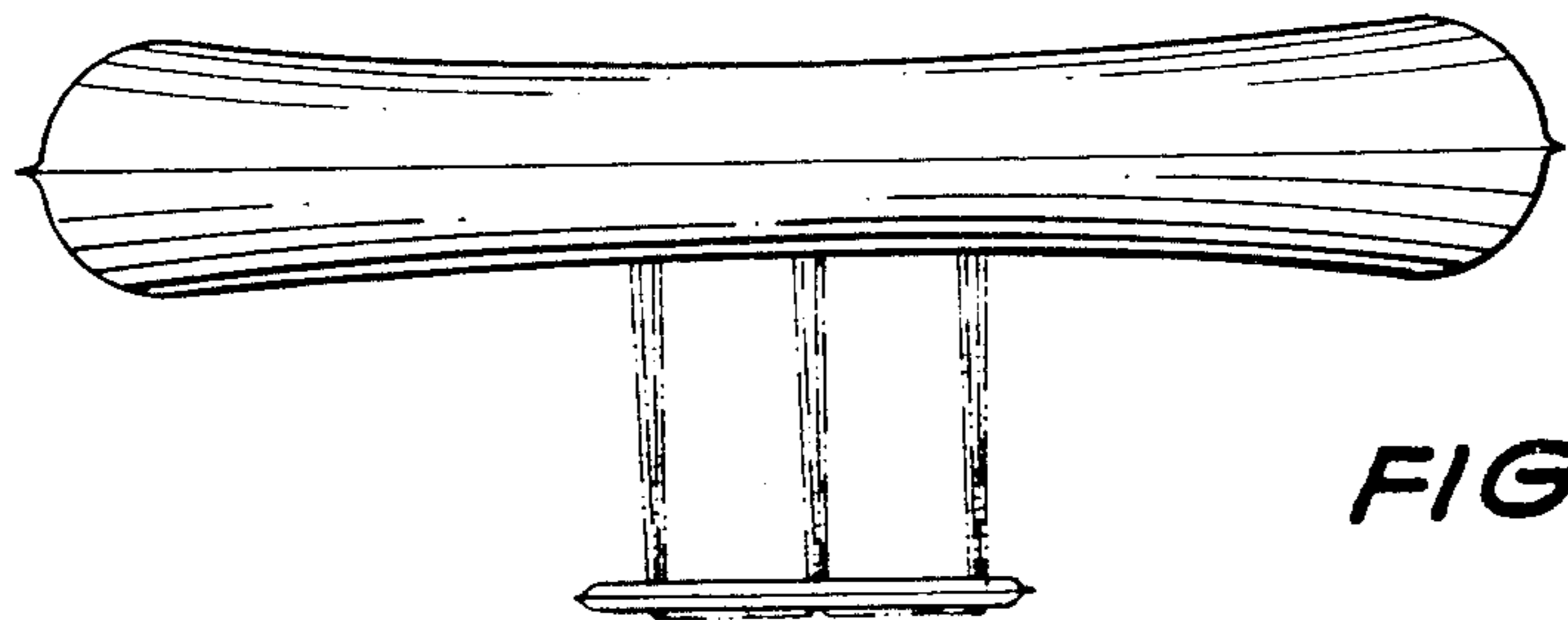

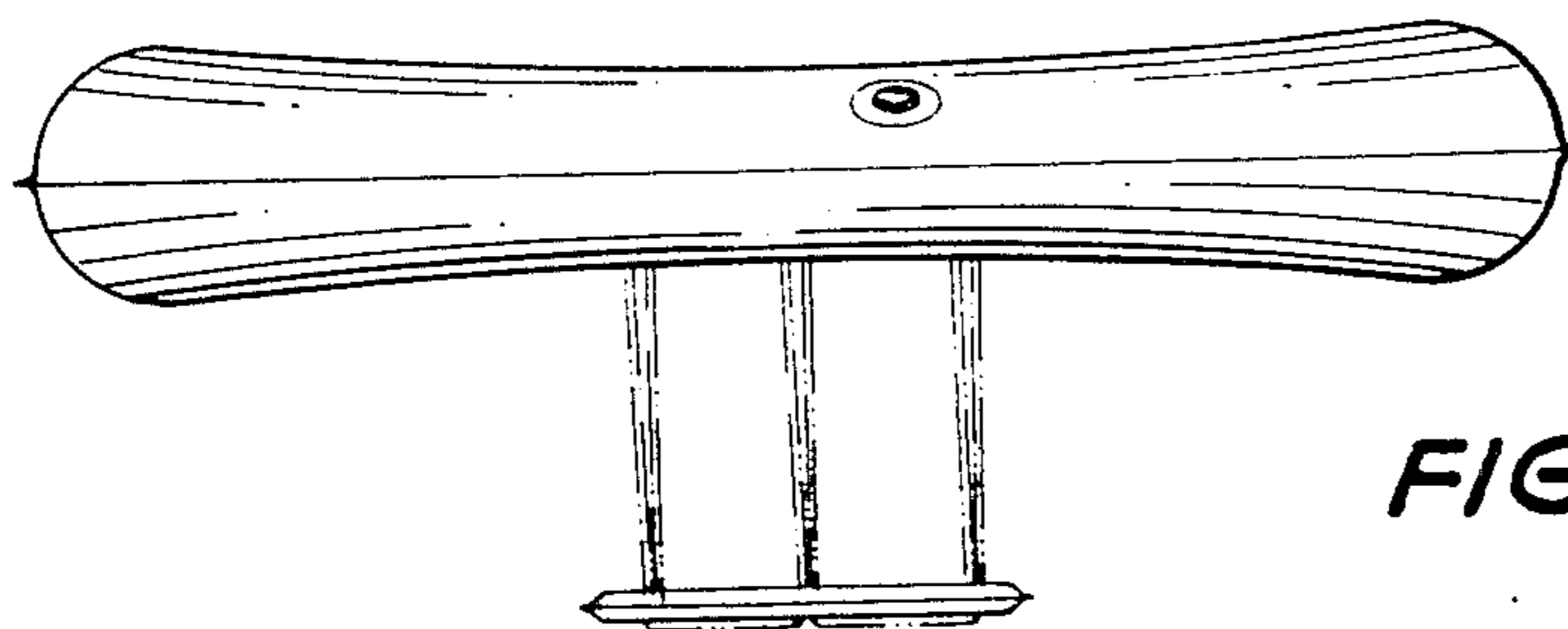

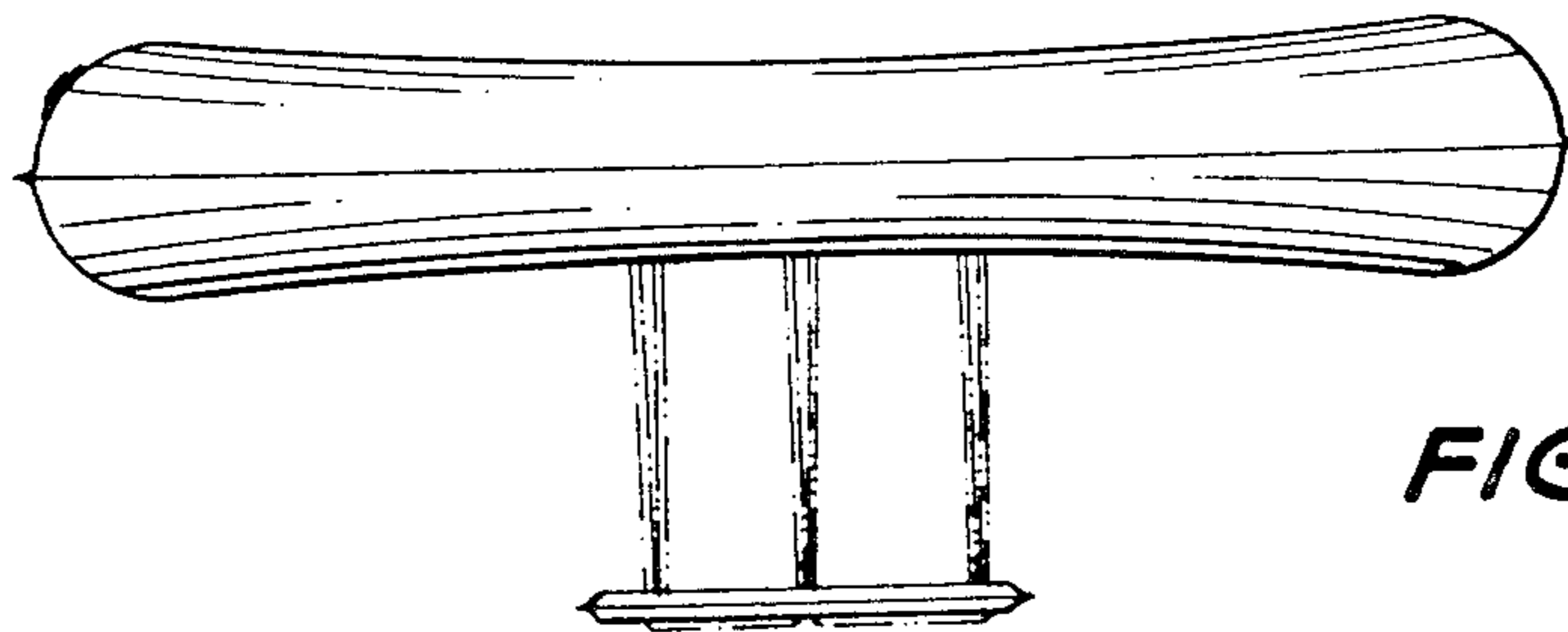
