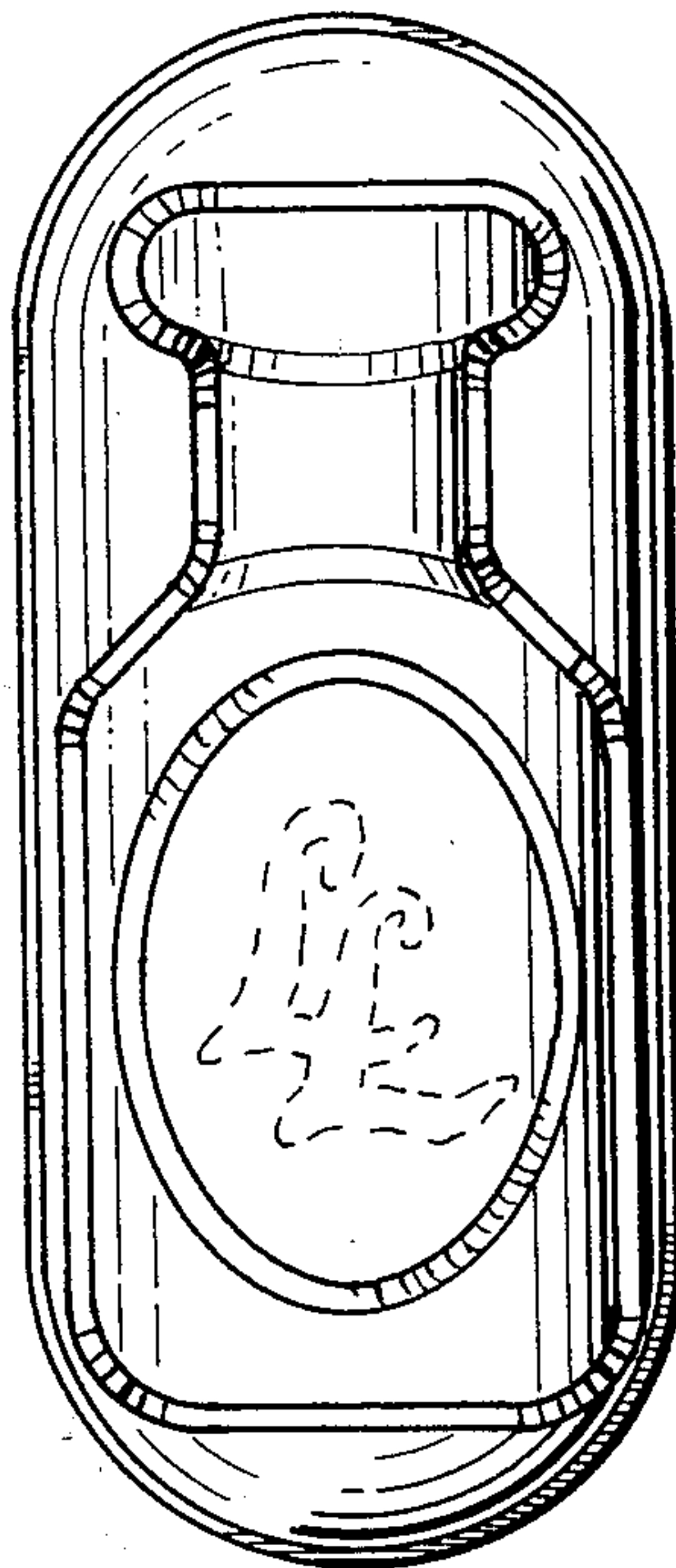

The broken lines shown in FIGS. 1, 2 and 4 of the drawing represent a trademark and are for illustrative purposes only and form no part of the design.



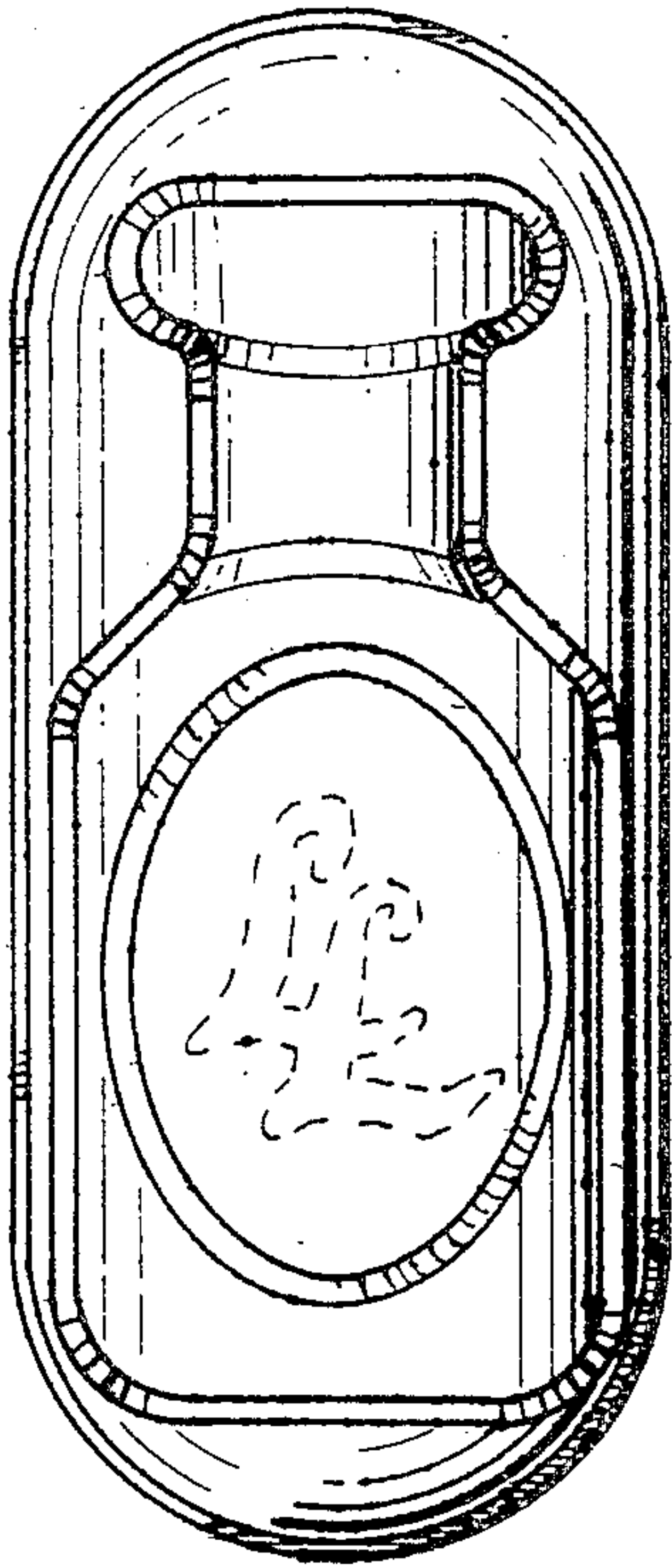

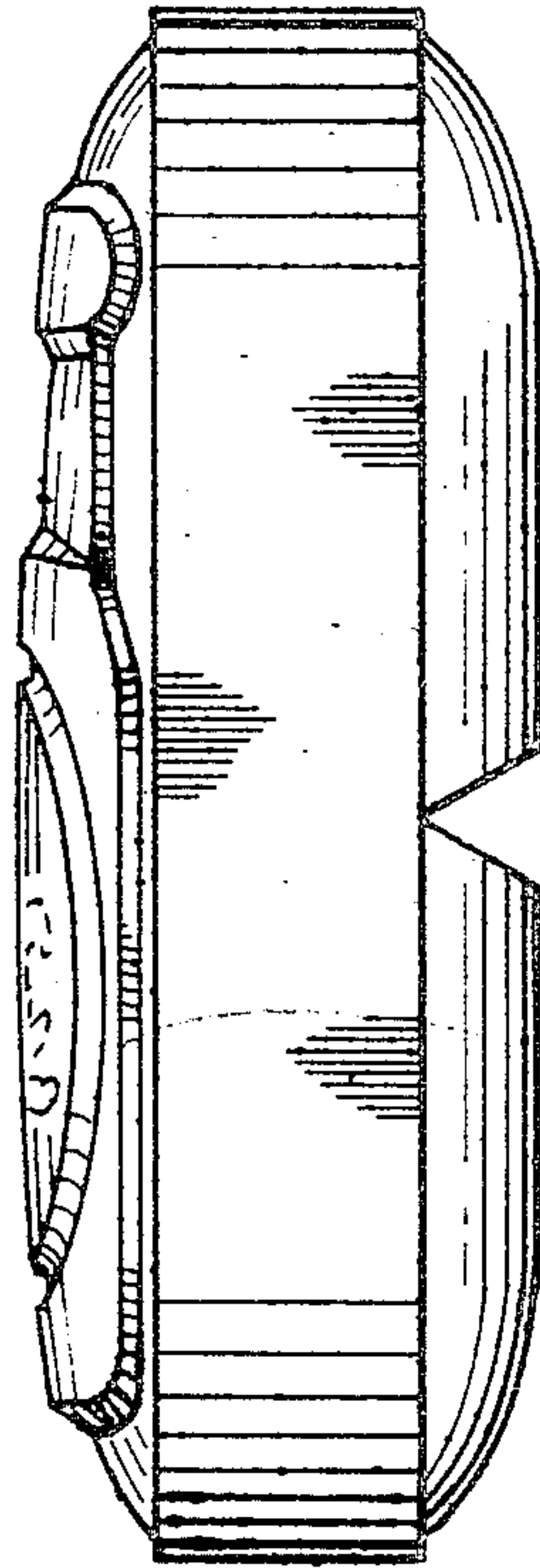

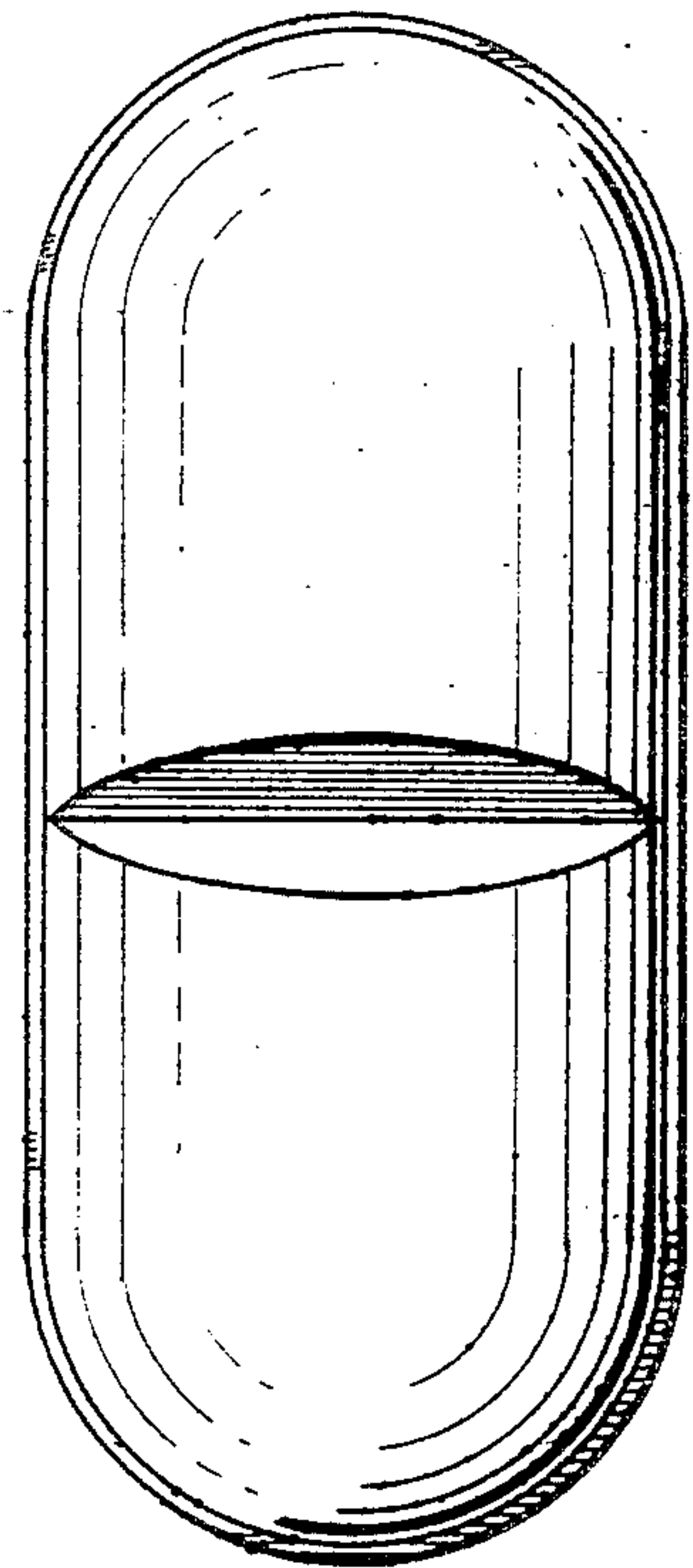

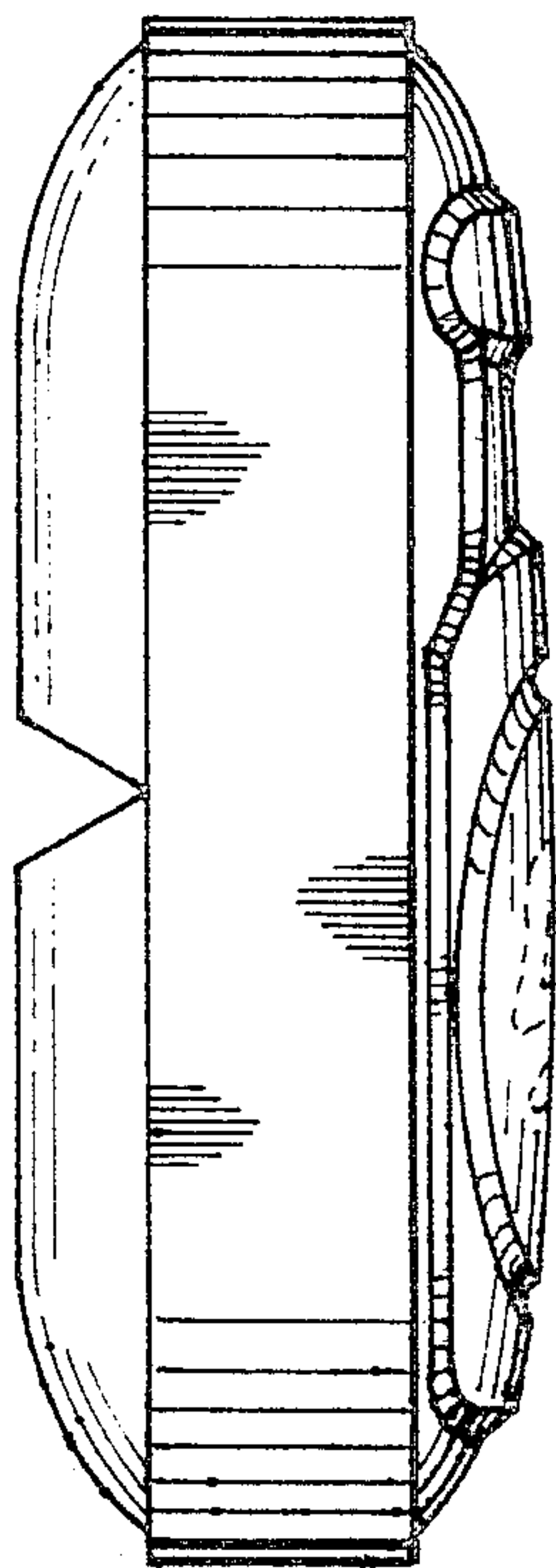

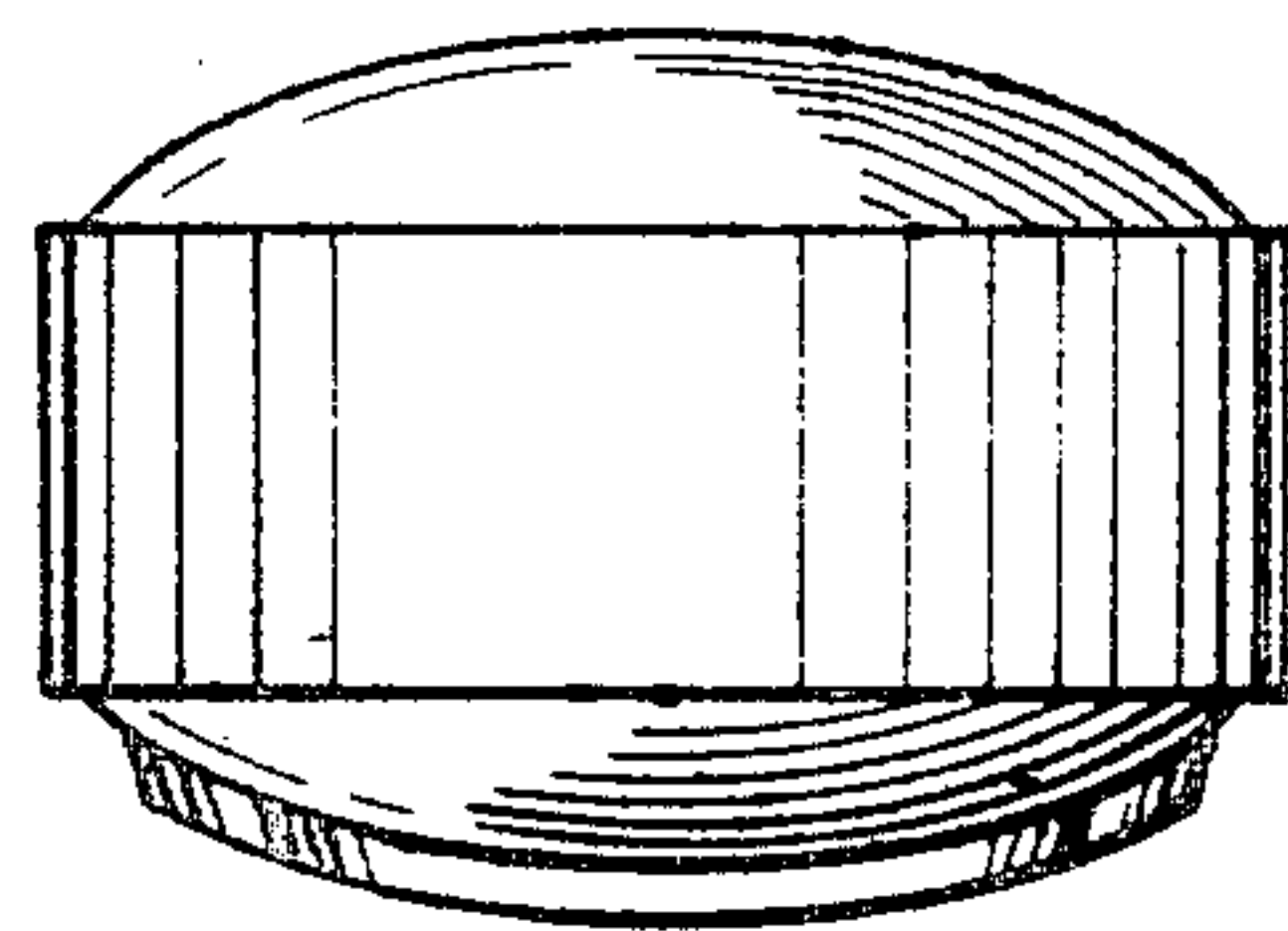

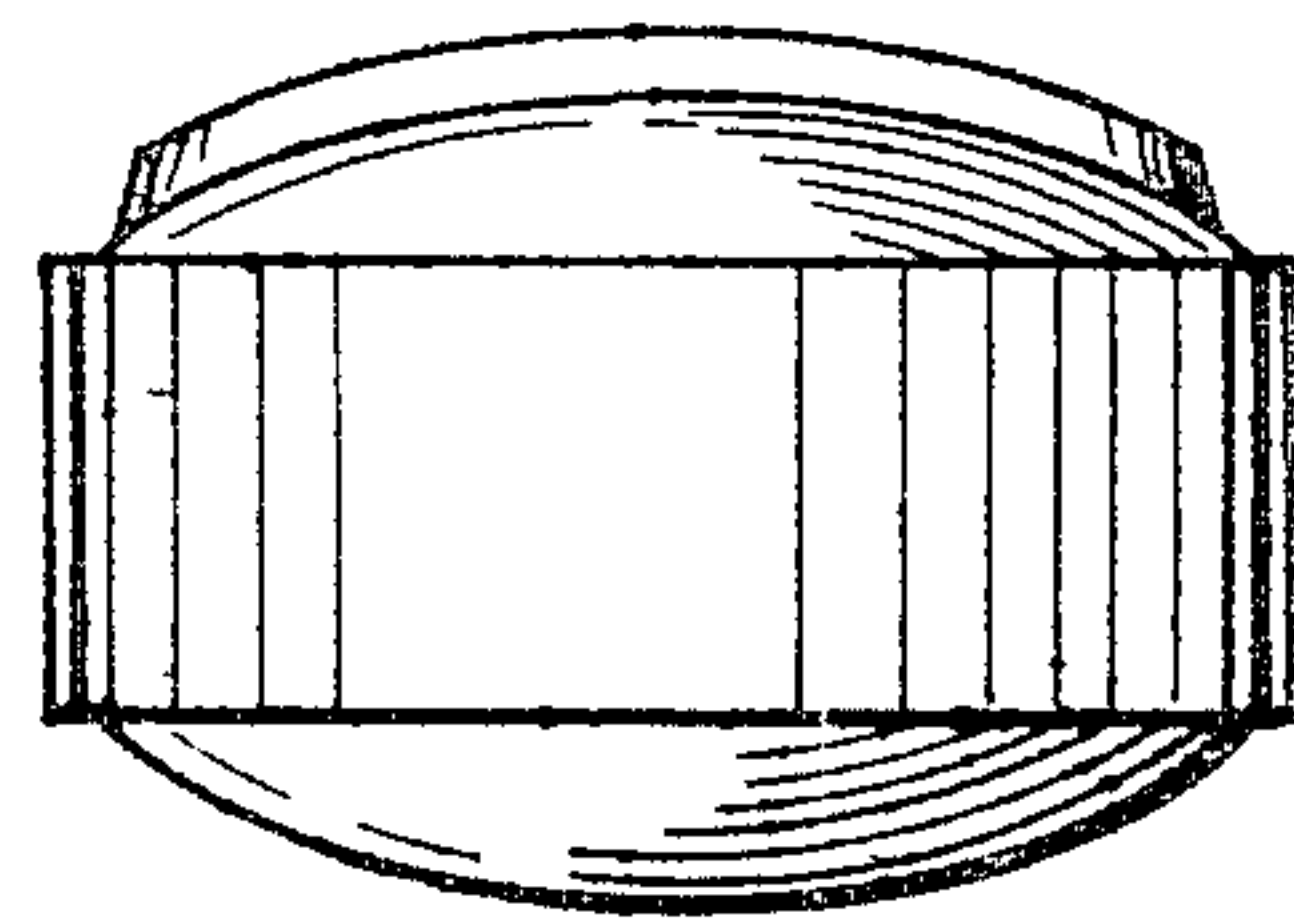

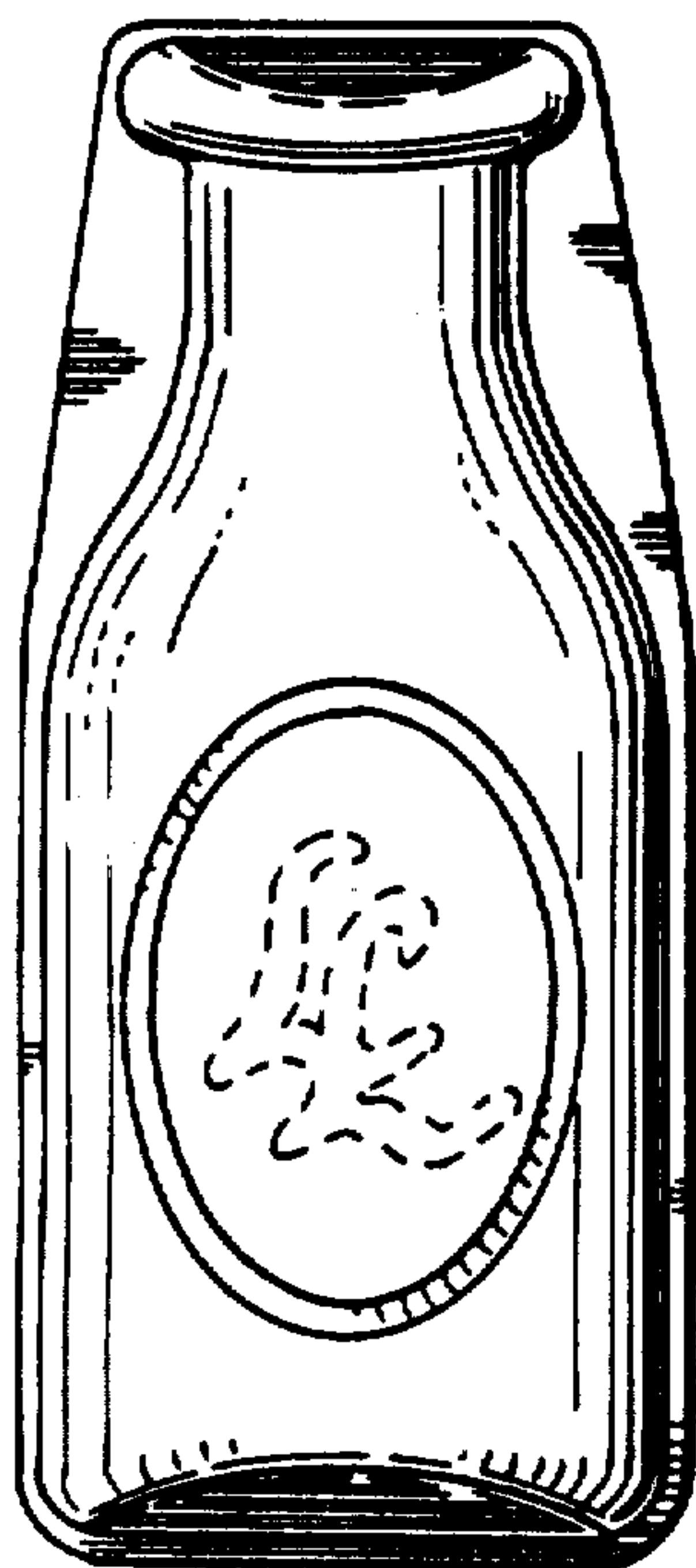

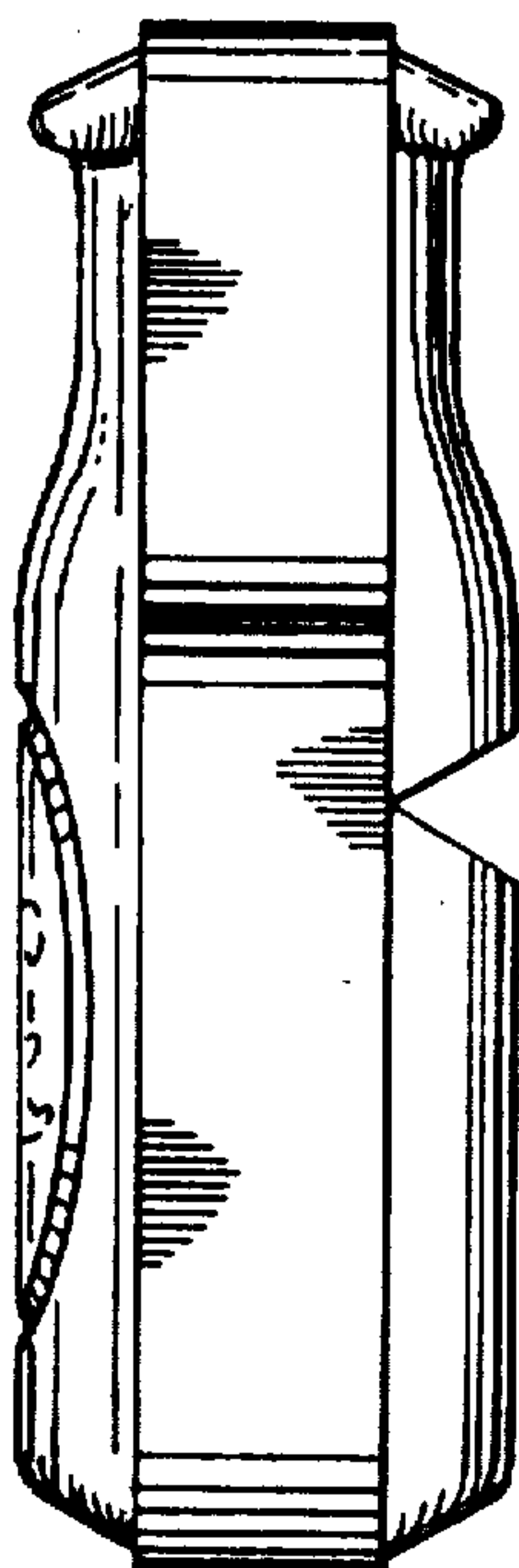

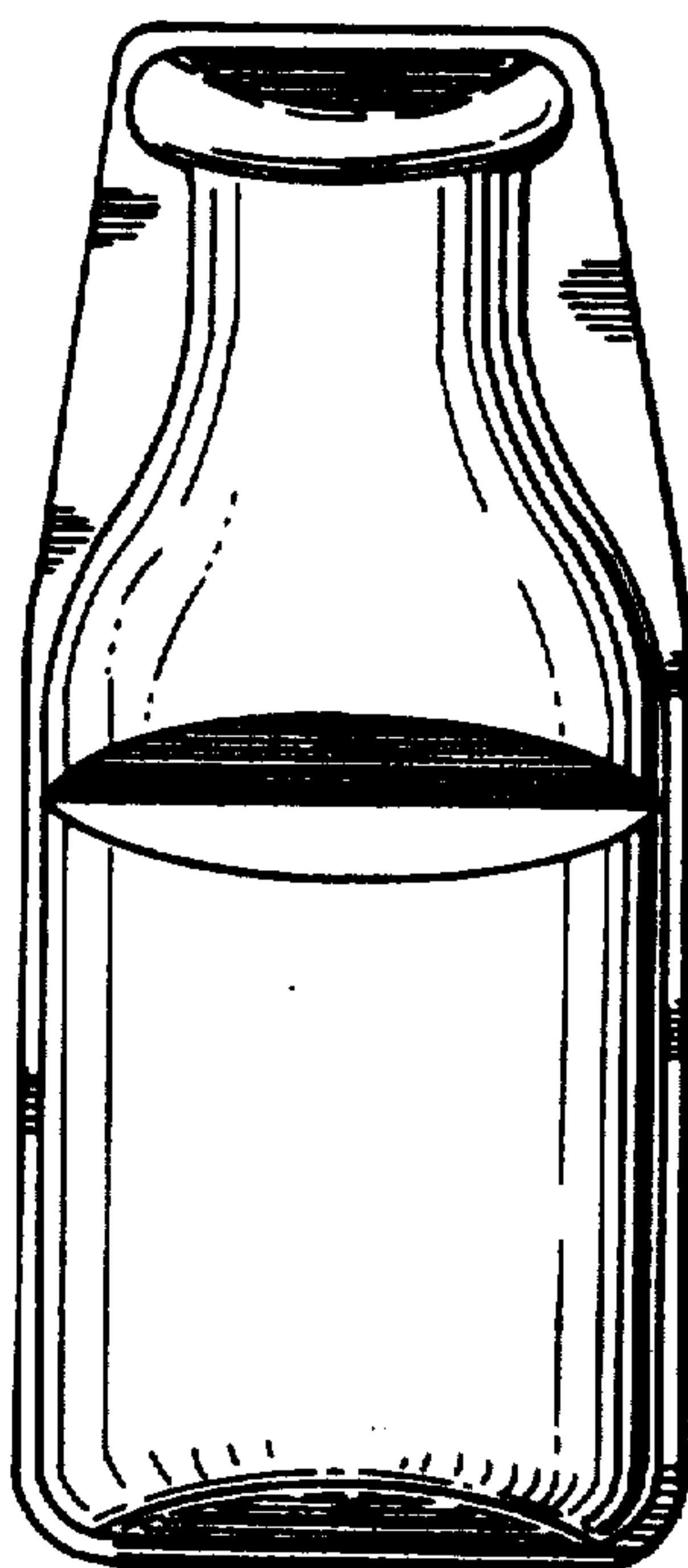

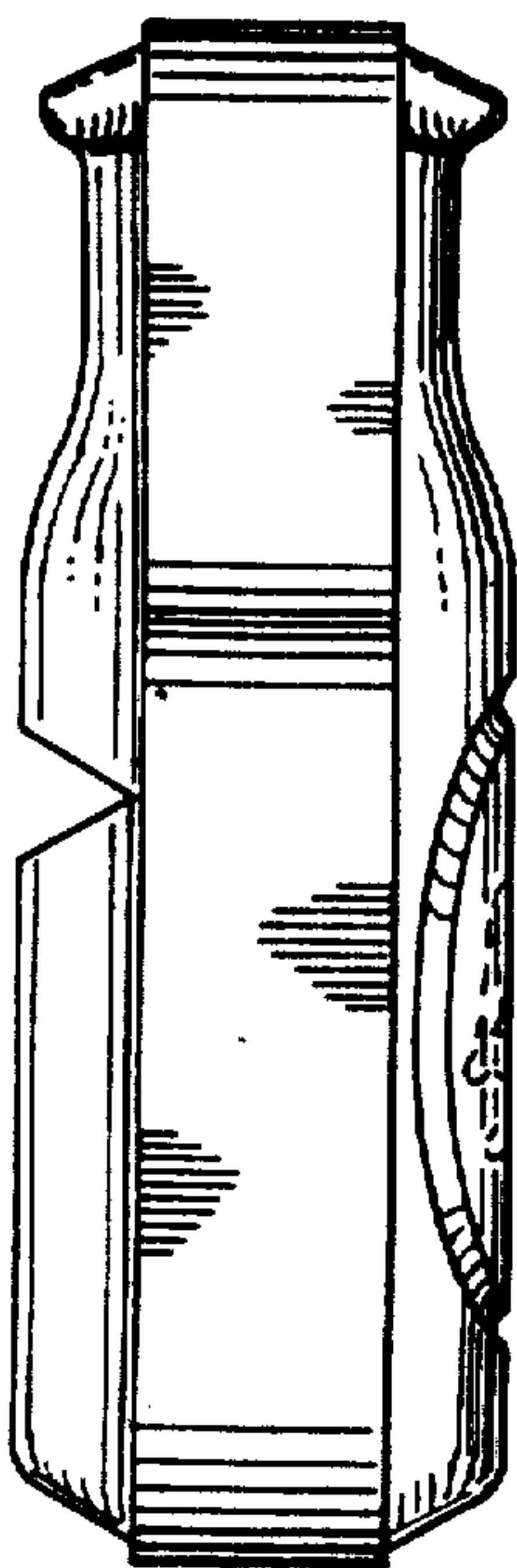

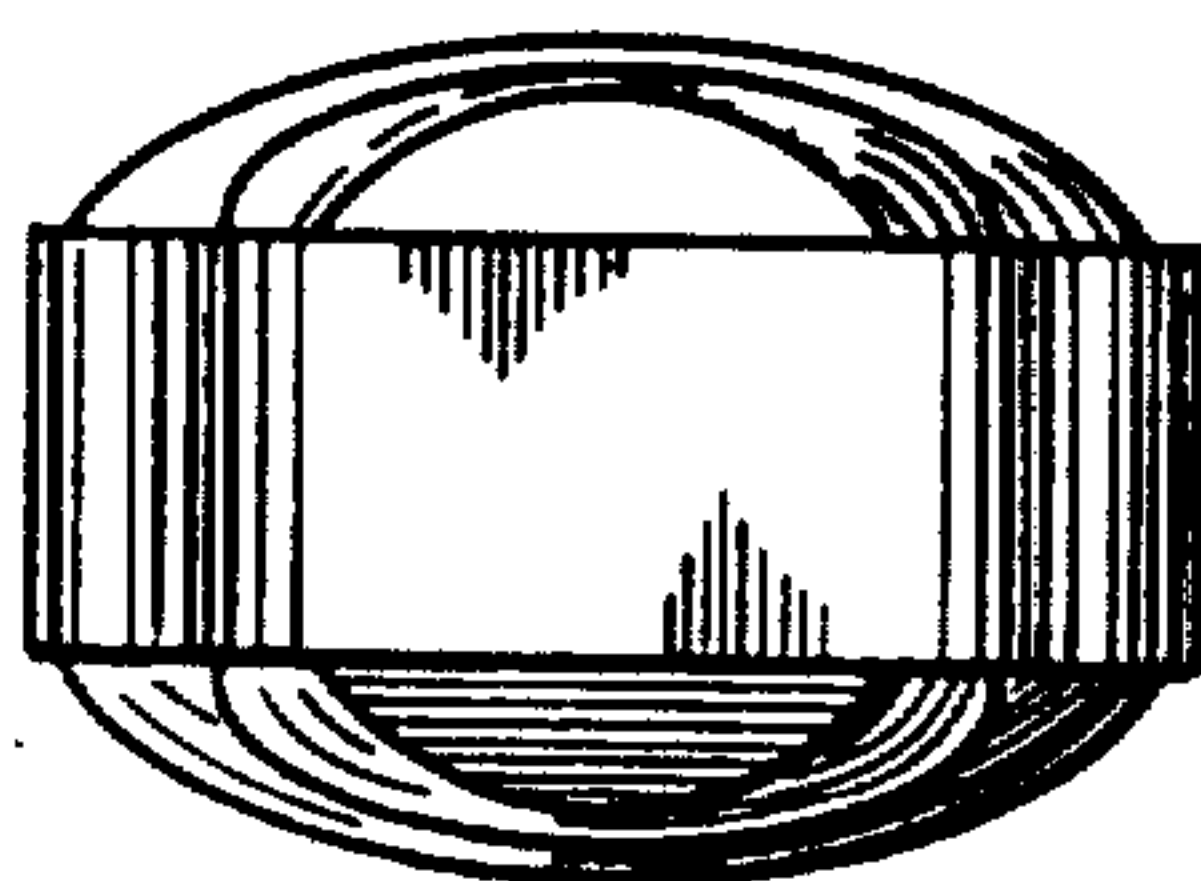

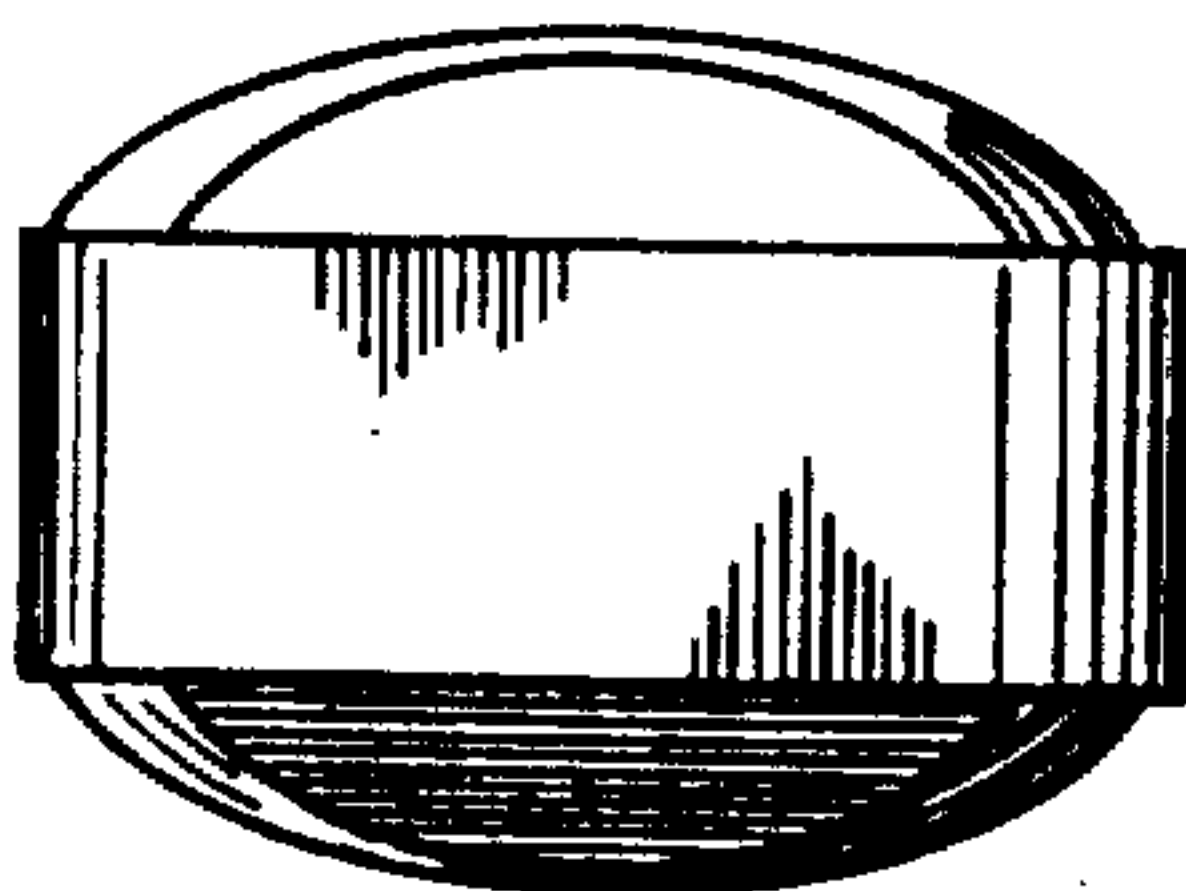
