The ornamental design for a stamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combination stamp and cap therefor showing my new design;  
 FIG. 2 is a front elevational view, the rear being identical;  
 FIG. 3 is a side elevational view, both sides being the same;  
 FIG. 4 is a top plan view;  
 FIG. 5 is a bottom plan view;  
 FIG. 6 is a perspective view of the stamp inverted with the cap removed;  
 FIG. 7 is a front elevational view of the stamp alone;  
 FIG. 8 is a side elevational view thereof;  
 FIG. 9 is a top plan view thereof;  
 FIG. 10 is a bottom plan view thereof; and  
 FIG. 11 is a cross sectional view taken on a vertical center plane in FIG. 3.

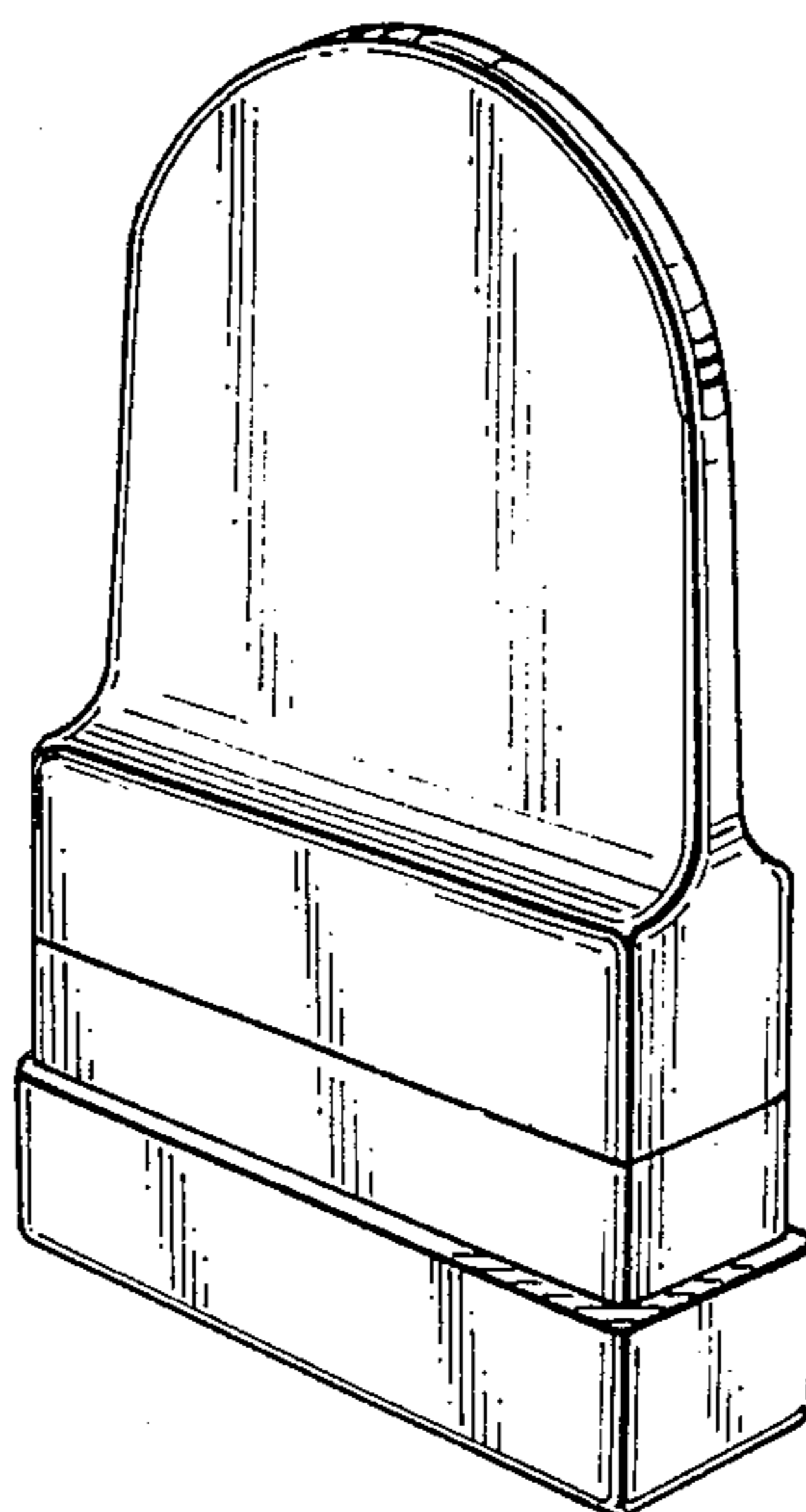

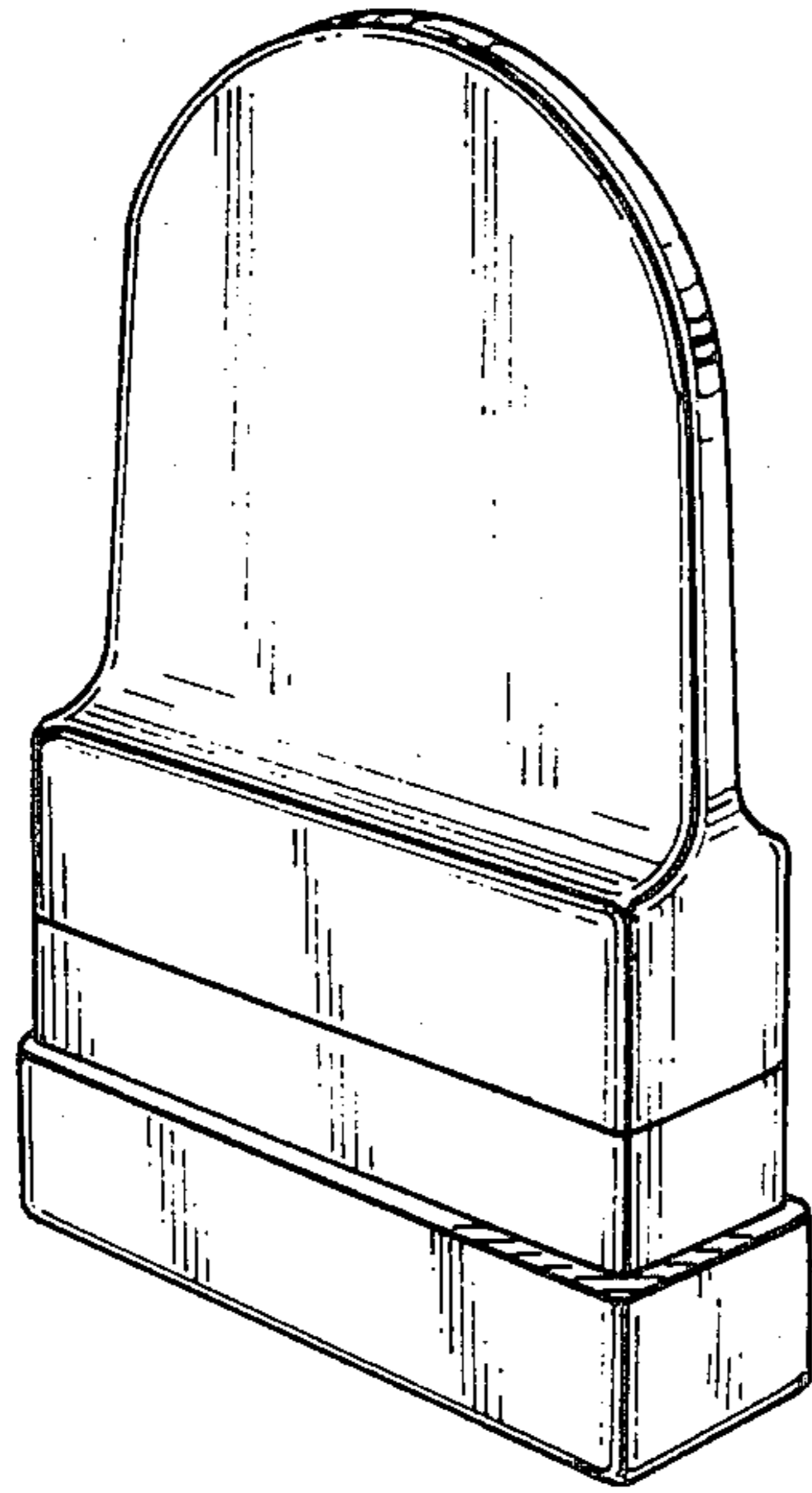

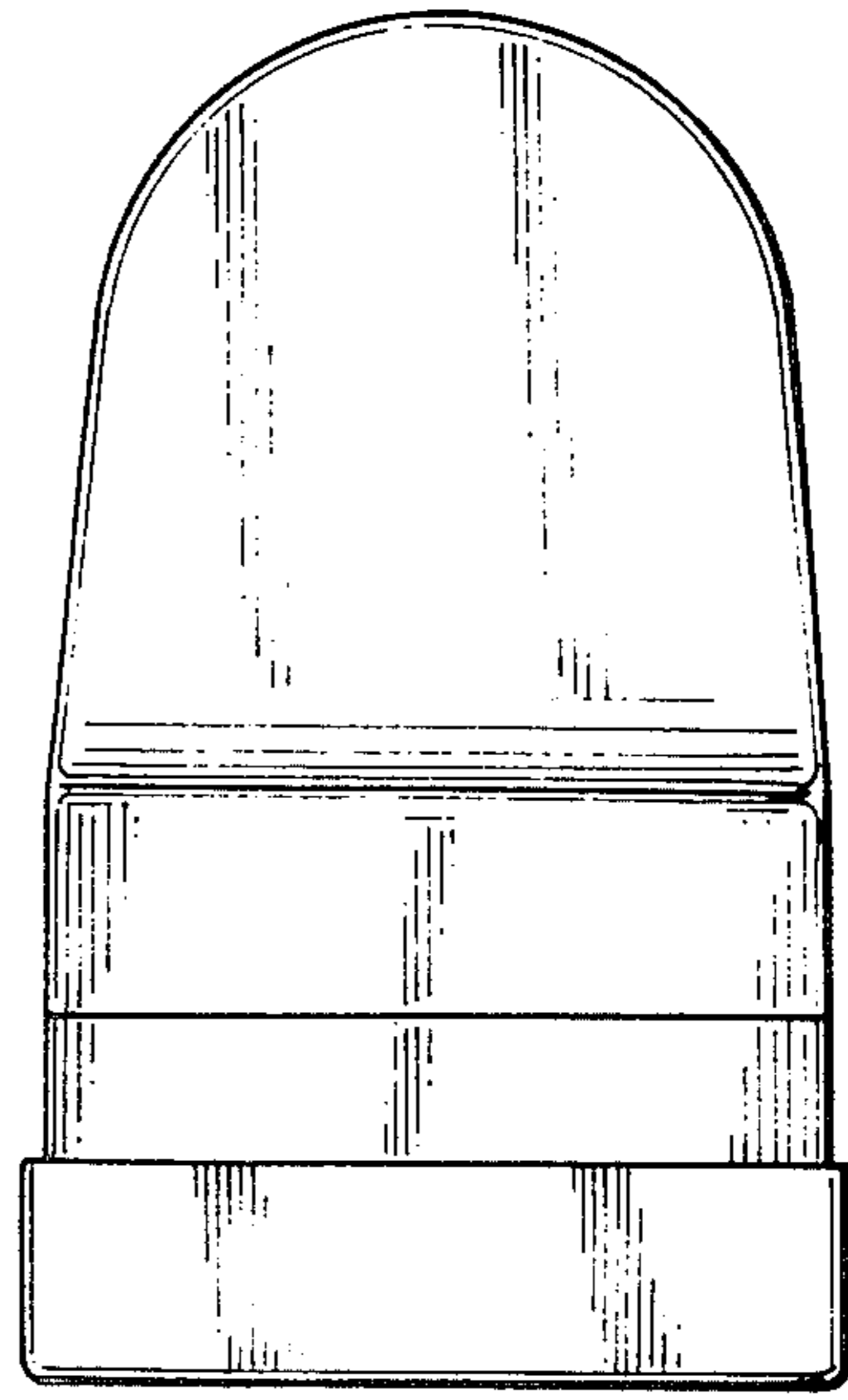

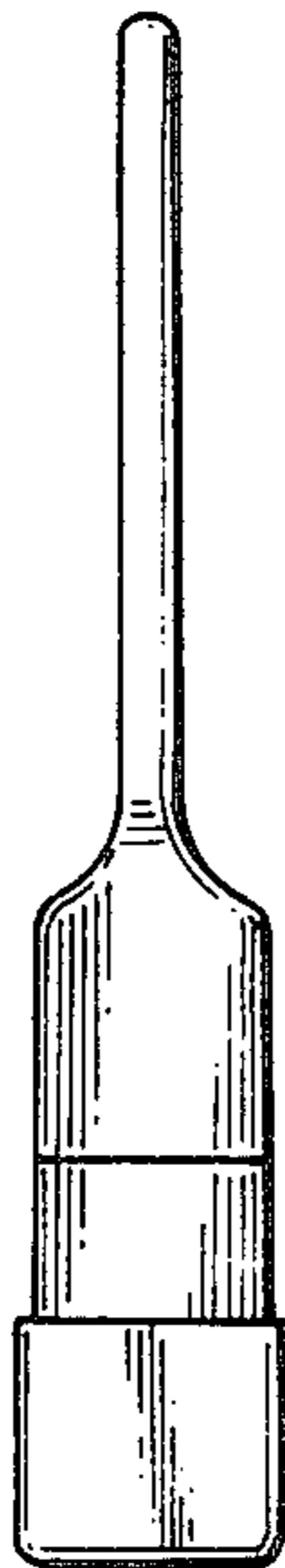

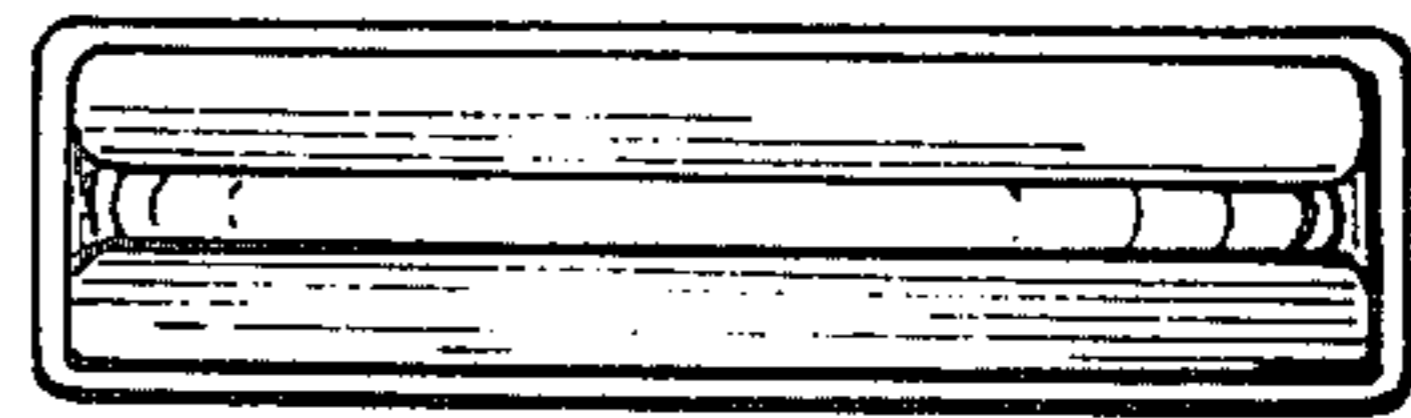

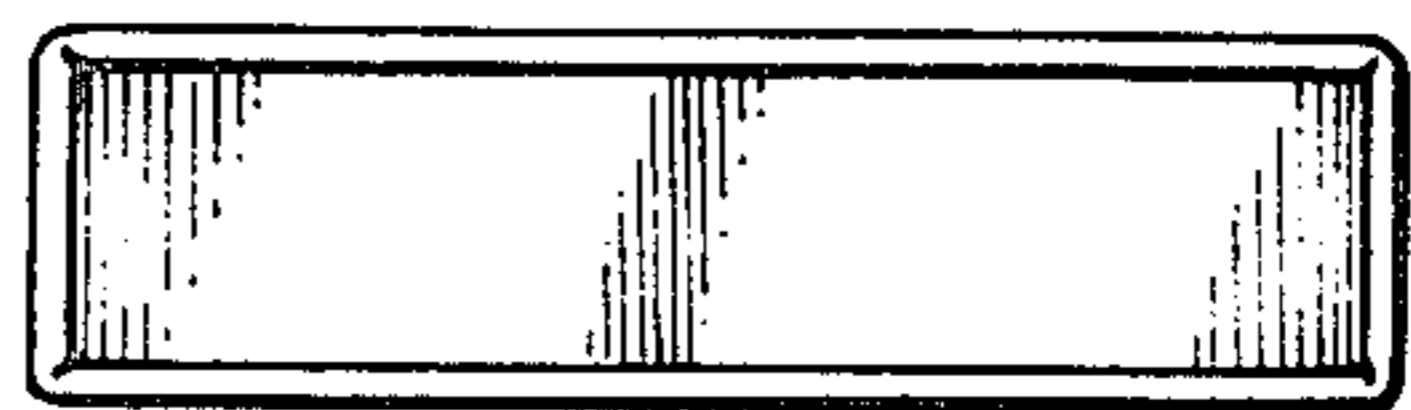

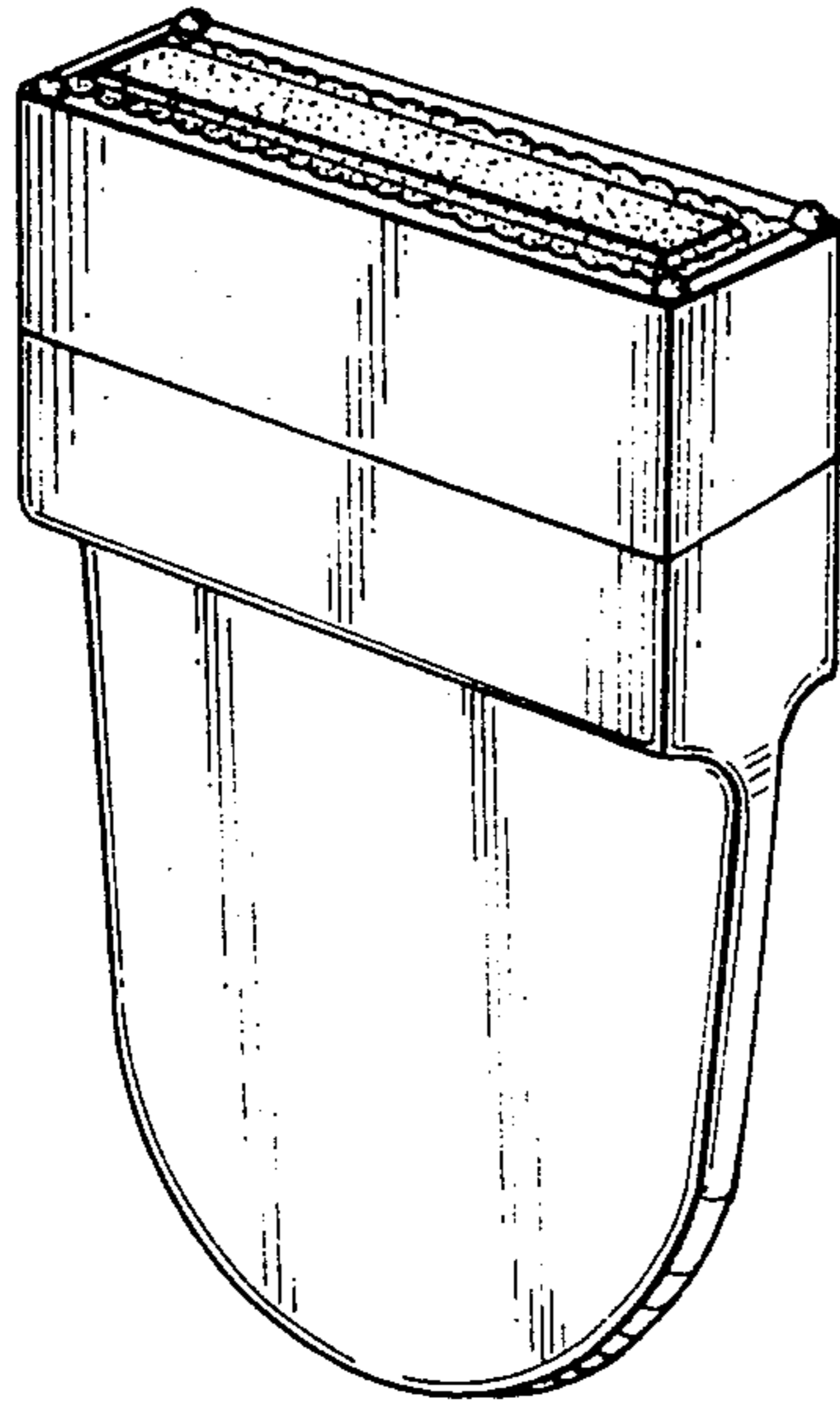

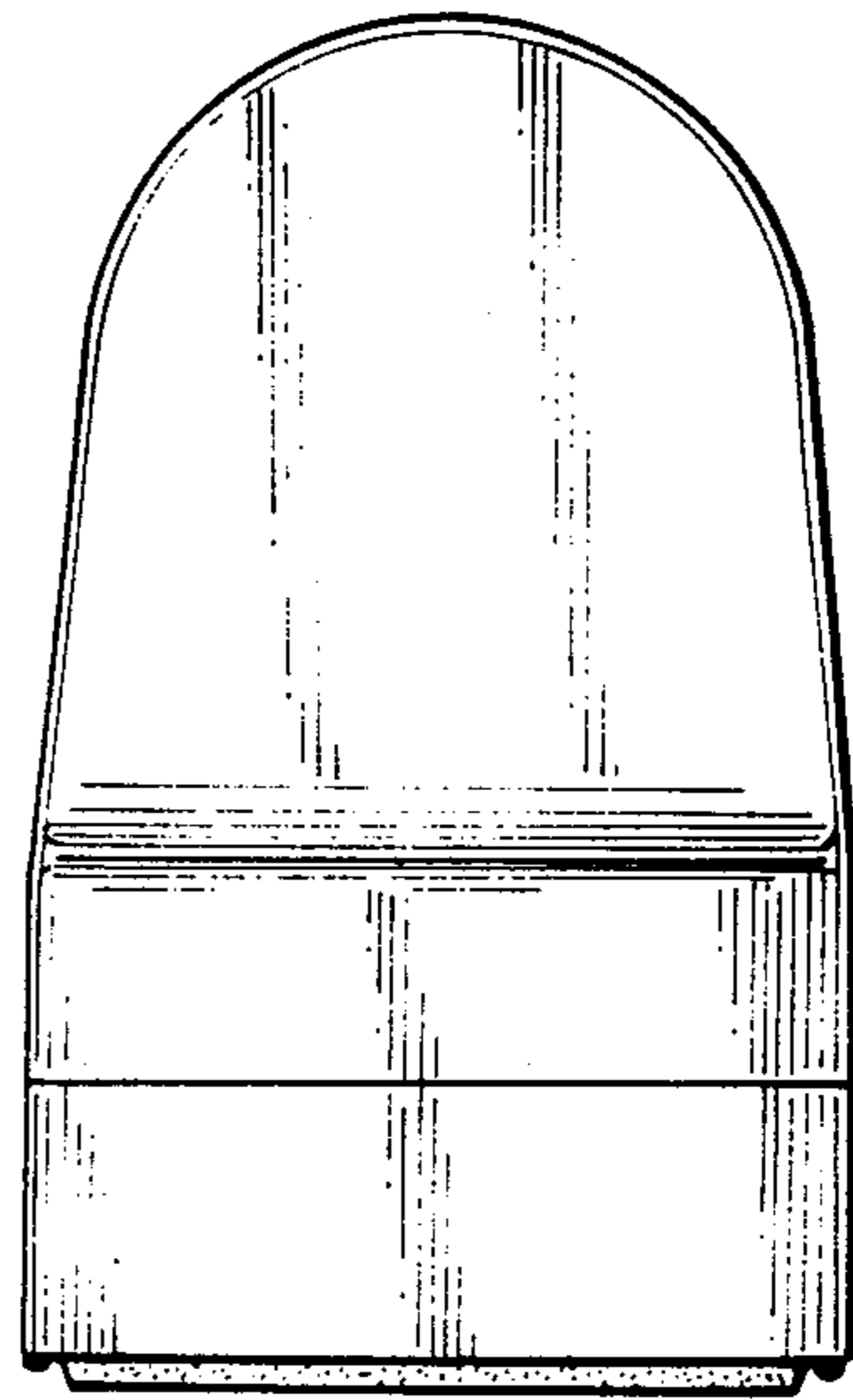

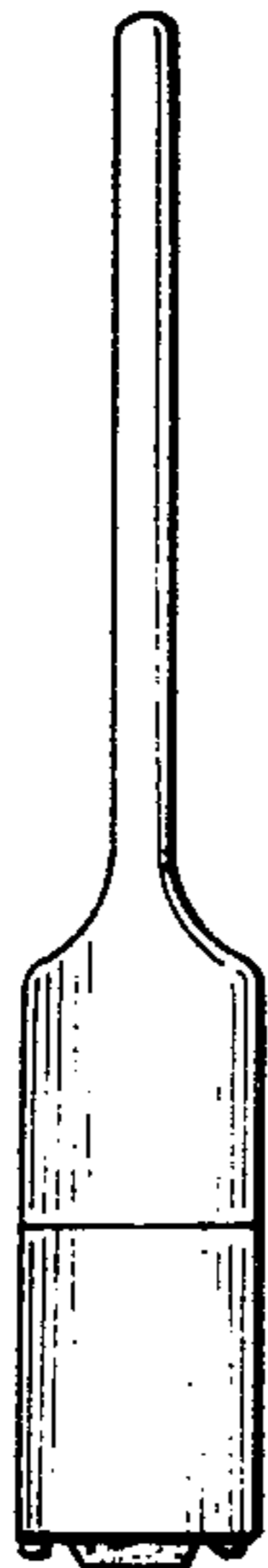

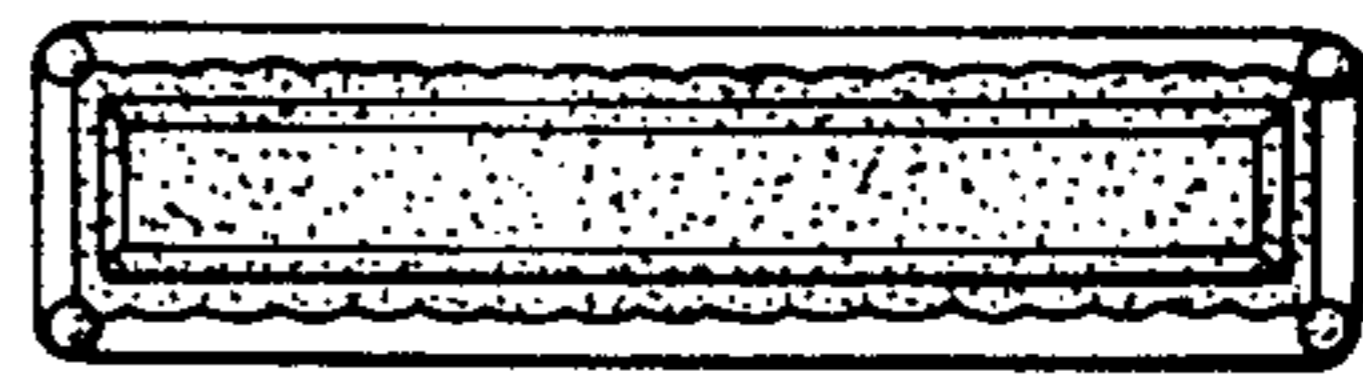

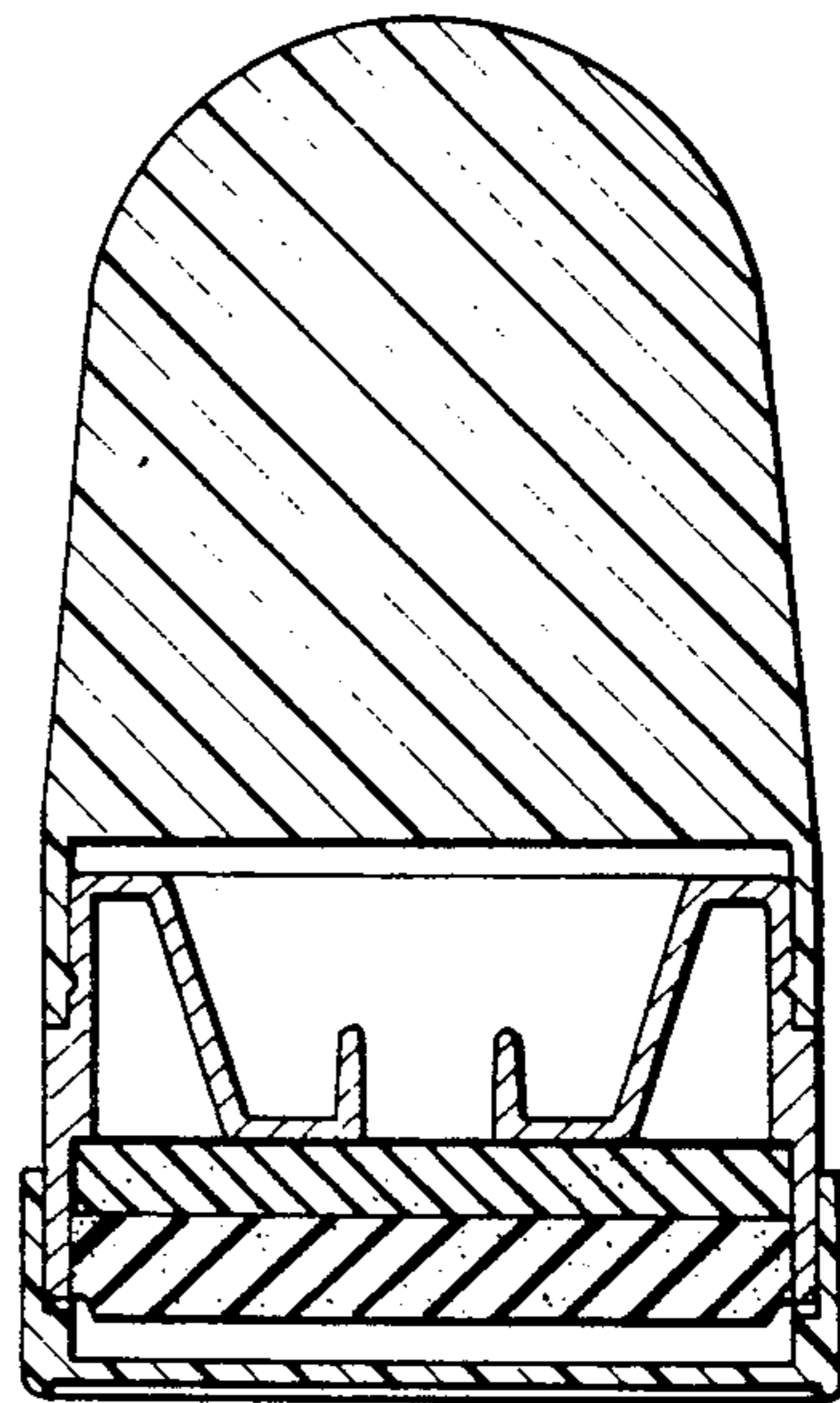
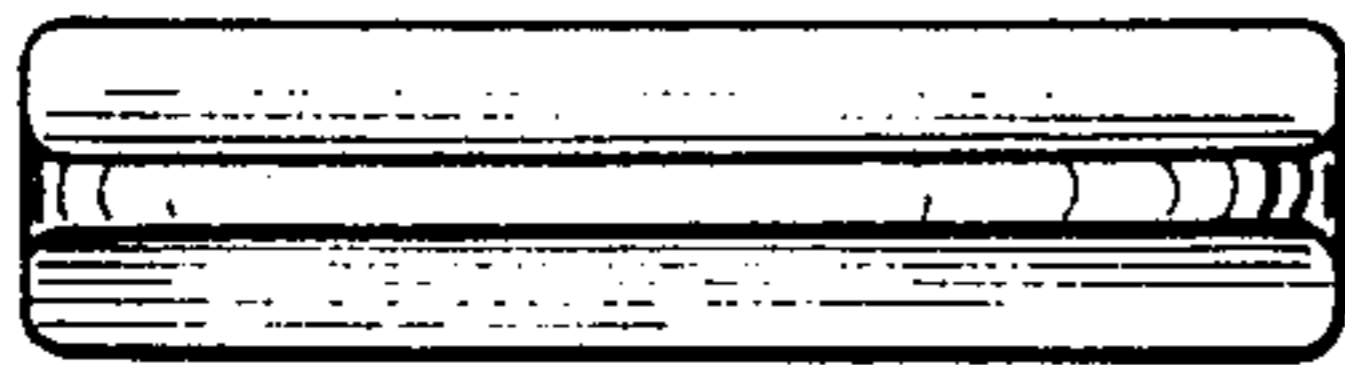
