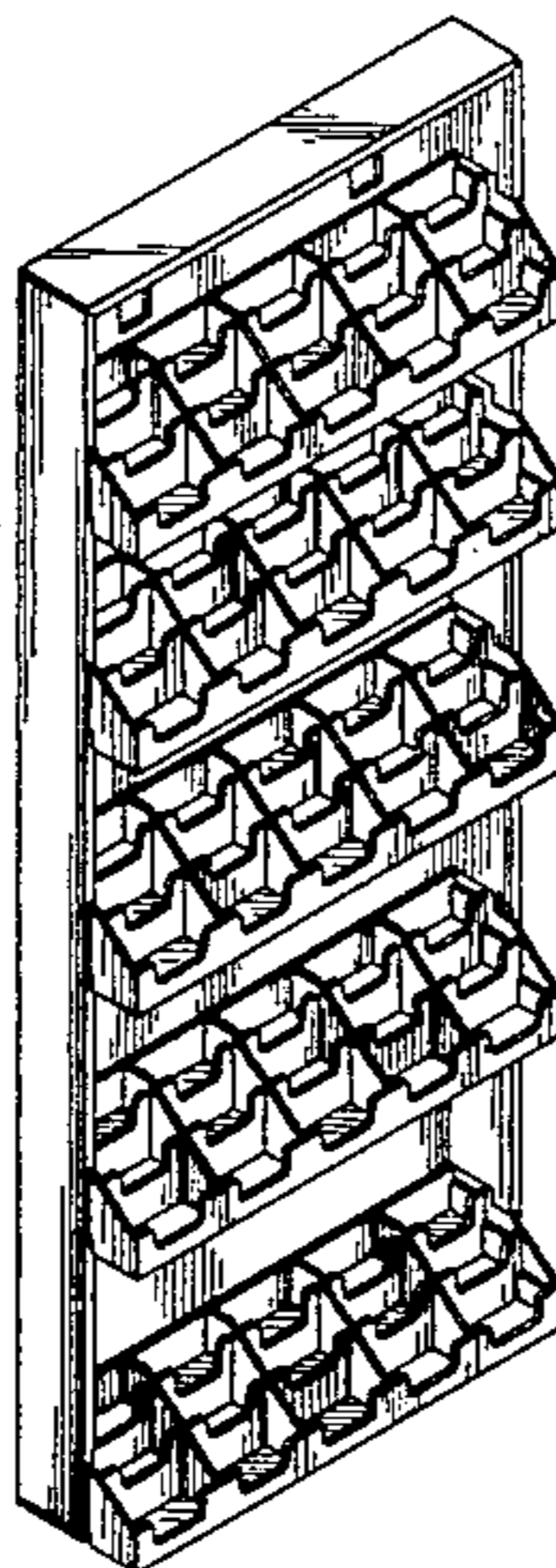

The ornamental design for display unit, as shown and described.

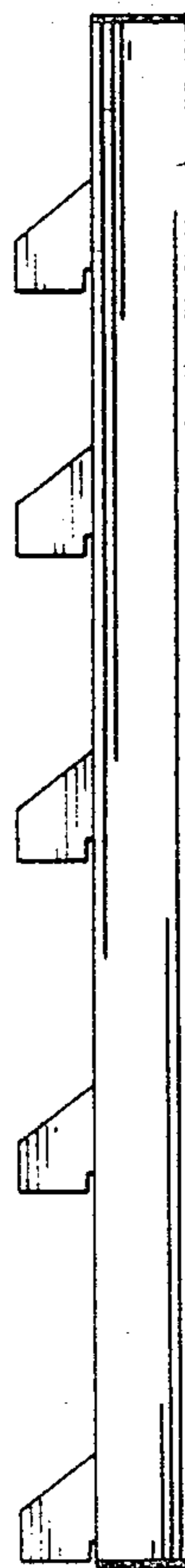
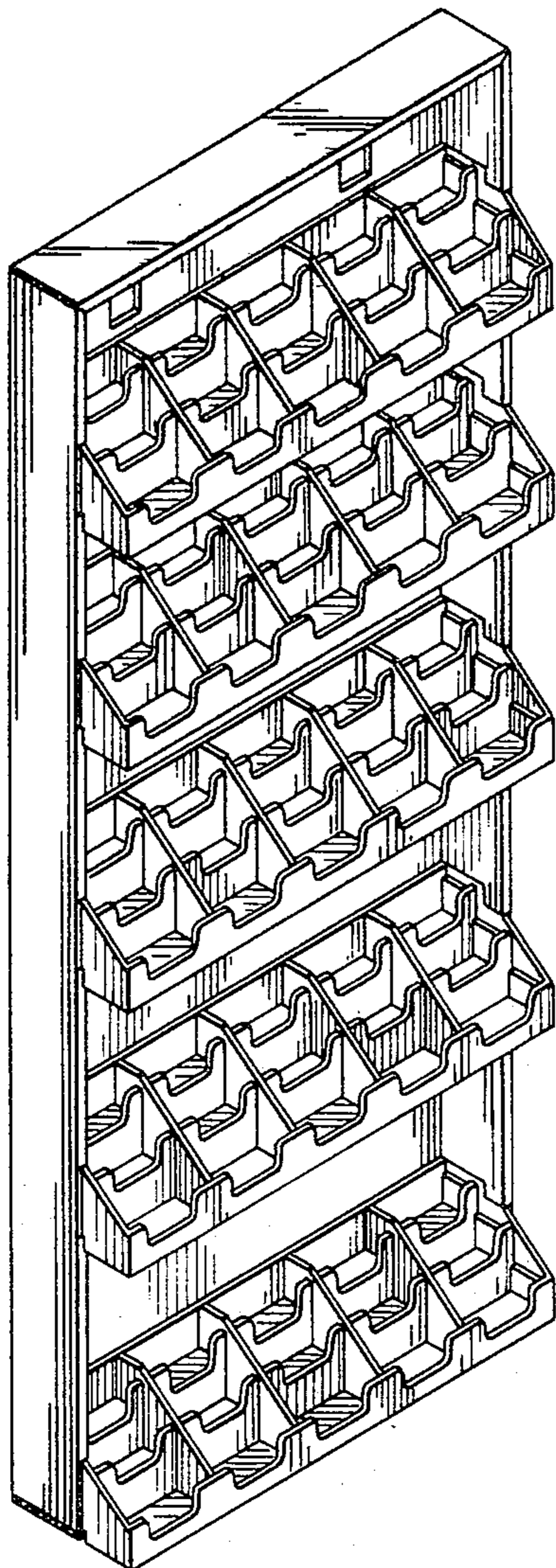
DESCRIPTION

FIG. 1 is a top and front perspective view of a display unit showing my new design;

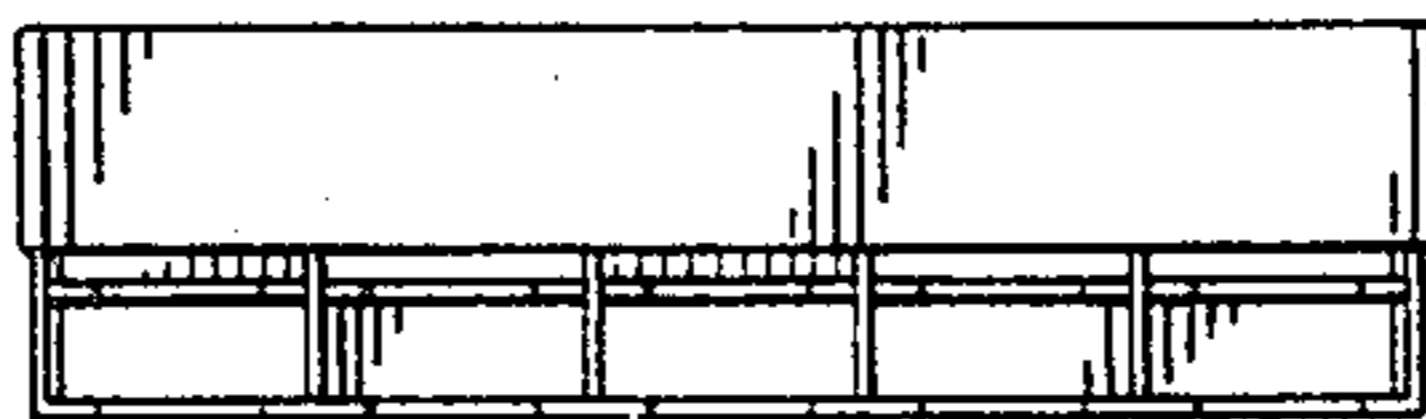
FIG. 2 is a side elevational view taken from the right of FIG. 1; the opposite side being a mirror image;

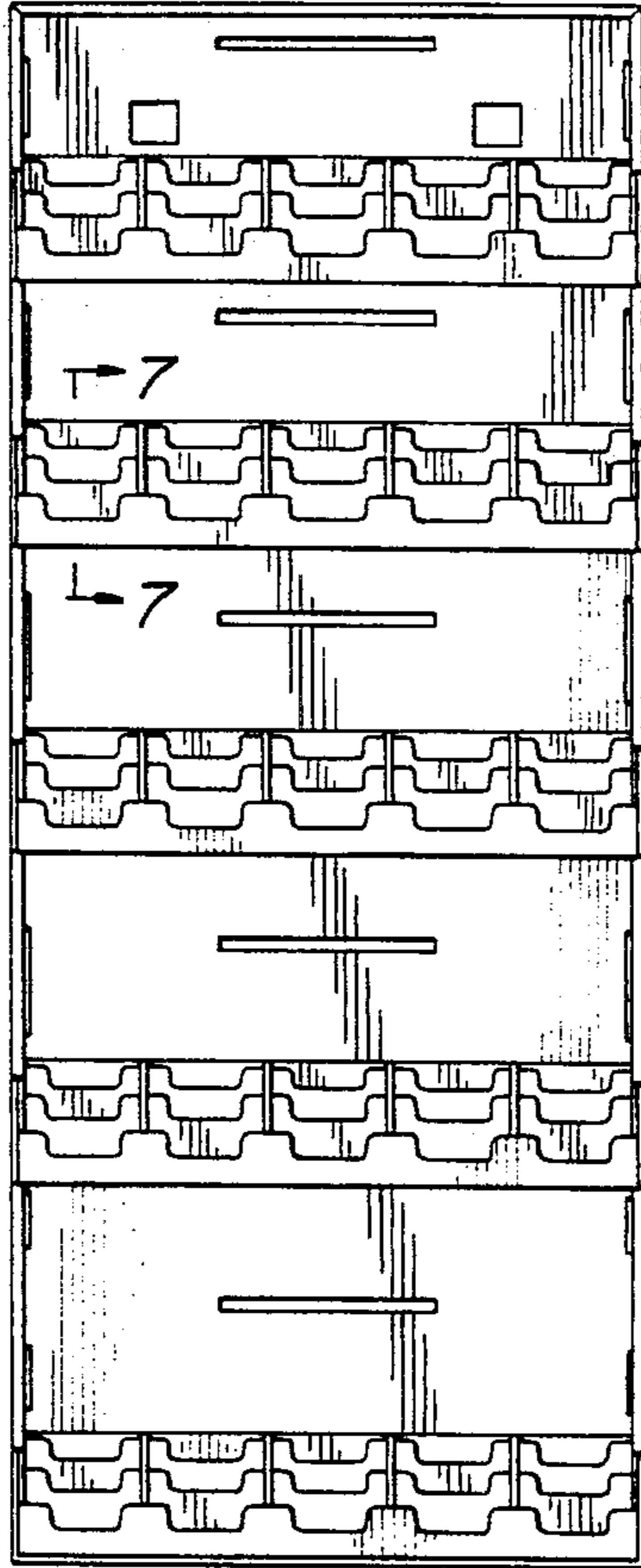

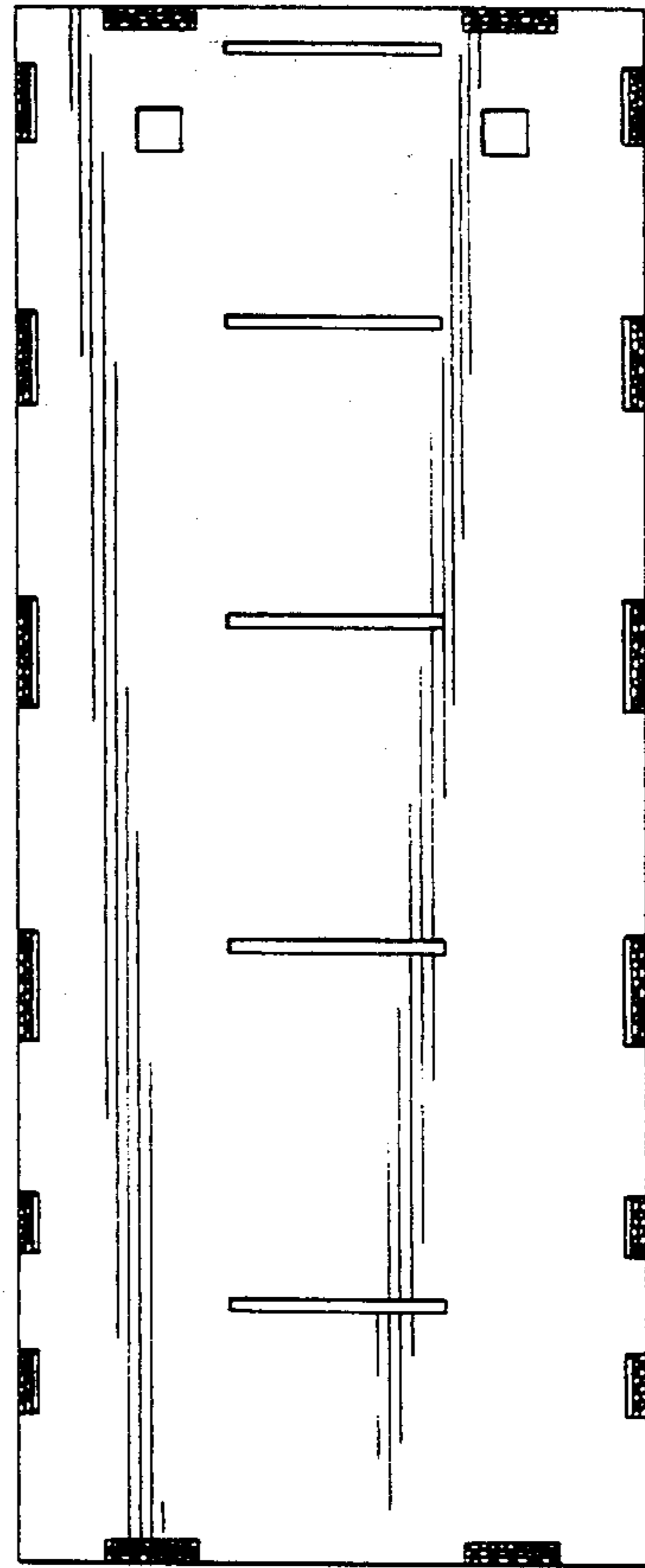

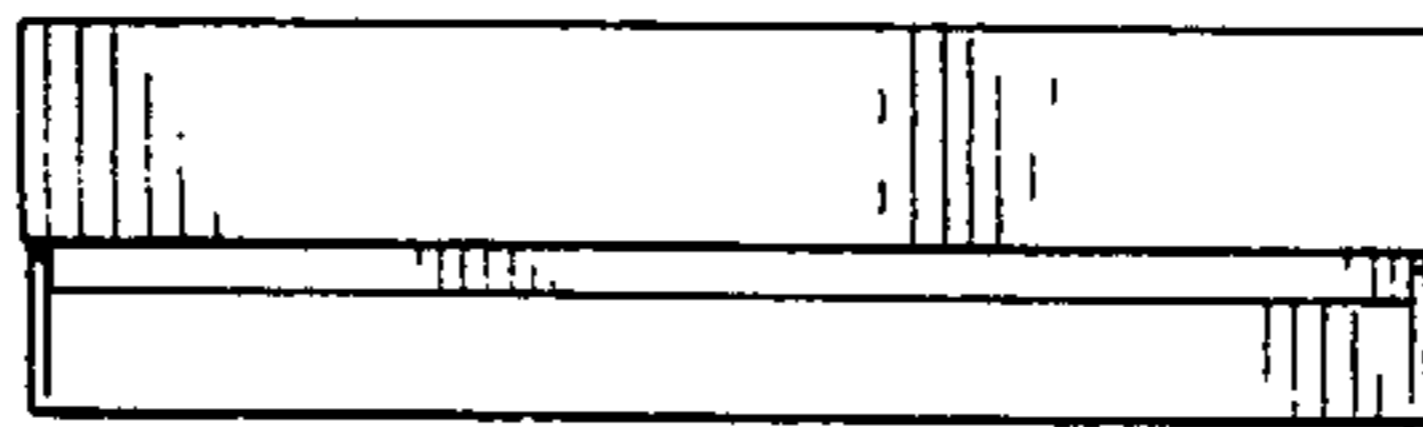

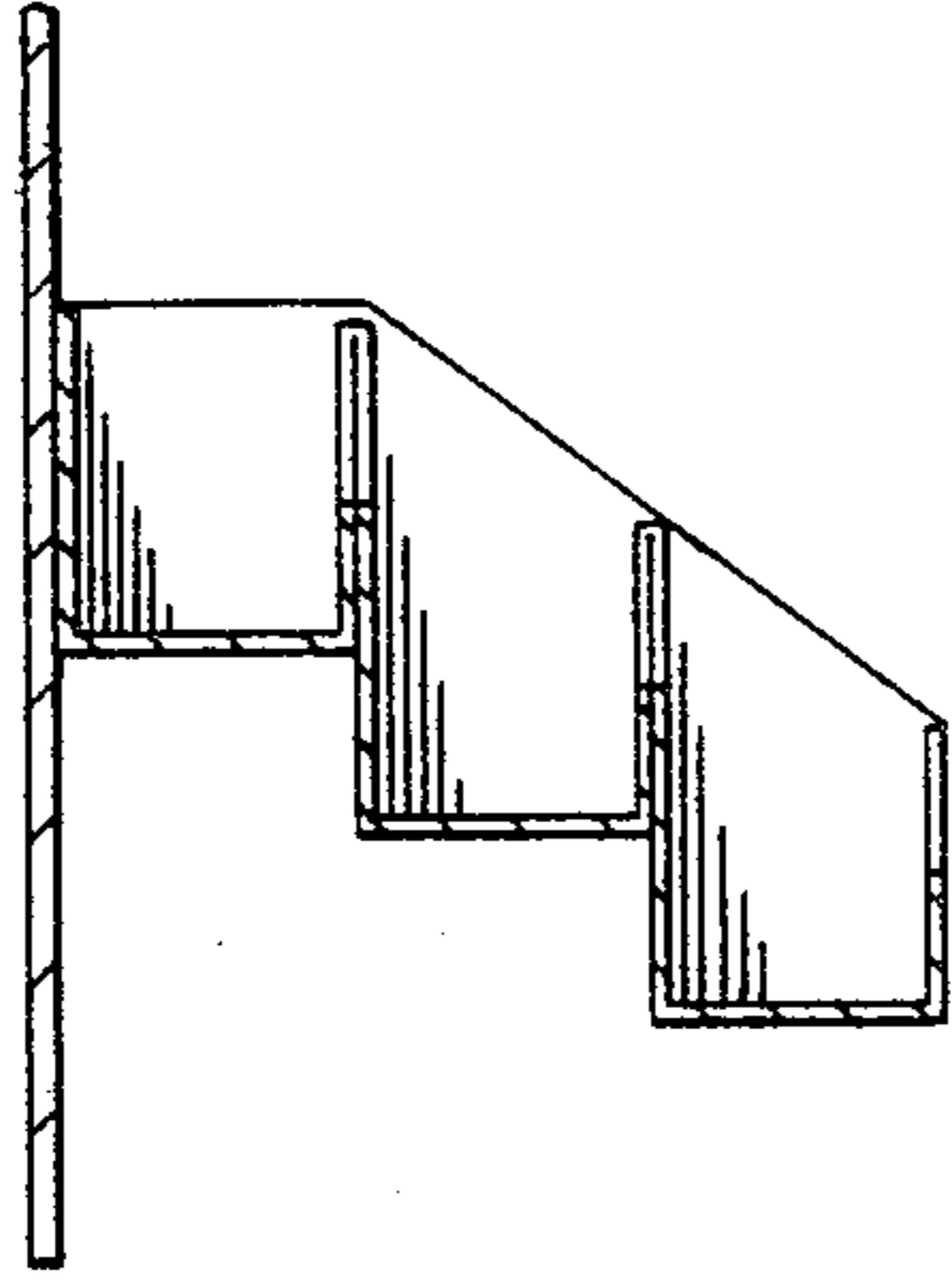

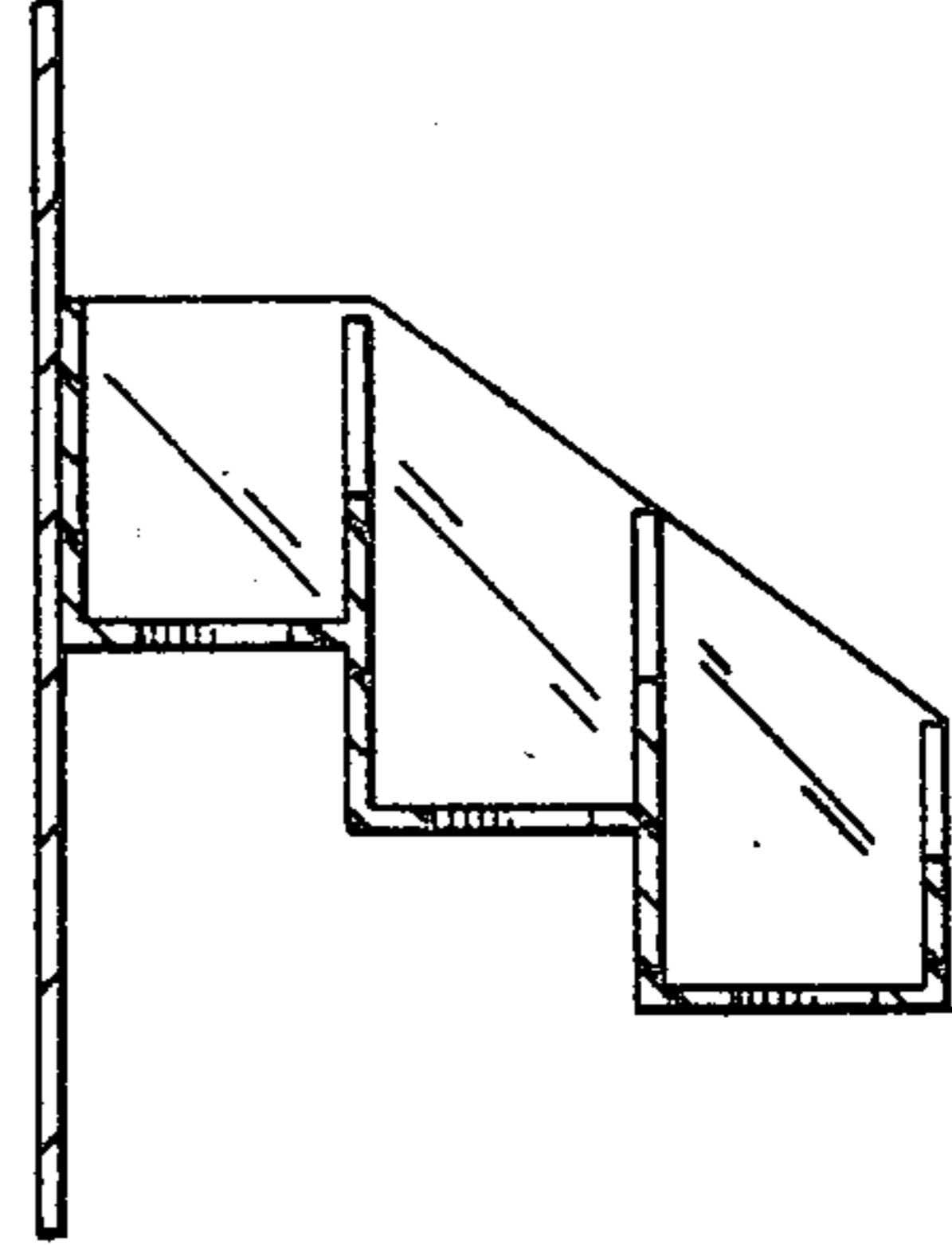

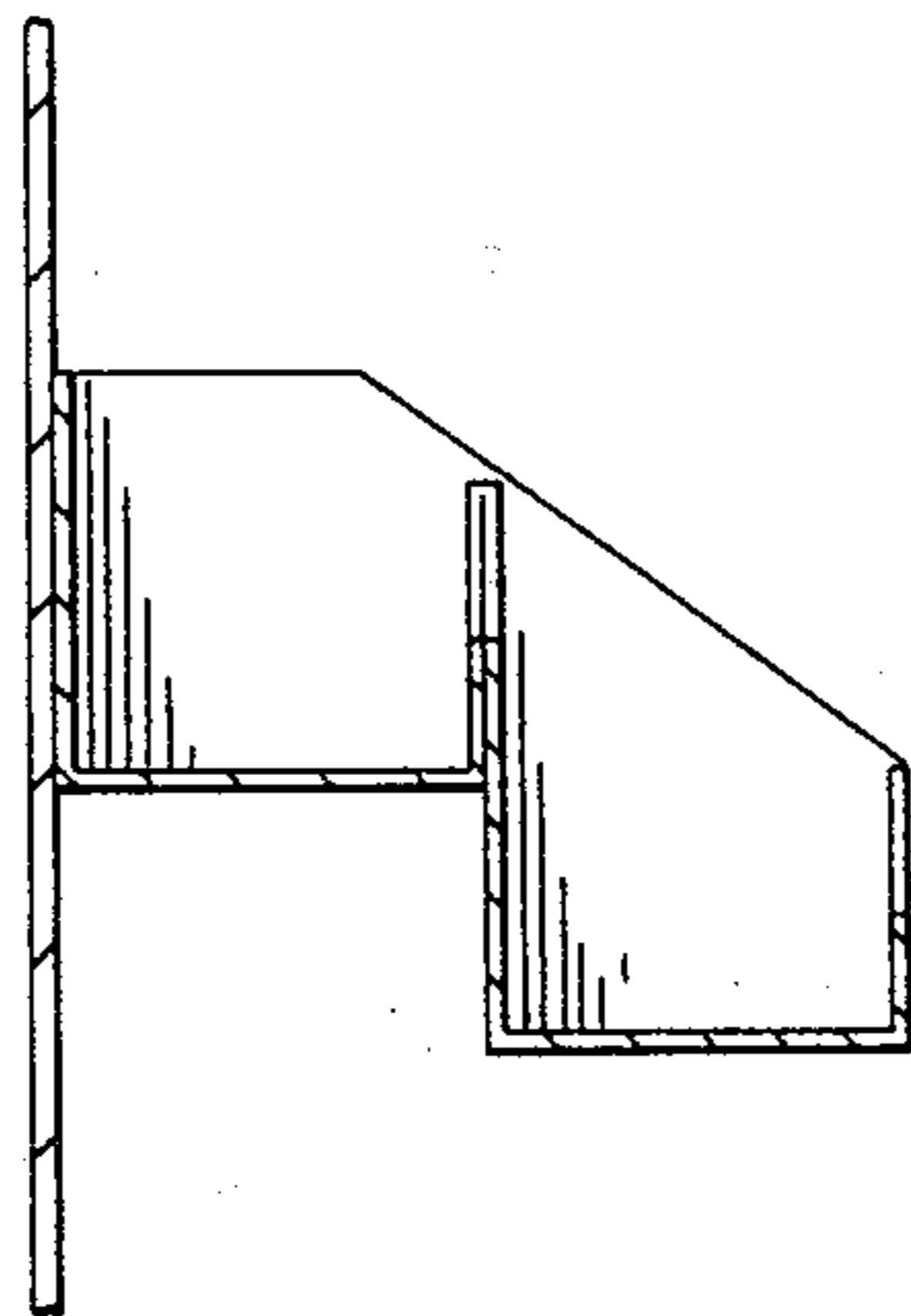

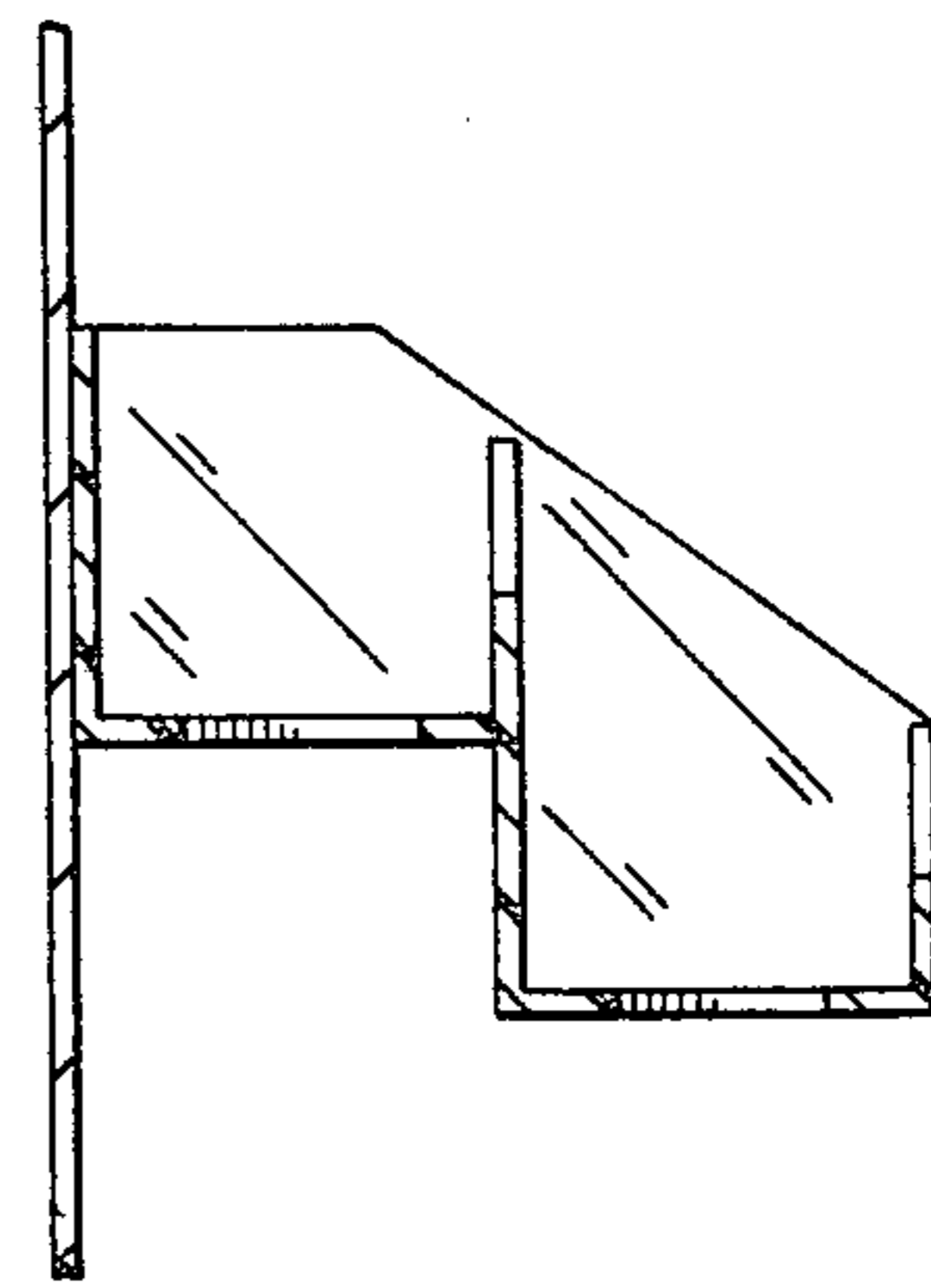

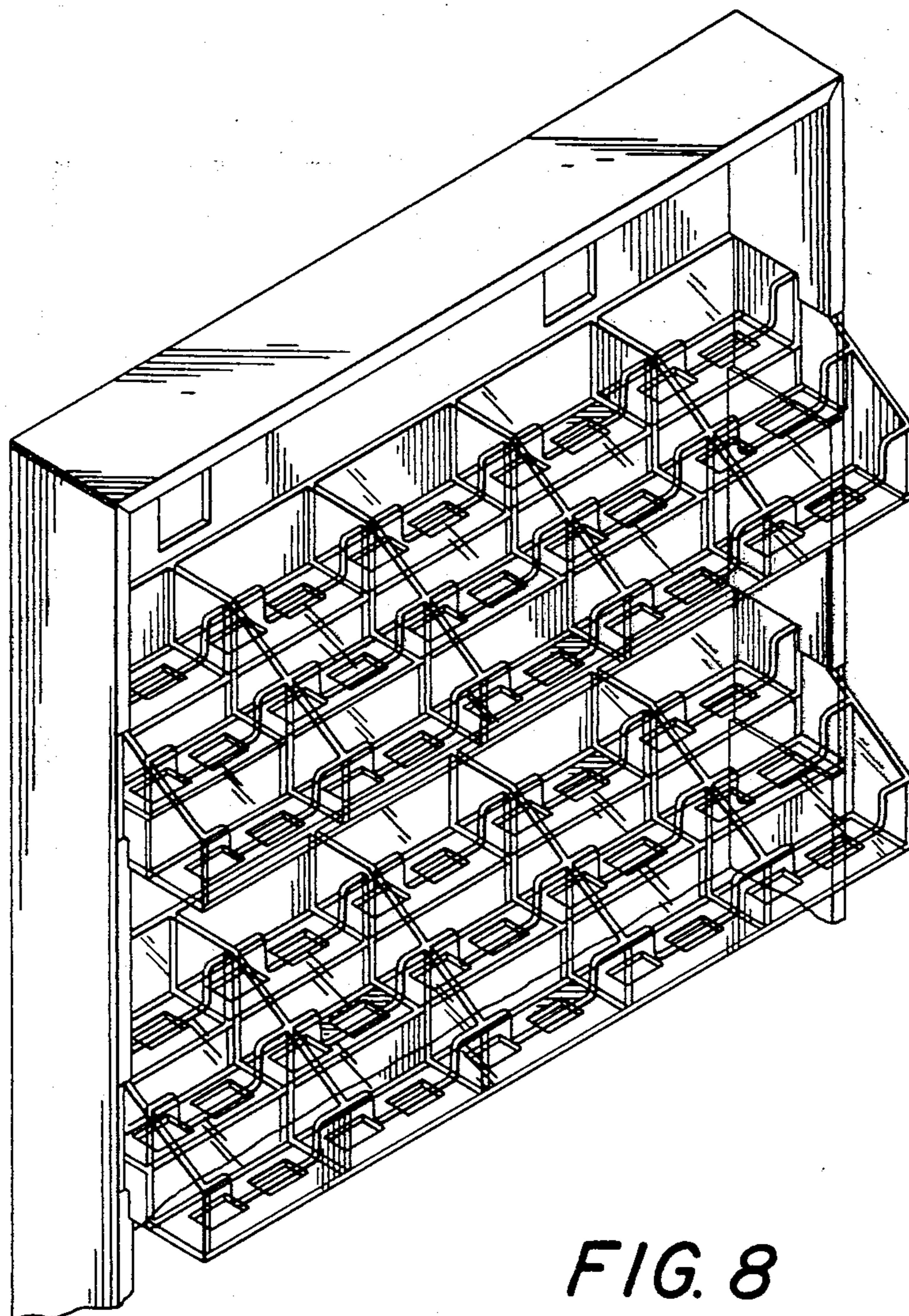

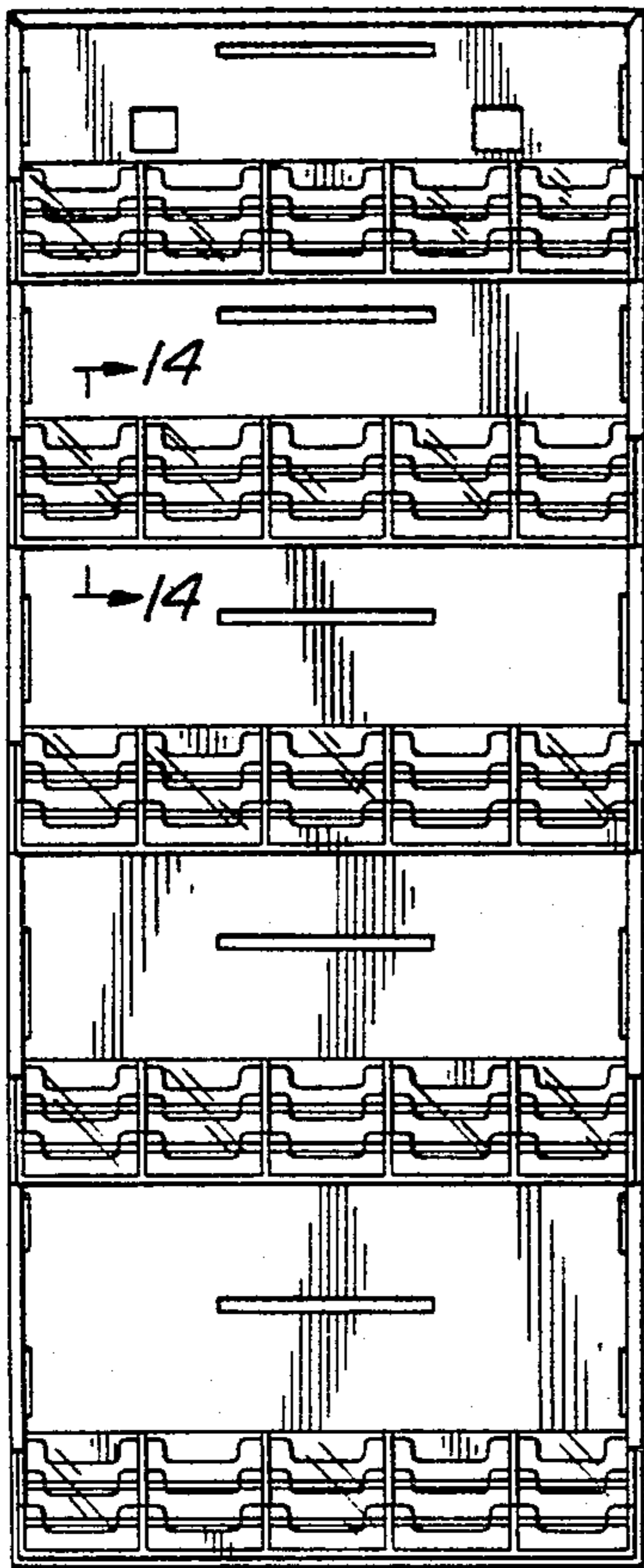

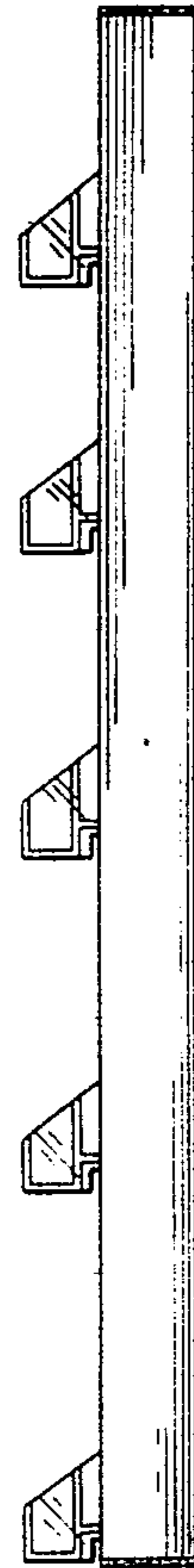
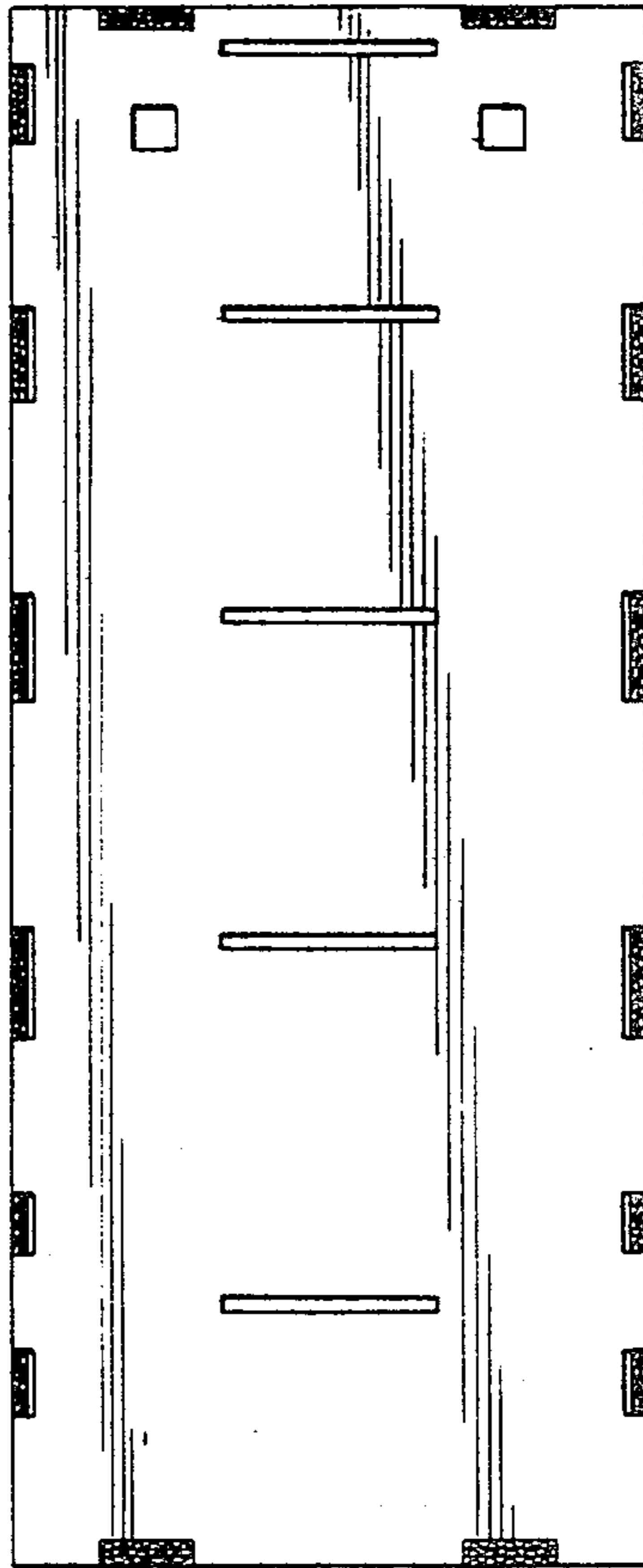

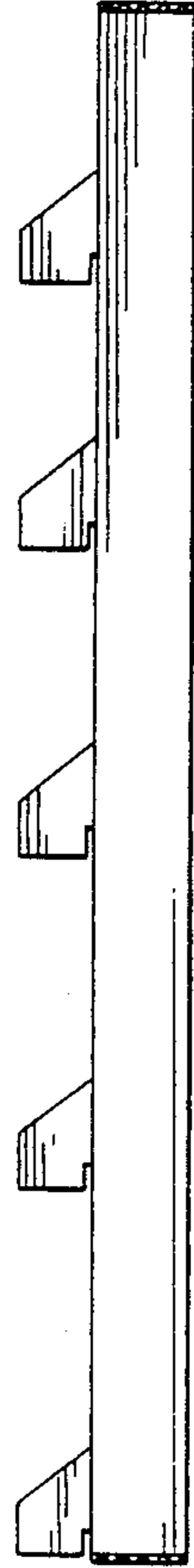
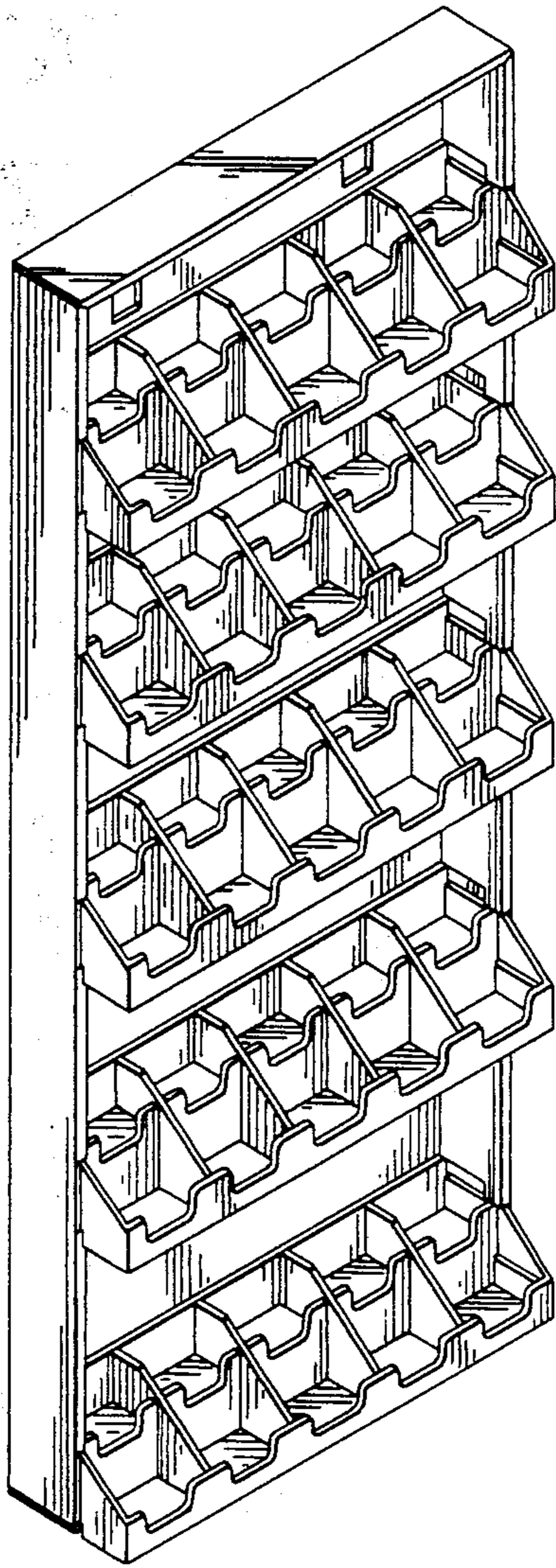

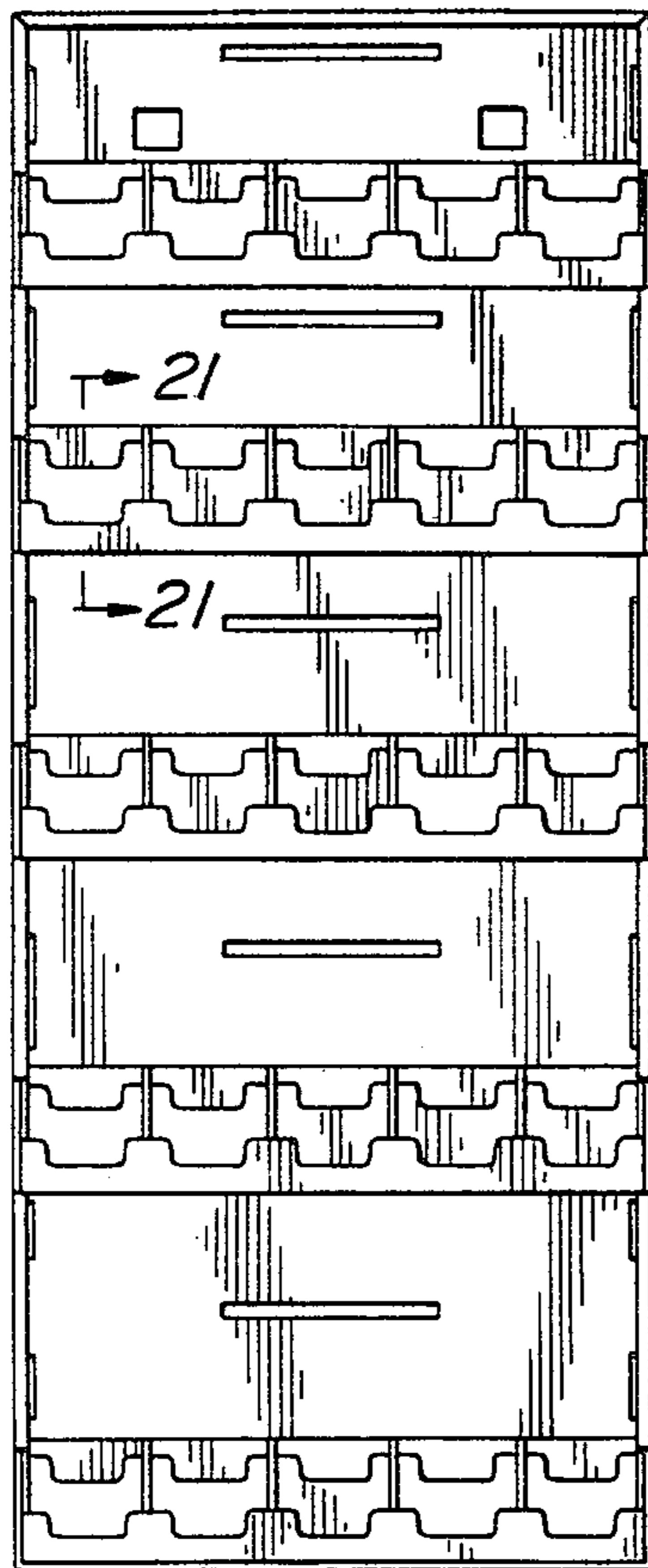

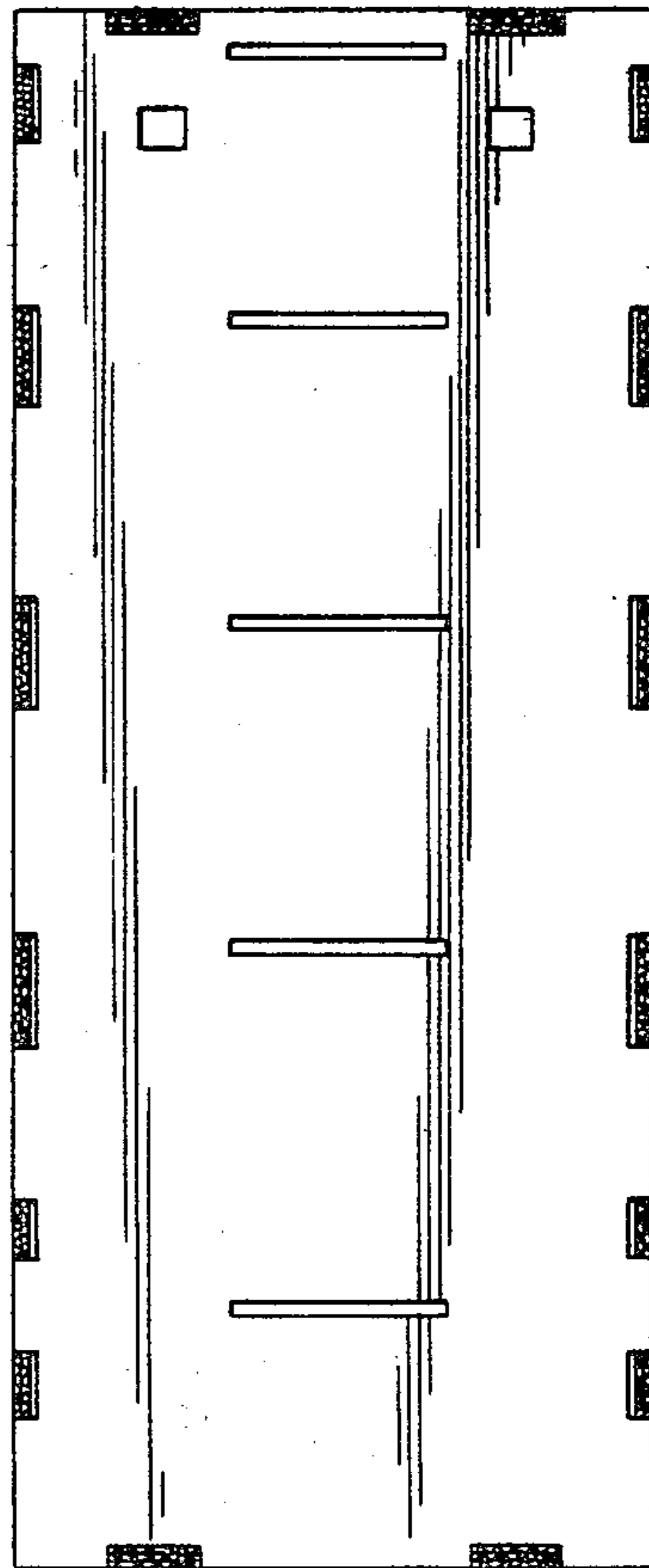

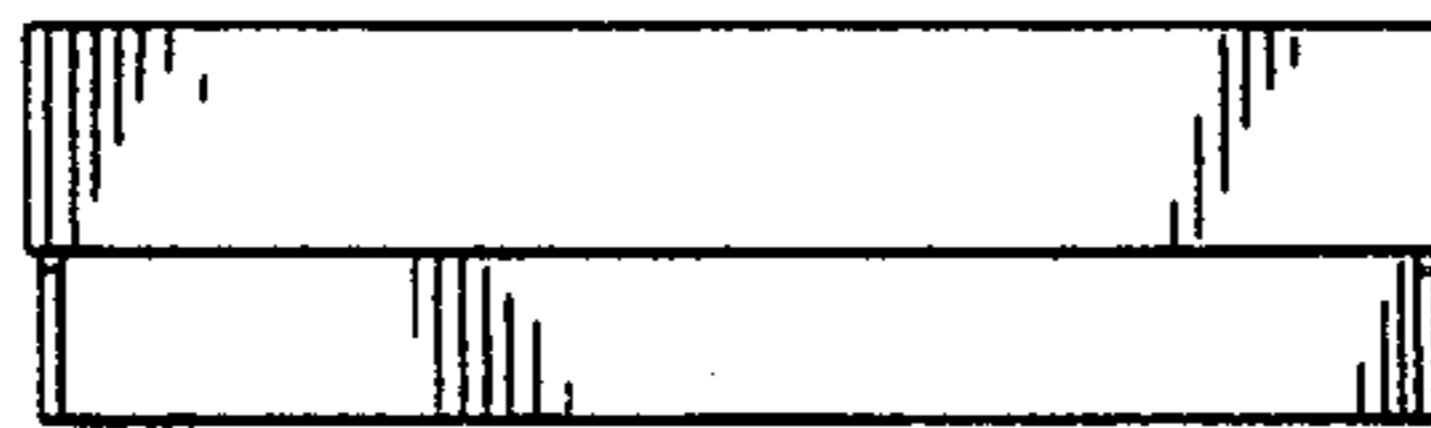

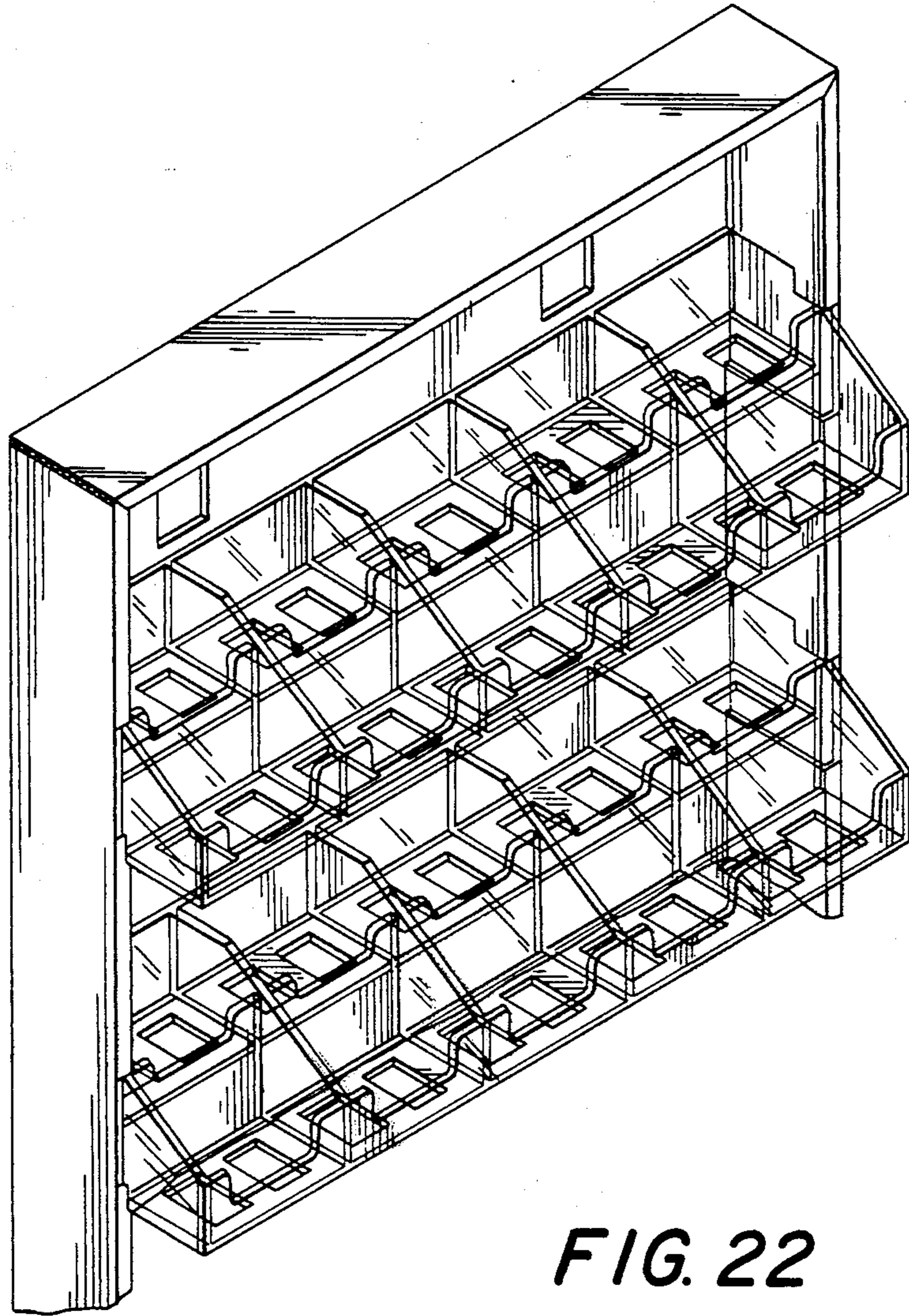

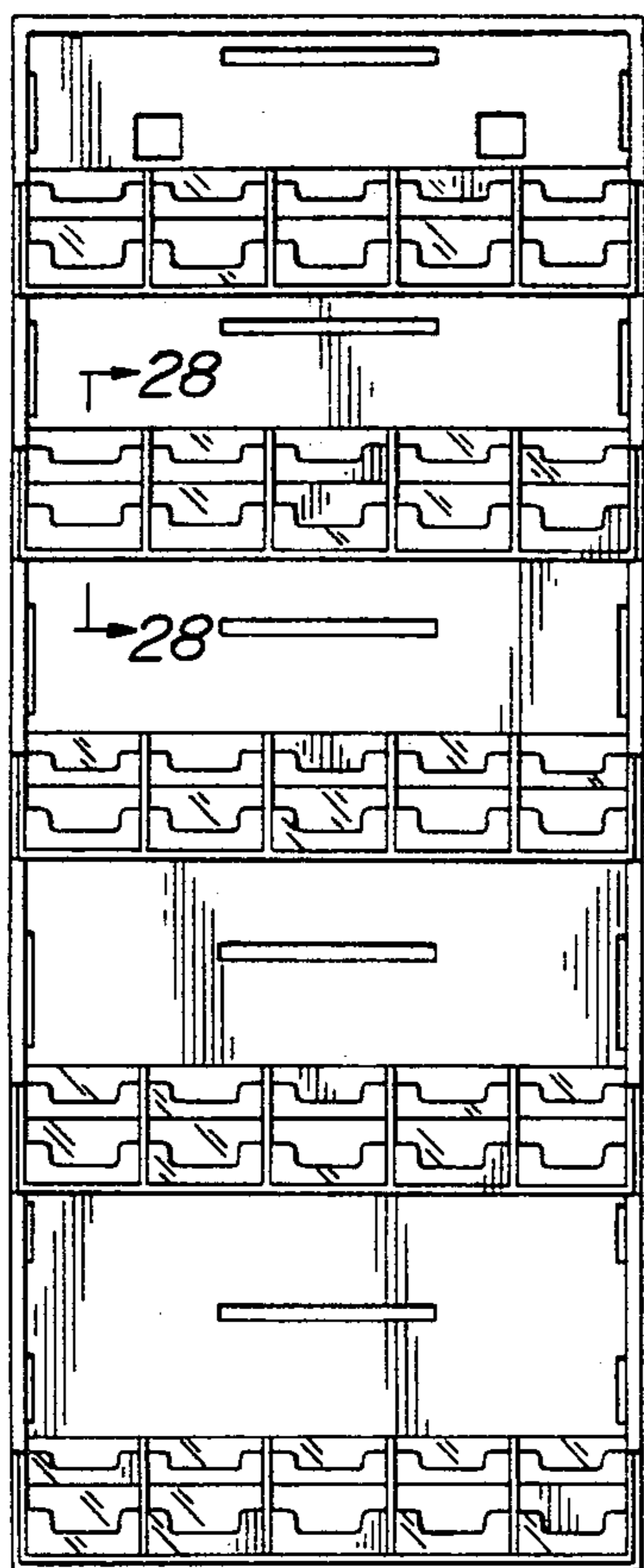




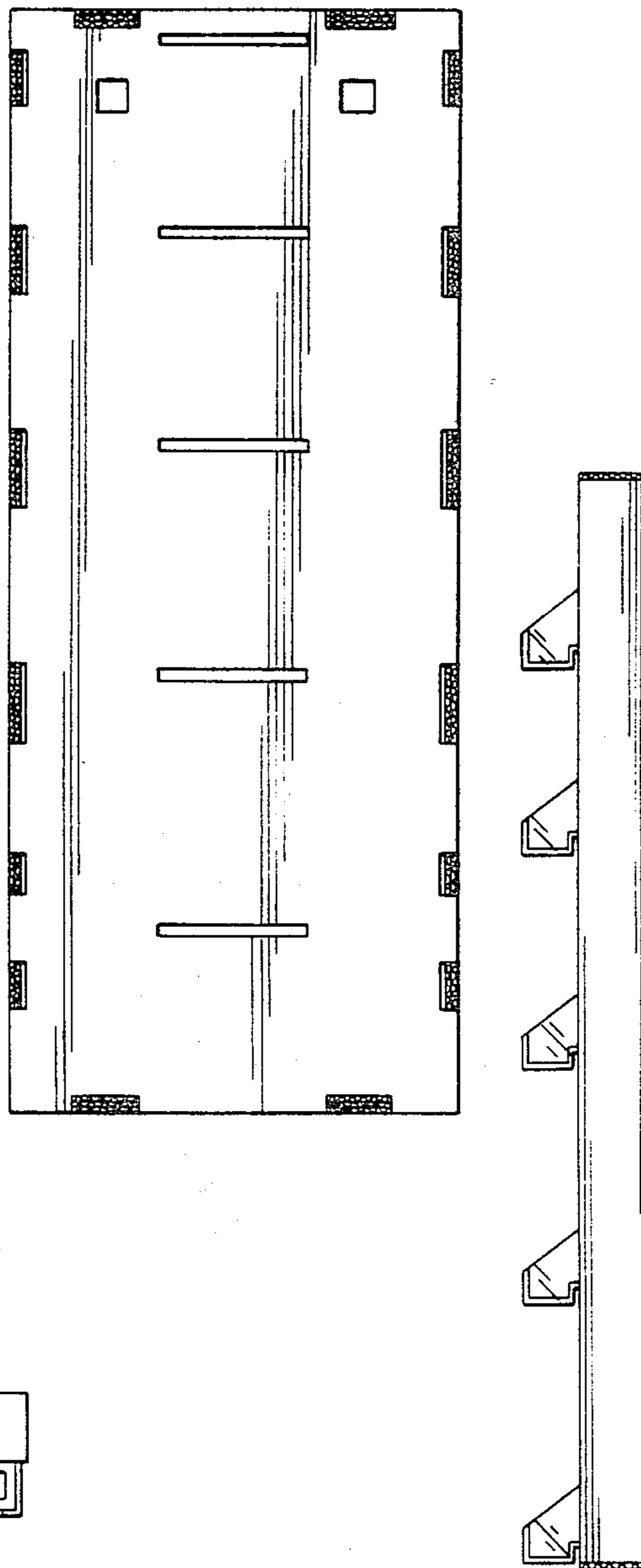

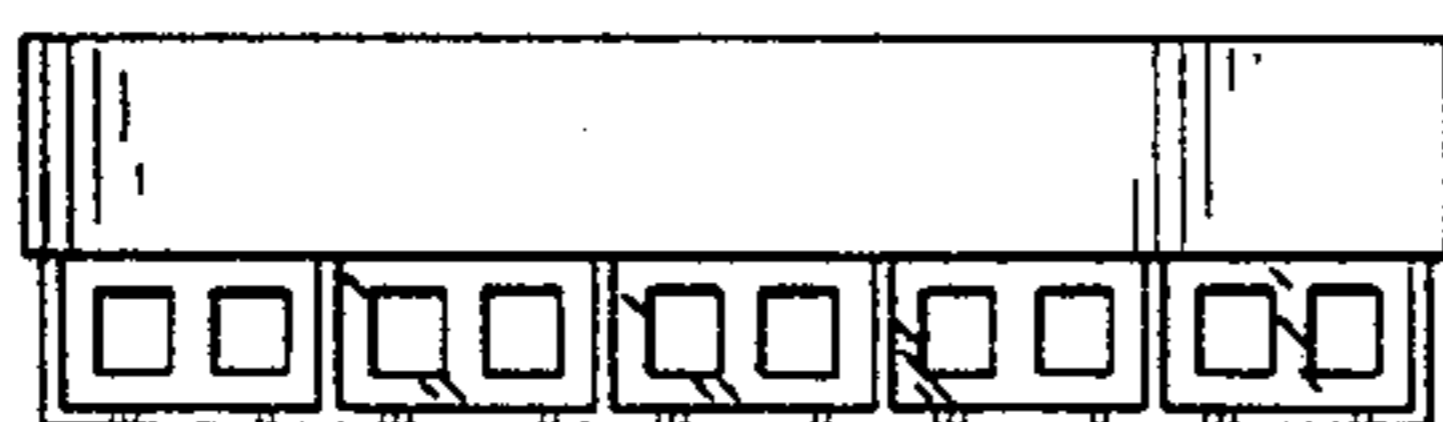
