[57] **CLAIM**

The ornamental design for the pocketed athletic shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and right front perspective view of the pocketed athletic shoe upper showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is another embodiment of my new design of FIGS. 1-3 wherein a snap button has been added to the cover flap; FIG. 5 is a left side elevational view thereof; and FIG. 6 is a rear elevational view thereof.

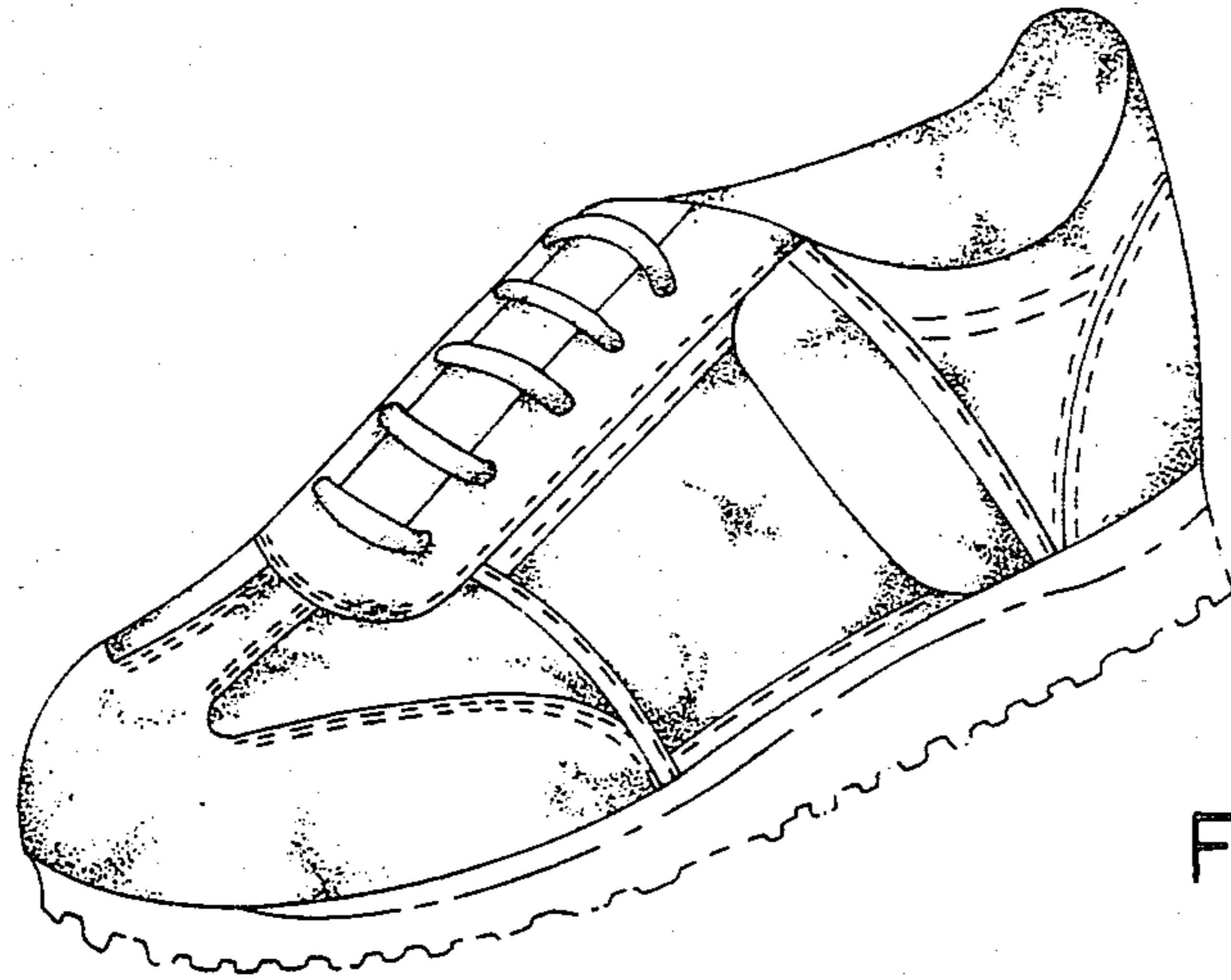

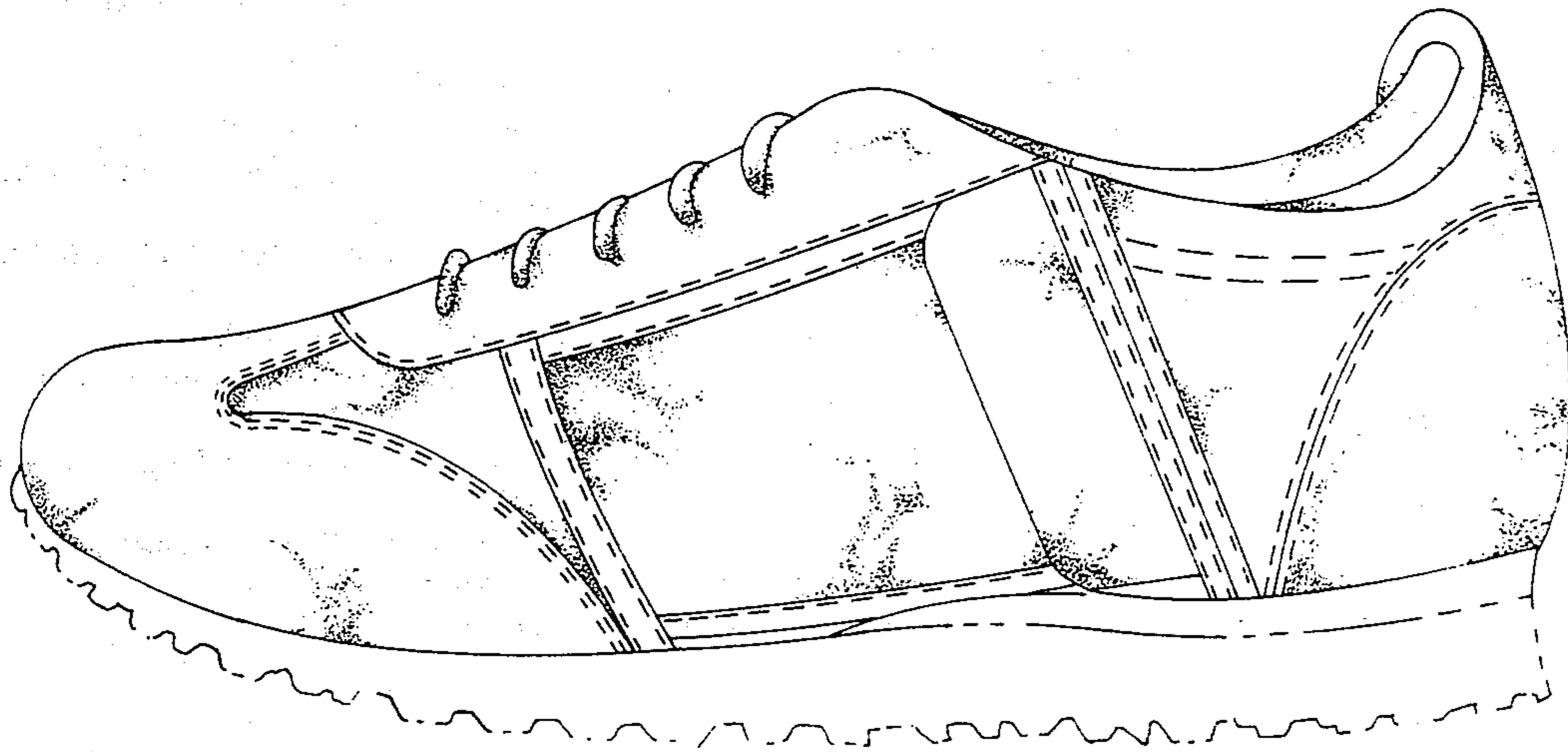

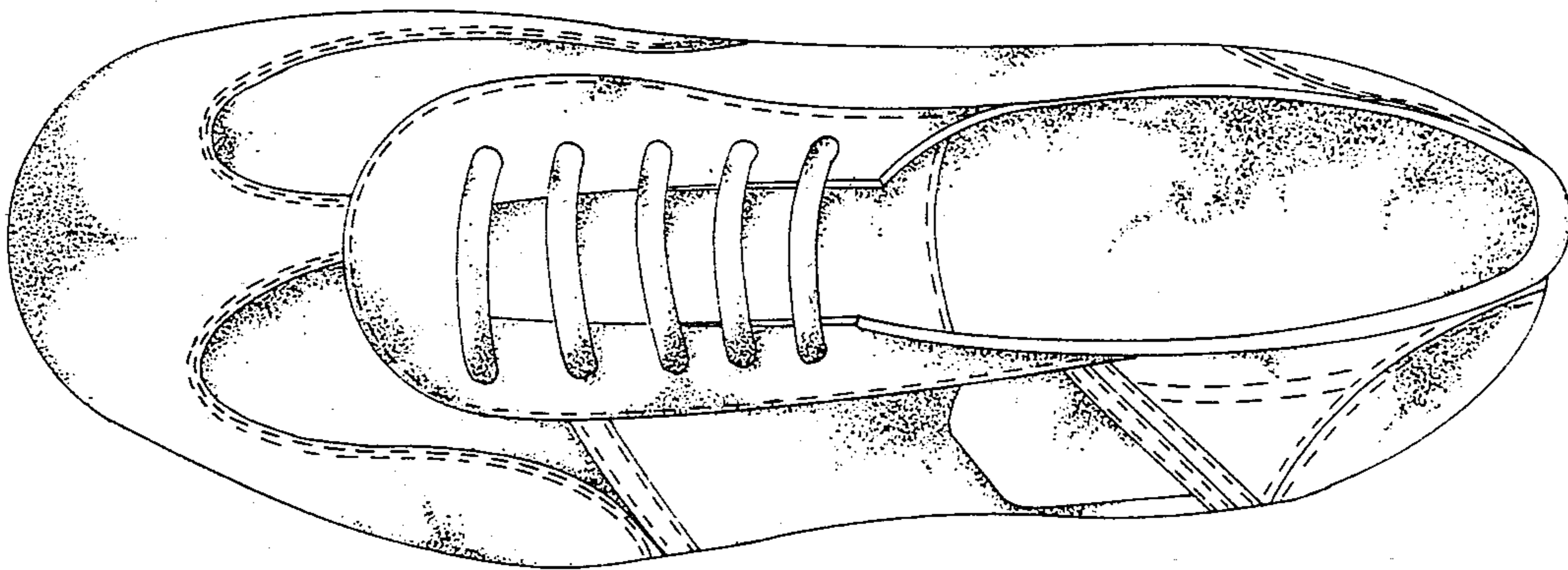

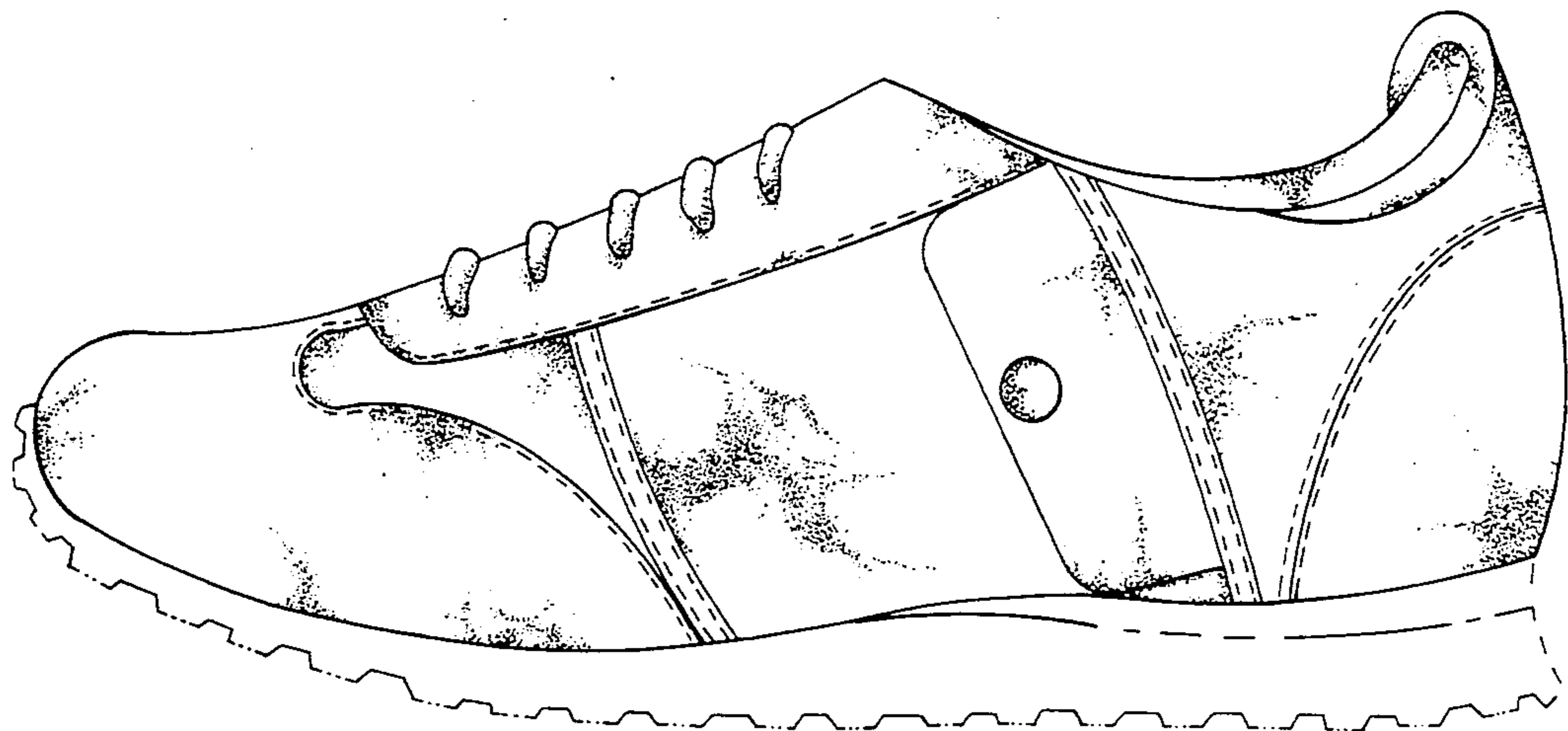

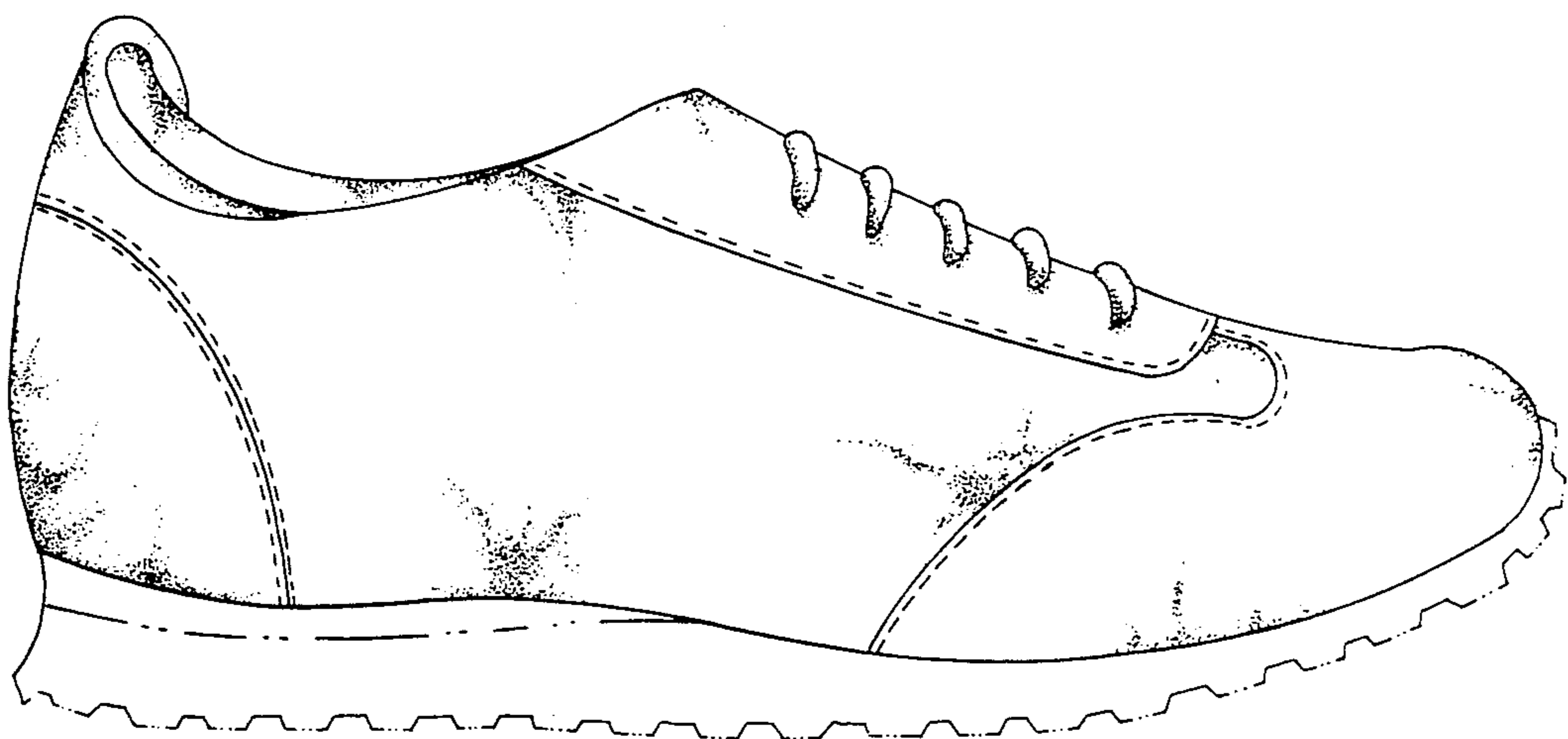

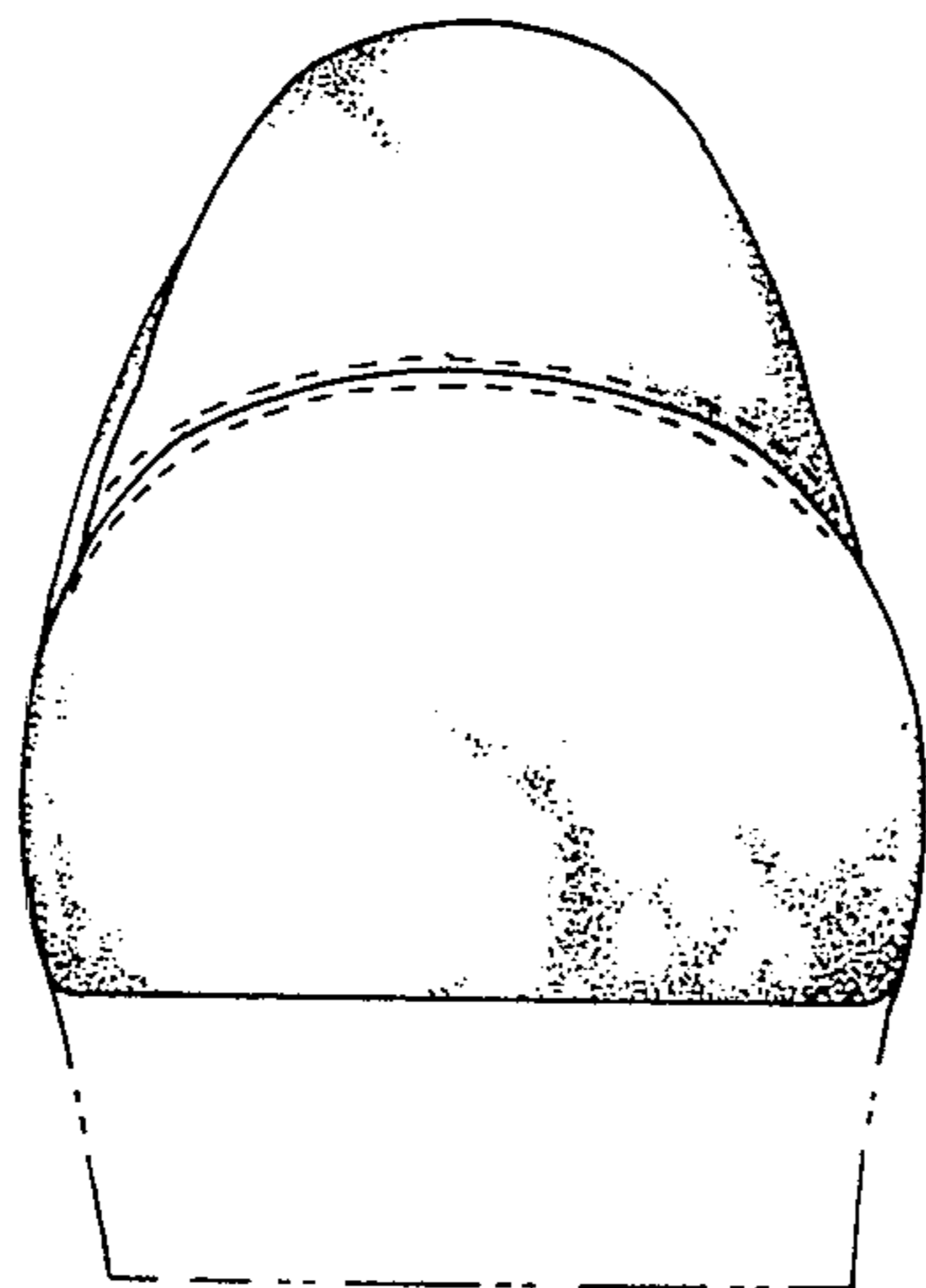
