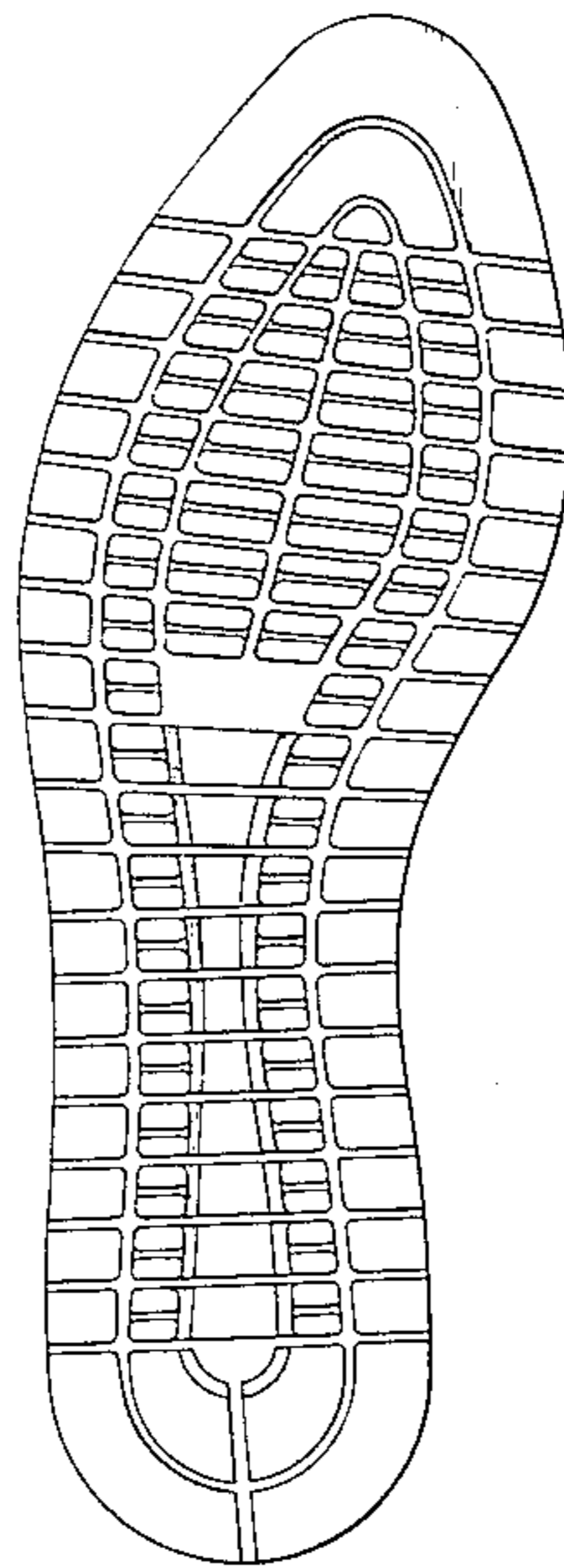

DESCRIPTION

FIG. 1 is a right side perspective view of a shoe outsole
 showing my new design;
 FIG. 2 is a left side elevational view thereof;

 substantially plain and unornamented.



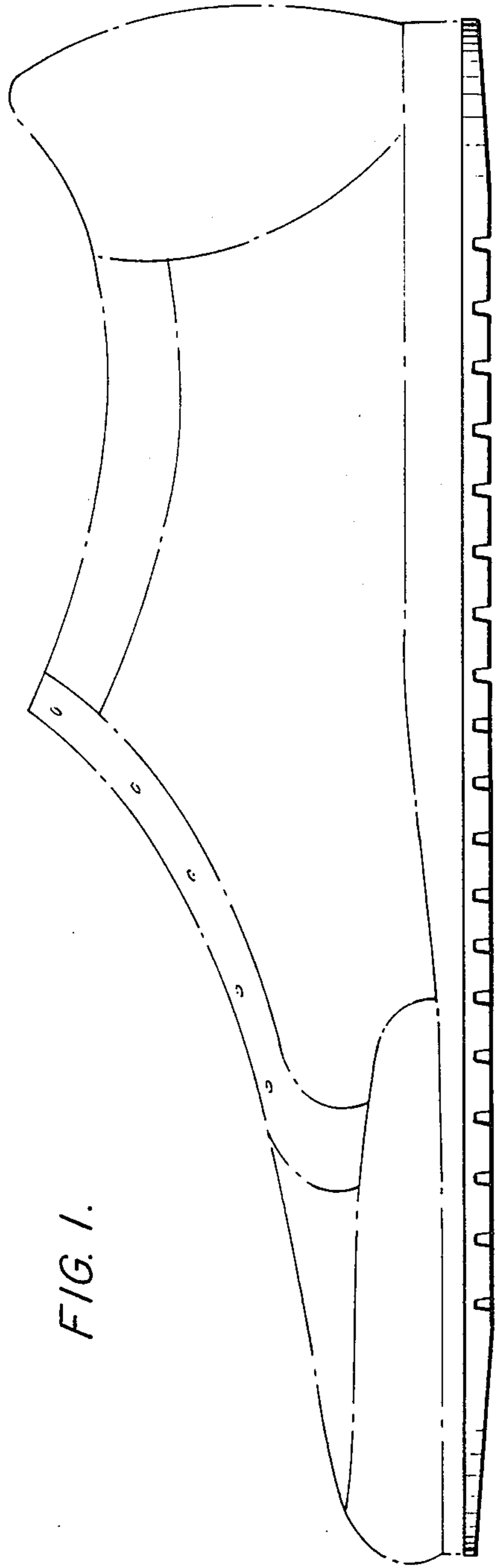
