[57] CLAIM

The ornamental design for a telephone set, substantially as shown.

FIG. 8 is a side by side plan view of the underside of the handset telephone, and of the top of its mount; FIG. 9 is a view similar to FIG. 2 thereof of a component of the set;

FIG. 10 is a view similar to the FIG. 3 thereof of a component of the set;

FIG. 11 is a view similar to FIG. 4 thereof of a component of the set;

FIG. 12 is a view similar to FIG. 5 thereof of a component of the set;

FIG. 13 is a view similar to FIG. 6 thereof of a component of the set;

FIG. 14 is a view similar to FIG. 7 thereof of a component of the set.
