[57] CLAIM

The ornamental design for a combined handset telephone and interlocking cradle stand assembly, substantially as shown.

DESCRIPTION

FIG. 1 is a perspective view of a combined handset telephone and interlocking cradle stand assembly showing my new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view of the handset of the assembly;
FIG. 6 is a side elevational view of the handset;
FIG. 7 is a bottom plan view of the handset;
FIG. 8 is a front elevational view of the handset;
FIG. 9 is a rear elevational view of the handset;
FIG. 10 is a top plan view of the cradle of the assembly with the handset removed therefrom;
FIG. 11 is a side elevational view of the cradle;
FIG. 12 is a bottom plan view of the cradle;
FIG. 13 is a front elevational view of the cradle; and
FIG. 14 is a rear elevational view of the cradle.
Components of the assembly are shown separately for clarity of illustration and exposure.

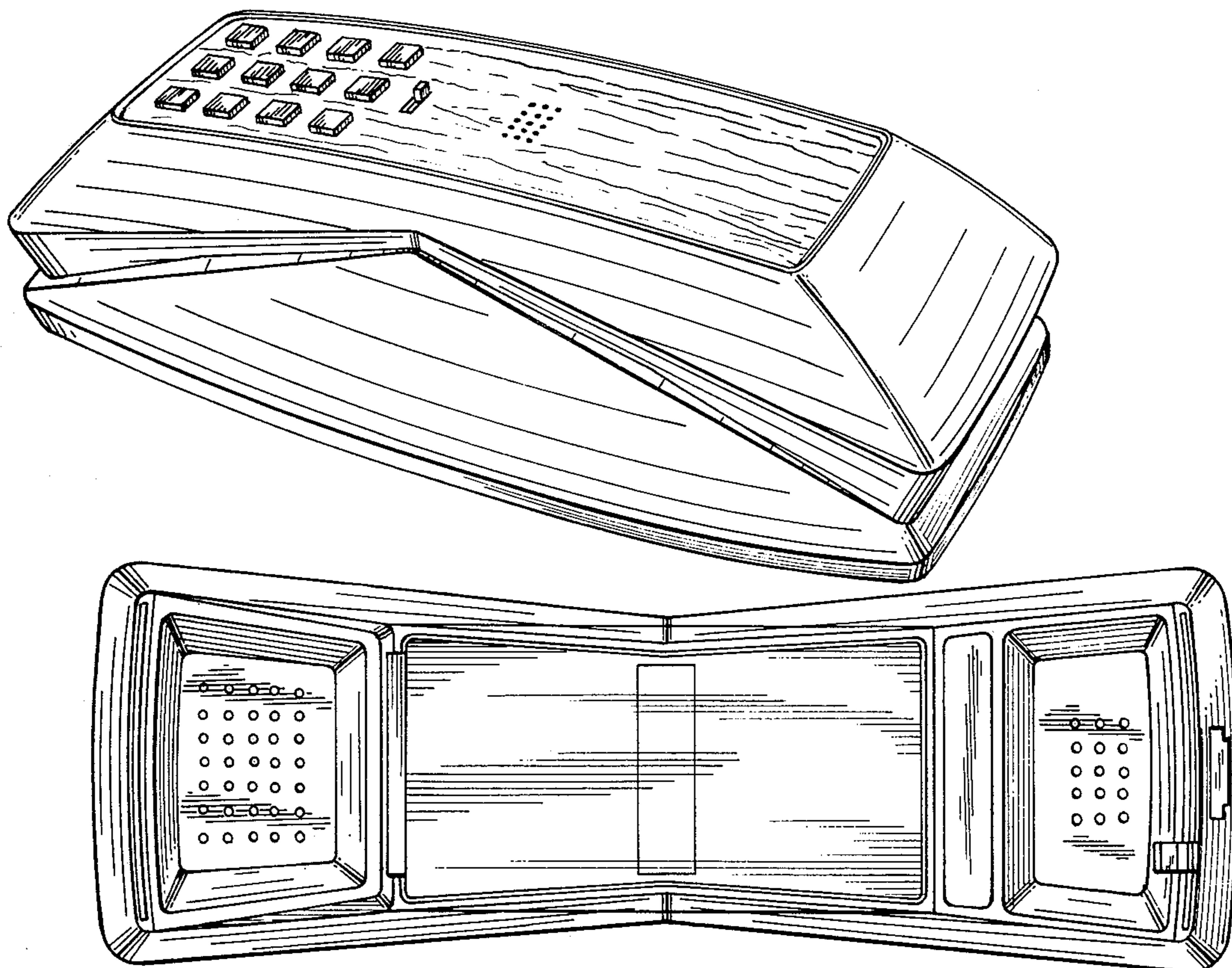

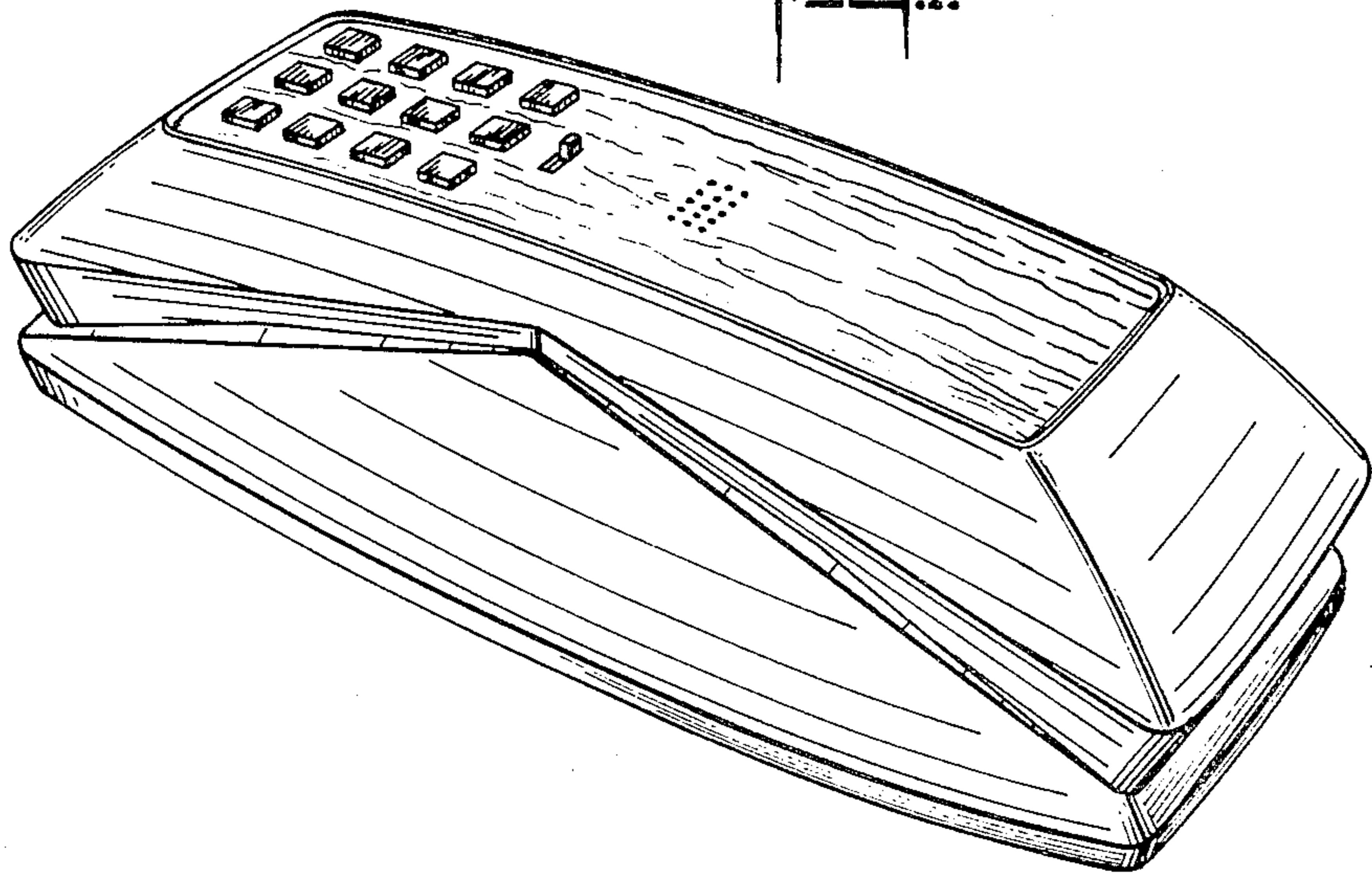

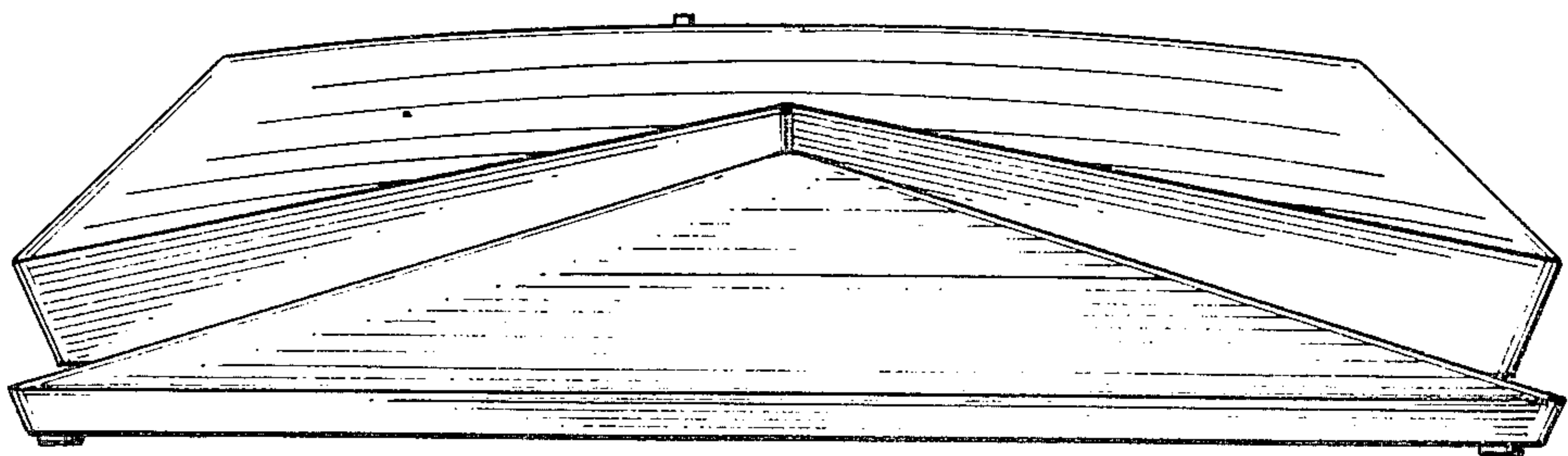

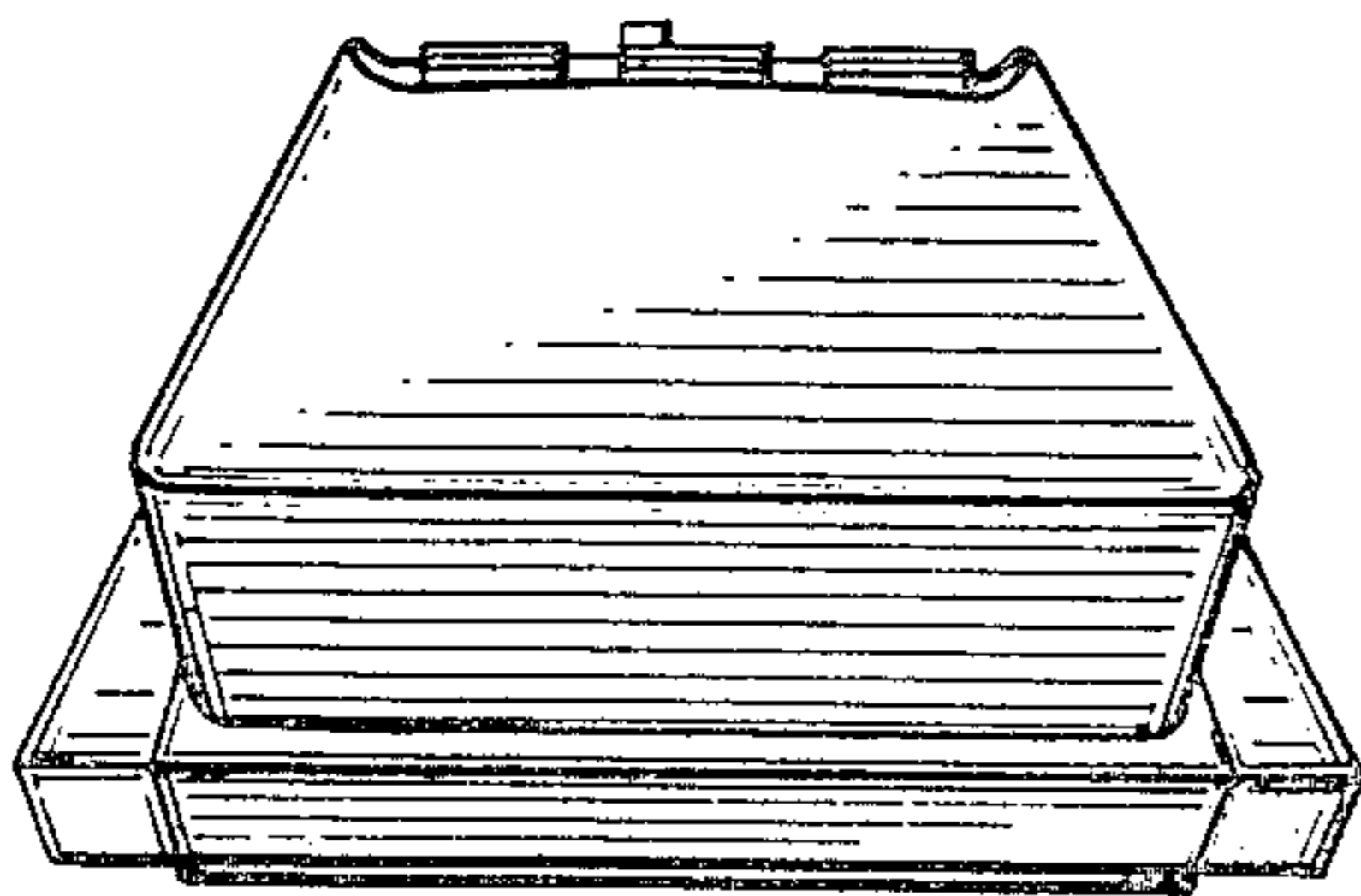

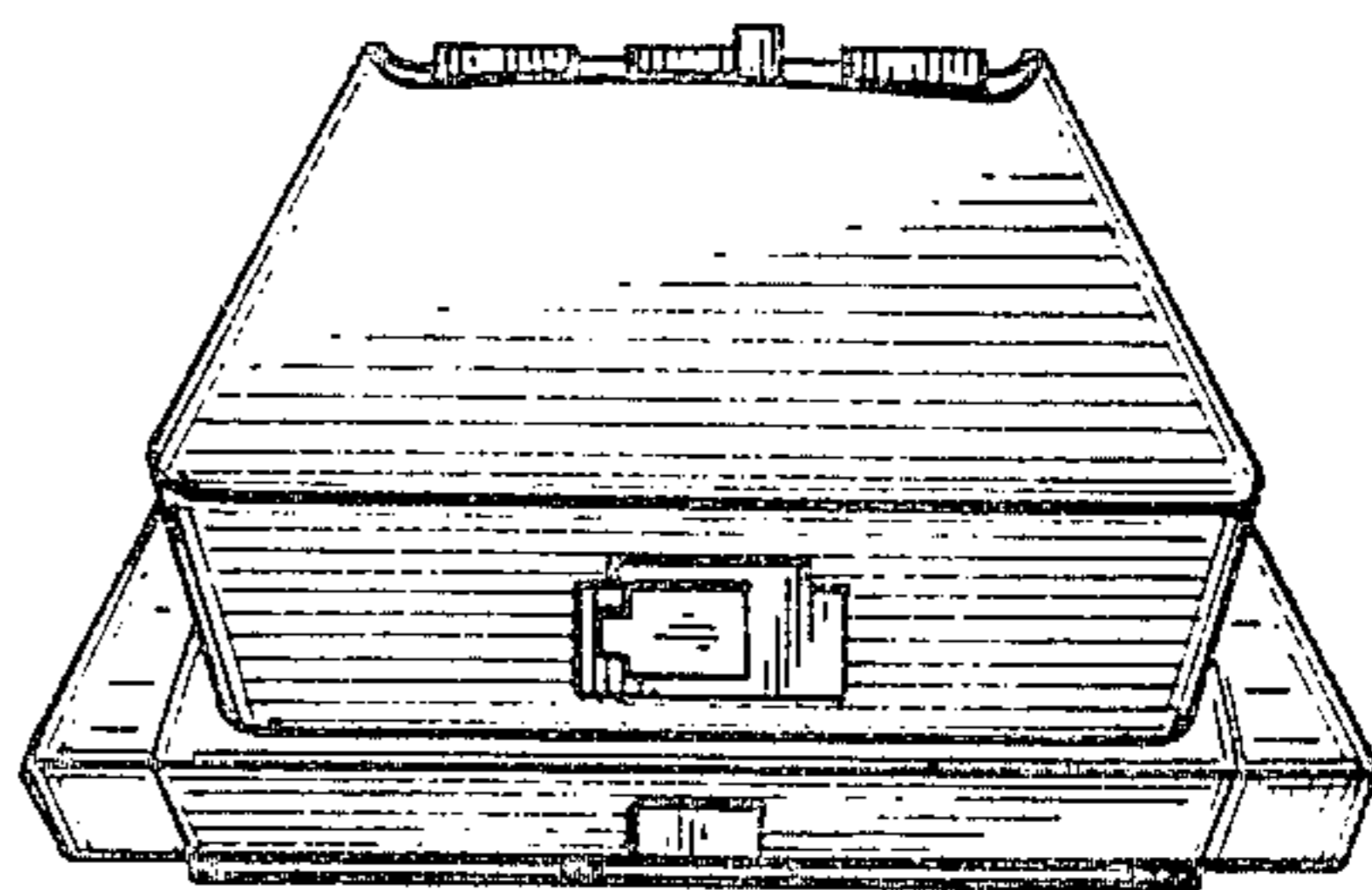

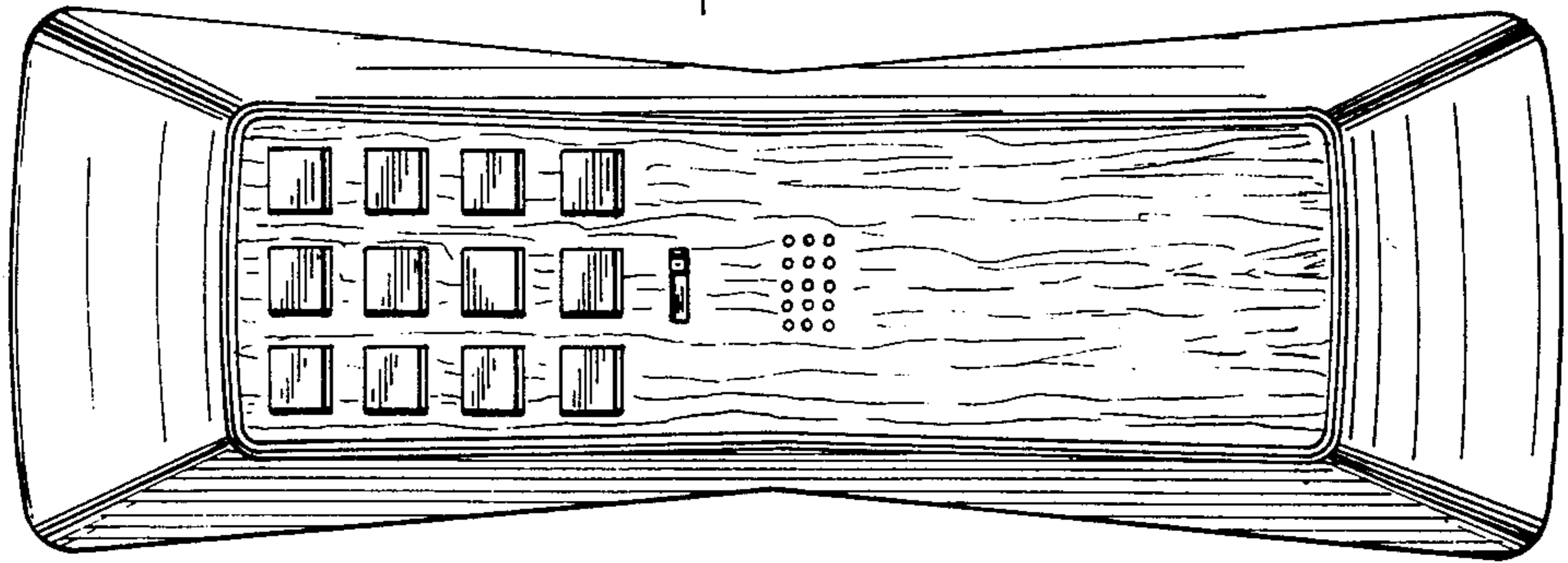

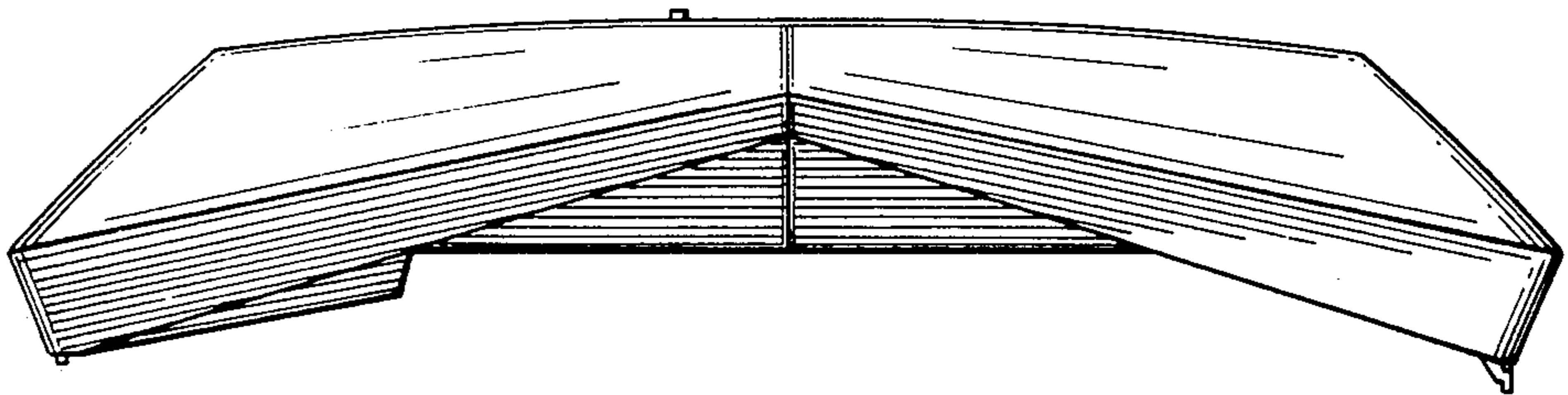

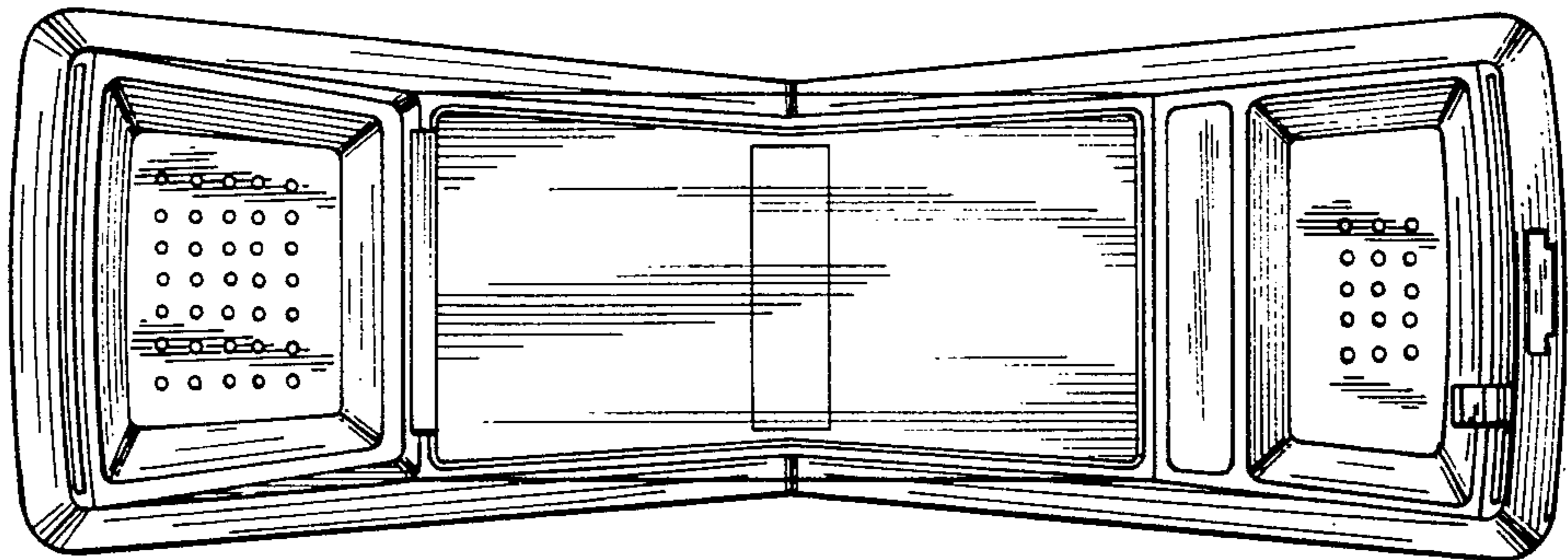

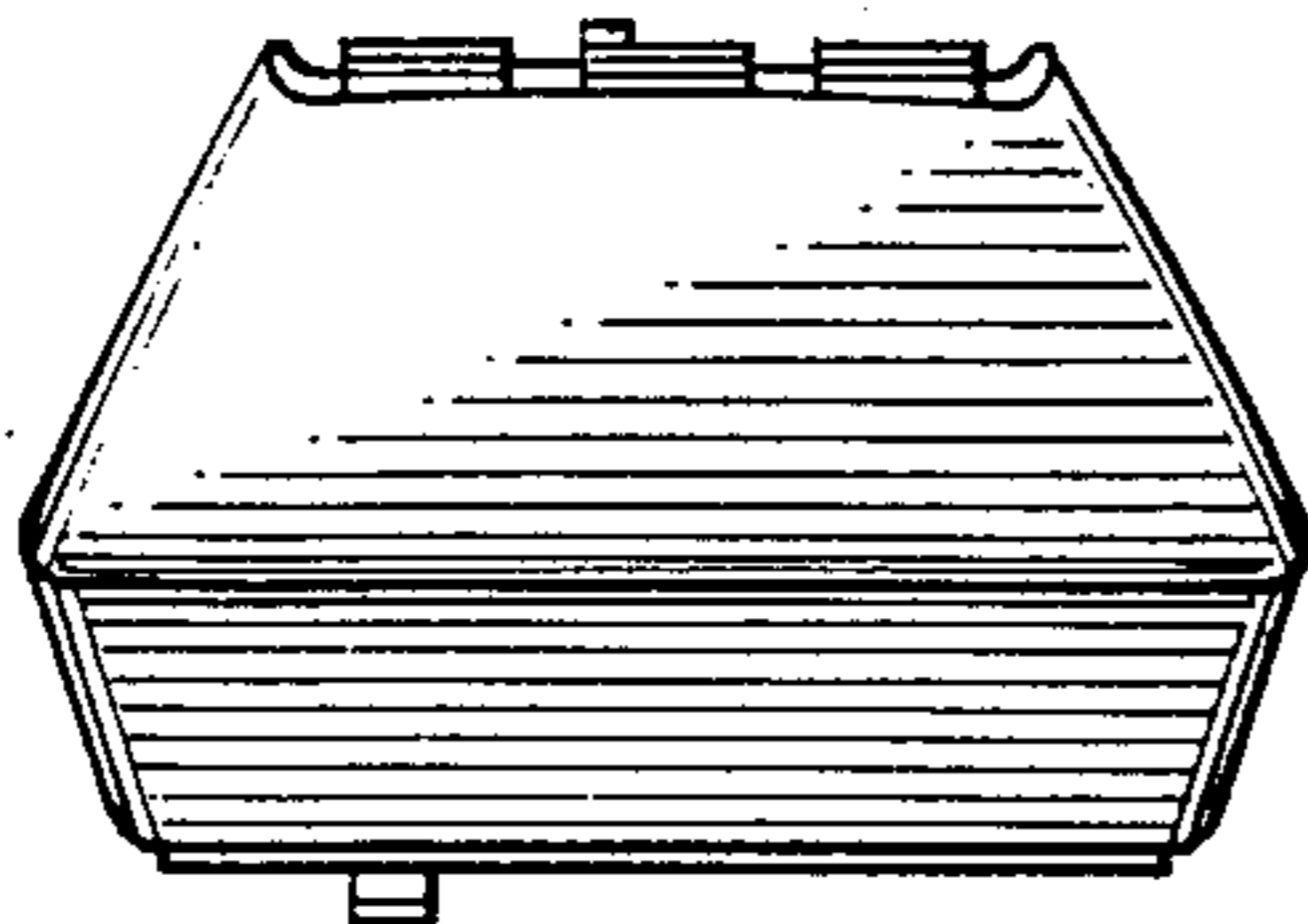

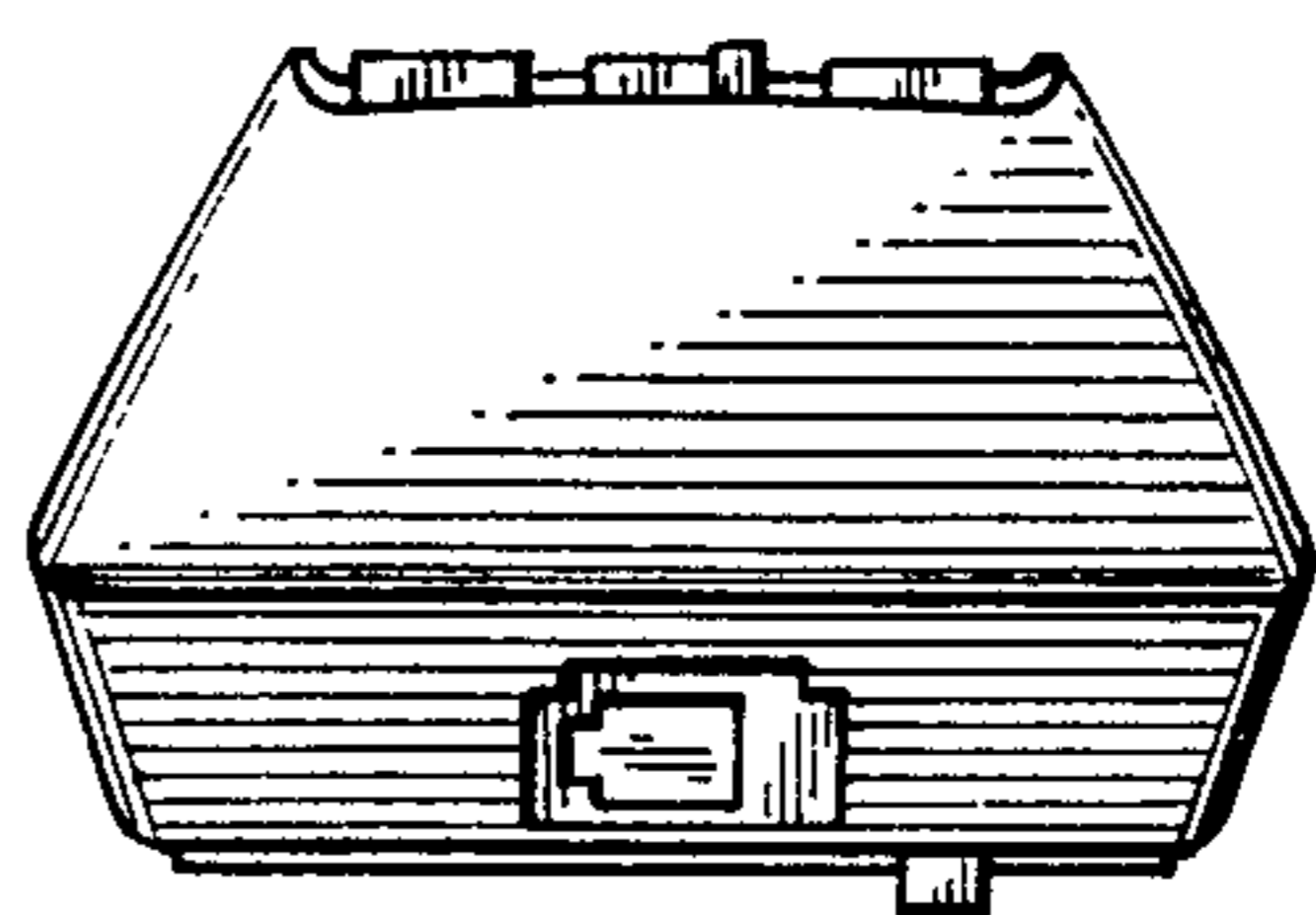

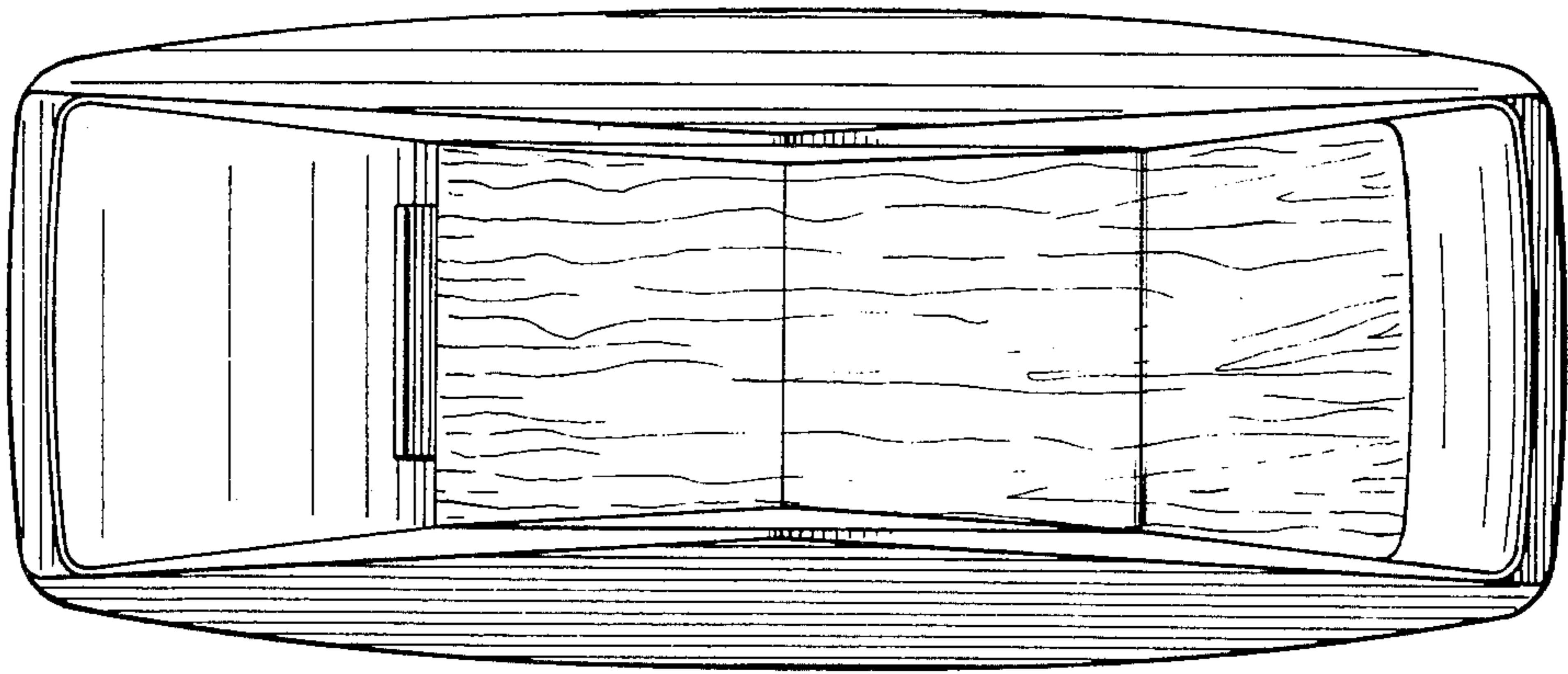

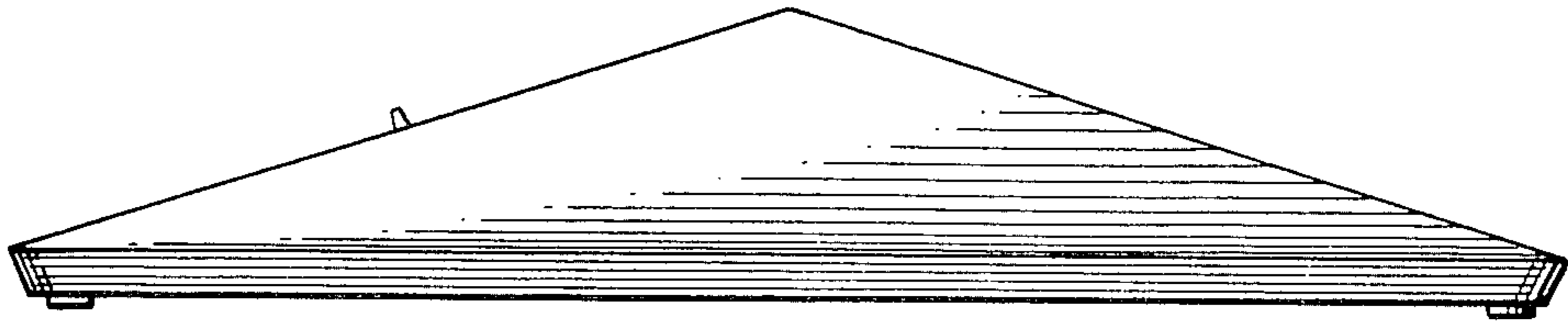

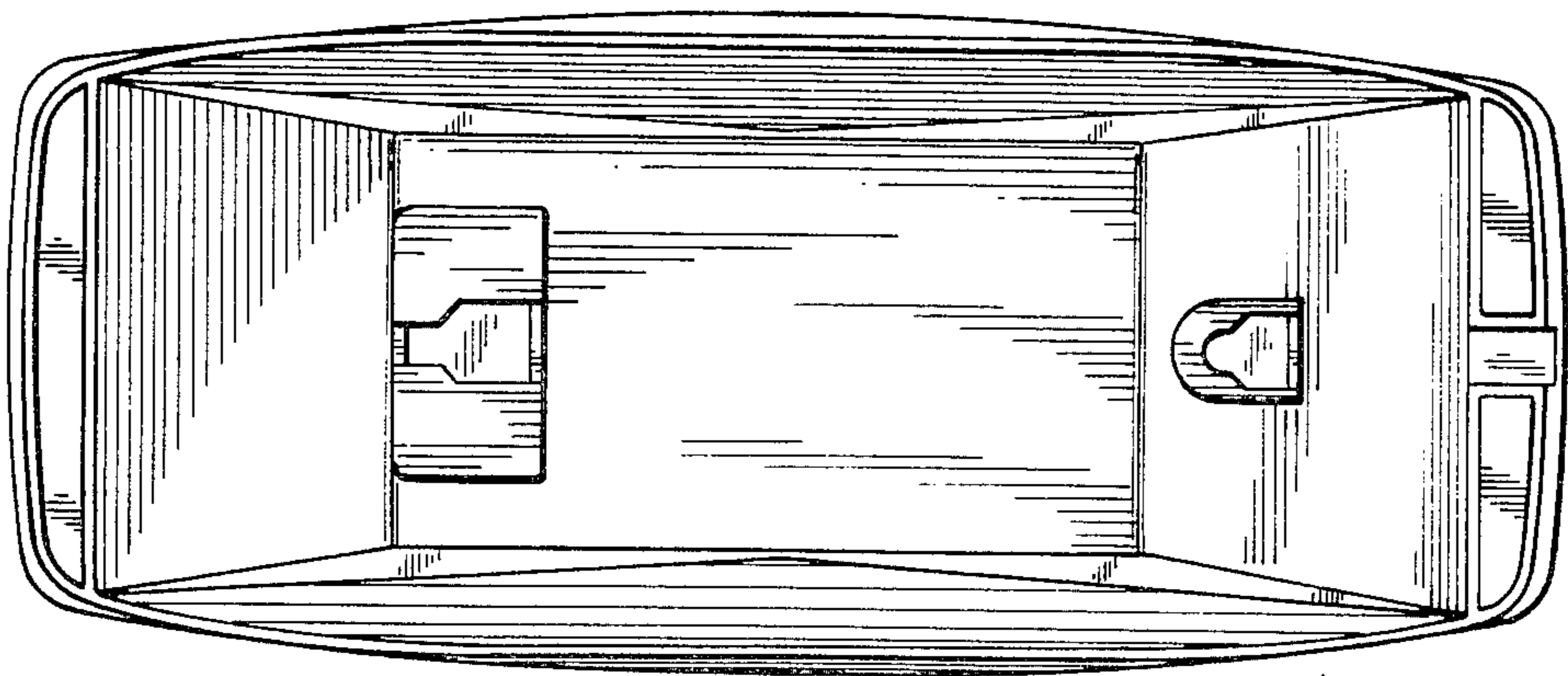

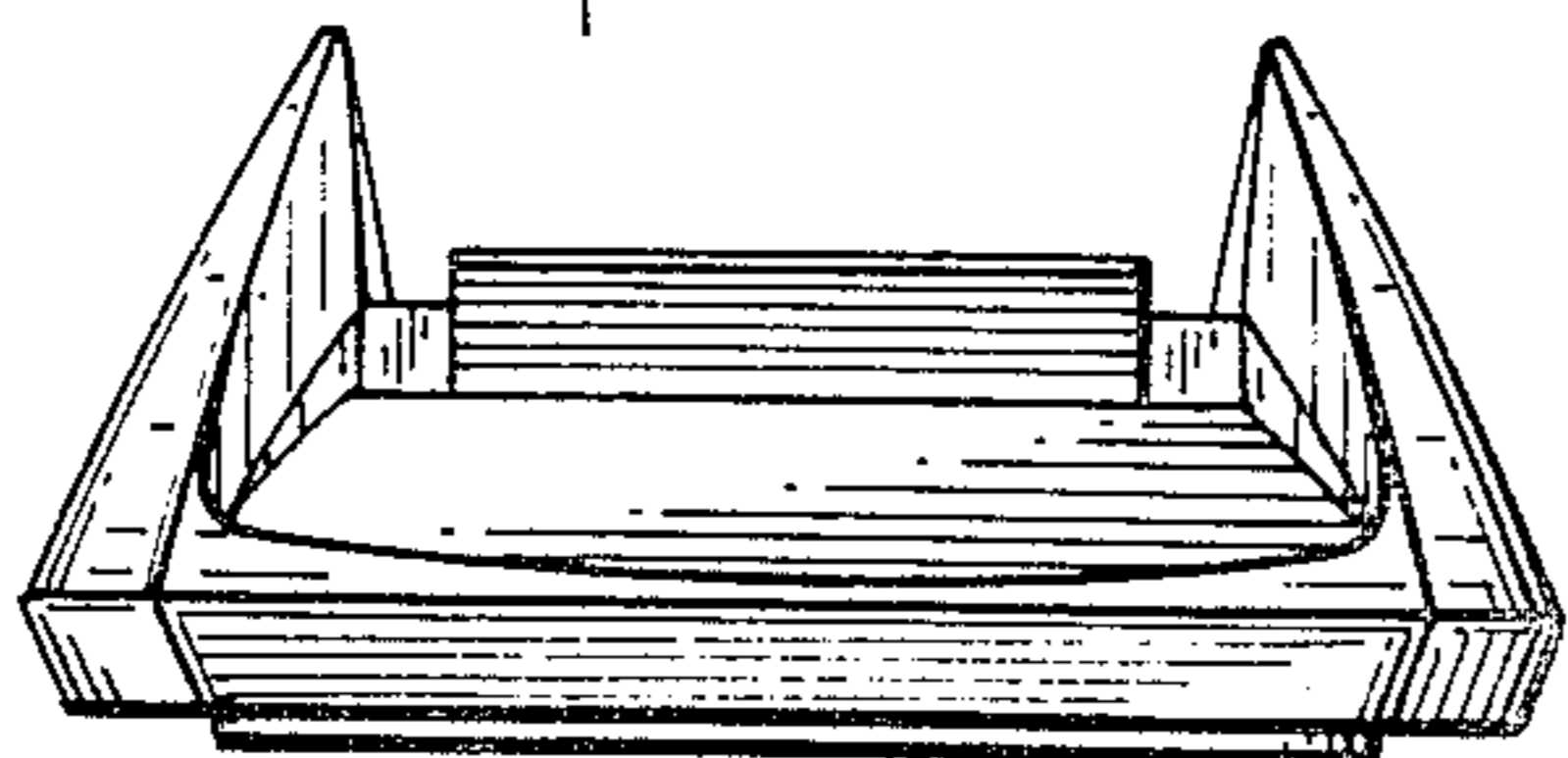
