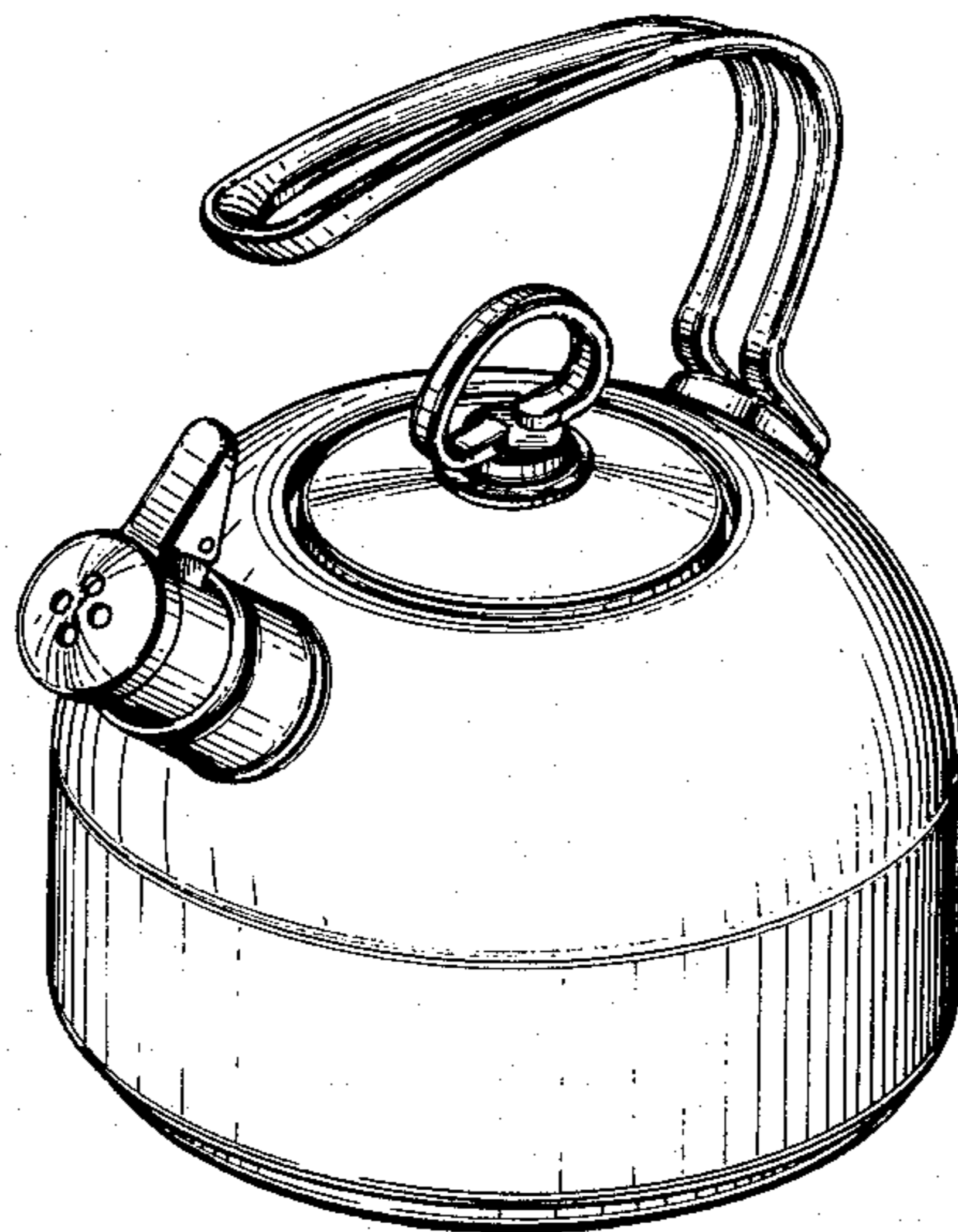
FIG. 1 is a perspective view of a kettle showing my new design;

FIG. 5 is a bottom view thereof.



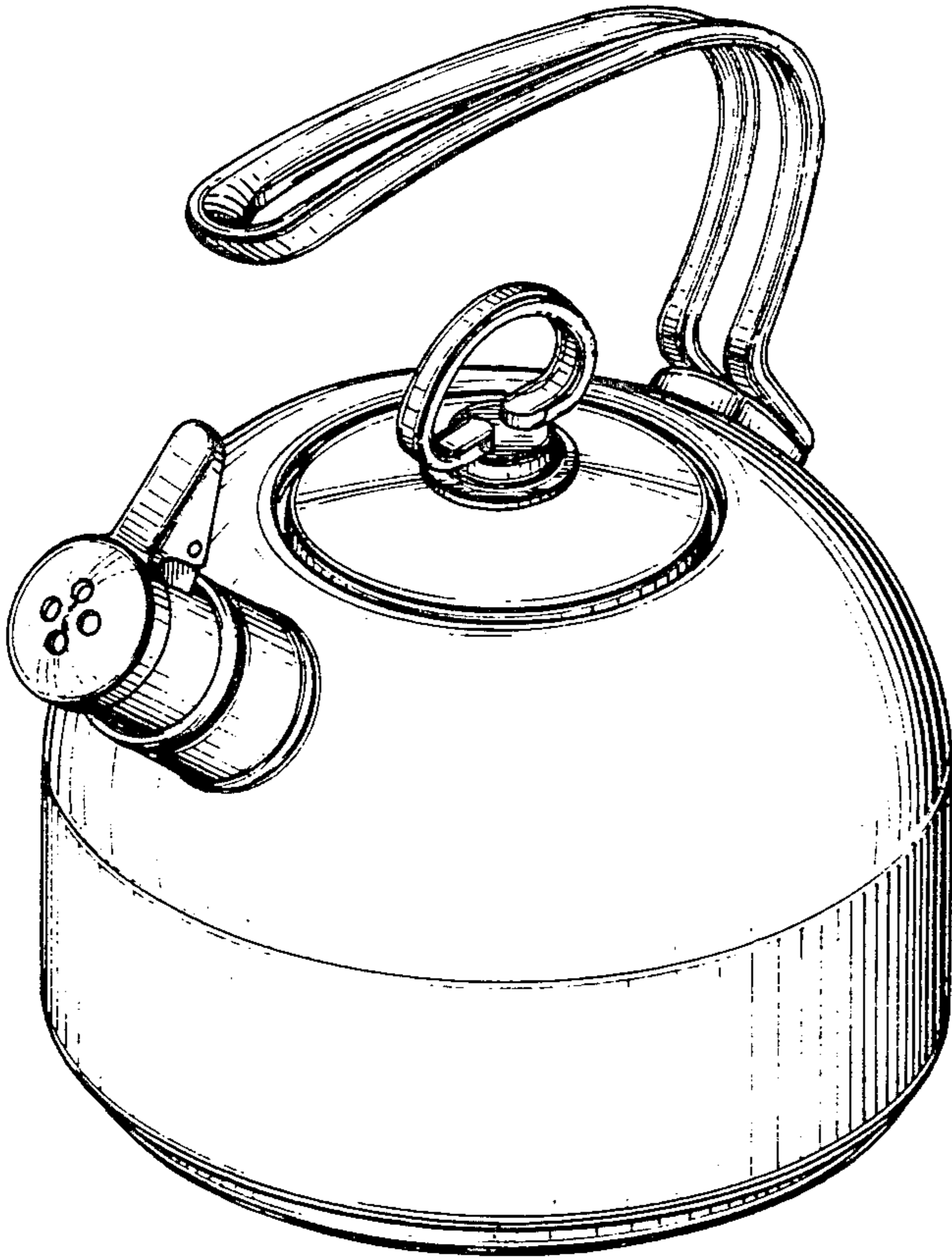

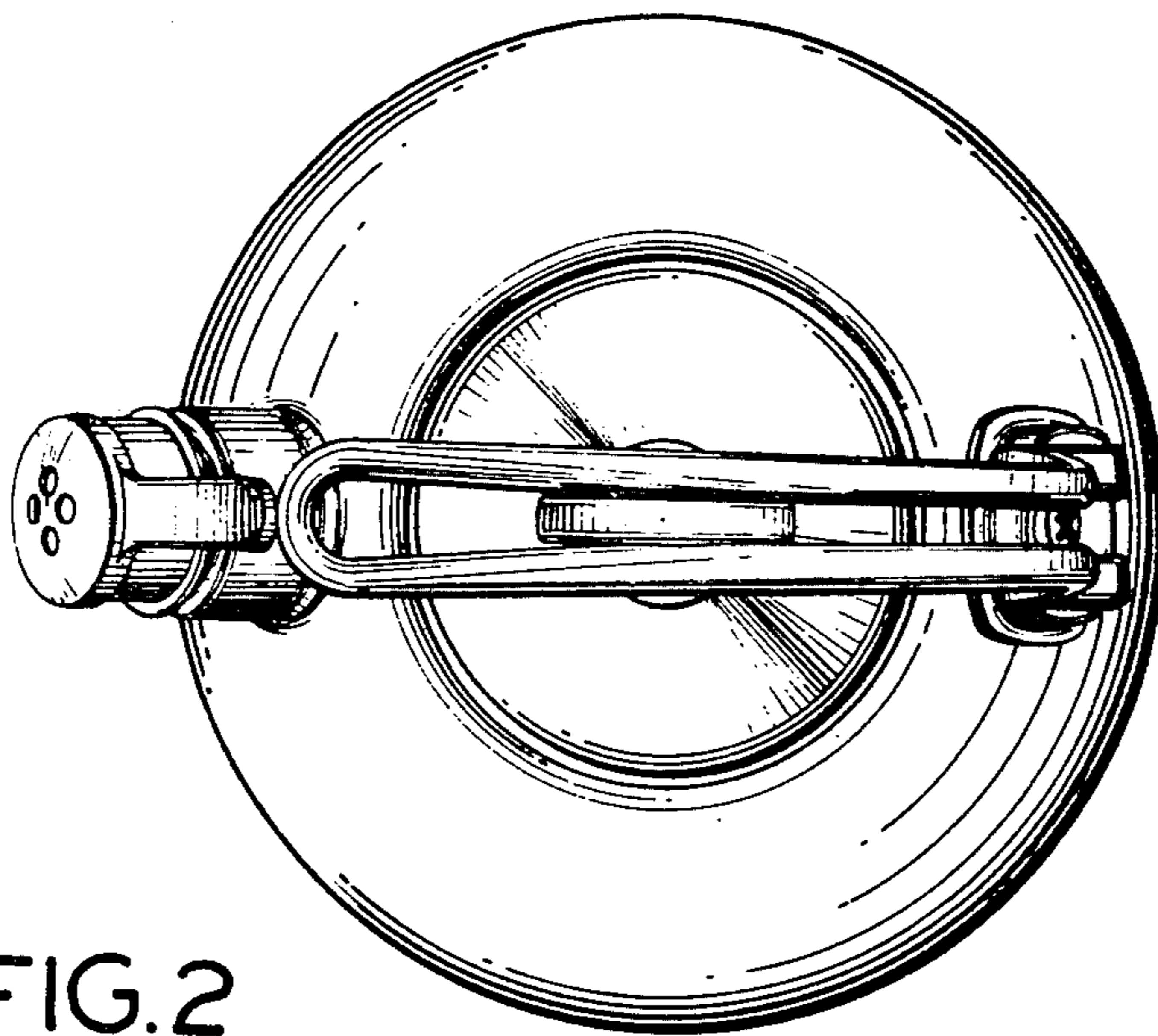

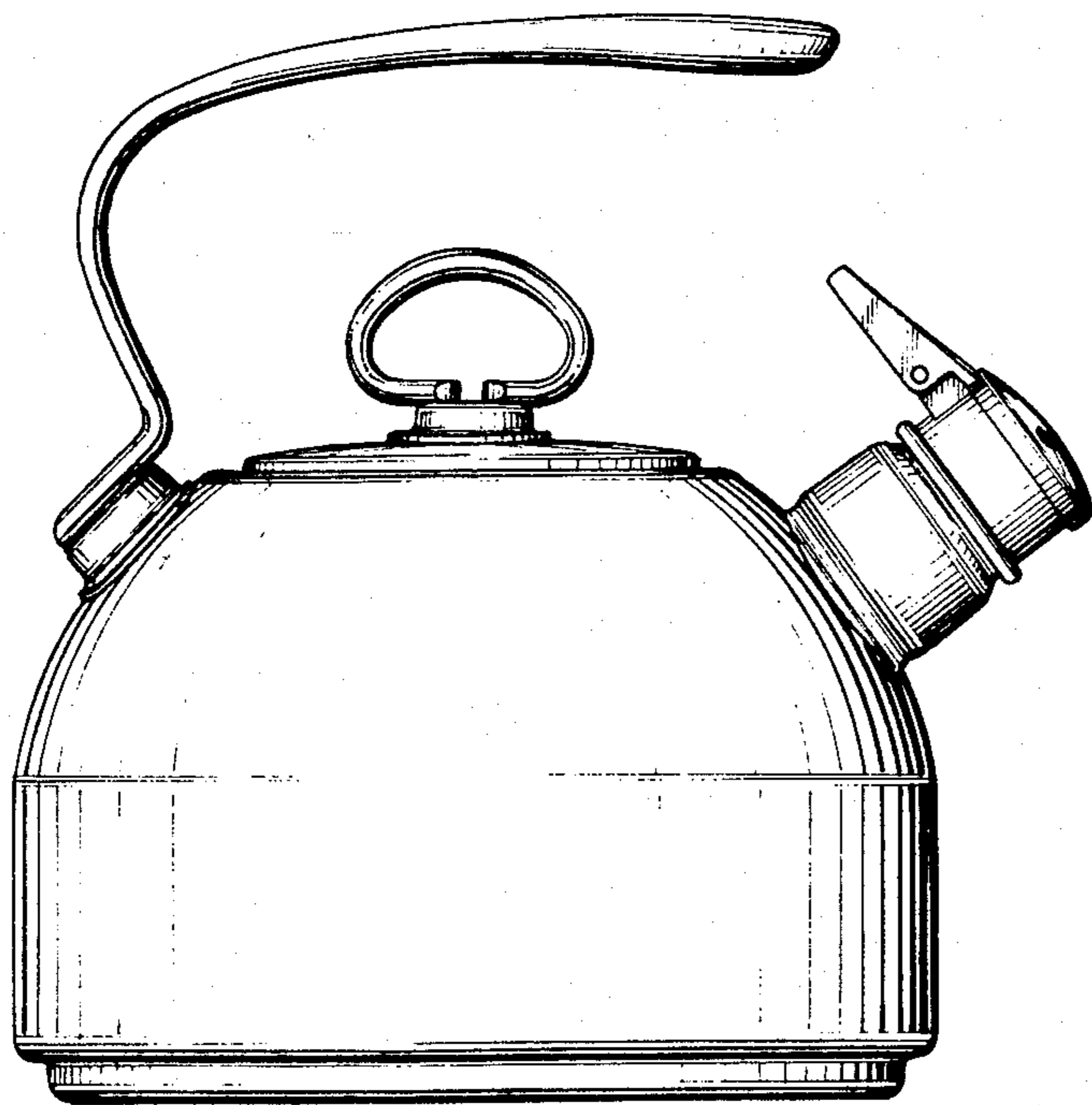

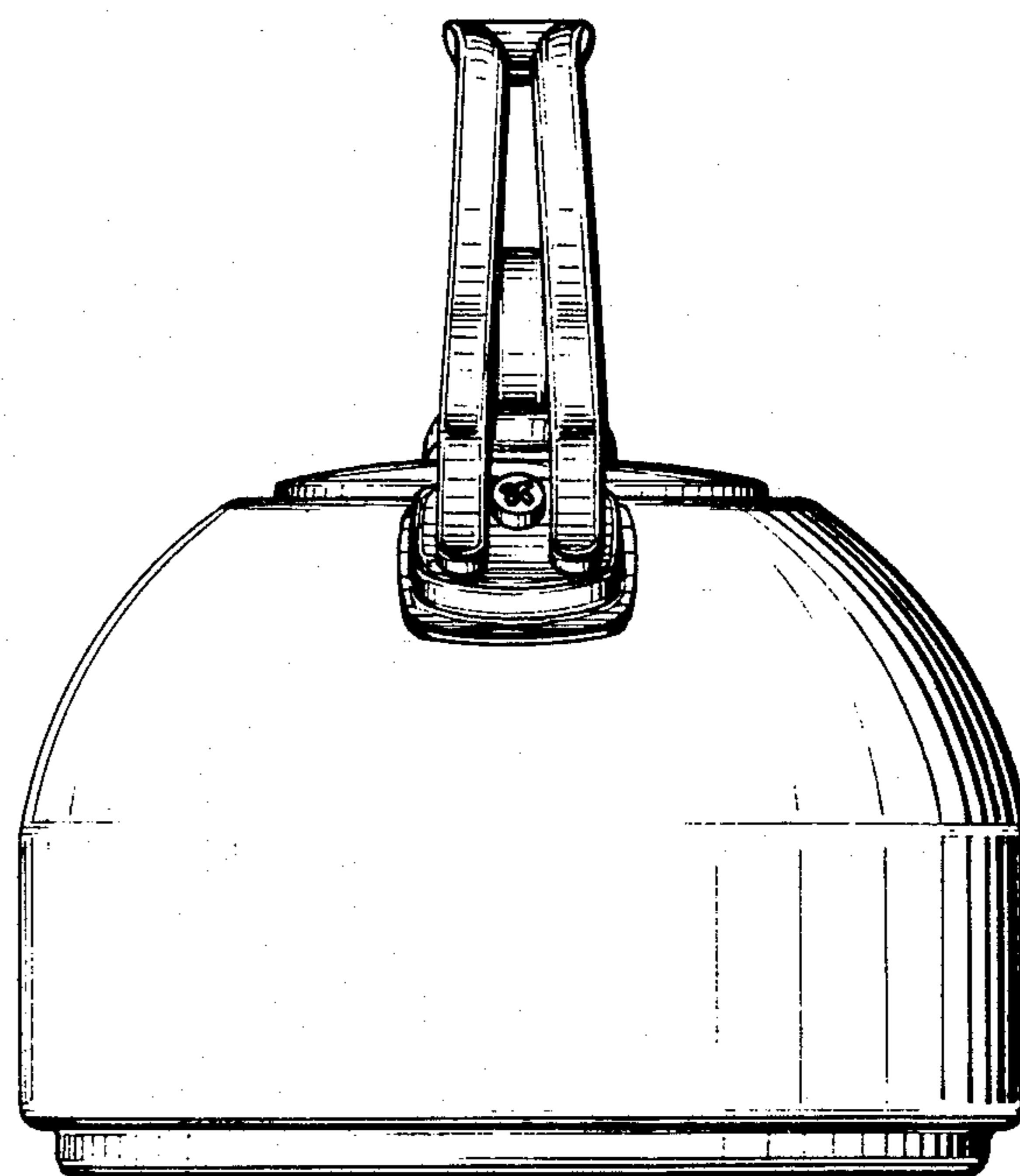

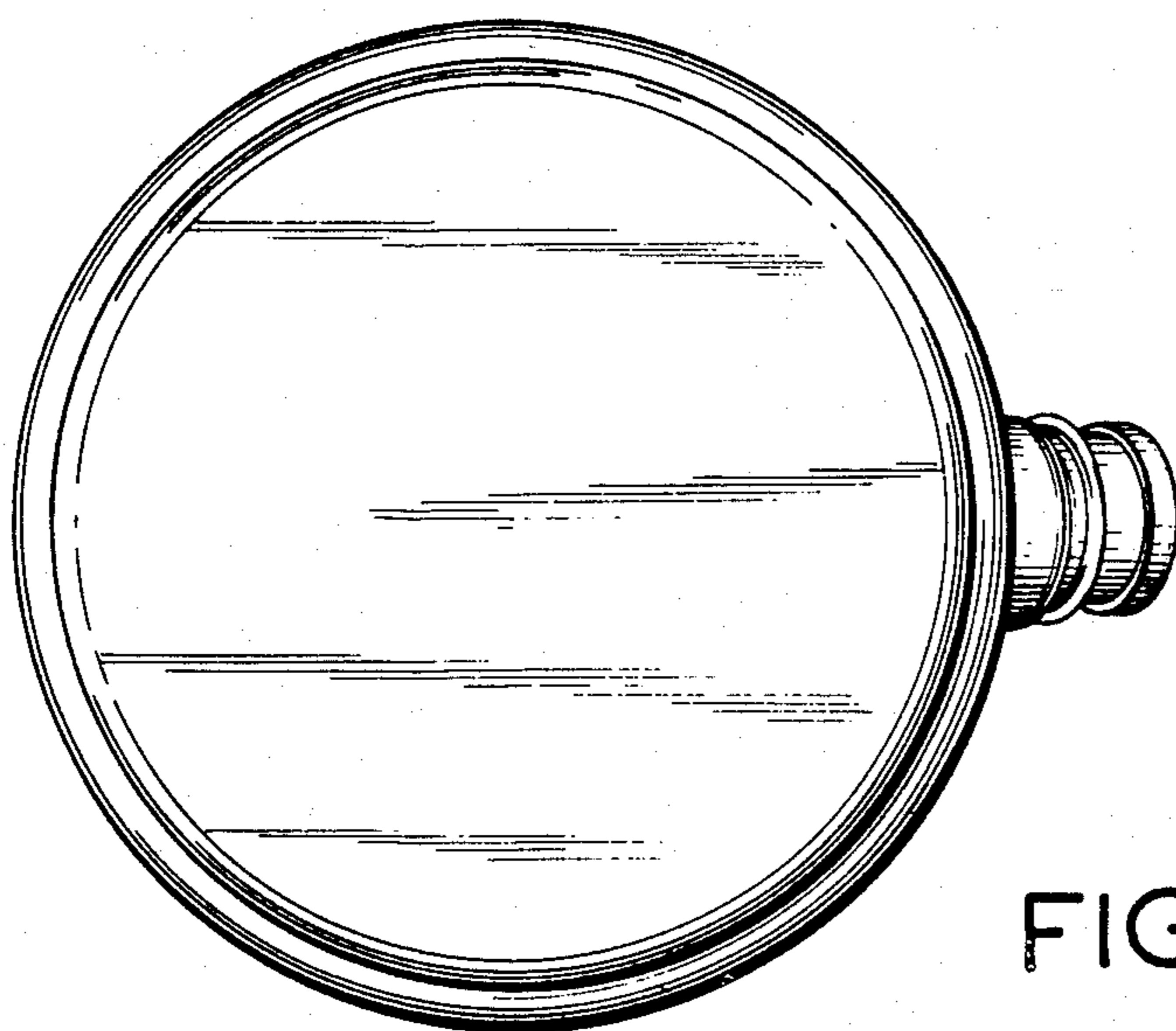
