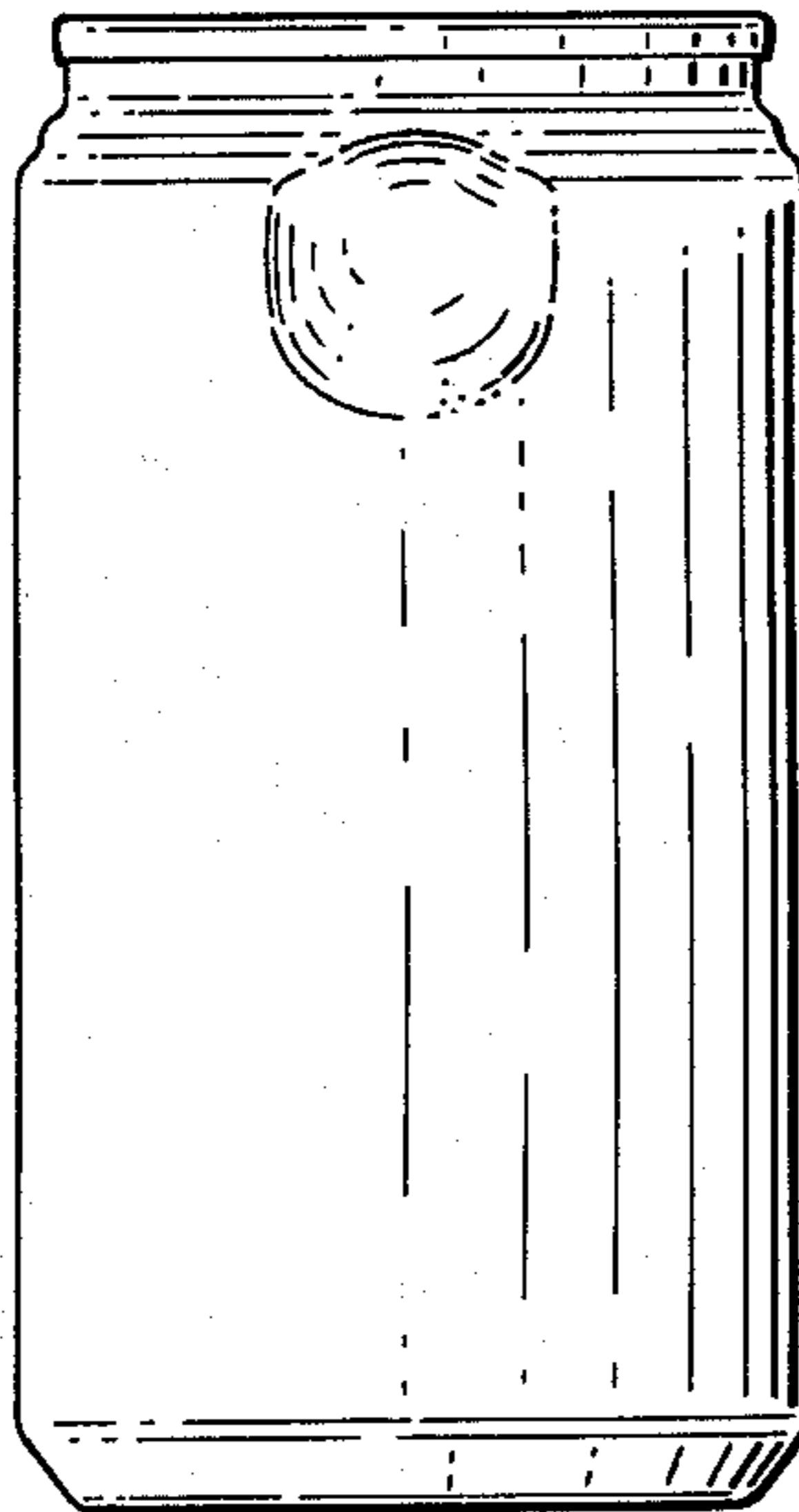

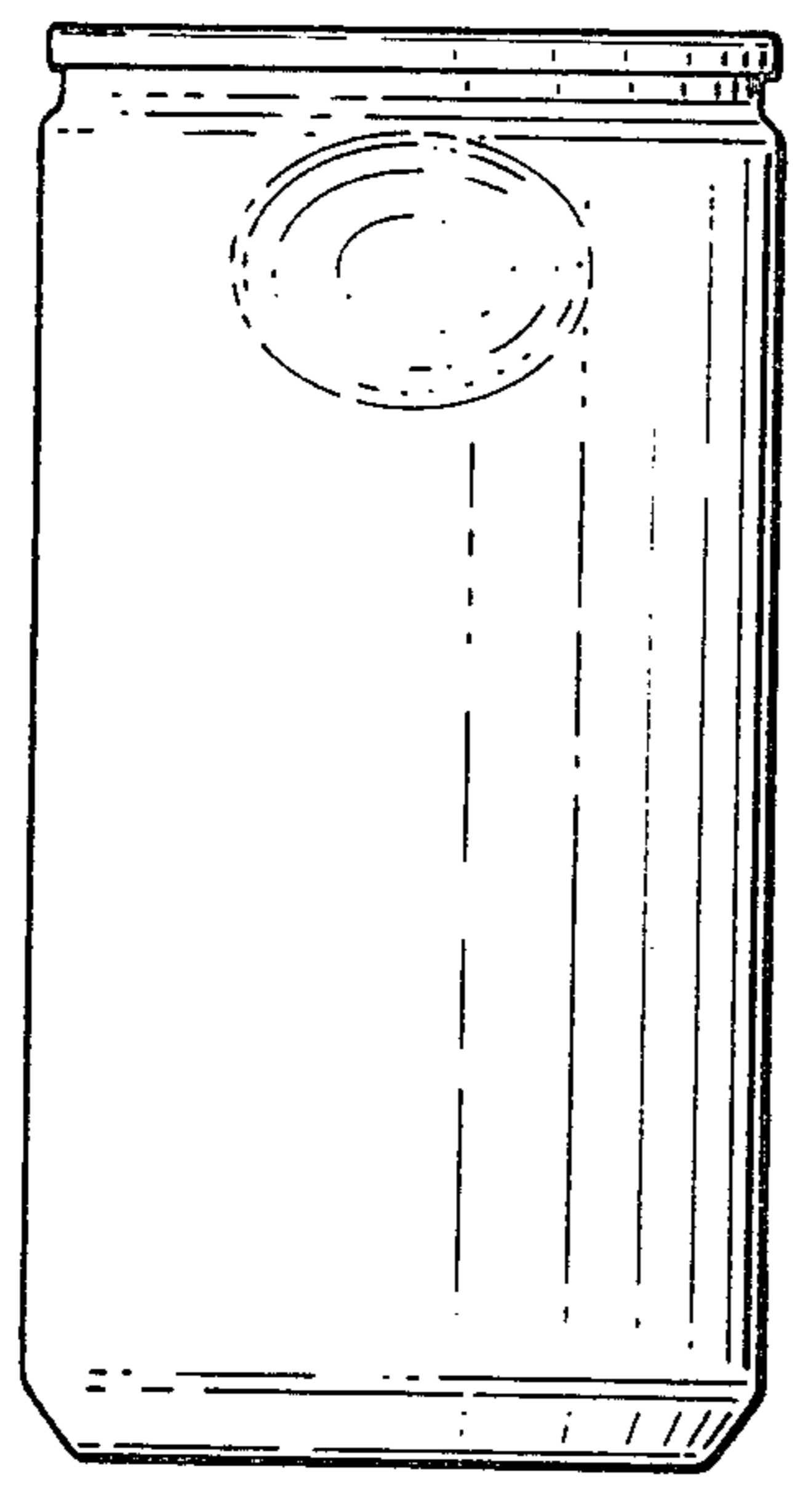
The ornamental design for a beverage container, as shown and described.

DESCRIPTION

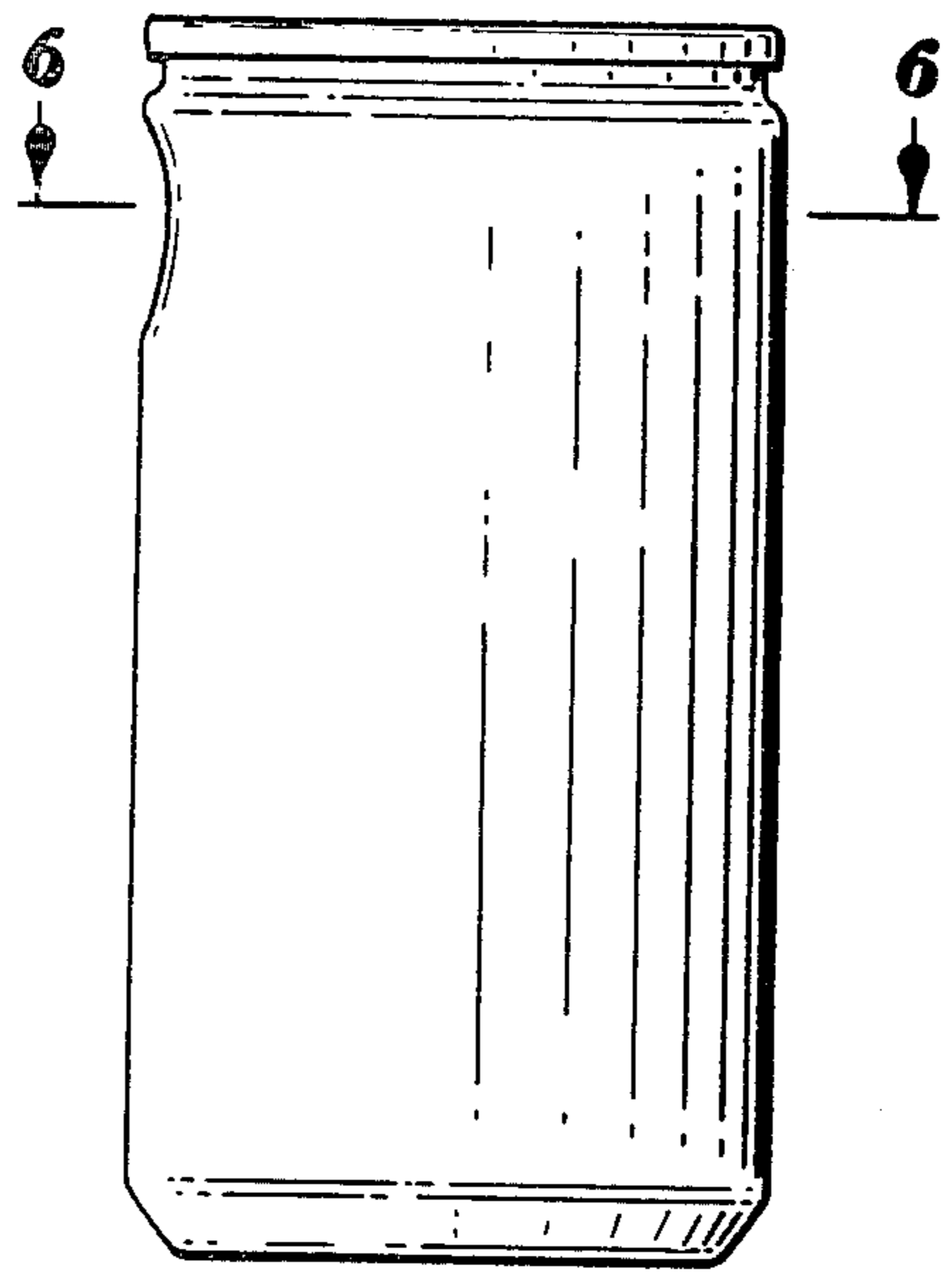
FIG. 1 is a front elevational view of a beverage container showing my new design;

 FIG. 8 is an elevational view looking from the right of FIG. 7;  
 FIG. 9 is a rear elevational view;  
 FIG. 10 is a top plan view;  
 FIG. 11 is a fragmentary vertical sectional view taken on the line 11—11 of FIG. 10; and  
 FIG. 12 is a horizontal sectional view taken on the line 12—12 of FIG. 8.  
 FIG. 13 is a front elevational view showing still another modified form of my new design;  
 FIG. 14 is an elevational view looking from the right of FIG. 13;  
 FIG. 15 is a rear elevational view;  
 FIG. 16 is a top plan view;  
 FIG. 17 is a fragmentary vertical sectional view taken on the line 17—17 of FIG. 16; and  
 FIG. 18 is a horizontal sectional view taken on the line 18—18 of FIG. 14.



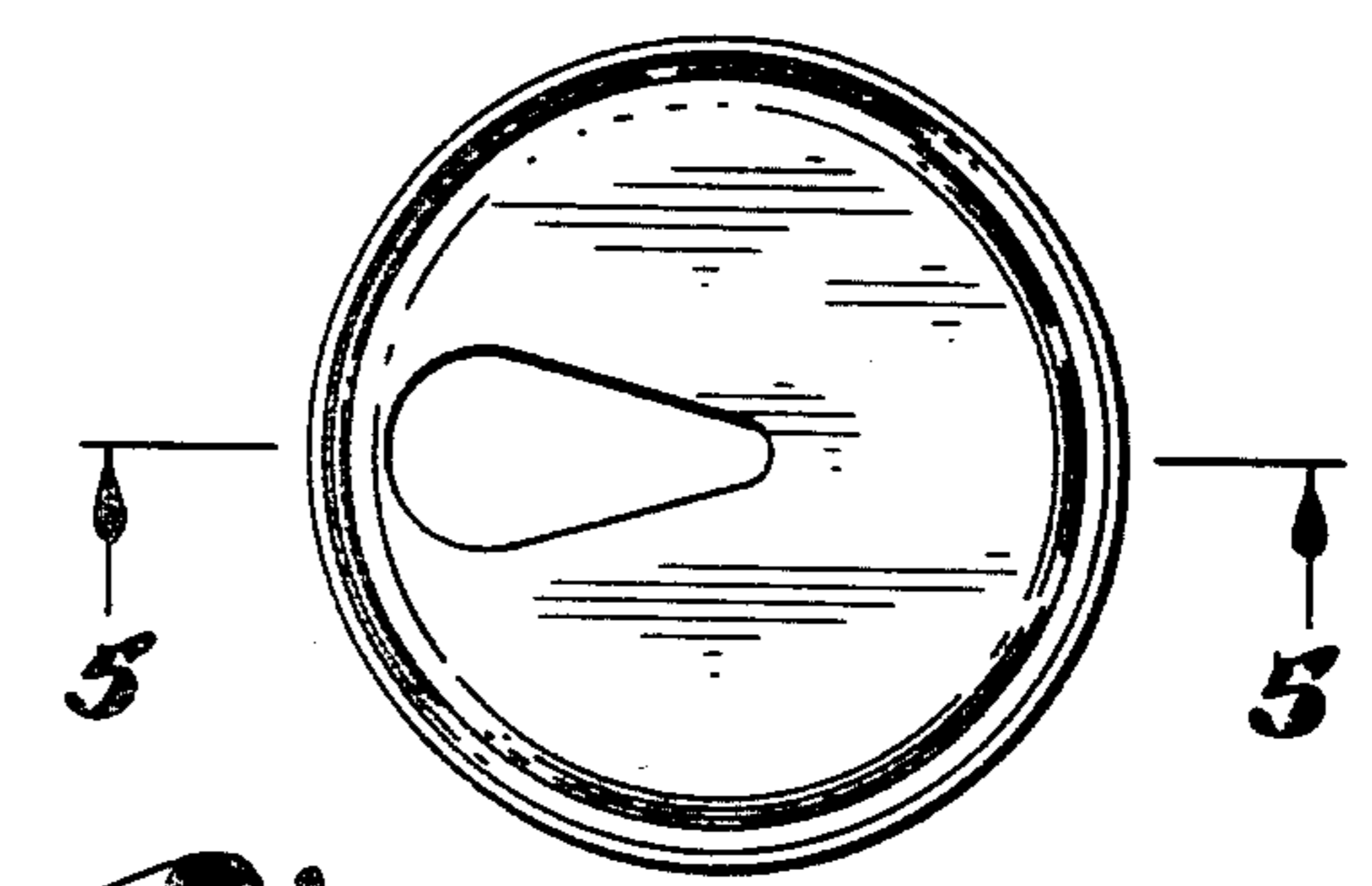
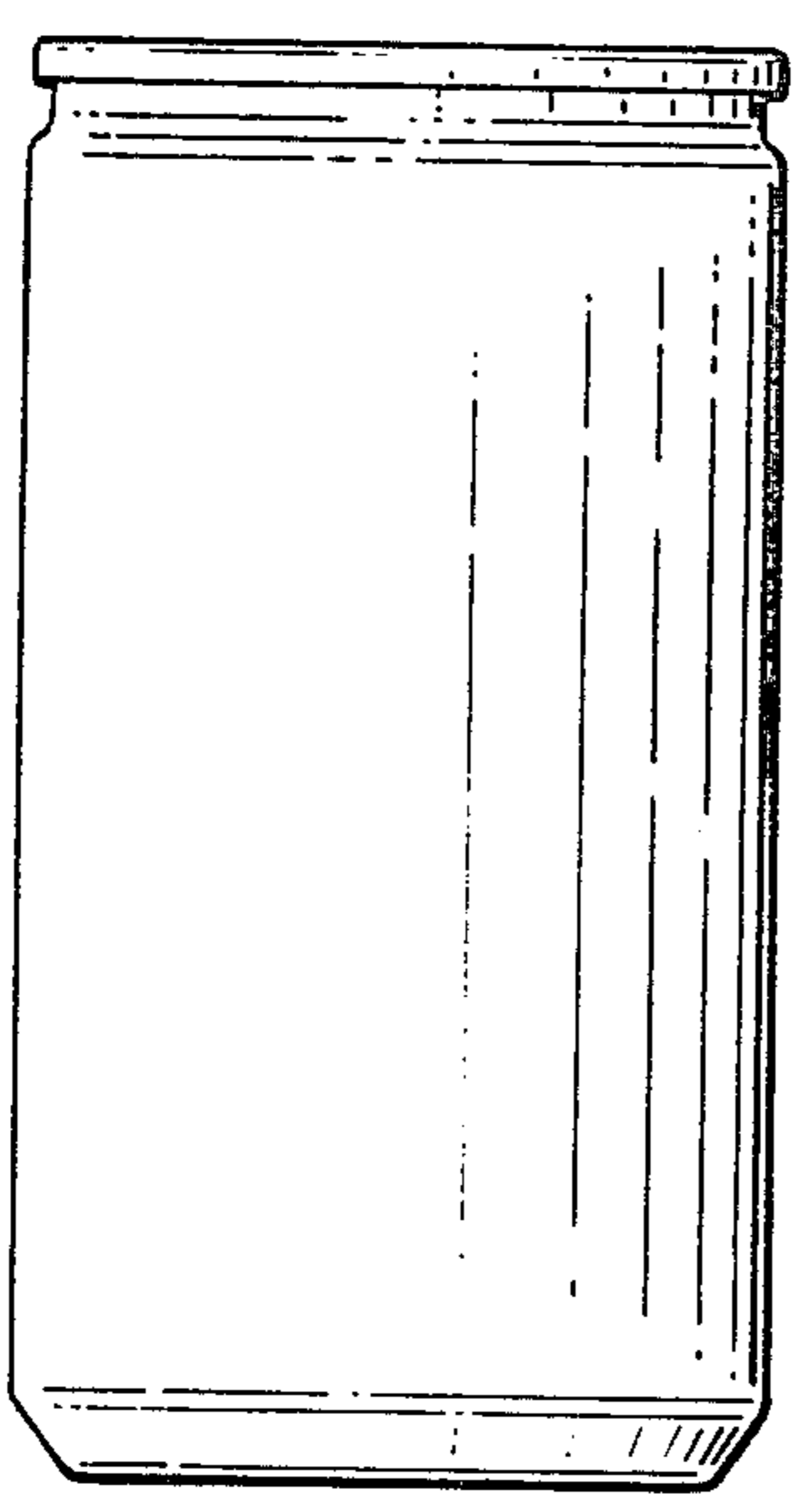

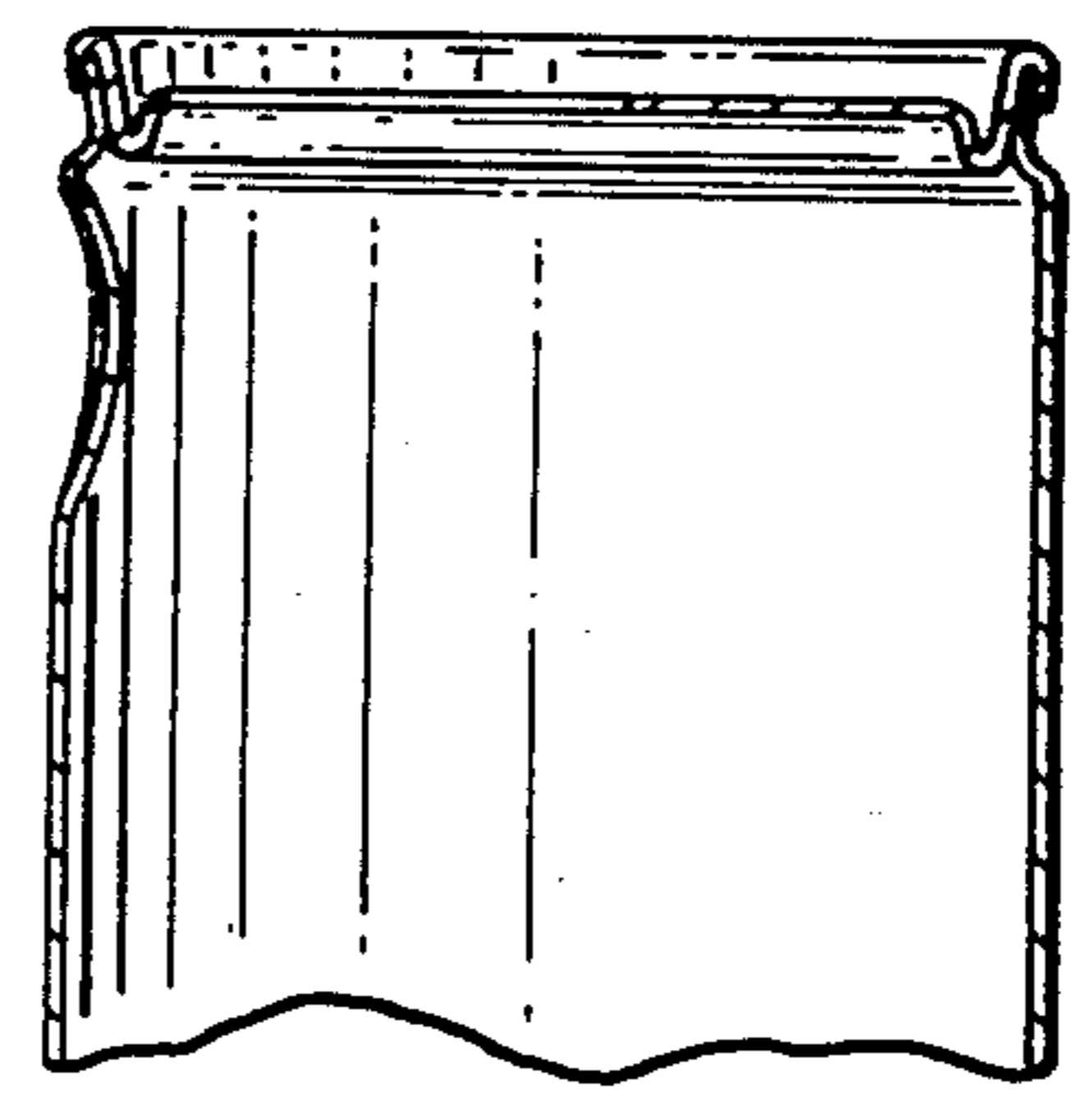

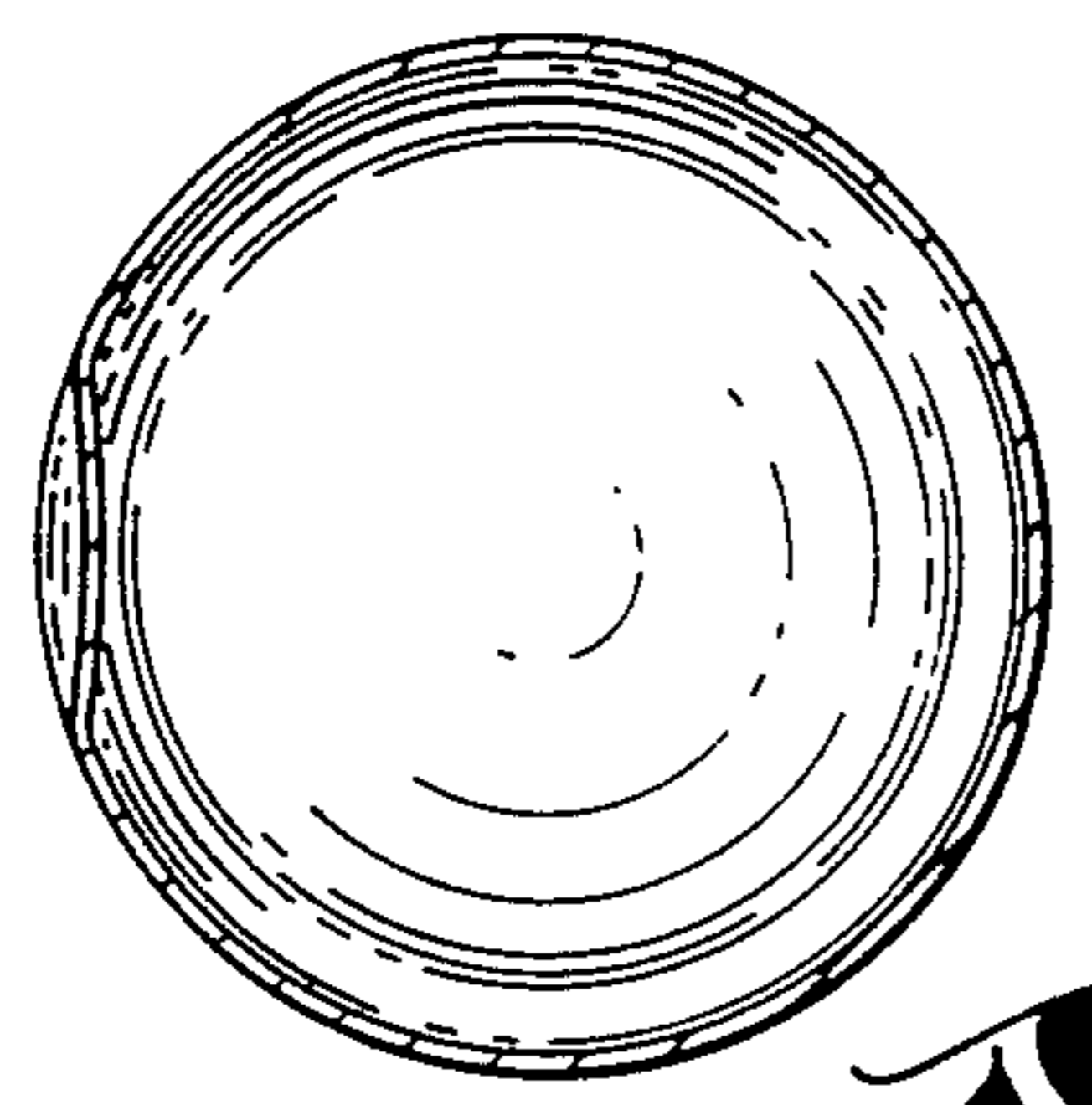

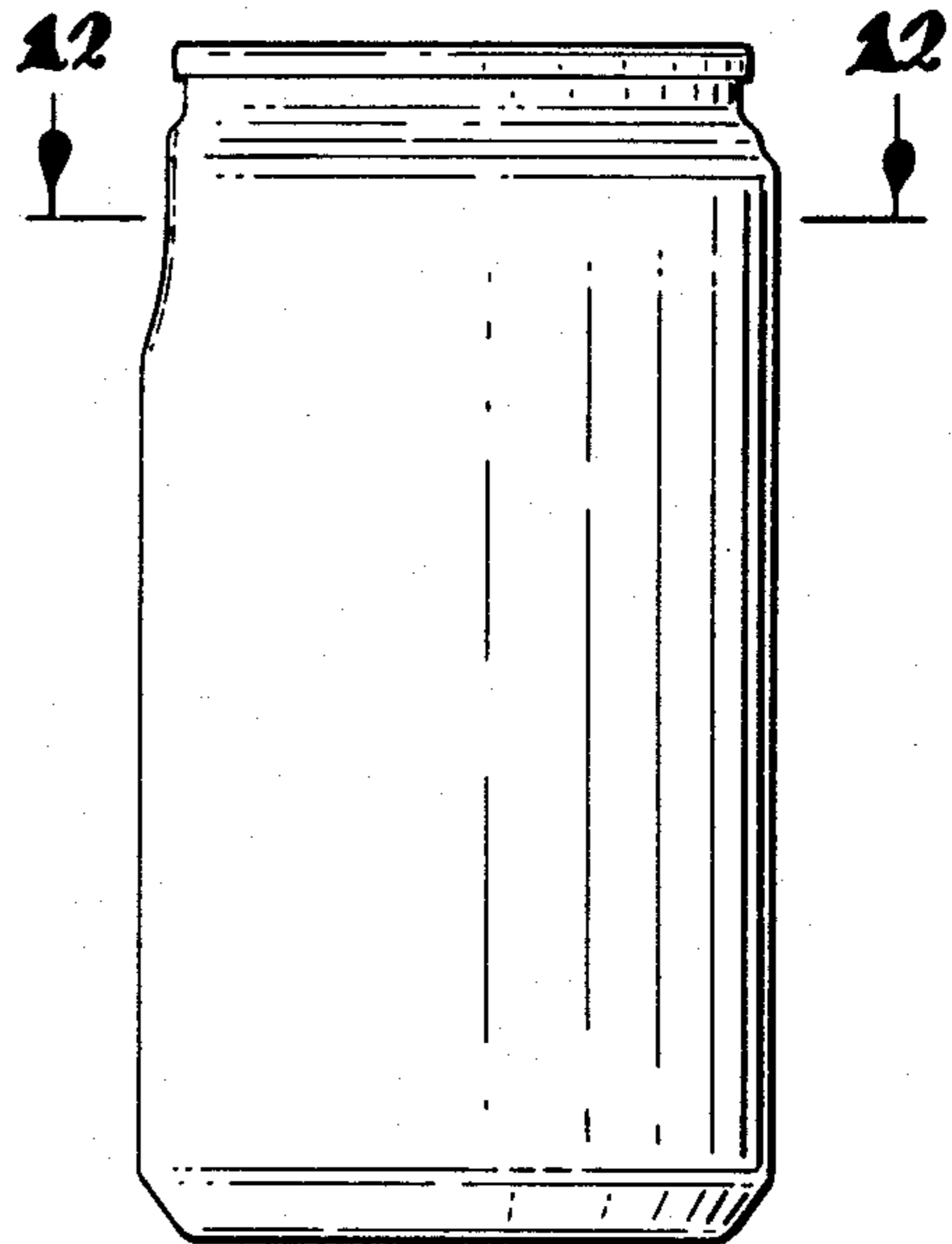
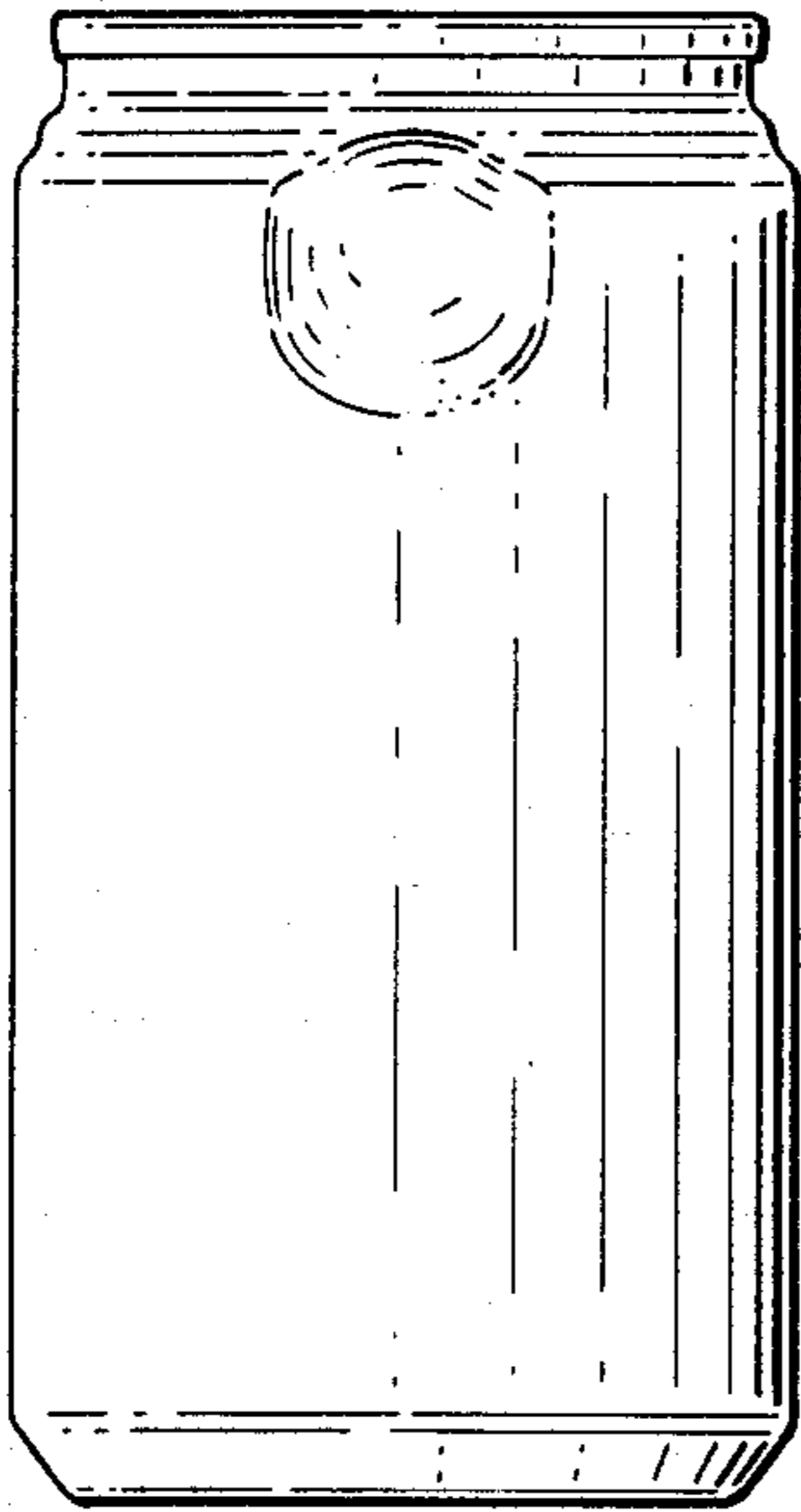

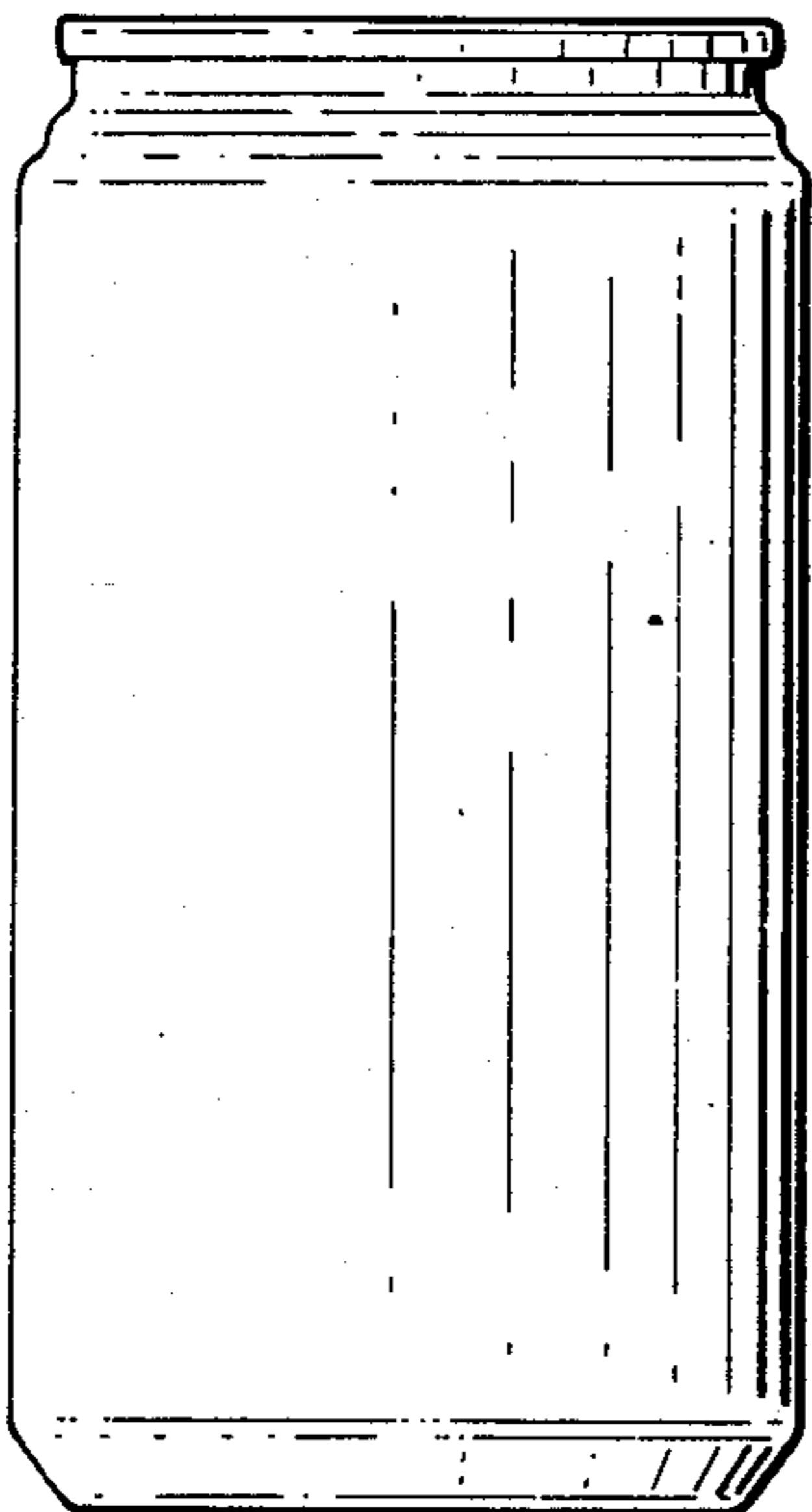

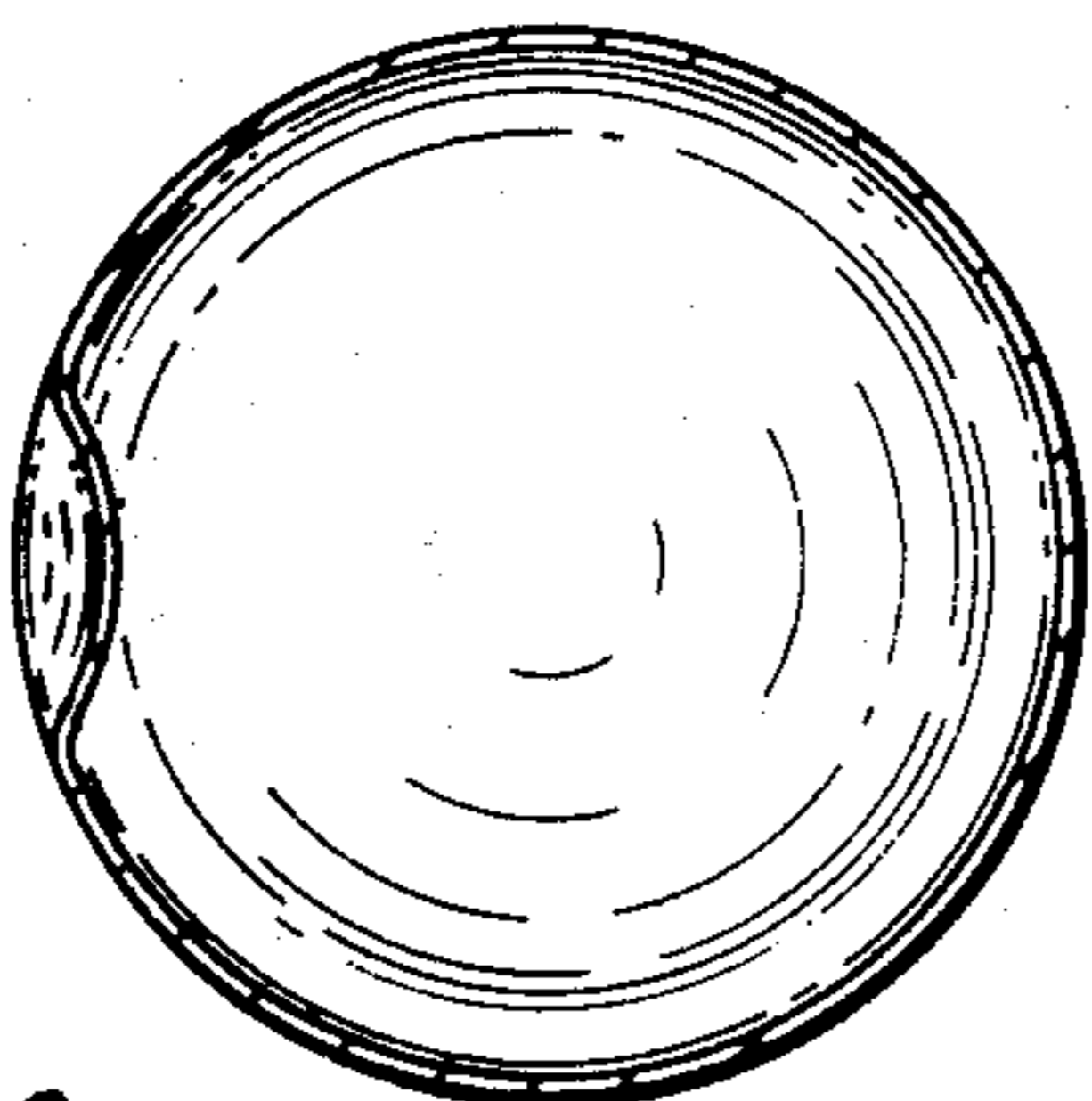
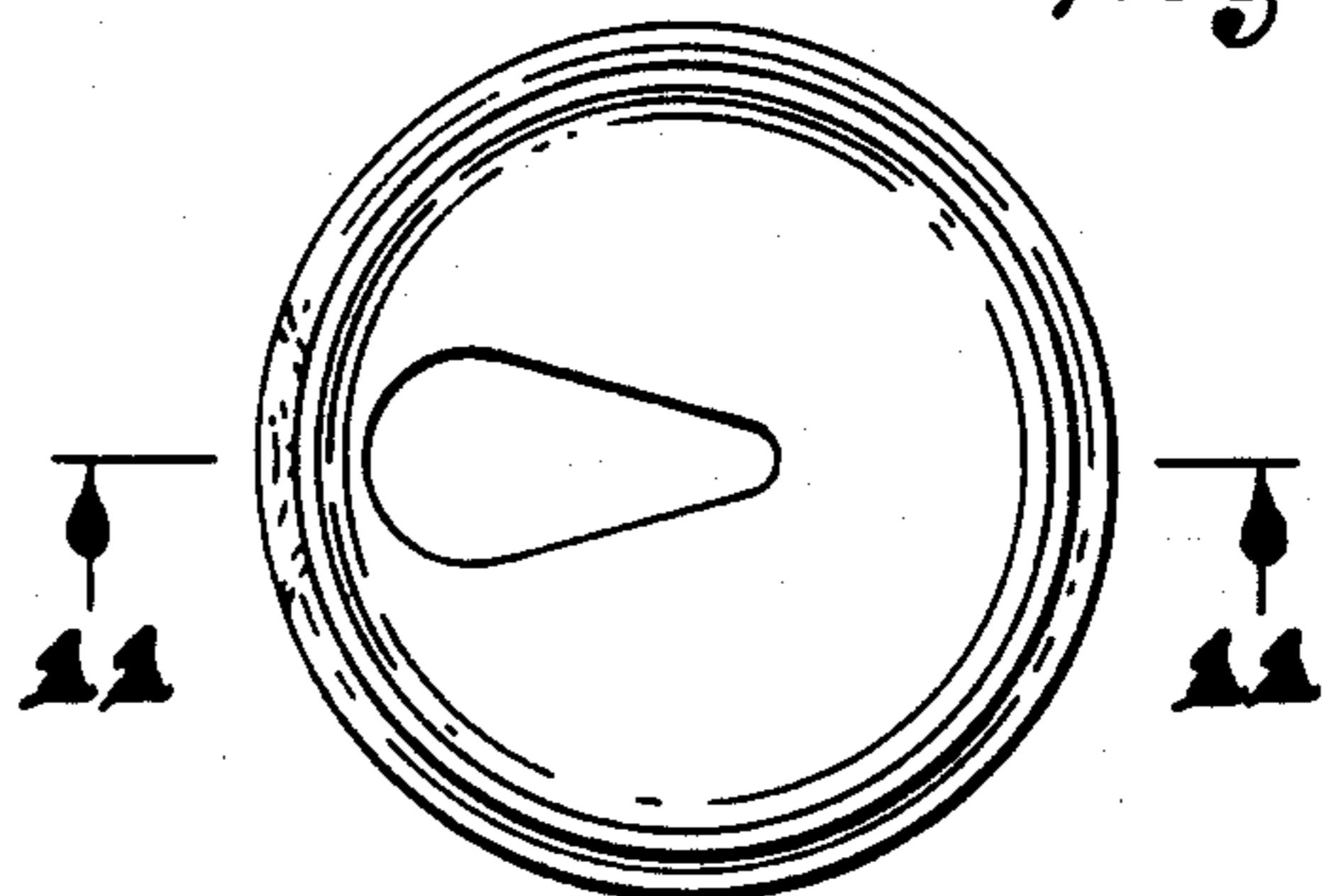

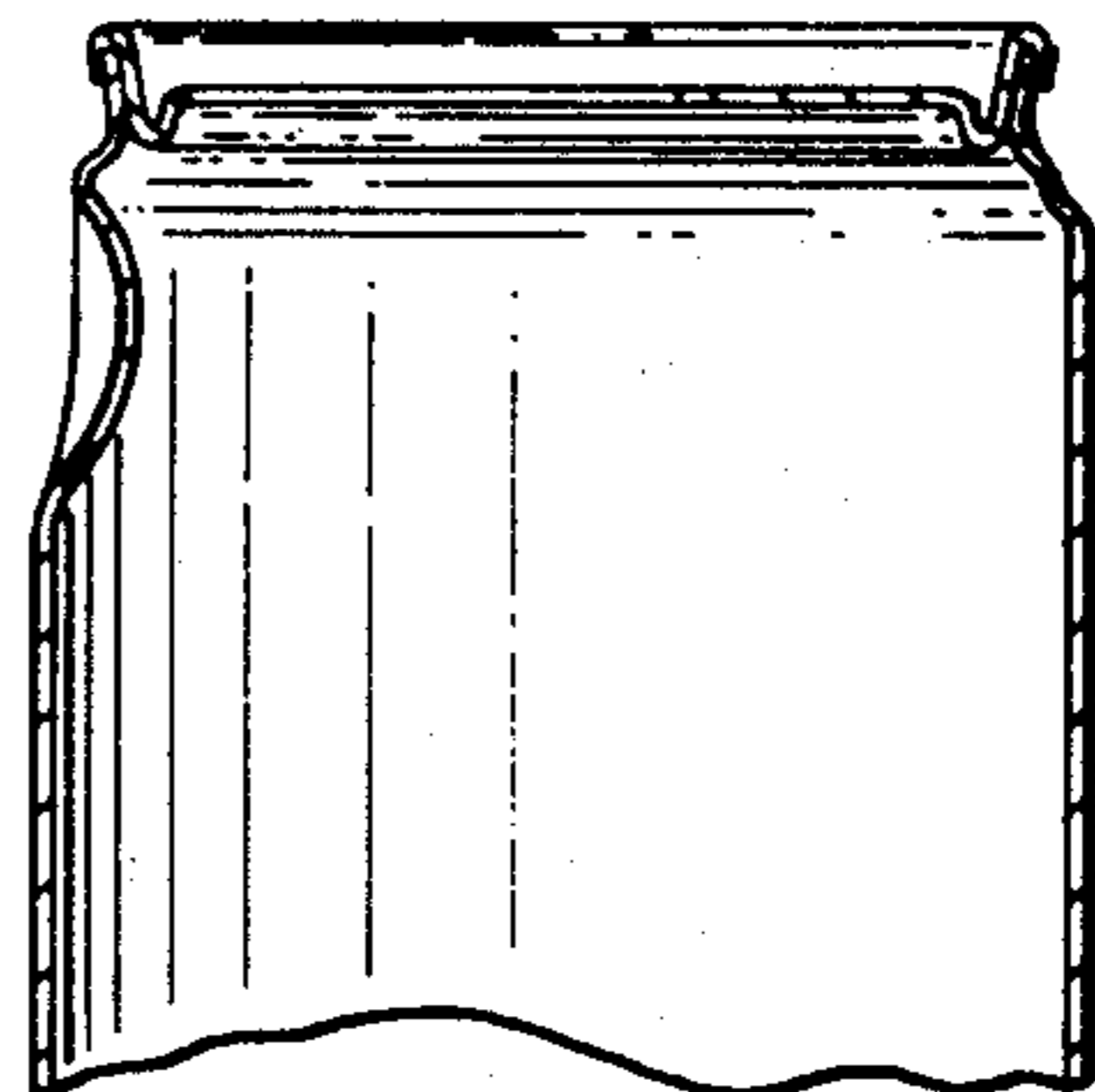

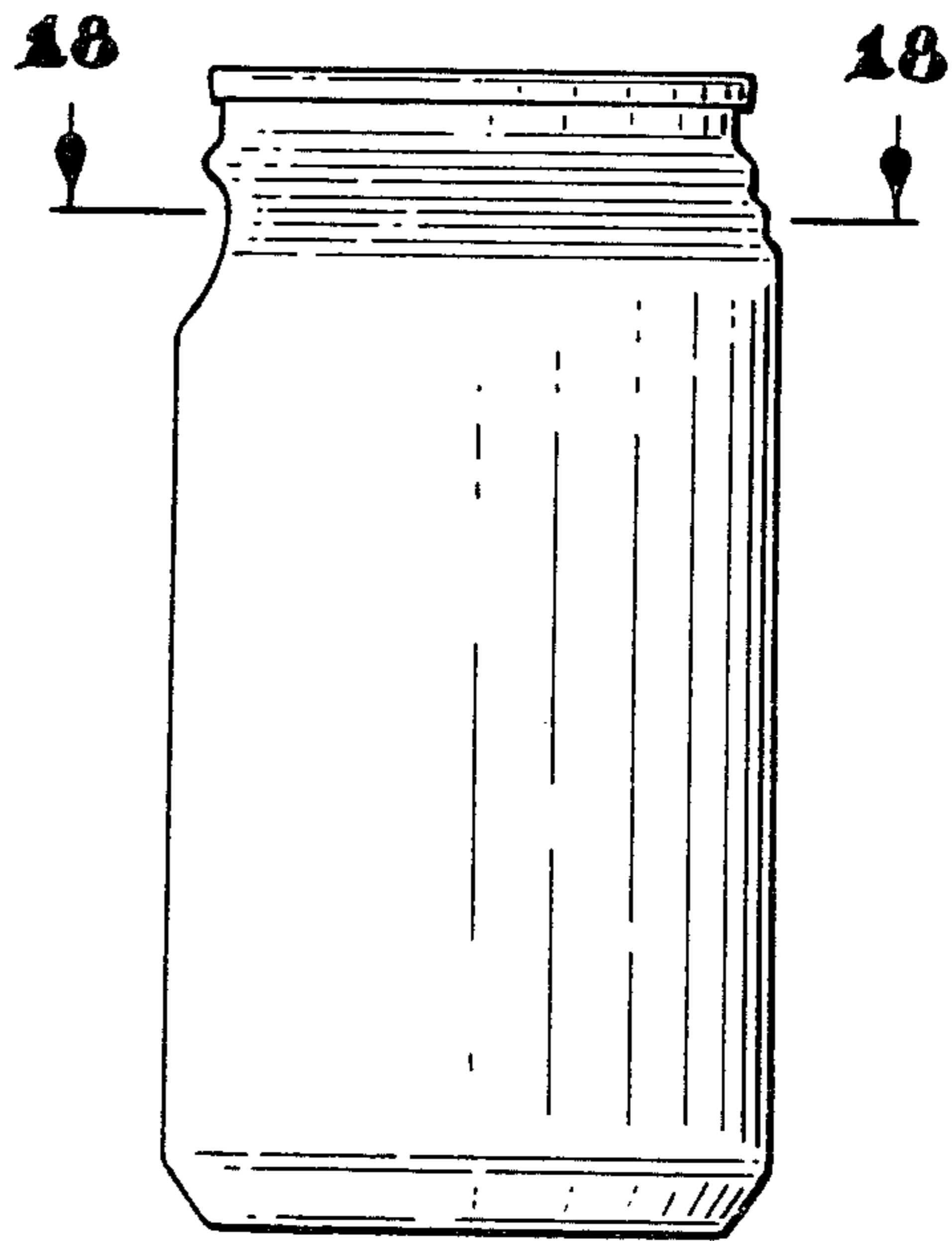
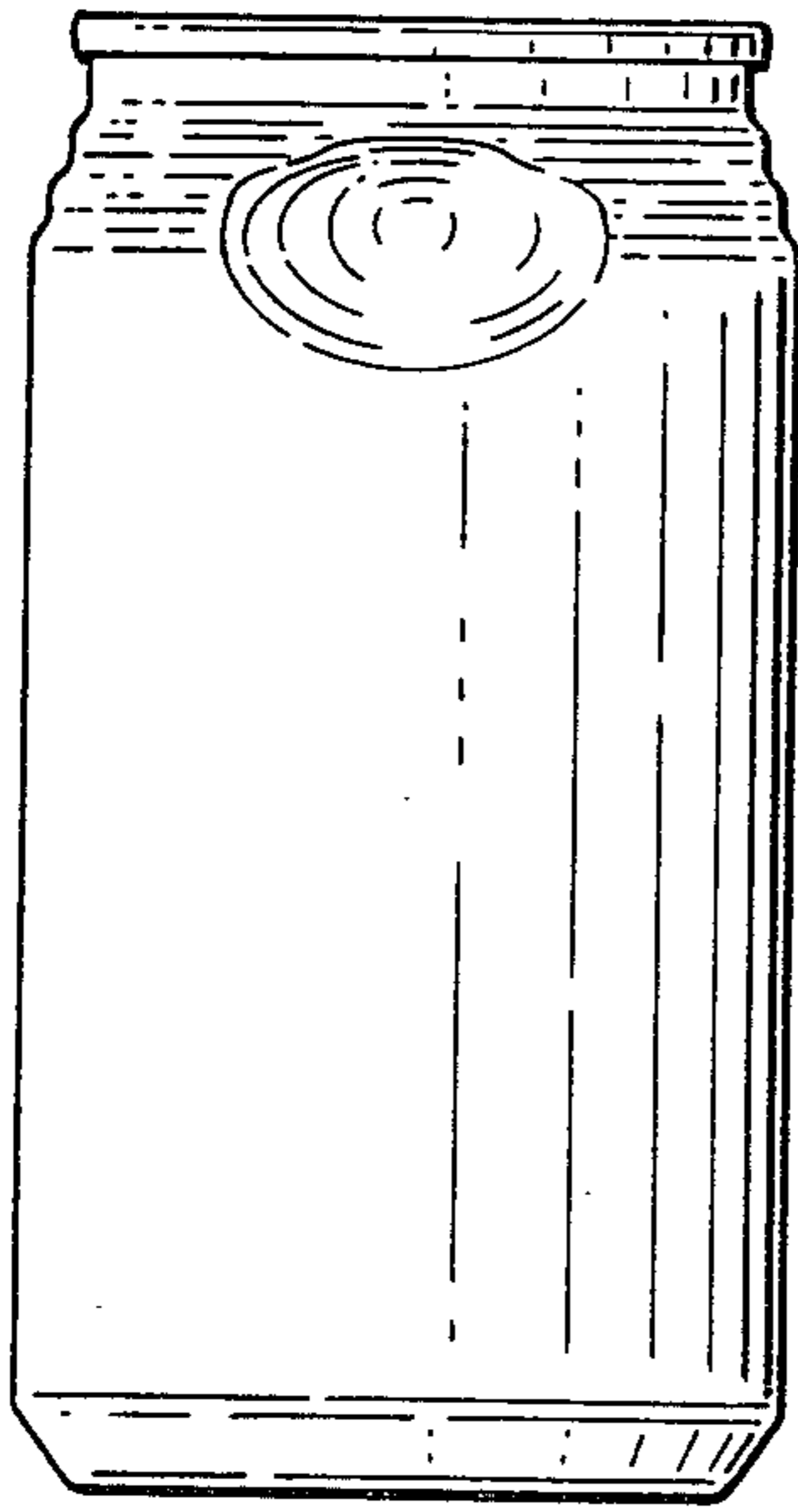

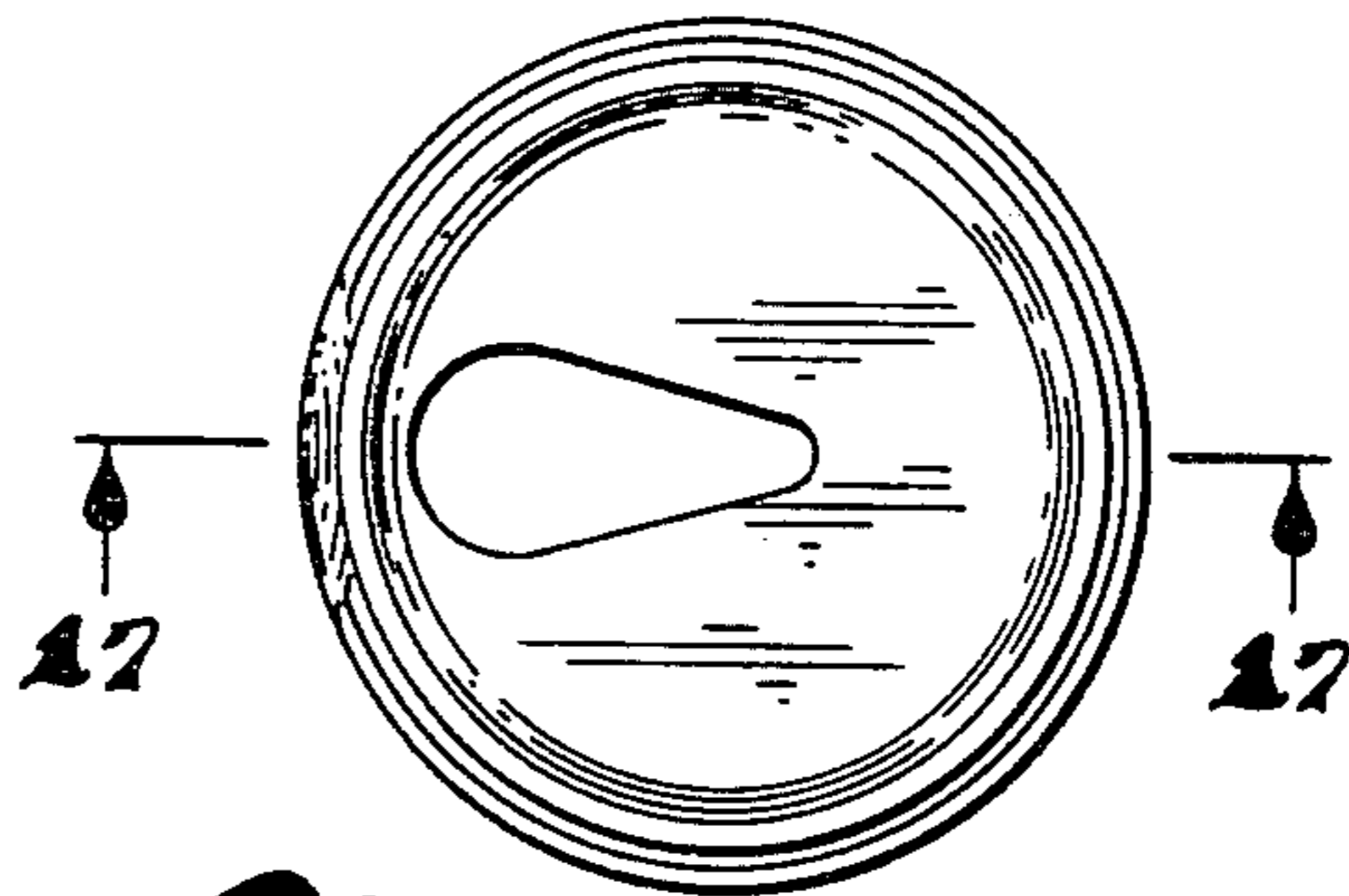
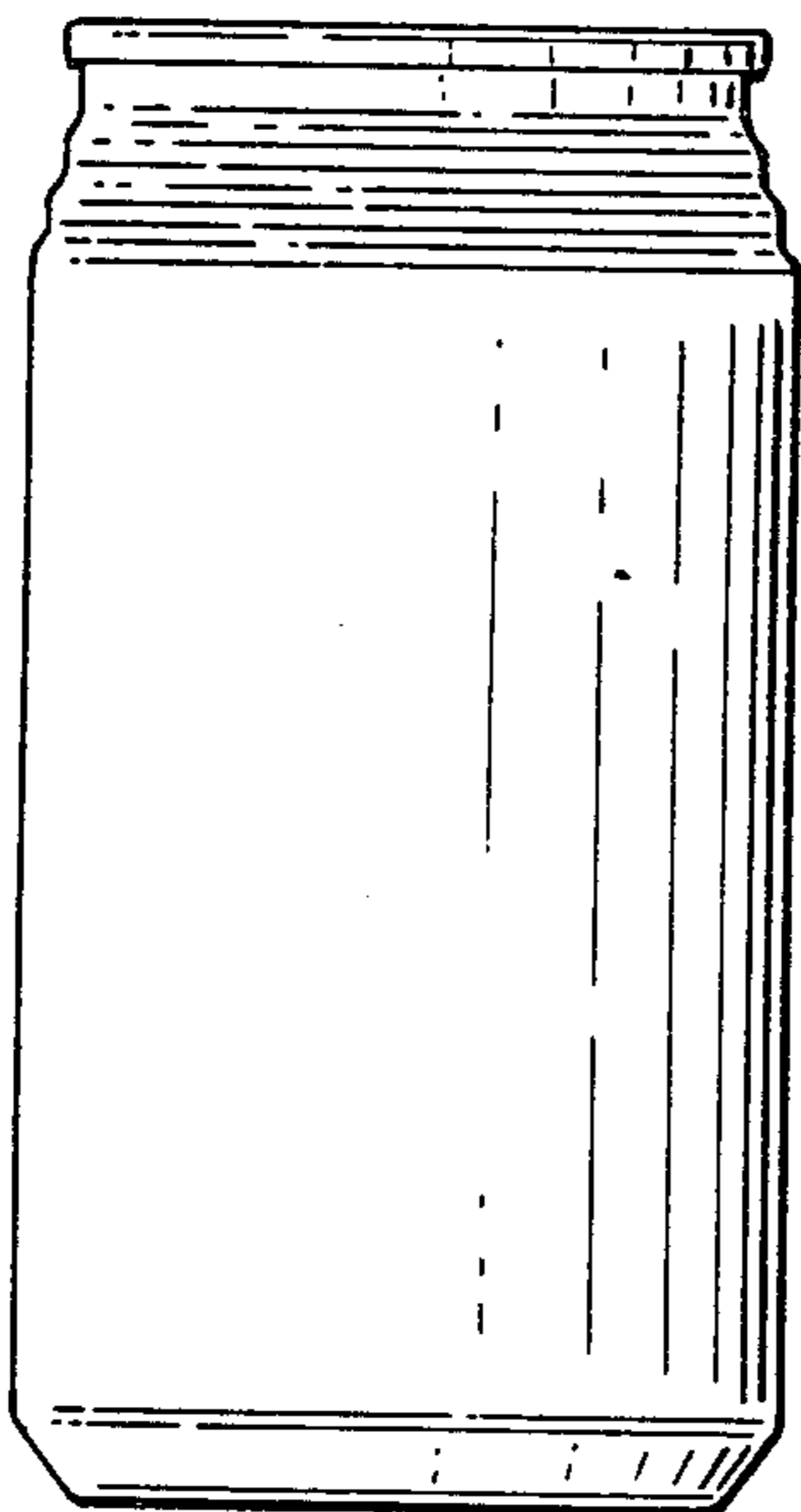

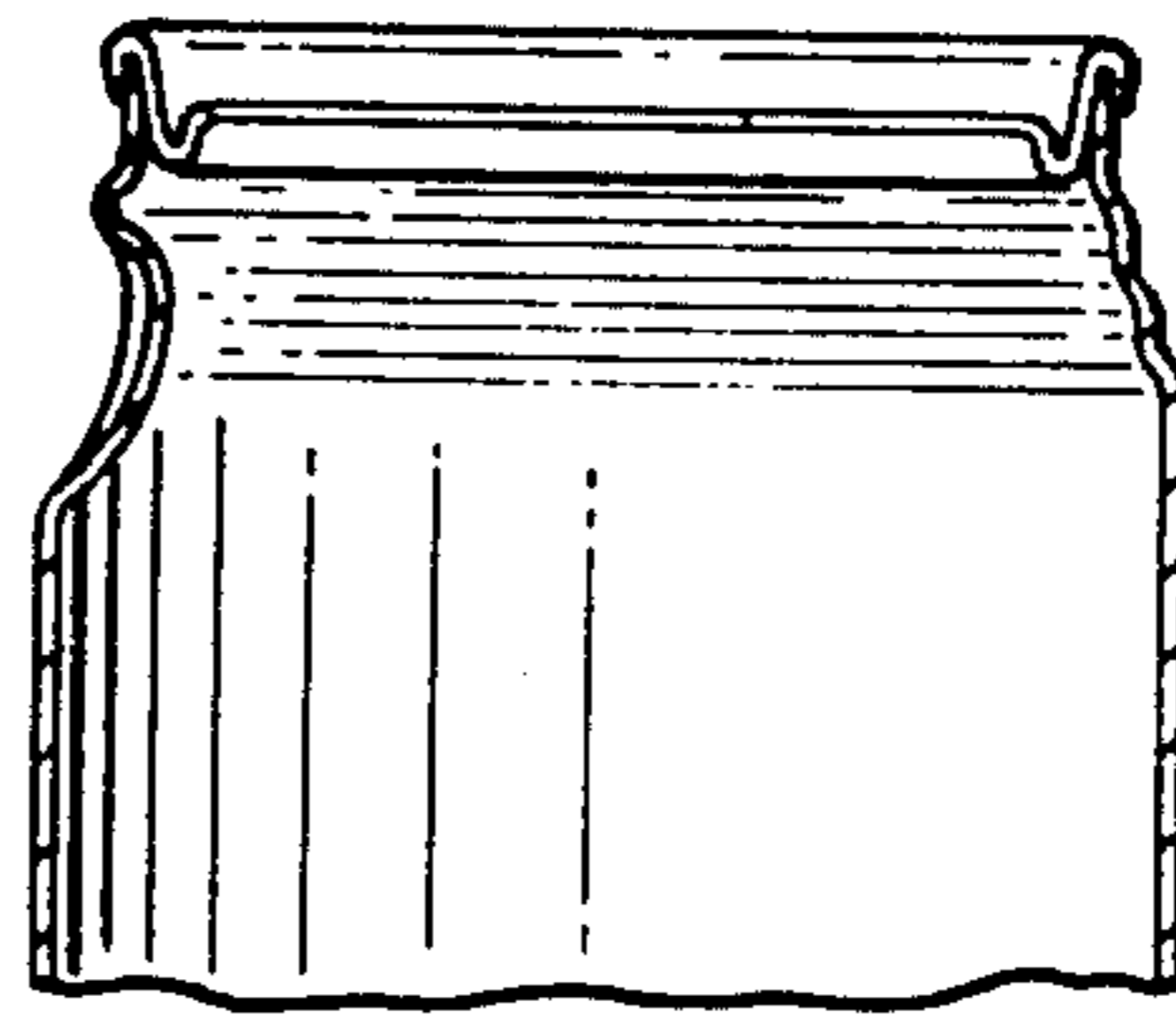

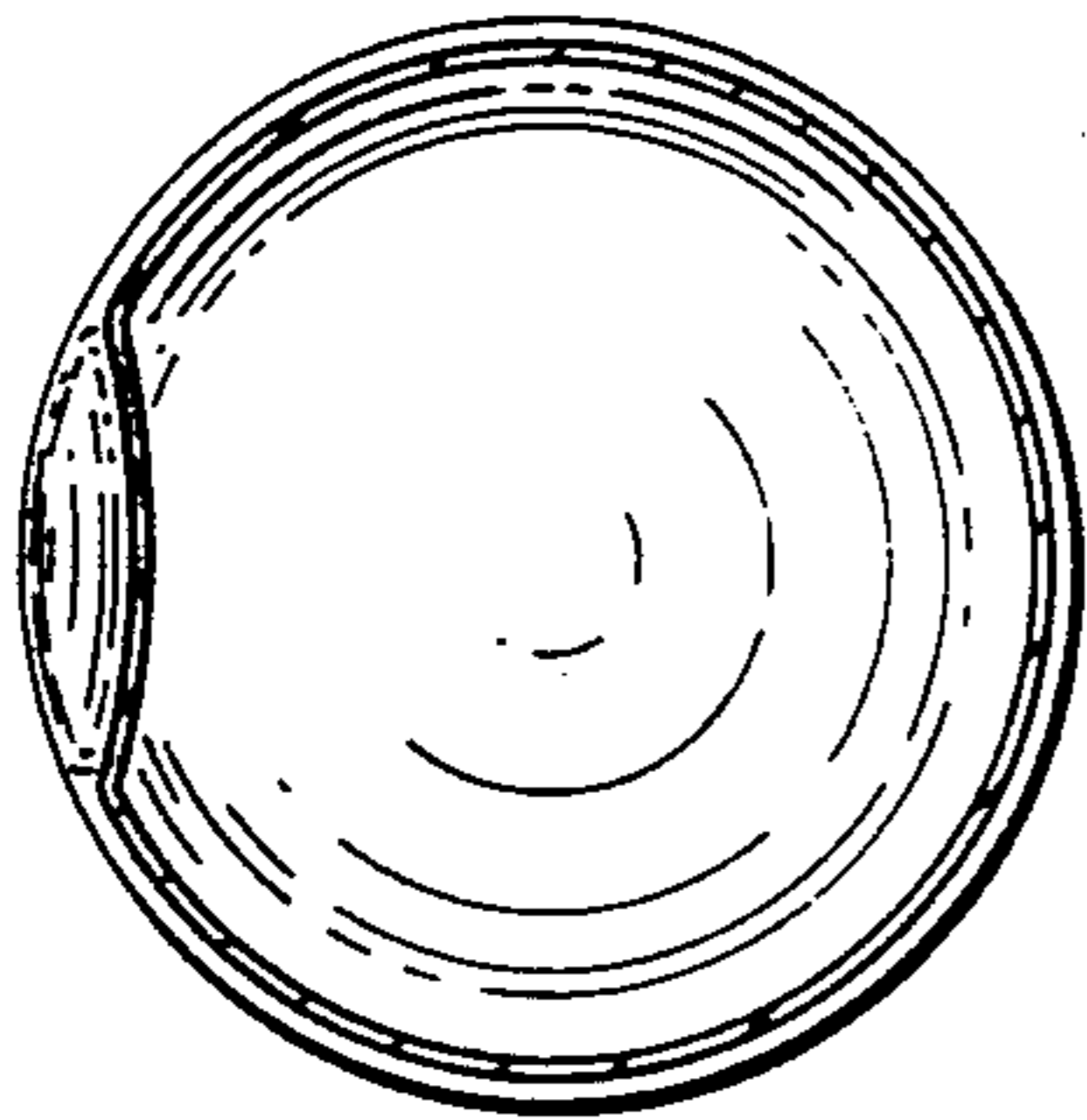
