The ornamental design for a telephone, substantially as shown.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a telephone showing our new design;  
FIG. 2 is a front, top and left side perspective view with the handset removed from the telephone base;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a left side elevational view thereof; and  
FIG. 8 is a front, top and right side perspective view of a second embodiment thereof.

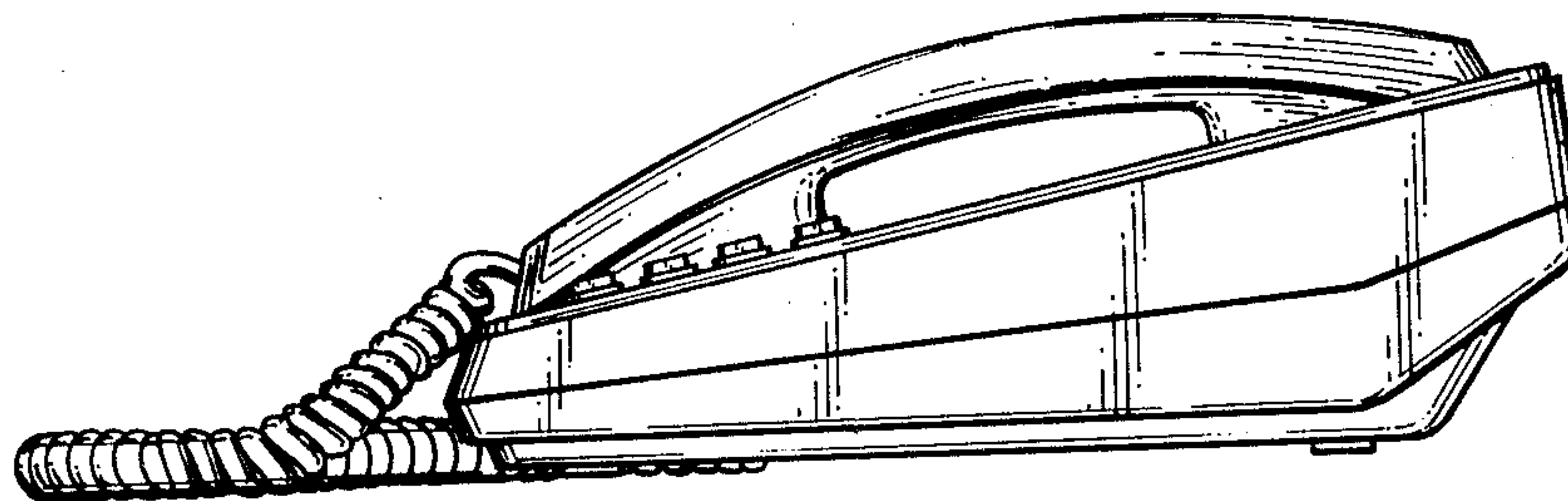
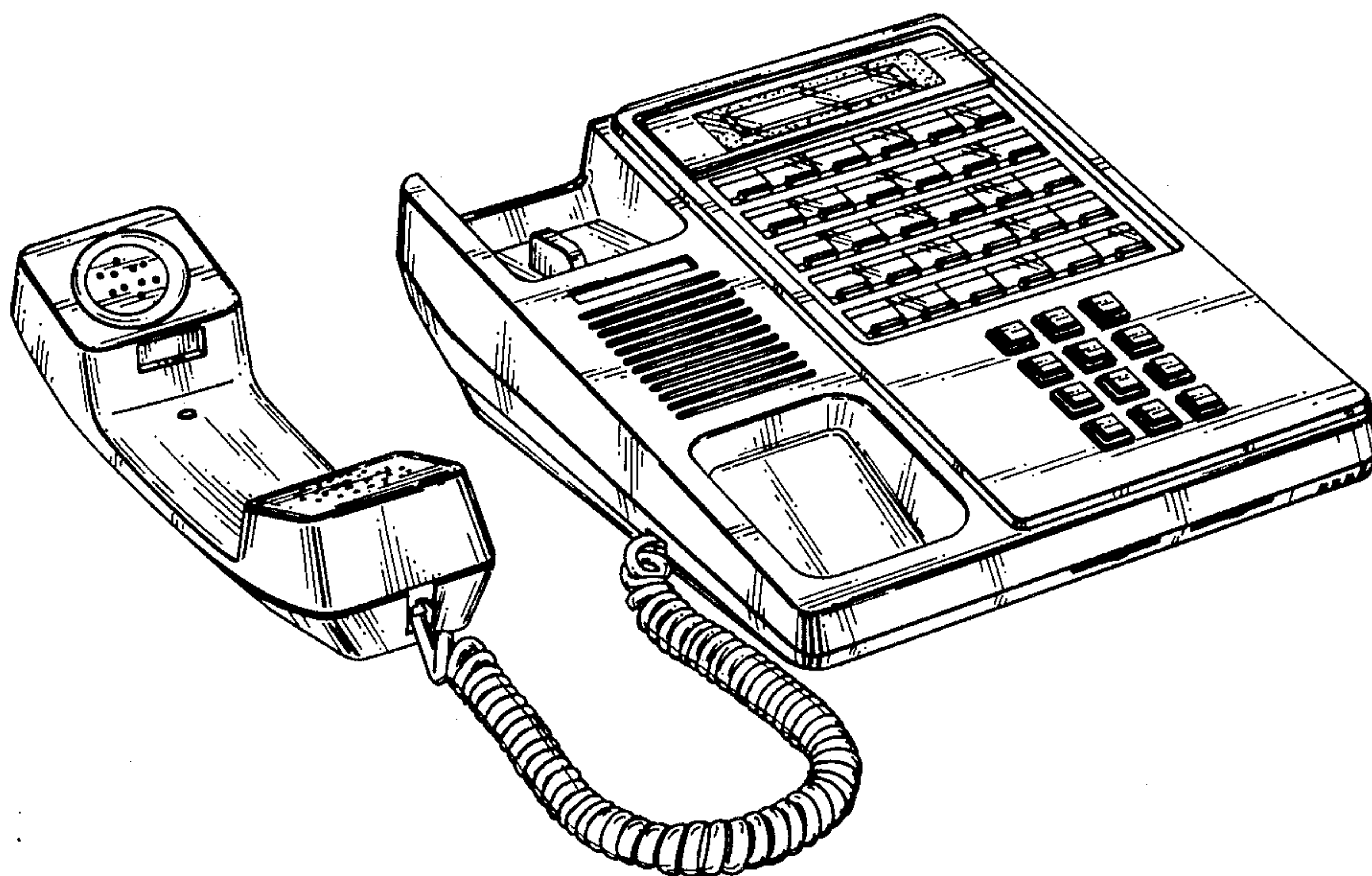

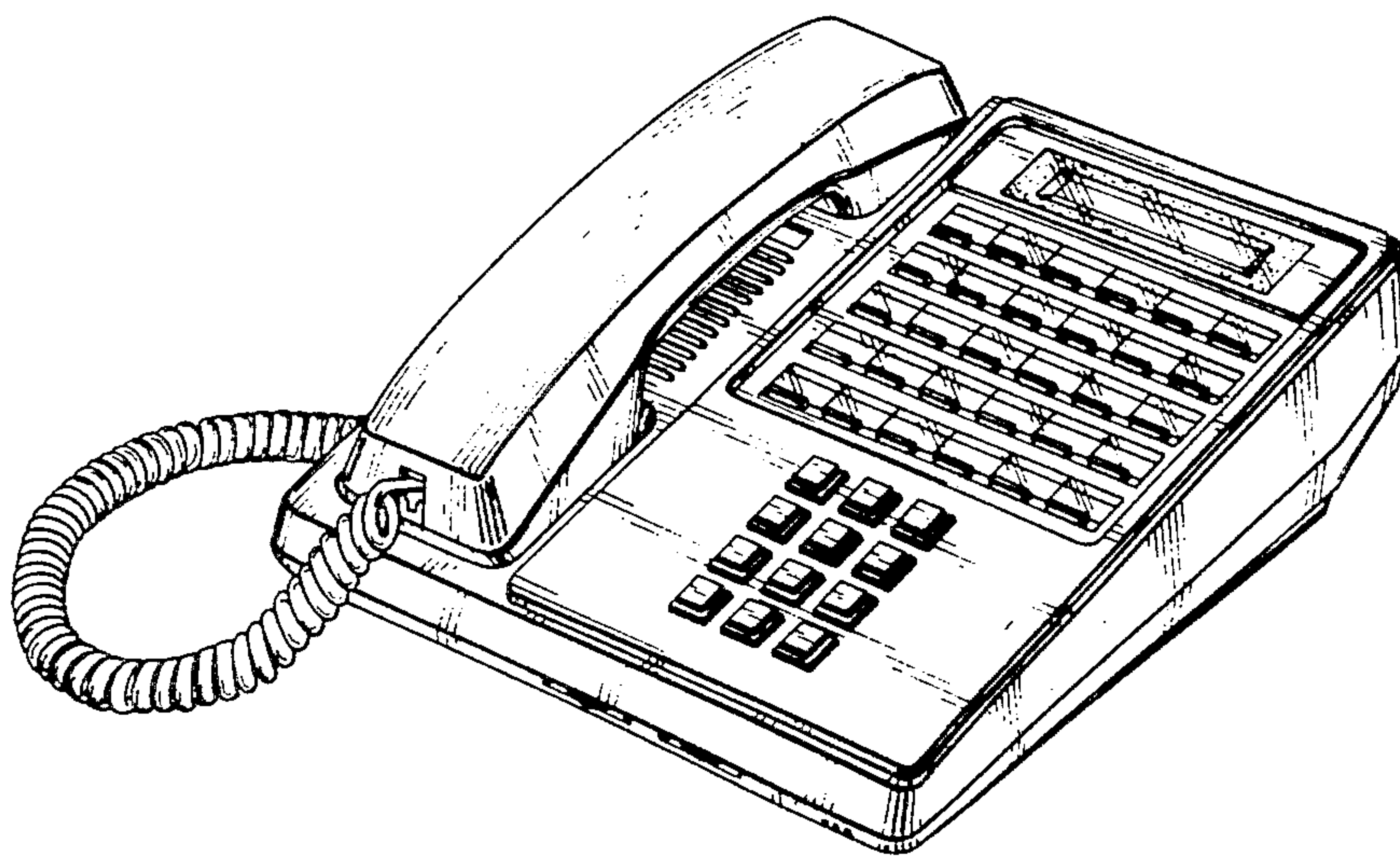

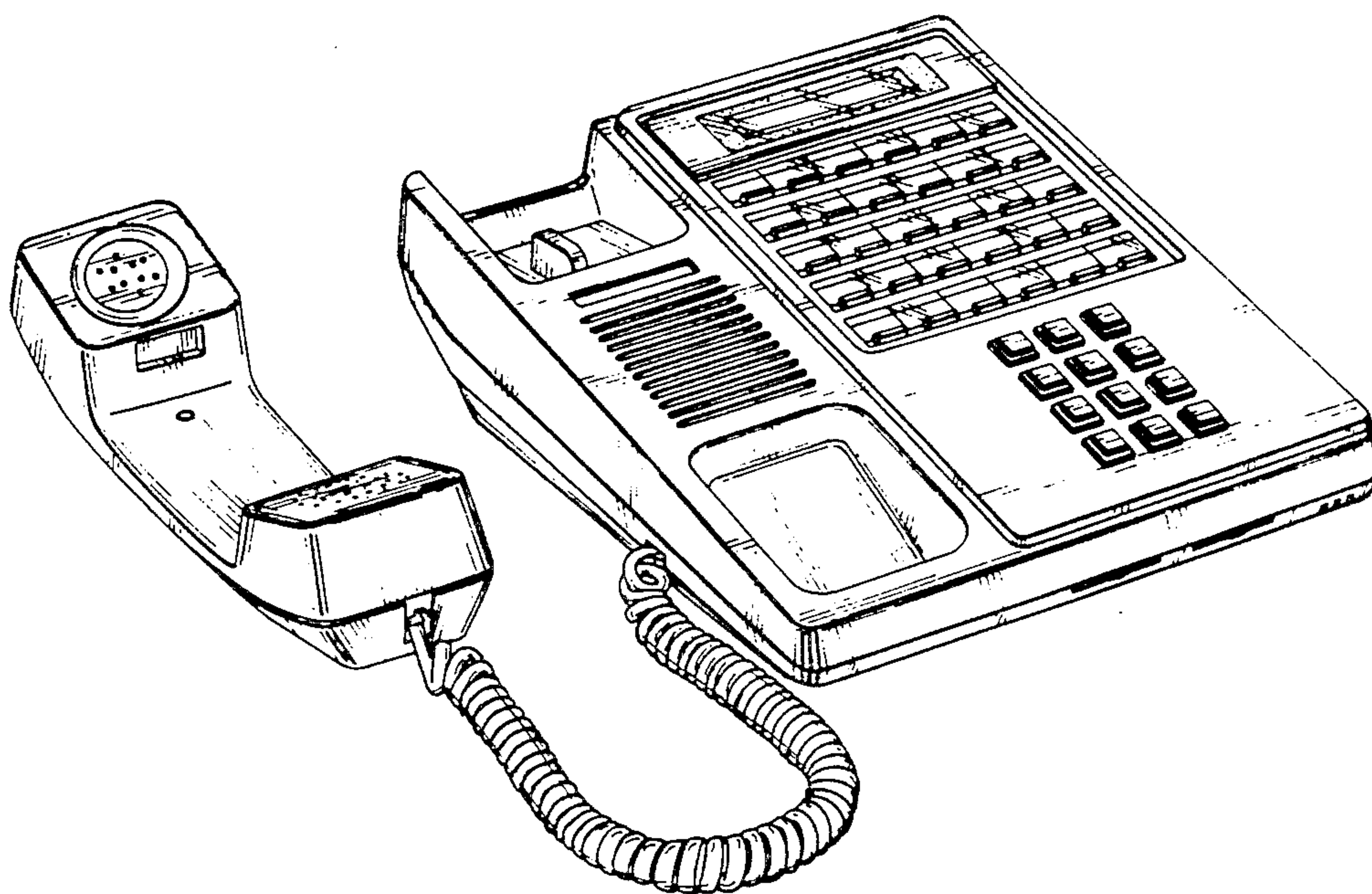

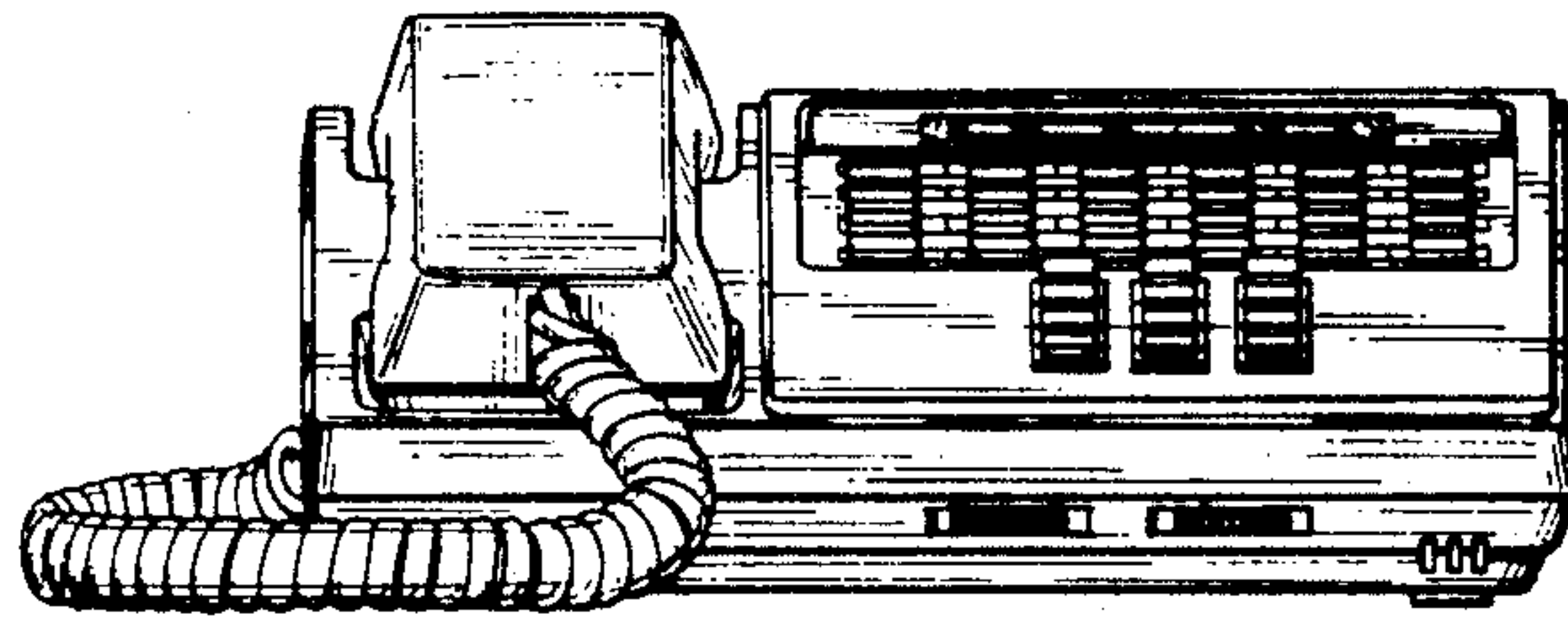

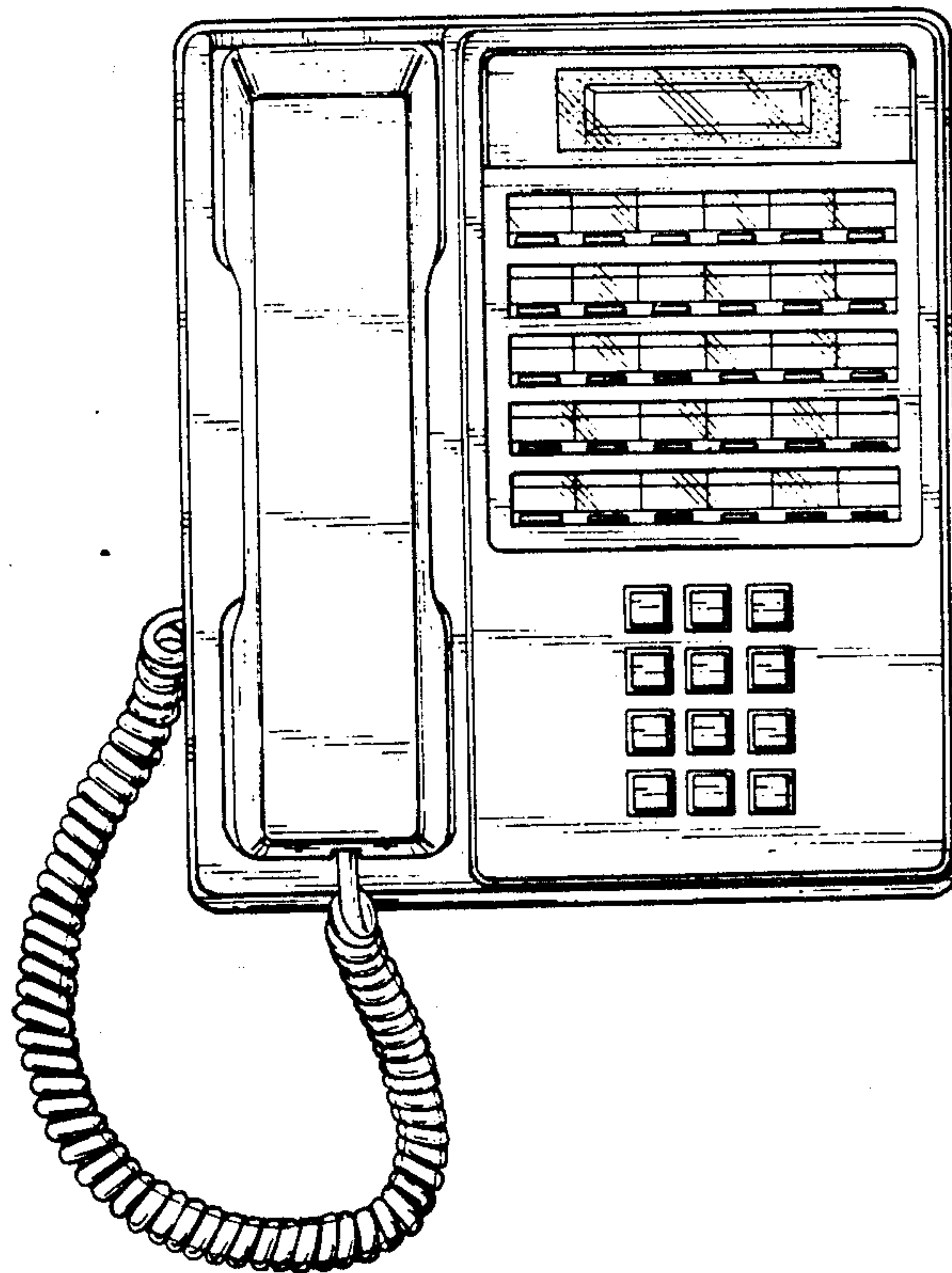

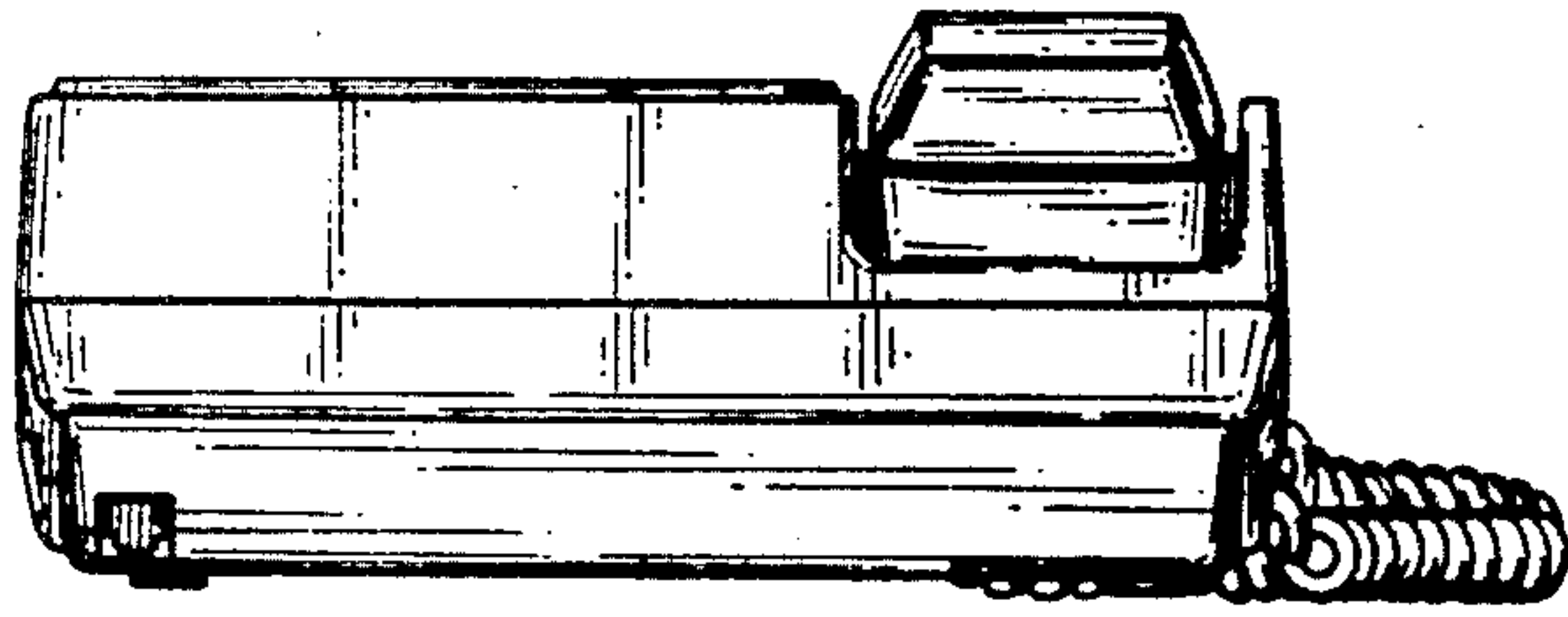

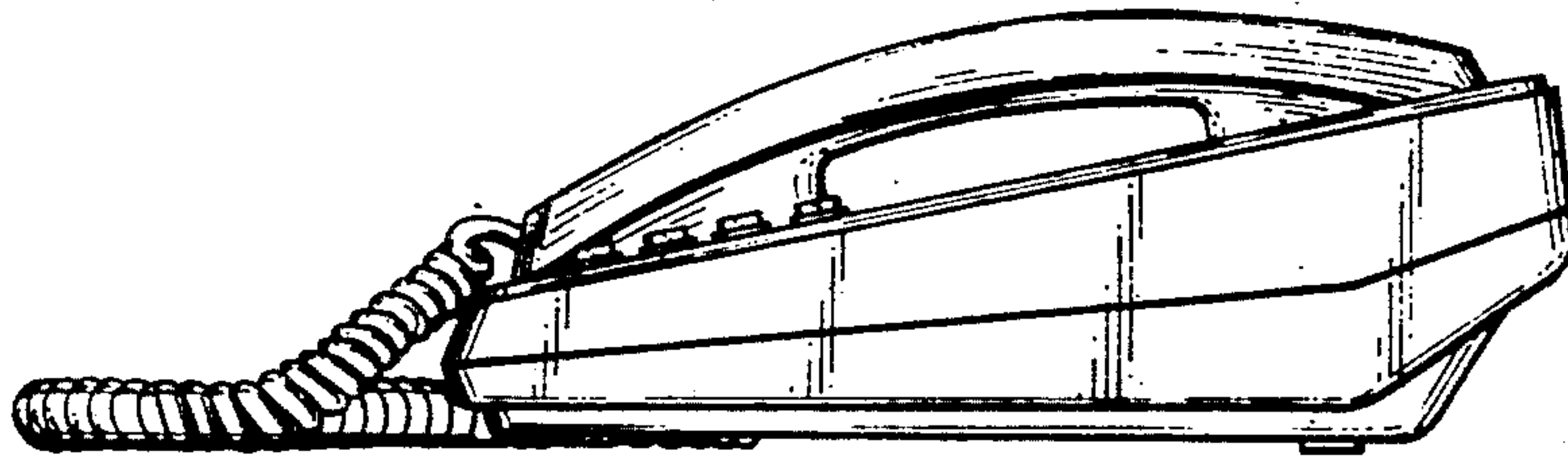

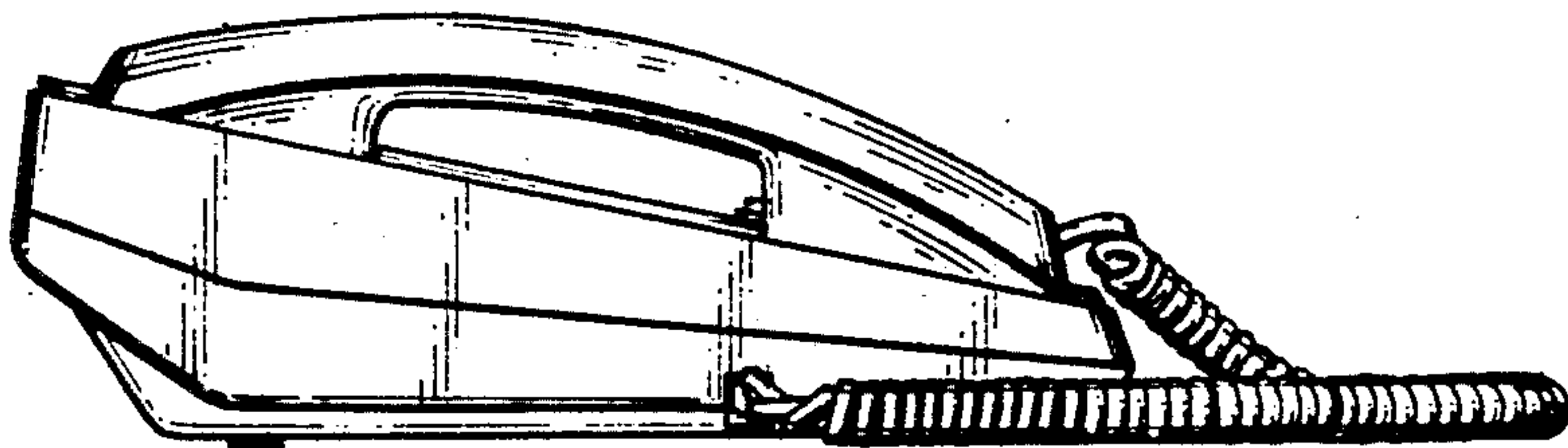
