FIG. 14 is a perspective view showing the fitting of the new design without the casing in a front angle view, from the upper right side;

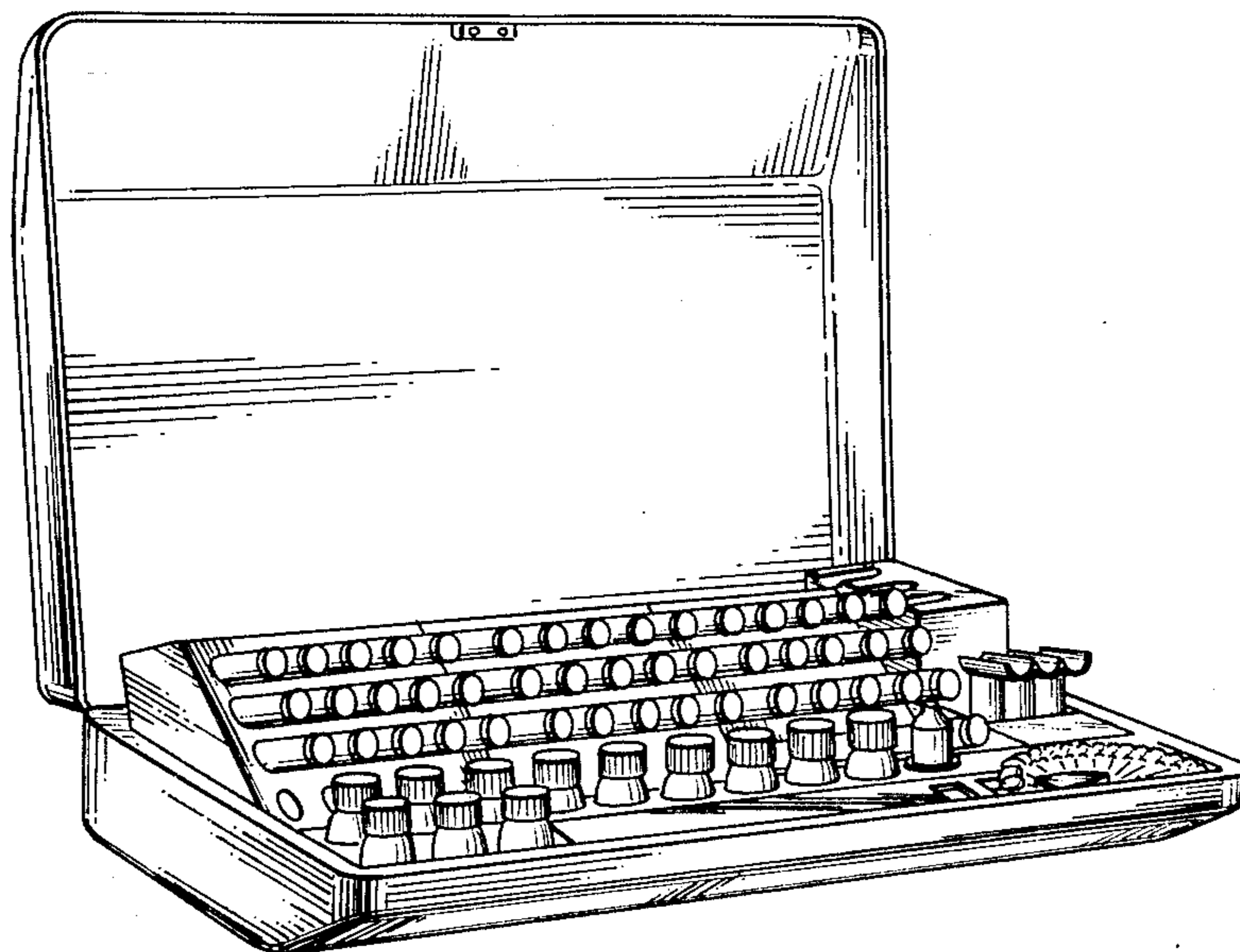
FIG. 15 is a perspective view of the fitting of the new design in a front angle view, from the upper left side;

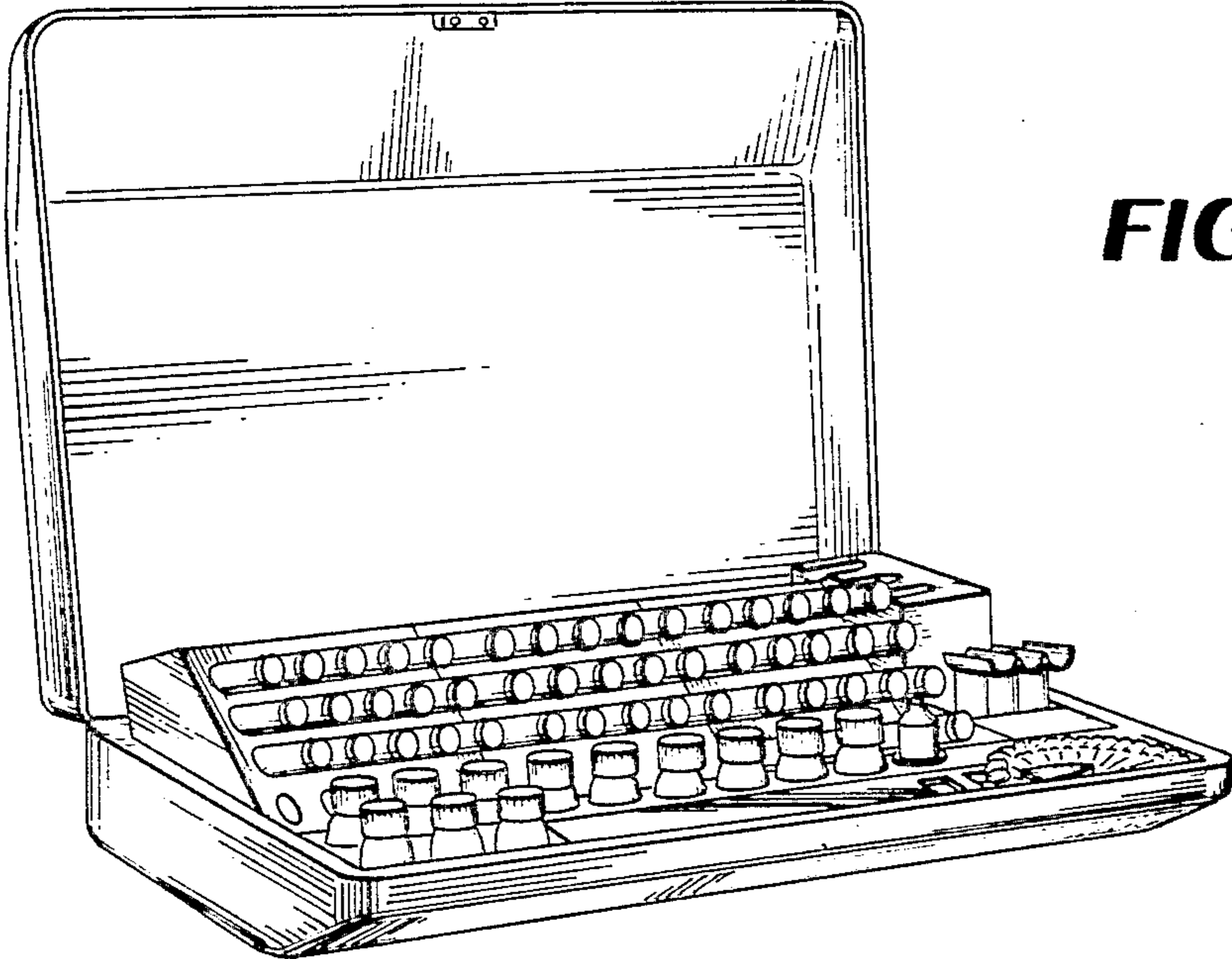

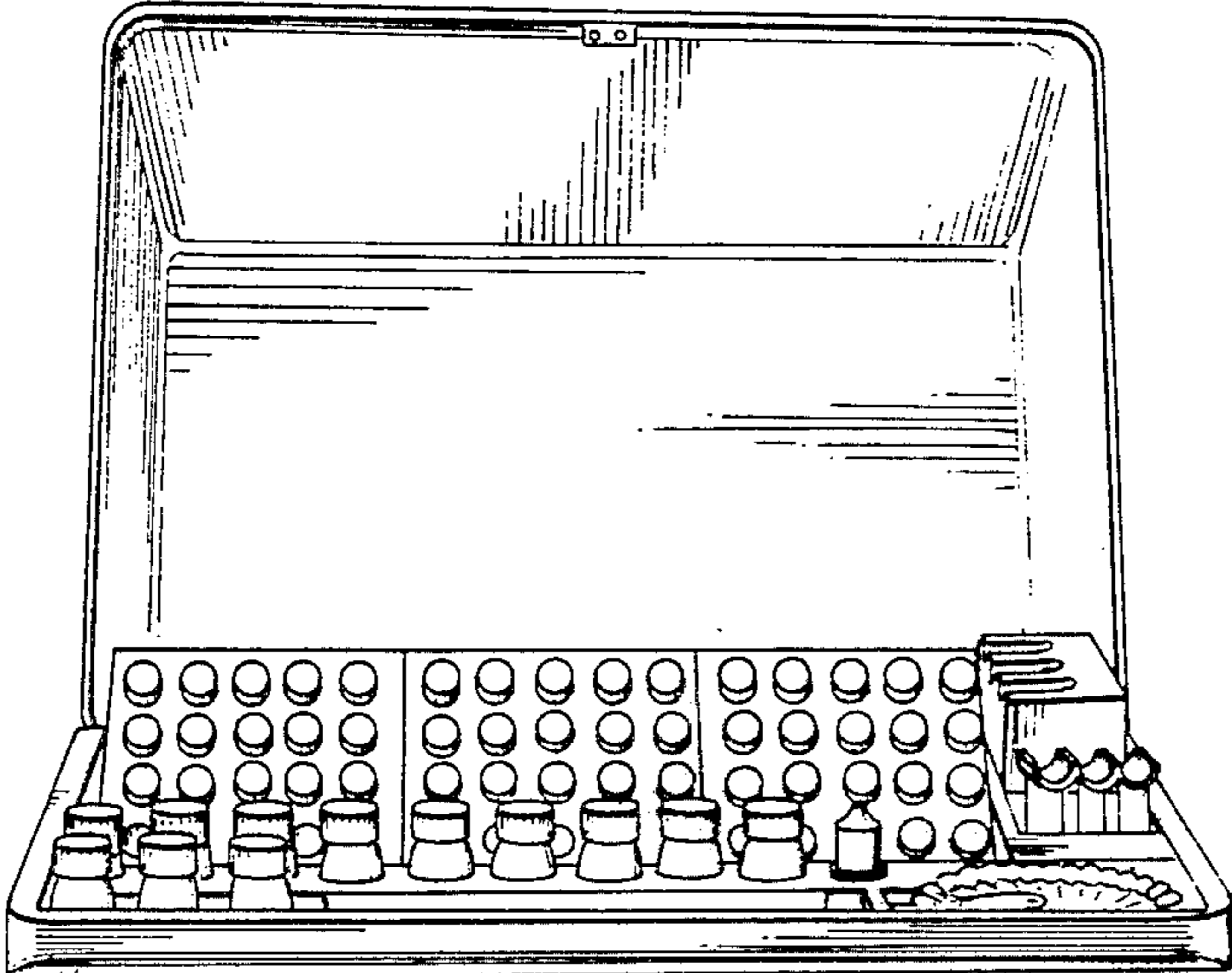

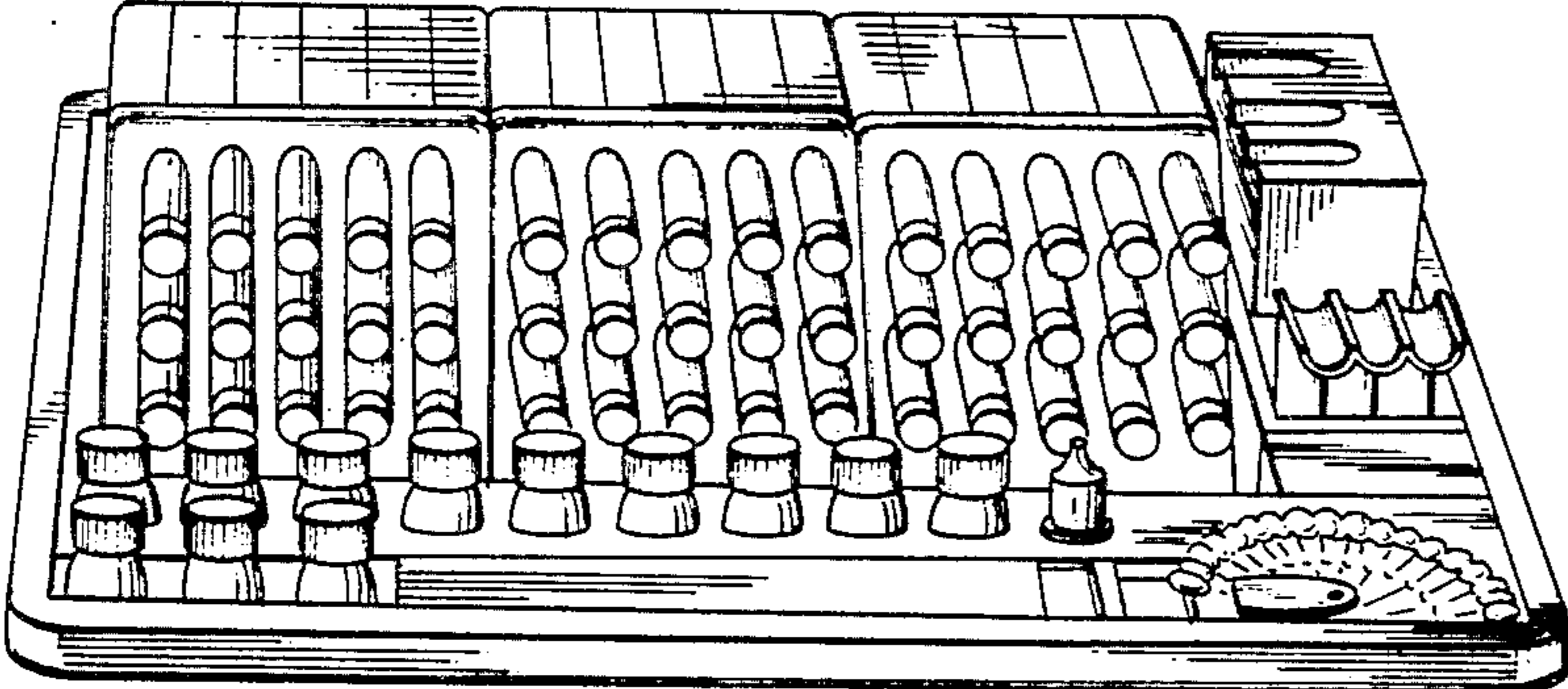

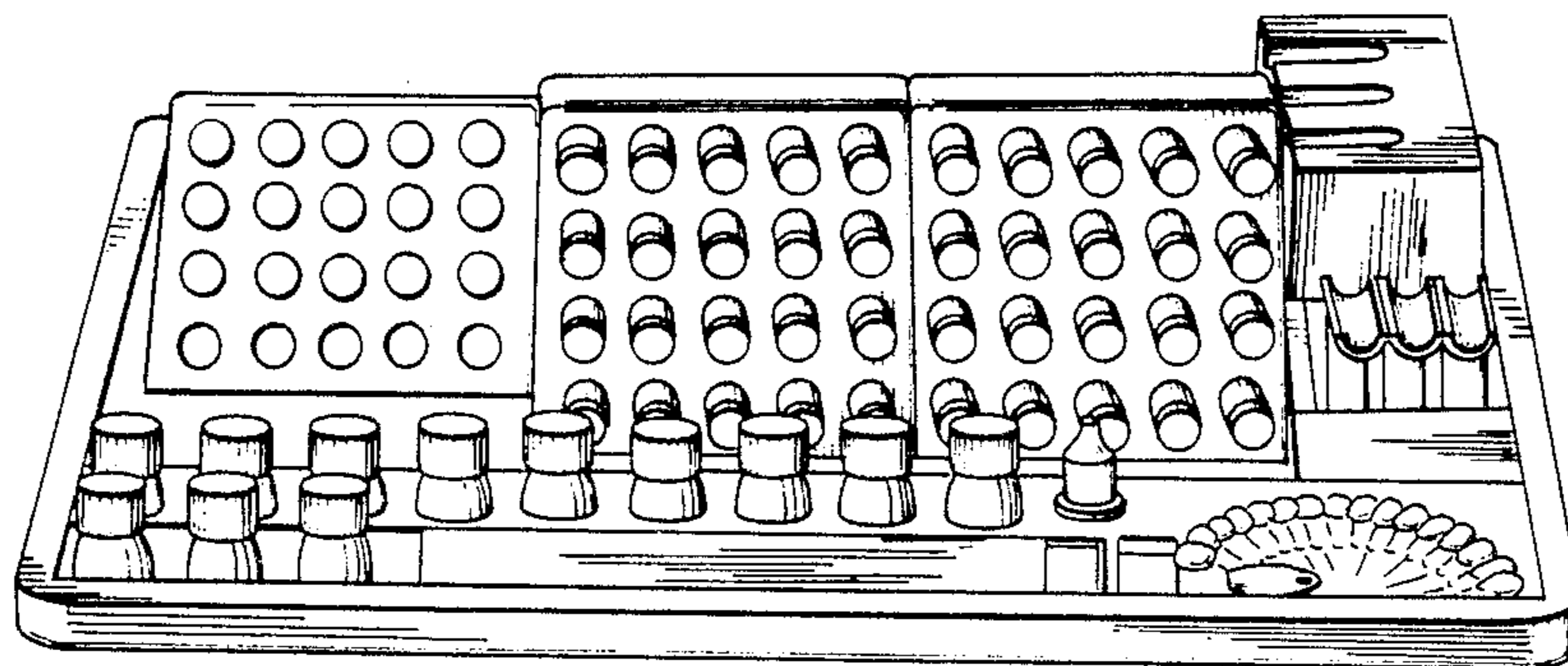

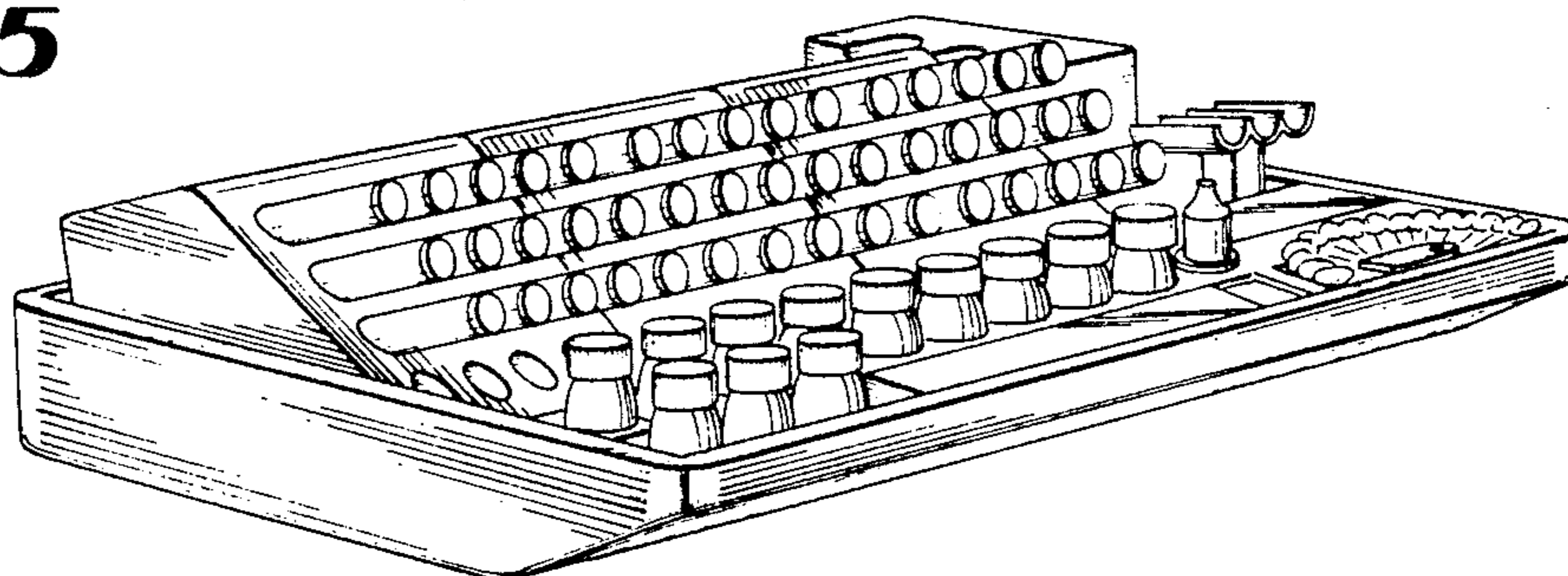

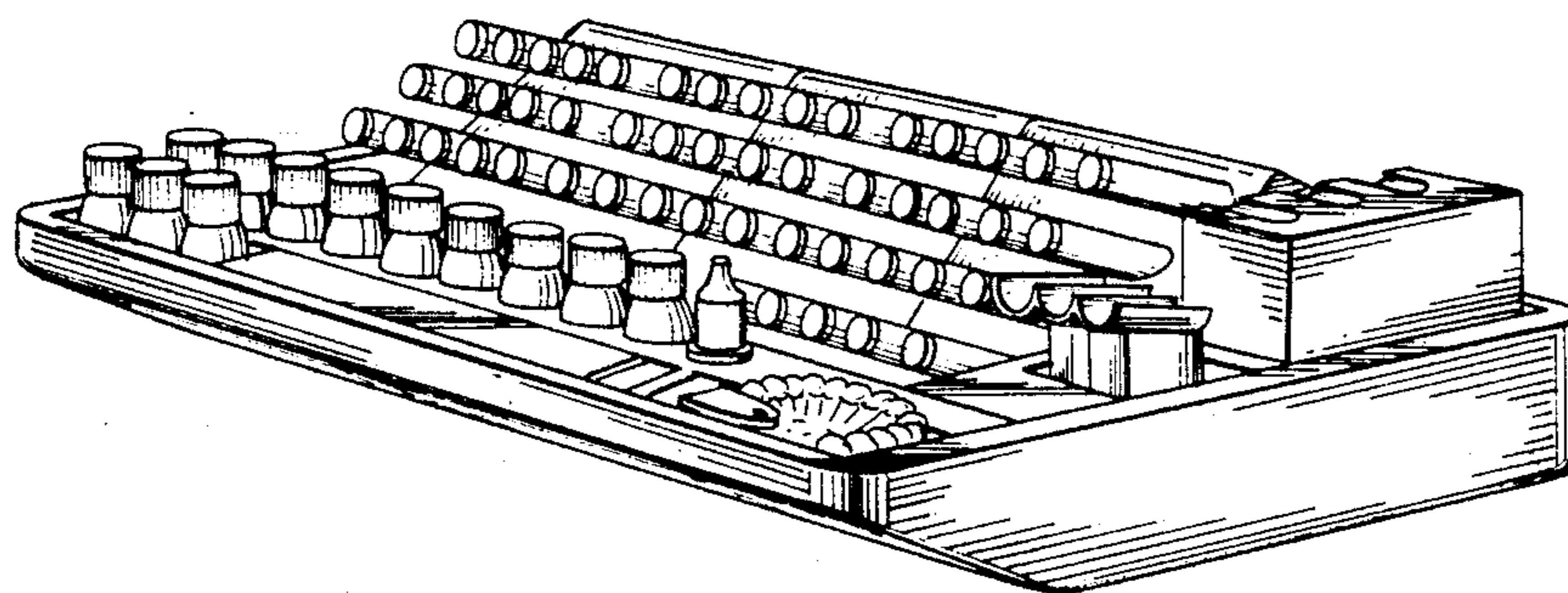

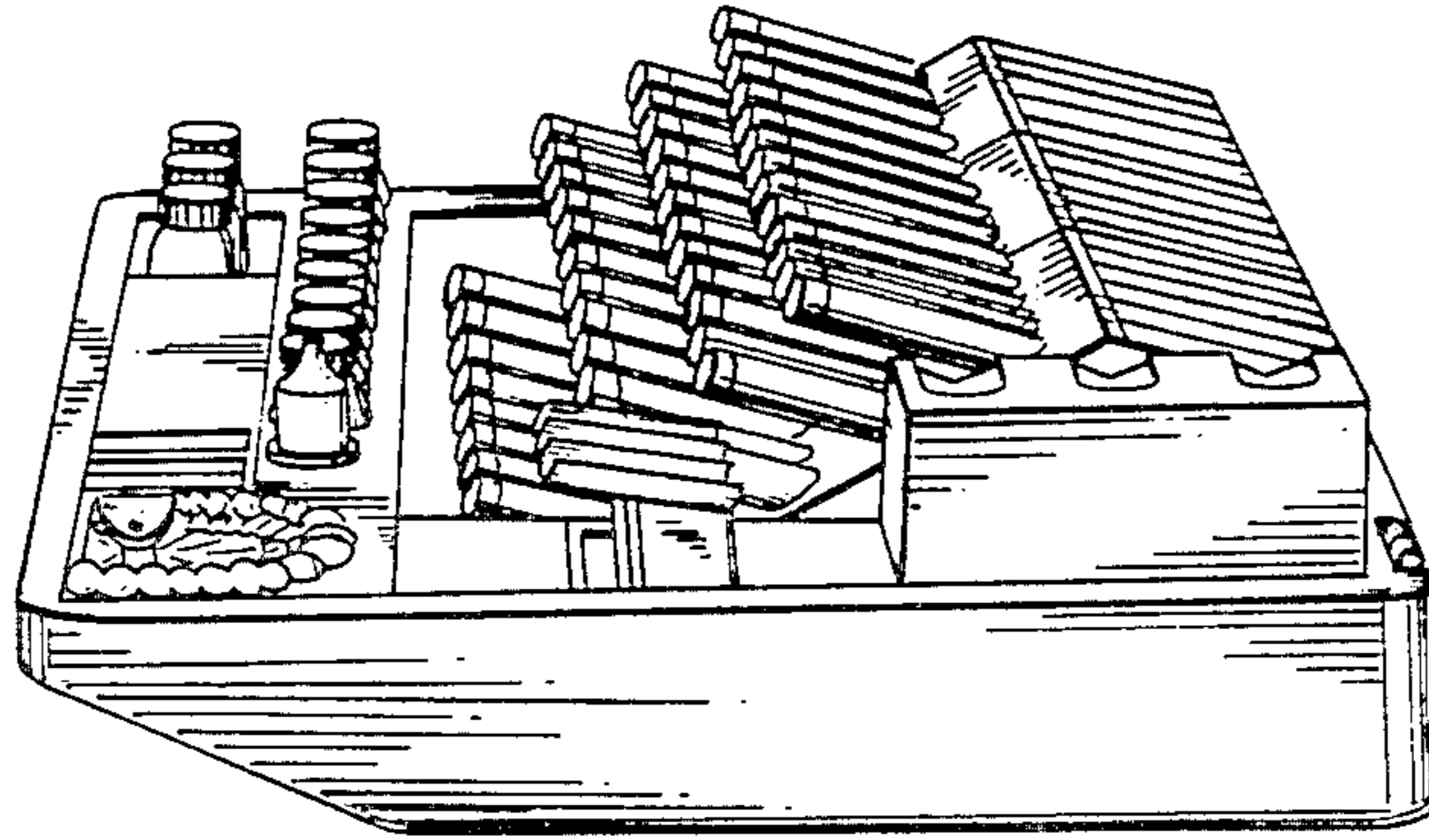

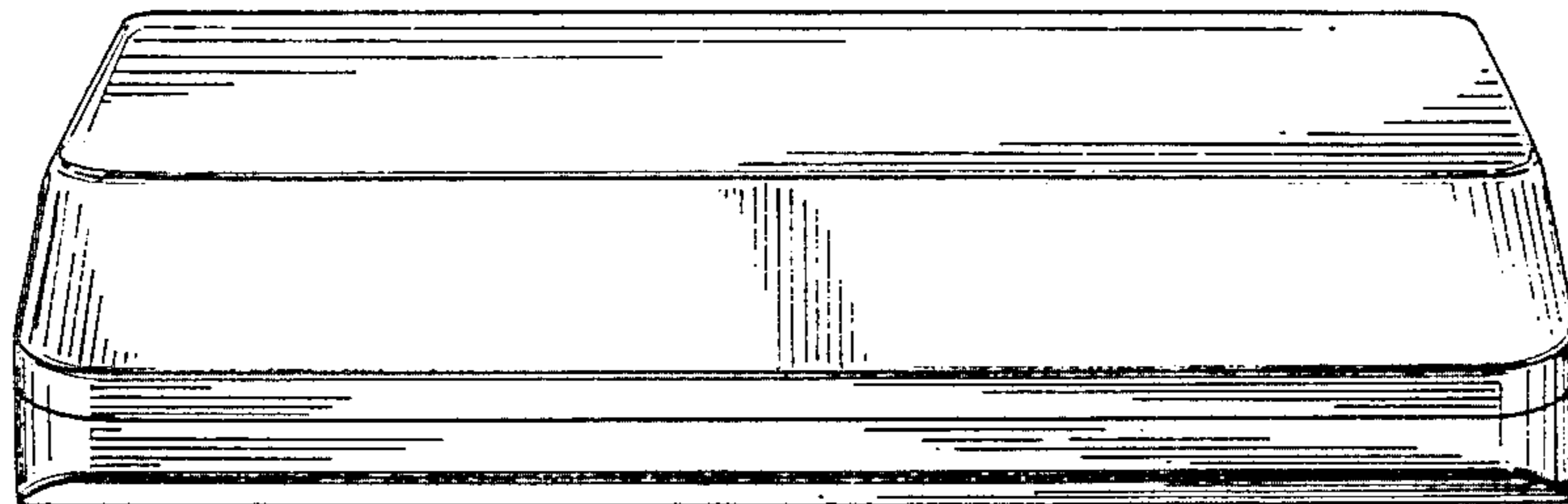
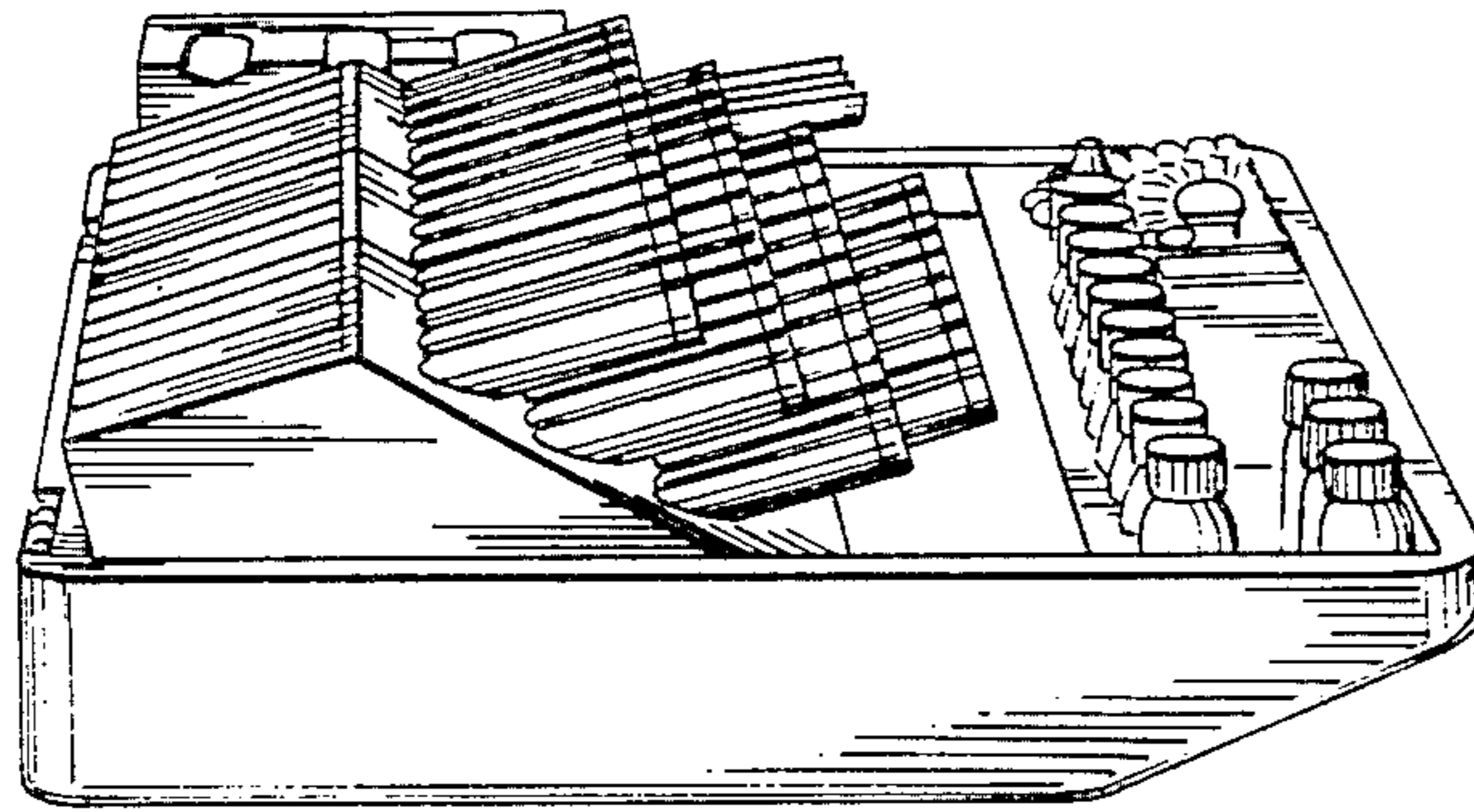

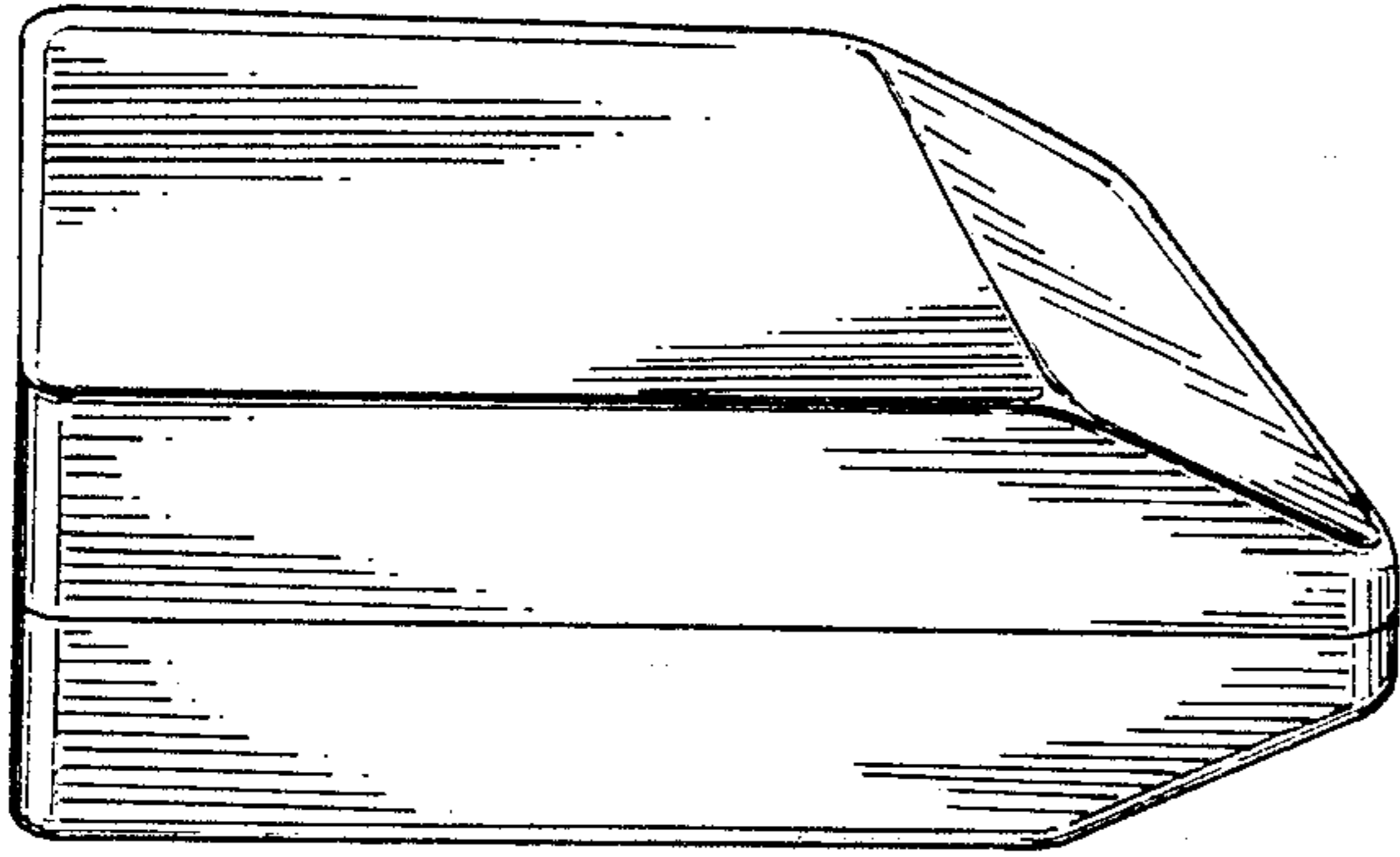

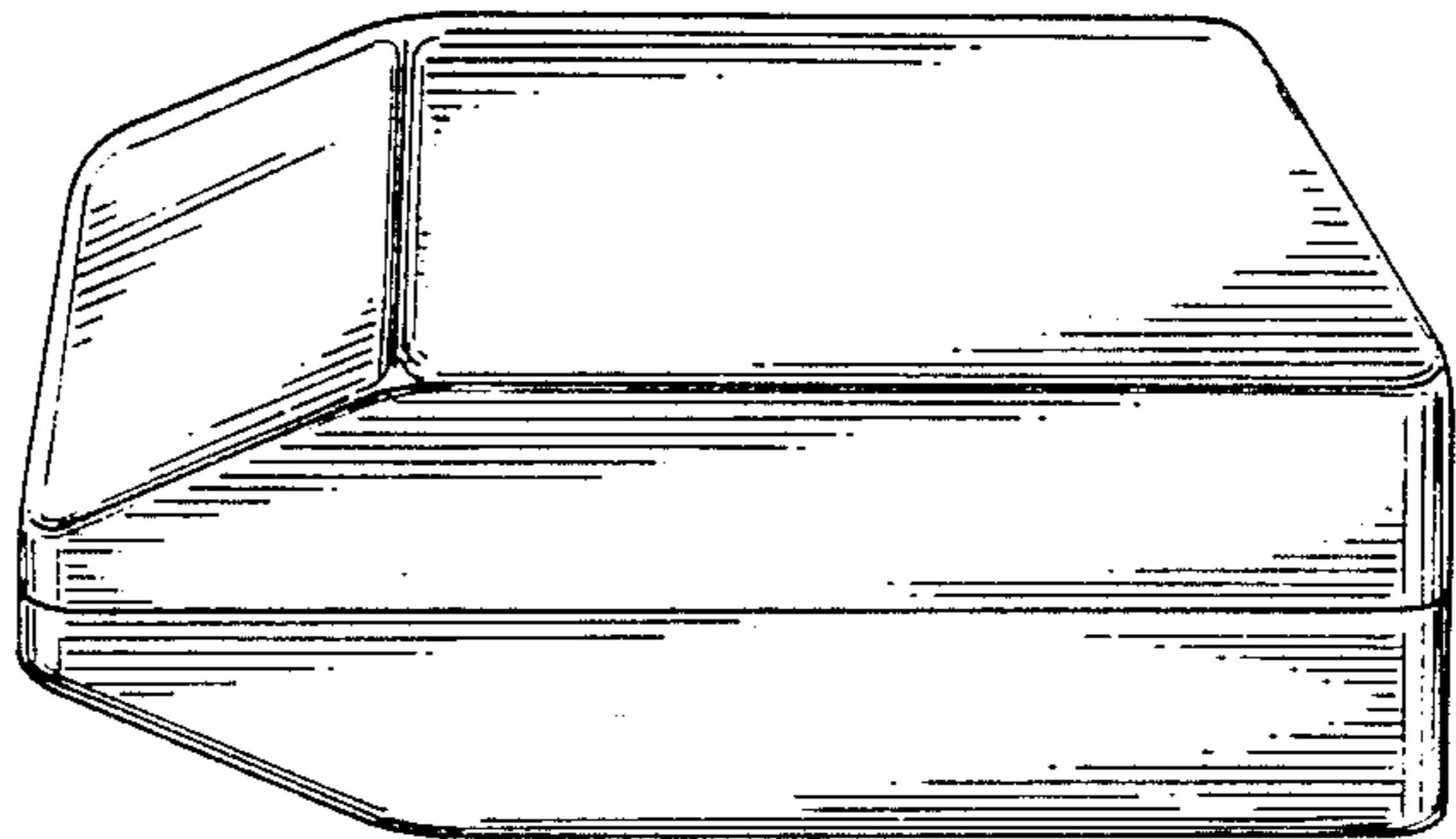

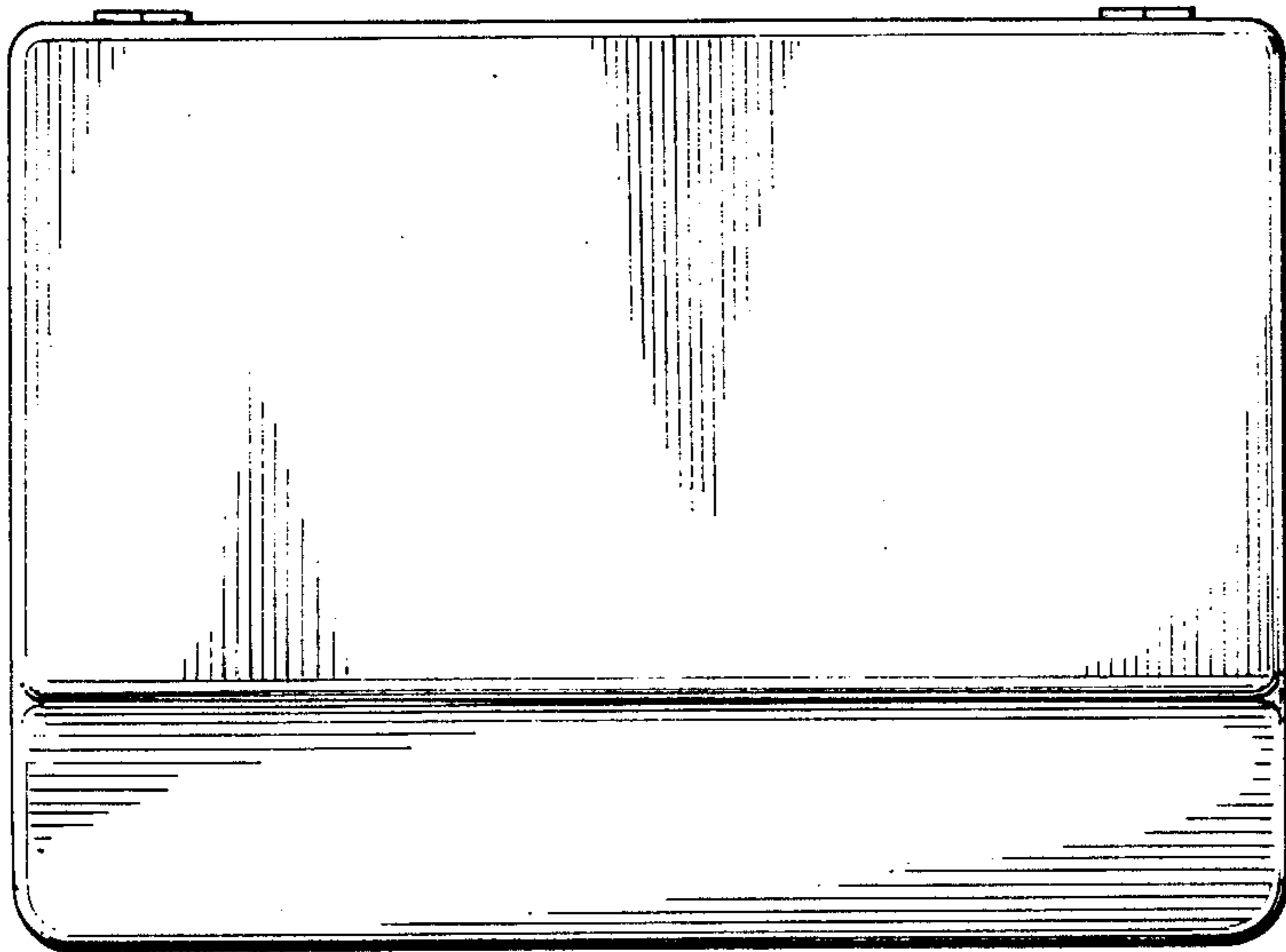

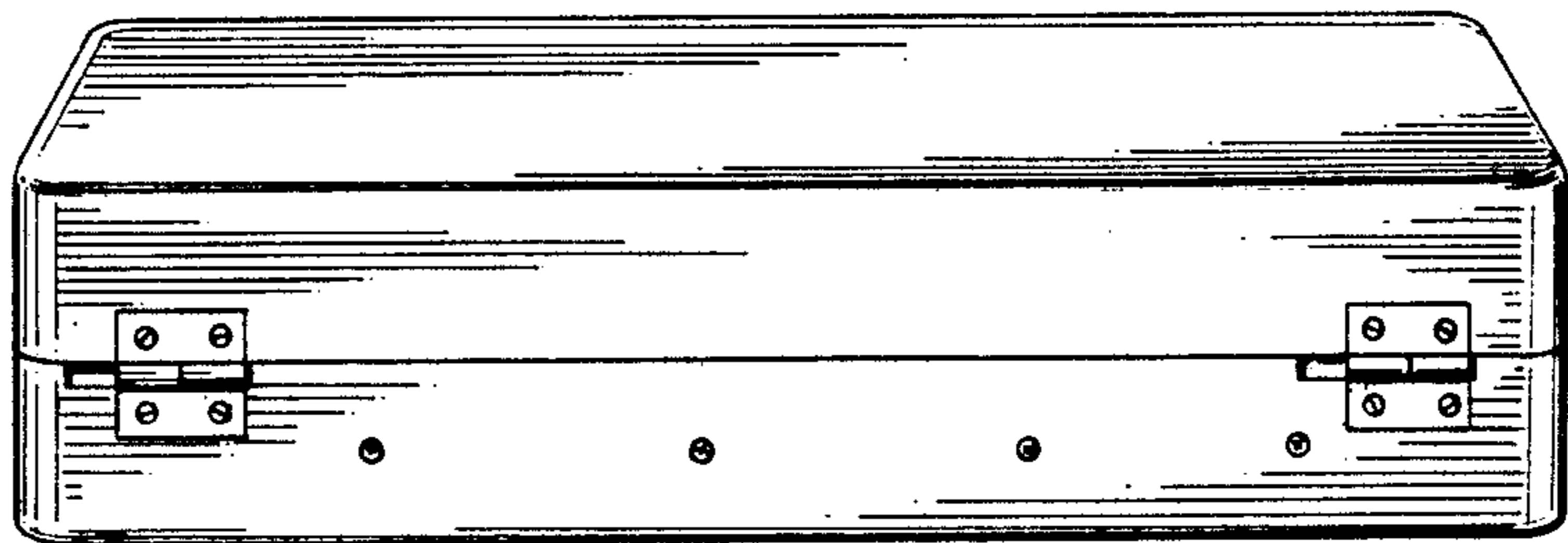

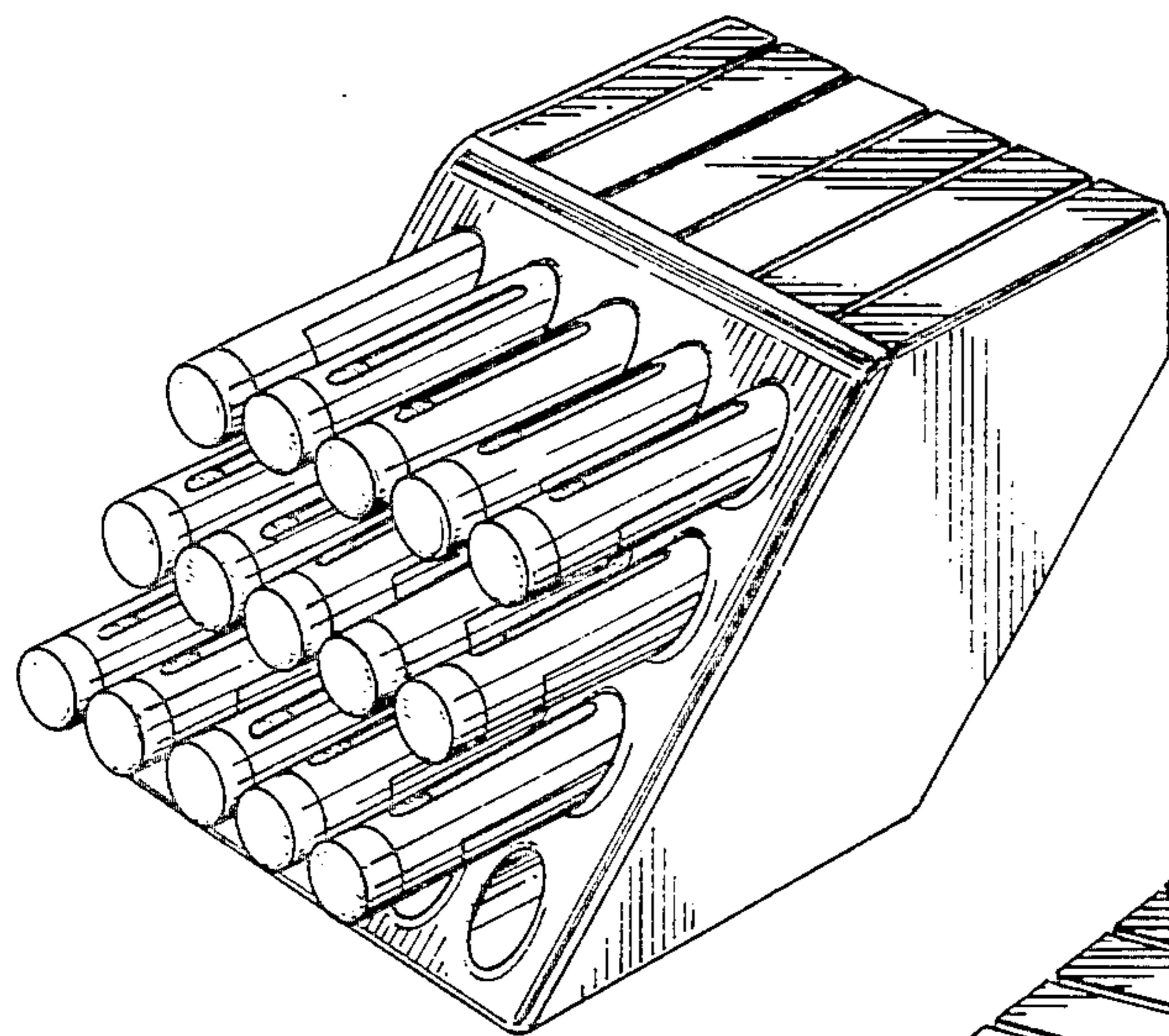

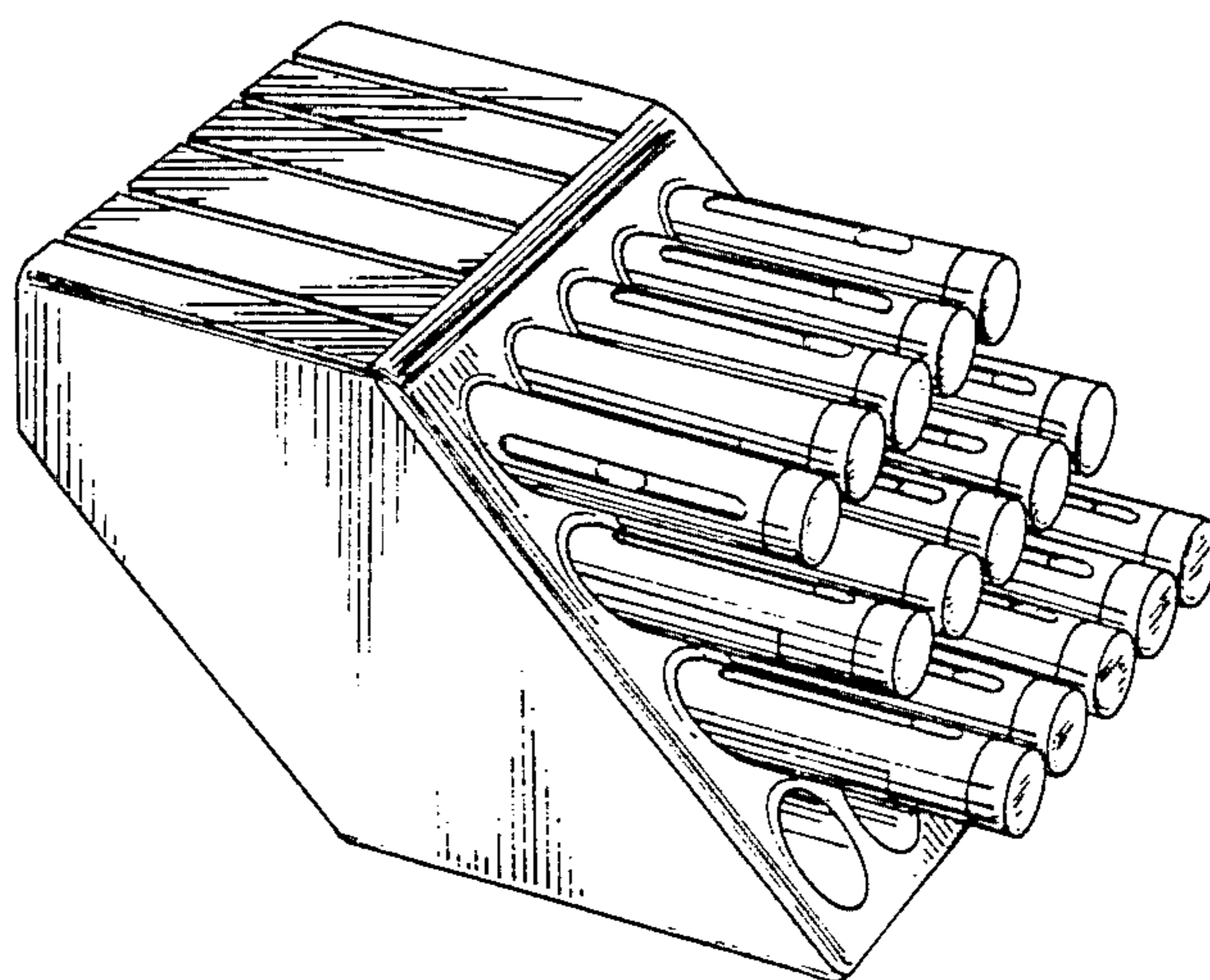

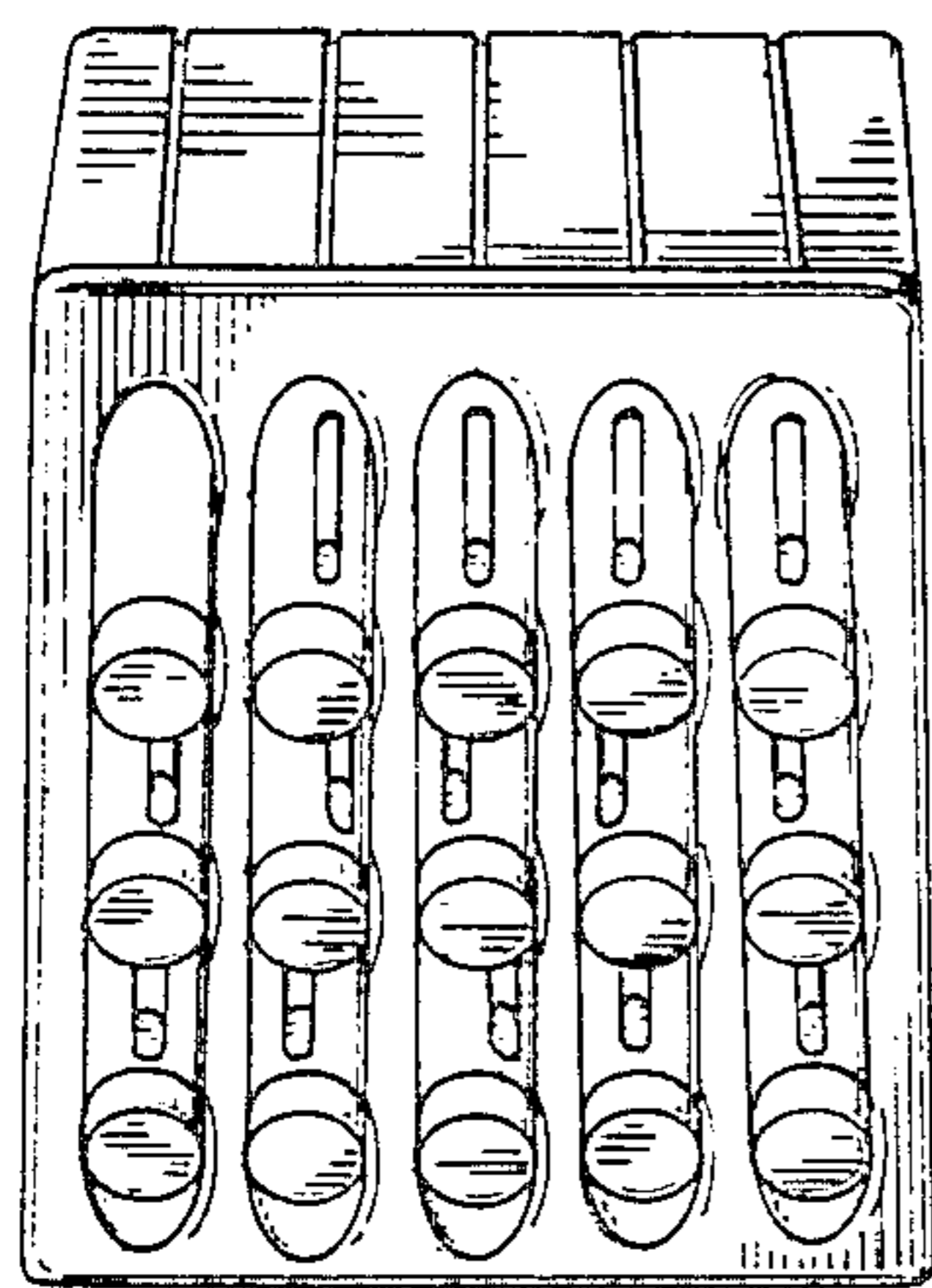
