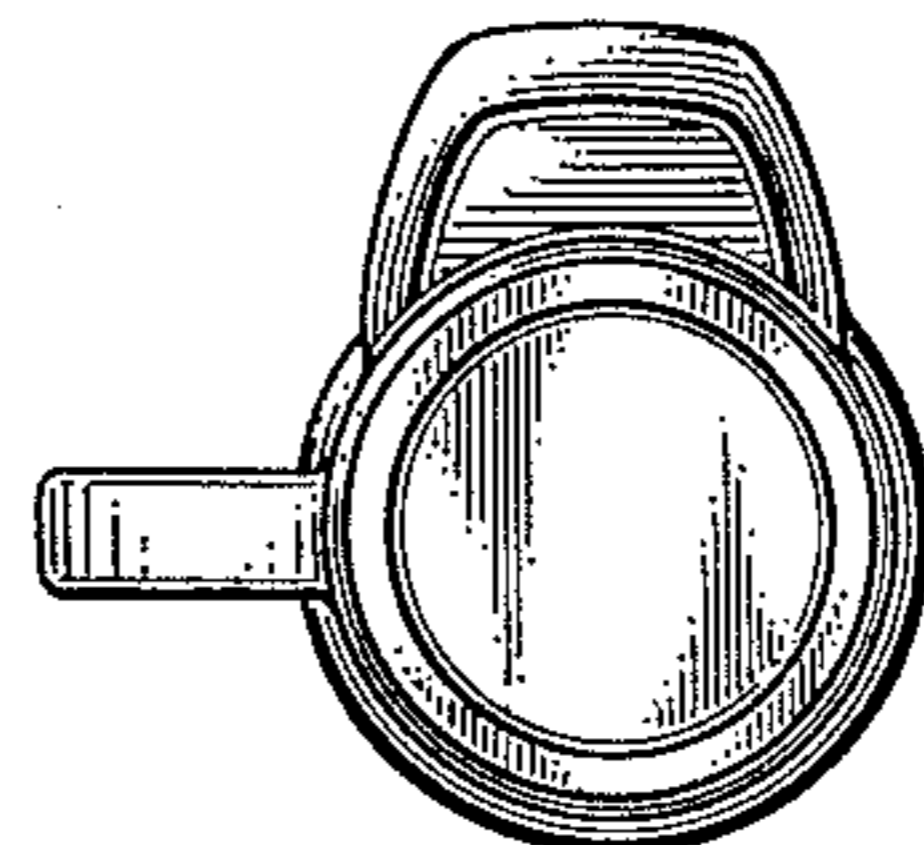
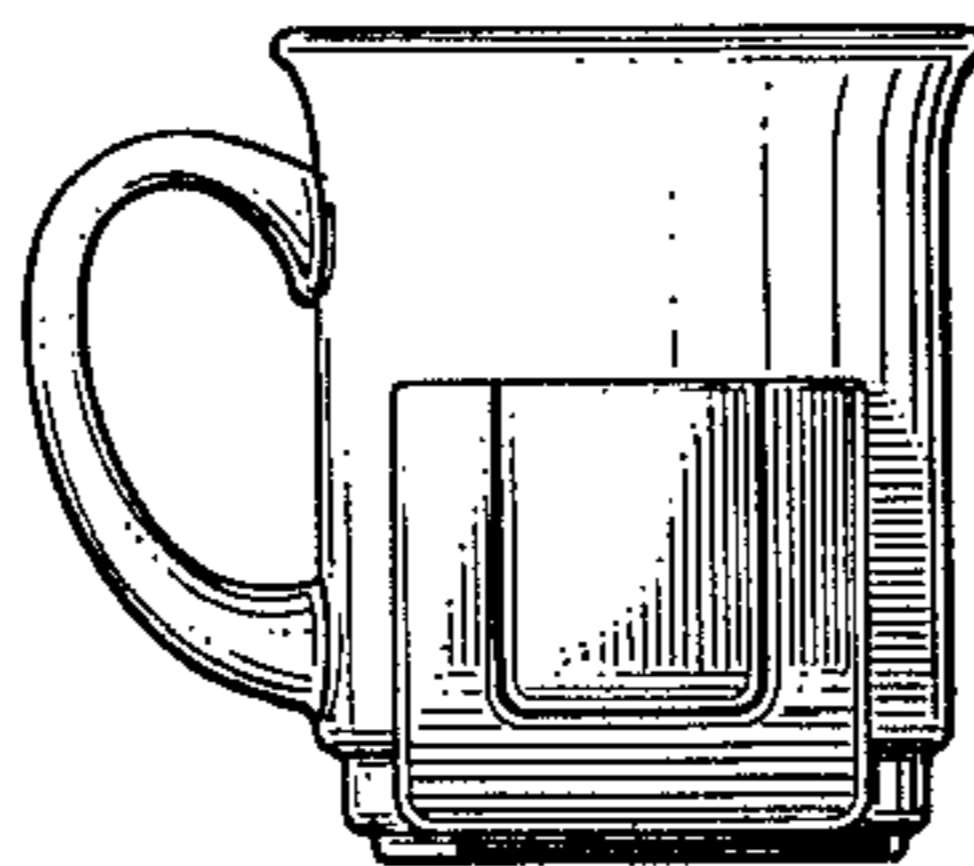
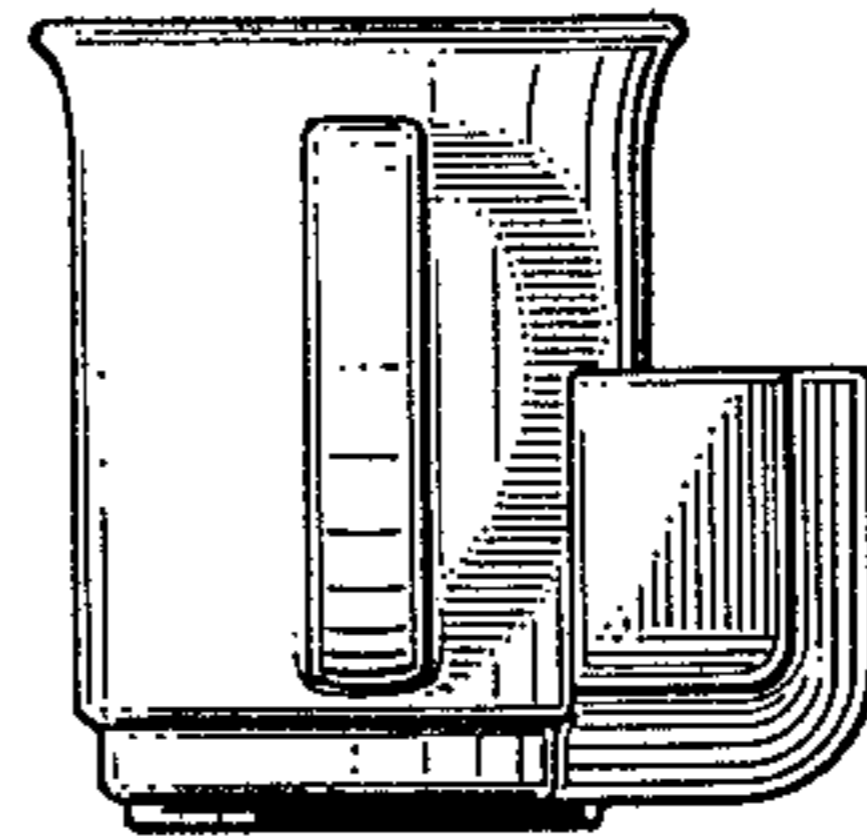

[57] CLAIM

The ornamental design for a cup having tea bag pouch, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cup having a tea bag pouch showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top plan view thereof; and FIG. 6 is a bottom plan view thereof.



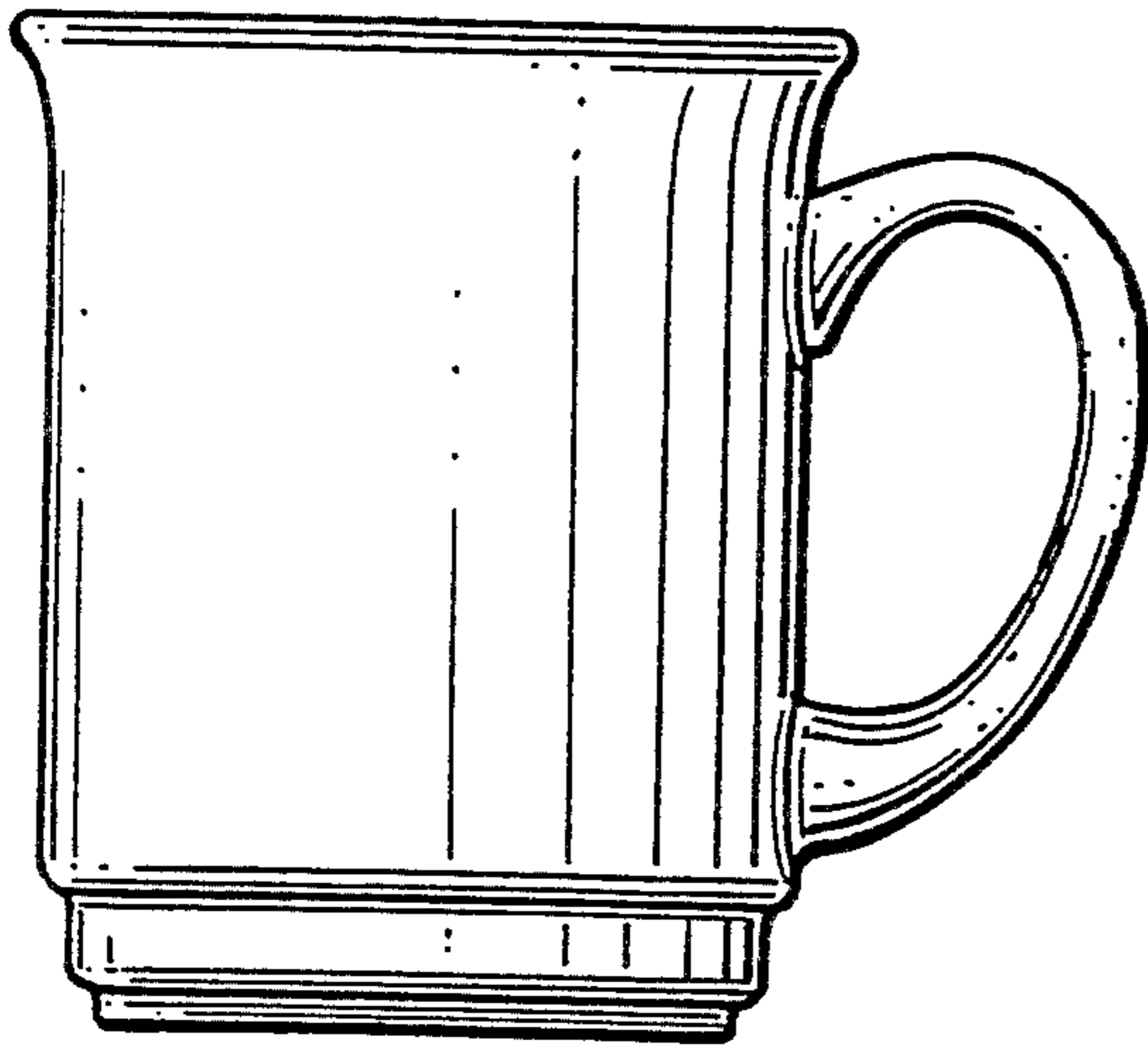

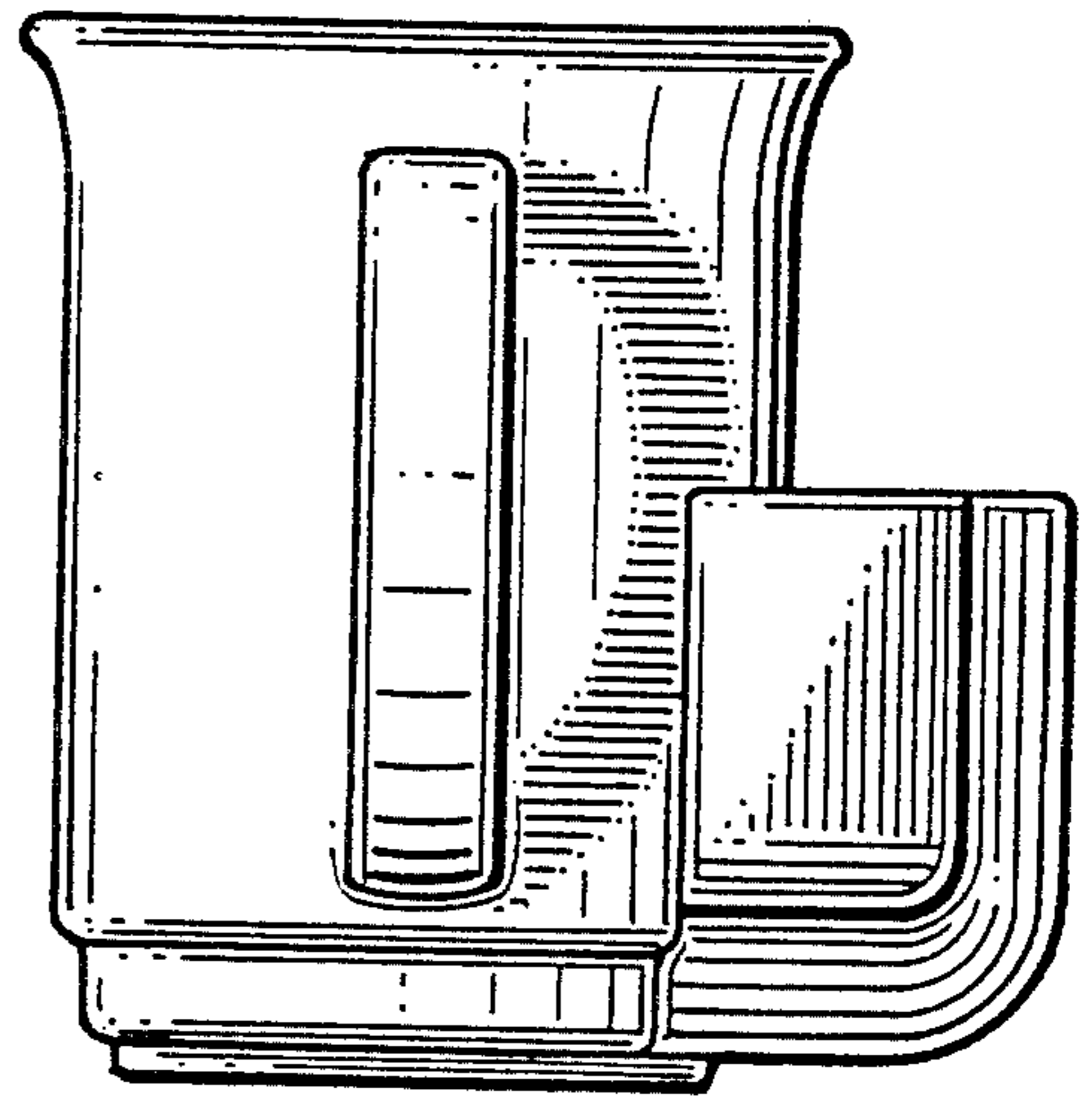

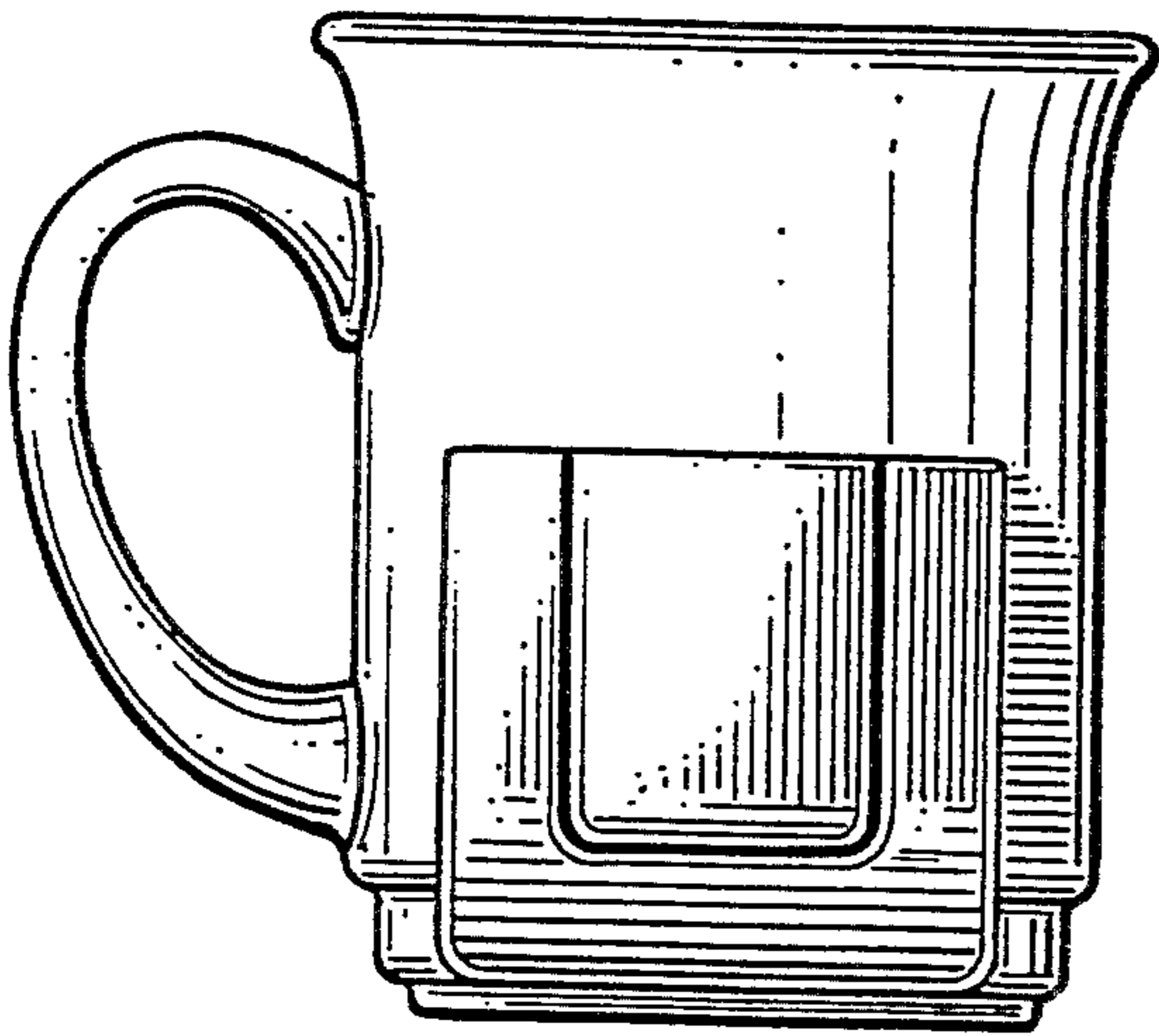

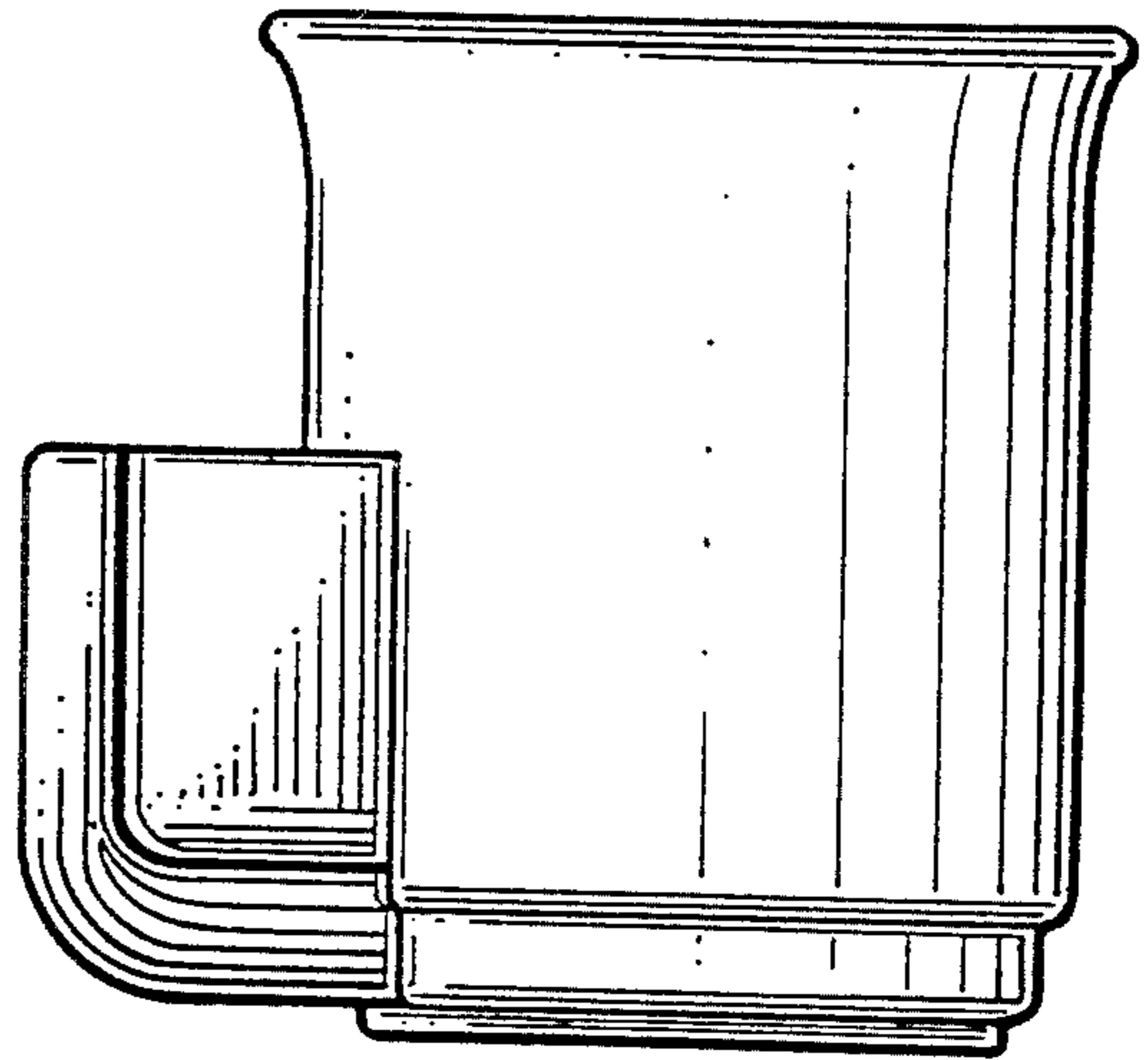

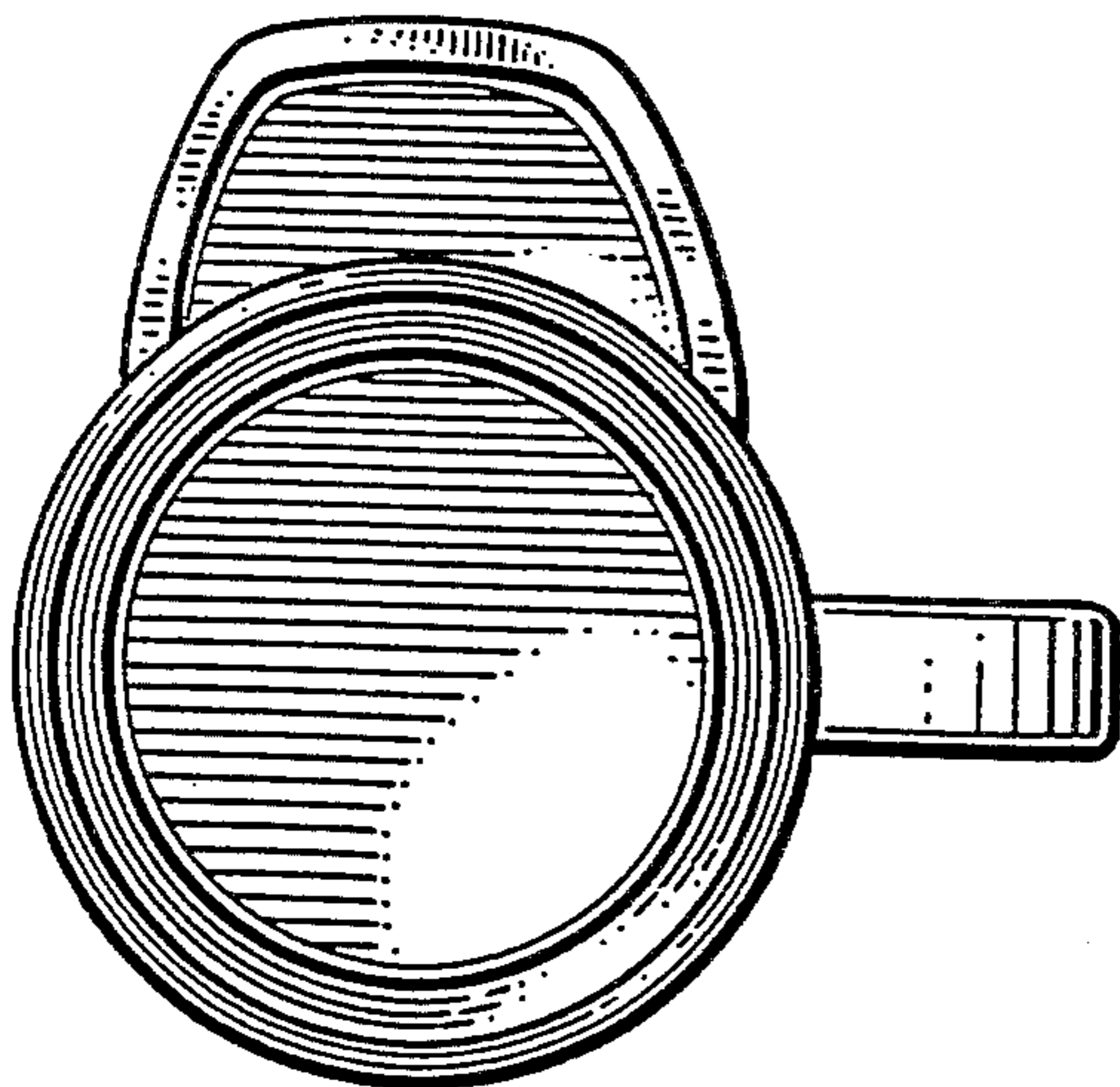

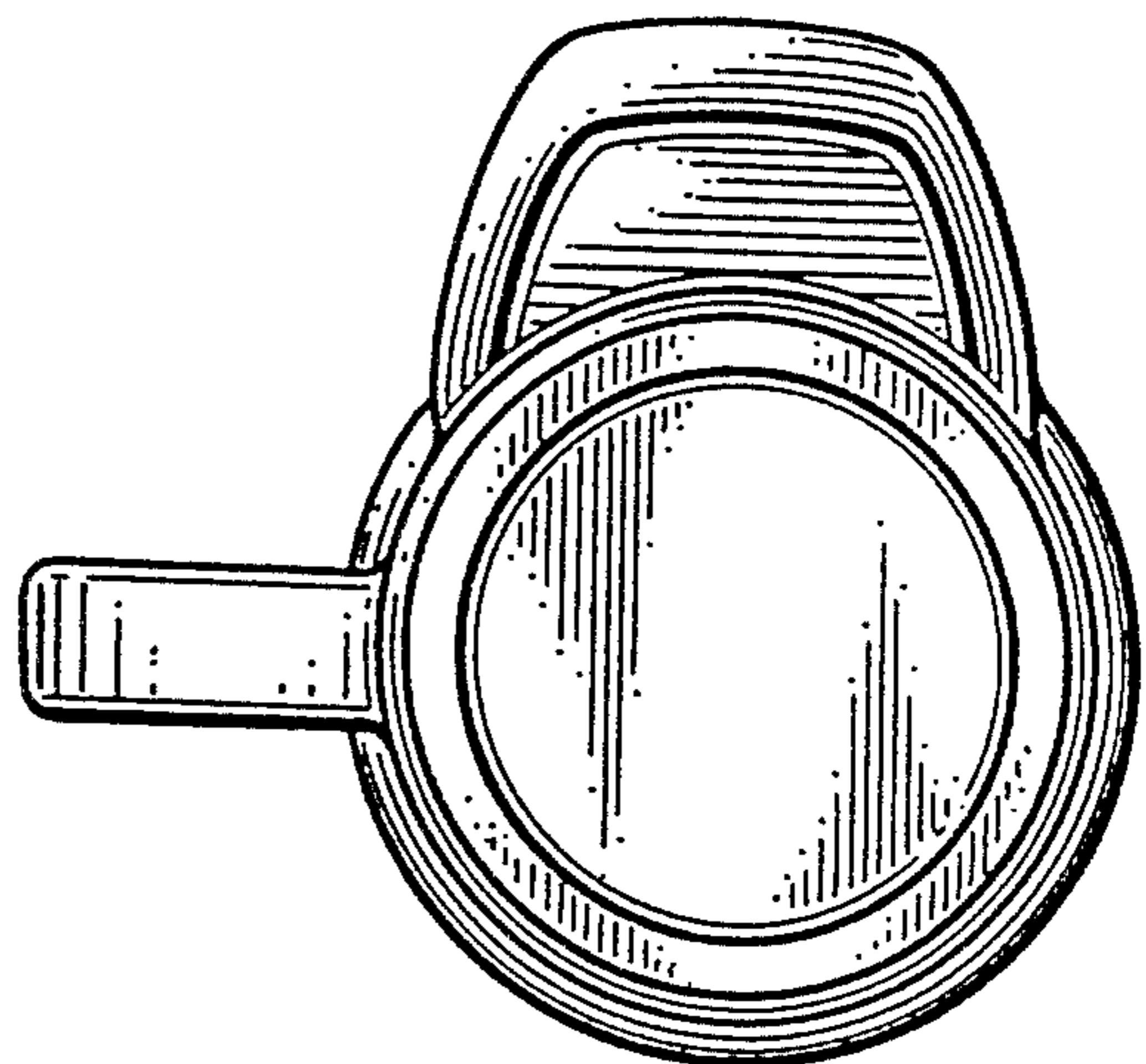
