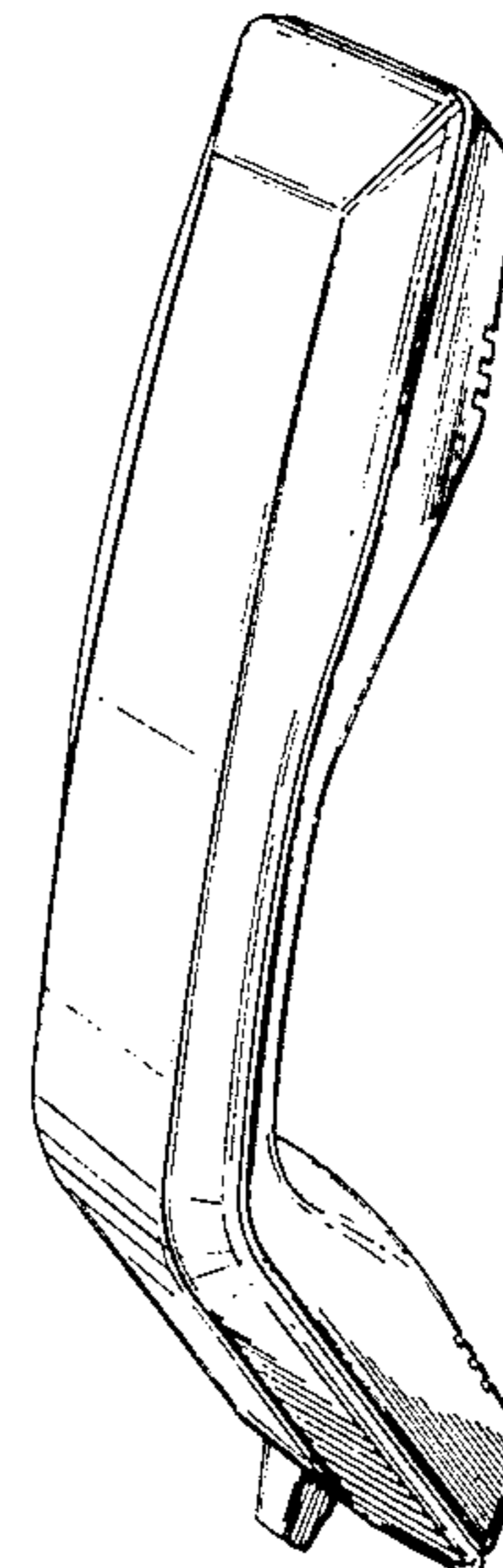
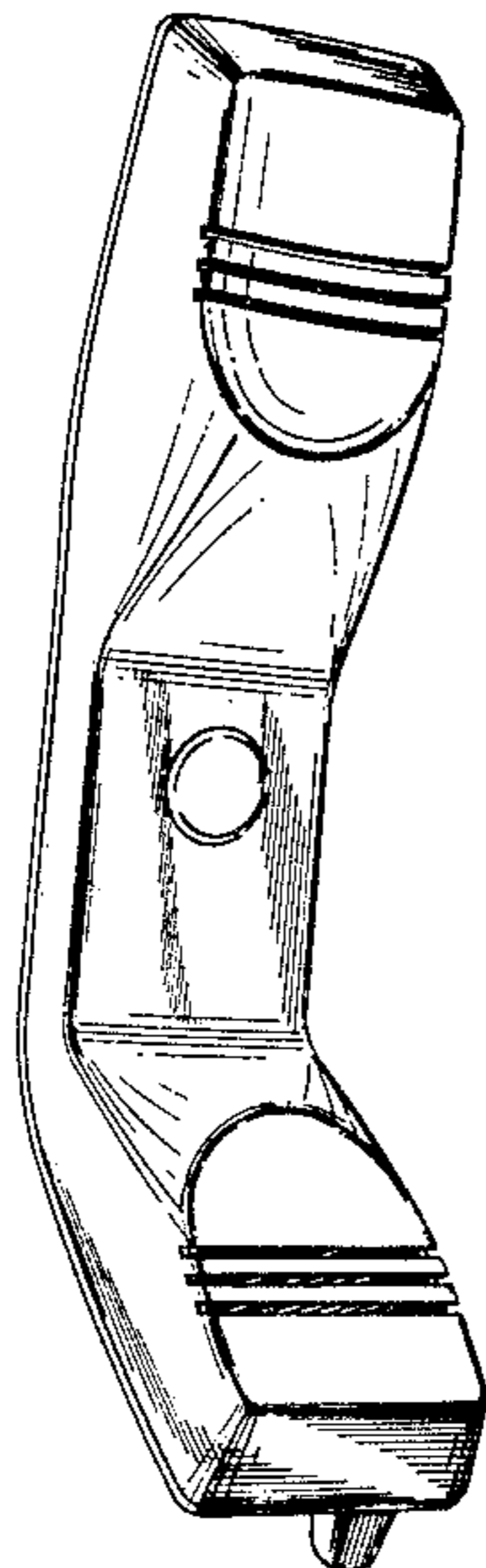

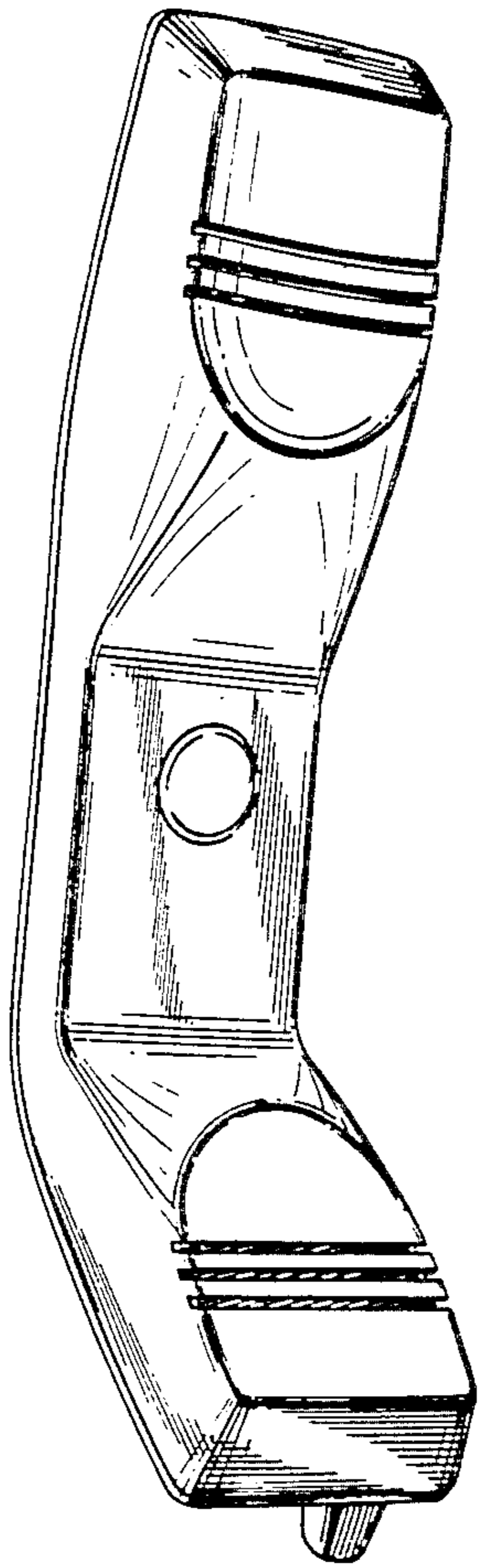
[57] CLAIM

The ornamental design for telephone handset, substantially as shown and described.

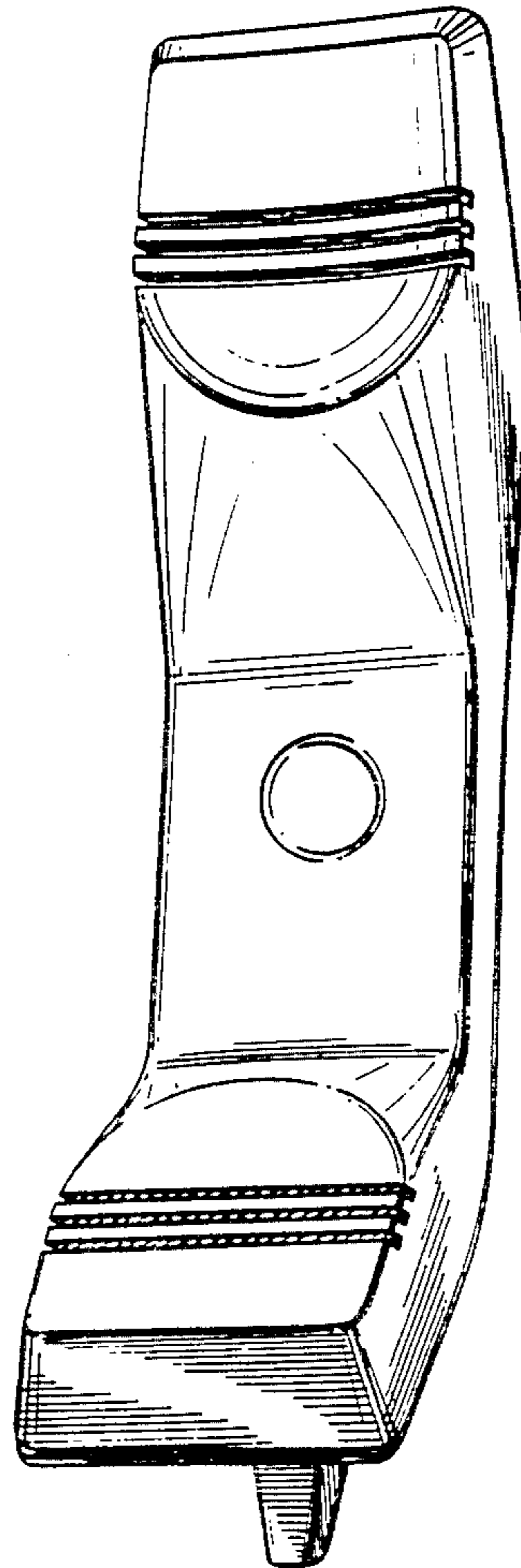
DESCRIPTION

FIG. 4 is a plan view of the bottom end thereof.

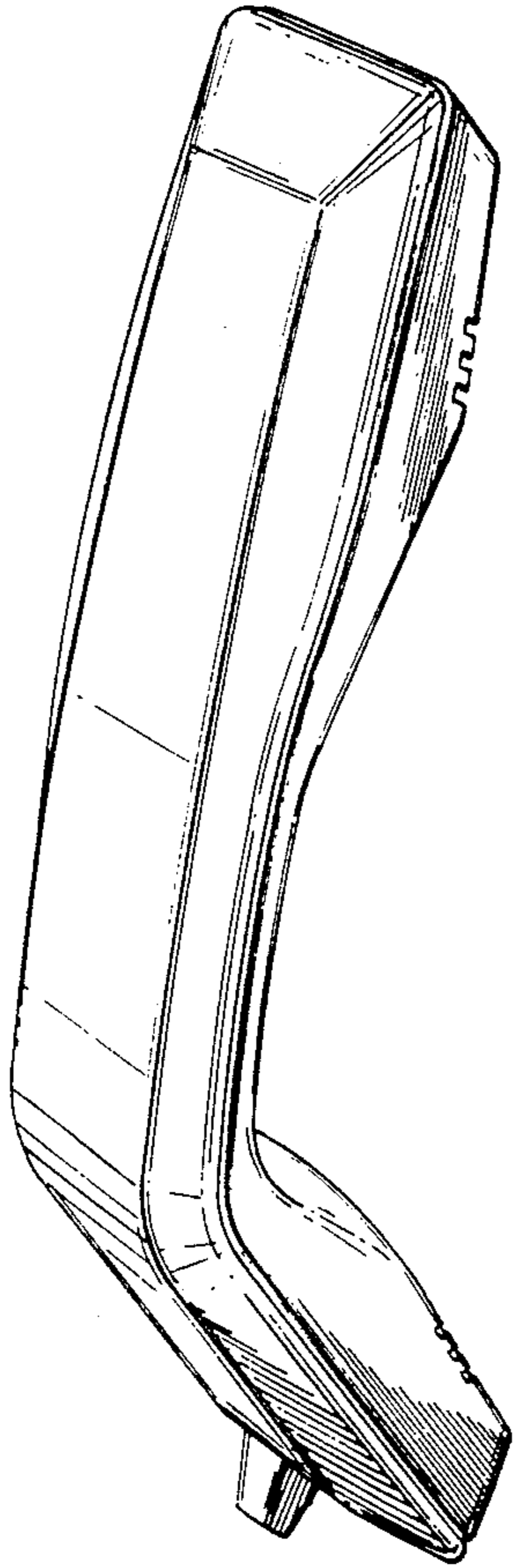




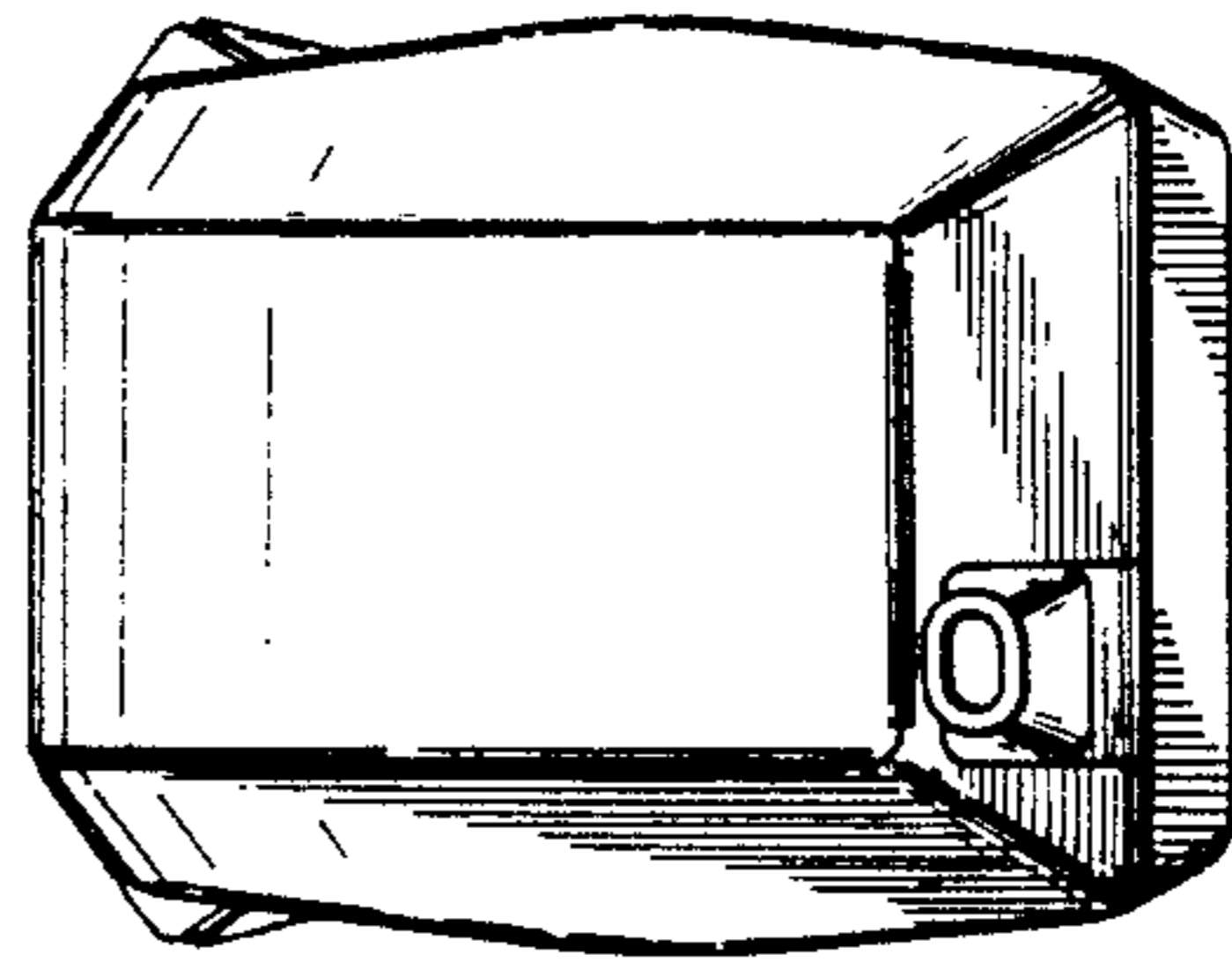
