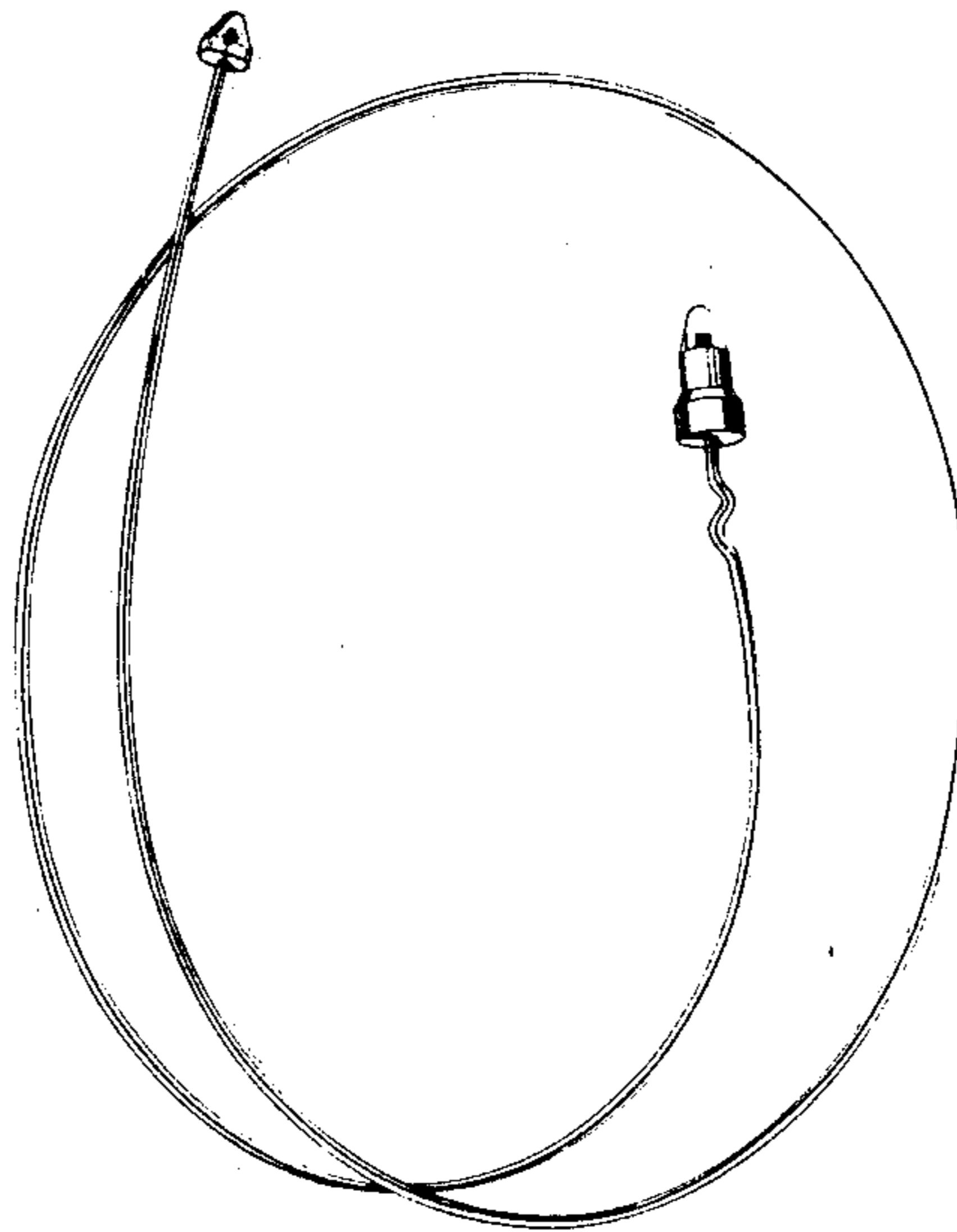

[57] CLAIM

The ornamental design for a vein stripping instrument and heads, cap and cable therefor, as shown and described.

DESCRIPTION

FIG. 1 is an elevational view of the vein stripping instrument and heads, cap and cable therefor;
 FIG. 2 is an enlarged elevational front view of the front end of the vein stripping instrument;
 FIG. 3 is an enlarged elevational rear view of the front end of the vein stripping instrument;
 FIG. 4 is an elevational view of a cable making part of the vein stripping instrument shown in FIG. 1;
 FIG. 5 is a side view of a cap making part of the vein stripping instrument shown in FIG. 1;
 FIG. 6 is a side view of a head making part of the vein stripping instrument shown in FIG. 1;
 FIG. 7 is a side view of a small diameter head which can replace the head shown in FIG. 6;
 FIG. 8 is a side view of a diameter head which can replace the head shown in FIG. 6;
 FIGS. 2, 3 and 5-8 are shown on an enlarged scale.



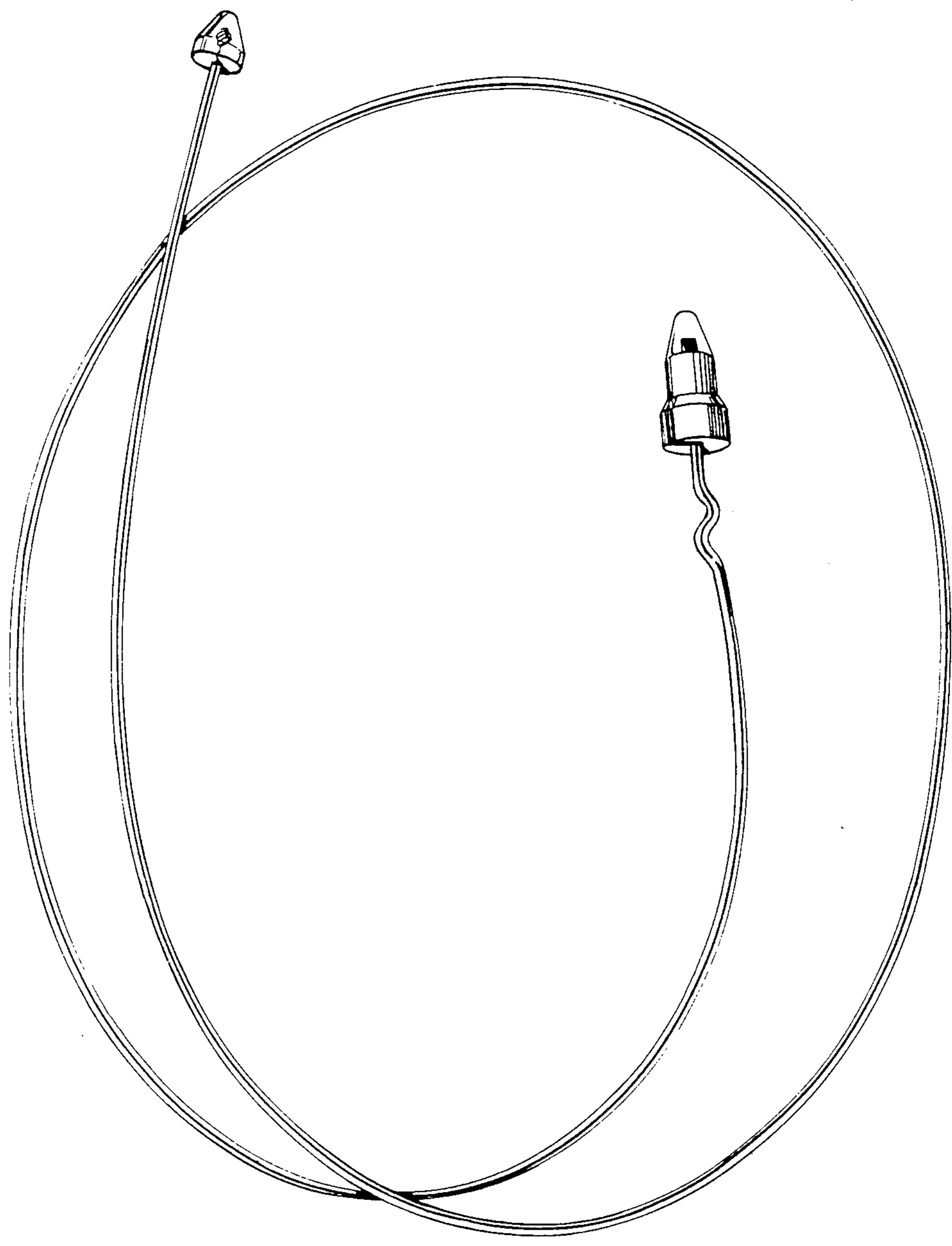

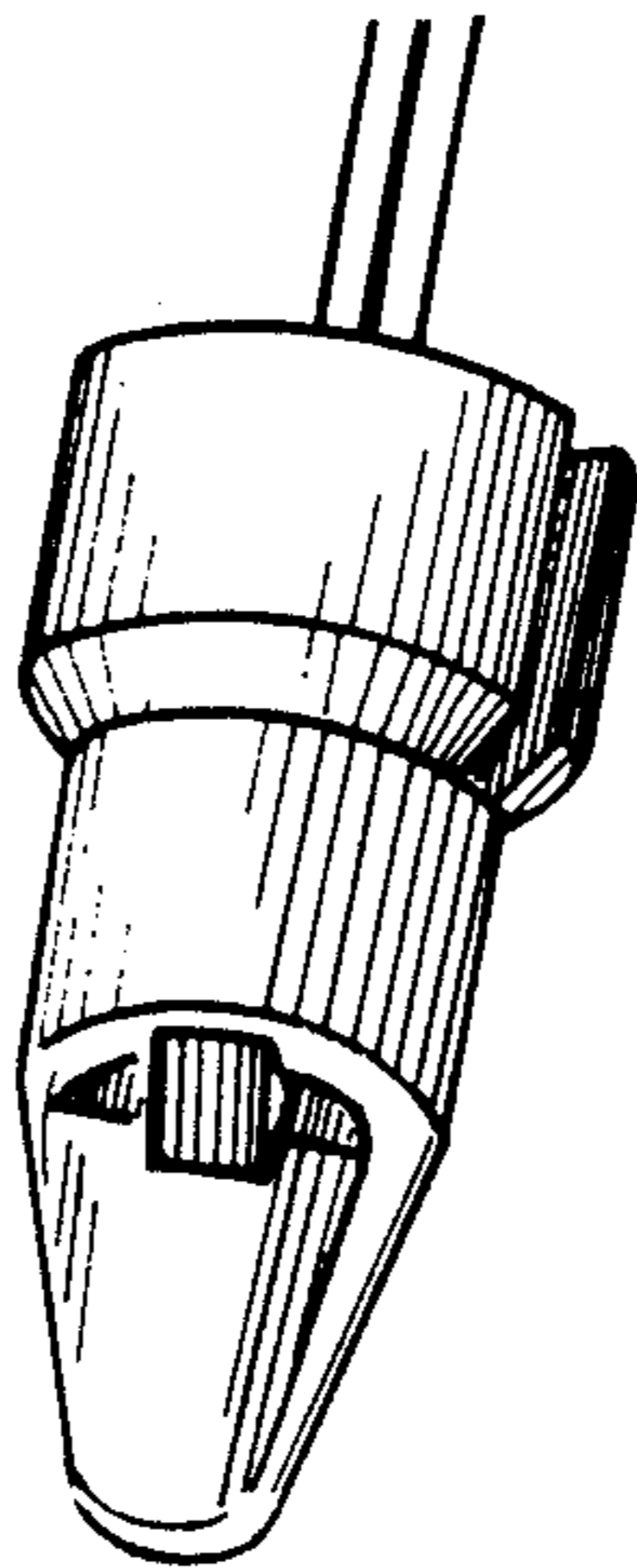

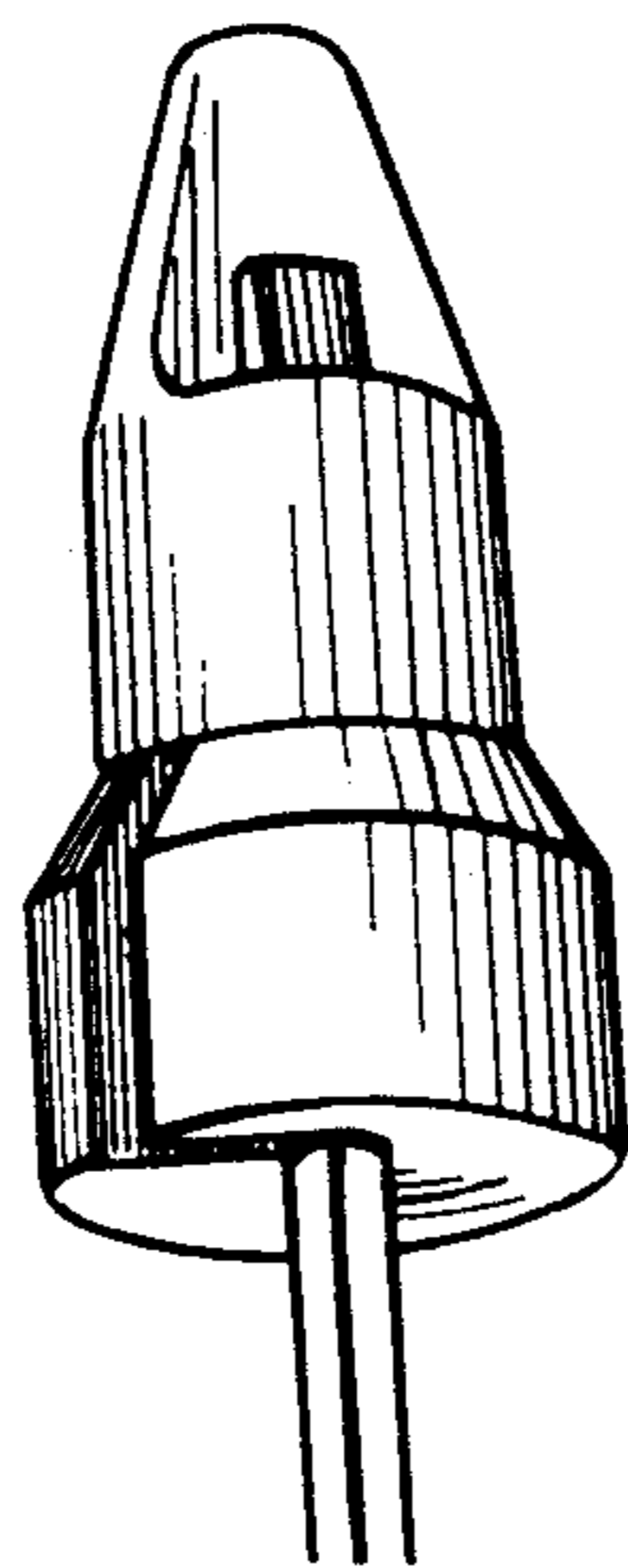

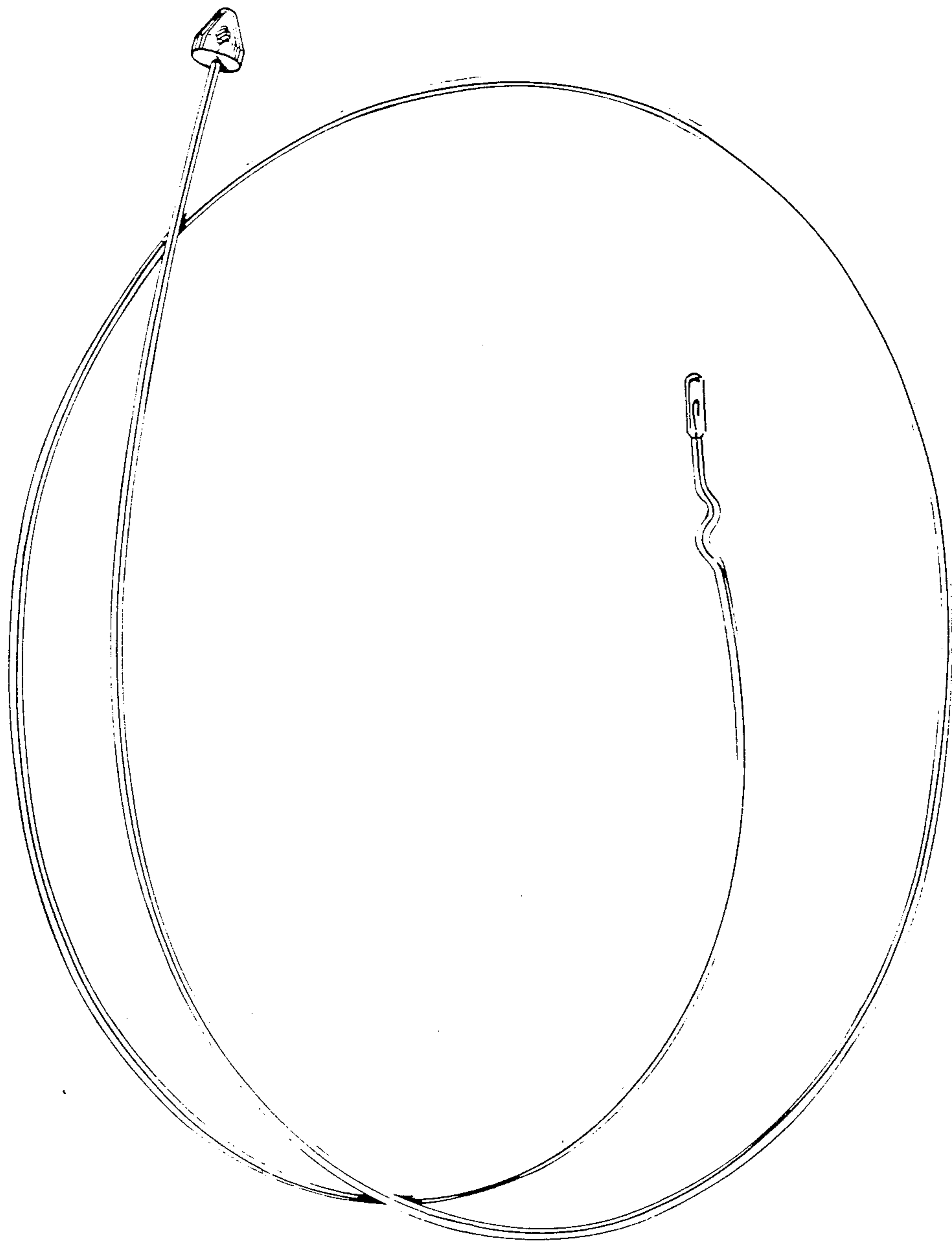

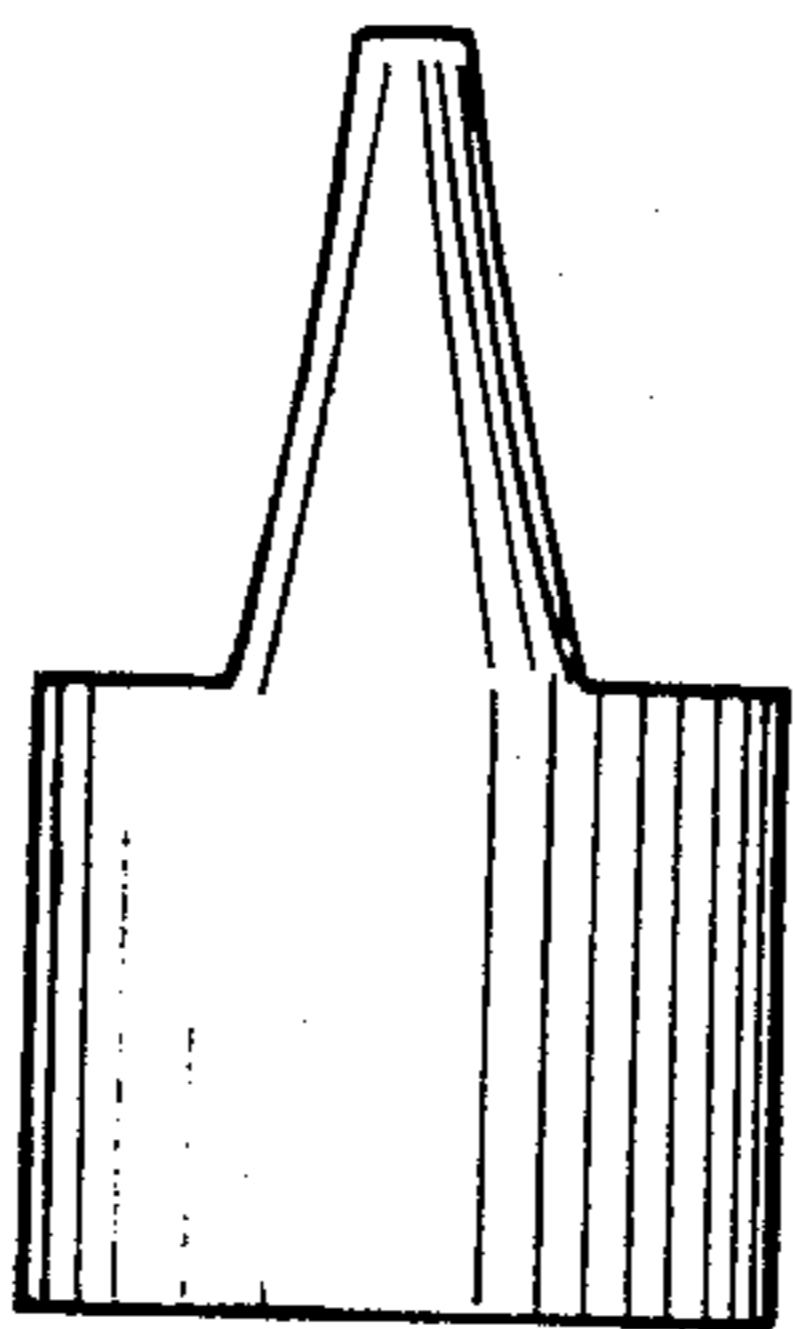

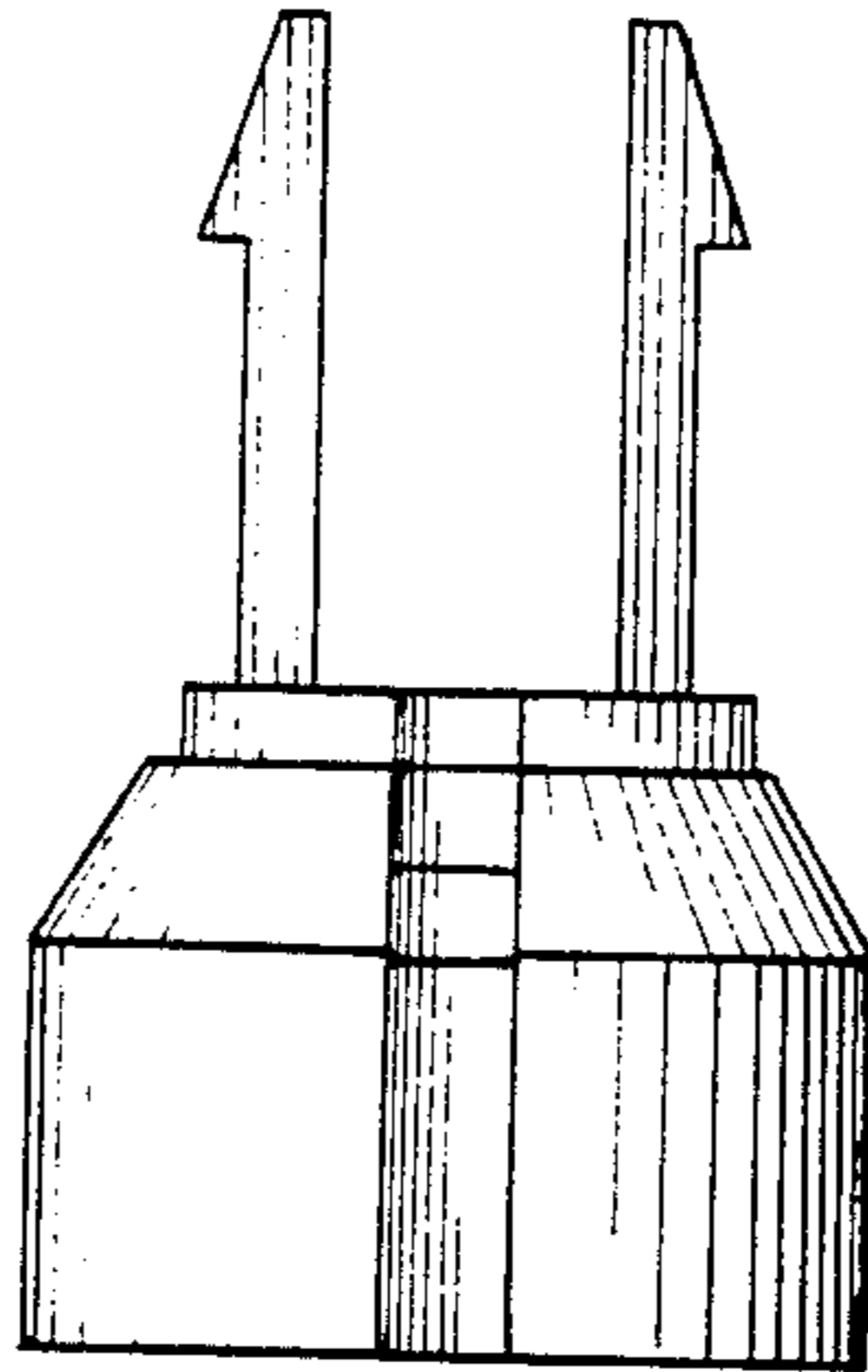

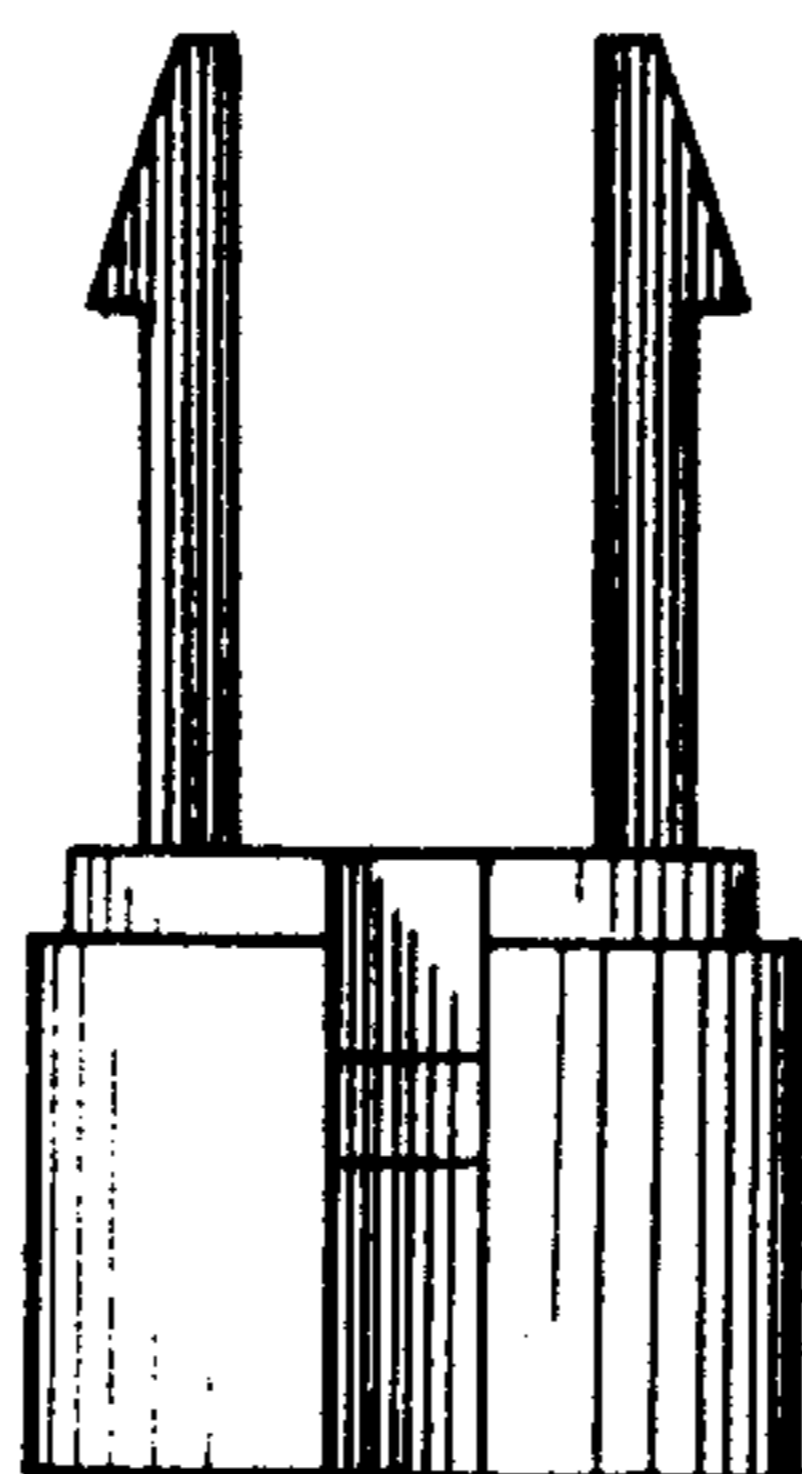

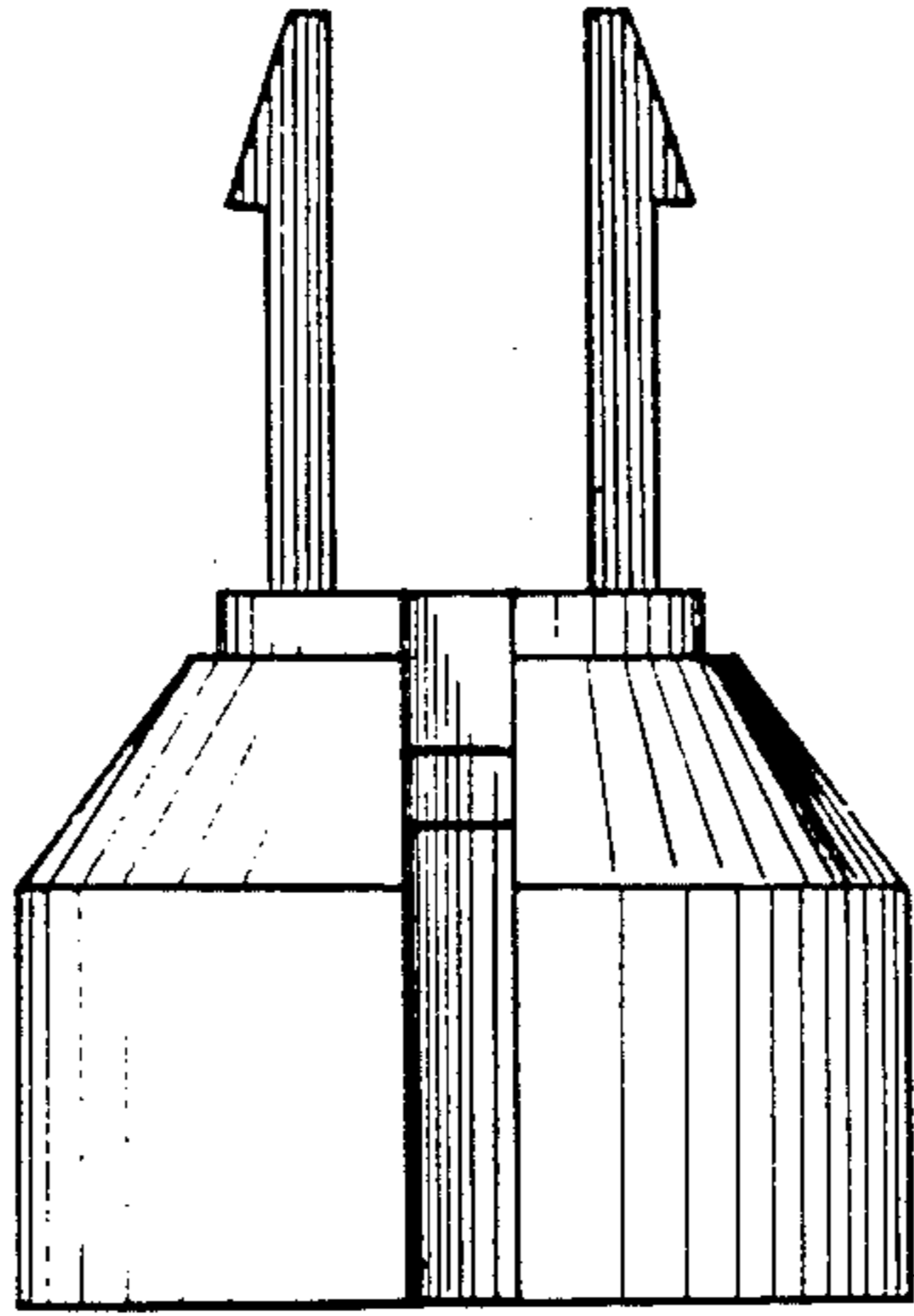
