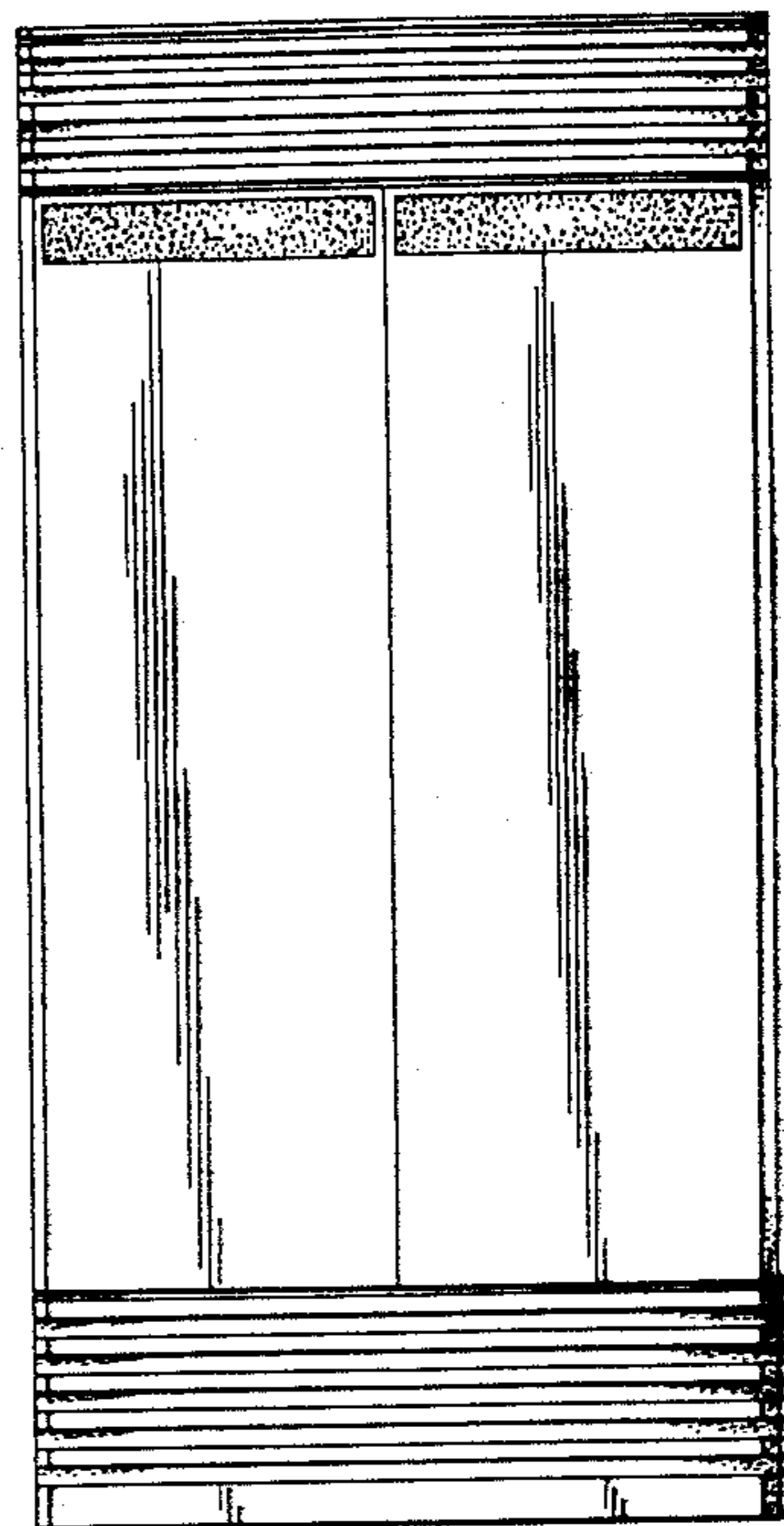
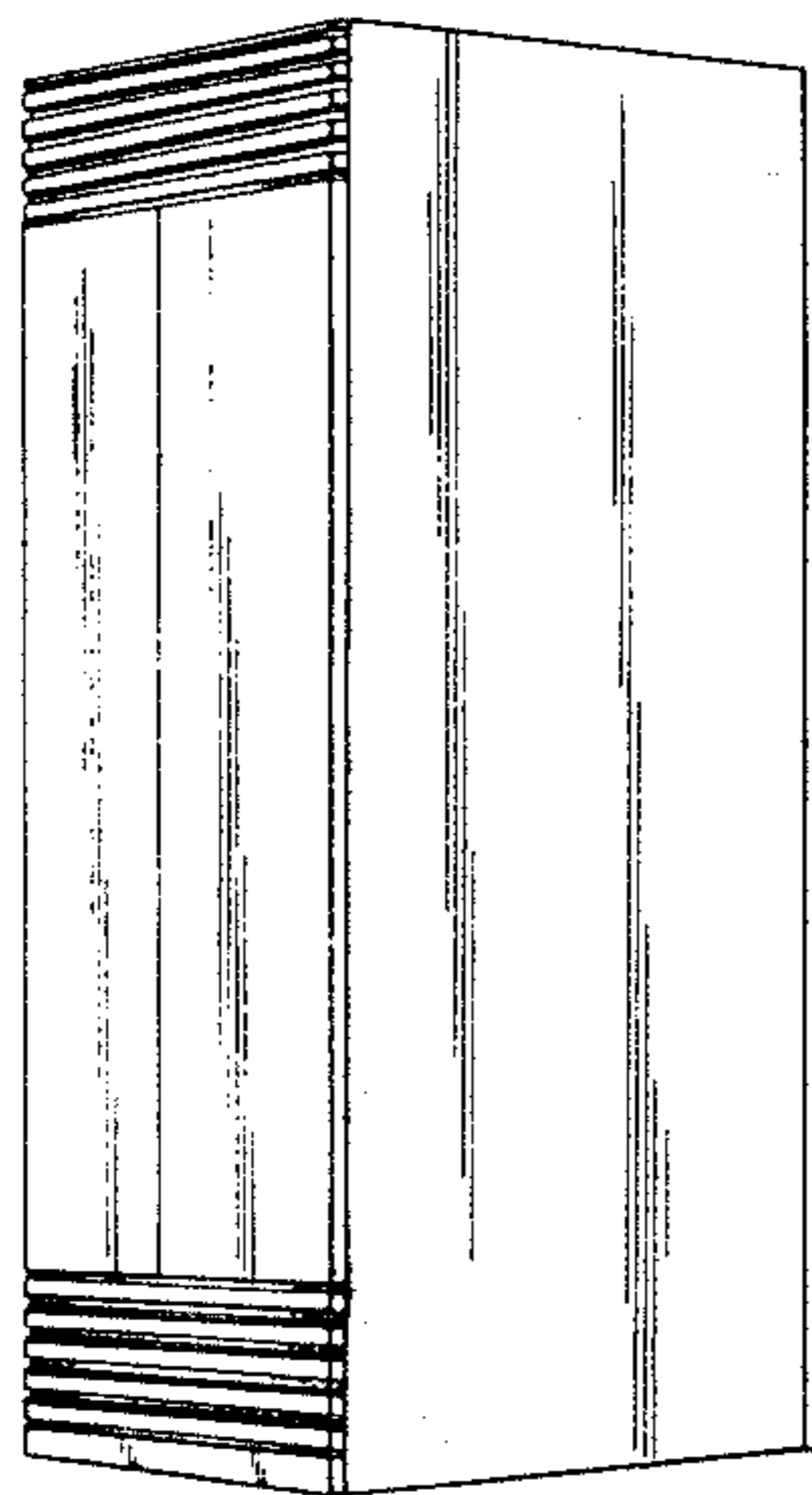

[57] CLAIM

The ornamental design for a telephone branch exchange cabinet, substantially as shown.

DESCRIPTION

FIG. 1 is a front elevational view of a cabinet showing my new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a fragmentary front elevational view thereof;  
FIG. 5 is a front and right side perspective view thereof showing an alternate embodiment of my new design; and  
FIG. 6 is a front elevational view of a cabinet showing another alternative embodiment of my new design.  
The rear view in all embodiments is identical to FIG. 1.  
The bottom is plain.



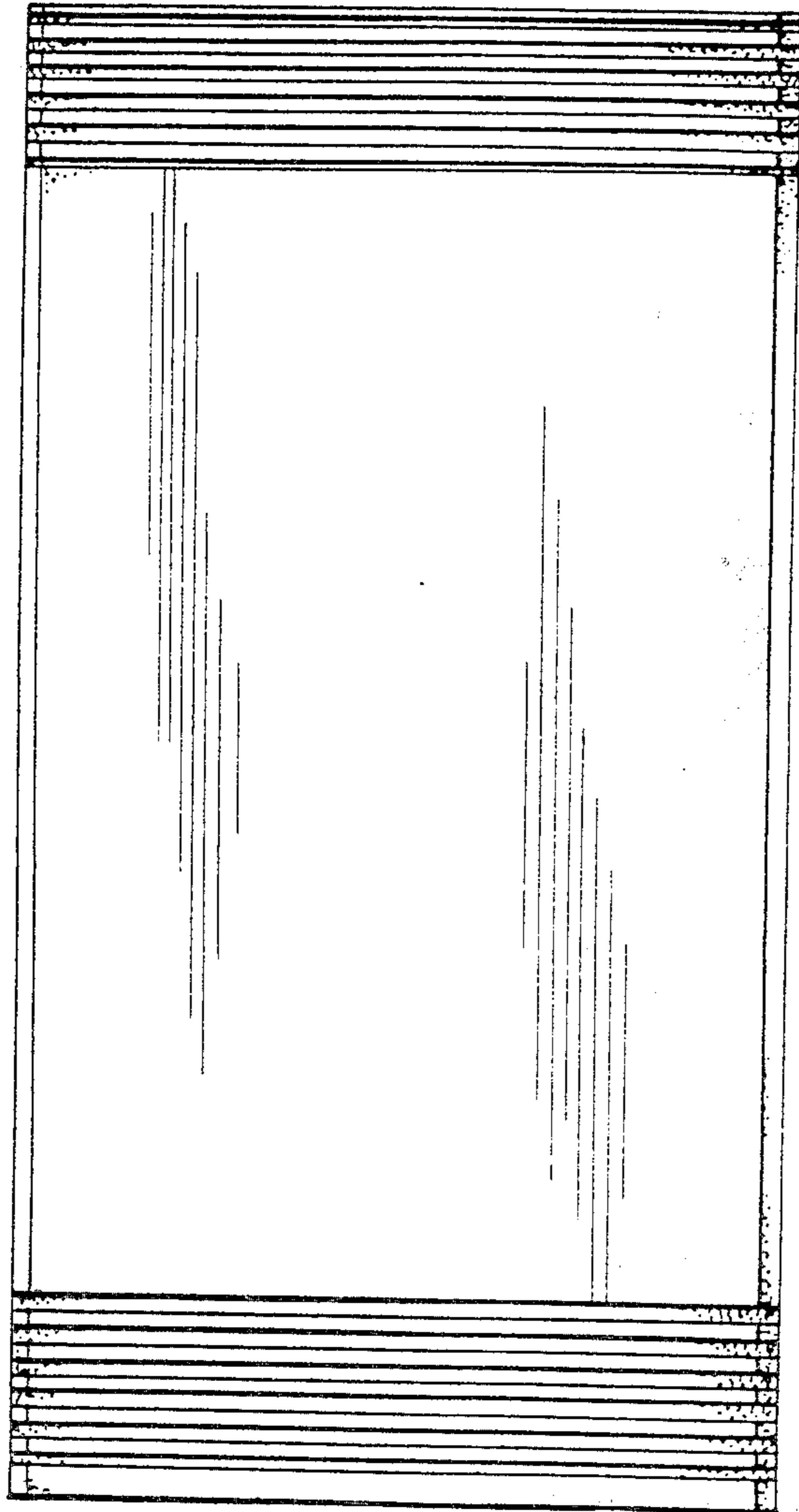

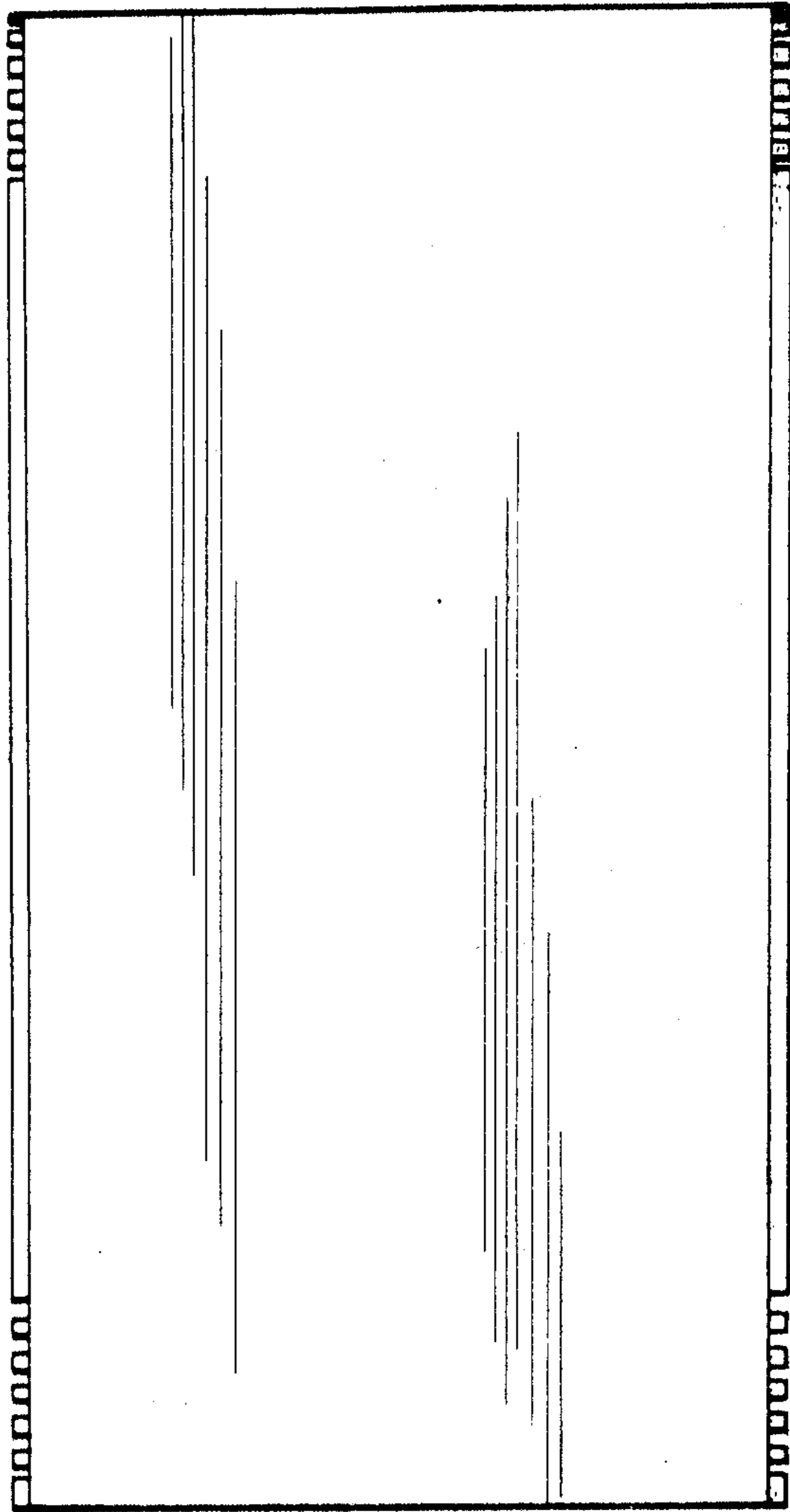

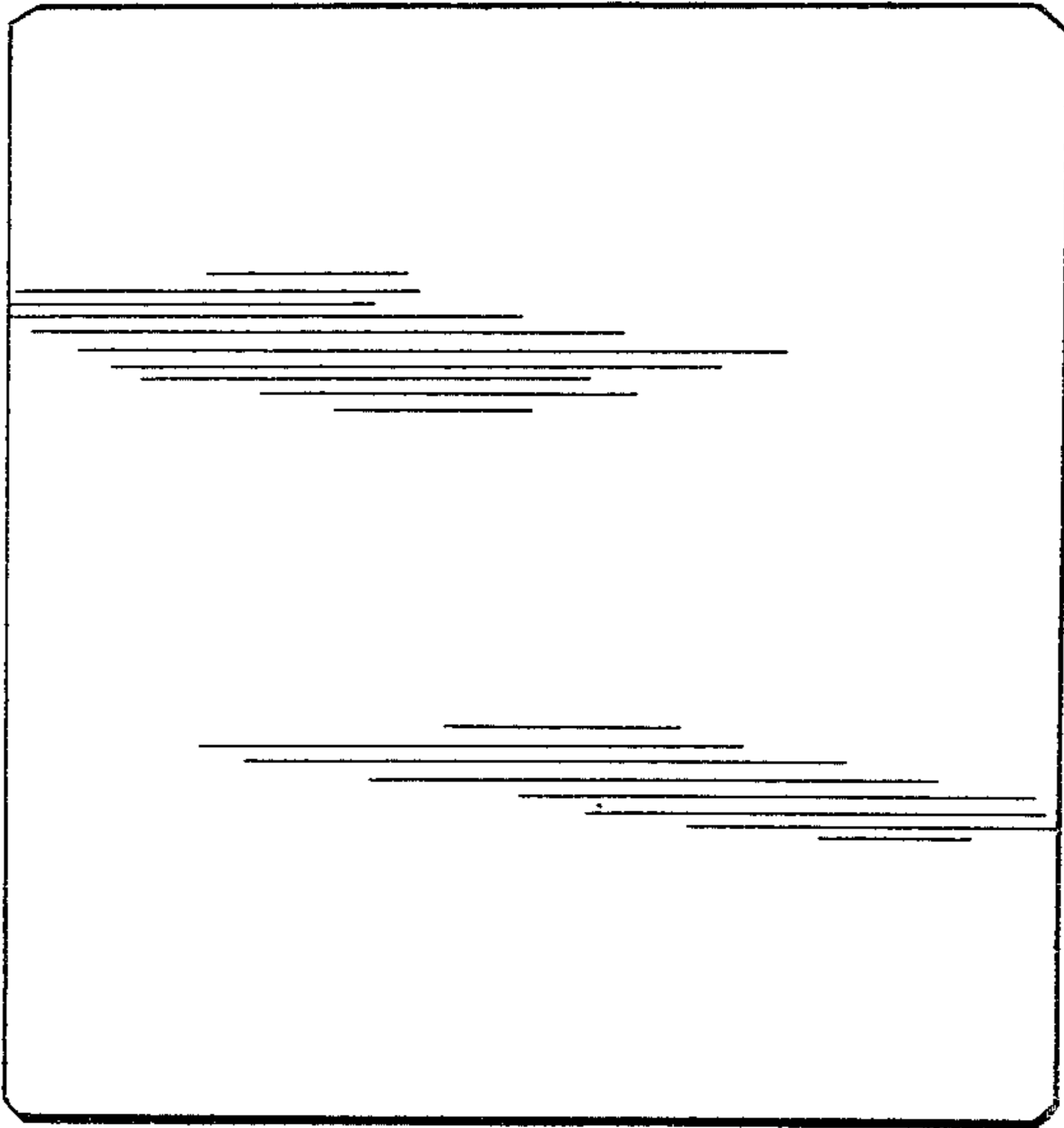

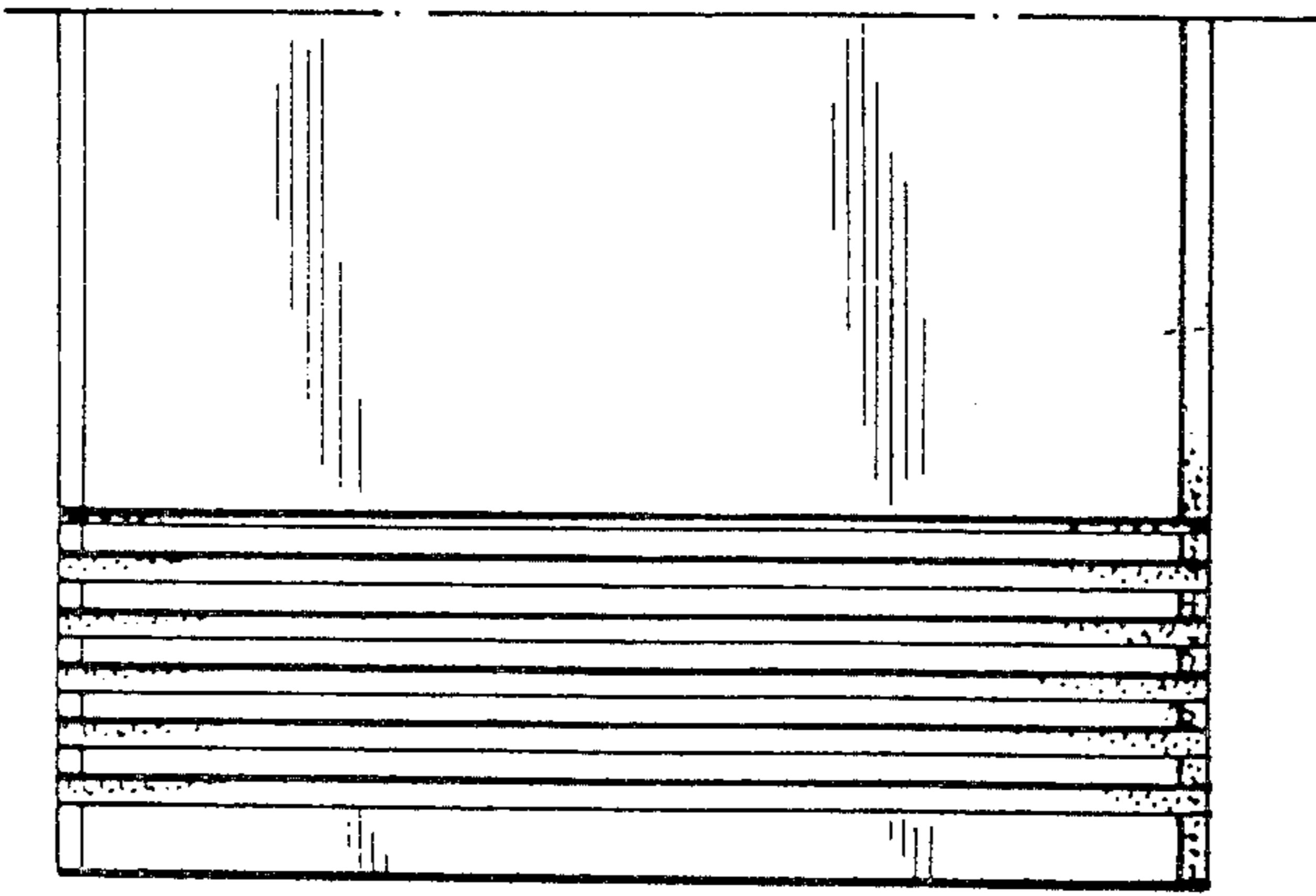

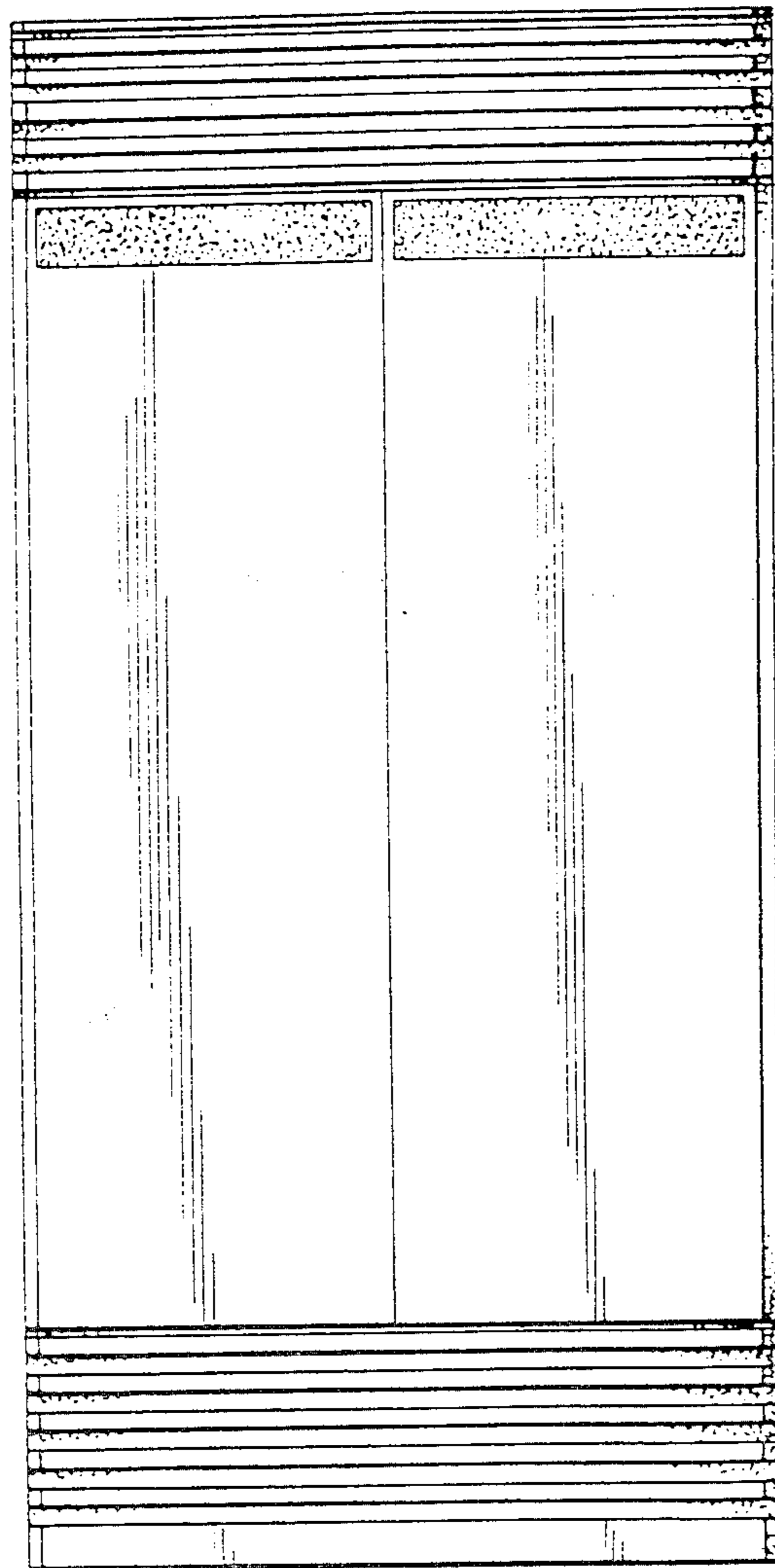
