[57] CLAIM

The ornamental design for an accessory holder for attachment to a bed, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view generally viewed as from above and to the left front of an accessory holder for attachment to a bed showing my new design.

FIG. 2 is an elevational view generally viewed as from the front of my design disclosed in FIG. 1.

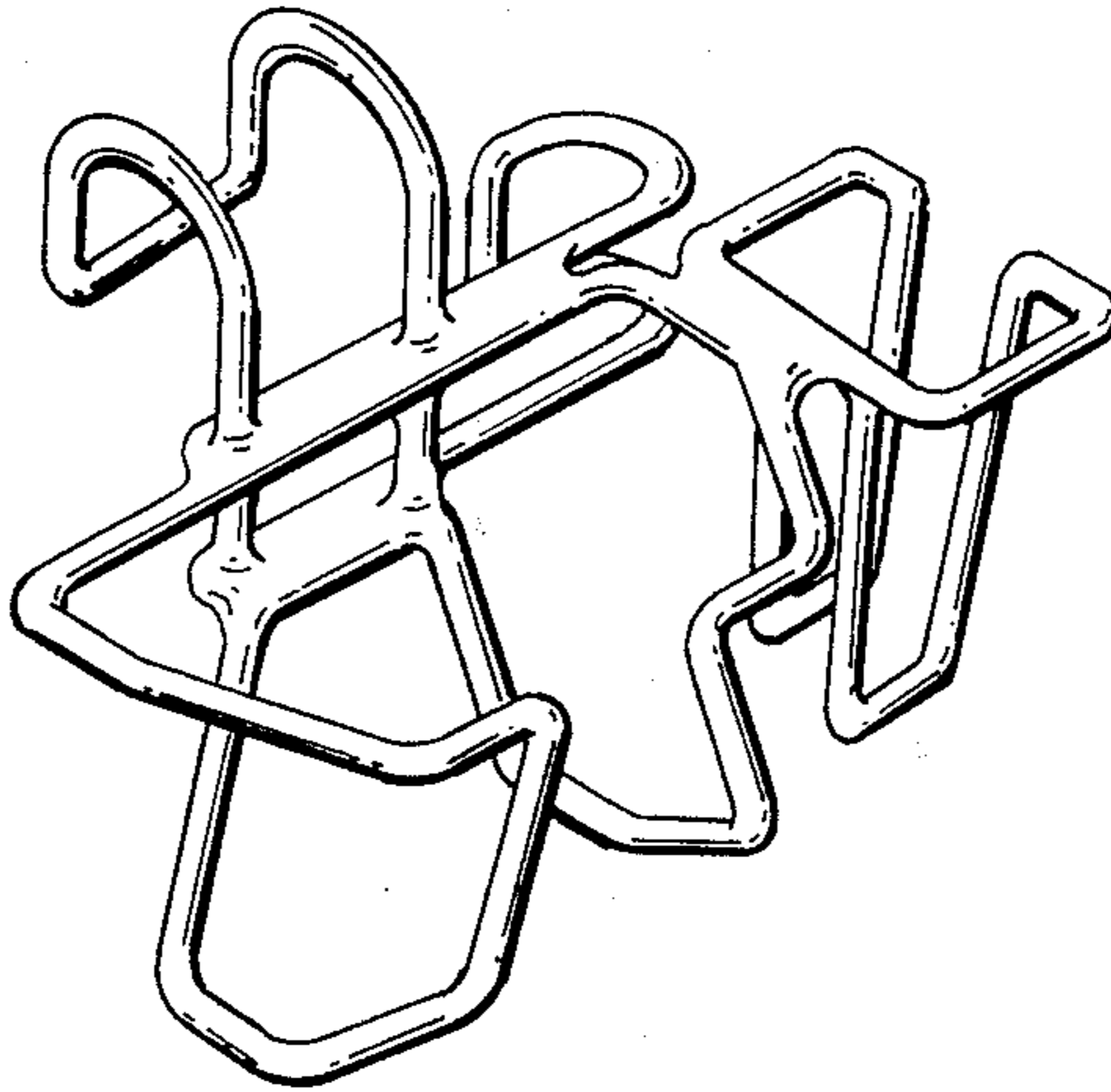
FIG. 3 is an elevational view generally viewed as from the rear of my design disclosed in FIG. 1.

FIG. 4 is an elevational view generally viewed as from the top of my design disclosed in FIG. 1.

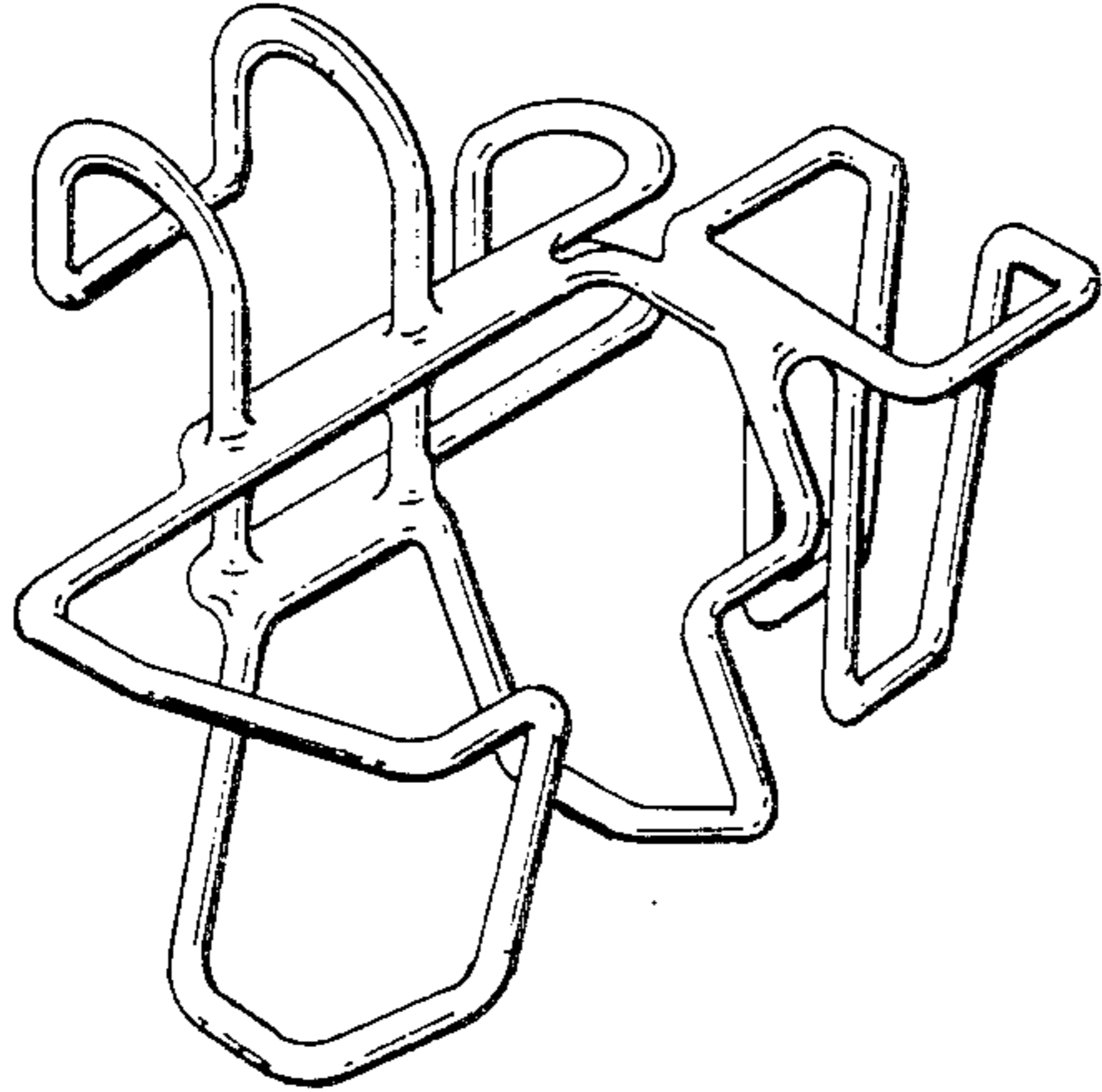
FIG. 5 is an elevational view generally viewed as from the left side of my design disclosed in FIG. 1.

FIG. 6 is an elevational view generally viewed as from the right side of my design disclosed in FIG. 1.

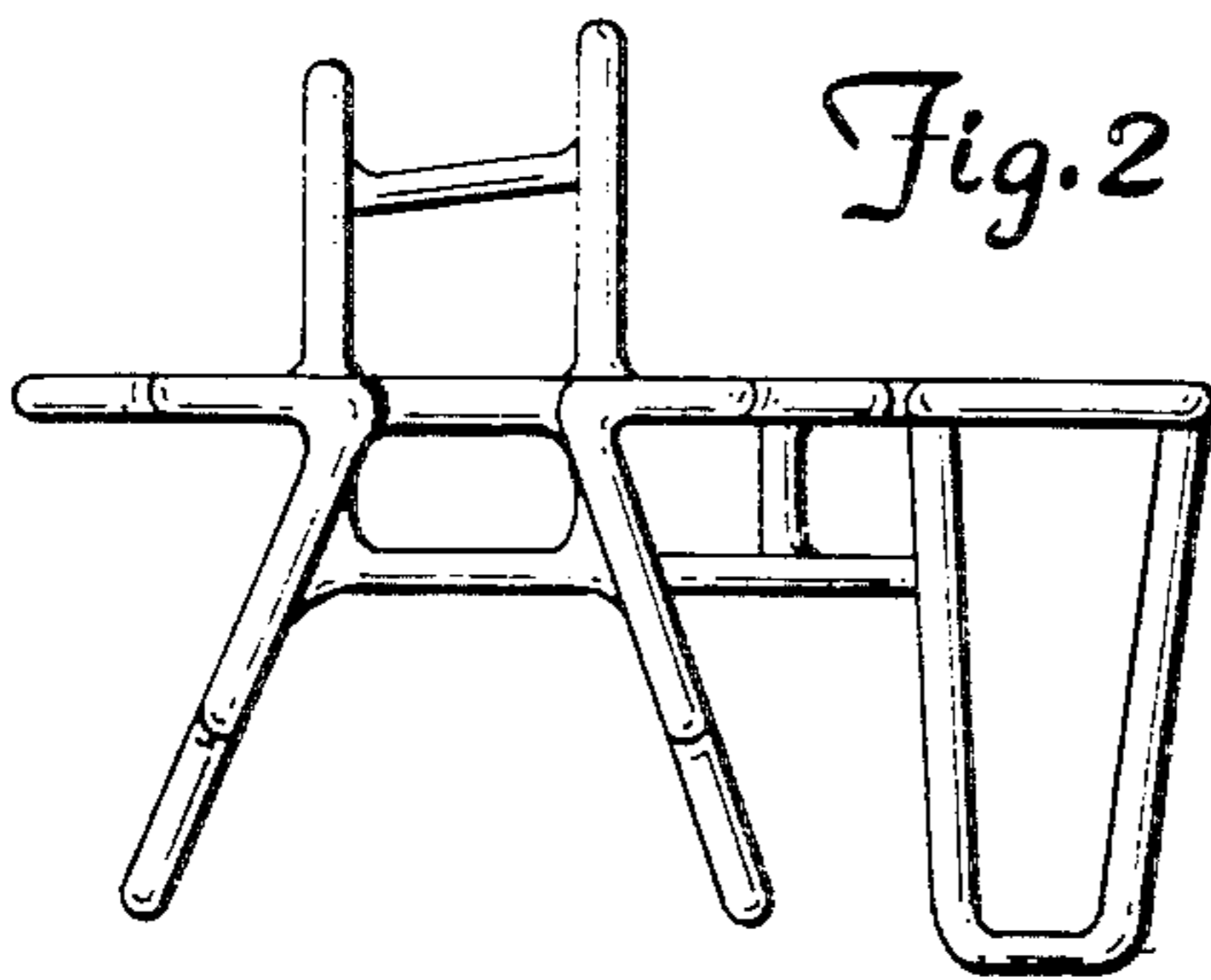
FIG. 7 is an elevational view generally viewed as from the bottom of my design disclosed in FIG. 1.



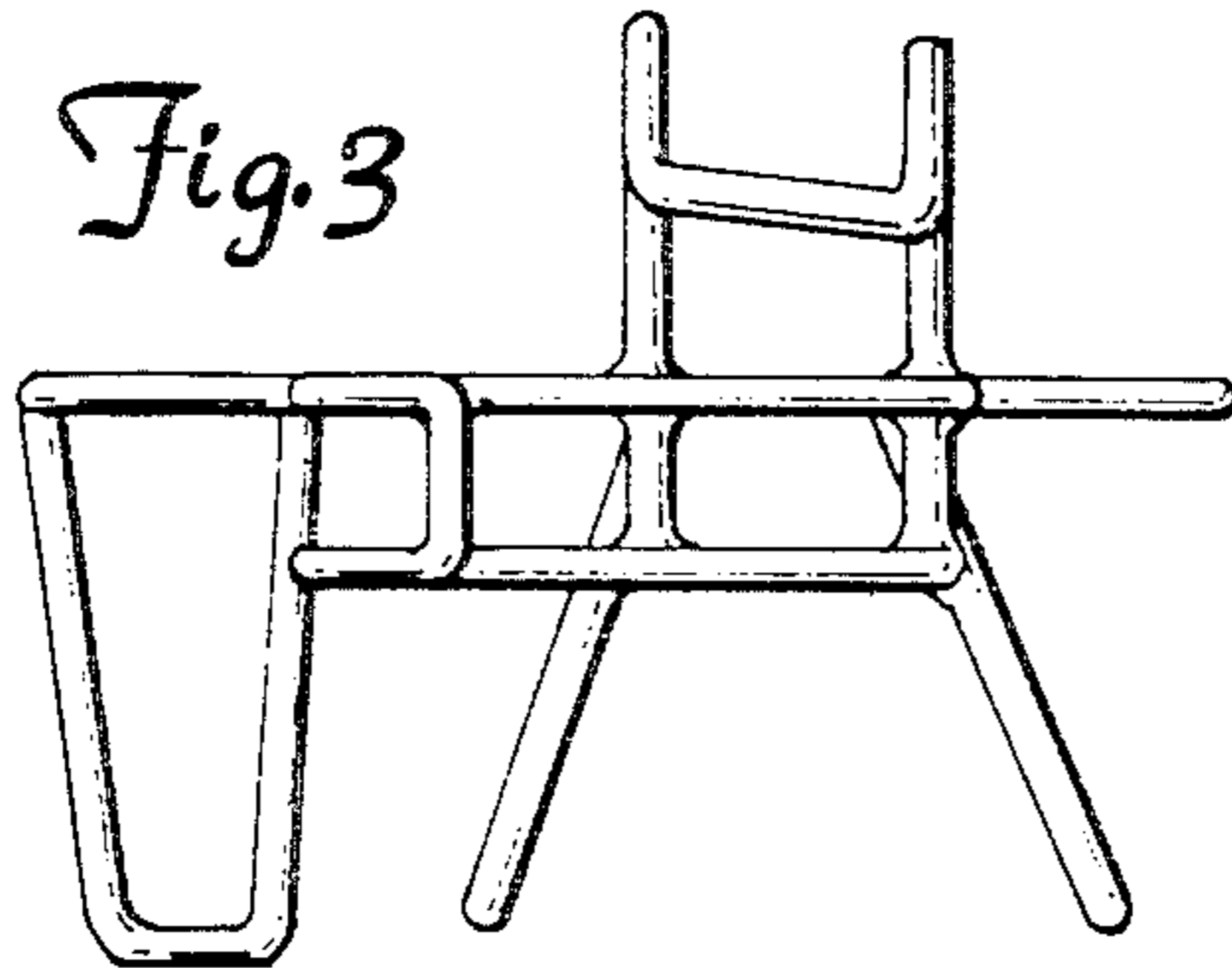

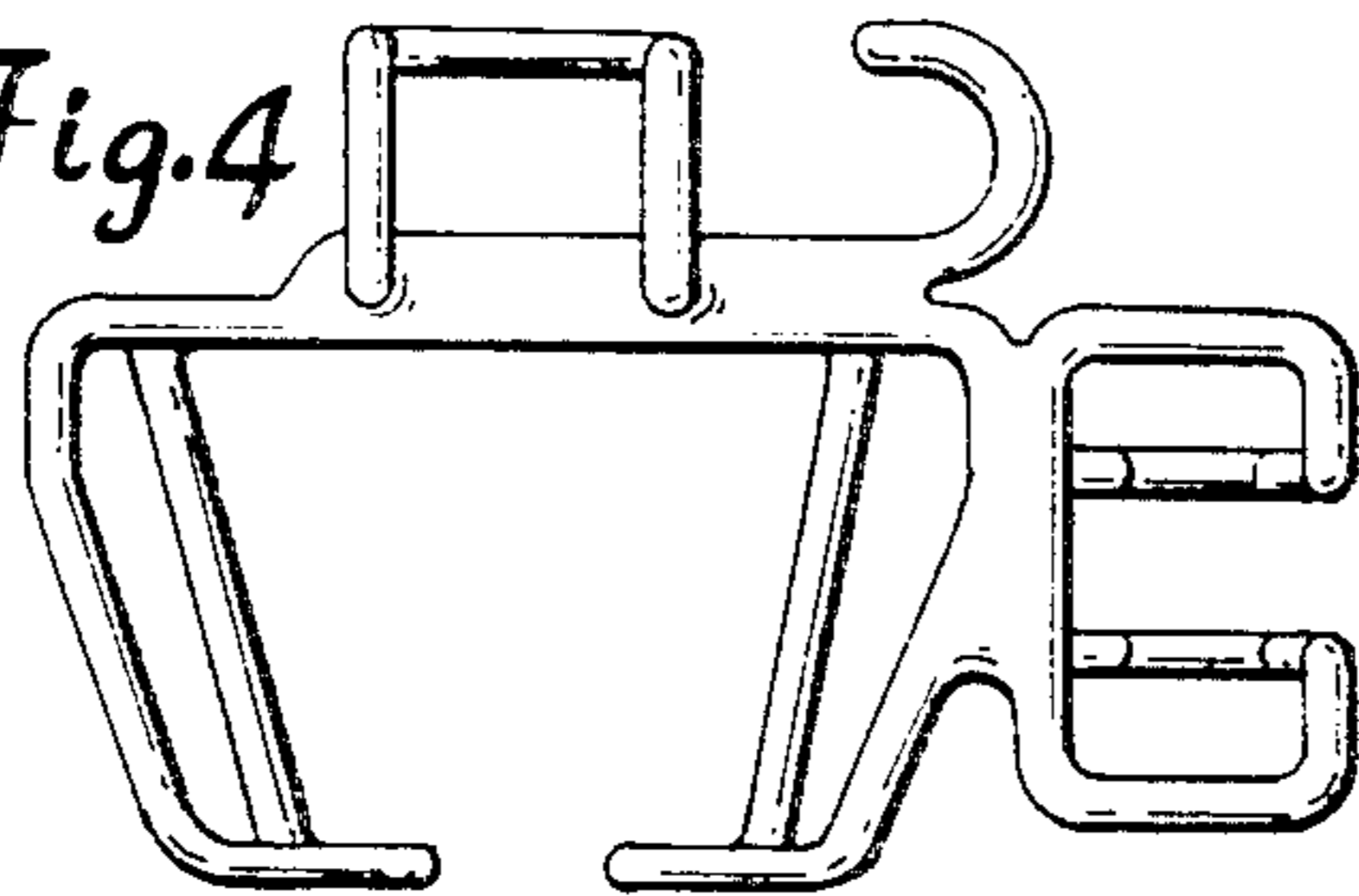

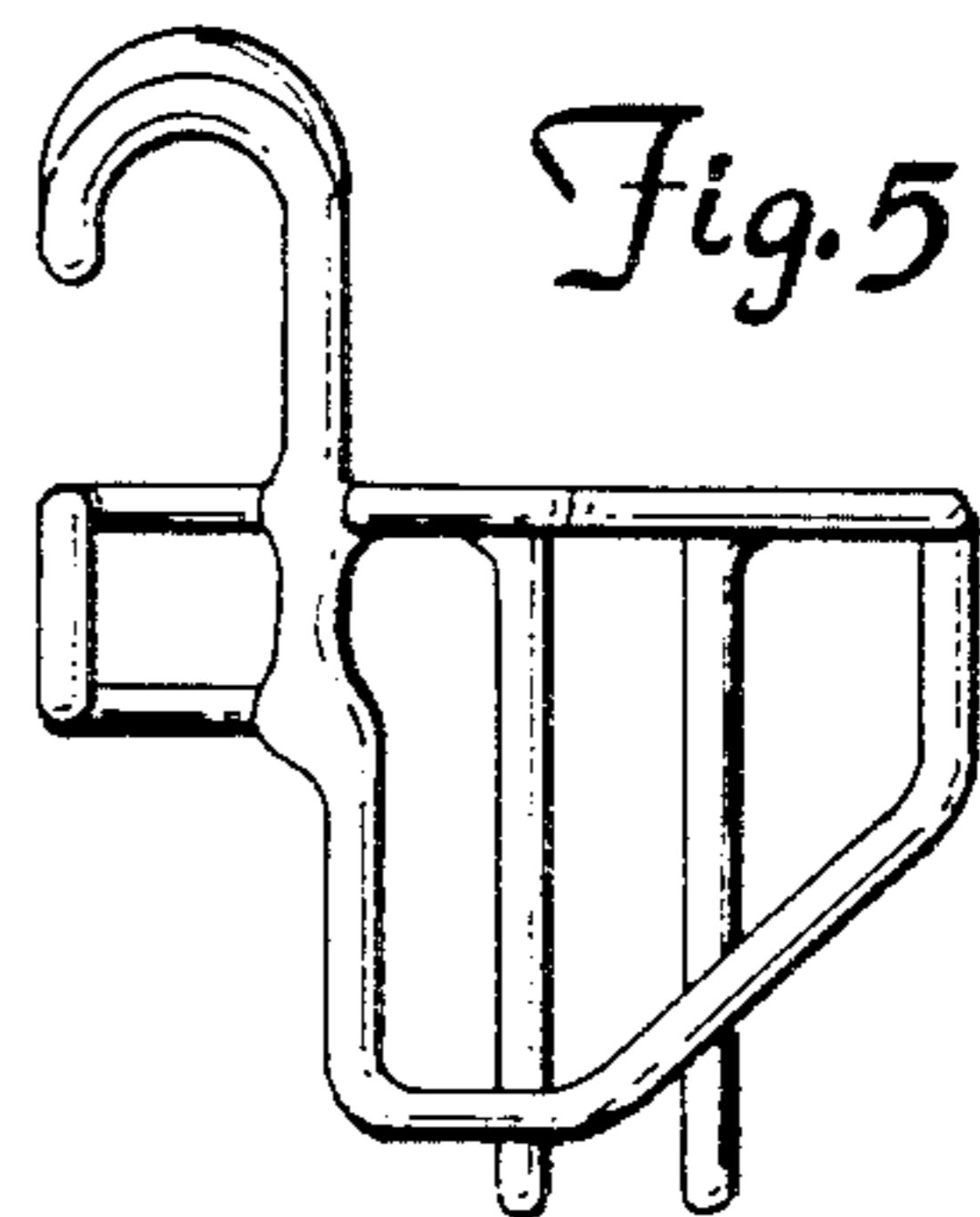

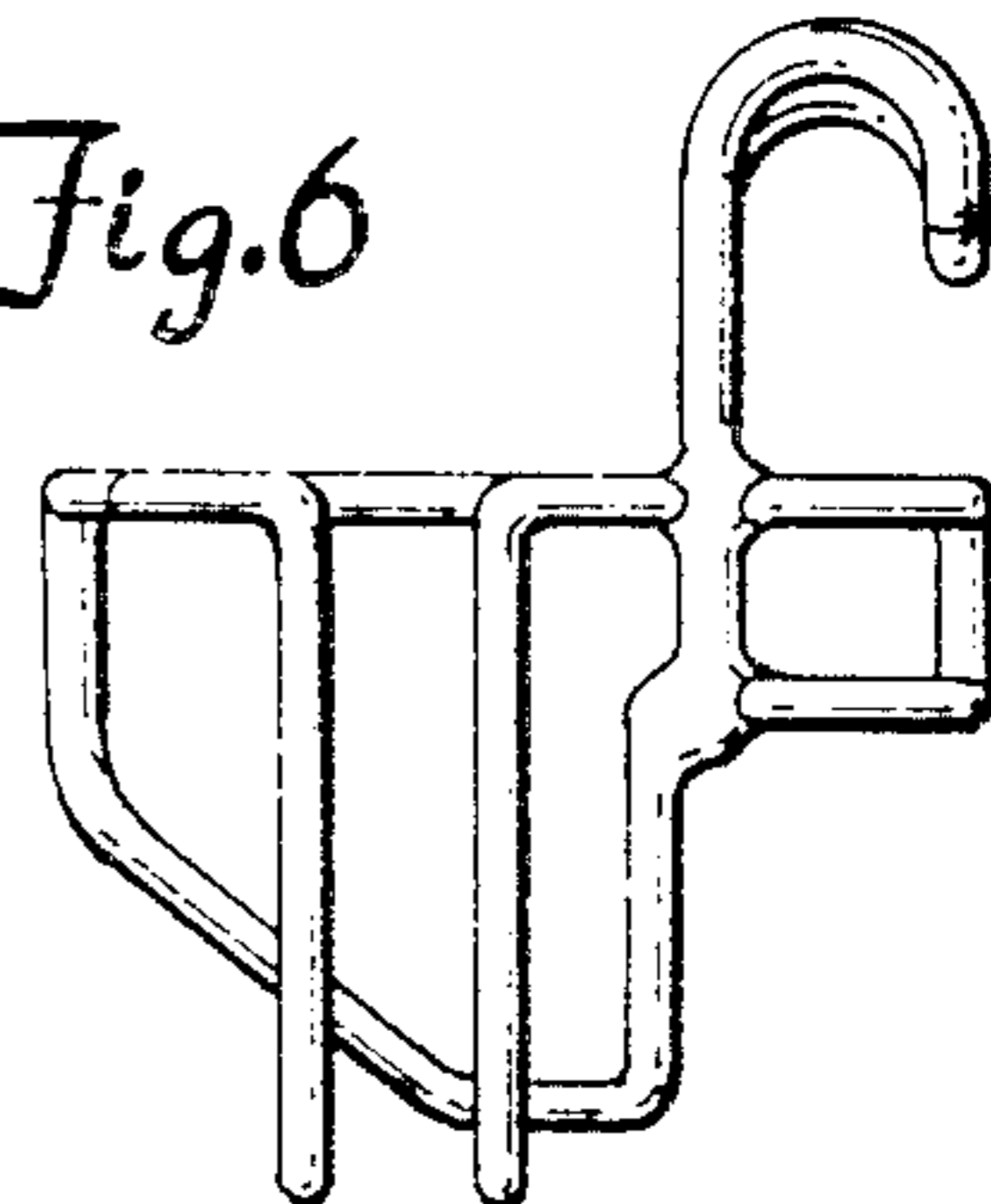
