[57] CLAIM

The ornamental design for a fluorescent lamp assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fluorescent lamp assembly showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is an elevational view looking from the right of FIG. 2; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and FIG. 6 is a bottom plan view thereof.

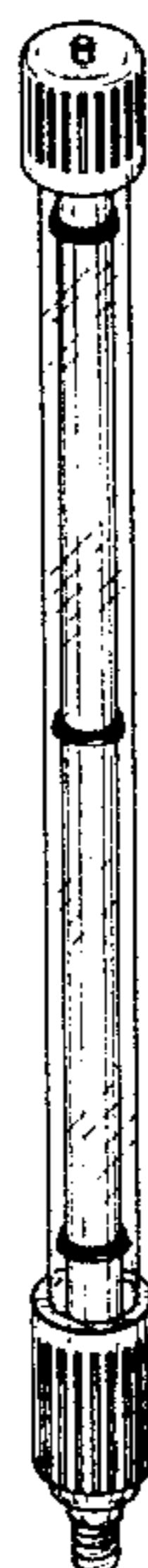

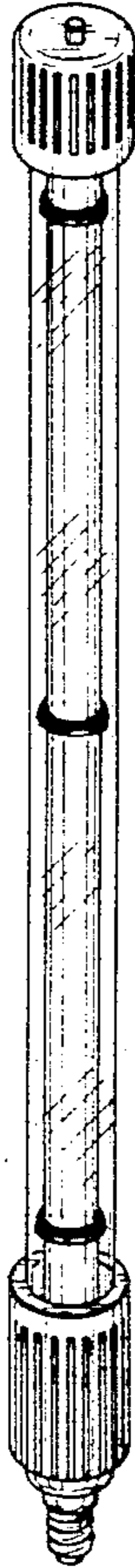

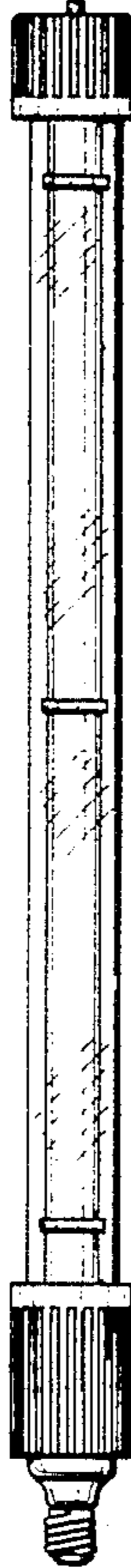
