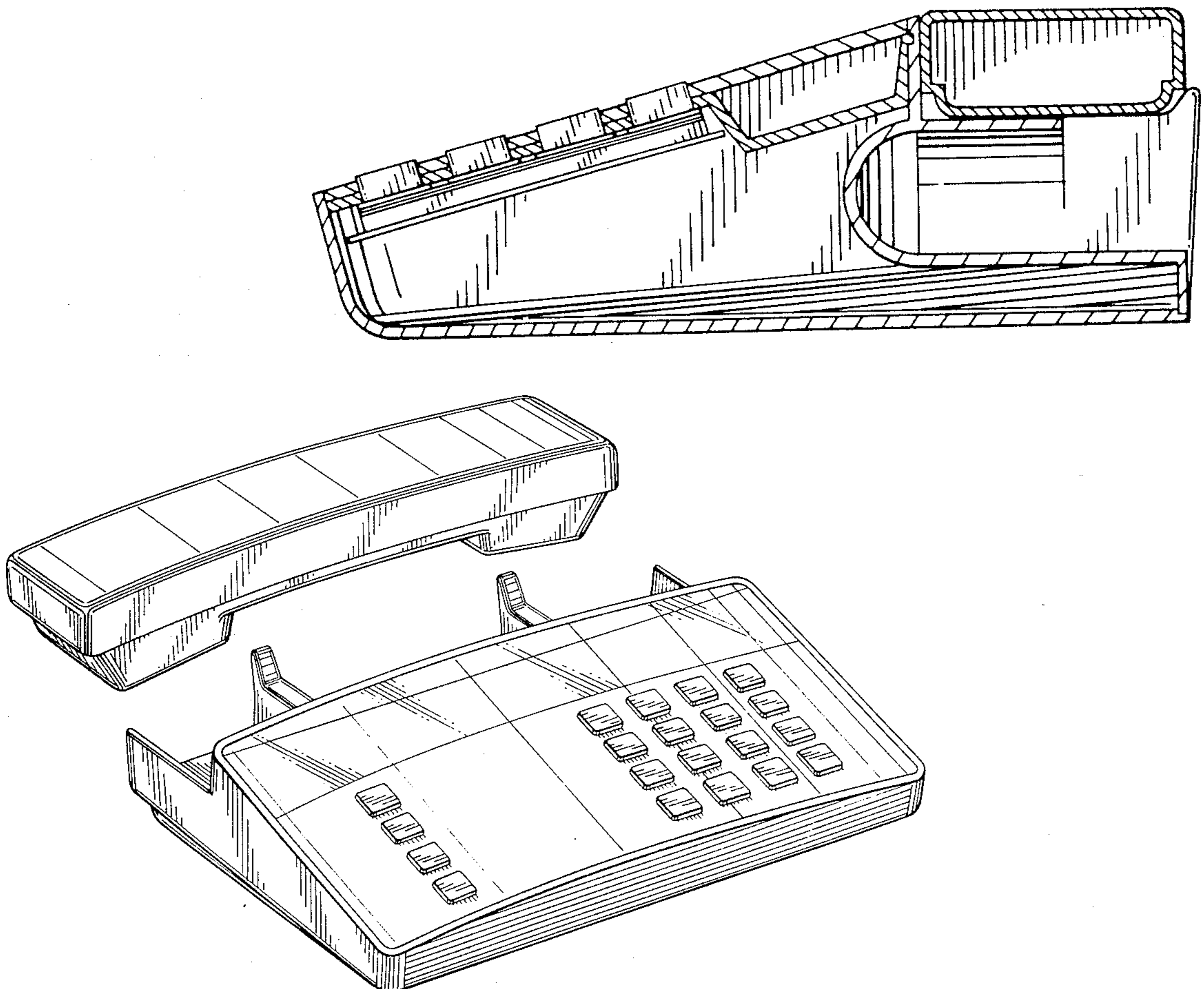

The ornamental design for a telephone, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a telephone showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bracketed rear elevational view thereof, with the handset of the telephone raised above its stand;
FIG. 6 is a bottom plan view thereof; and
FIG. 7 is a cross-sectional view thereof taken along the line 7—7 of FIG. 1.



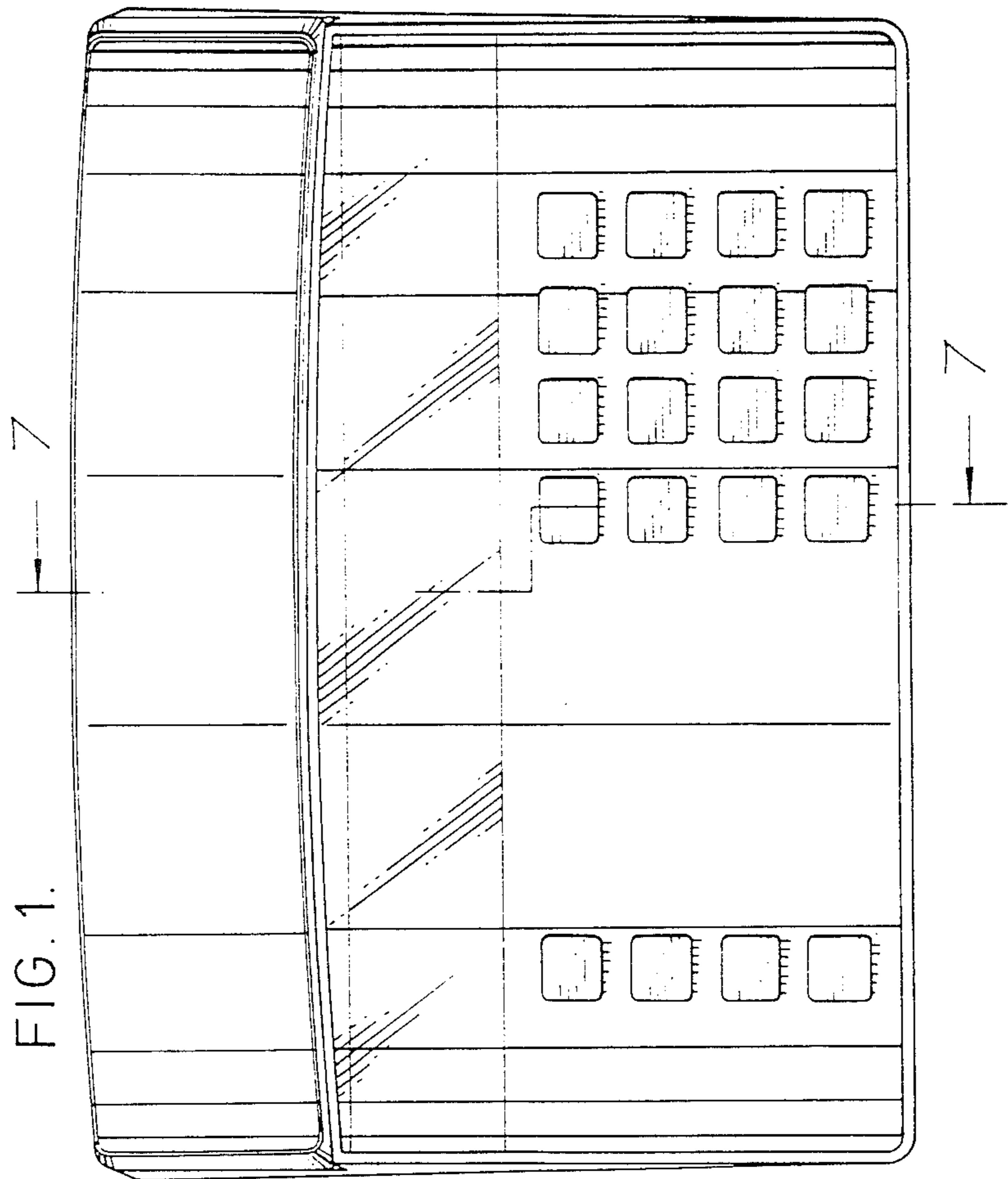

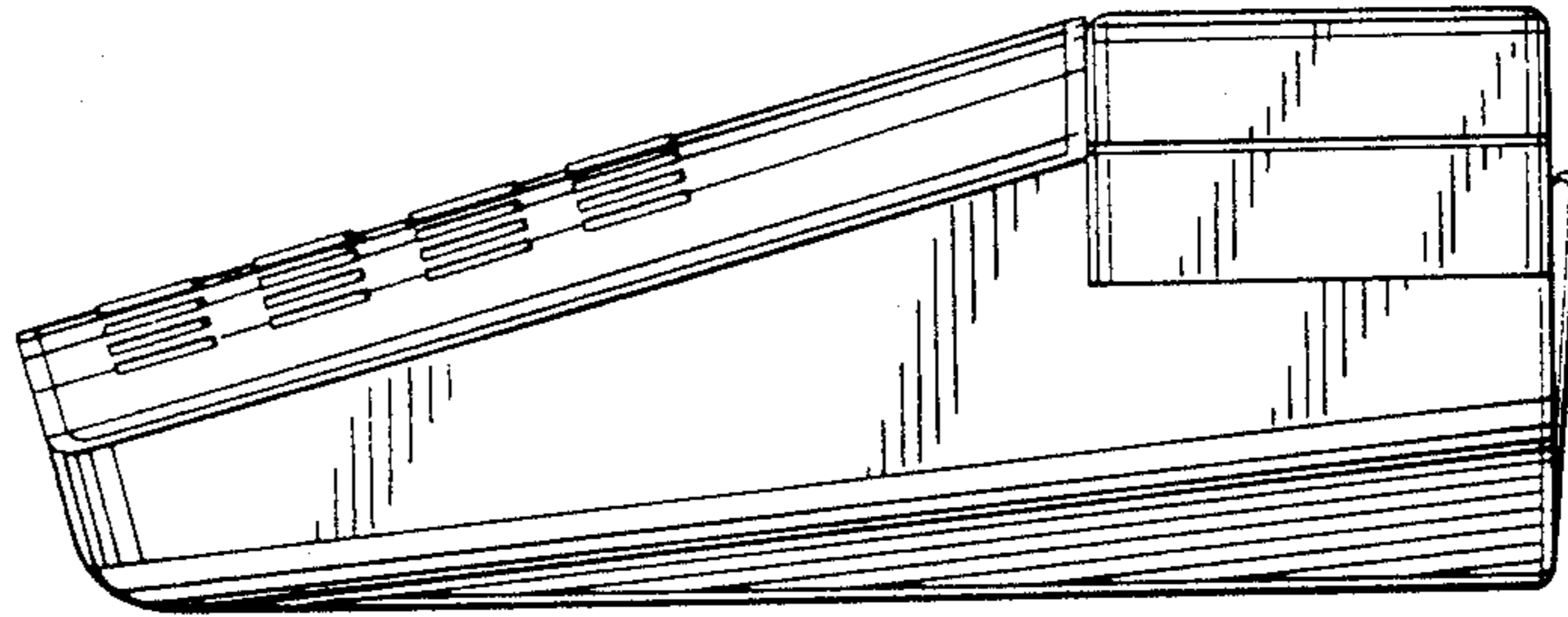

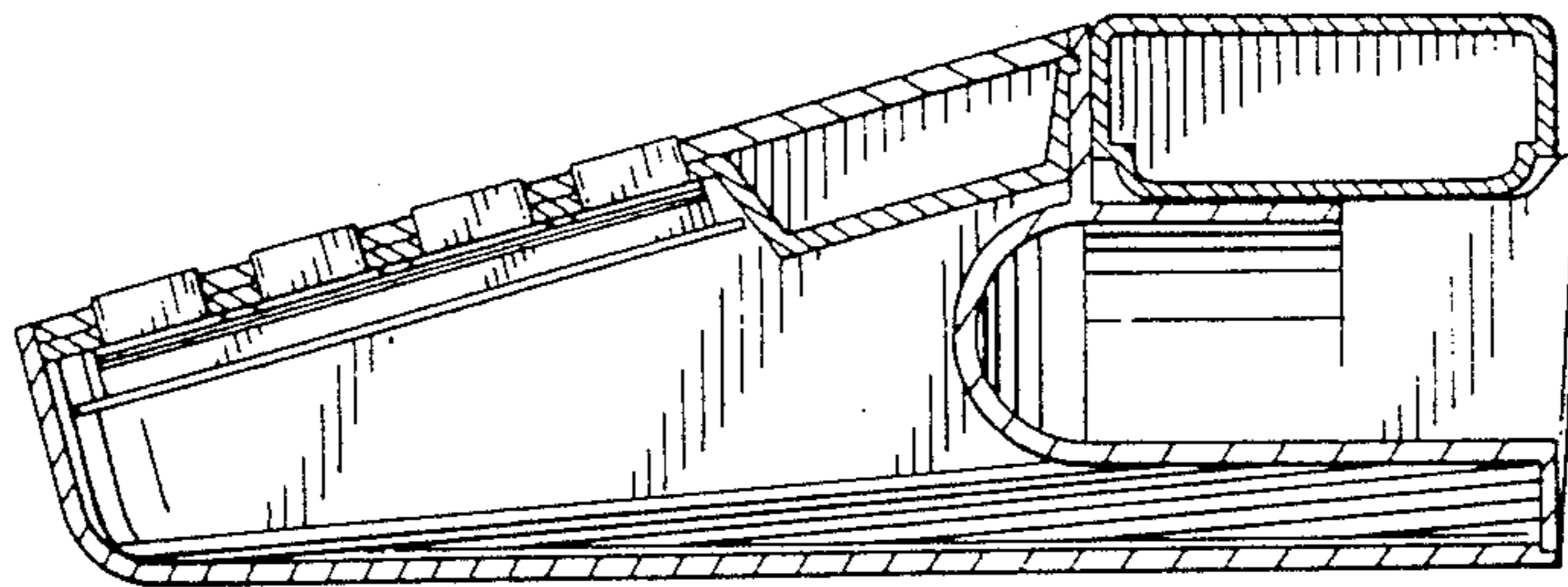

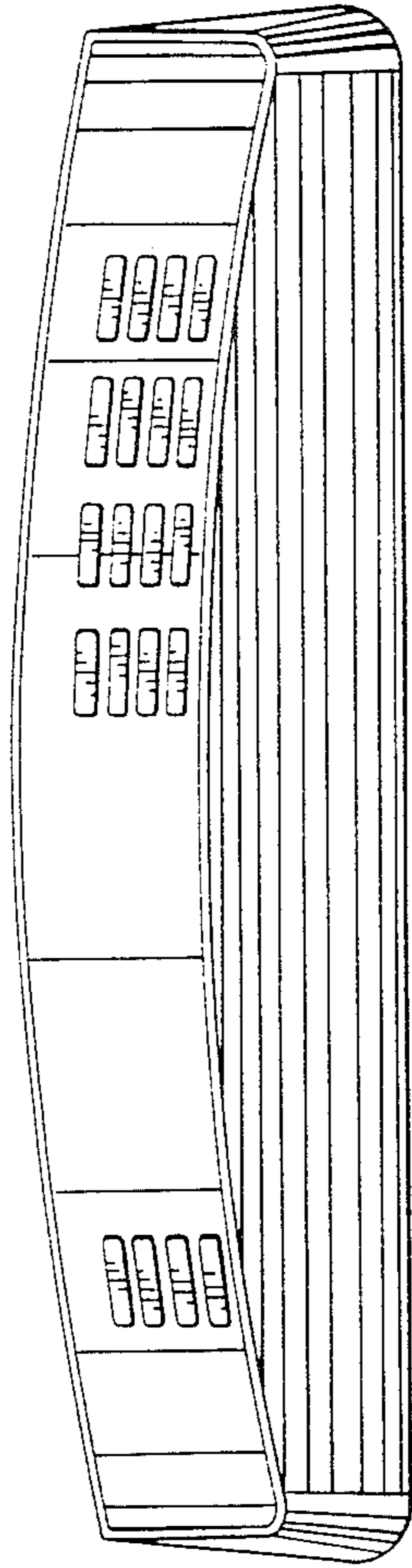

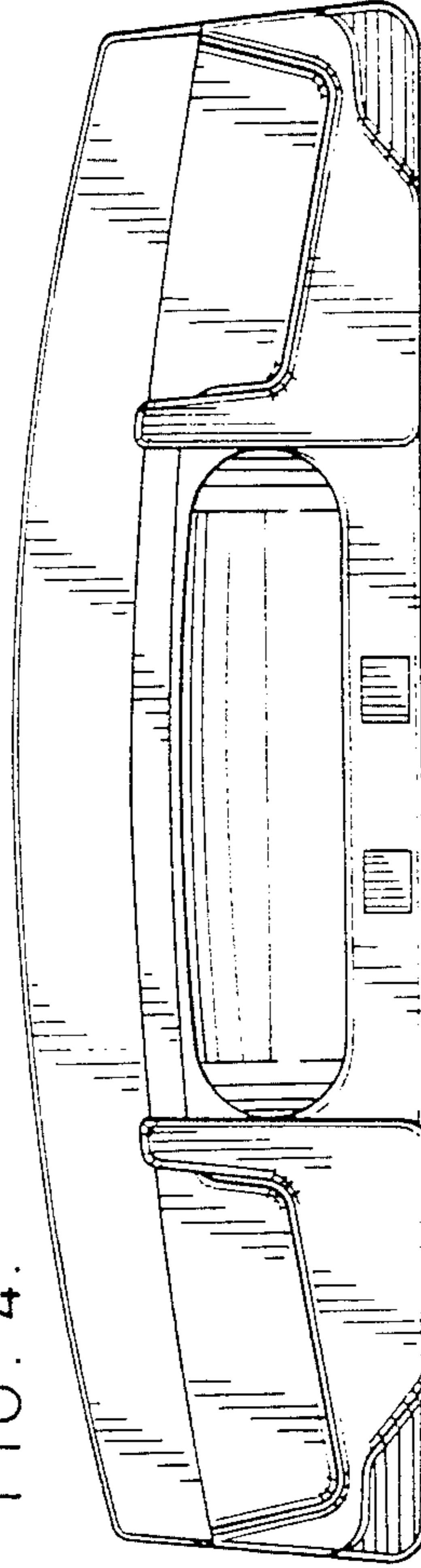
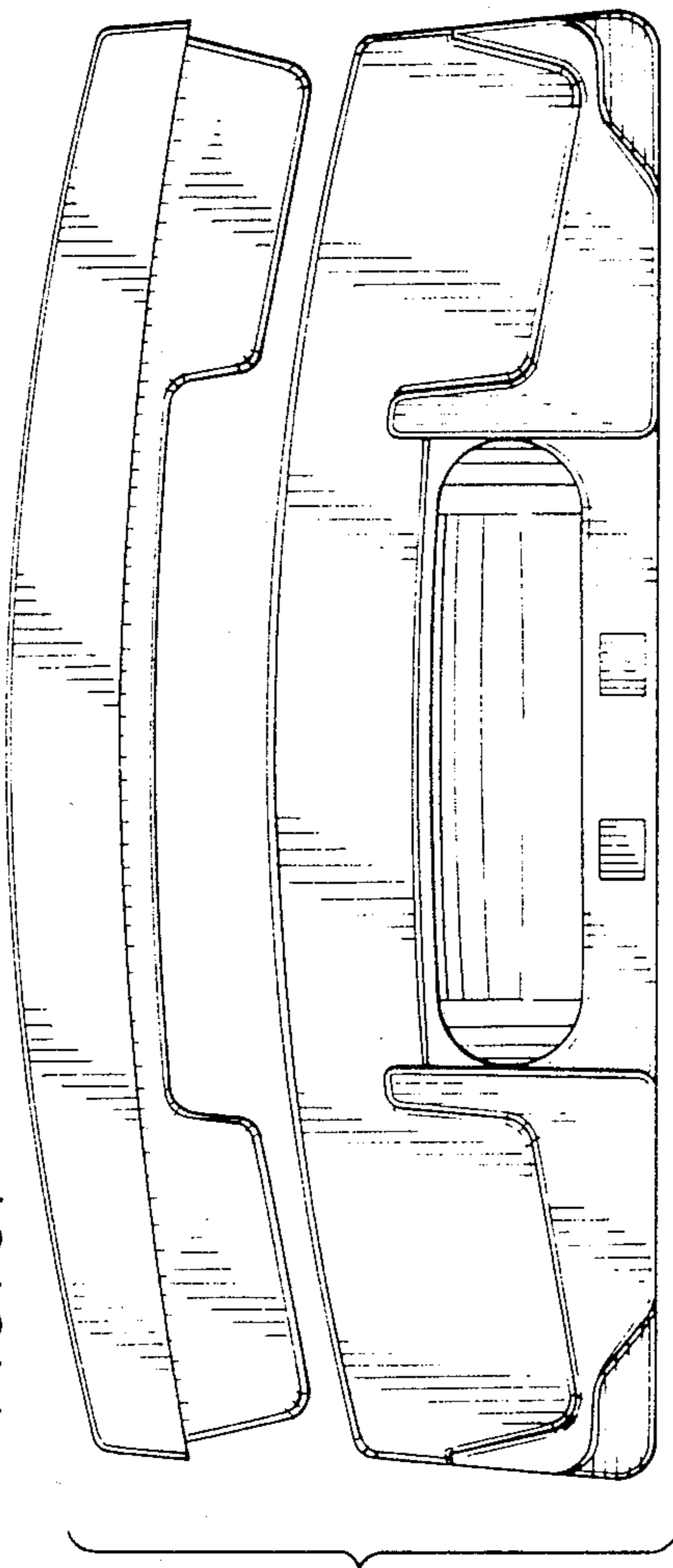

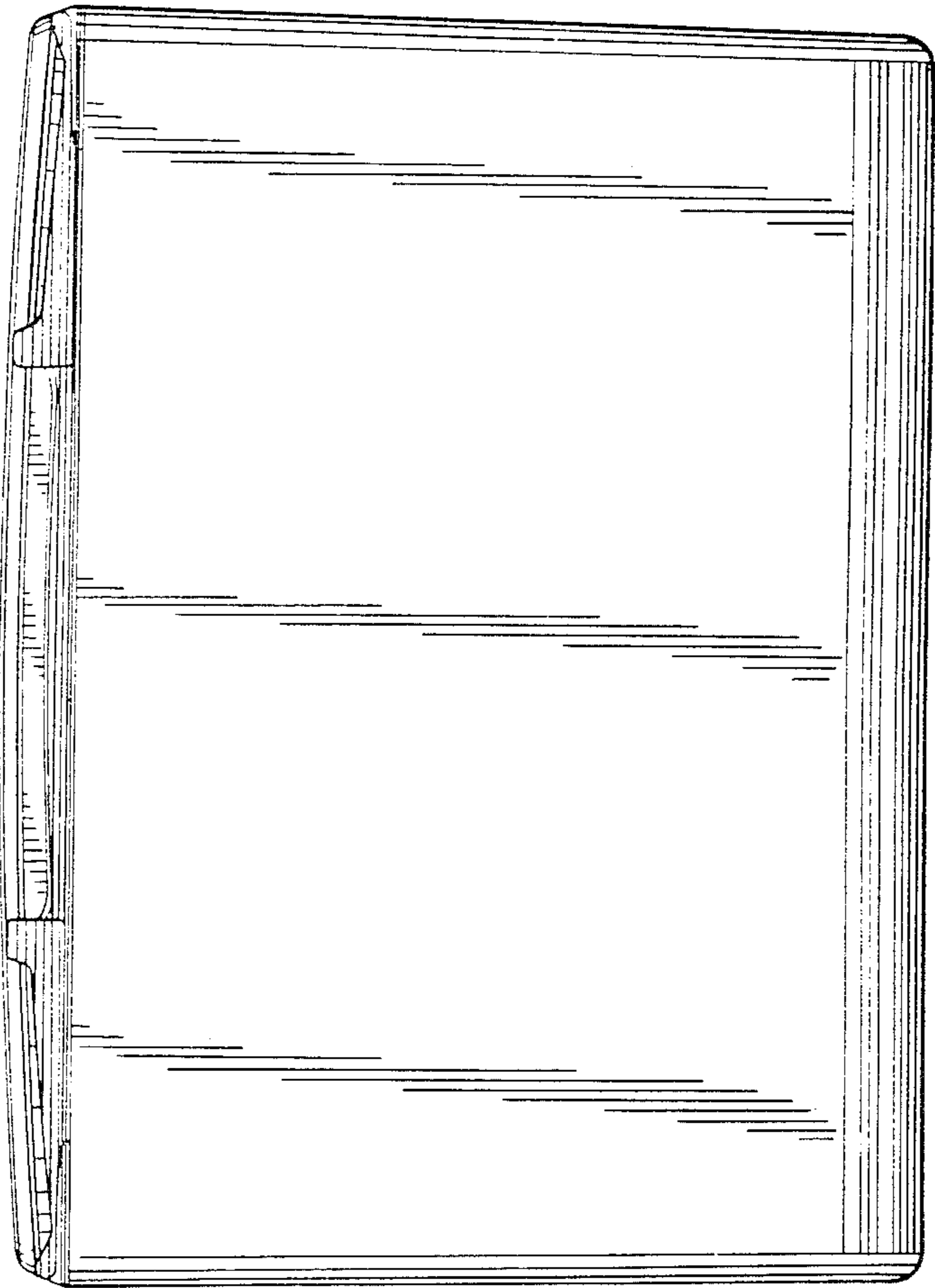
