[57] **CLAIM**

The ornamental design for a surgical knife handle or similar article, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a surgical knife handle showing our new design; the handle being shown in solid lines and the blade portion being shown in dotted lines;  
 FIG. 2 is a top plan view of the FIG. 1 embodiment;  
 FIG. 3 is a cross-sectional view taken along line 3—3 of FIG. 1;  
 FIG. 4 is a cross-sectional view taken along line 4—4 of FIG. 1;  
 FIG. 5 is an enlarged elevational view taken from the right of FIG. 1;  
 FIG. 6 is an enlarged fragmentary front view of the tip section as seen in FIG. 1;  
 FIG. 7 is an enlarged fragmentary top view of the tip section as seen in FIG. 2.

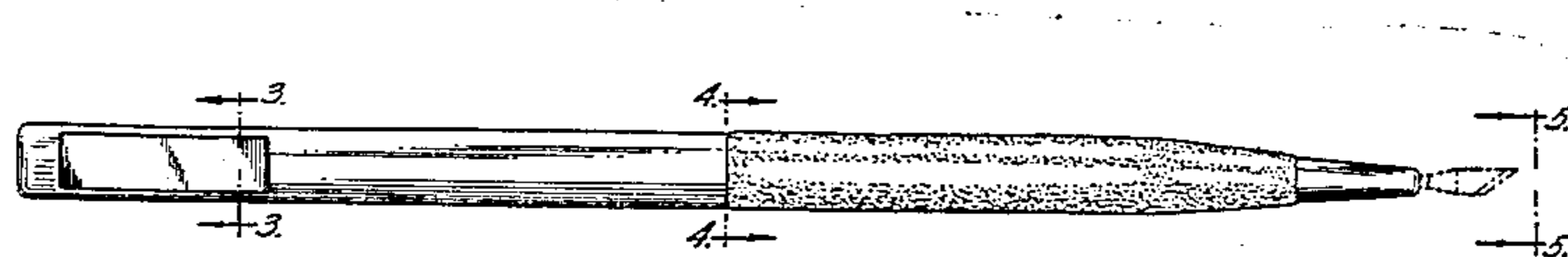

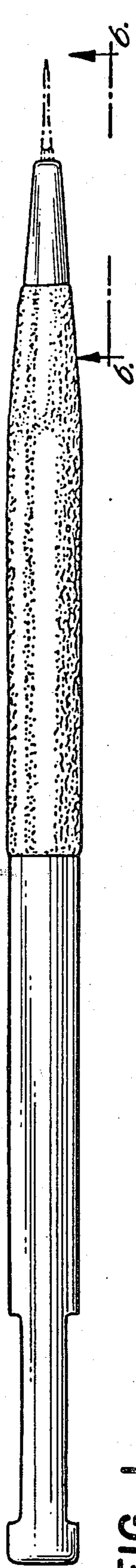

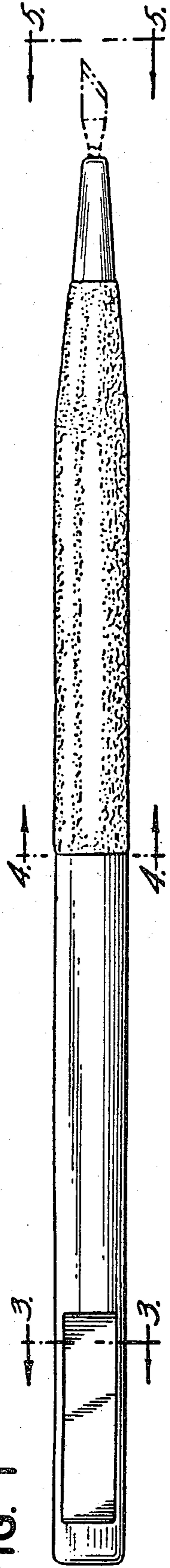

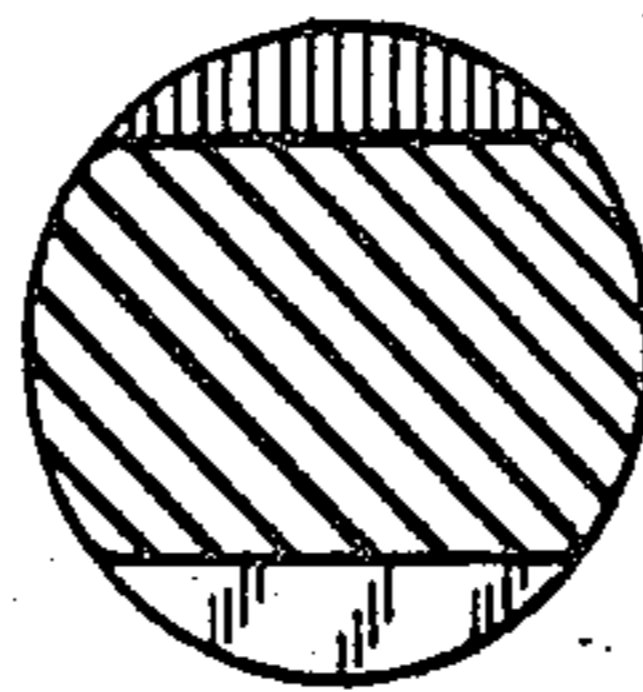

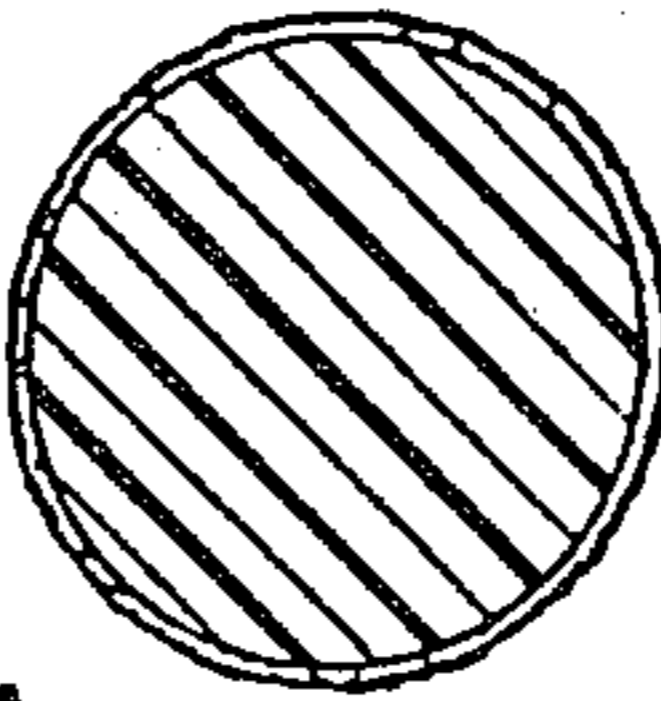

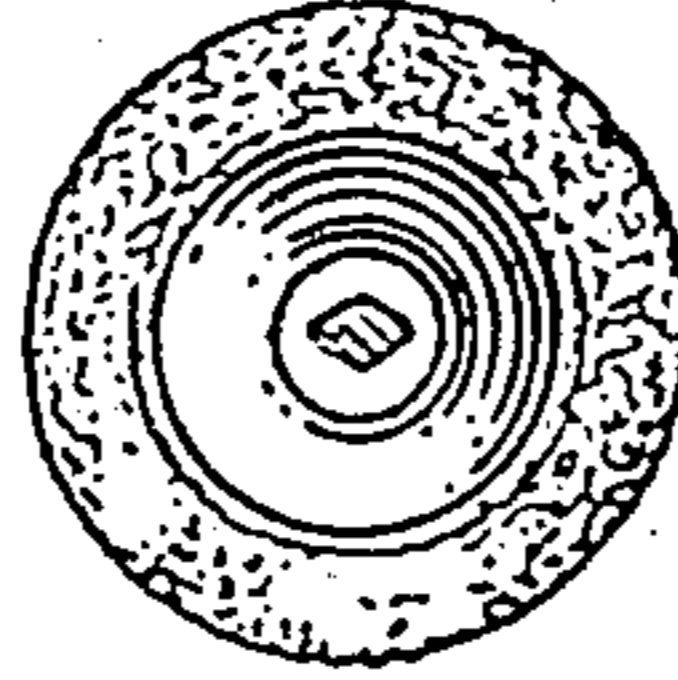

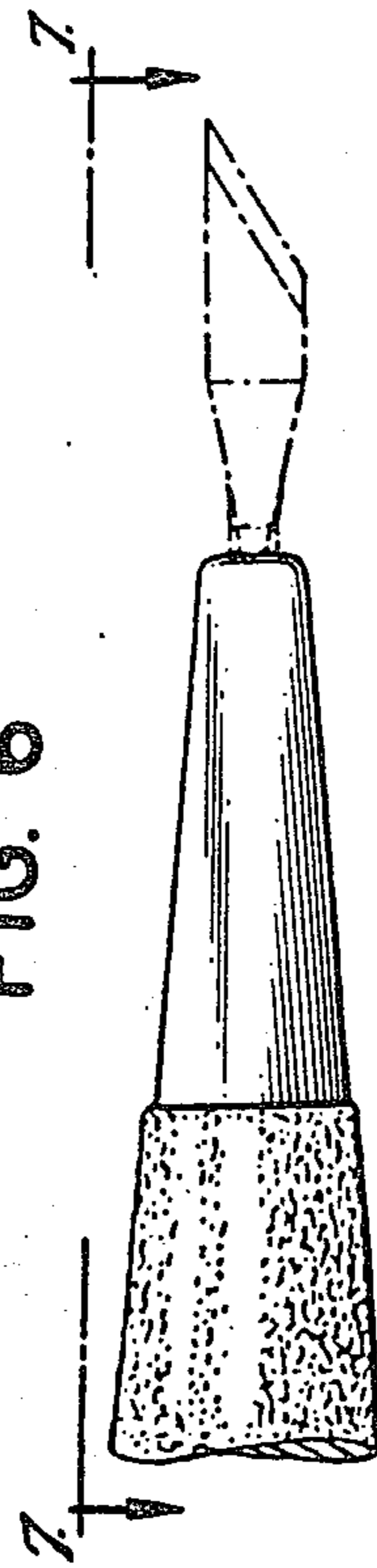
