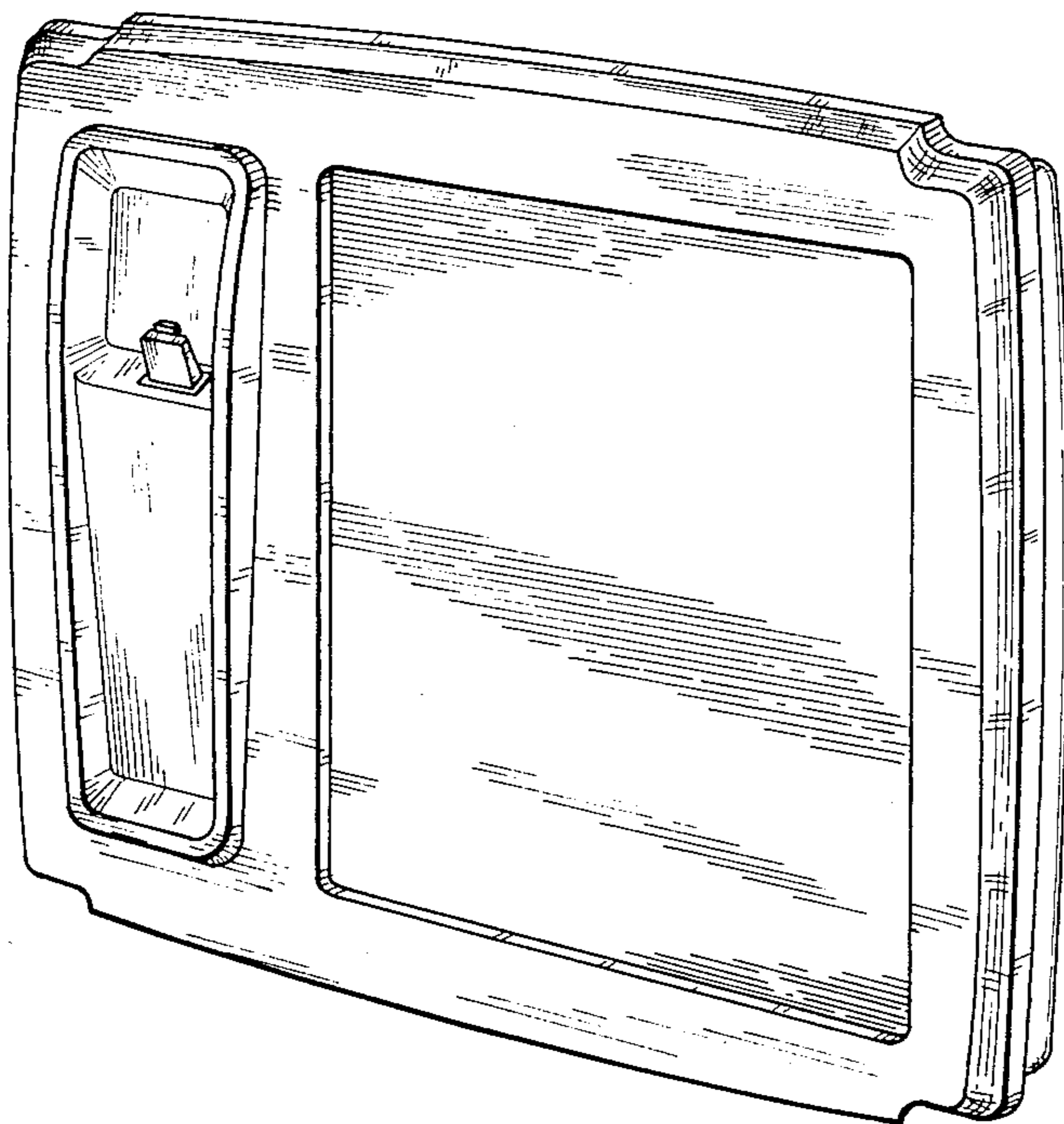

 FIG. 4 is a top end elevational view as seen from FIG. 2.



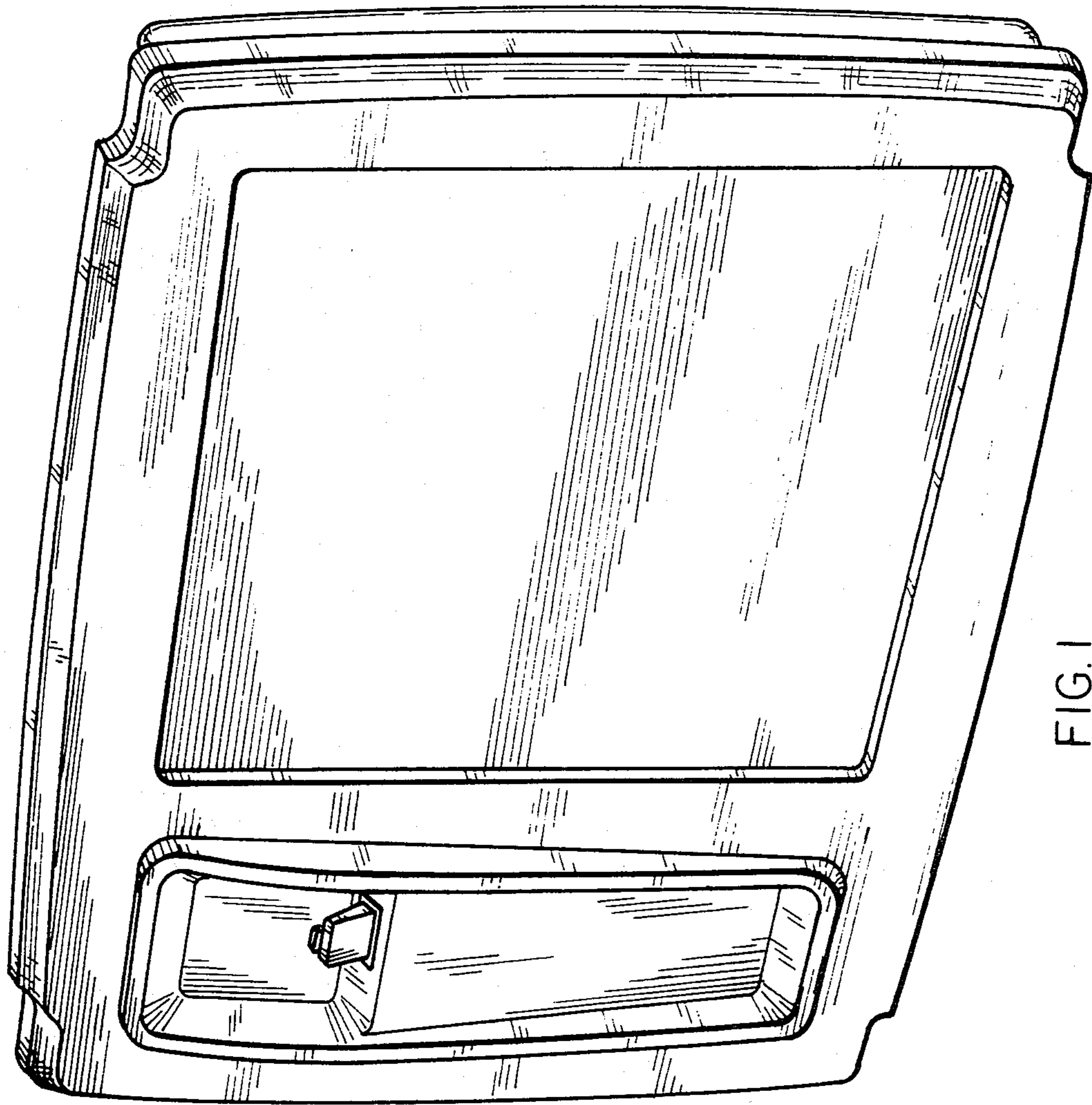

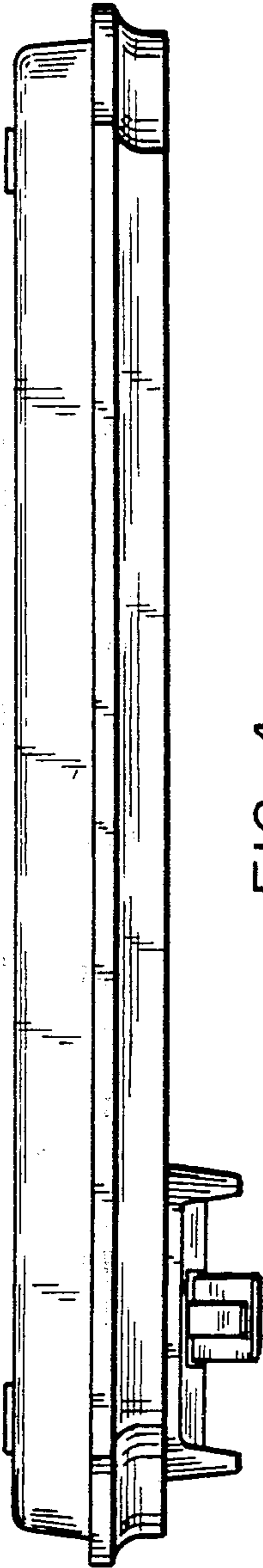

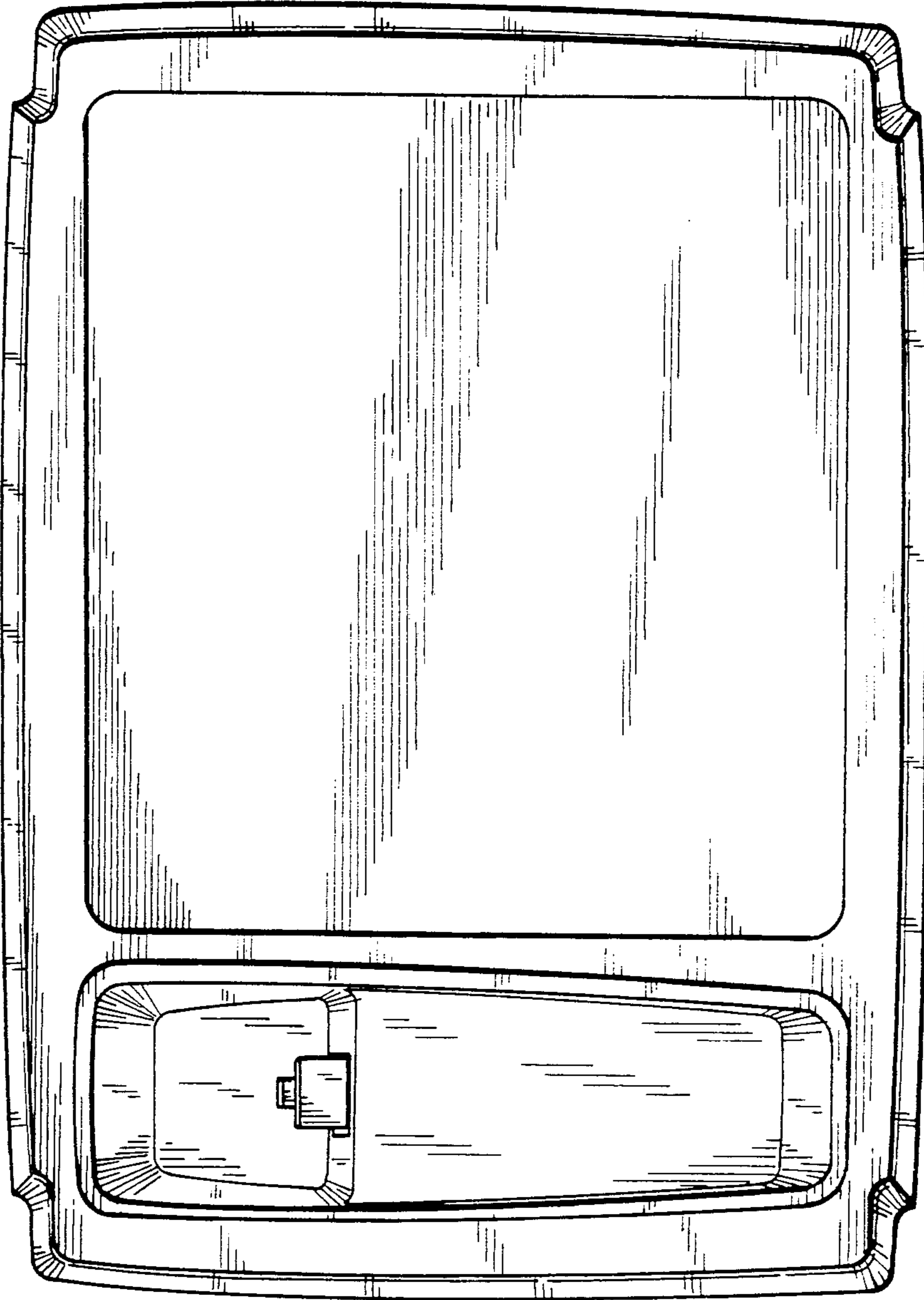

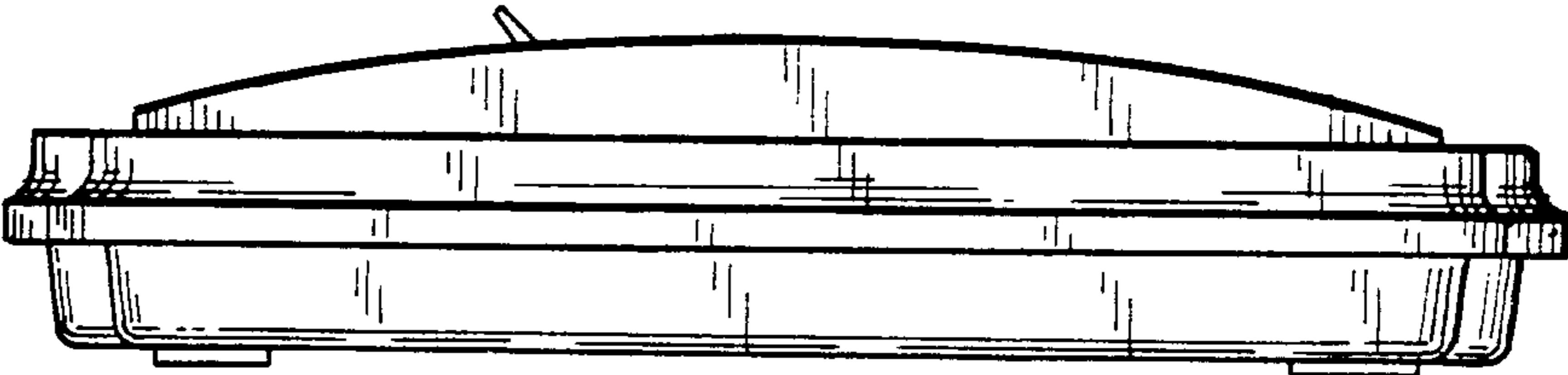
