#### CLAIM

The ornamental design for a delivery storage cabinet, substantially as shown and described.

#### DESCRIPTION

FIG. 1 is a perspective view of the delivery storage cabinet of the invention showing my new design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a bottom plan view thereof.
FIG. 4 is a front elevational view thereof.
FIG. 5 is a right side elevational view thereof.
FIG. 6 is a left elevational view thereof.
FIG. 7 is a rear elevational view thereof.
FIG. 8 is a right elevational view thereof.
FIG. 8 is a right elevational view of a second embodiment of the delivery storage cabinet shown in FIG.
1, the left being identical to FIG. 6 with the addition of the bottom plate extending between the casters; and

FIG. 9 is a bottom plan view thereof.

The top, front and rear views of the second embodiment

are identical to the views shown in FIGS. 2, 4 and 7 respectively.
