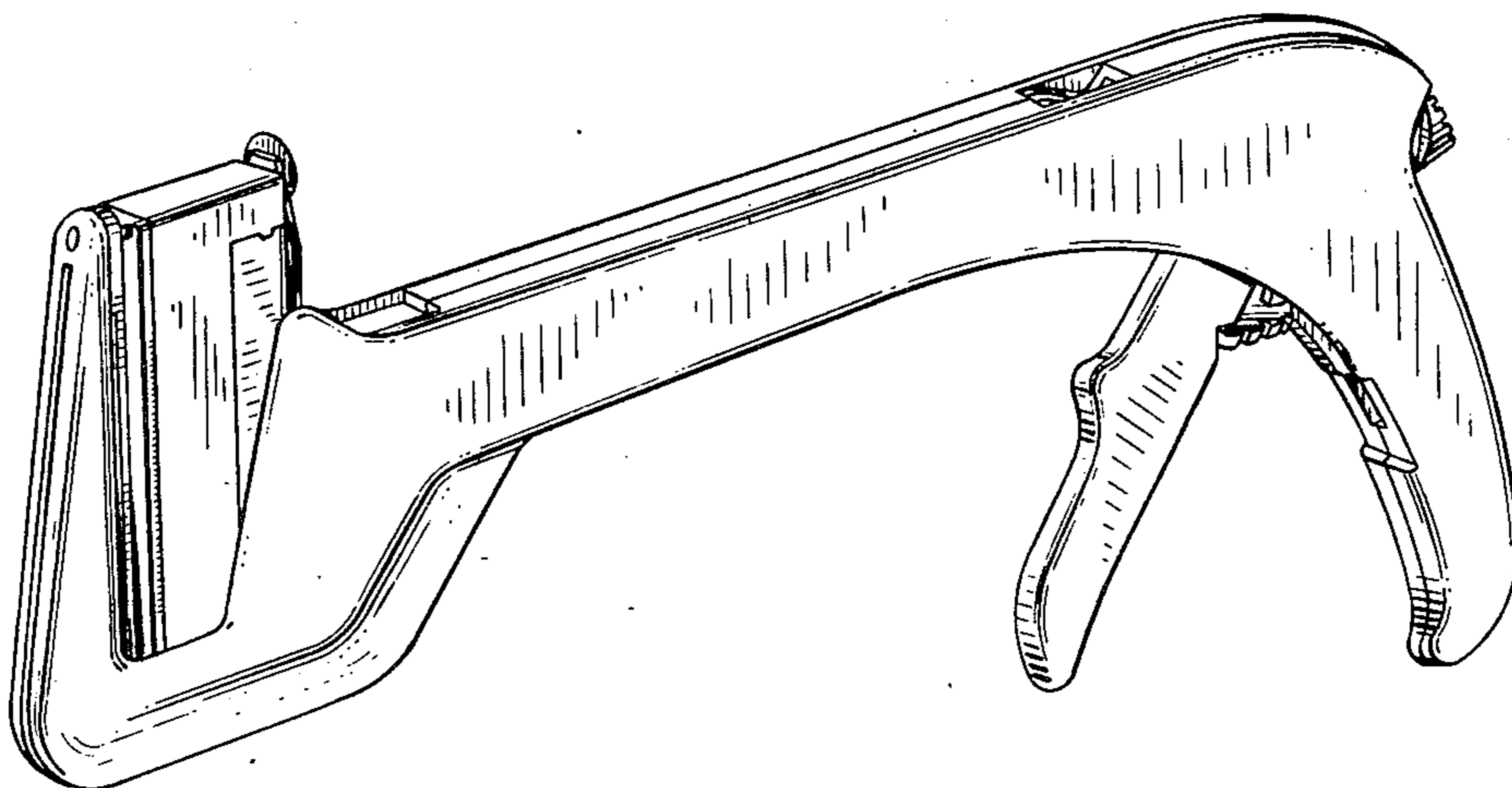

[57] **CLAIM**

The ornamental design for a linear surgical fastener applier, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a linear surgical fastener applier showing our new design;  
 FIG. 2 is a side elevational view thereof;  
 FIG. 3 is an end elevational view thereof, as seen from the right of FIG. 2;  
 FIG. 4 is an end elevational view thereof, as seen from the left of FIG. 2;  
 FIG. 5 is a top plan view thereof; and  
 FIG. 6 is a bottom plan view thereof.



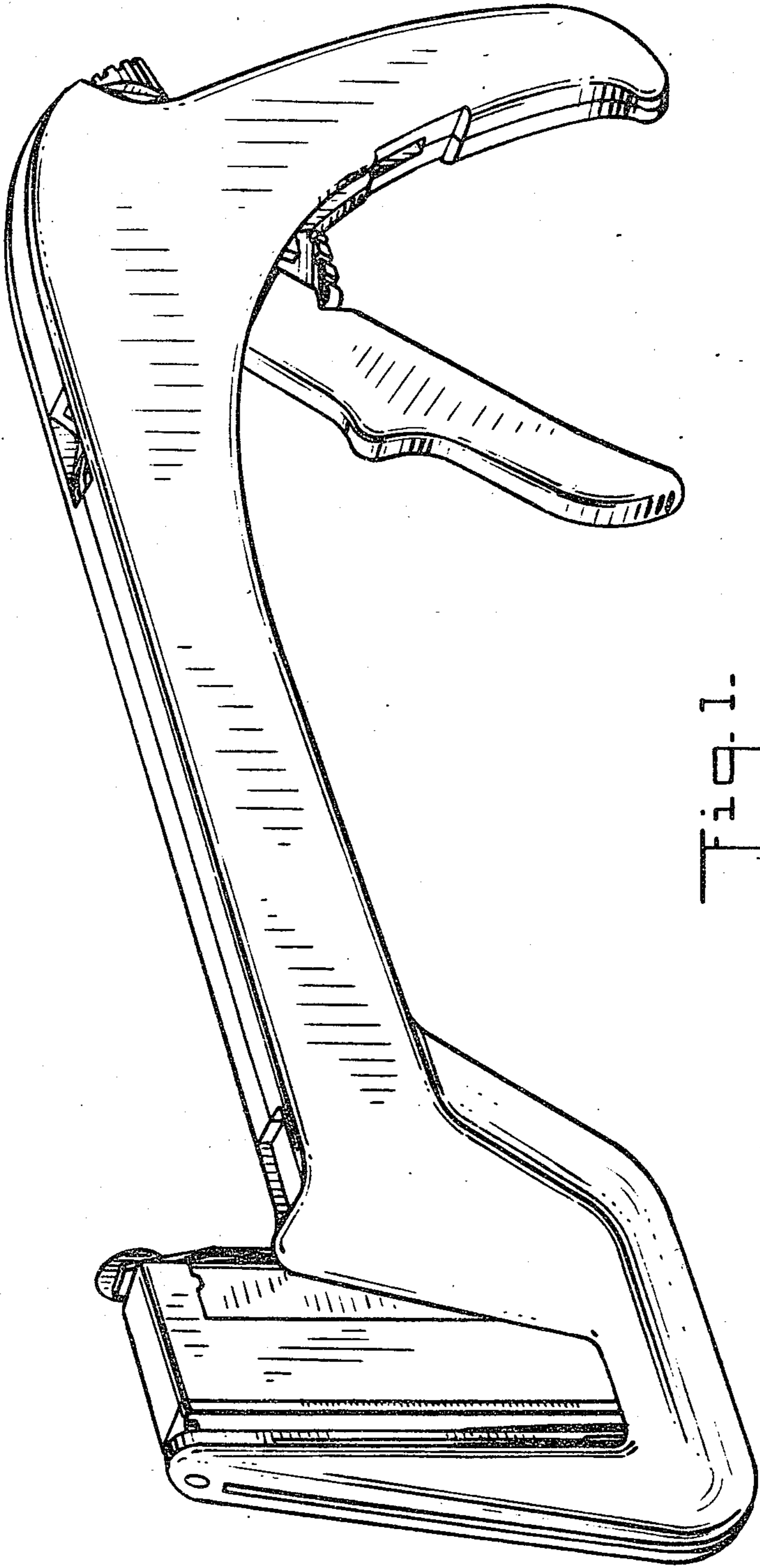

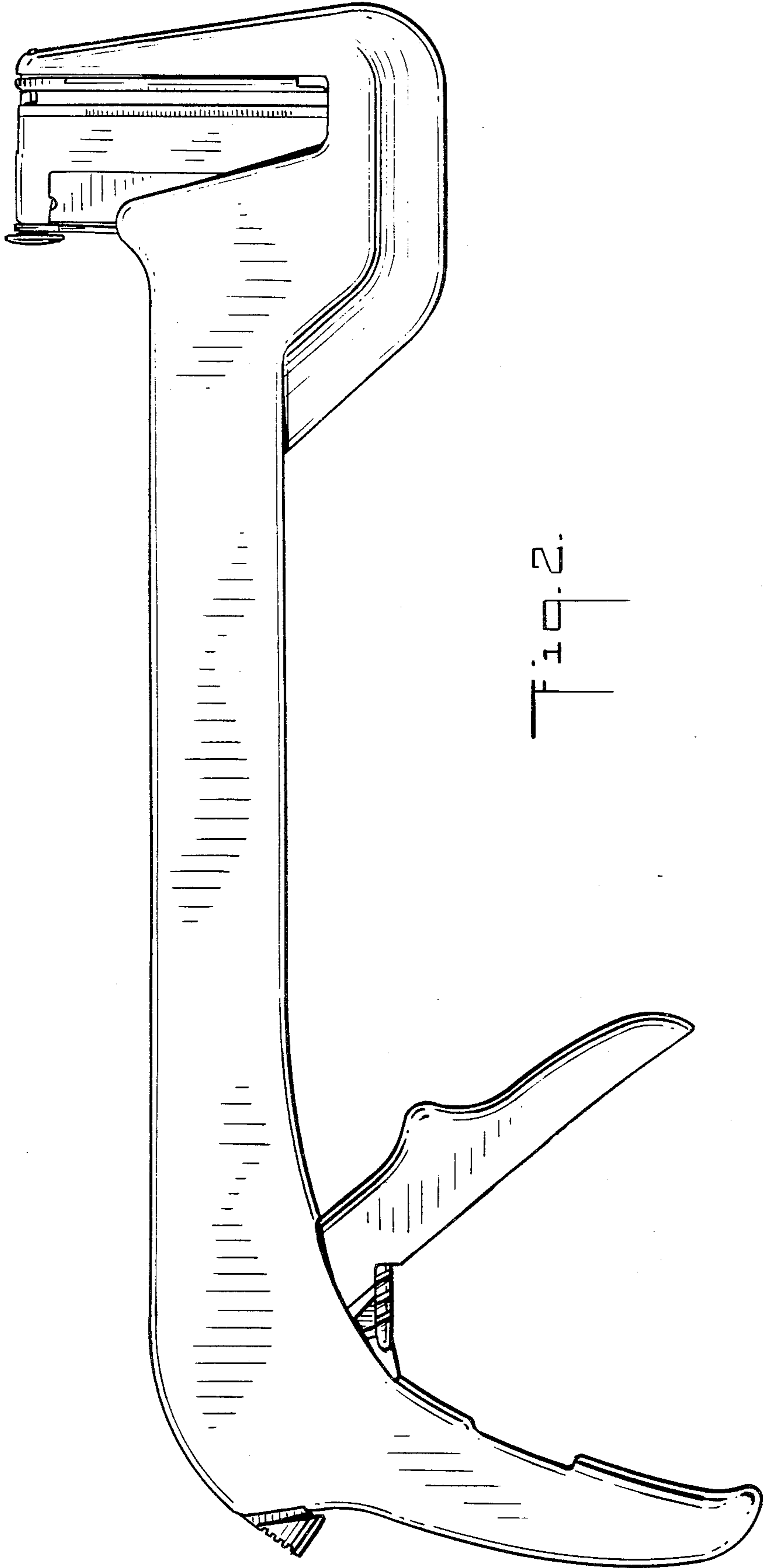

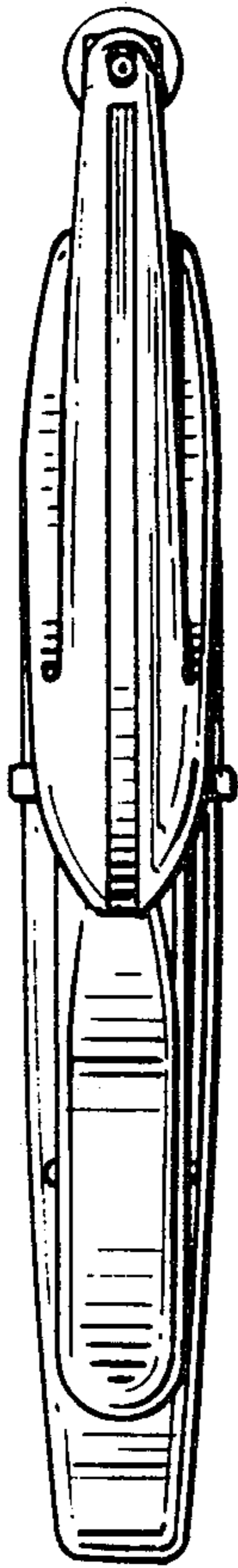

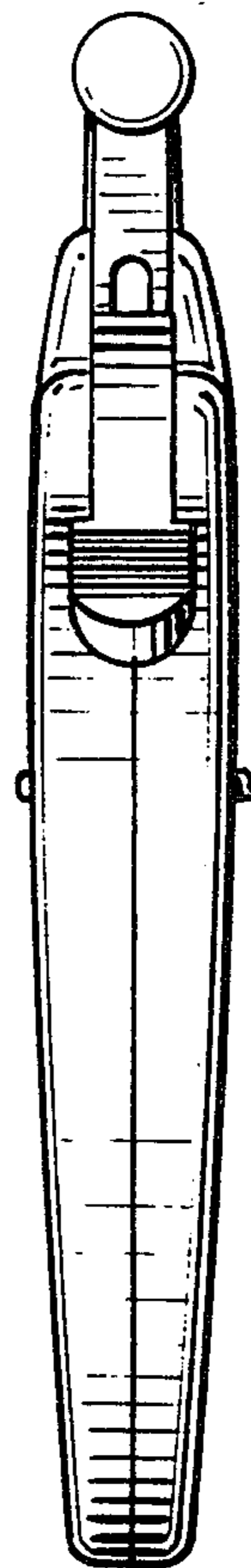

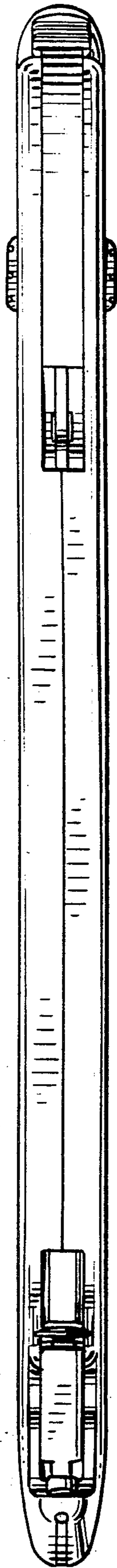
