[57] CLAIM

The ornamental design for a travel iron, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right-side perspective view of a travel iron showing my new design, the handle being in its upright position;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a right-side elevational view thereof;
 FIG. 5 is a left-side elevational view thereof;
 FIG. 6 is a front elevational view thereof;
 FIG. 7 is a rear elevational view thereof;
 FIG. 8 is a front, top and right-side perspective view of the travel iron, with the handle in its folded position;
 FIG. 9 is a front elevational view of FIG. 8;
 FIG. 10 is a rear elevational view of FIG. 8;
 FIG. 11 is a left-side elevational view of FIG. 8;
 FIG. 12 is a top plan view of FIG. 8;
 FIG. 13 is a bottom plan view of FIG. 8; and
 FIG. 14 is a right-side elevational view of FIG. 8.

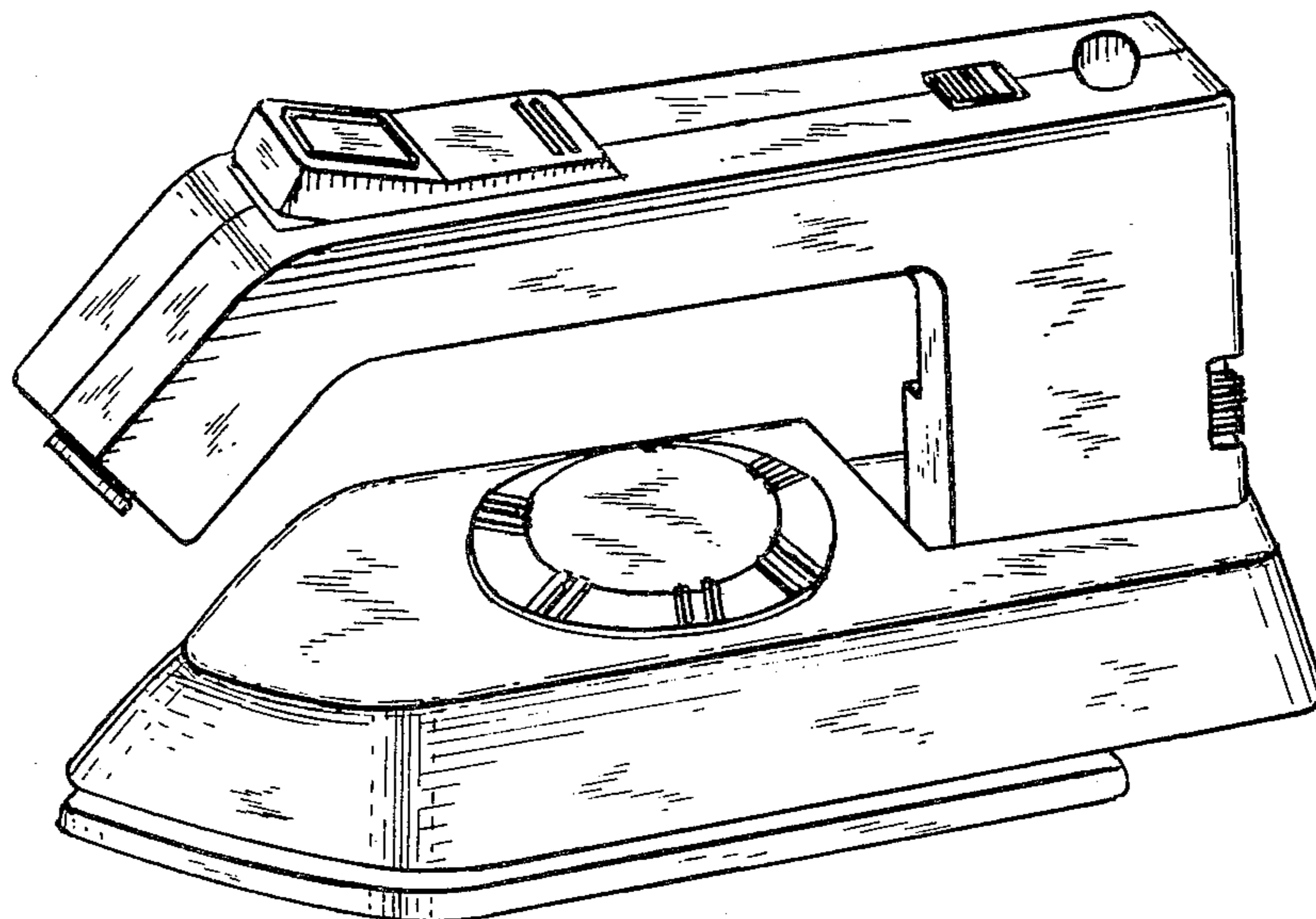

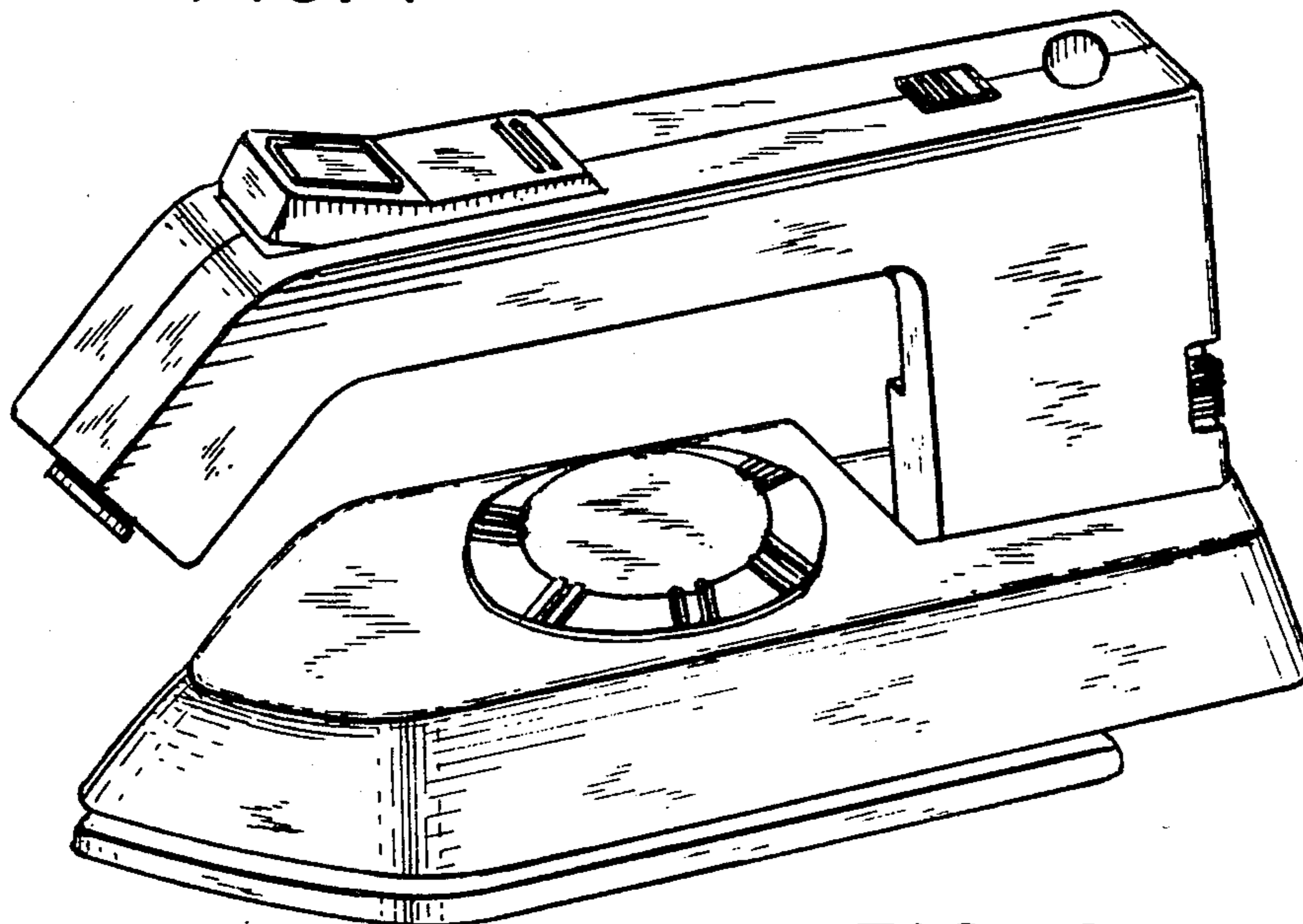

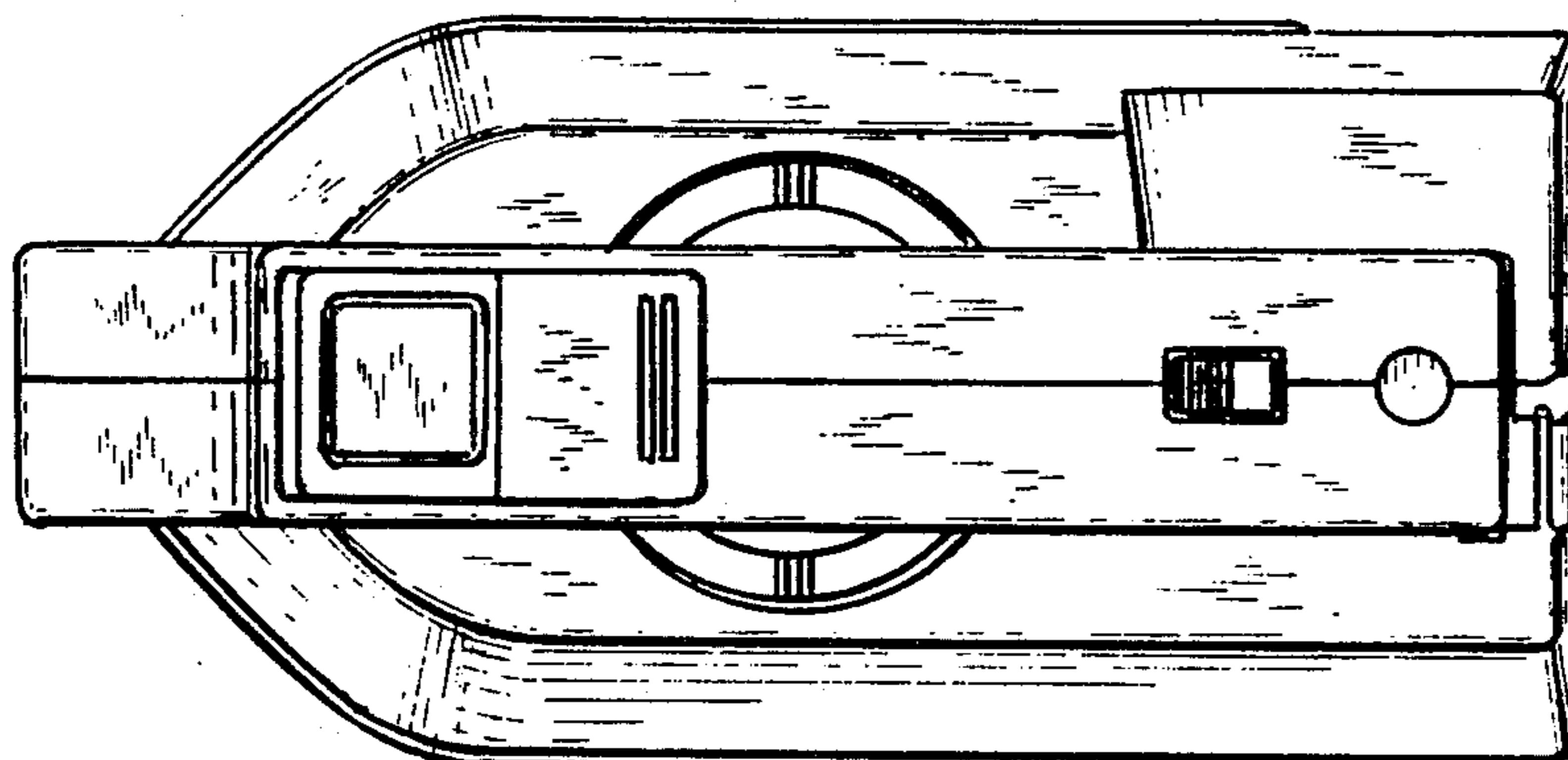

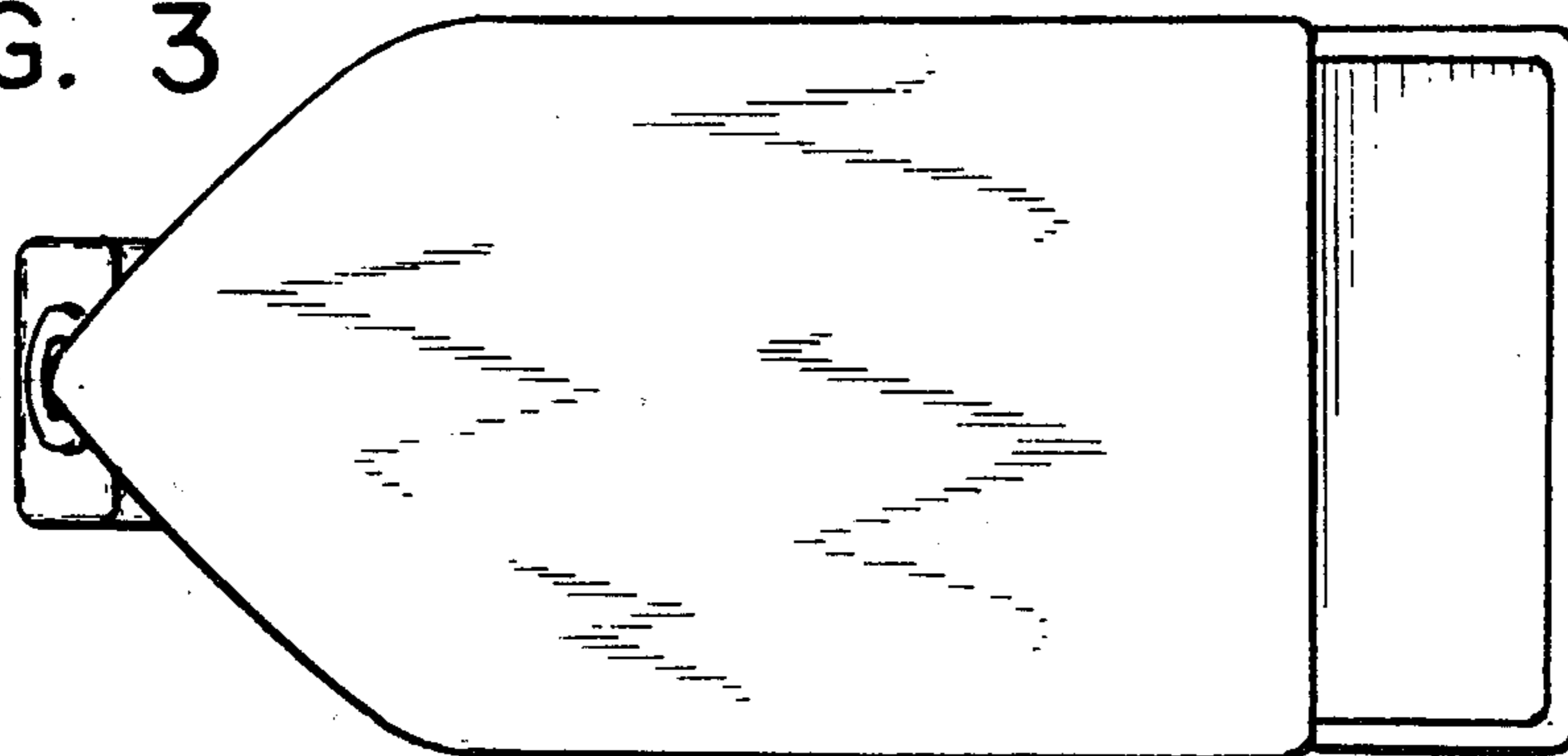

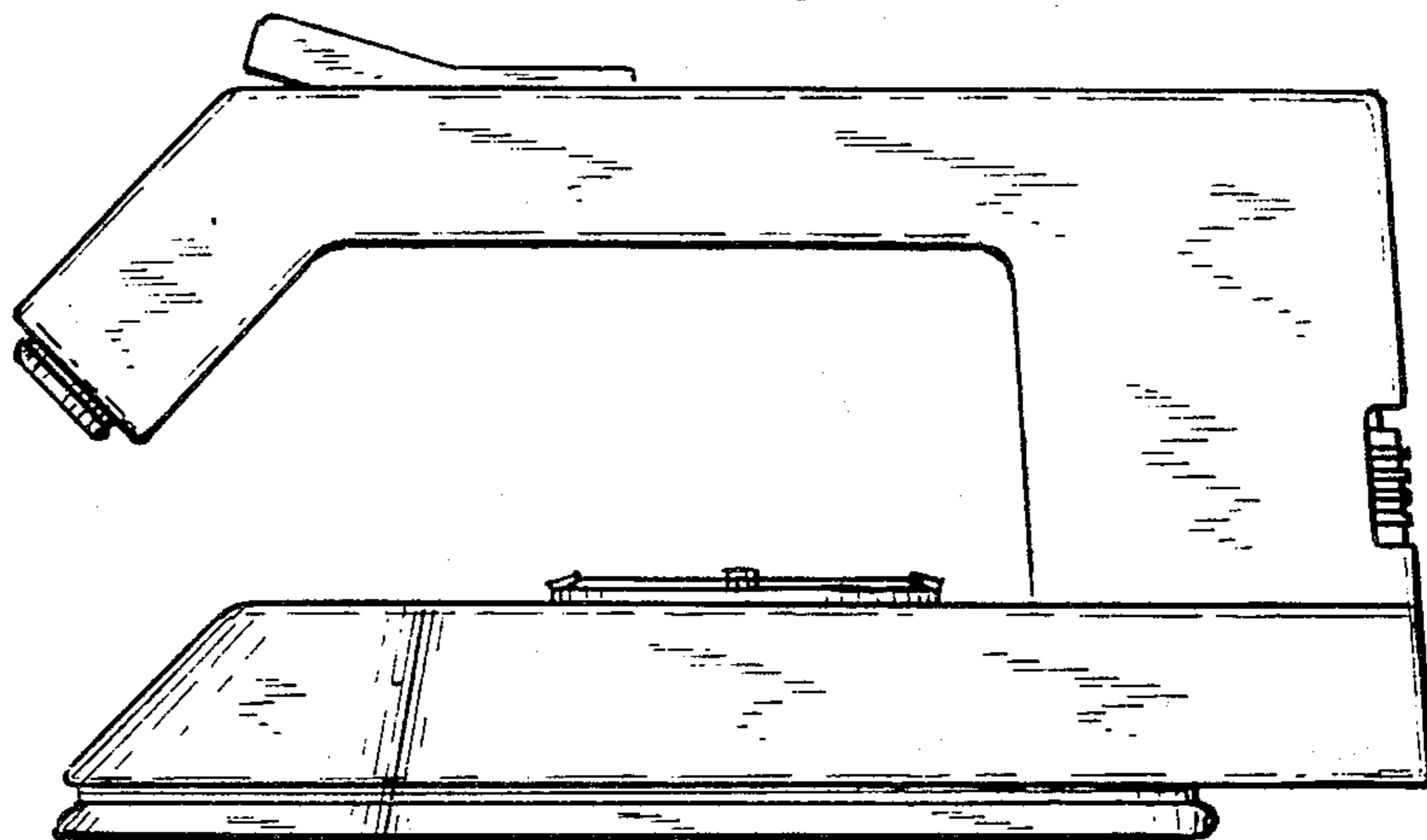

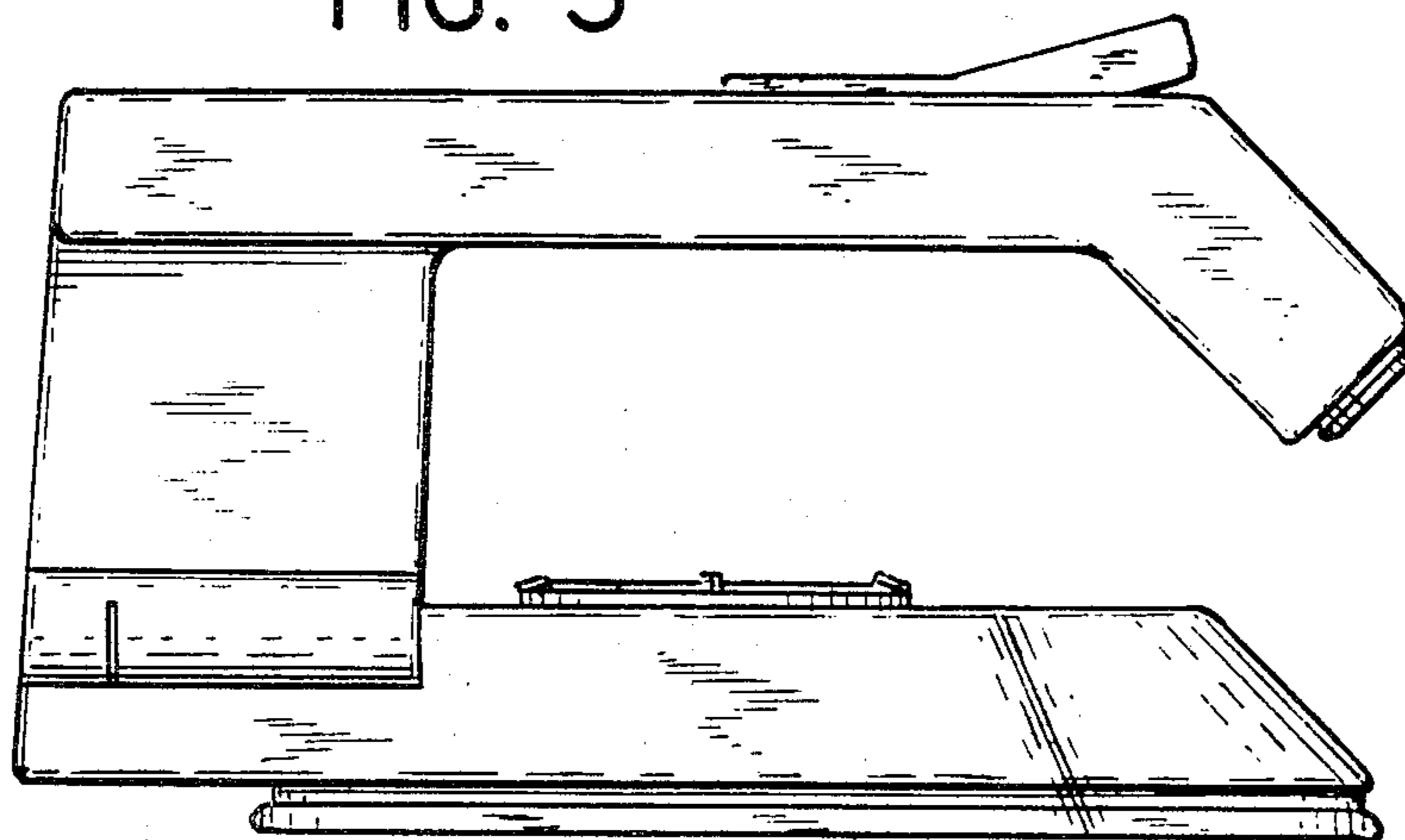

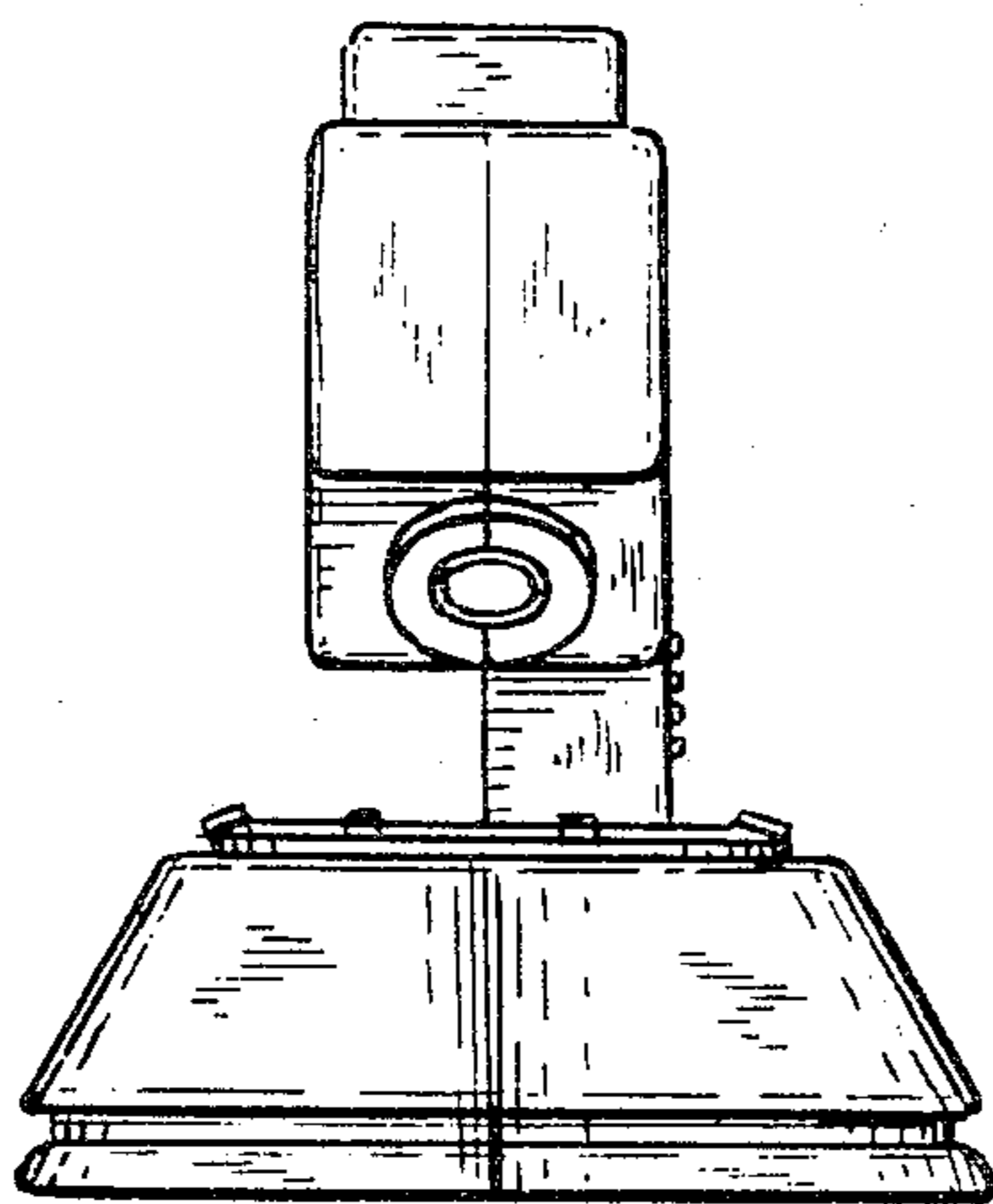

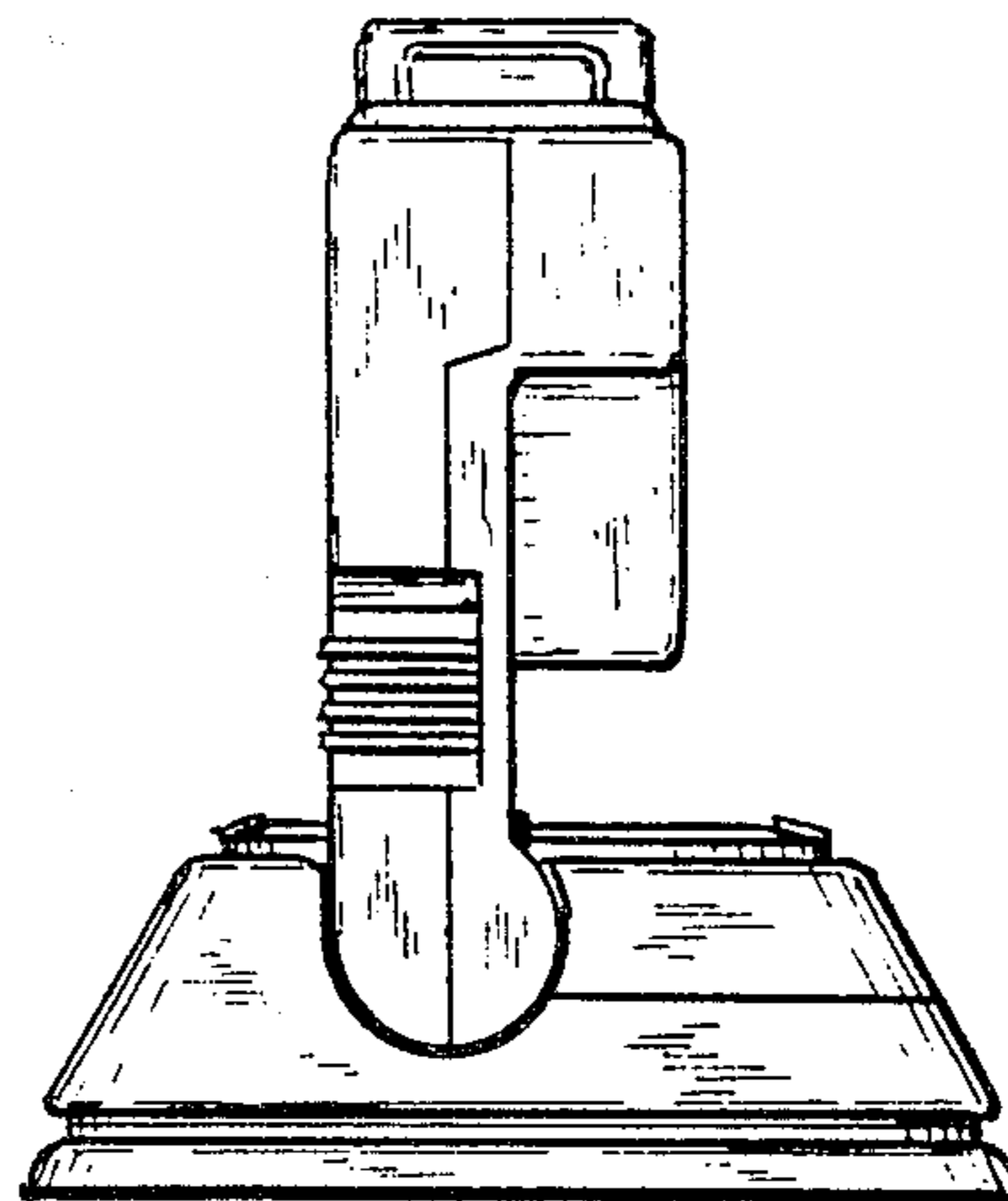

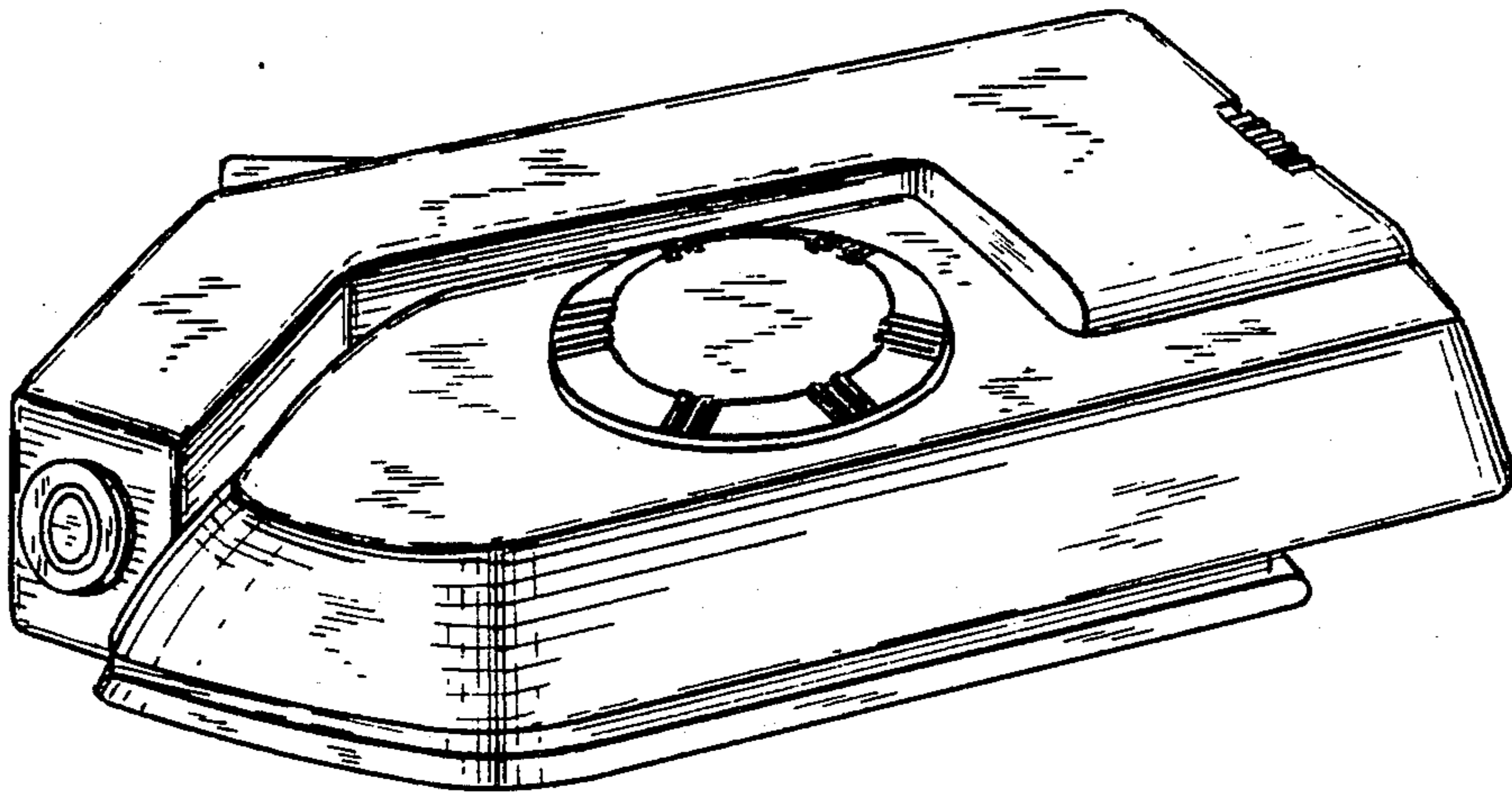

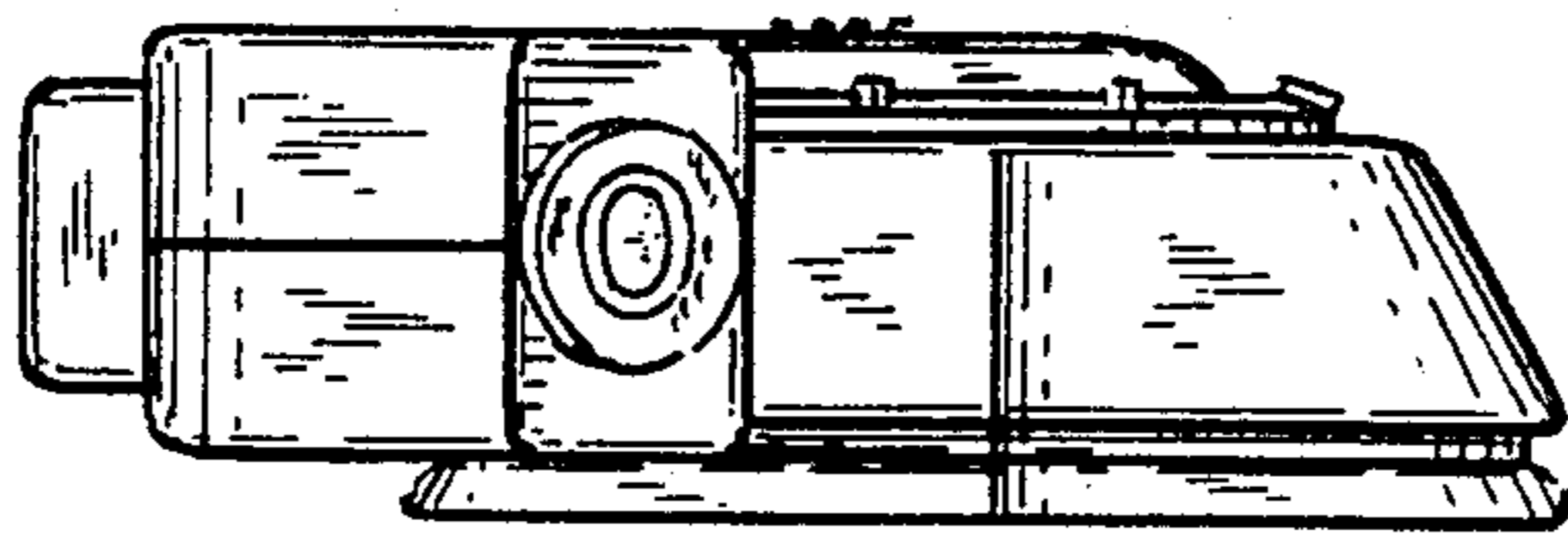

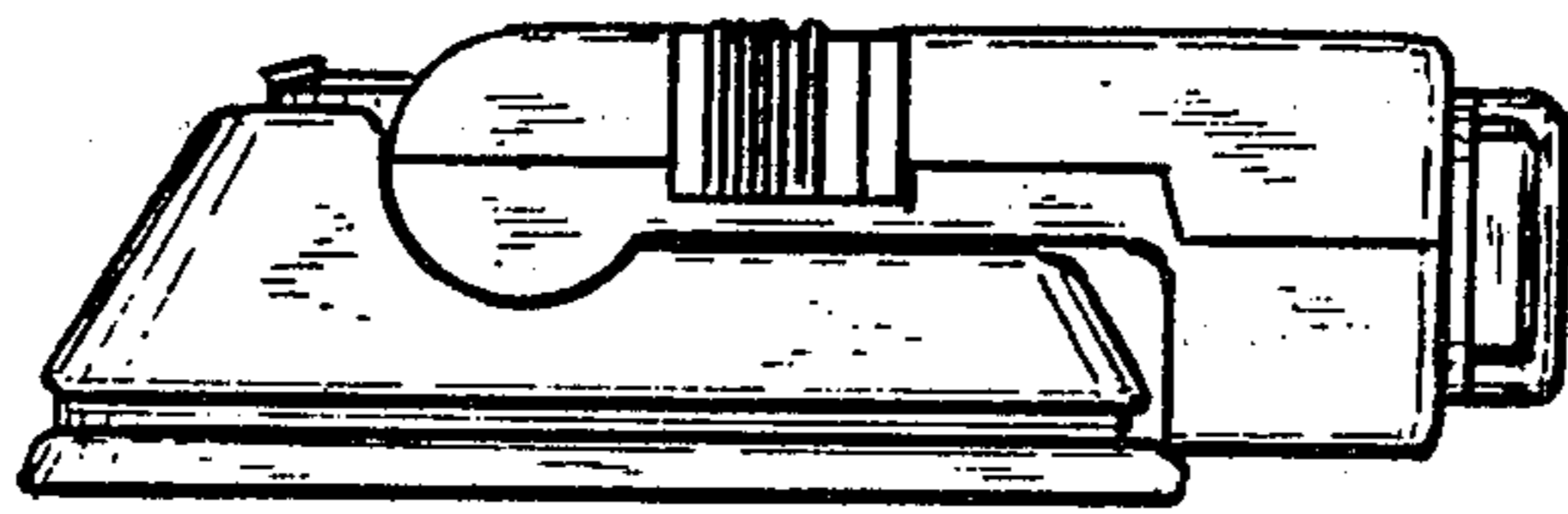

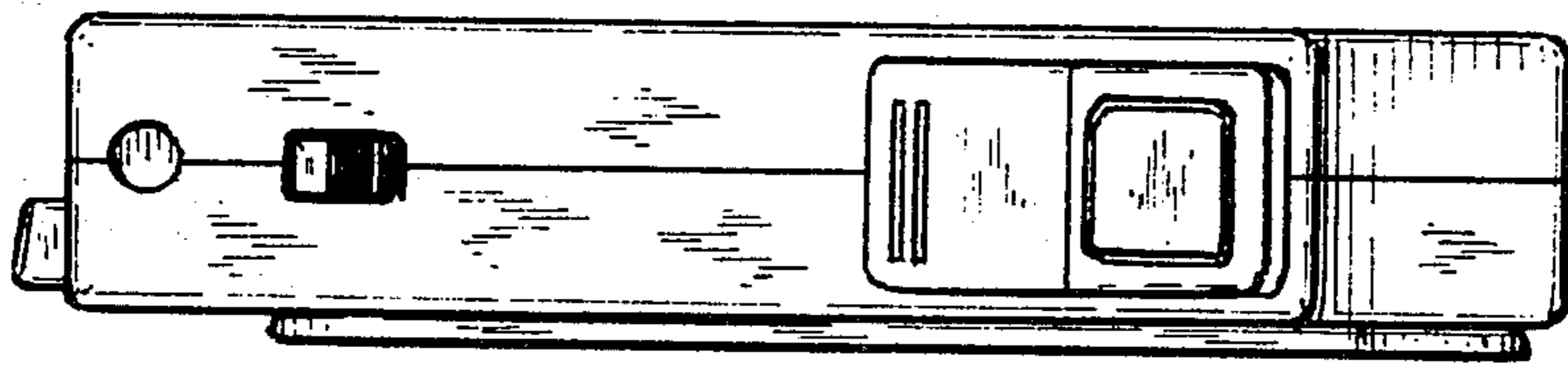

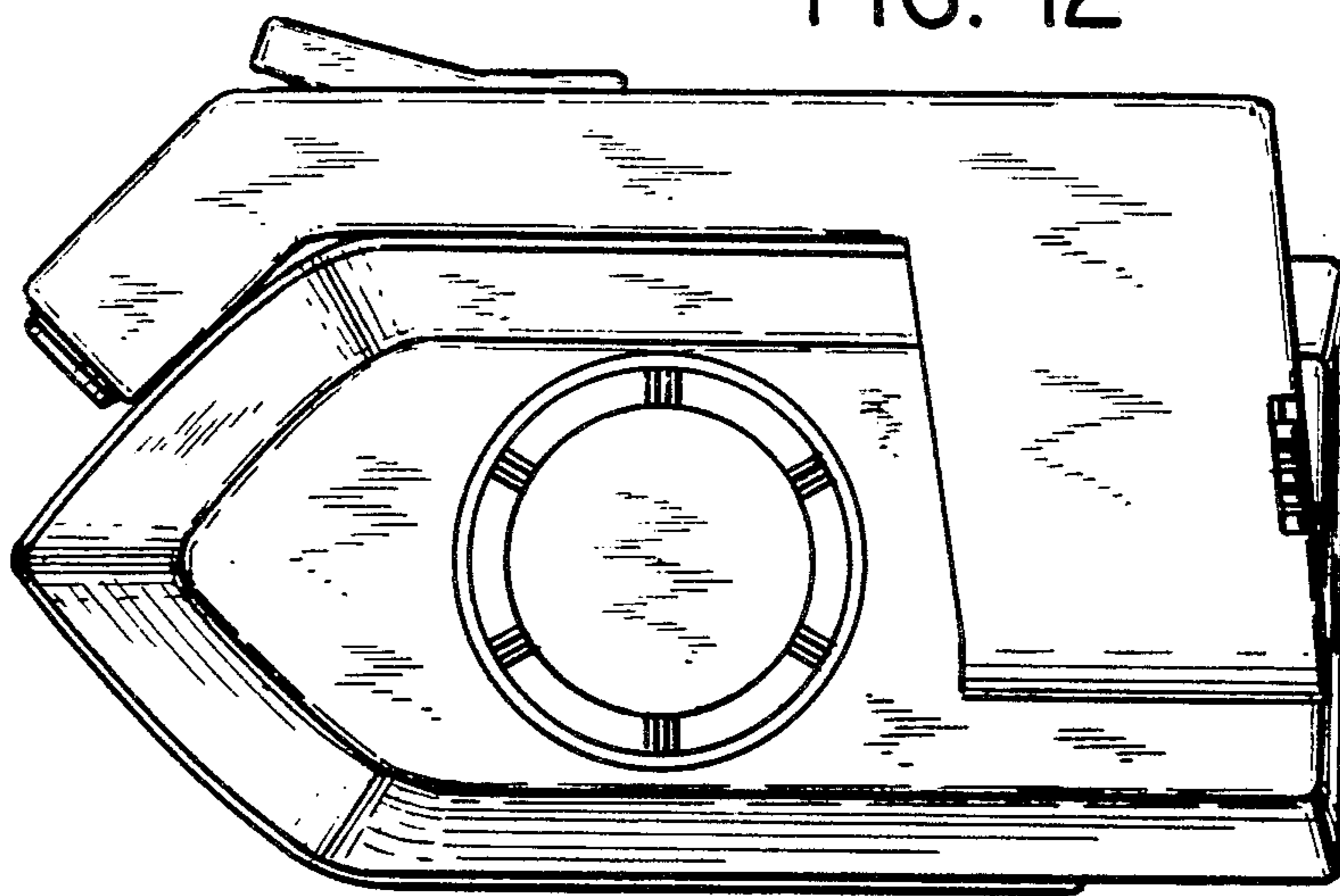

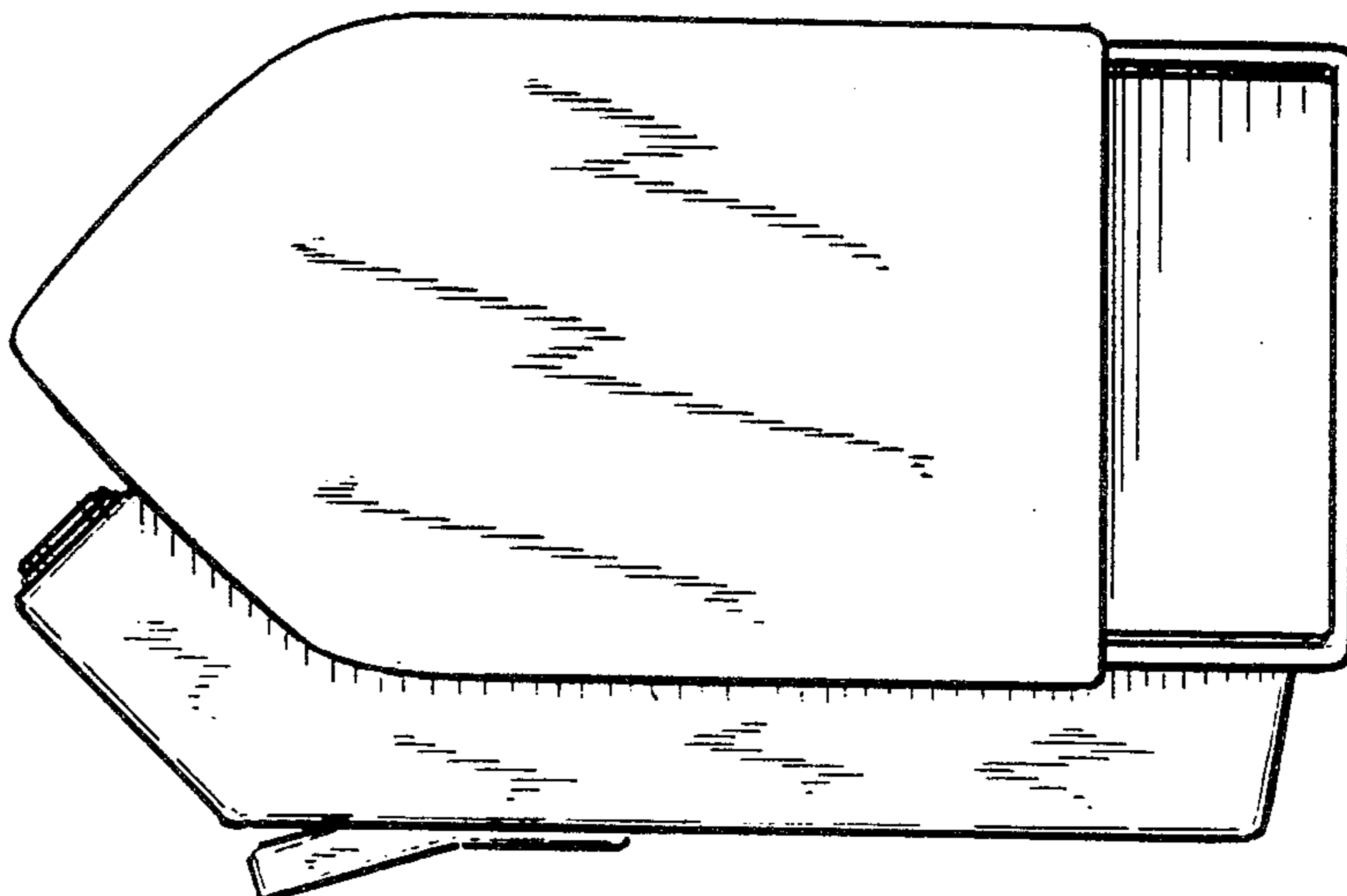
