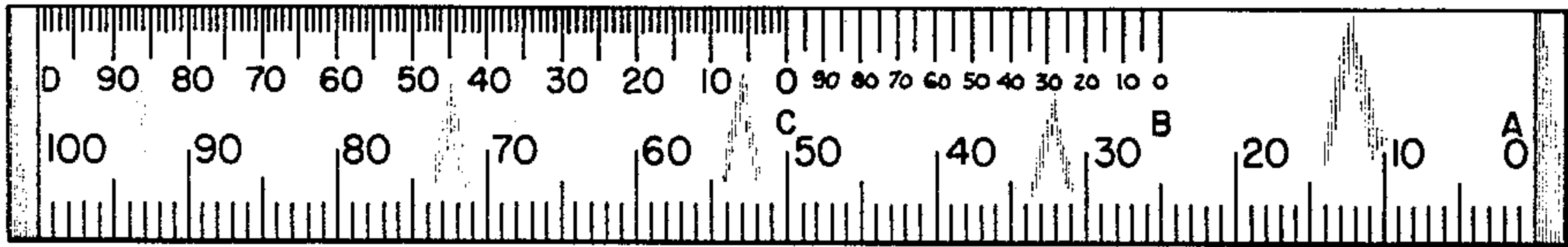

[57] CLAIM
The ornamental design for an expansible proportional
rule, as shown and described.

DESCRIPTION
FIG. 1 is a top plan view of an expansible proportional
rule showing my new design;
FIG. 2 is a front edge elevational view thereof, the

raised portions of the rear edge having been omitted for
ease of illustration;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear edge elevational view thereof, the raised
portions of the front edge having been omitted for ease
of illustration;
FIG. 5 is a left end elevational view thereof;
FIG. 6 is a right end elevational view thereof;
FIG. 7 is a top plan view of another embodiment of my
new design of FIGS. 1-6;
FIG. 8 is a front edge elevational view thereof, the
raised portions of the front edge having been omitted
for ease of illustration;
FIG. 9 is a bottom plan view thereof;
FIG. 10 is a left end elevational view thereof;
FIG. 11 is right end elevational view thereof;
FIG. 12 is a top plan view of a third embodiment of my
new design of FIGS. 1-6, the bottom plan view being
identical to FIG. 3;
FIG. 13 is a typical front or rear edge elevational view
of the third and fourth embodiments of the design;
FIG. 14 is a typical left or right end elevational view of
the third and fourth embodiments of the design;
FIG. 15 is a top plan view of a fourth embodiment of
my new design of FIGS. 1-6, the bottom plan view
being flat, plain and unornamented.
FIG. 3, besides being an illustration of the reverse face
of the embodiment of the rule of FIG. 1, is also a true
visual representation of the reverse face of the rule
embodiment of FIG. 12; and
The reverse face of the embodiment of FIG. 15, which
is not shown, is blank (i.e., without graduation scales).



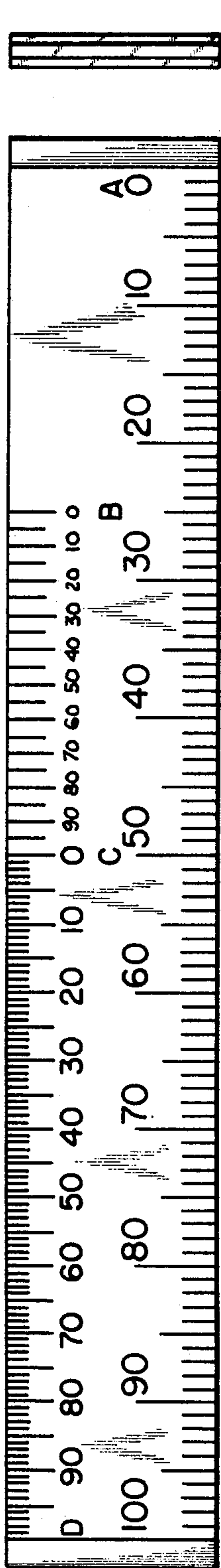

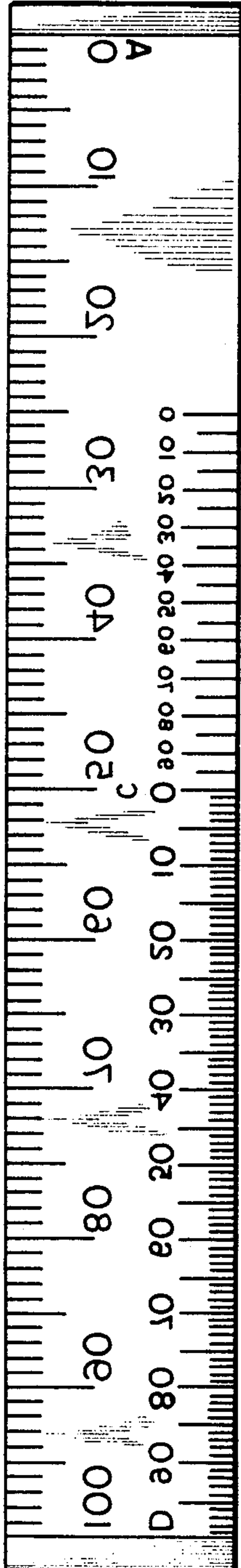

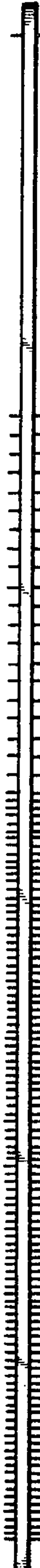

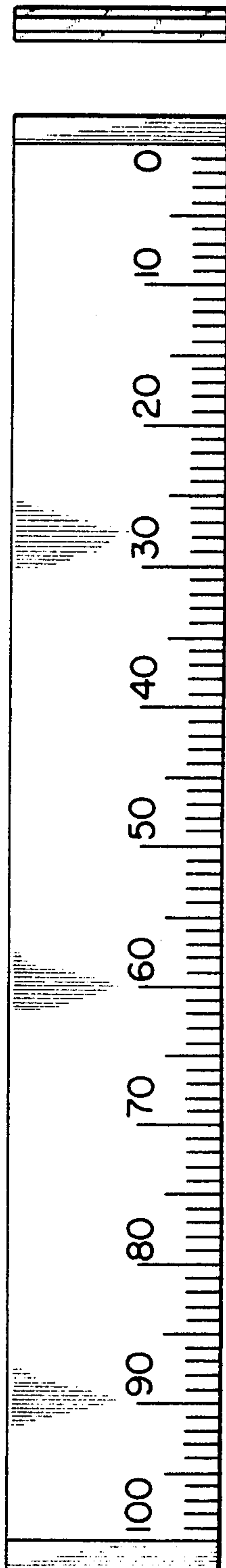

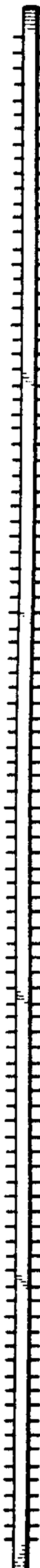

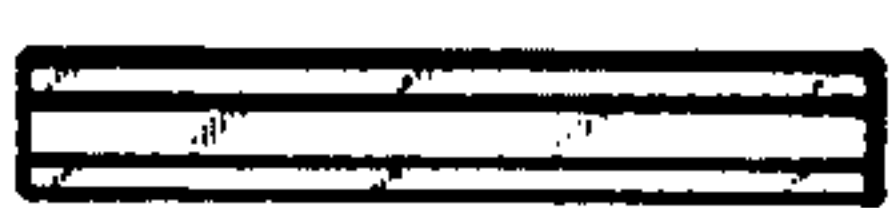

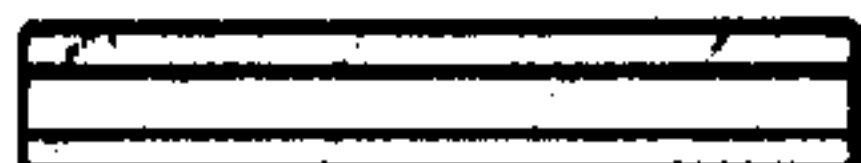

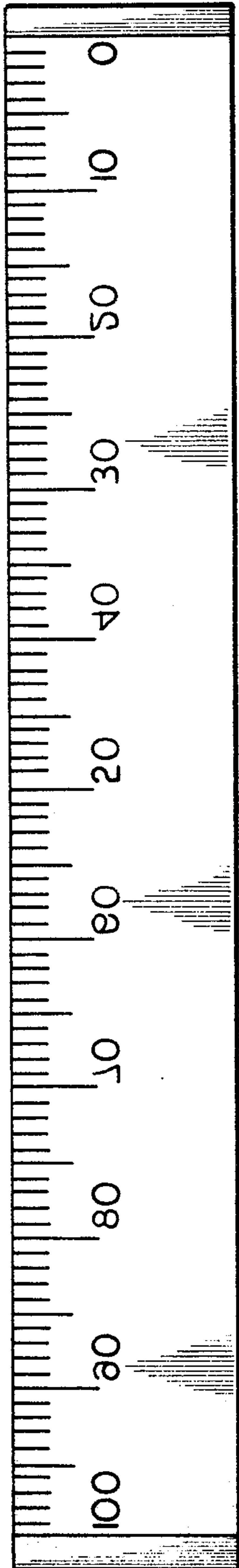

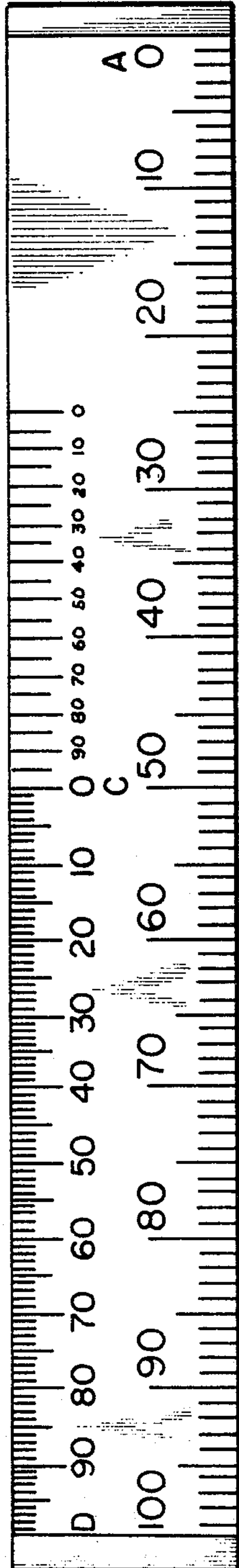

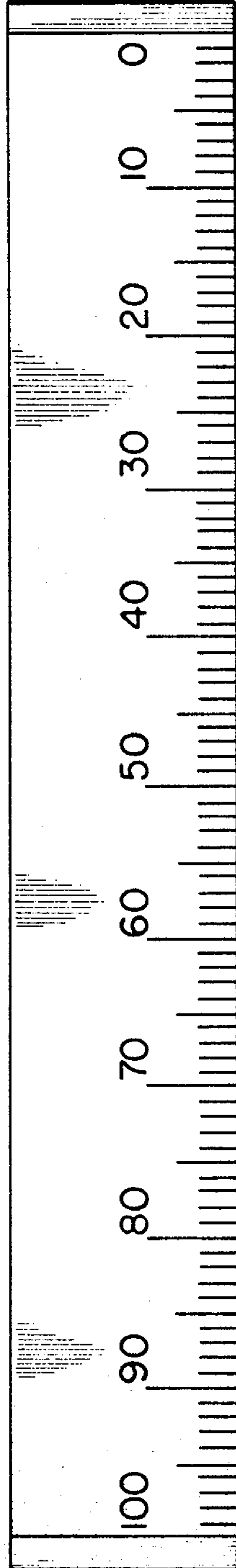
