DESCRIPTION

FIG. 1 is a right side elevational view of a sports shoe showing my new design;

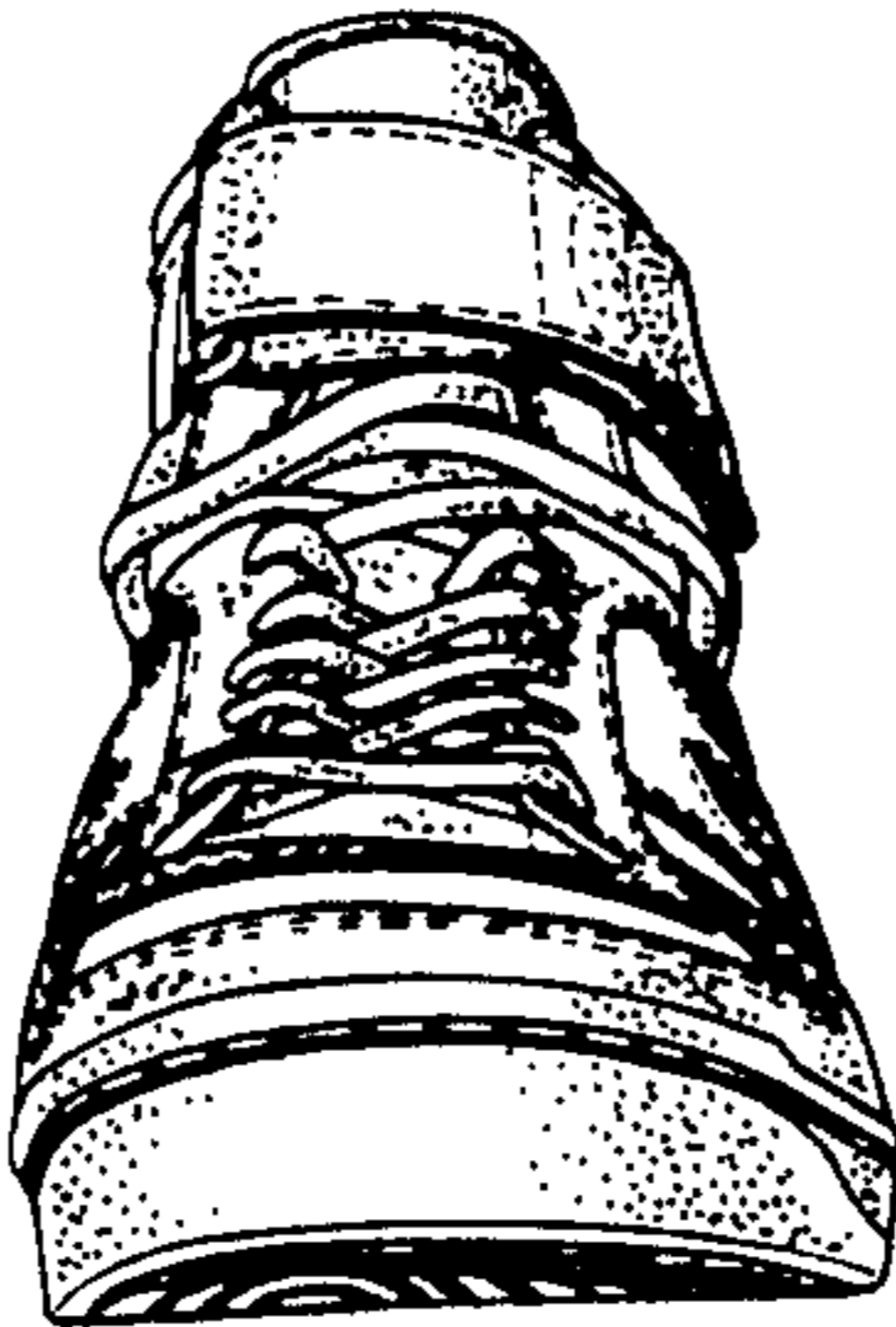

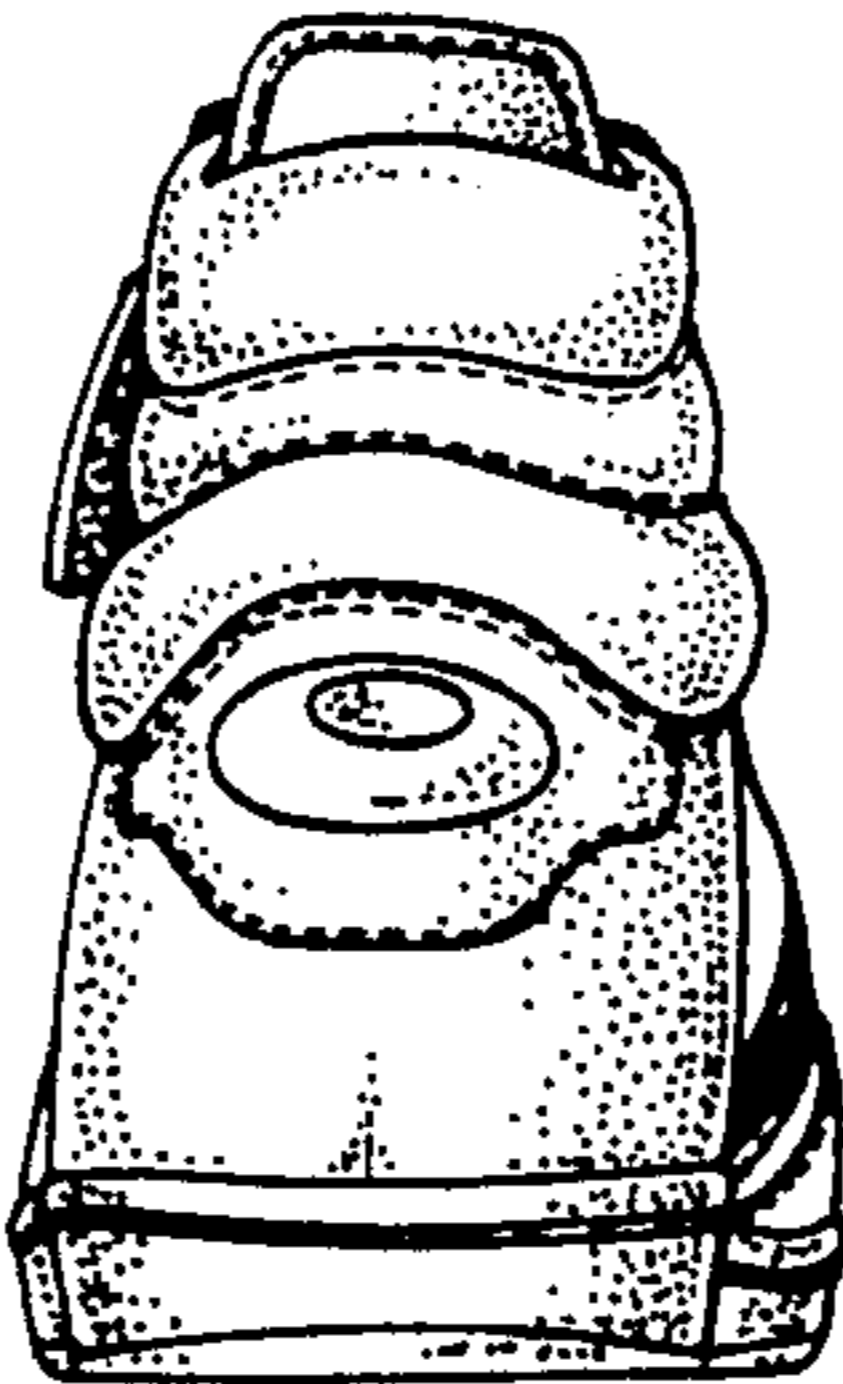

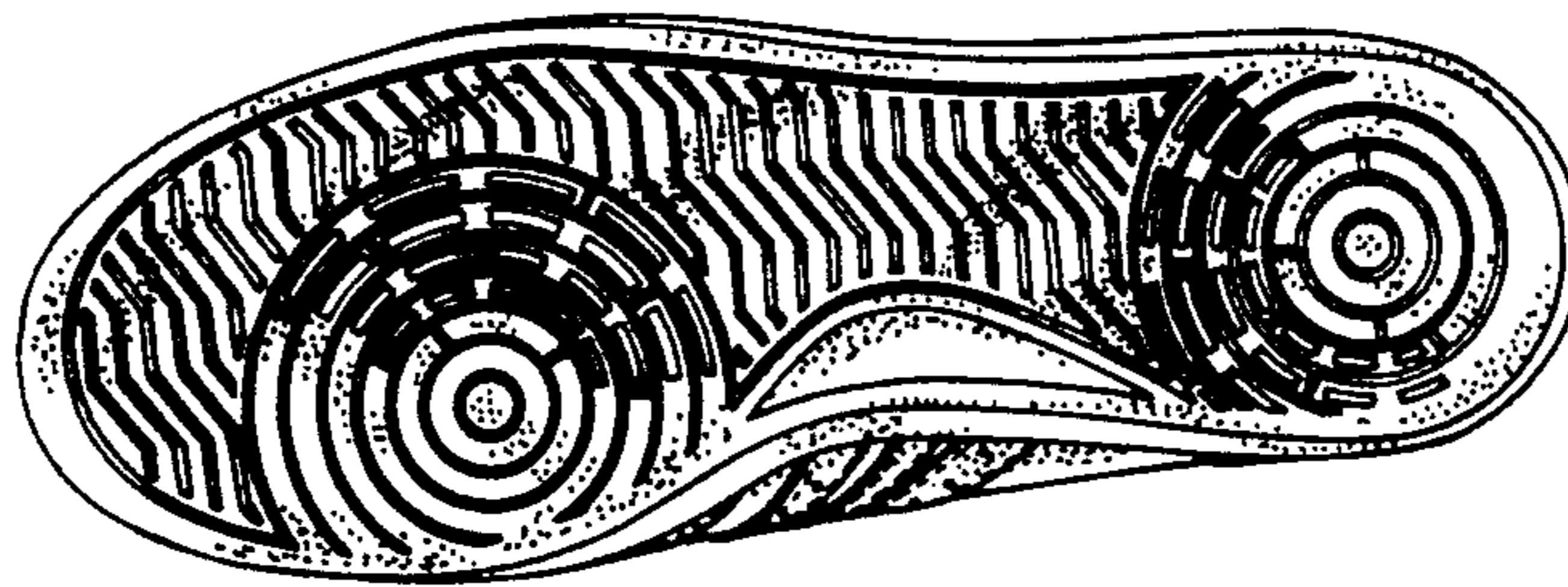
