The ornamental design for a telephone, substantially as shown.

DESCRIPTION

FIG. 1 is a front elevational view of a telephone showing our new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

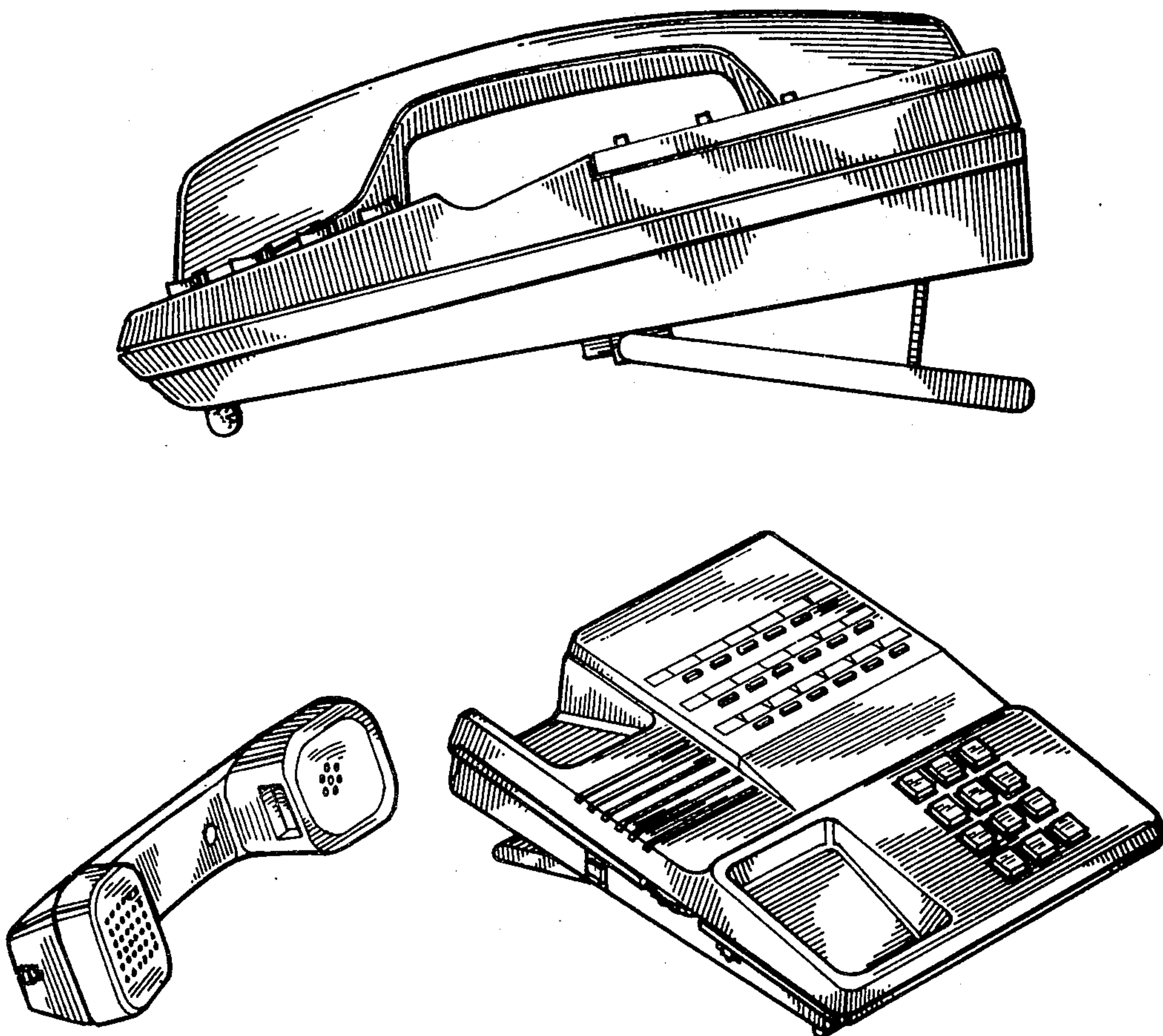
FIG. 4 is a bottom plan view thereof;

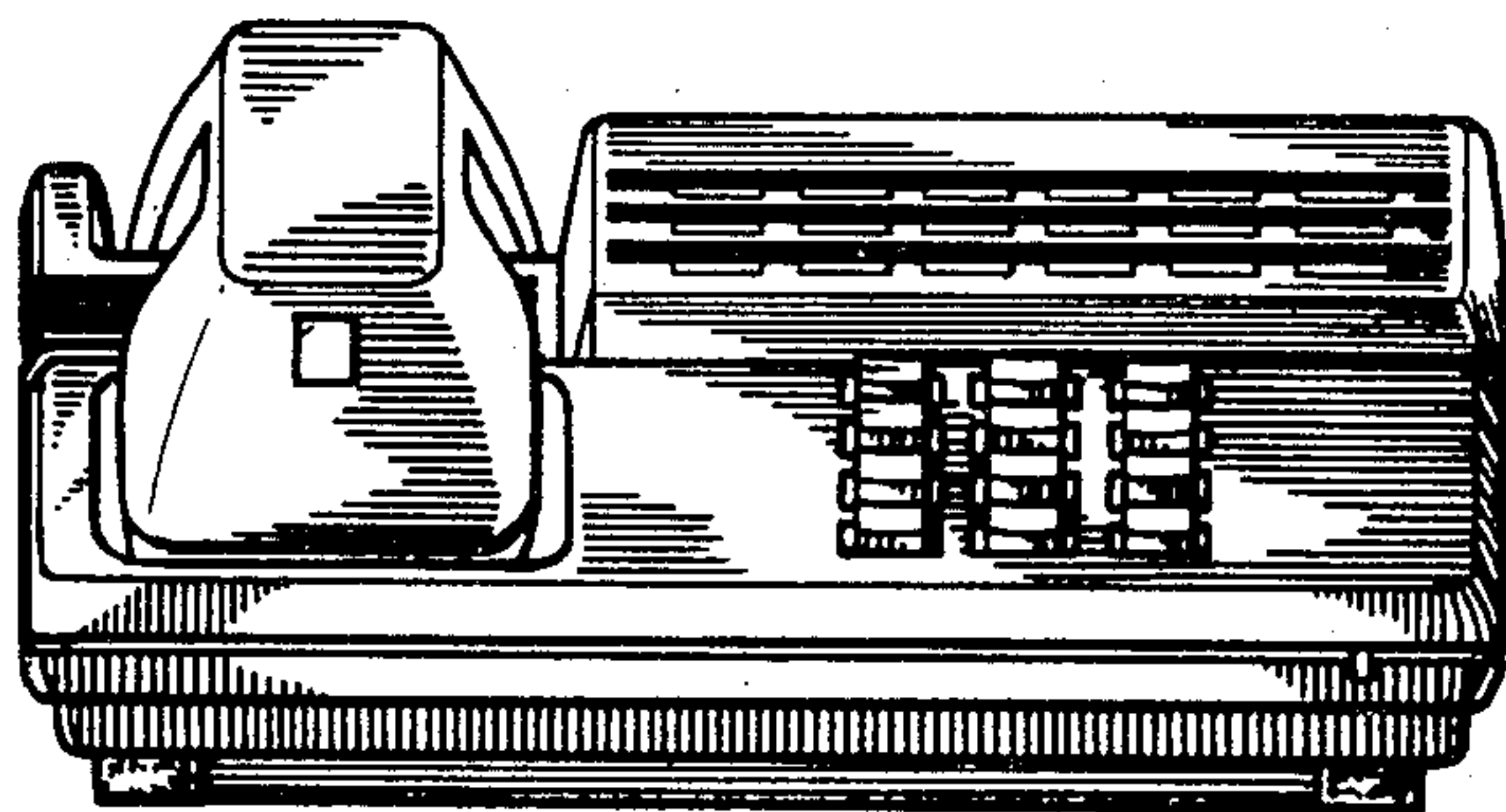

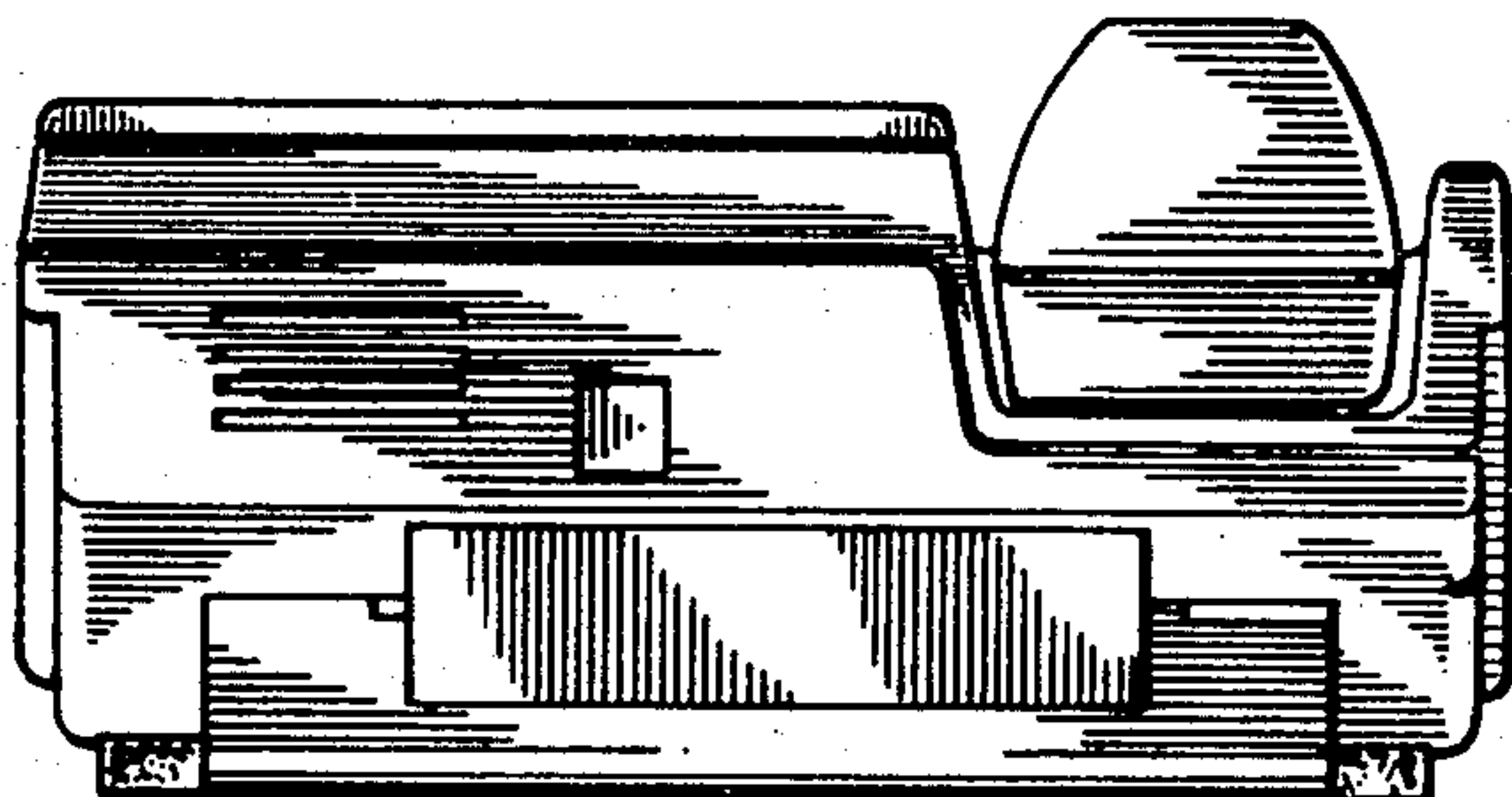

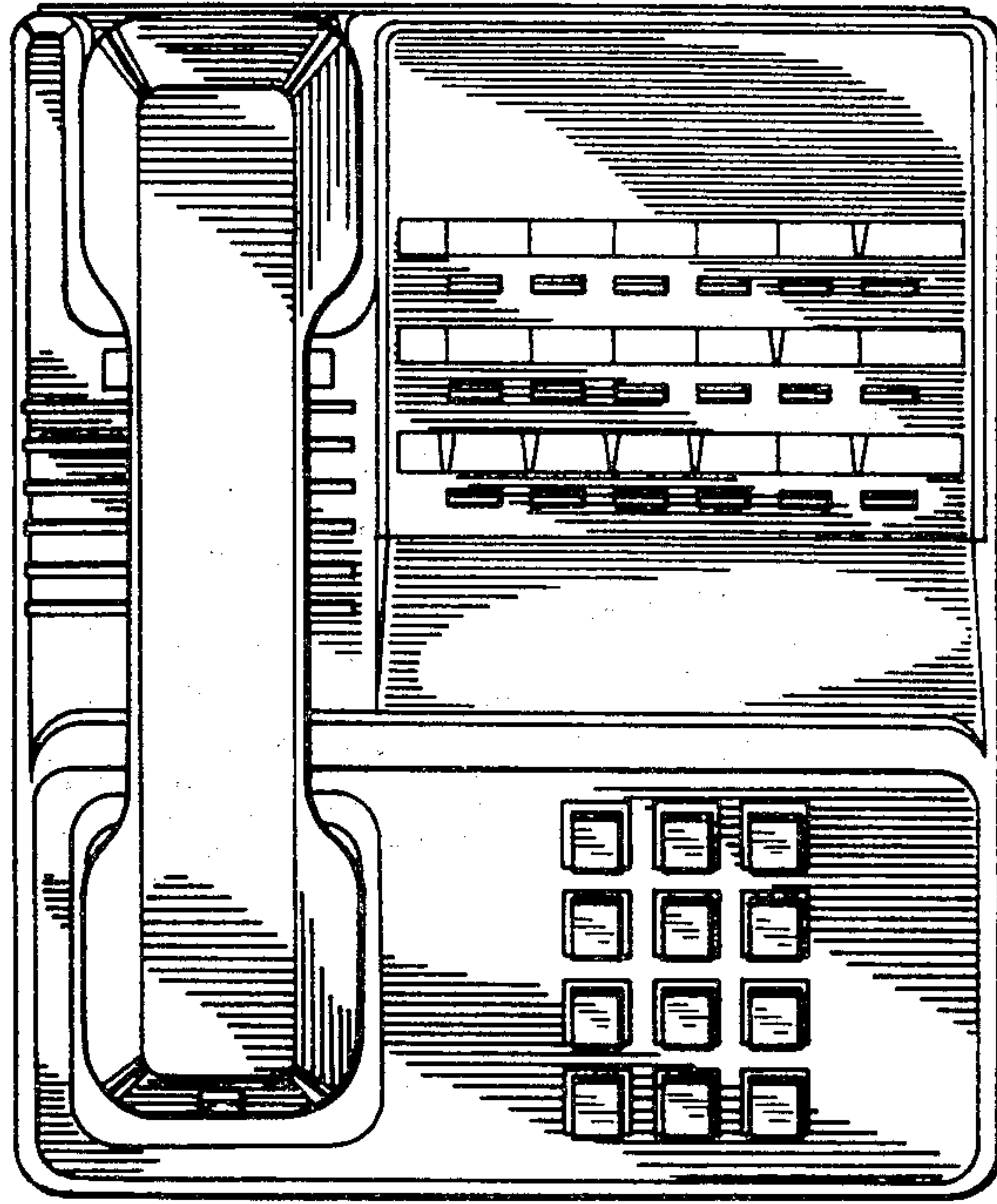

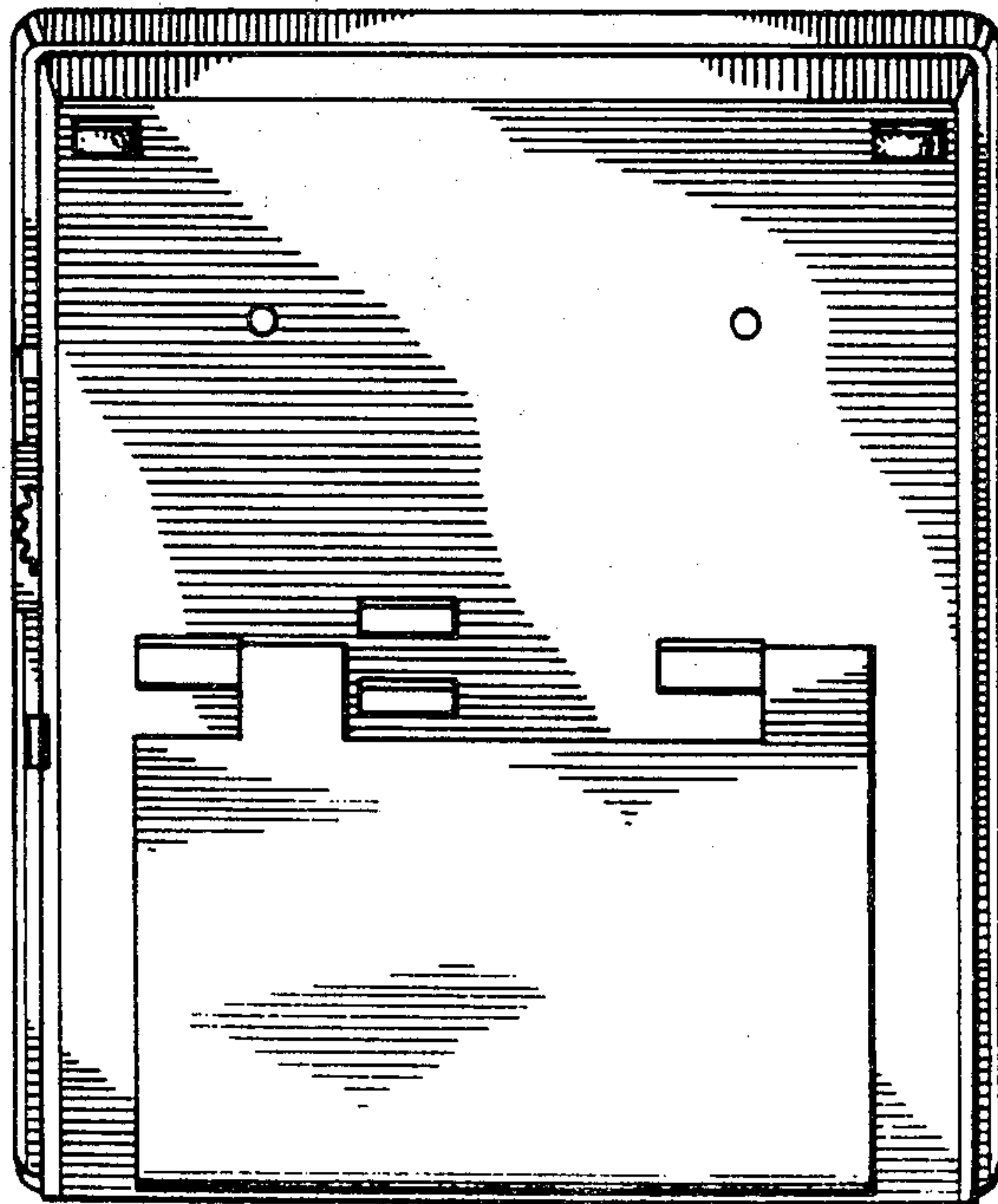

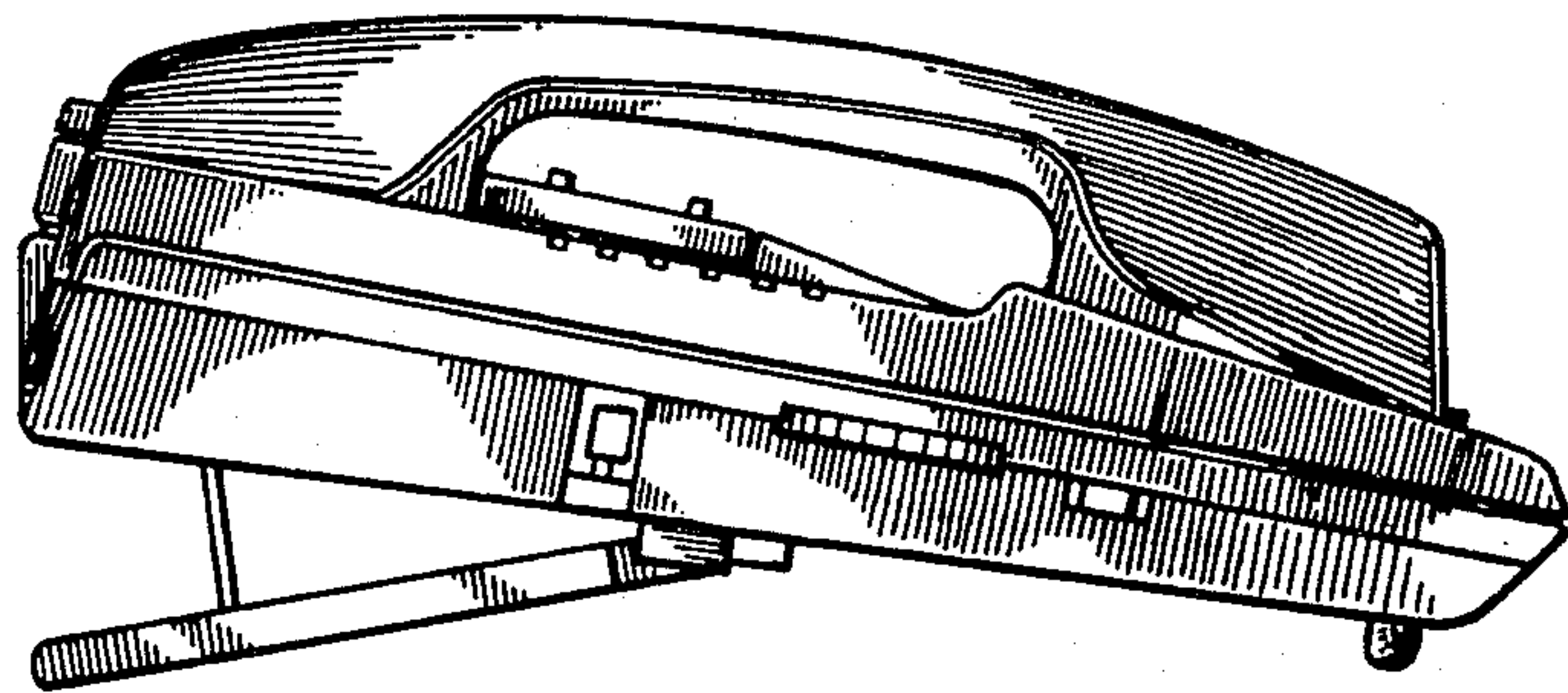

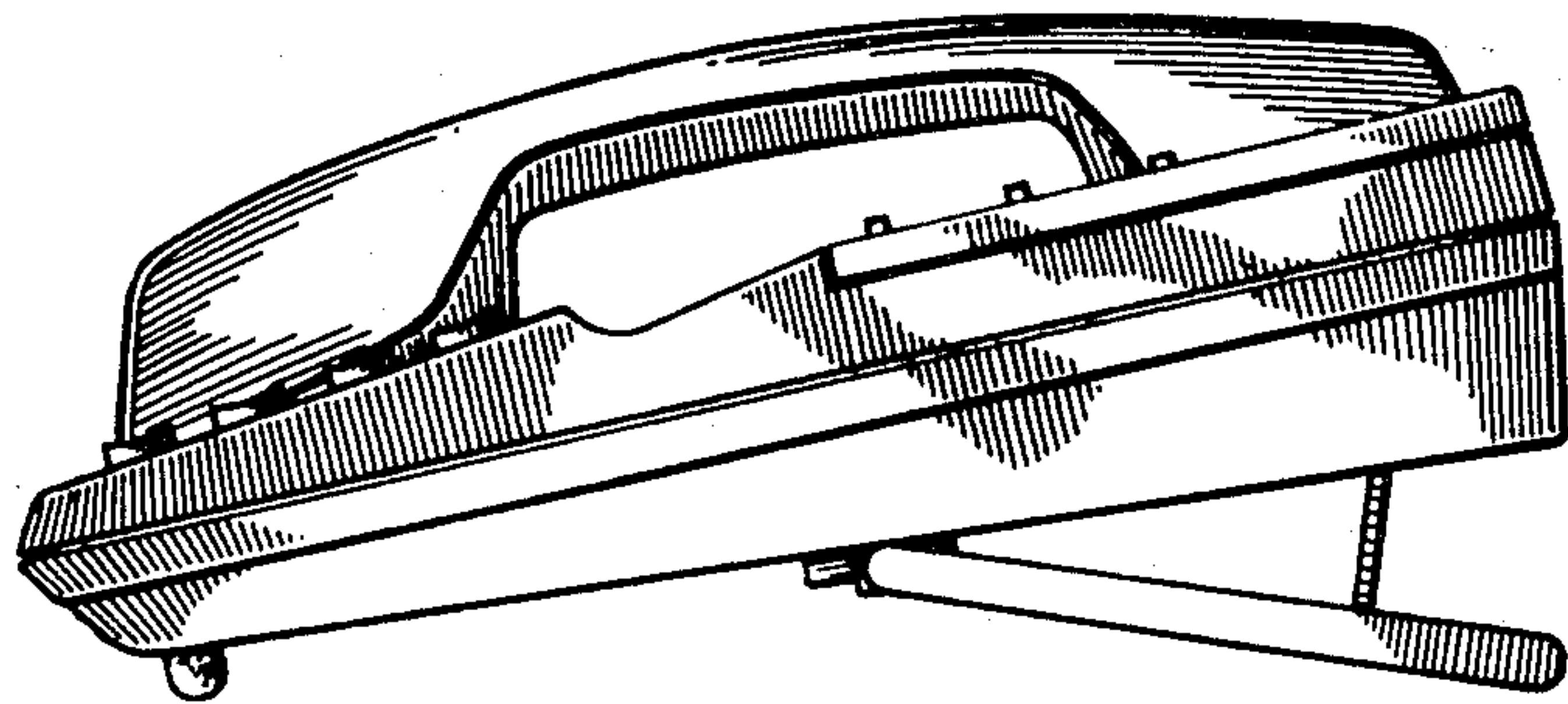

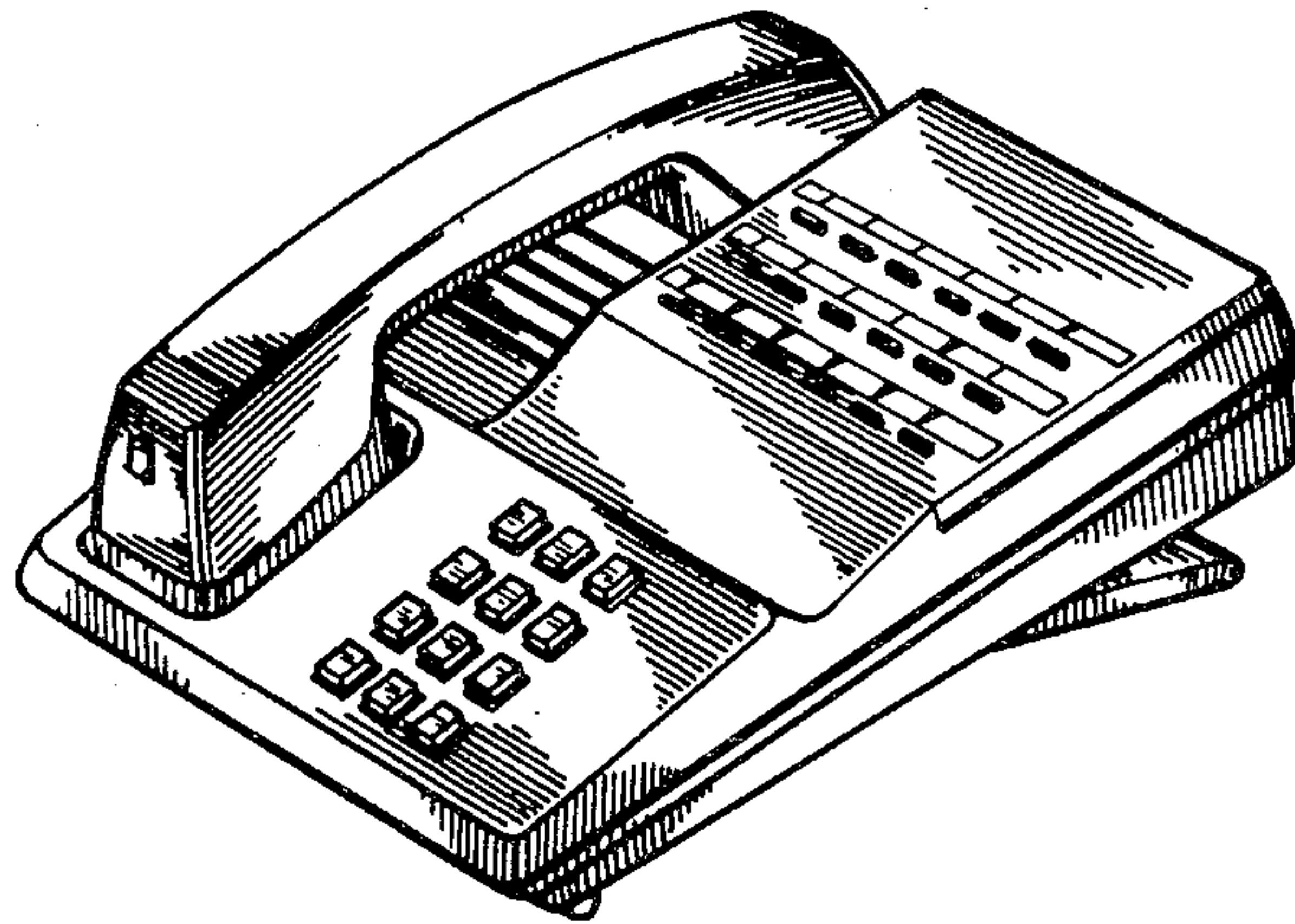

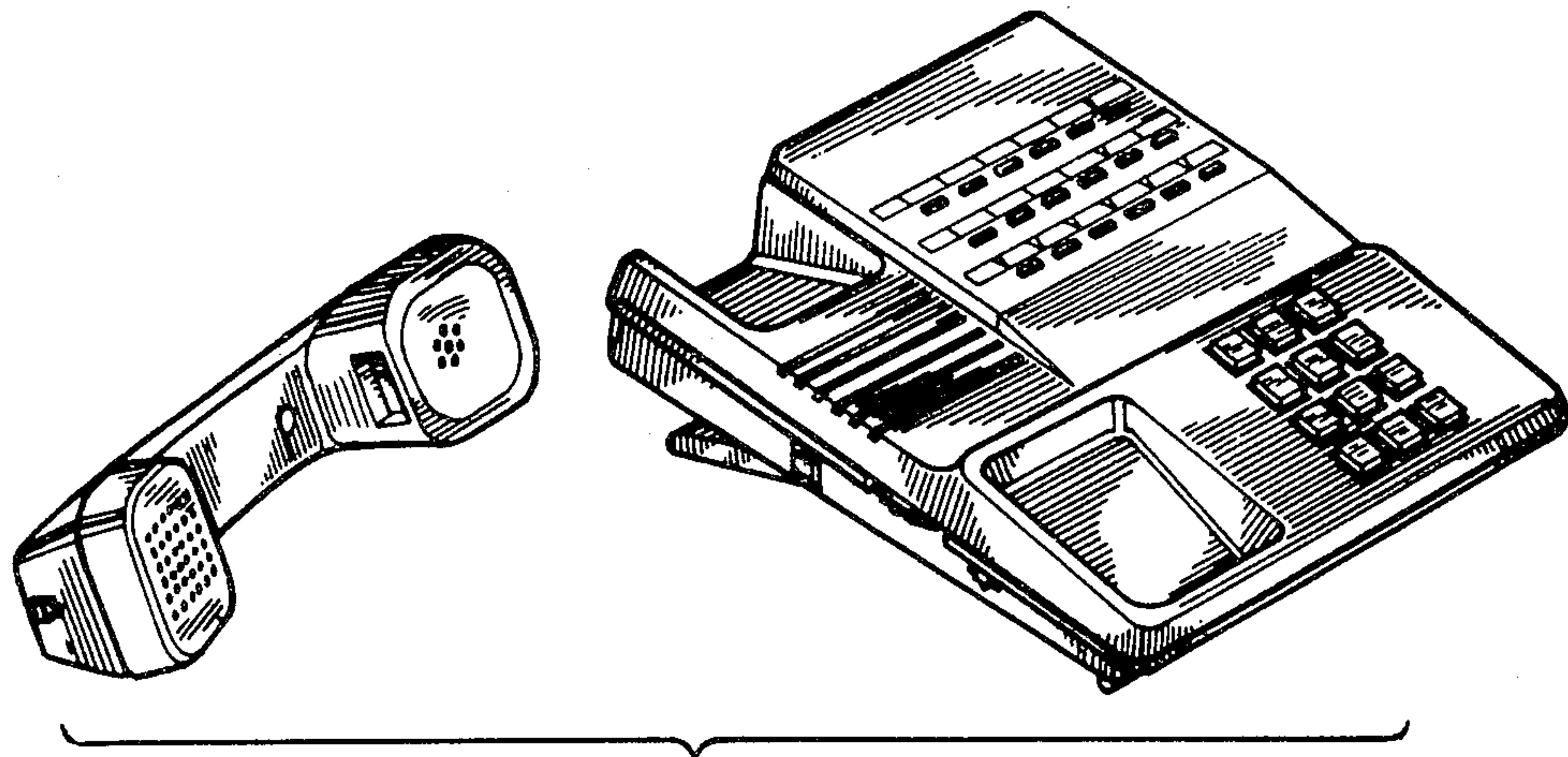
