The ornamental design for a telephone instrument, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a telephone instrument showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front, top and right side perspective view thereof; and

FIG. 8 is a top plan view thereof with the handset removed from the telephone base.

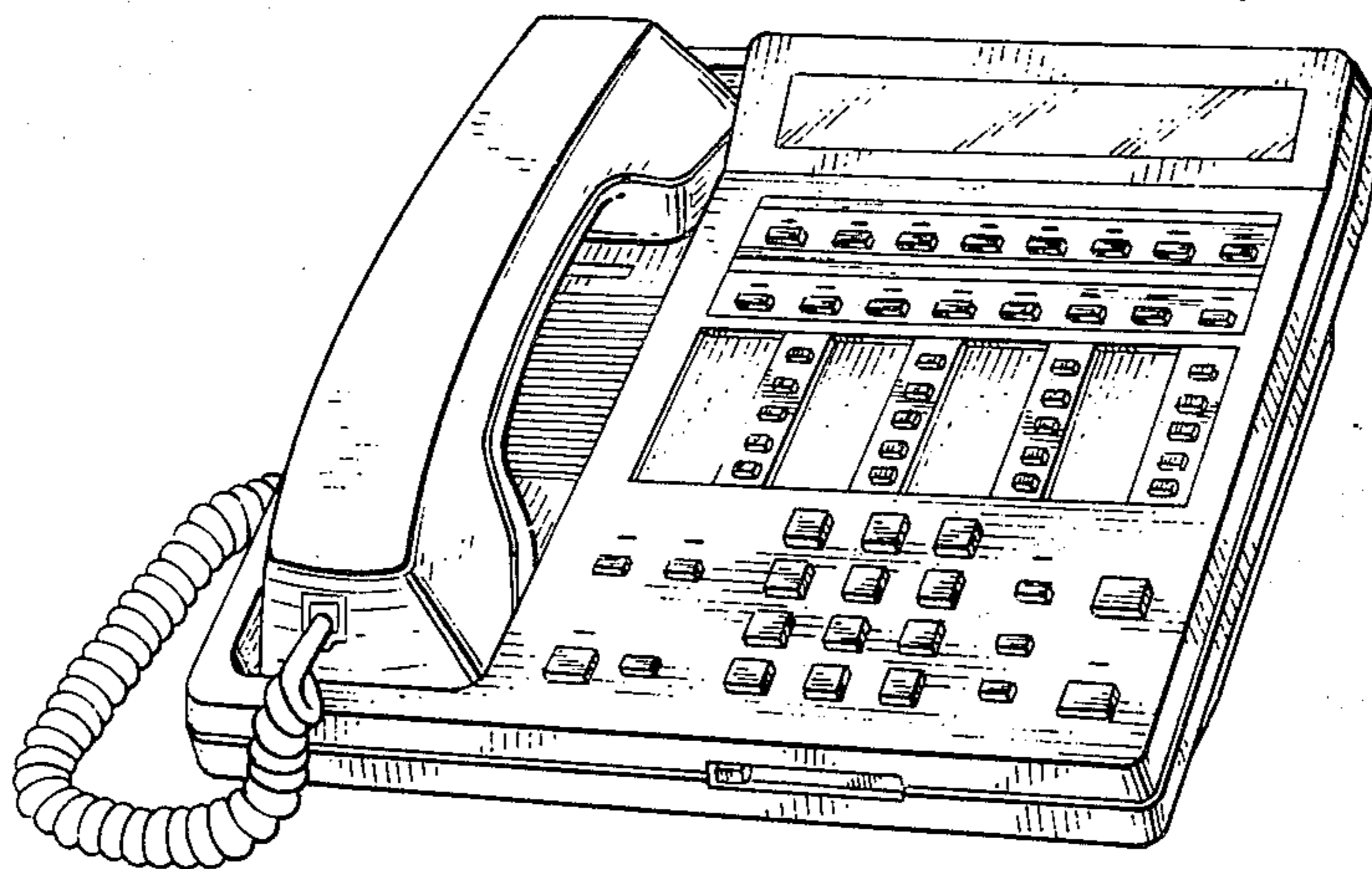
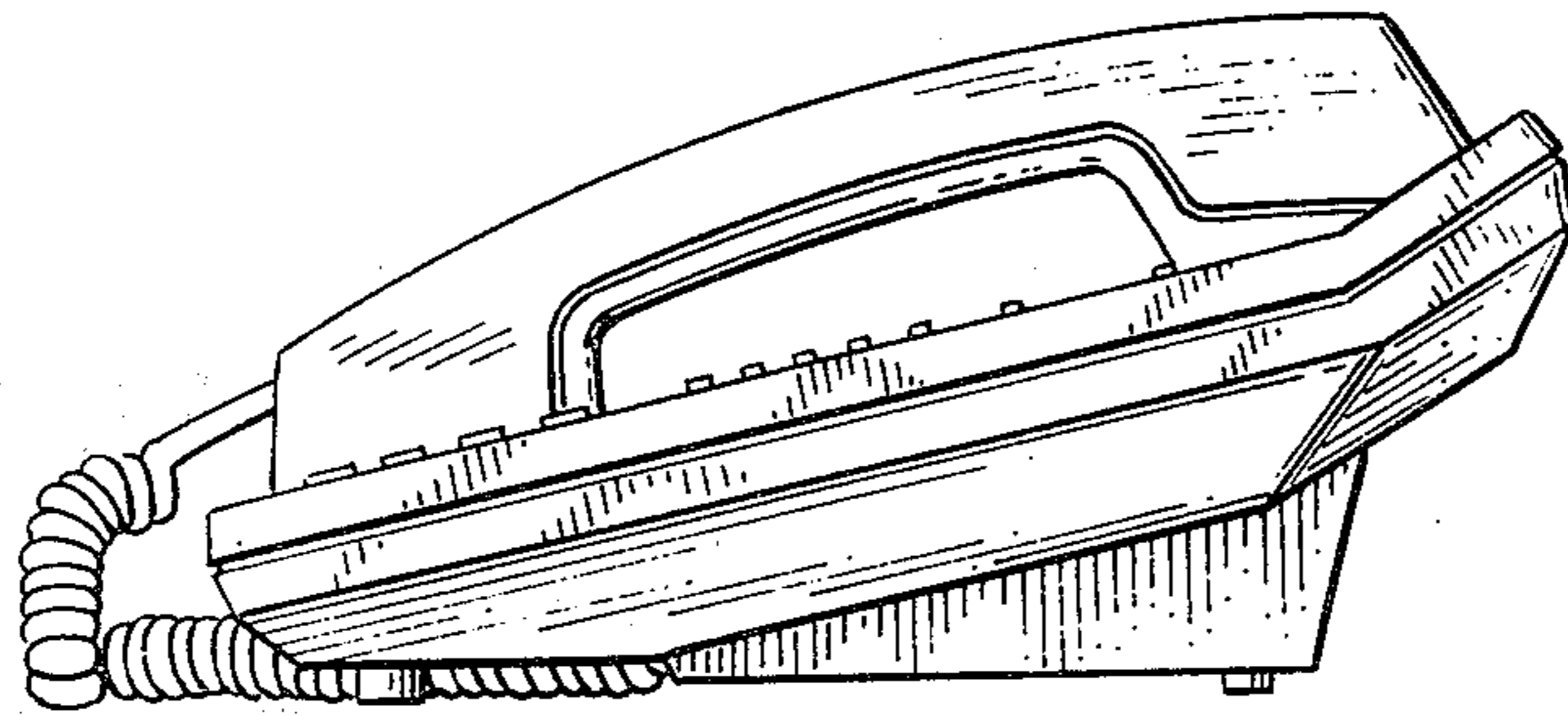

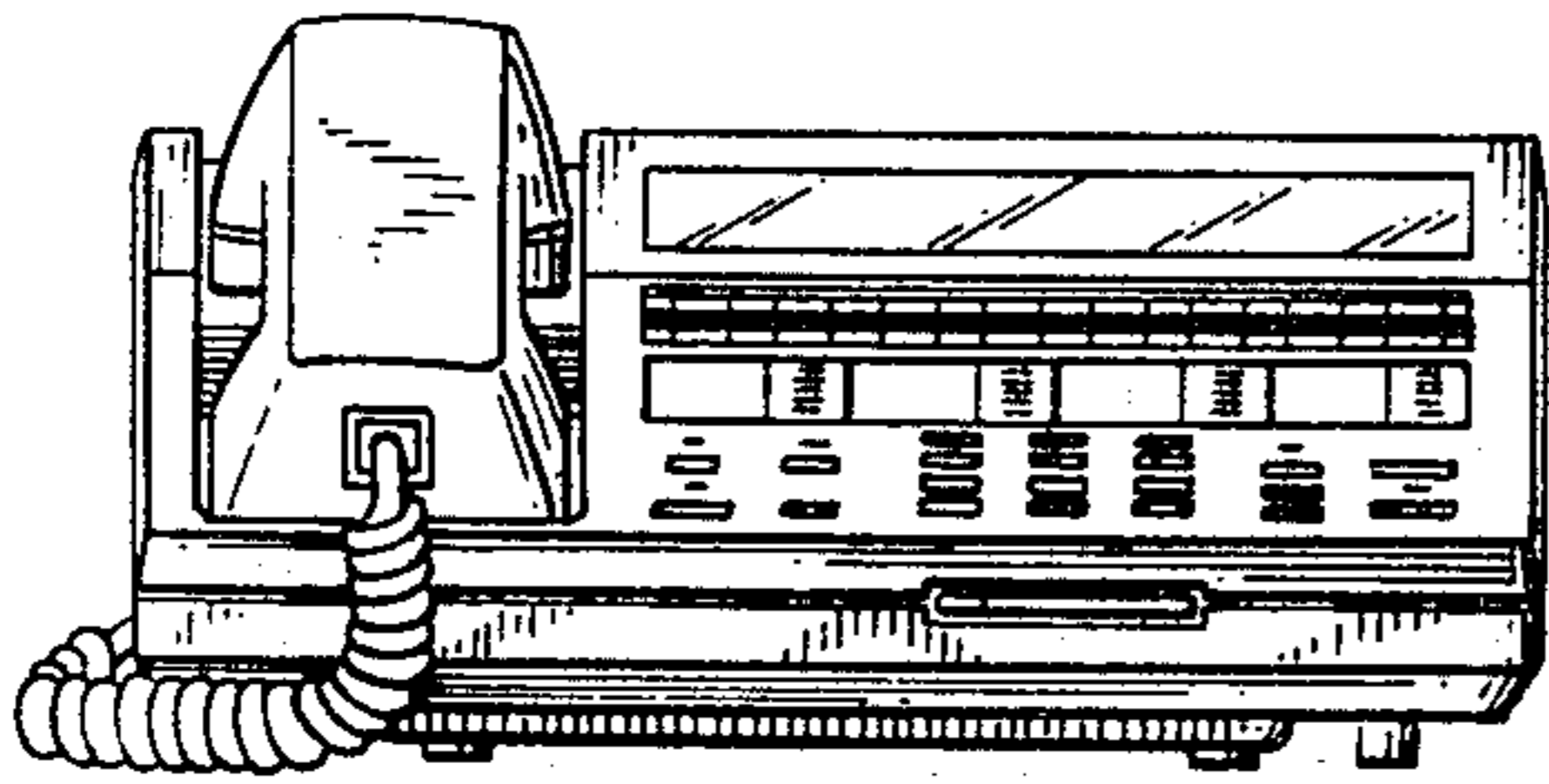

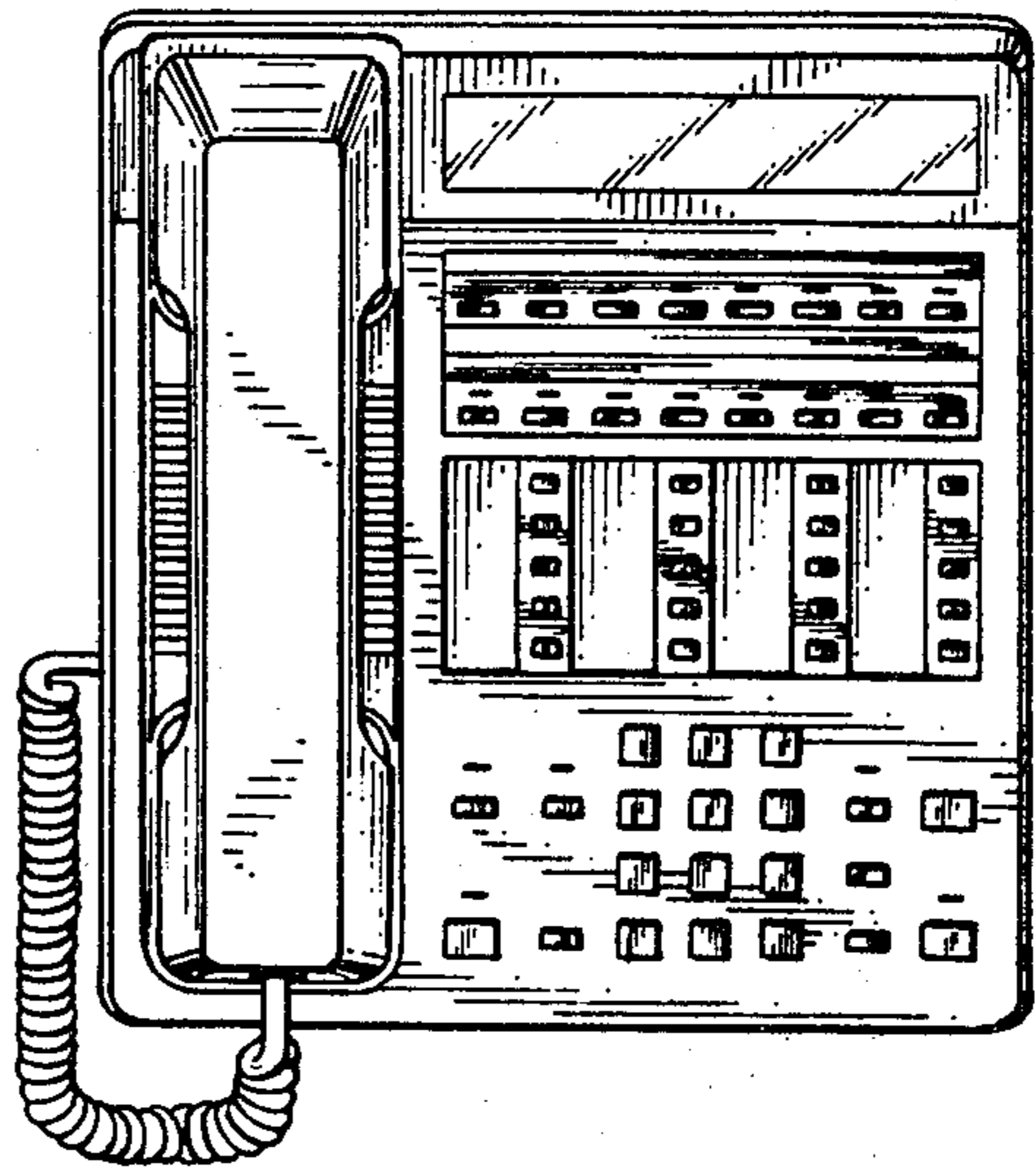

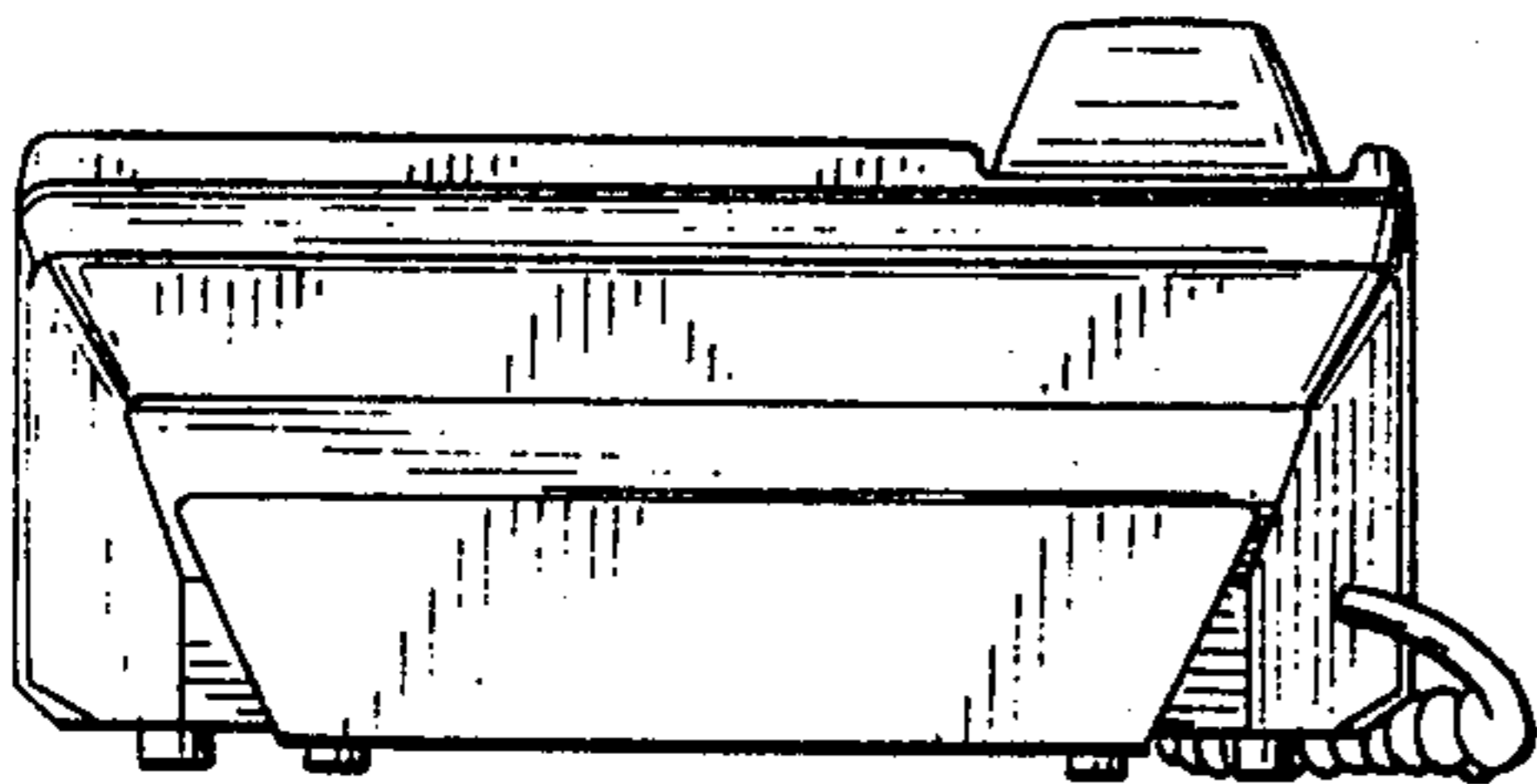

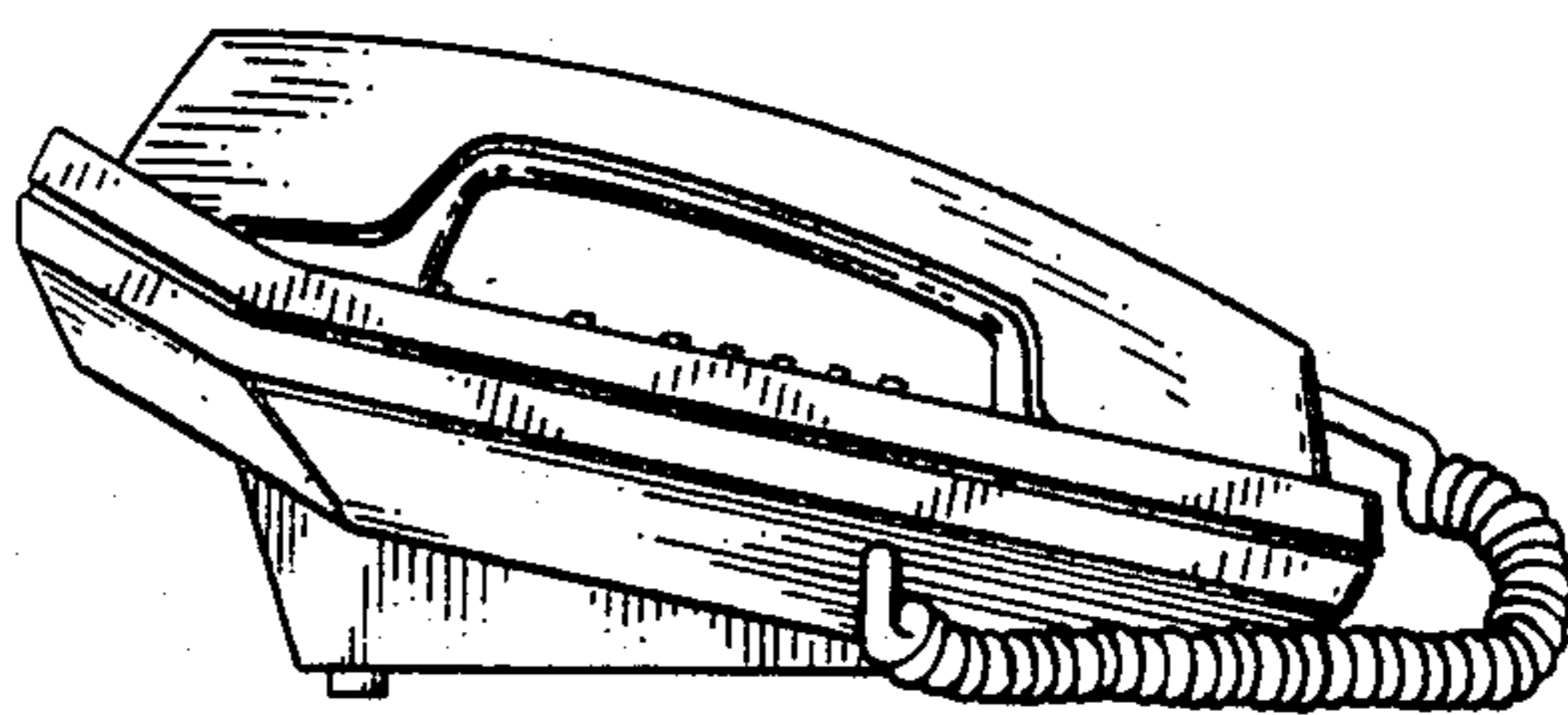
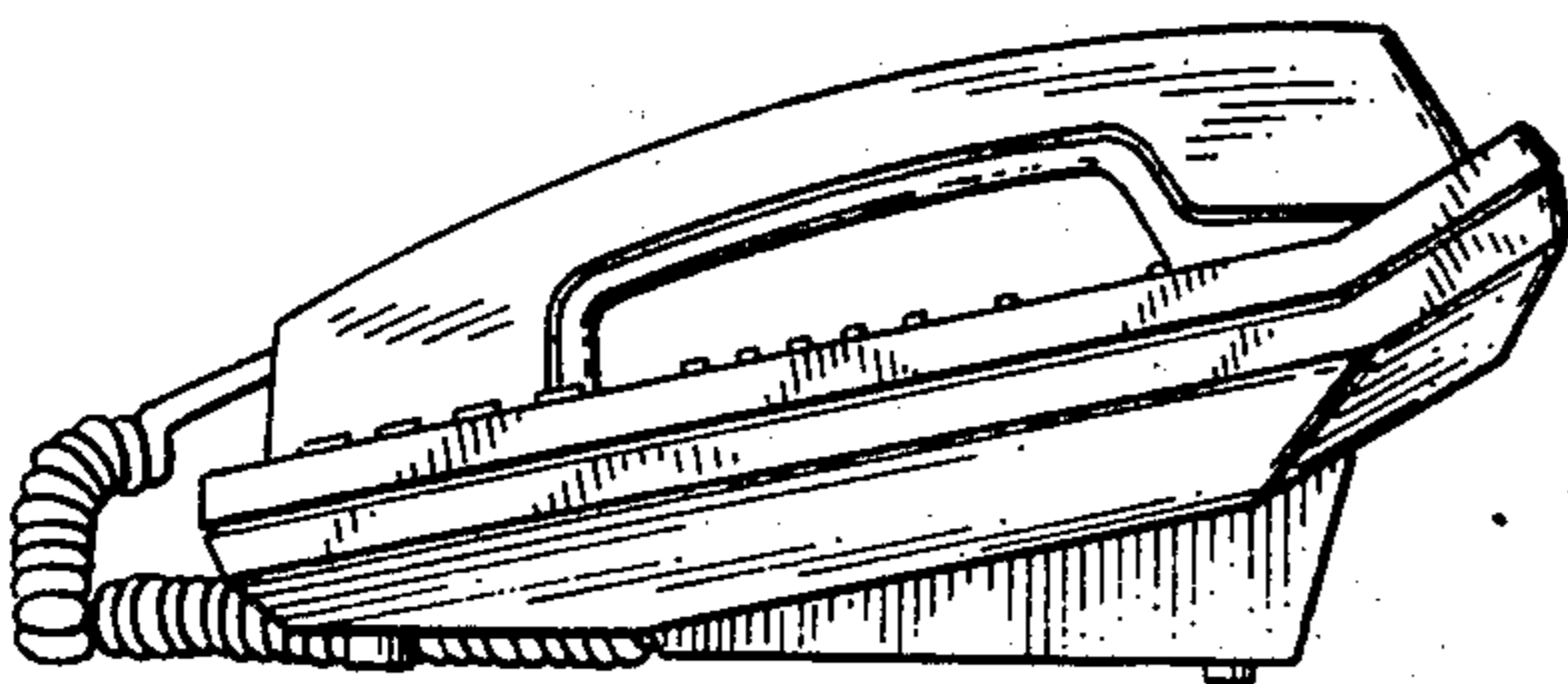

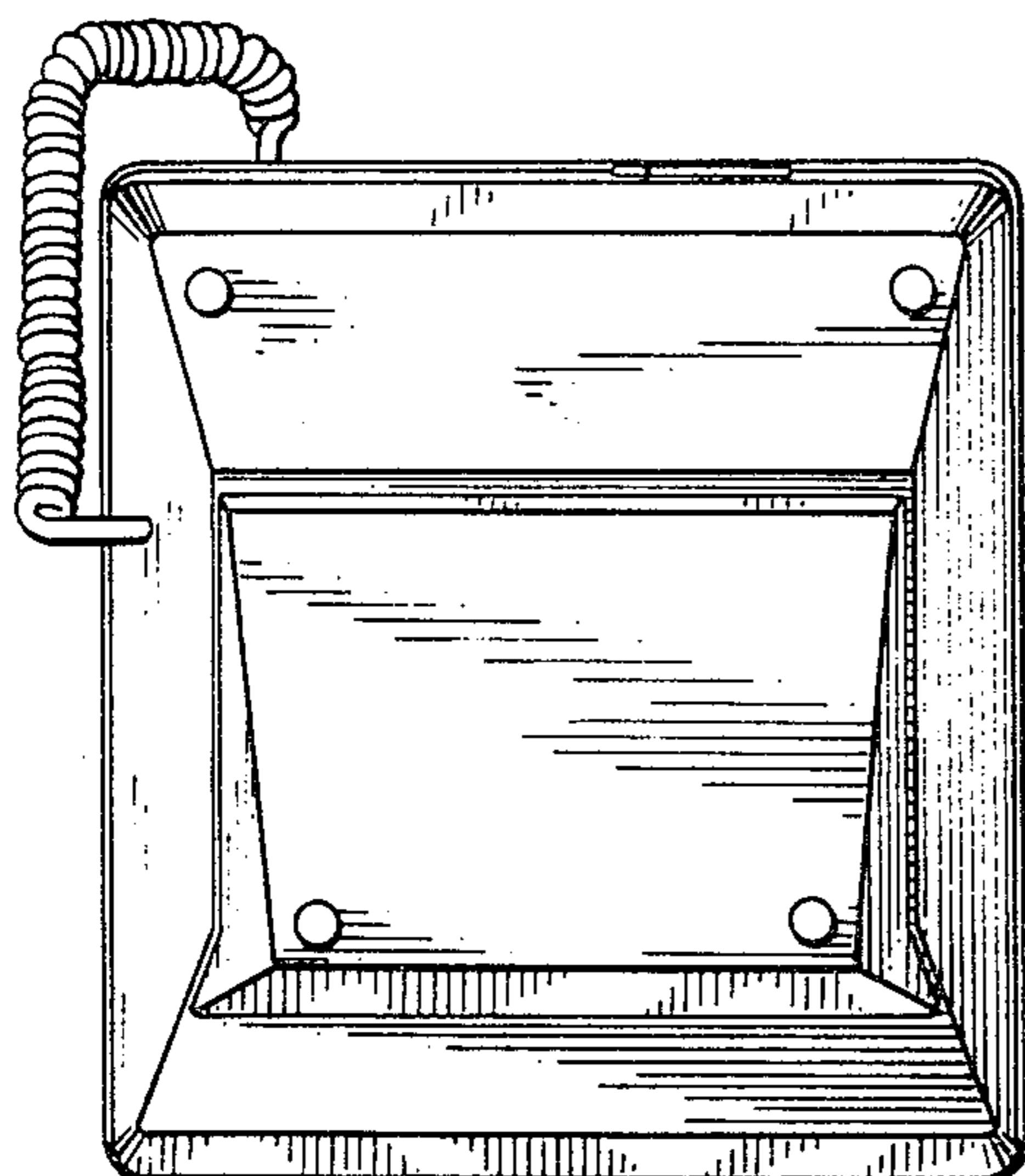

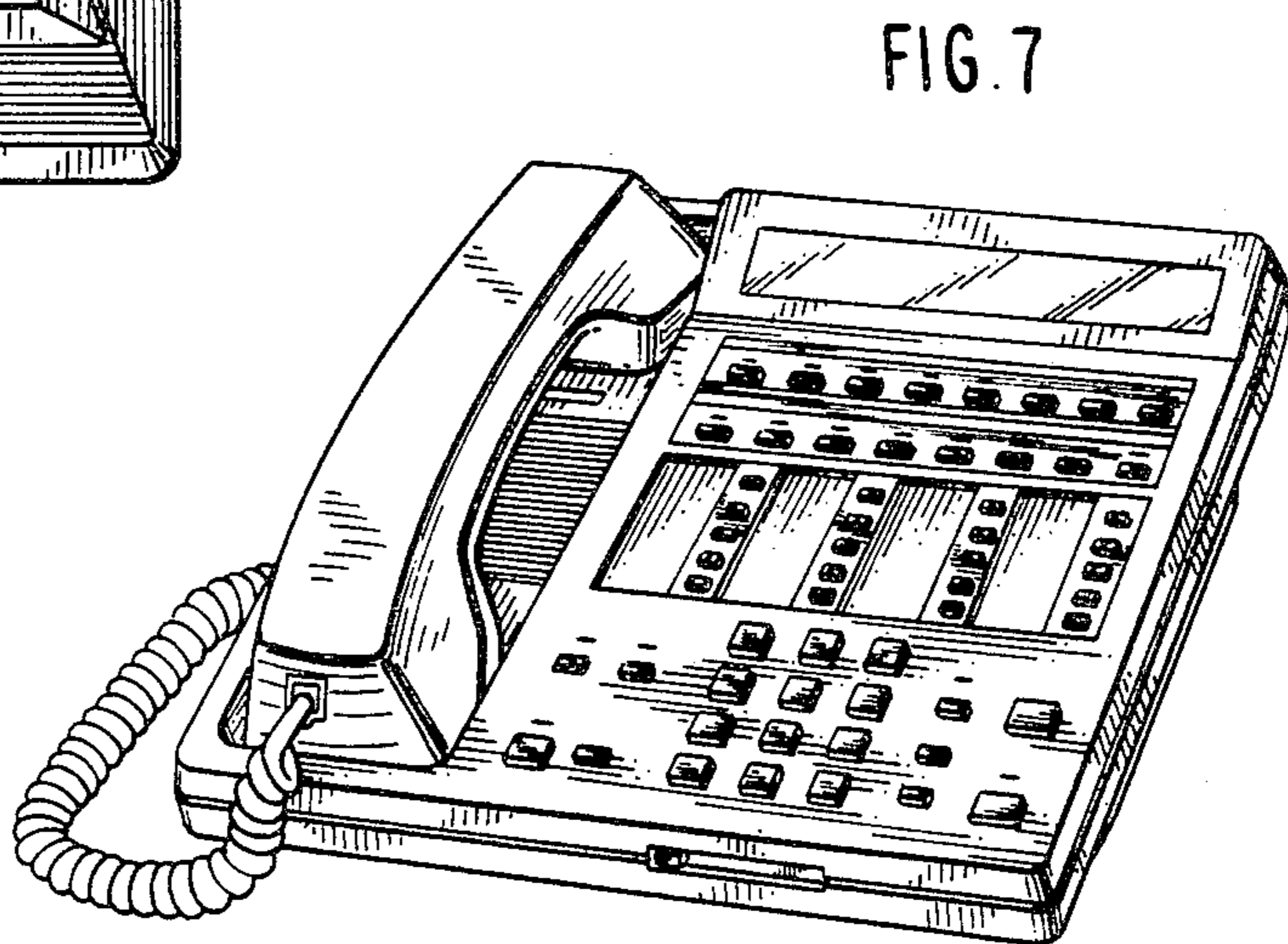

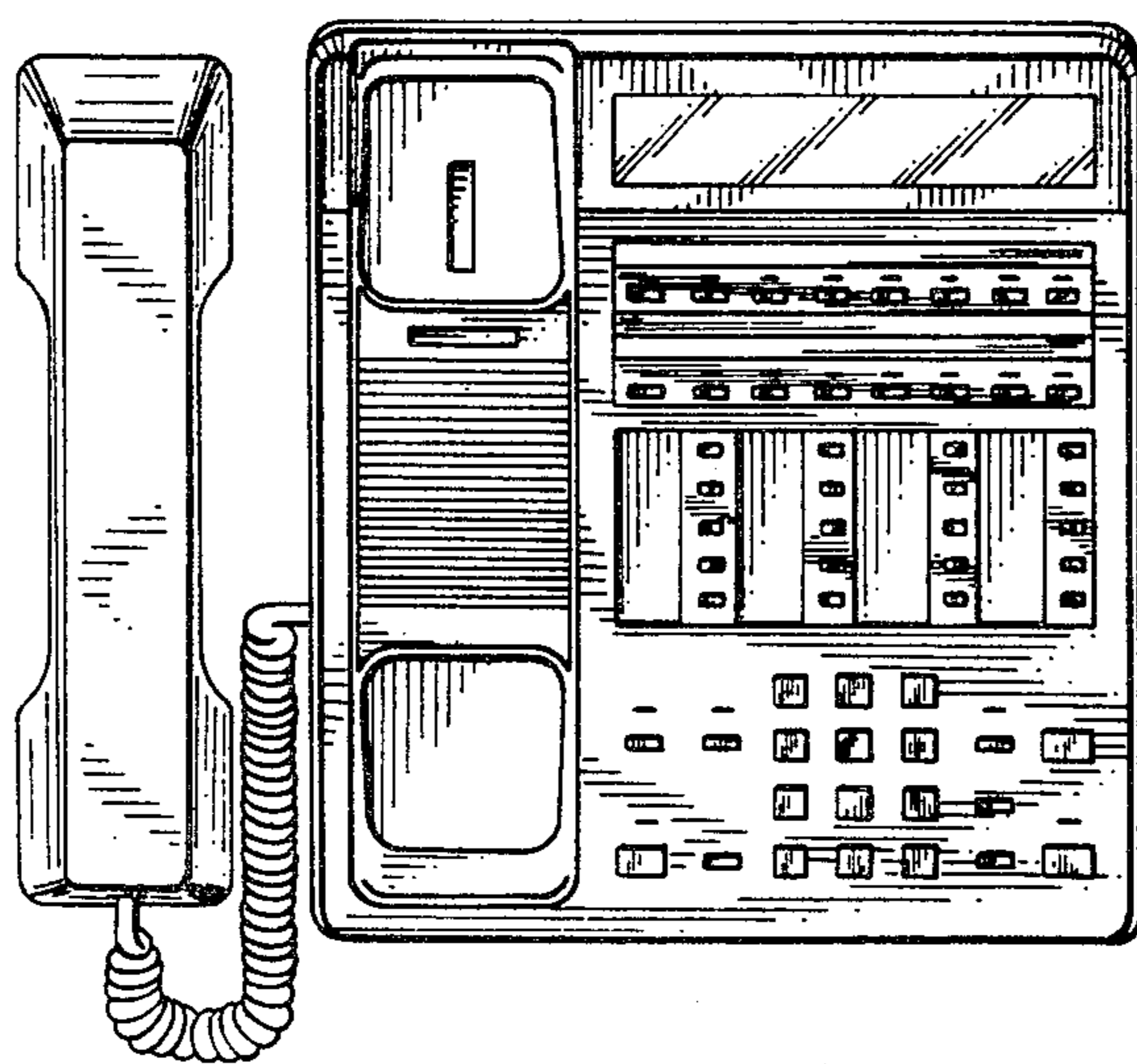
