The ornamental design for a linear surgical stapler, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a linear surgical stapler showing my new design;
 FIG. 2 is a side elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is an end elevational view thereof, as seen from the right of FIG. 2; and
 FIG. 6 is an end elevational view thereof, as seen from the left of FIG. 2.

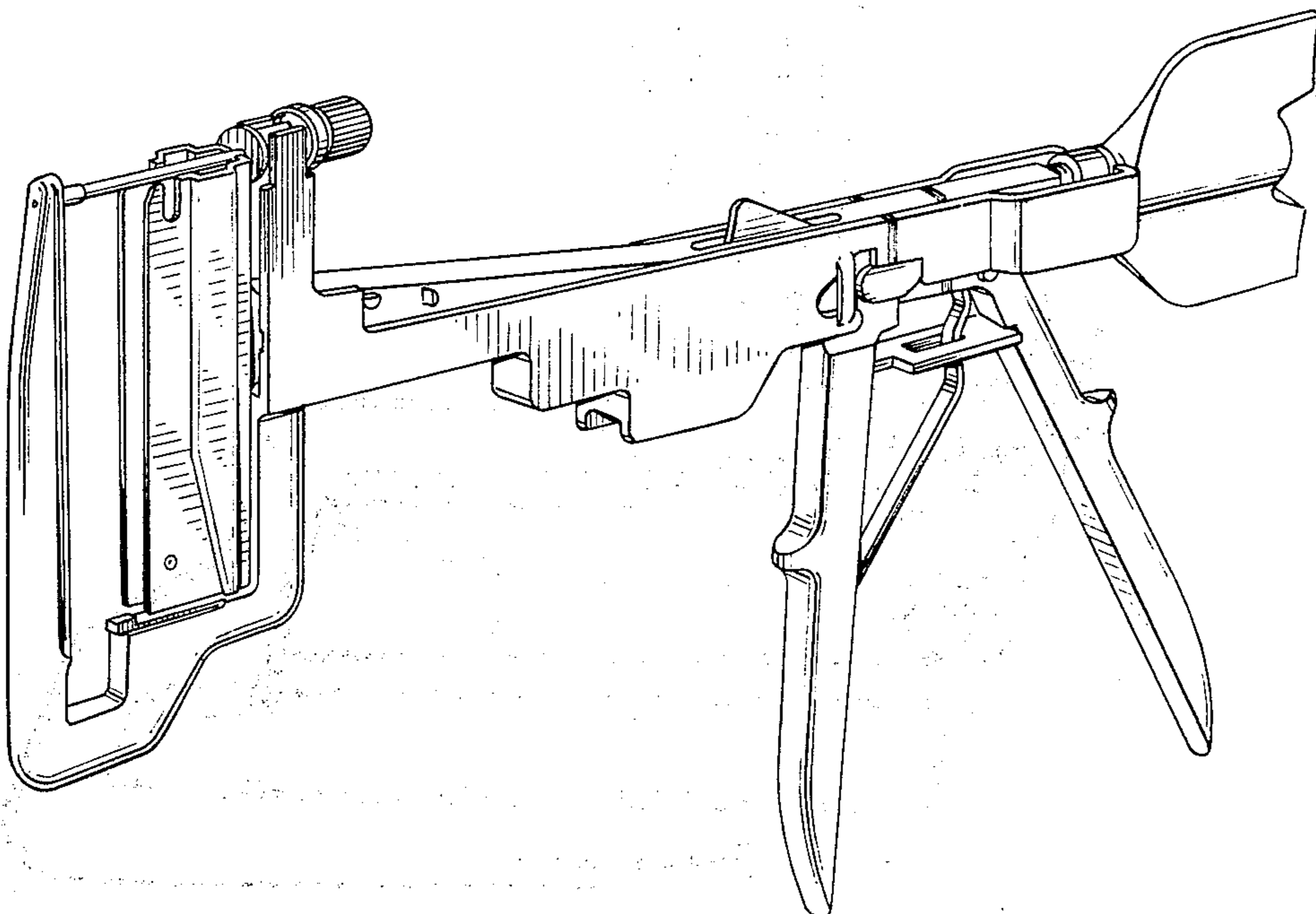
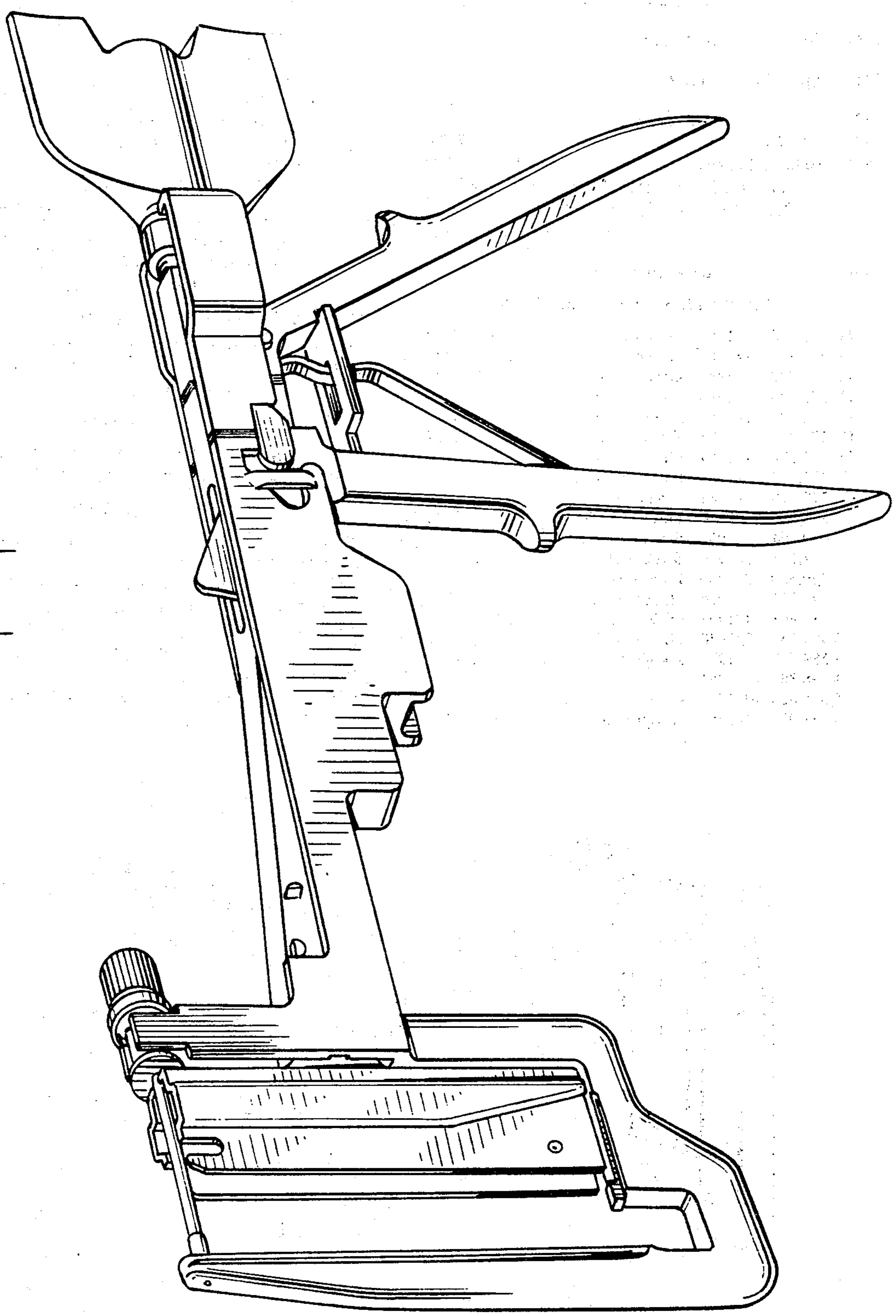

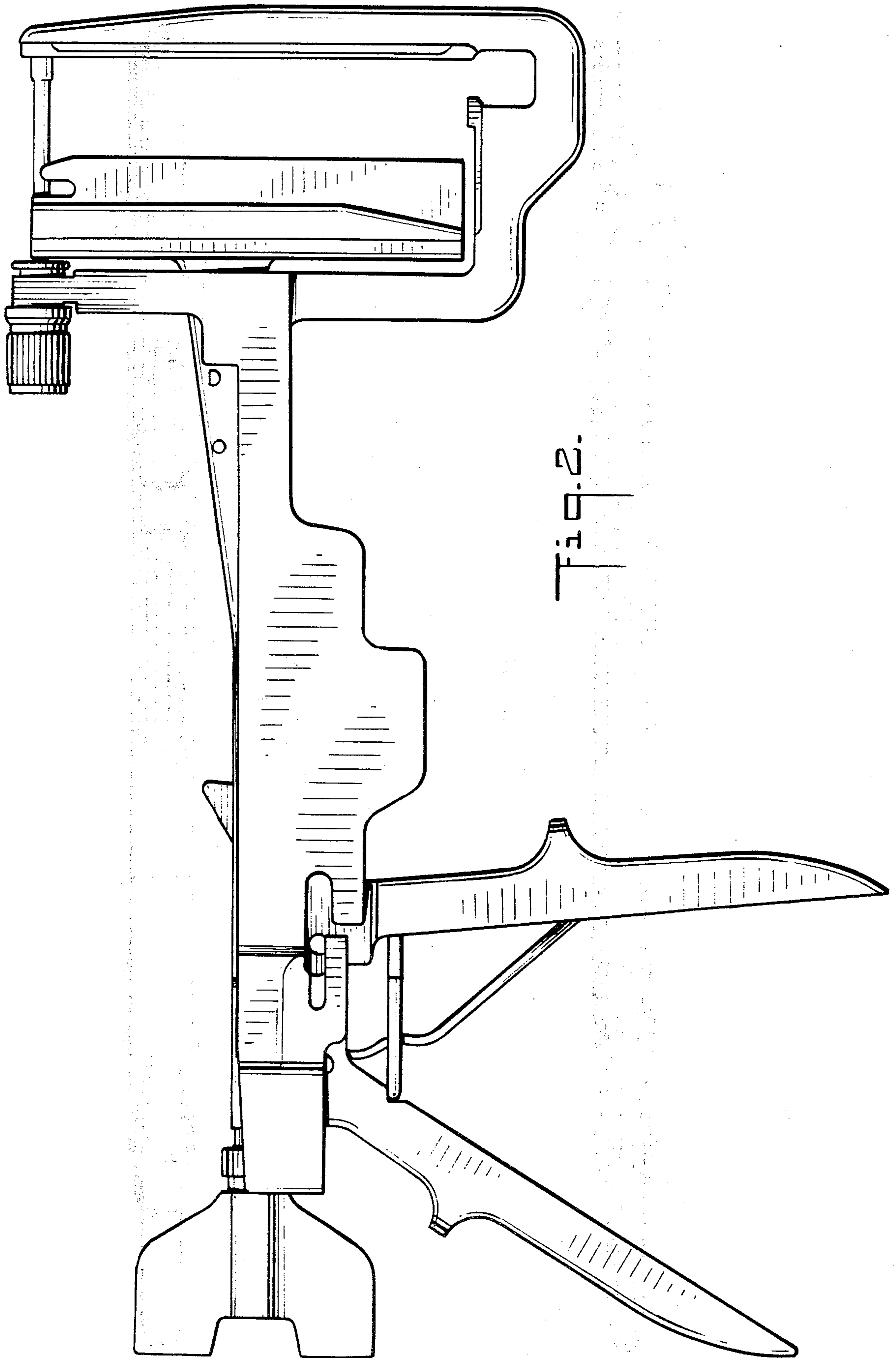

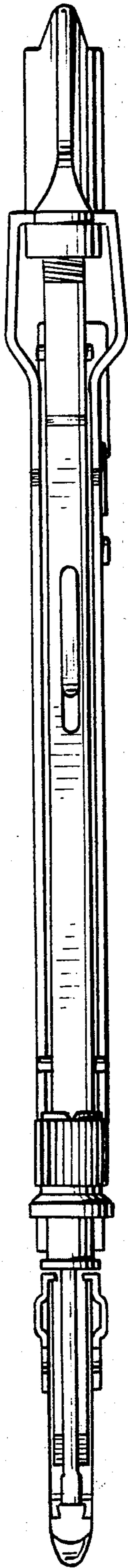

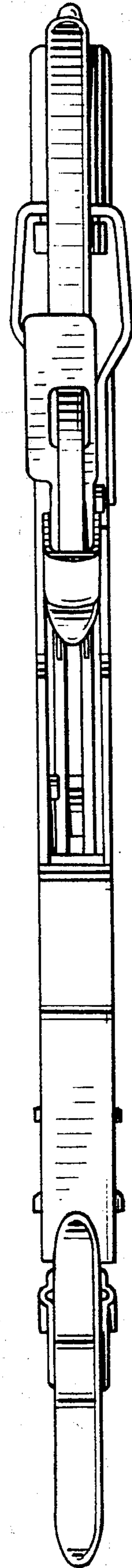

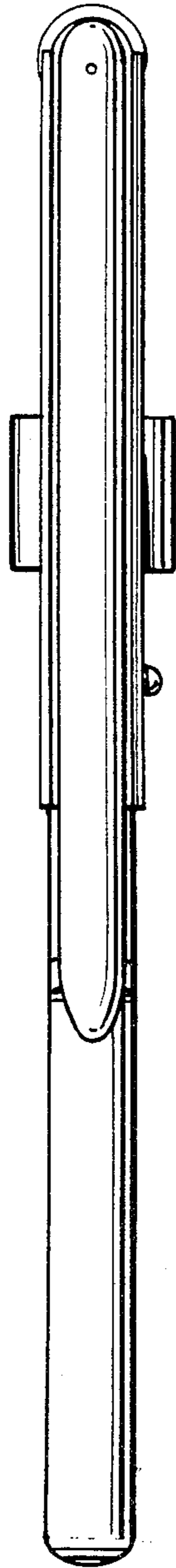
