[57] CLAIM

The ornamental design for a chain guard for jewelry or the like, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a chain guard for jewelry or the like showing my new design;

FIG. 2 is a front perspective view thereof in the open position;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof, the bottom being a mirror image;

FIG. 7 is a perspective view of a second embodiment of the design of FIG. 1;

FIG. 8 is an exploded perspective view of FIG. 7;

FIG. 9 is a front elevational view of FIG. 7, the rear being a mirror image;

FIG. 10 is a side elevational view of FIG. 7;

FIG. 11 is a top plan view of FIG. 7, the bottom being a mirror image;

FIG. 12 is a perspective view of a third embodiment of the design of FIG. 1;

FIG. 13 is a perspective view of FIG. 12 in the open position;

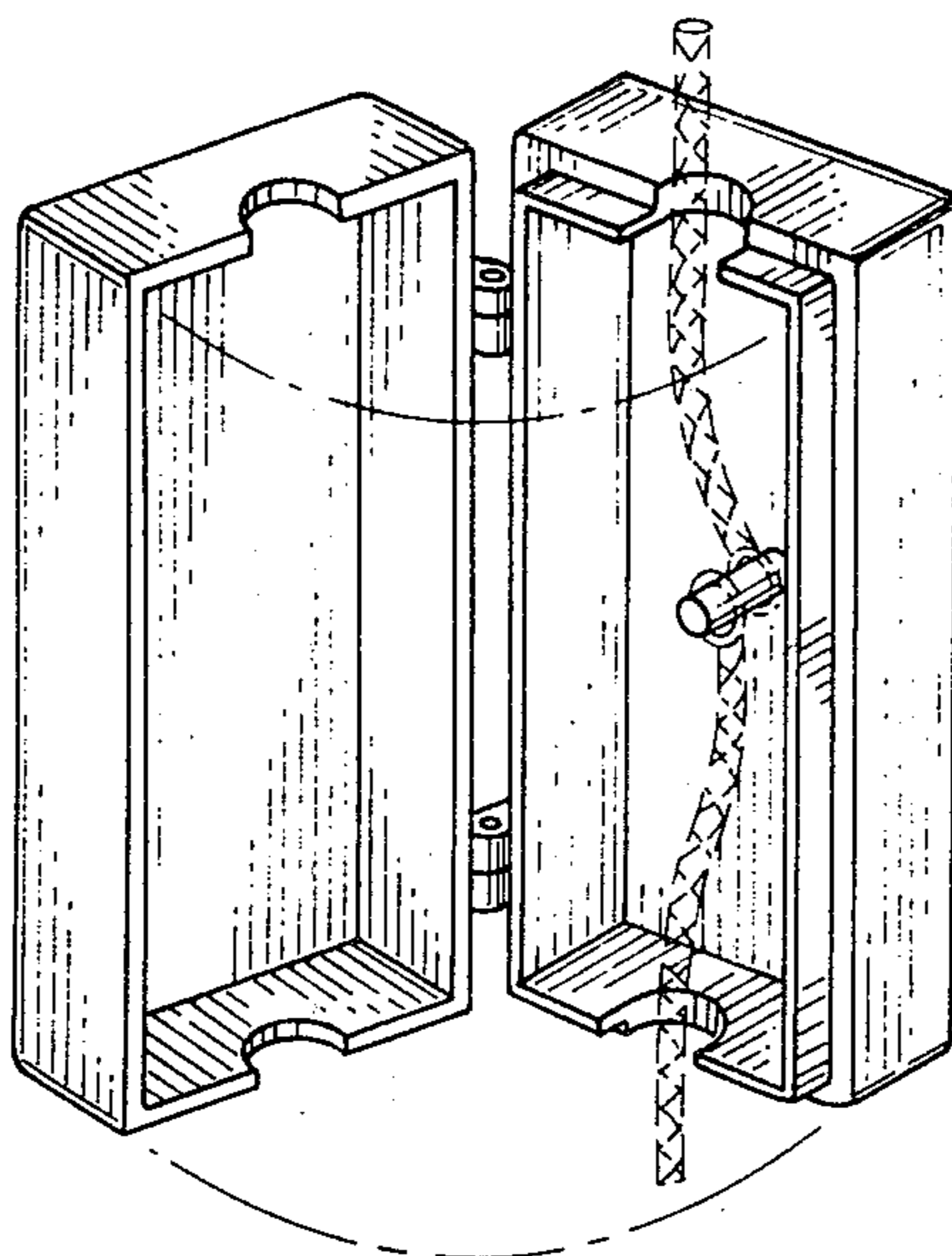
FIG. 14 is a front elevational view of FIG. 12, the rear being a mirror image;

The broken line showing of the chains in FIGS. 1, 2, 7, 8 and 13 is for illustrative purposes only.



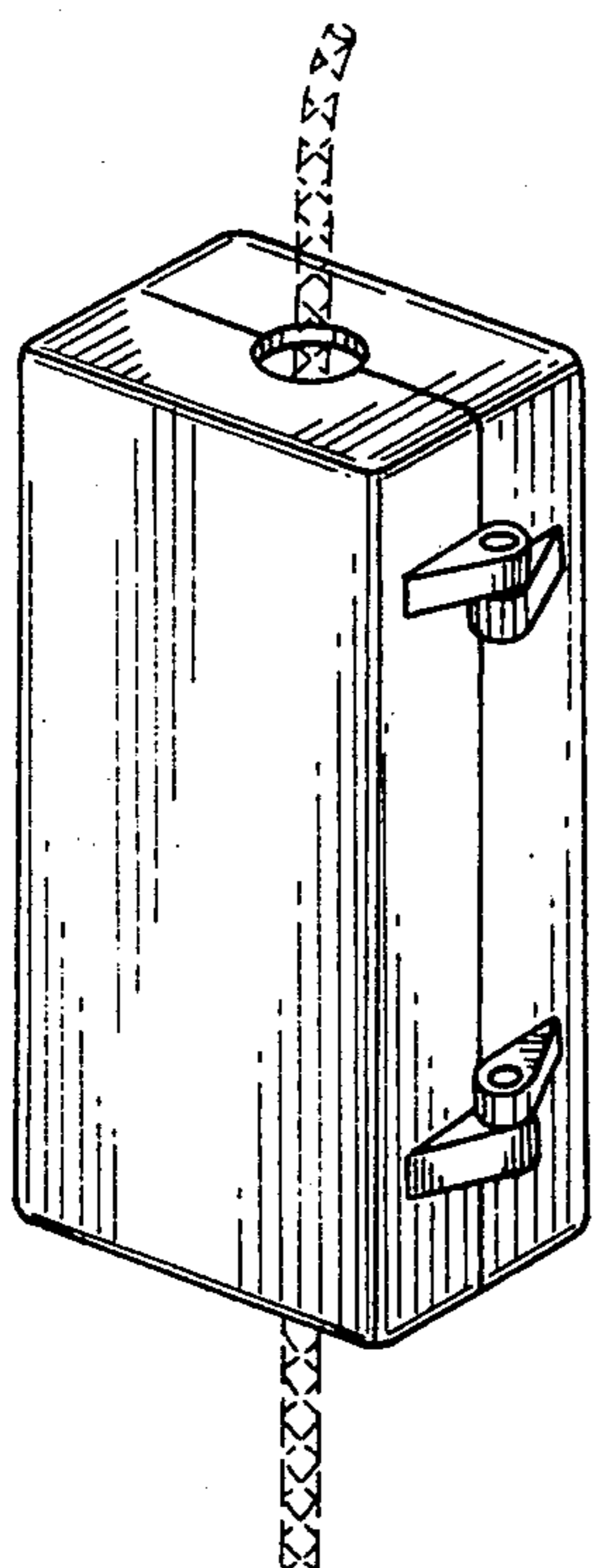

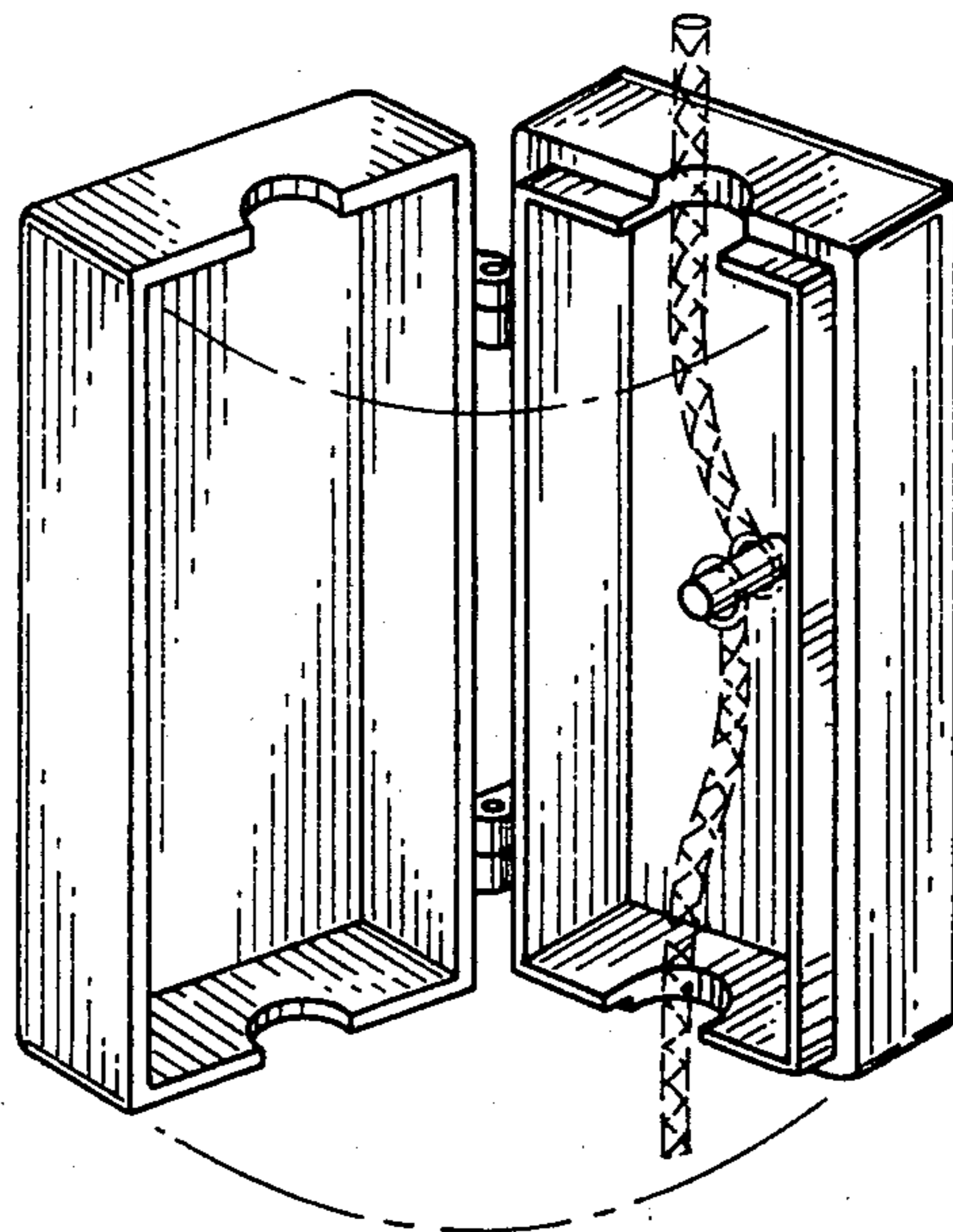

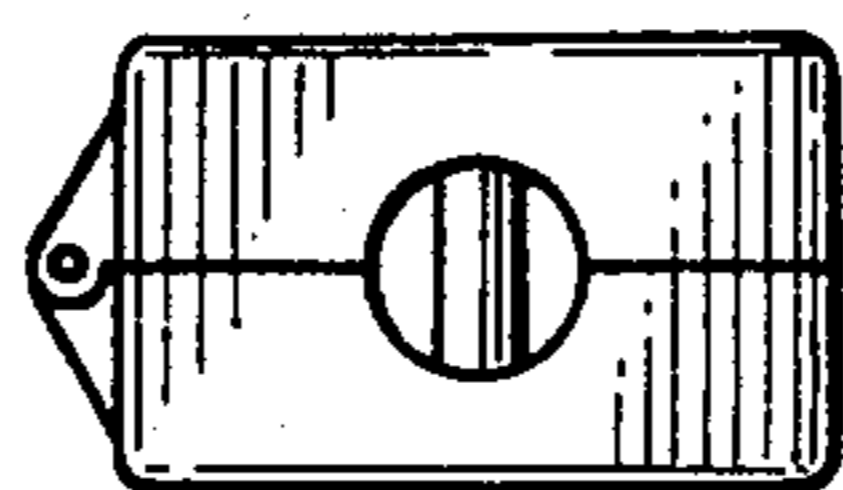

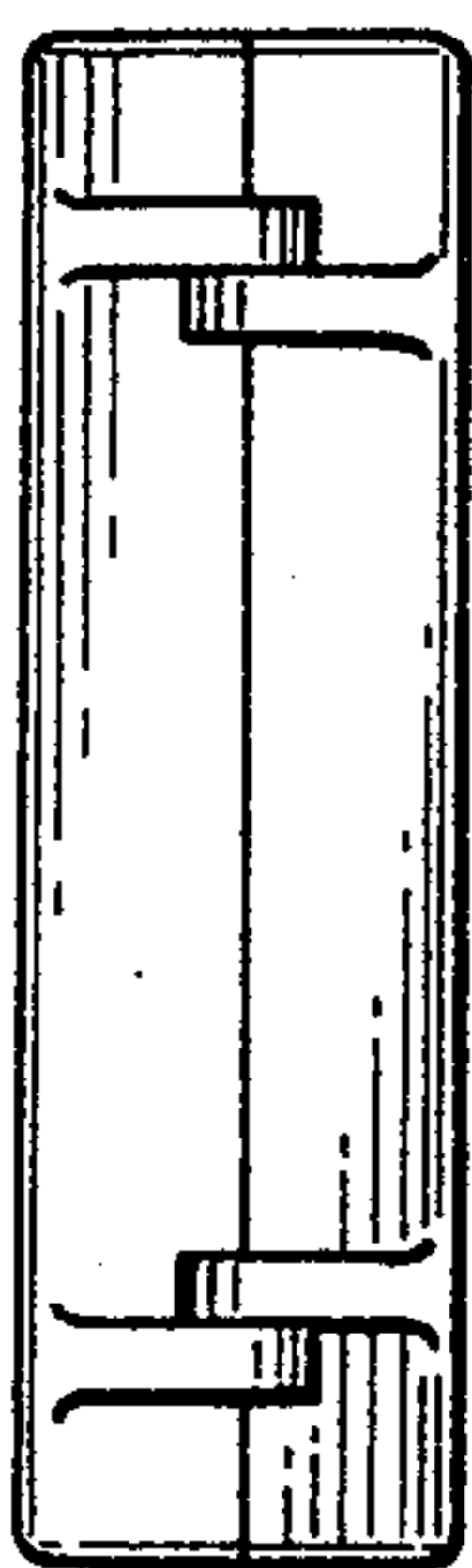

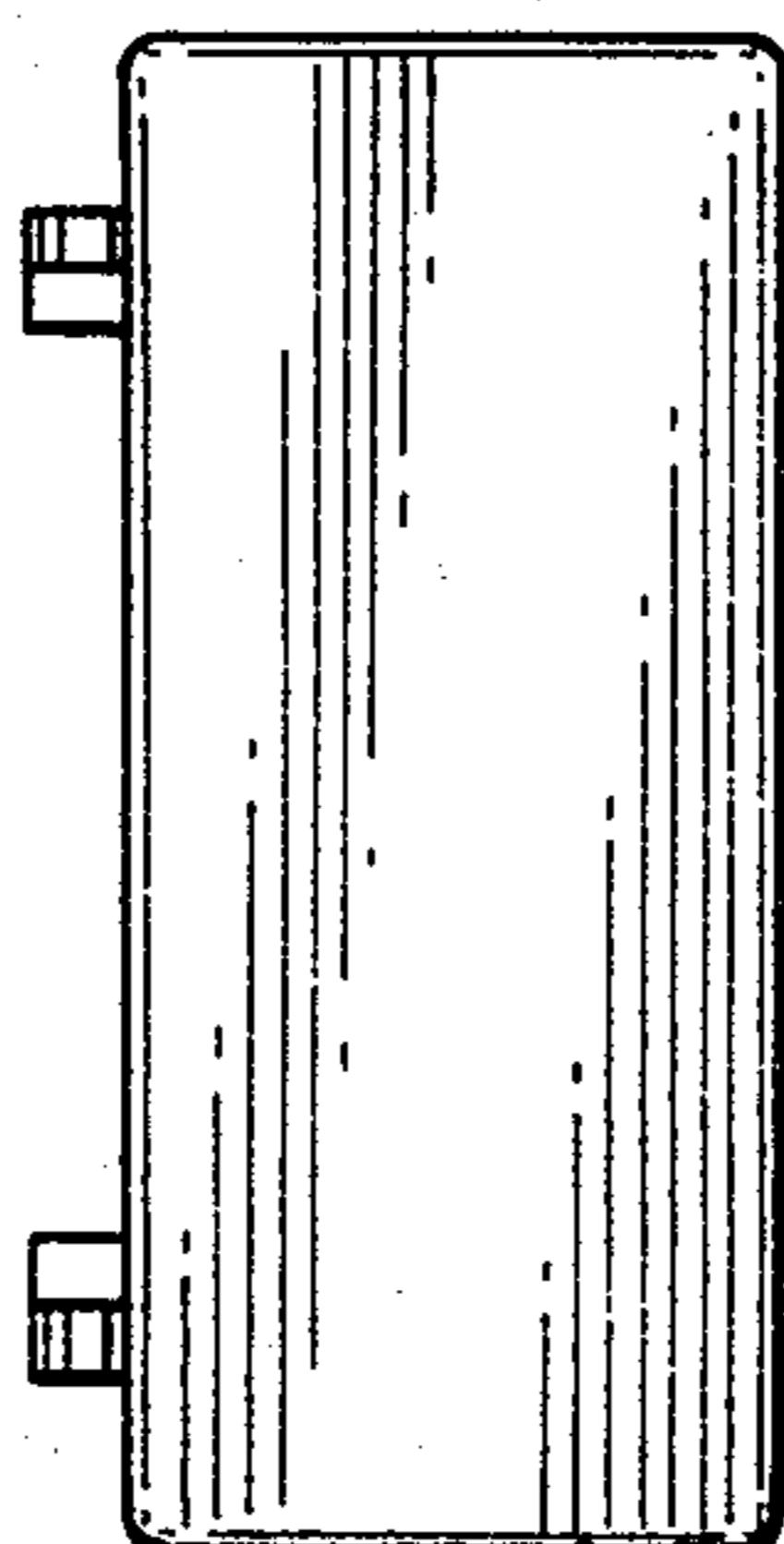

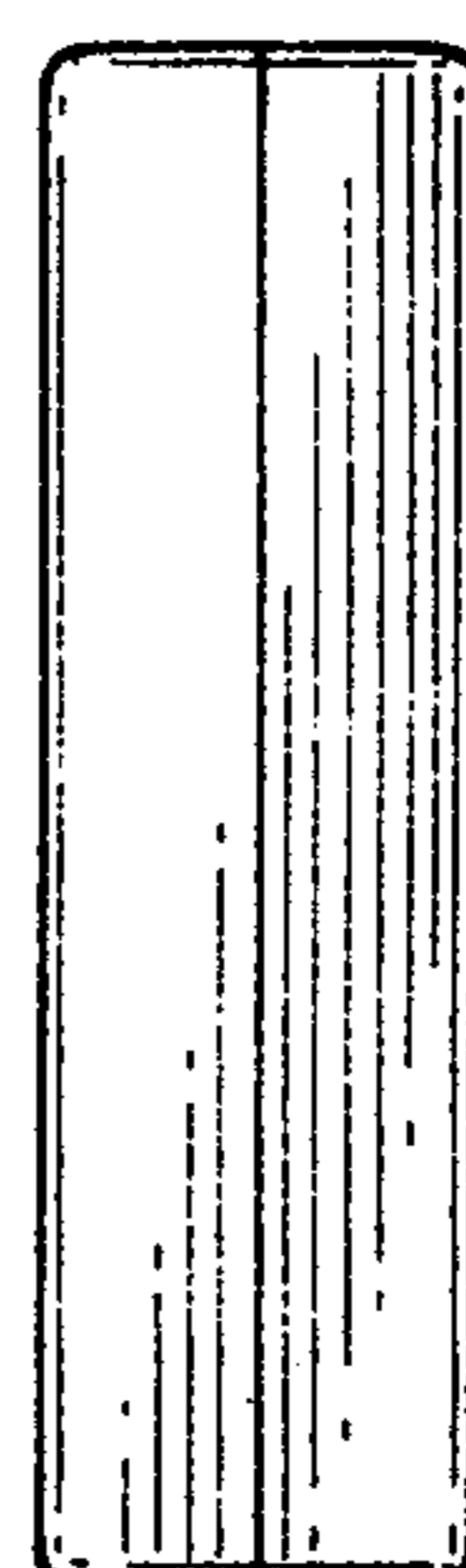

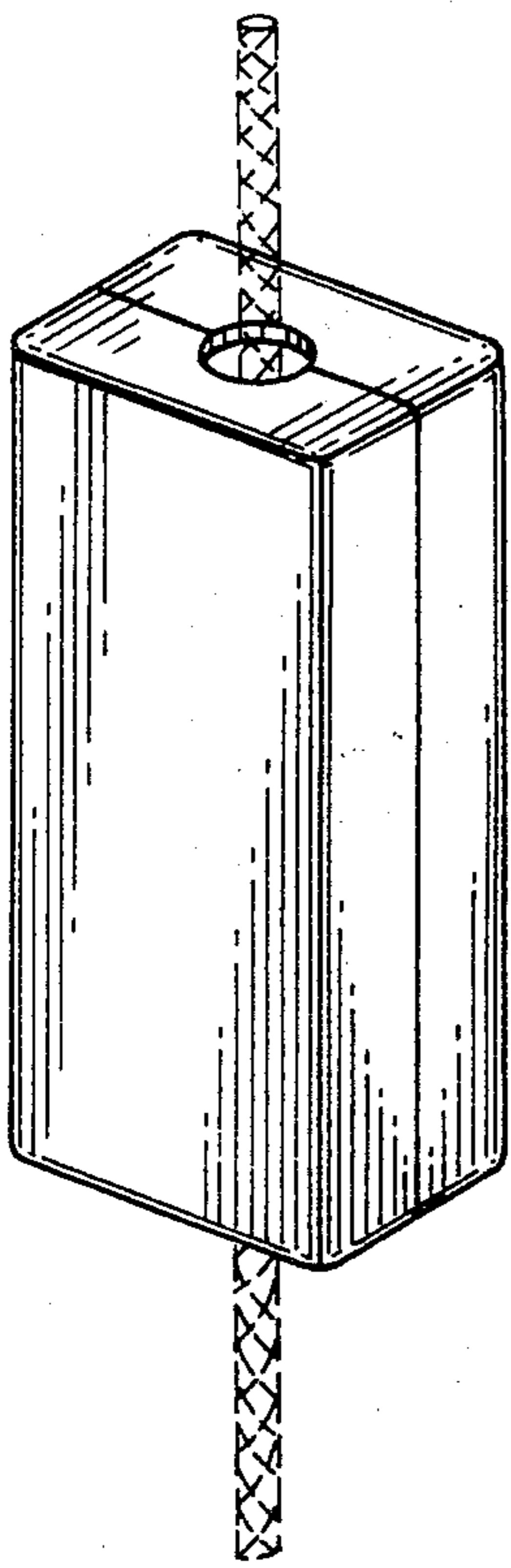

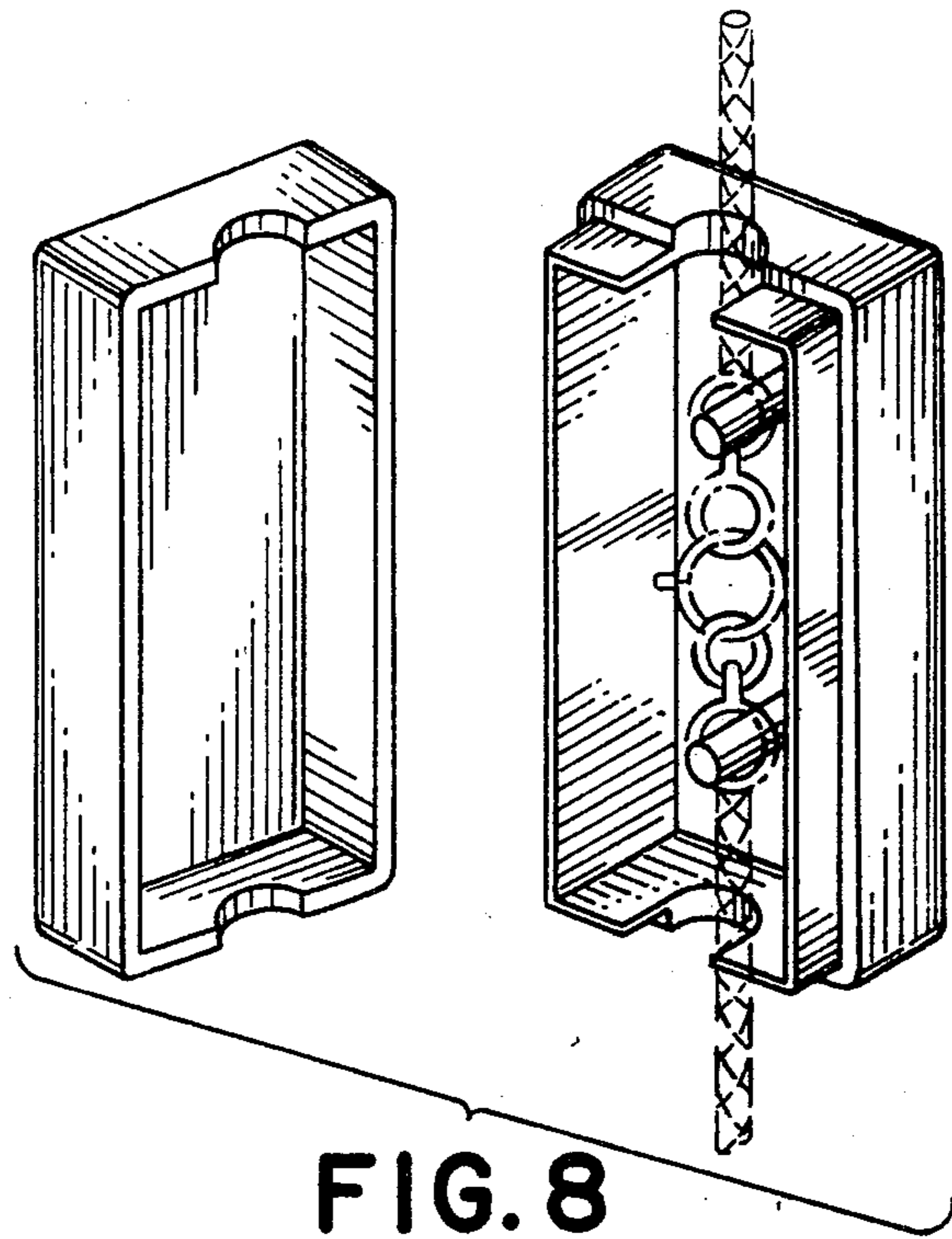

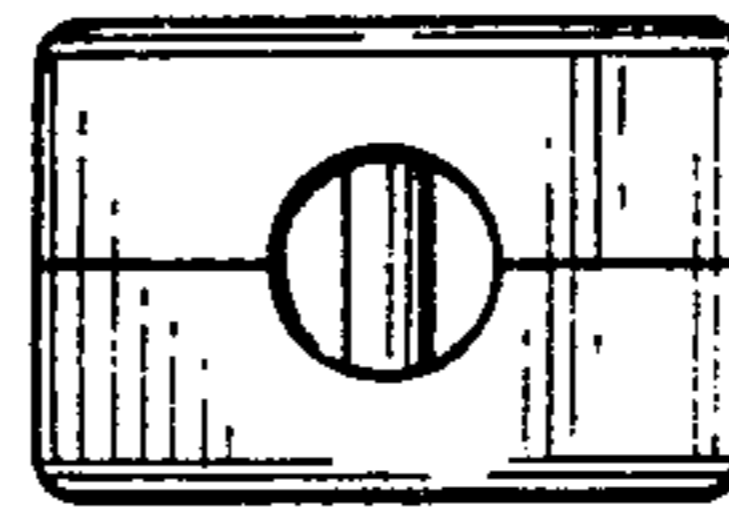

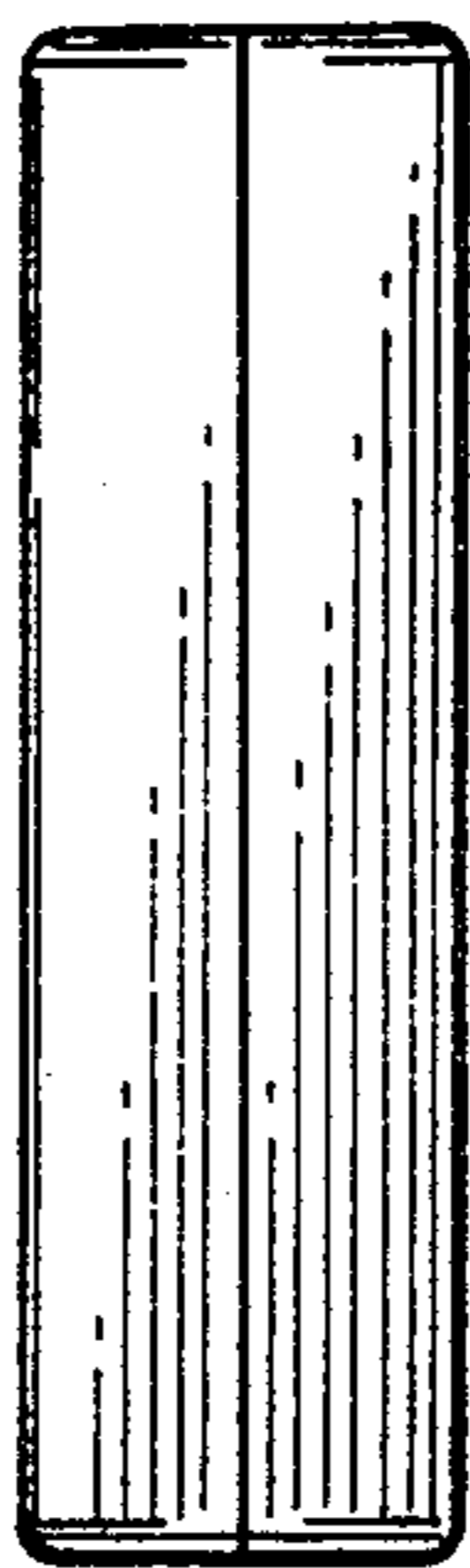

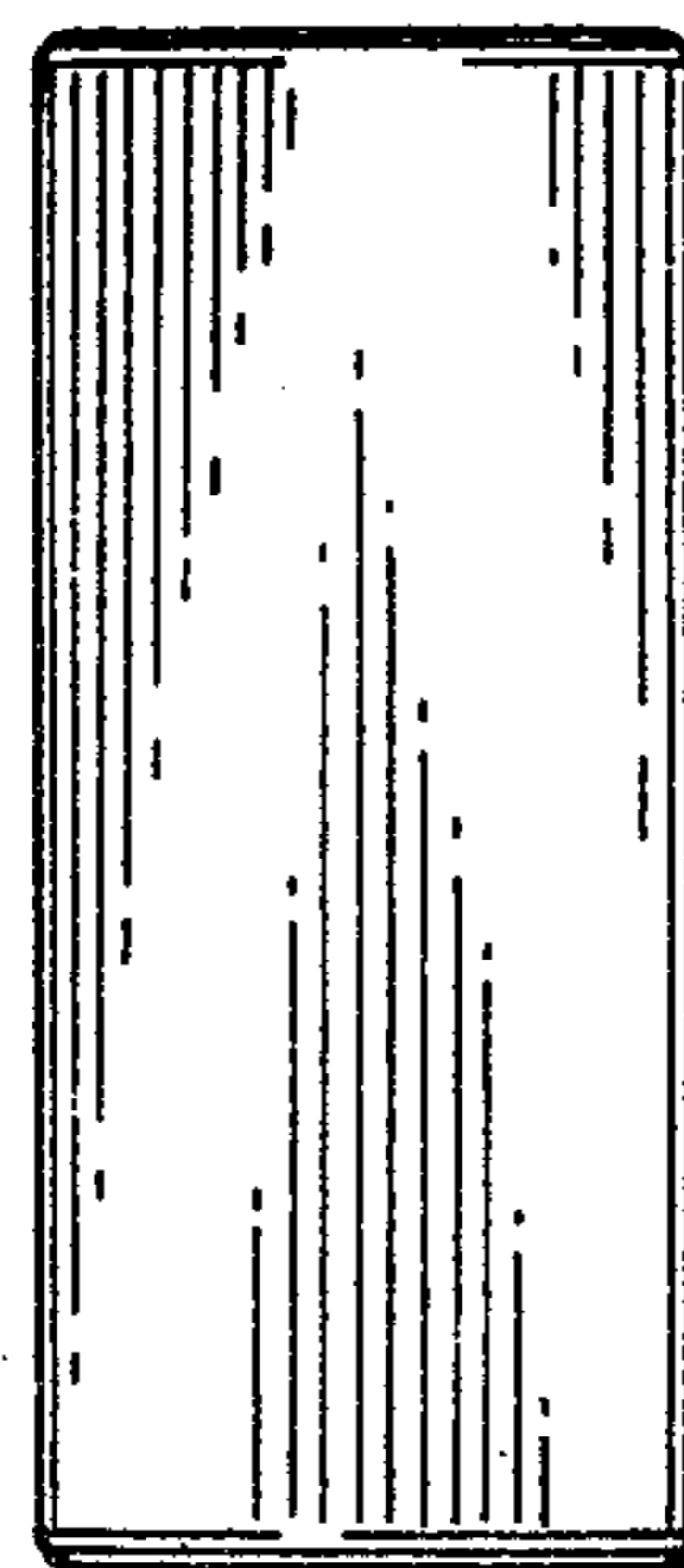

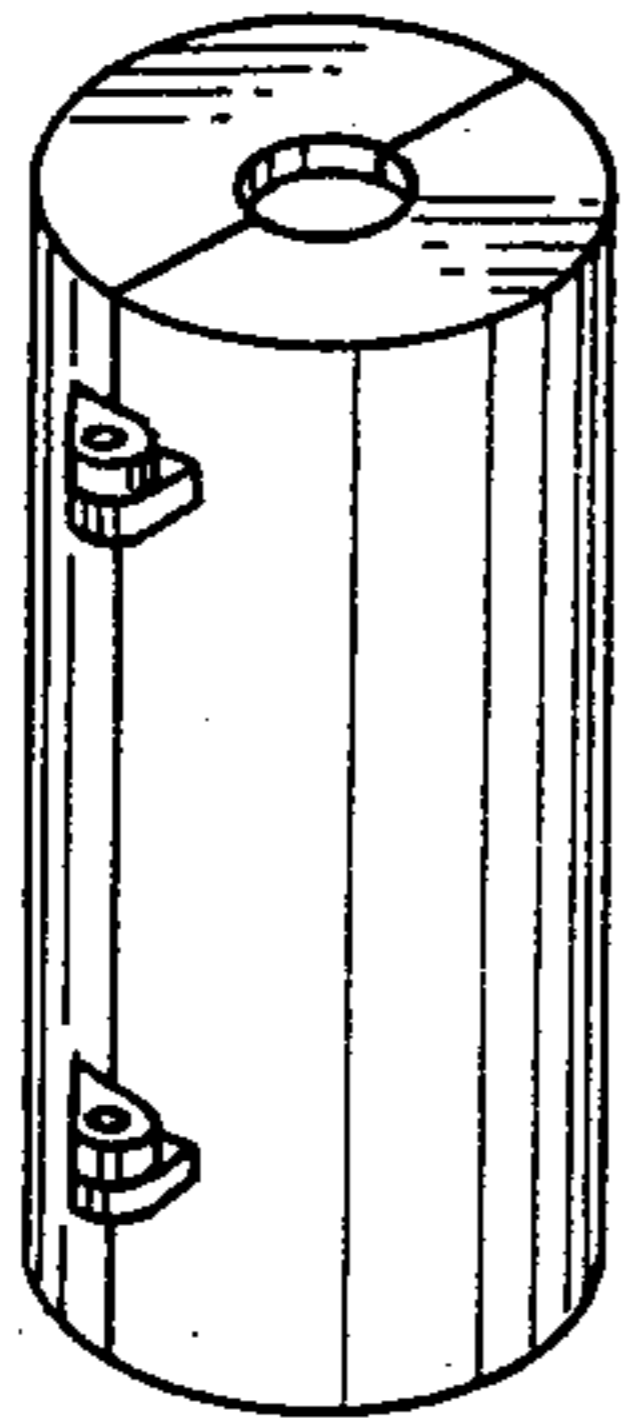

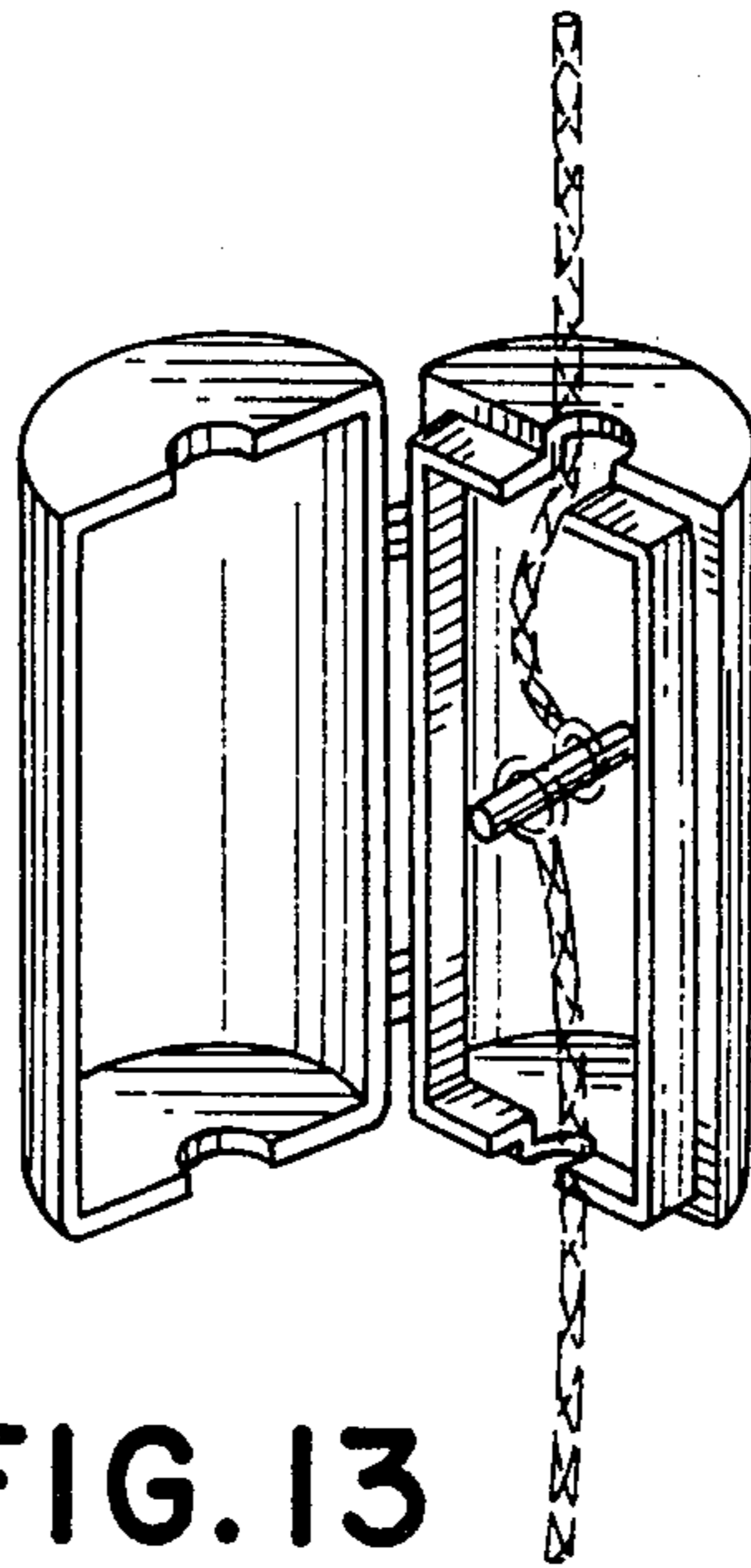

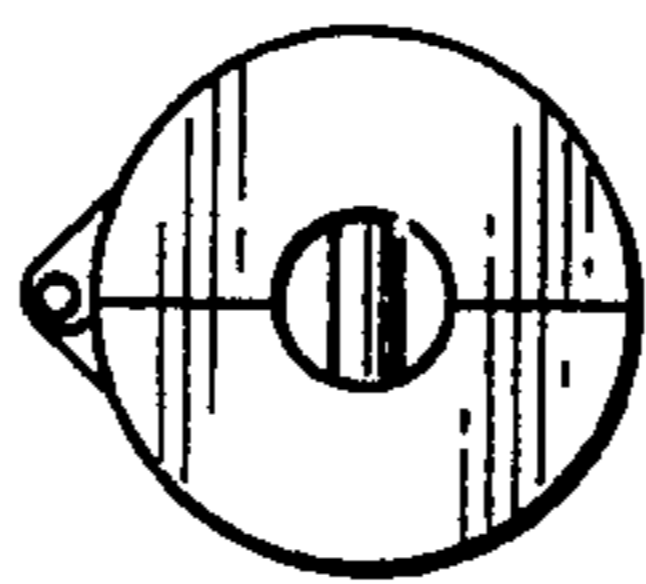

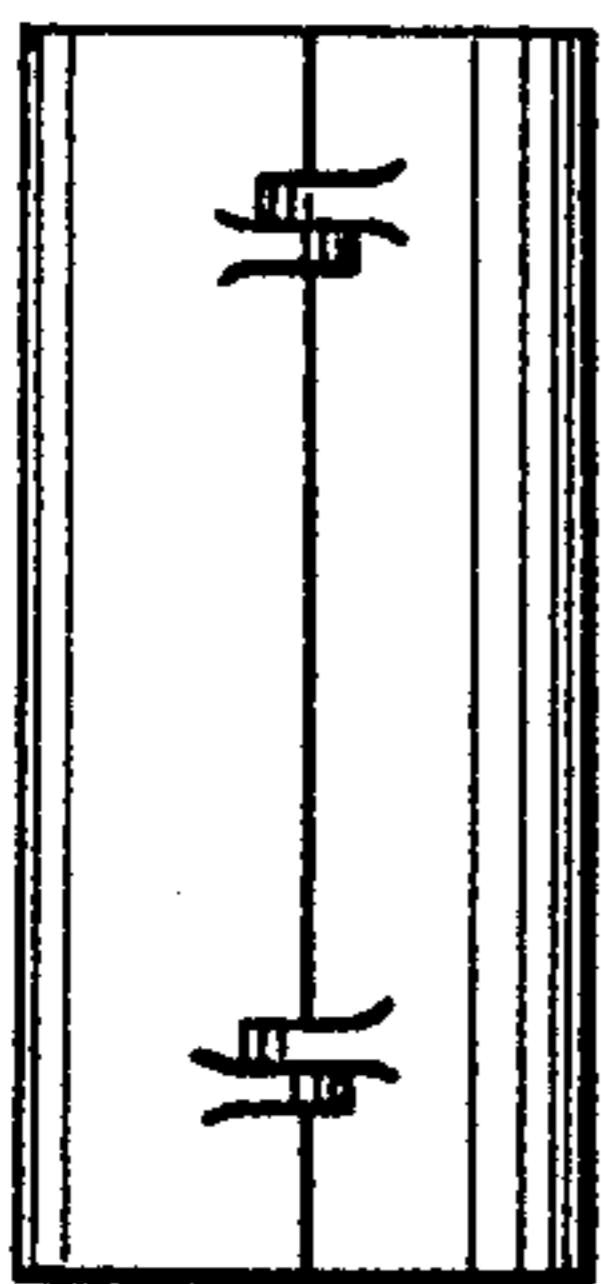

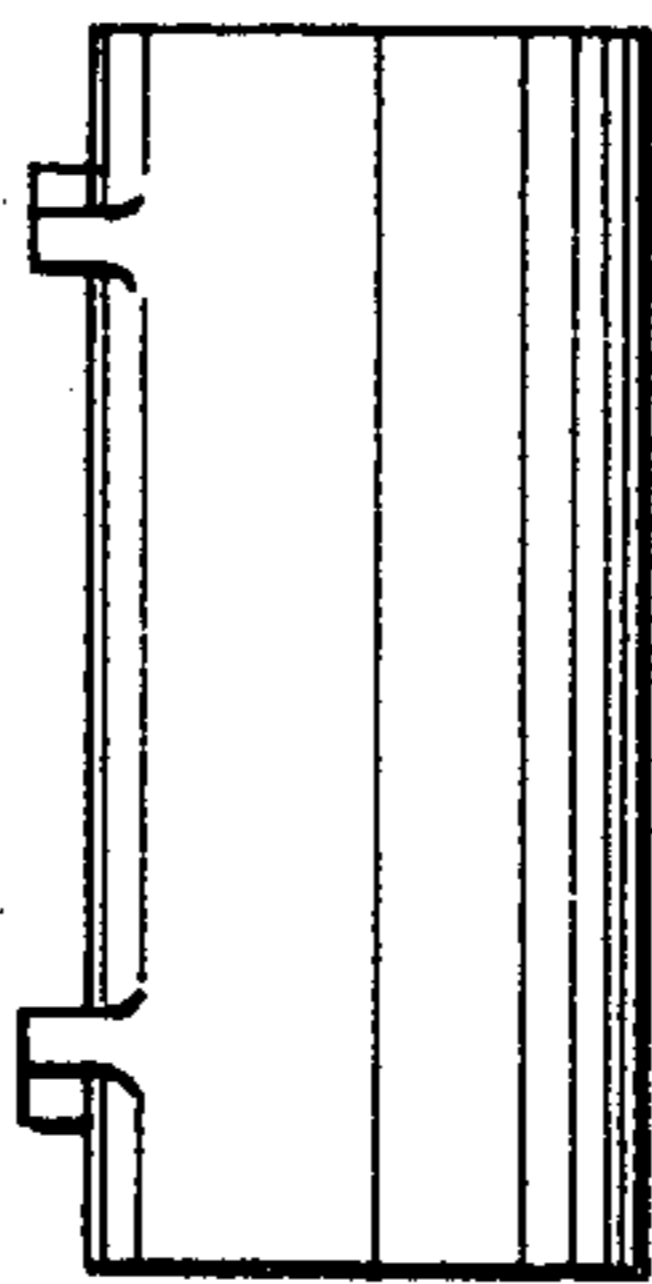

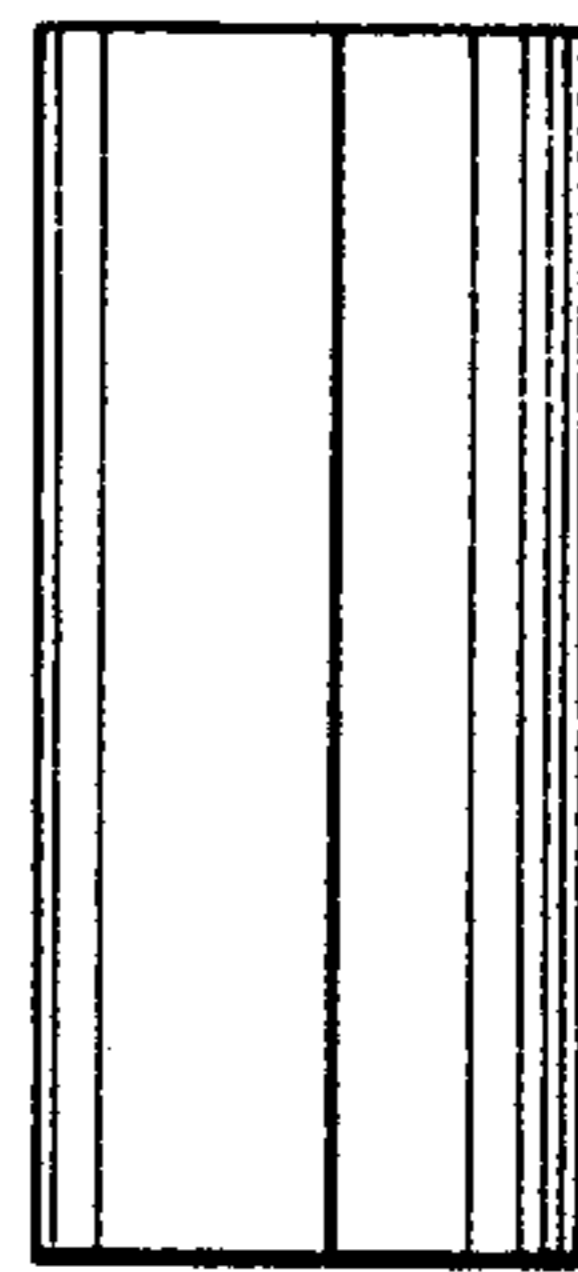
