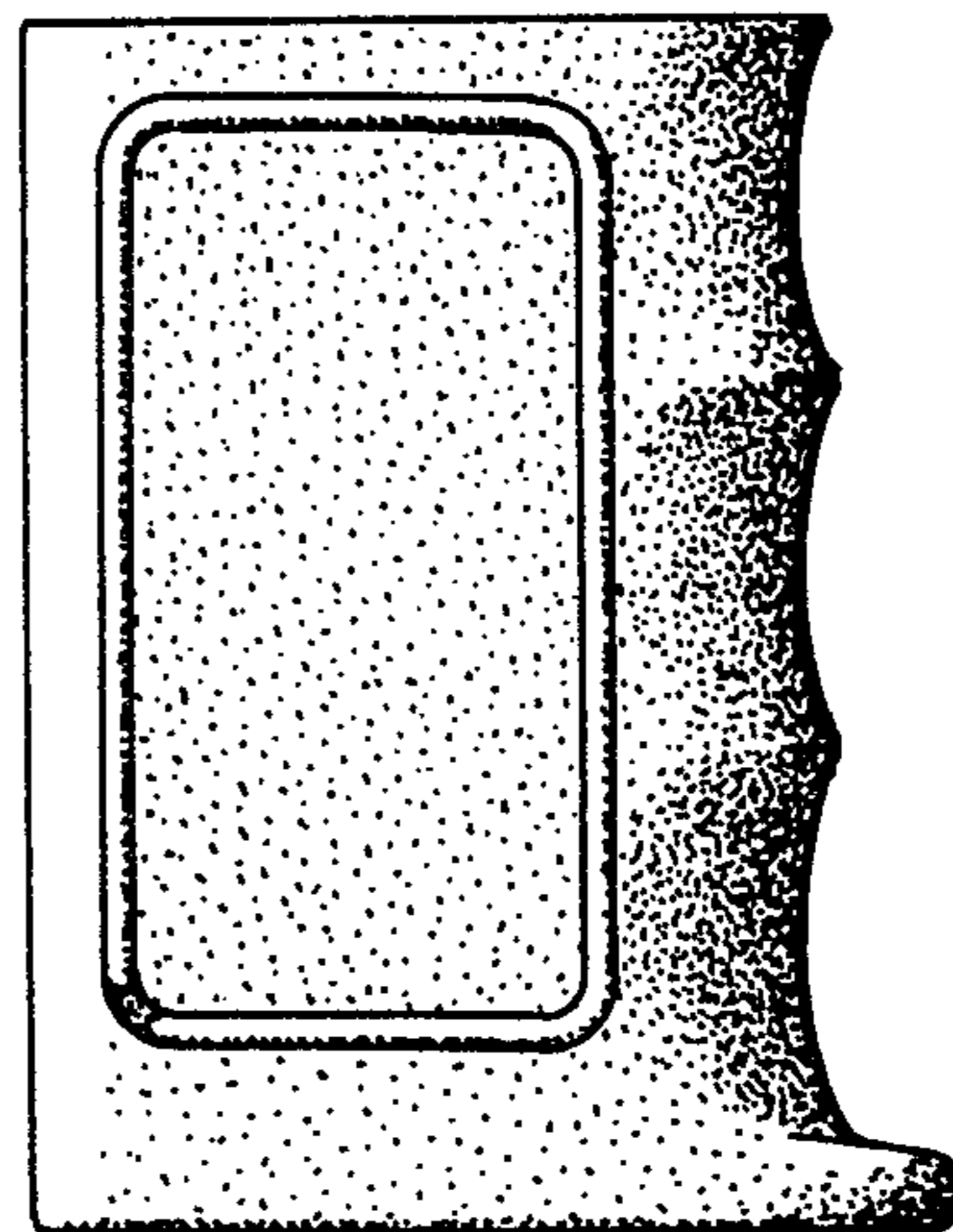
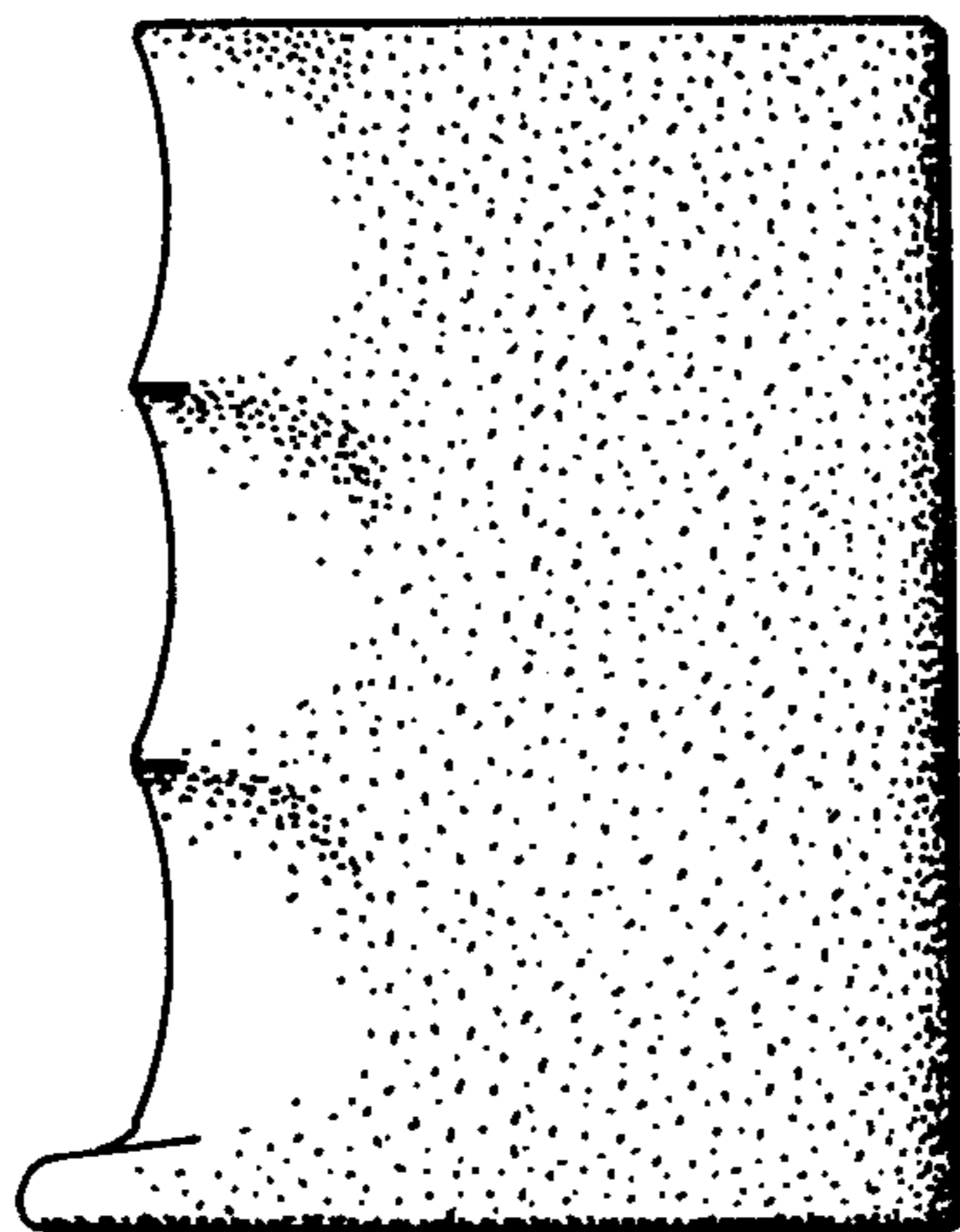

The ornamental design for an umbrella handle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of an umbrella handle showing my new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan thereof; and
FIG. 6 is a top plan view thereof.



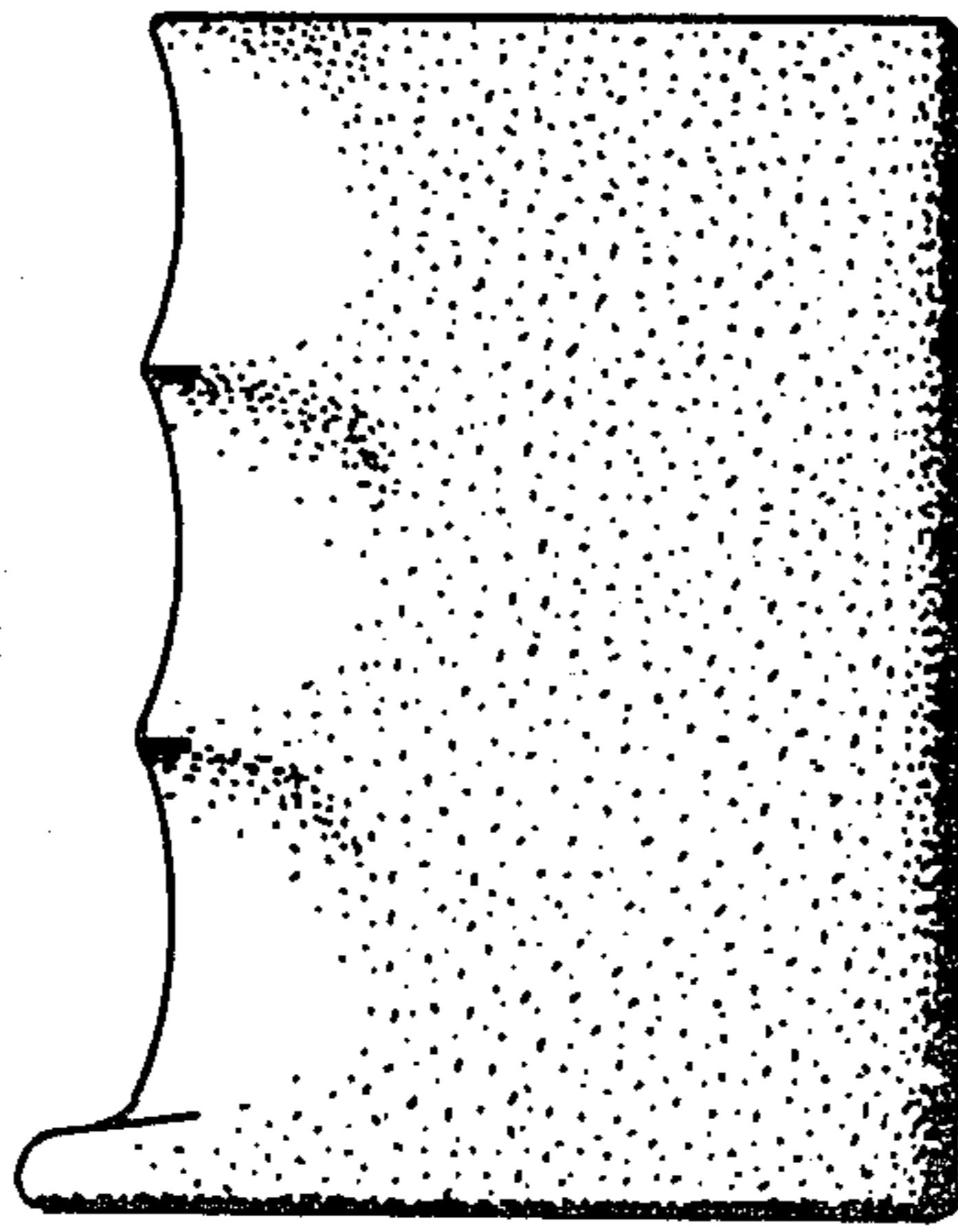

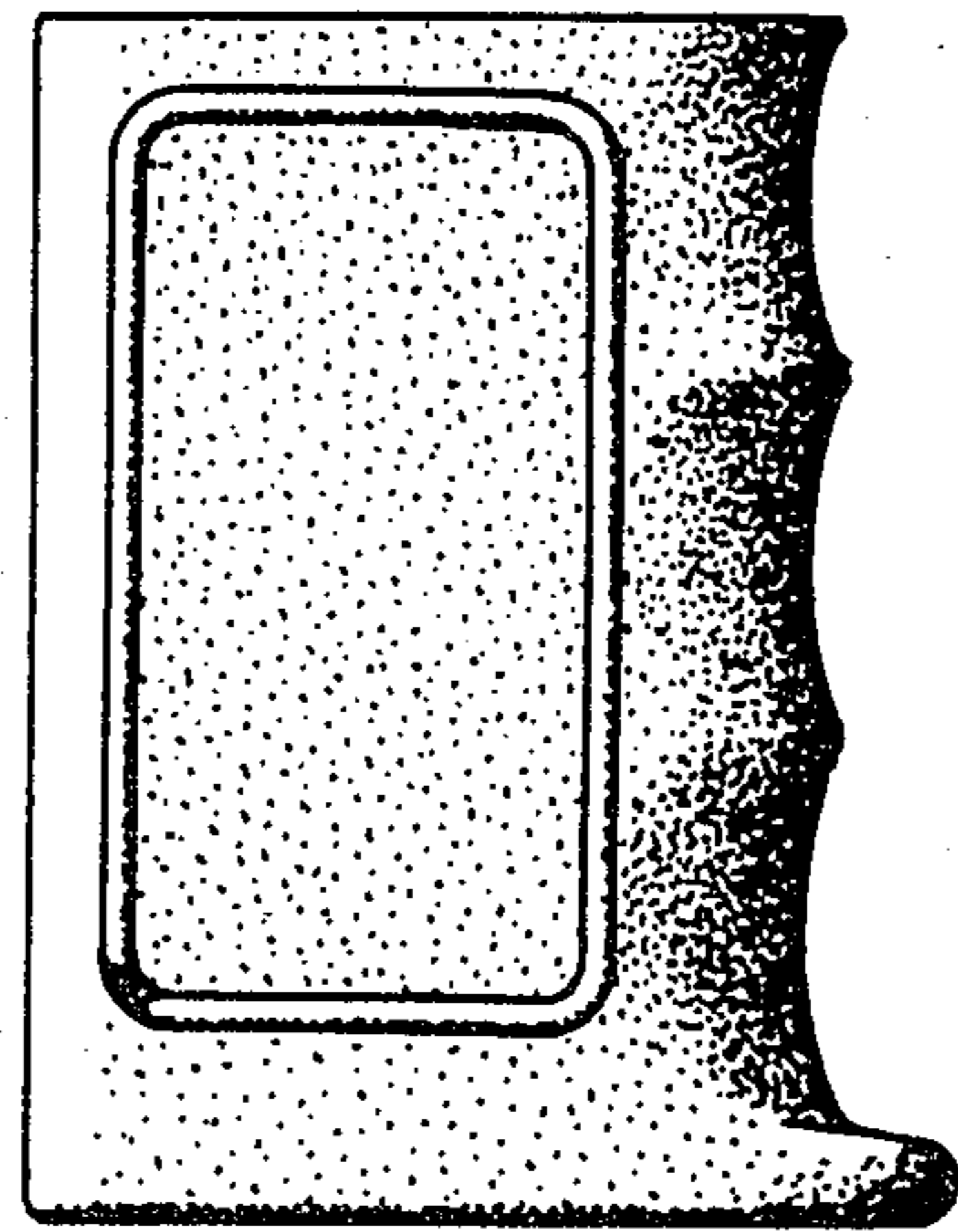

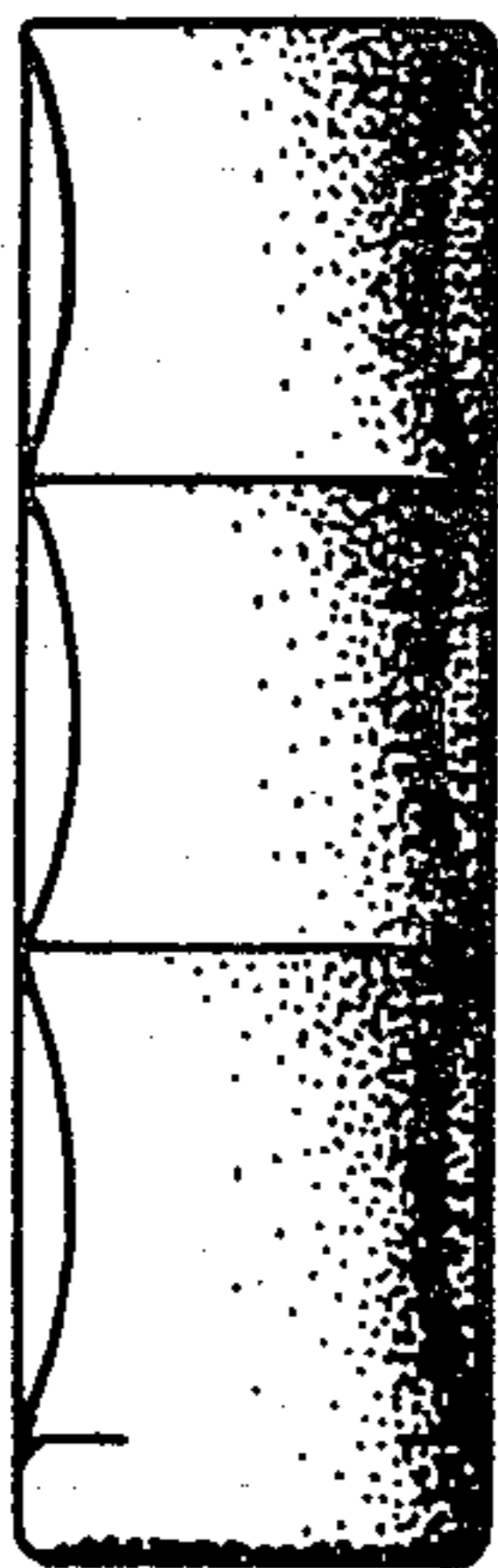

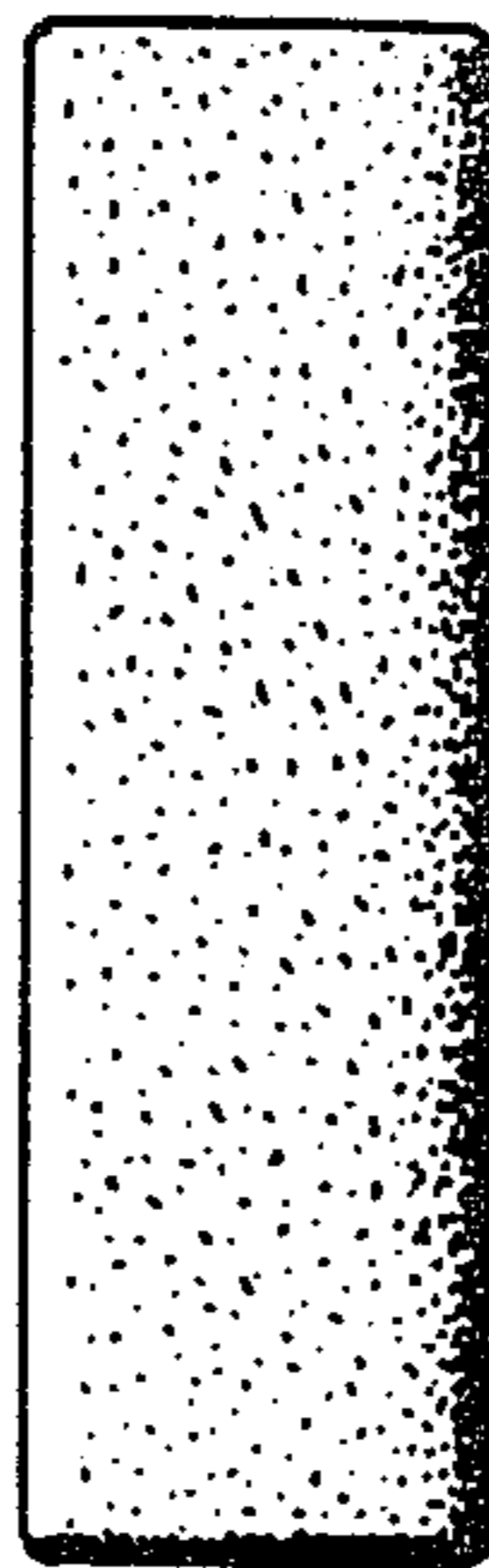

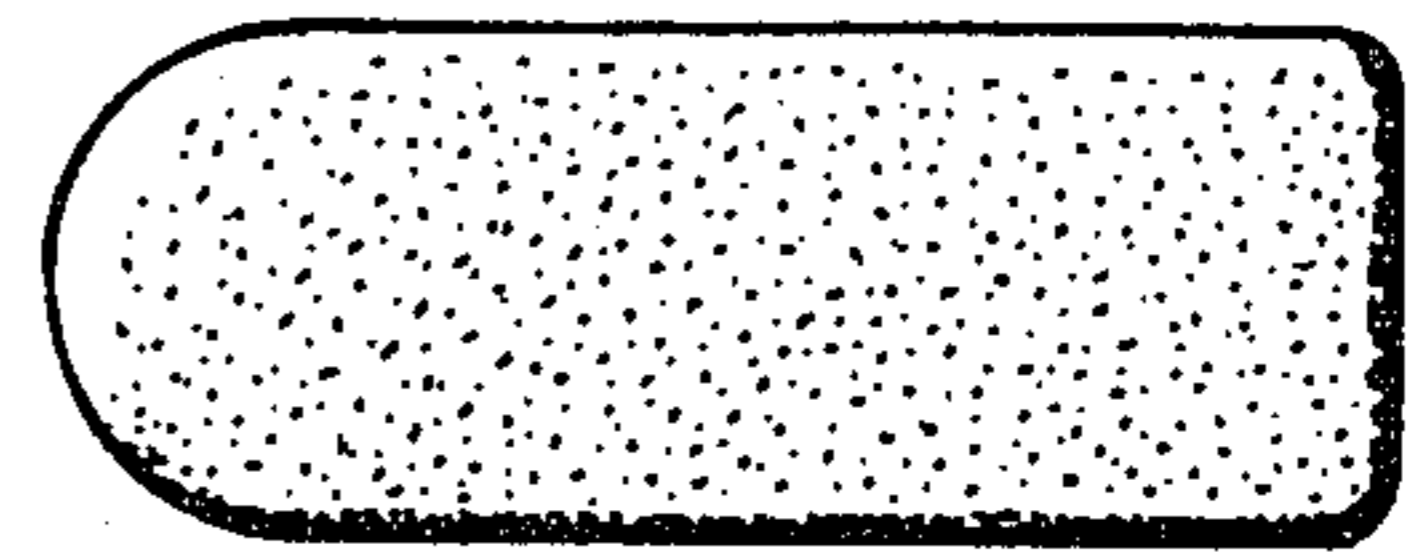

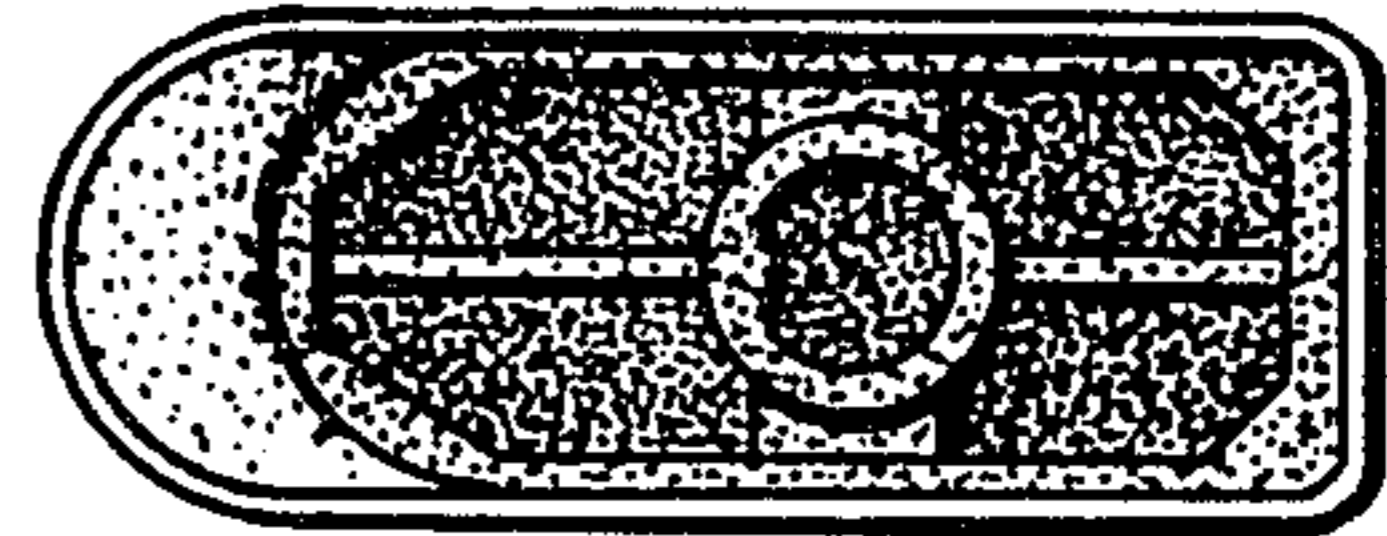
