[57] CLAIM

The ornamental design for a portable floral container, substantially as shown.

DESCRIPTION

FIG. 1 is a top front perspective view of a portable floral container embodying my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a sectional view taken in the direction of the arrows on line 3—3 of FIG. 1;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a right side elevational view thereof; and  
FIG. 7 is a bottom plan view thereof.

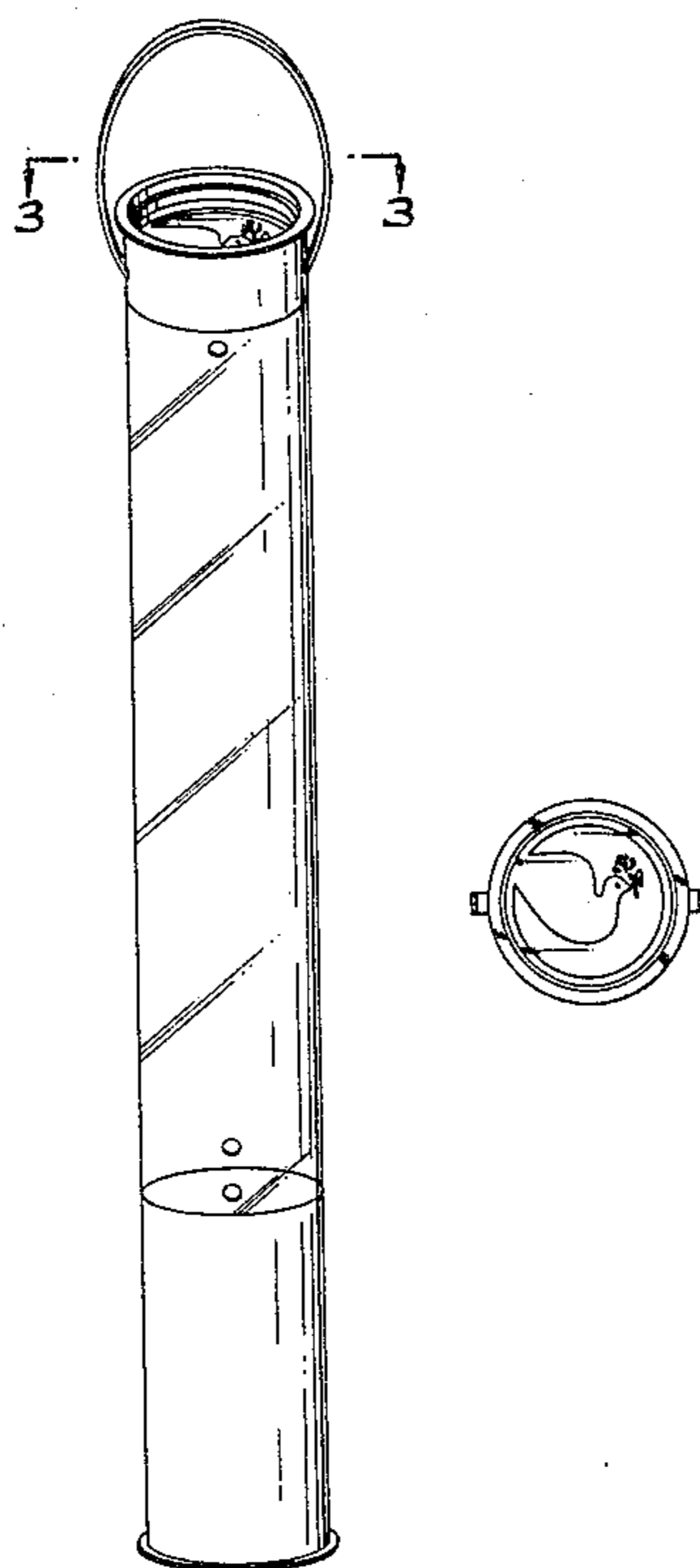

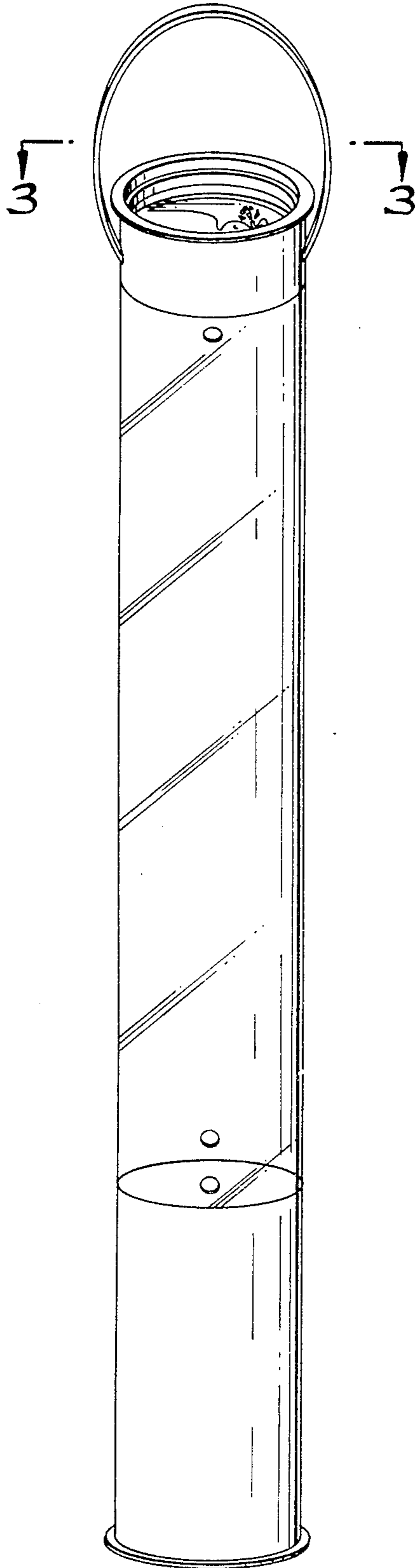

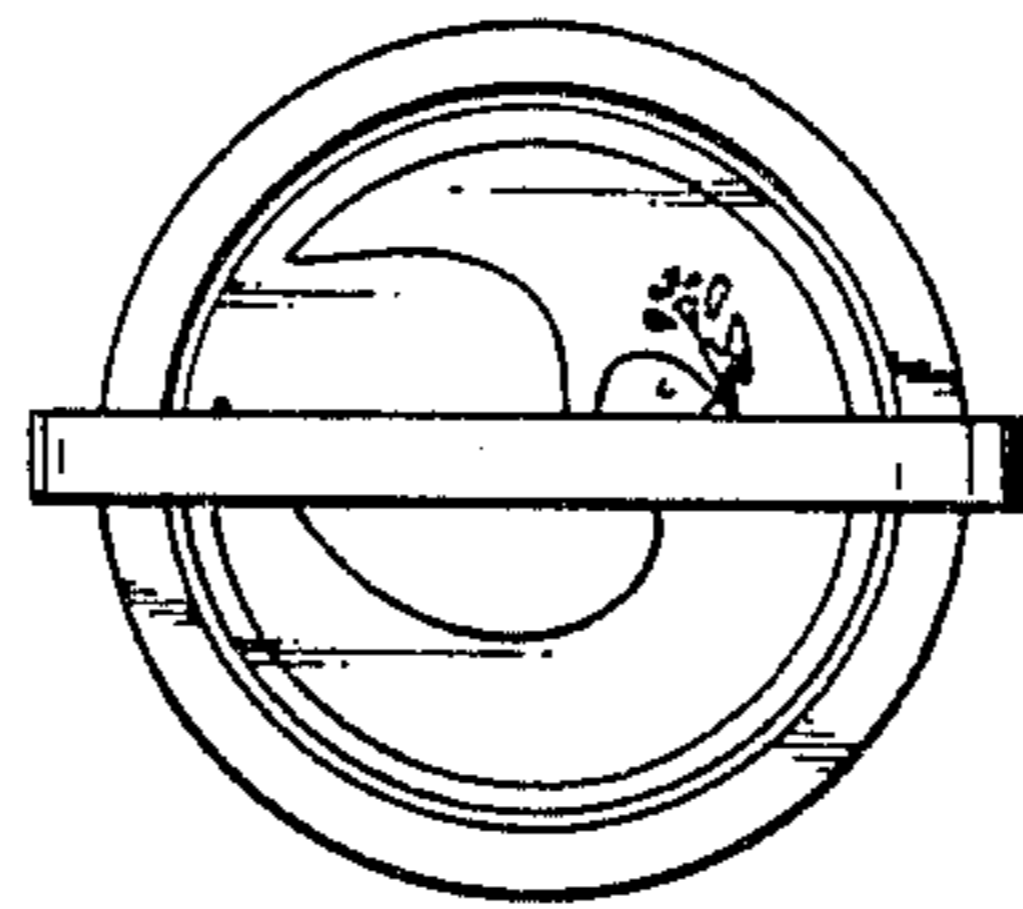
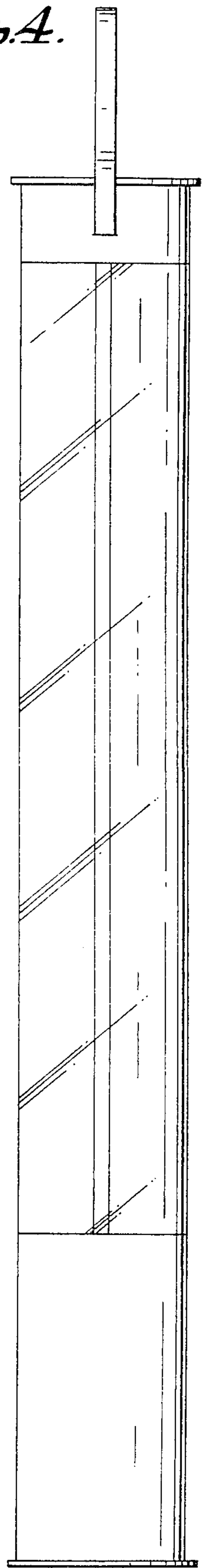

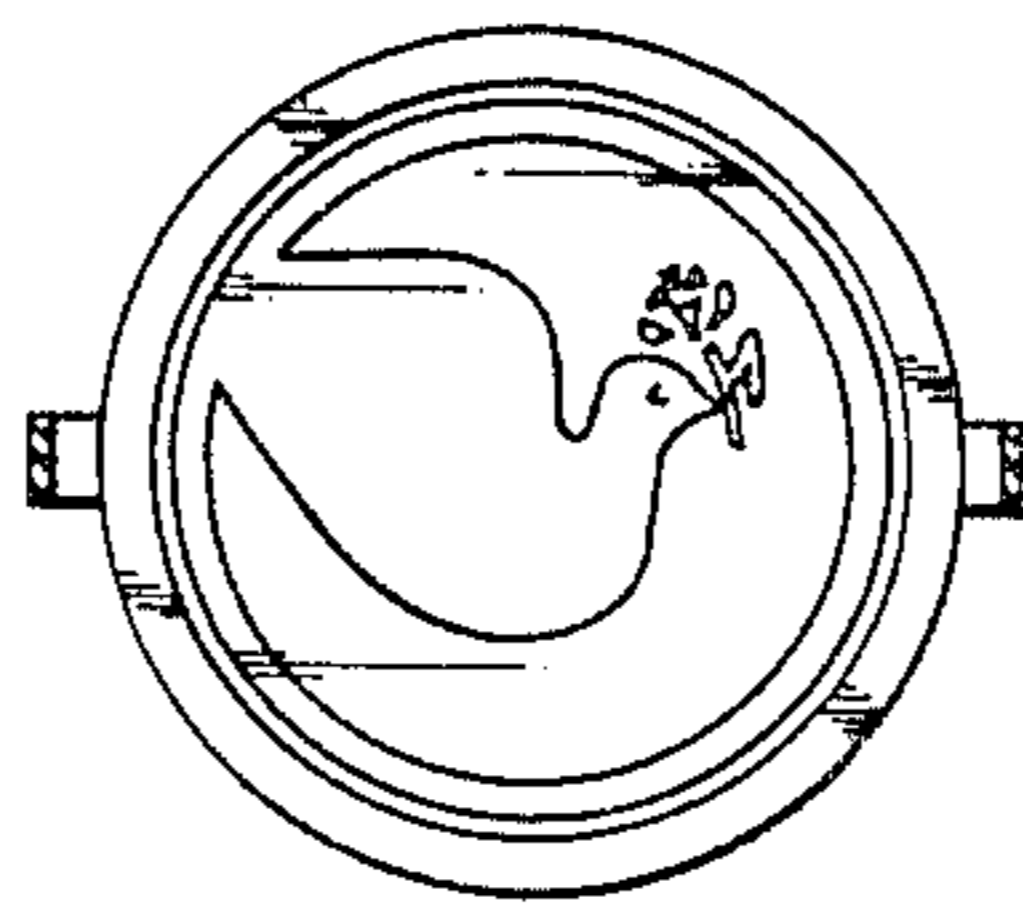

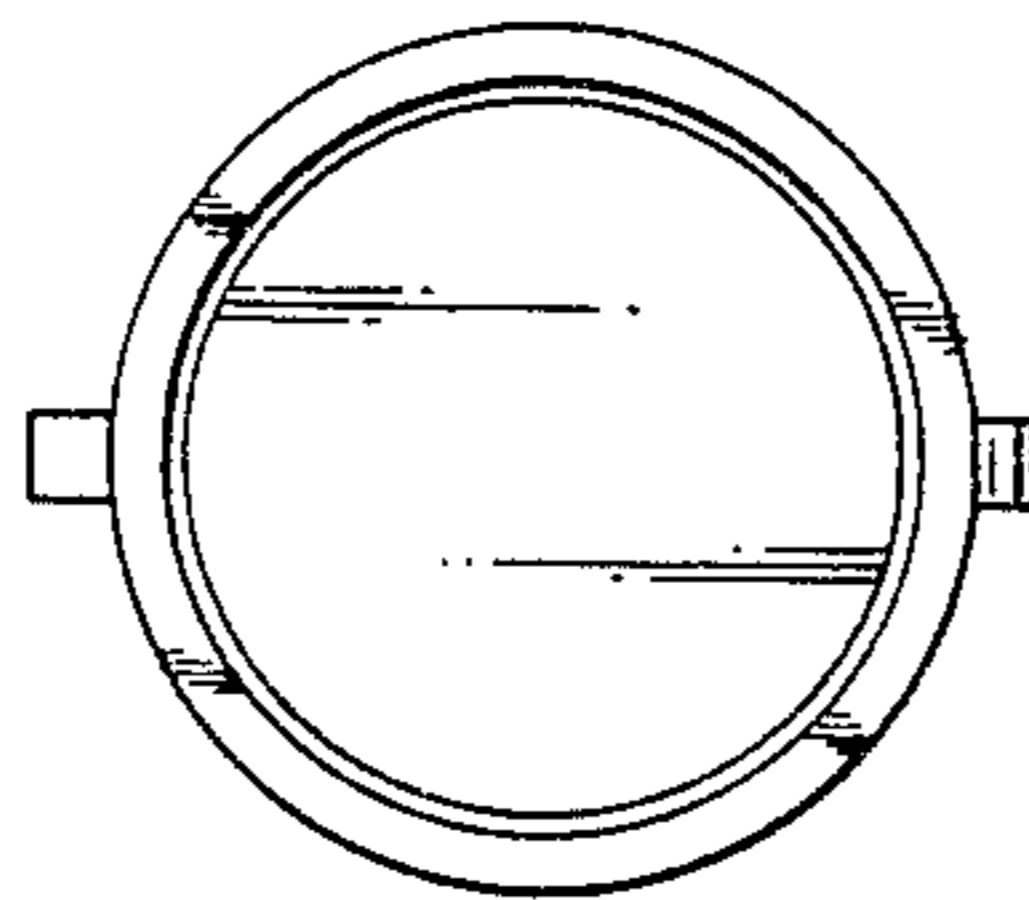

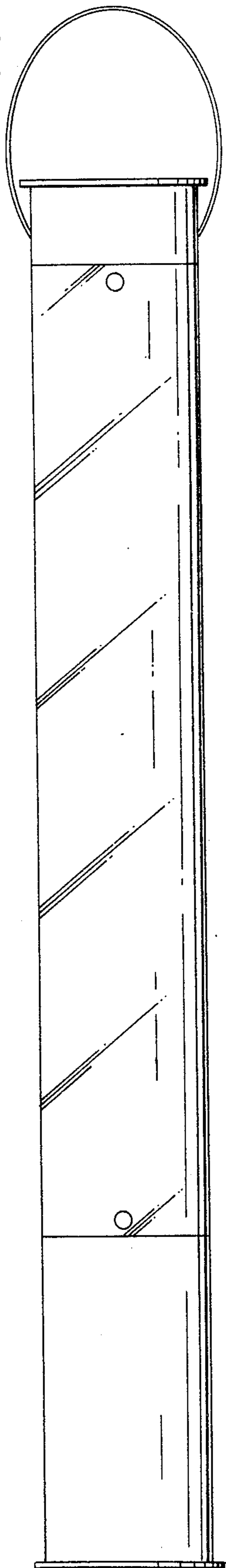
