[57] CLAIM

The ornamental design for a ring-lug terminal with attached magnet, as shown and described.

DESCRIPTION

FIG. 1 is an end elevational view of the ring-lug termi-

nal with attached magnet showing a first embodiment of my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is an opposite end elevational view thereof;

FIG. 4 is a side elevational view thereof, the opposite side being a mirror image;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is an end elevational view of a ring-lug terminal with attached magnet showing a second embodiment of my new design;

FIG. 7 is a top plan view thereof;

FIG. 8 is an opposite end elevational view thereof;

FIG. 9 is a side elevational view thereof, the opposite side being a mirror image;

FIG. 10 is a bottom plan view thereof;

FIG. 11 is an end elevational view of a ring-lug terminal with attached magnet showing a third embodiment of my new design;

FIG. 12 is a top plan view thereof;

FIG. 13 is an opposite end elevational view thereof;

FIG. 14 is a bottom plan view thereof;

FIG. 15 is an end elevational view of a ring-lug terminal with attached magnet showing a fourth embodiment of my new design;

FIG. 16 is a top plan view thereof;

FIG. 17 is an opposite end elevational view thereof;

FIG. 18 is a sectional view taken along line 18—18 of FIG. 16;

FIG. 19 is a bottom plan view thereof;

FIG. 20 is a perspective view thereof.

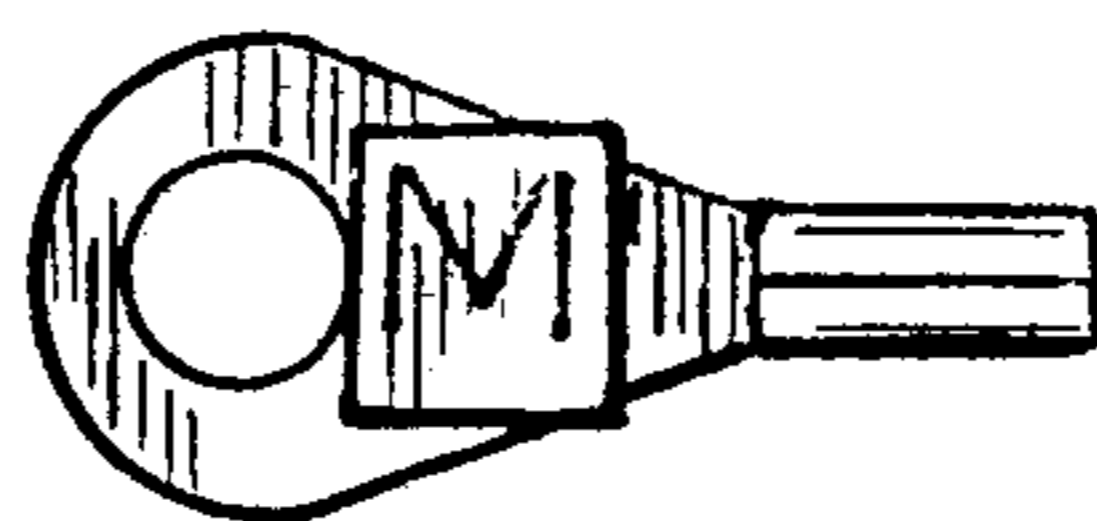

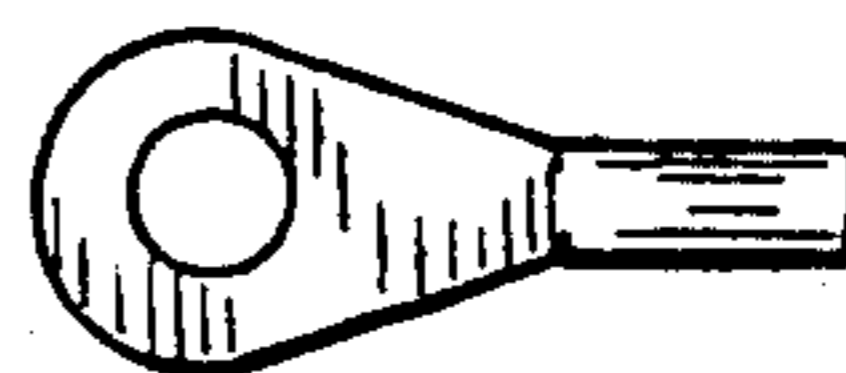

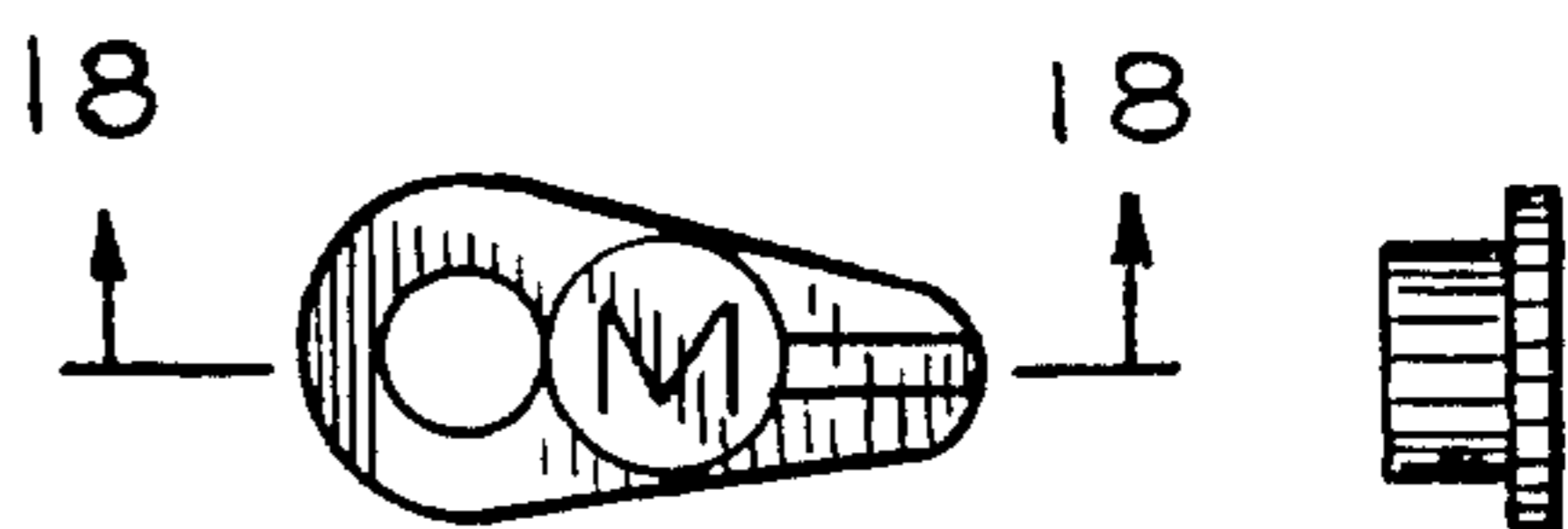

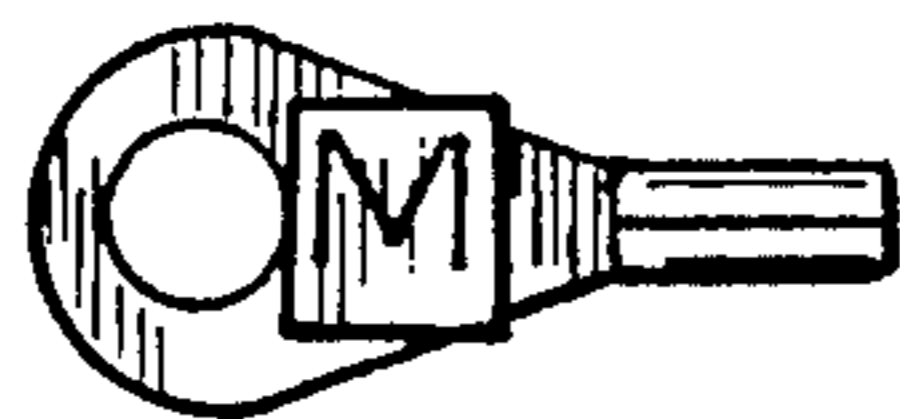

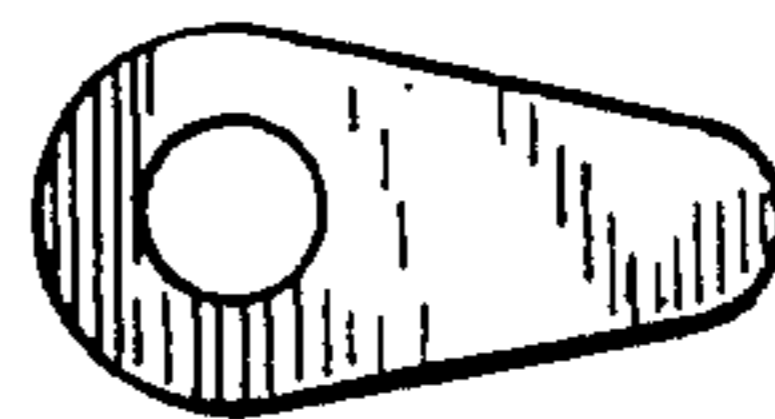

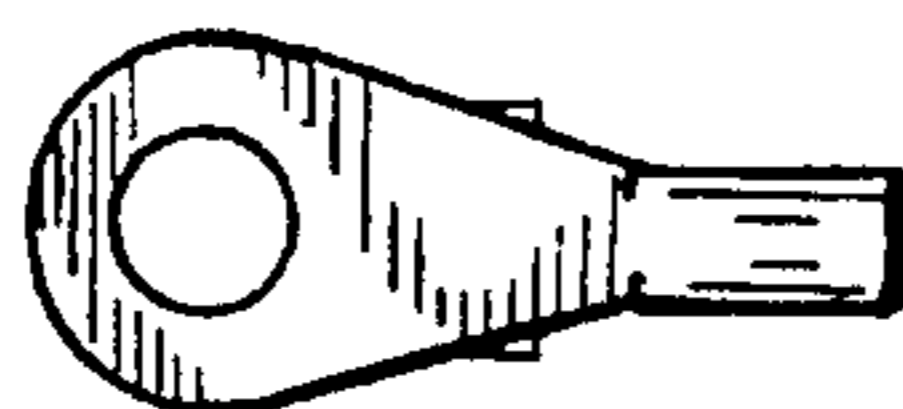

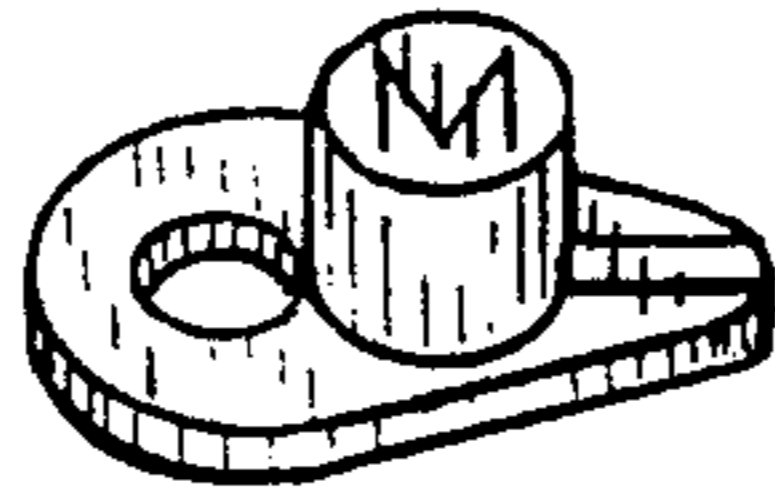
