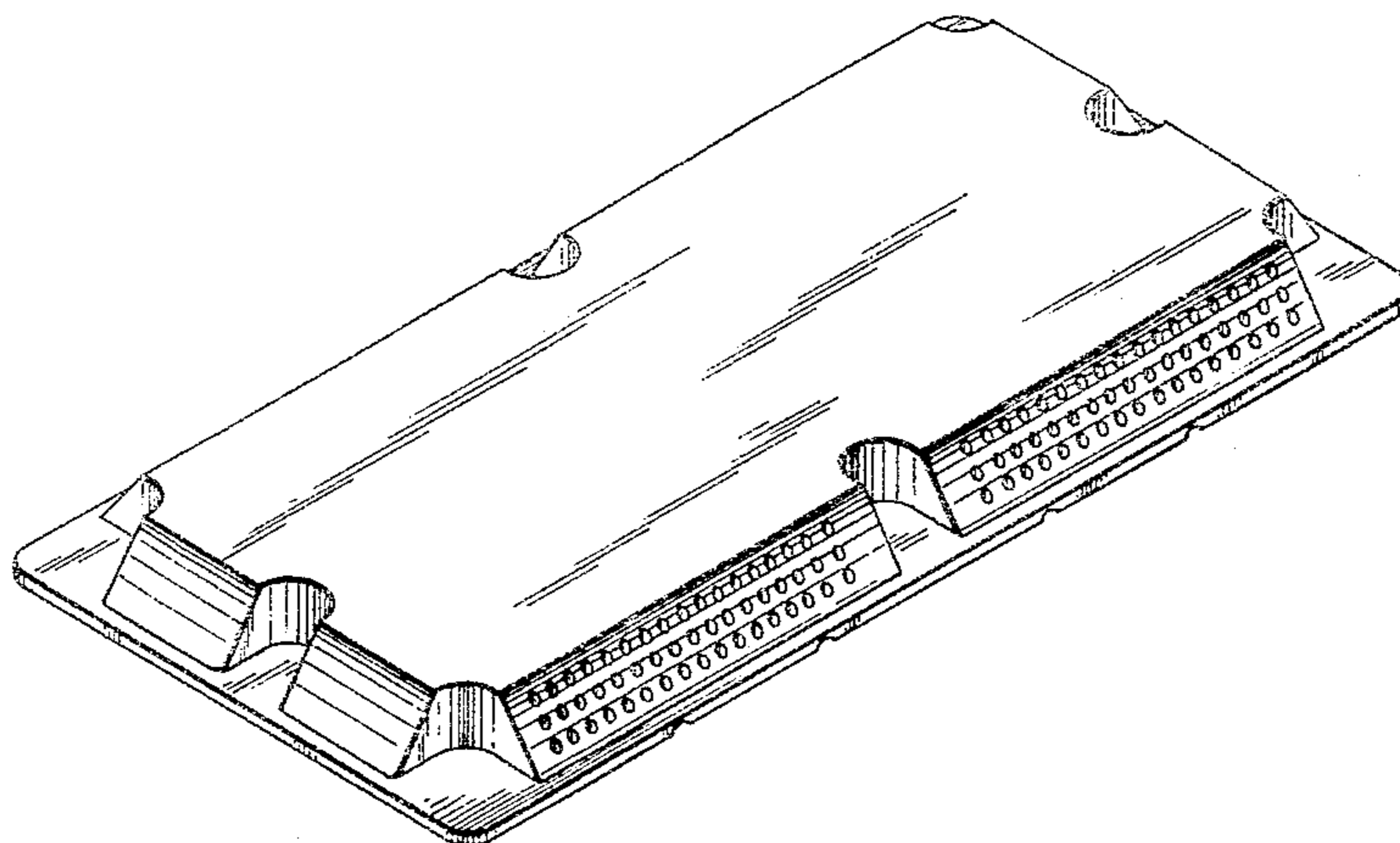

The ornamental design for a ventilator for cargo container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a ventilator for cargo container showing my new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a frontal elevational view thereof, the rear elevational view being a mirror image of FIG. 4;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a right side view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a sectional view thereof, taken along line 8—8 of FIG. 7;
 FIG. 9 is a top plan view of a second embodiment thereof;
 FIG. 10 is a front elevational view thereof, the rear elevational view being a mirror image of FIG. 10;
 FIG. 11 is a left elevational view thereof;
 FIG. 12 is a right elevational view thereof;
 FIG. 13 is a bottom plan view thereof;
 FIG. 14 is a sectional view thereof, taken along line 14—14 of FIG. 11; and
 FIG. 15 is a bottom perspective view thereof.



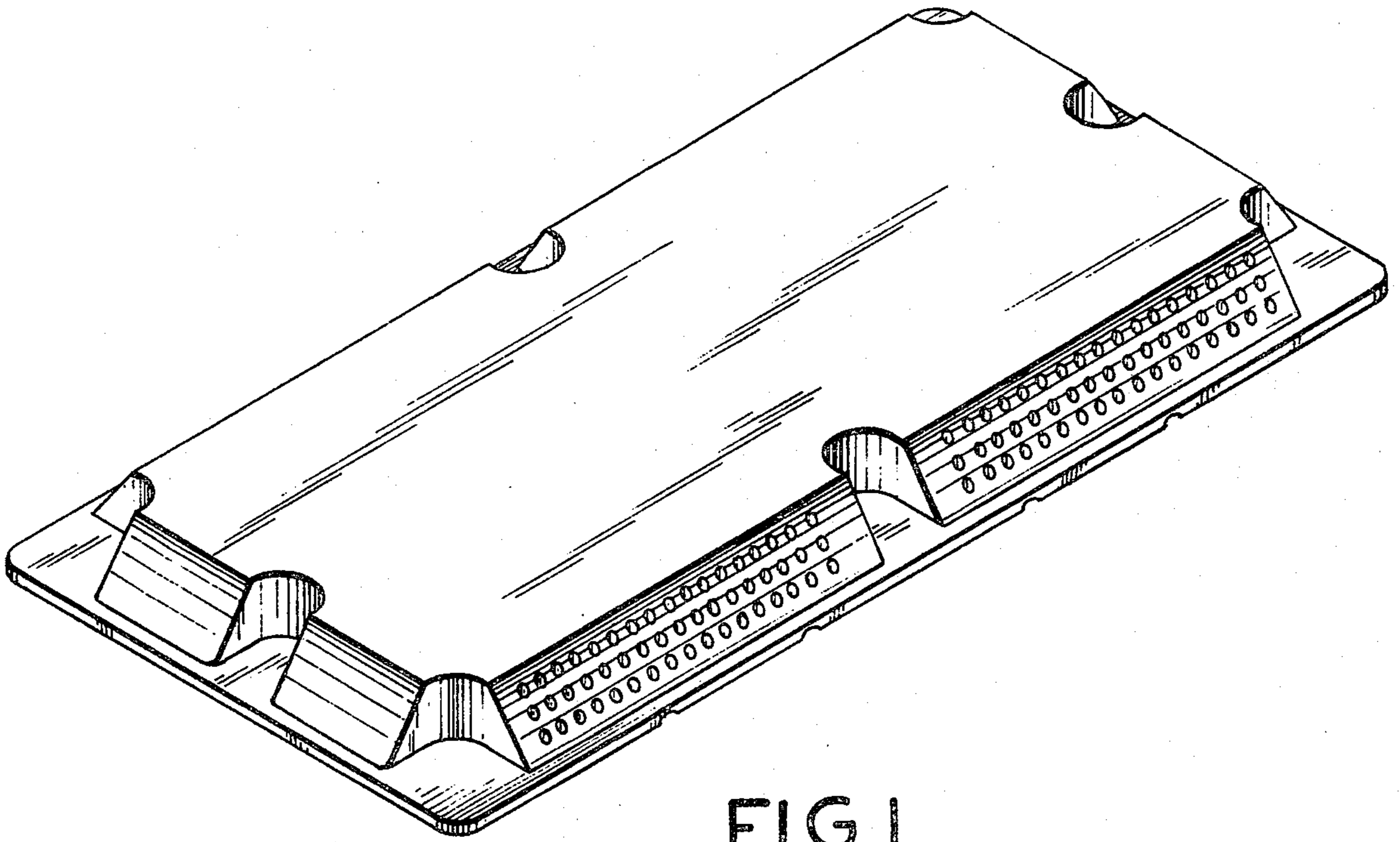

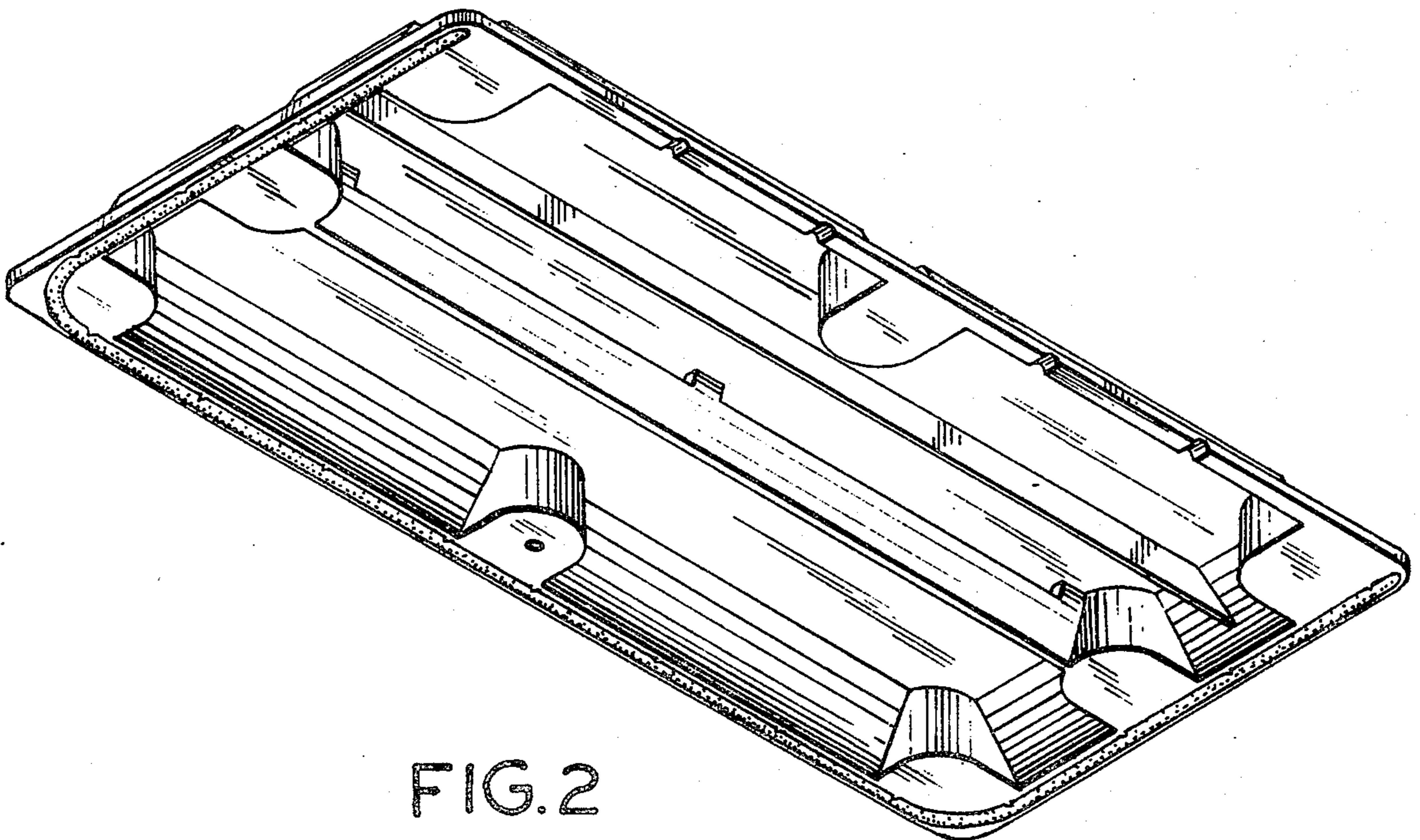

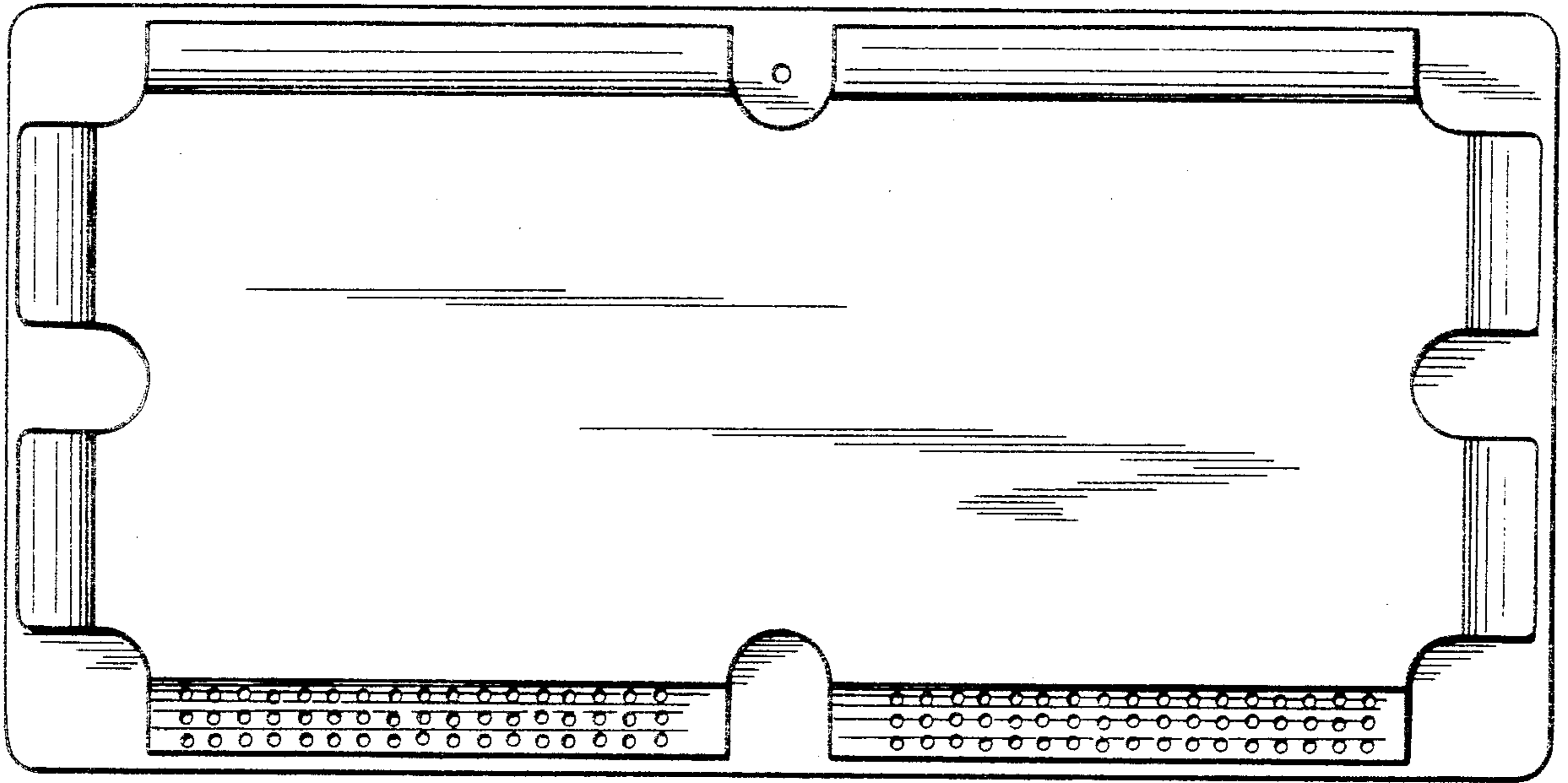

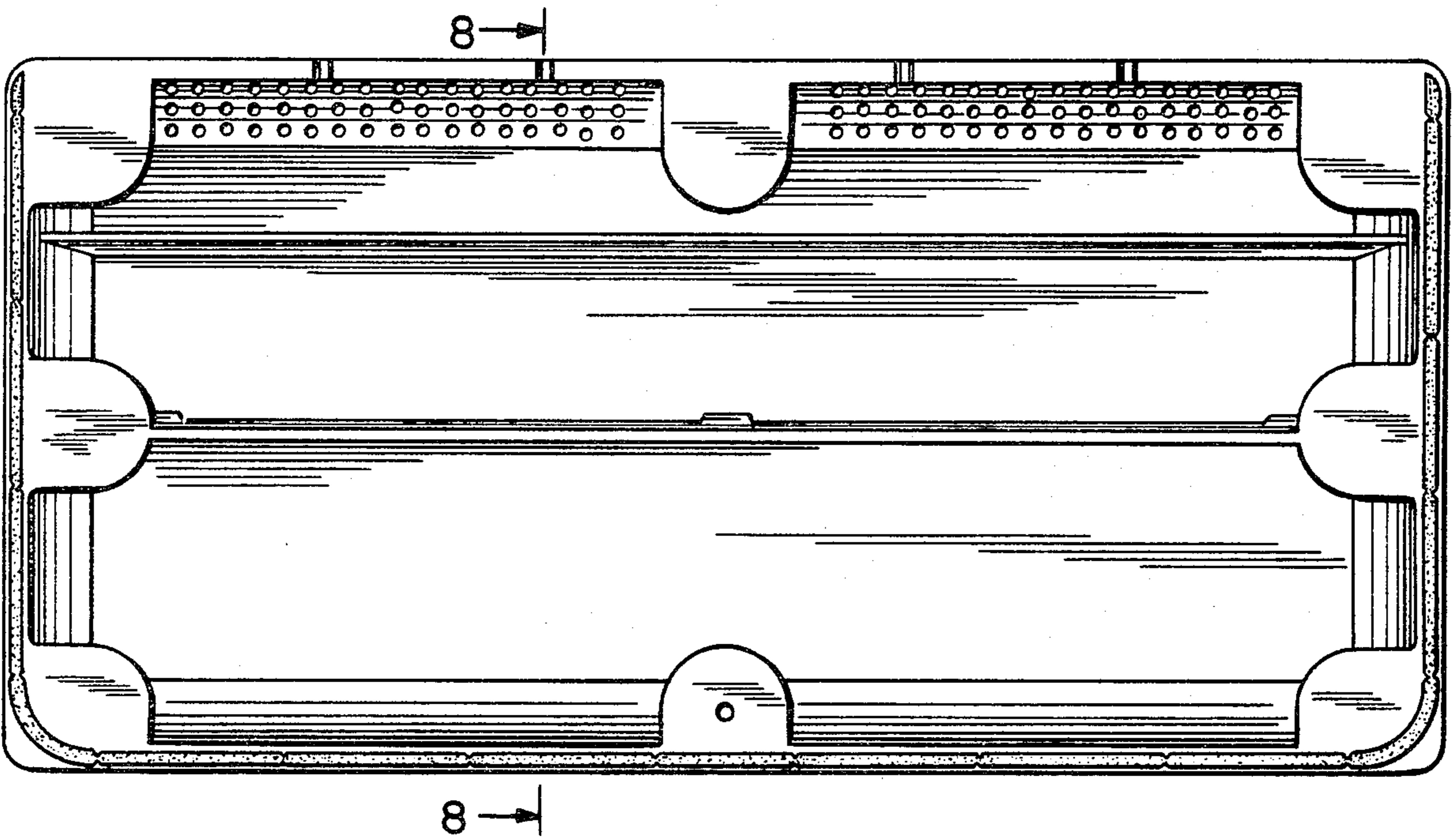

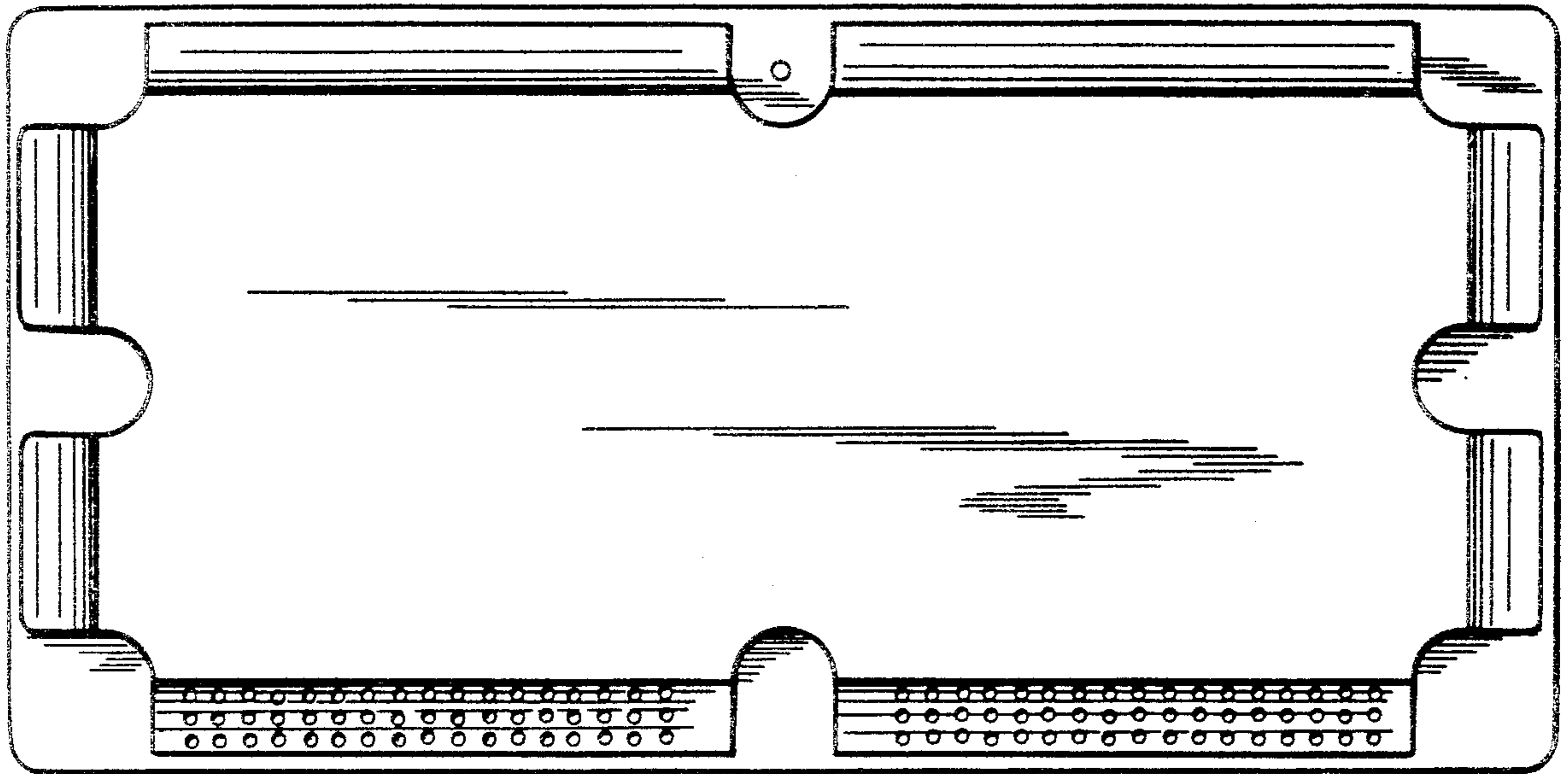

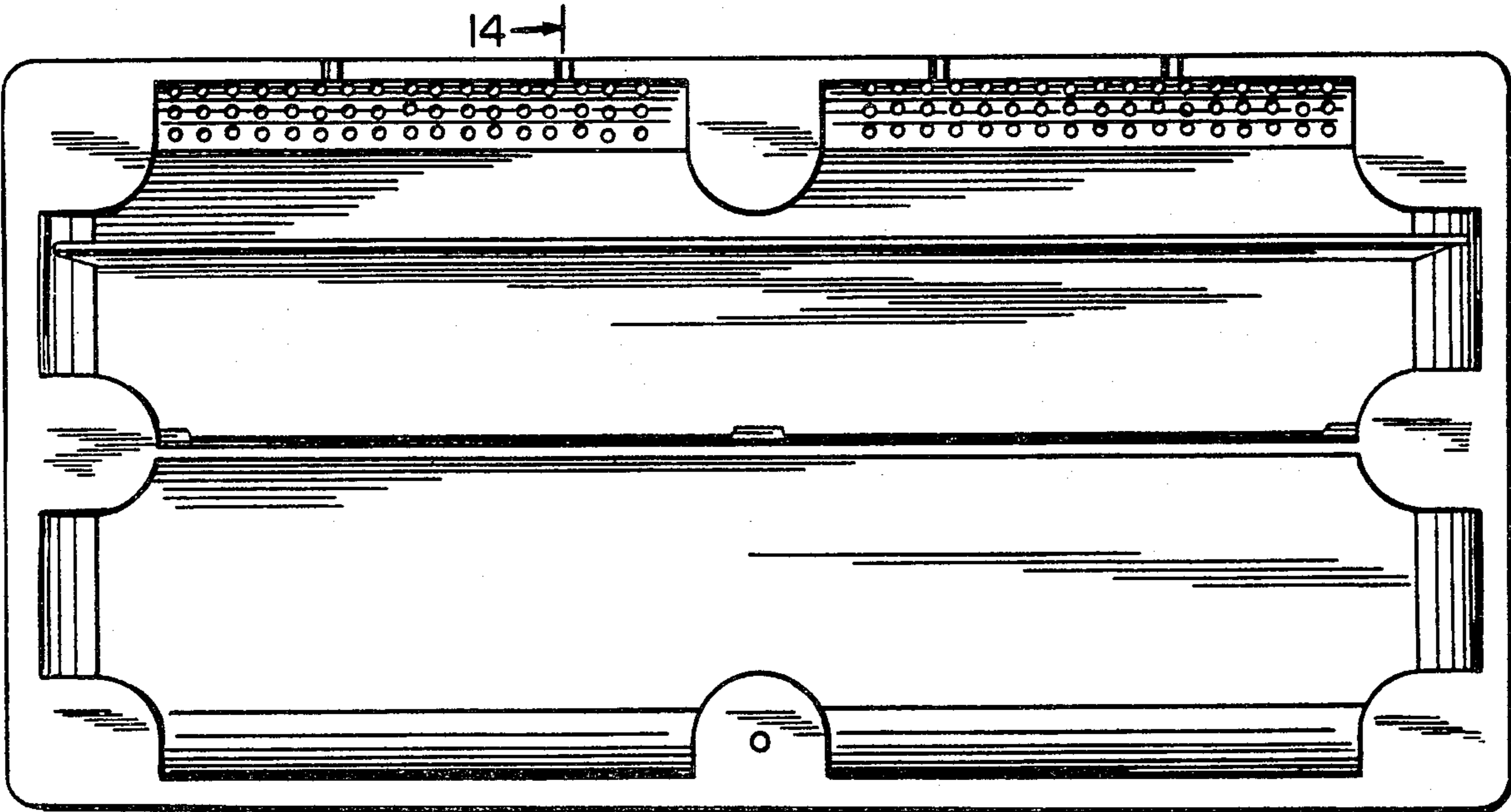

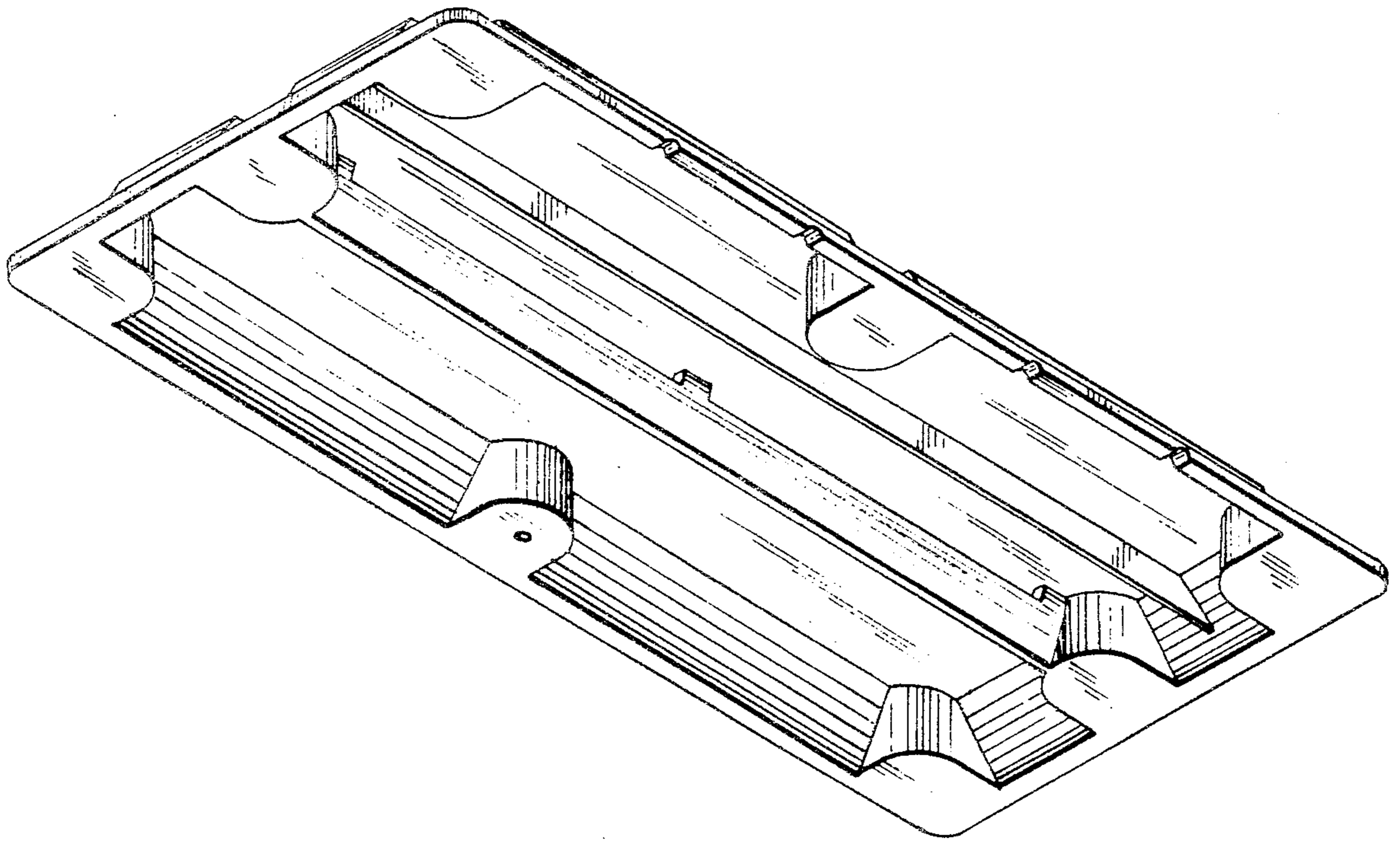
