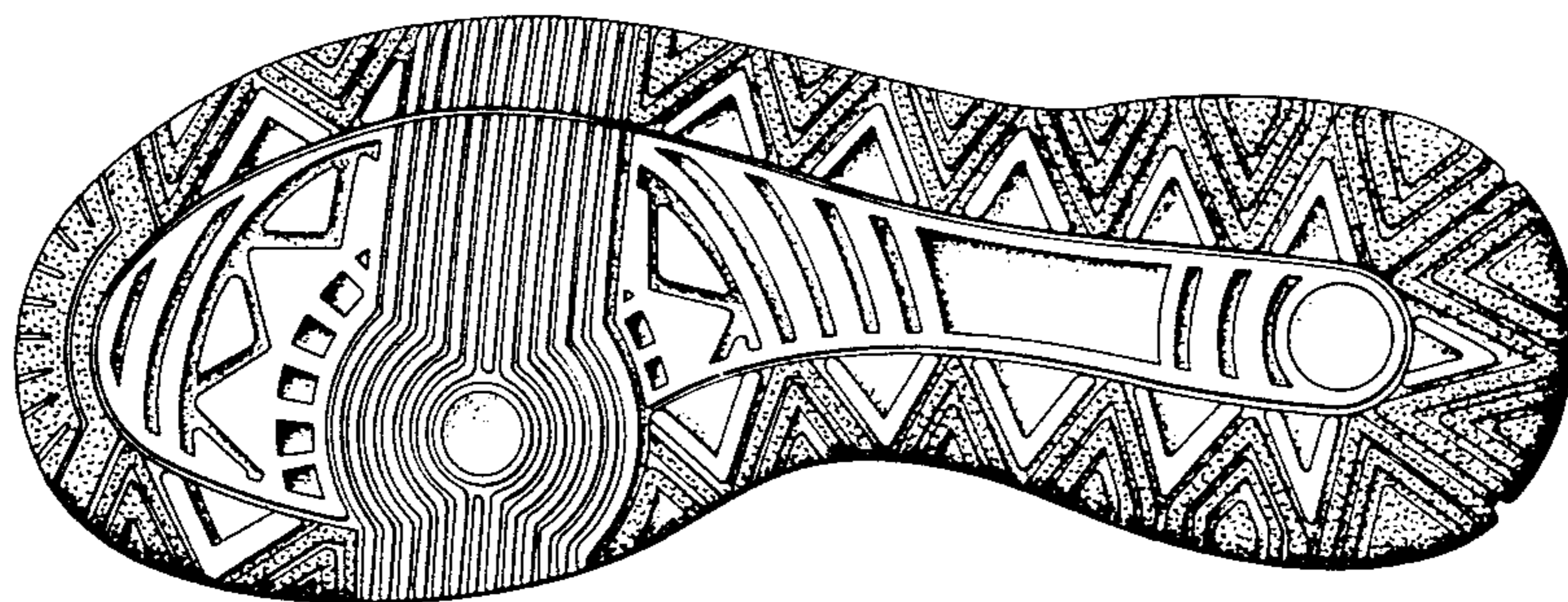

[57] CLAIM

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a shoe sole showing our new design, the broken line showing of a shoe upper being environmental only and forms no part of the claimed design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a rear elevational view thereof.



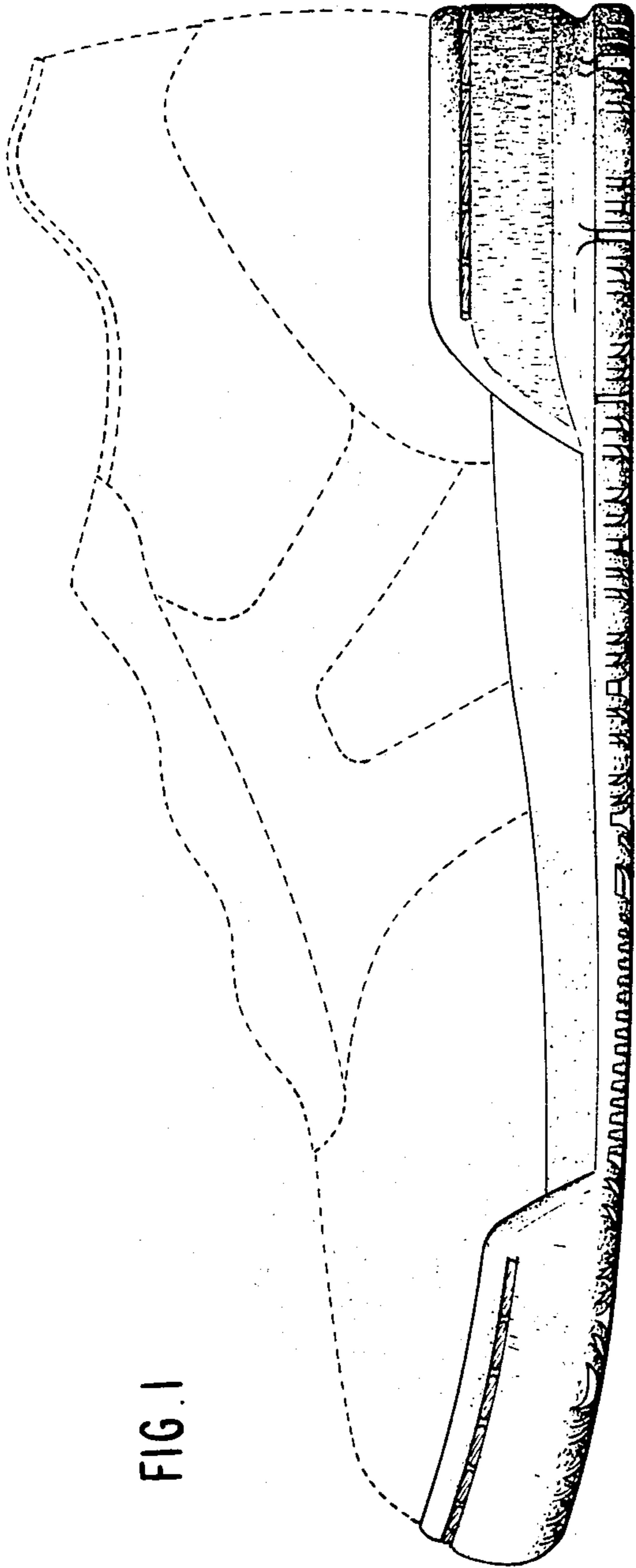

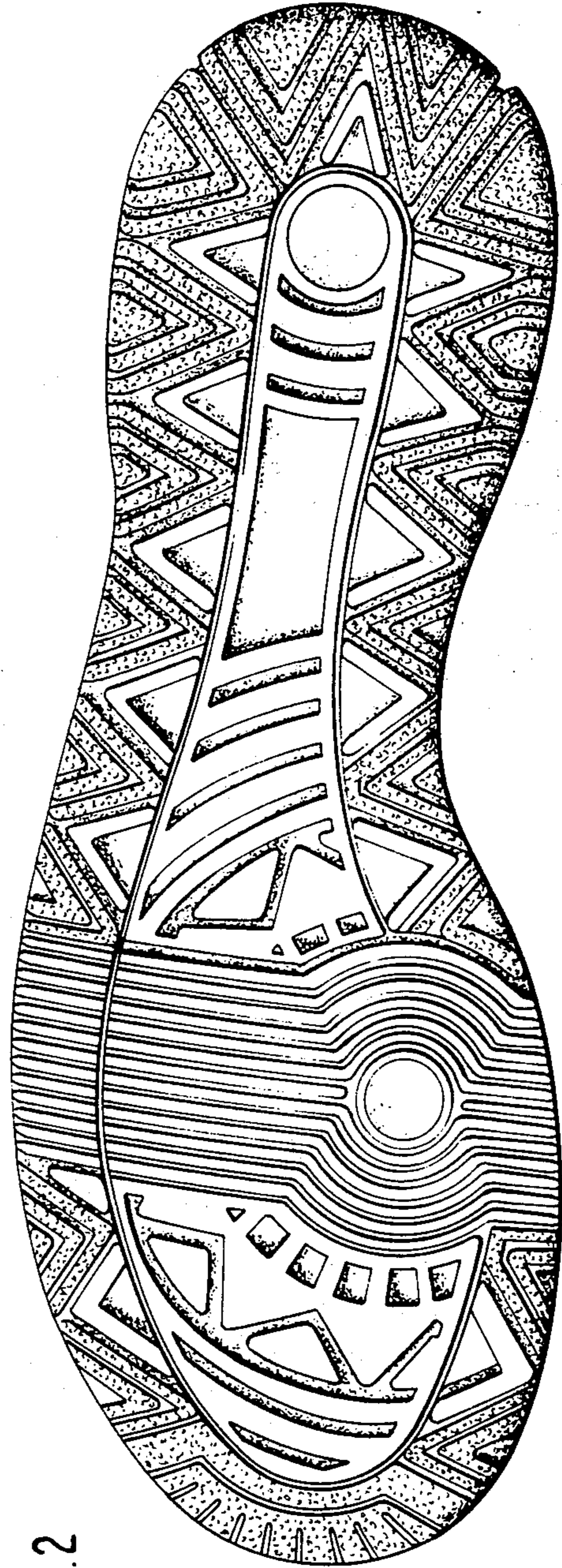

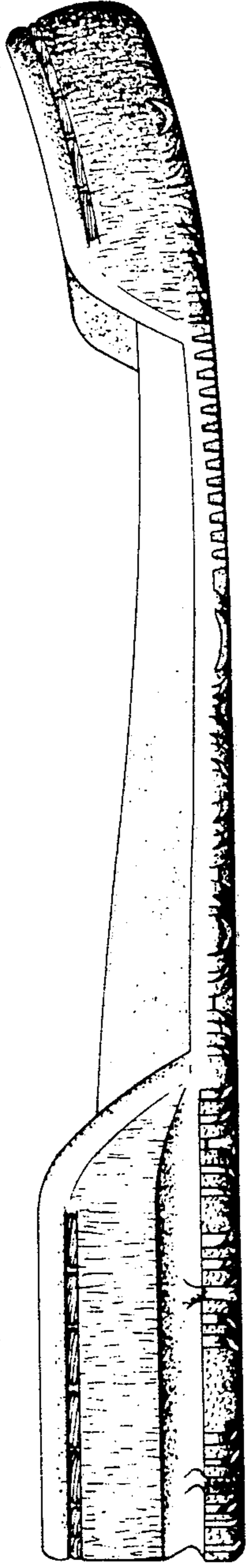

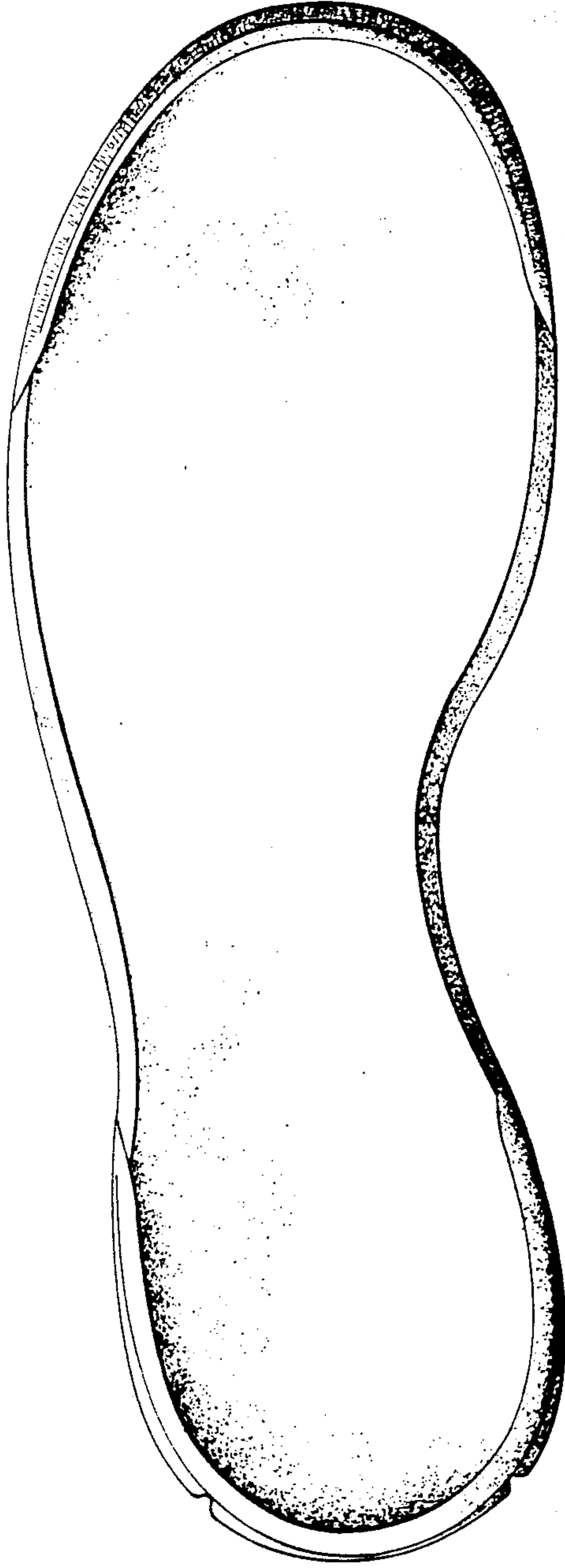

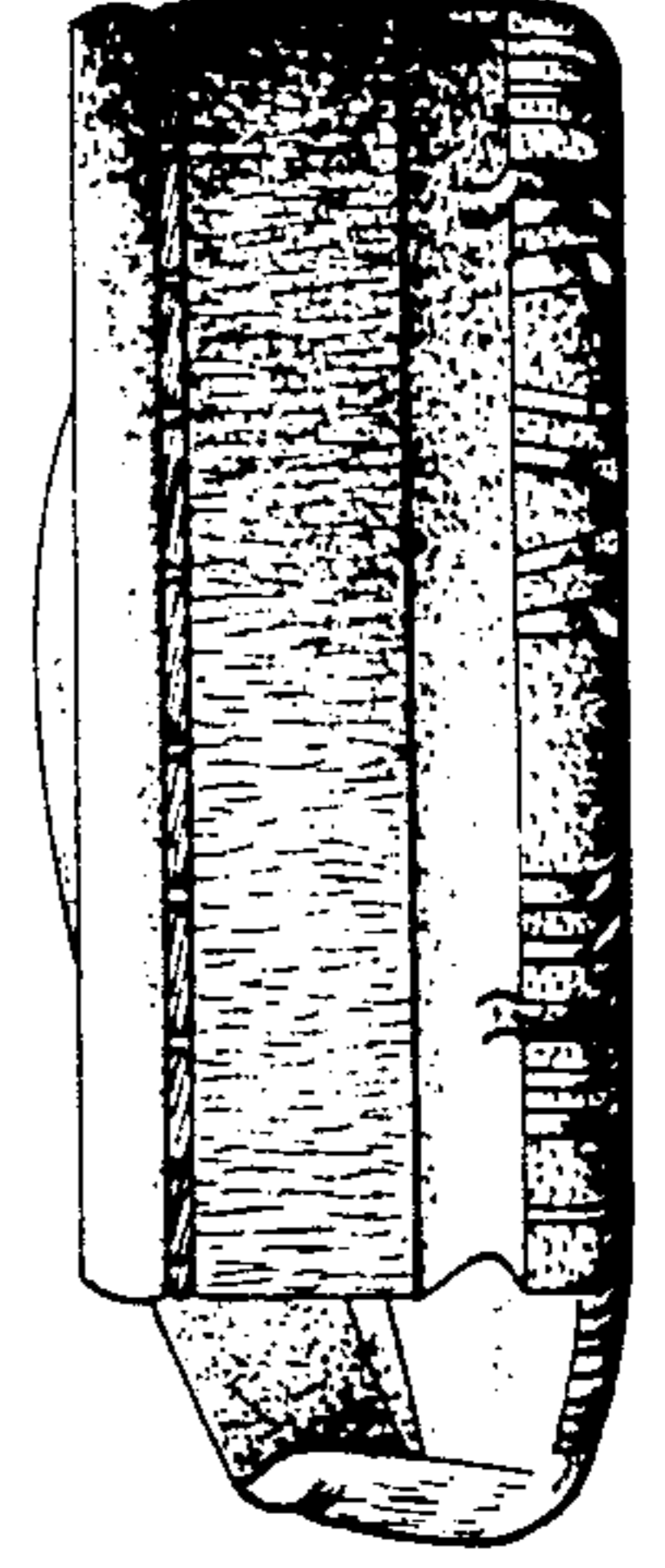

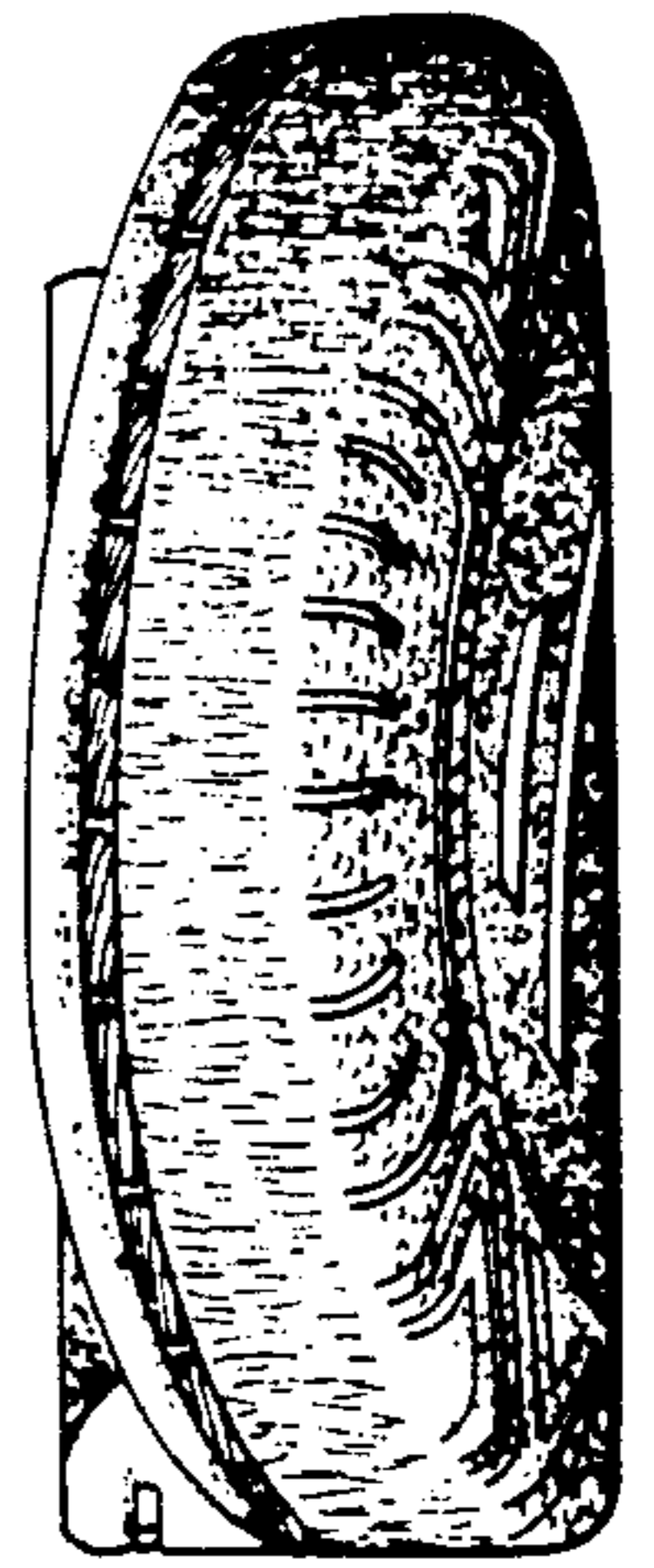
