[57] CLAIM

The ornamental design for a telephone handset, as shown and described.

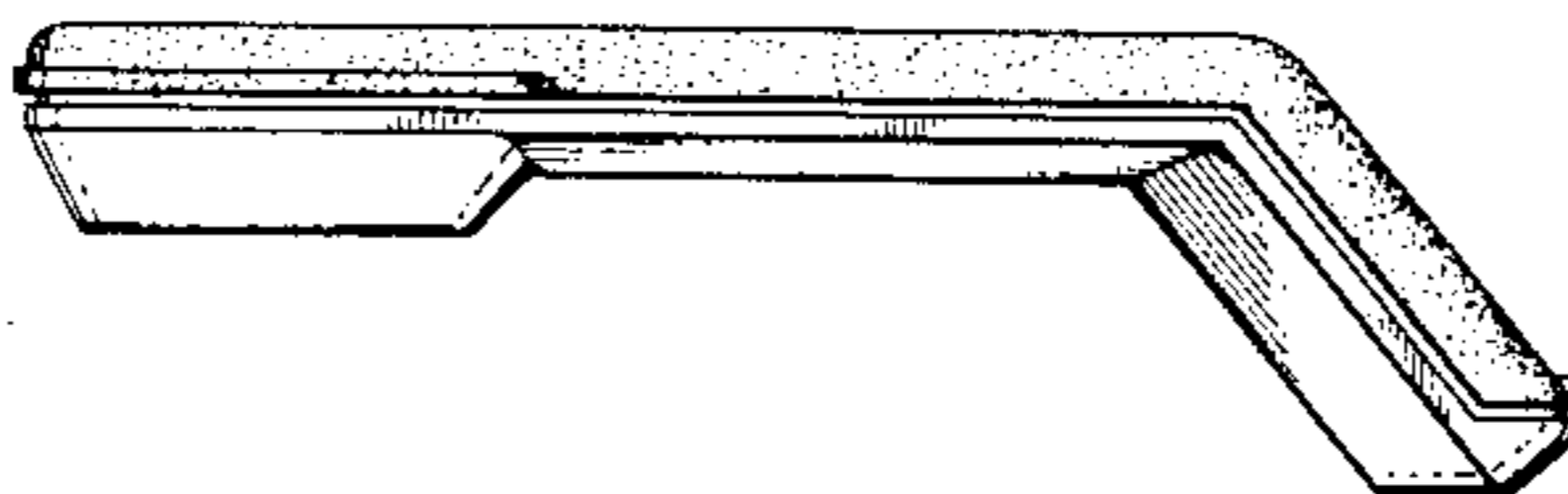
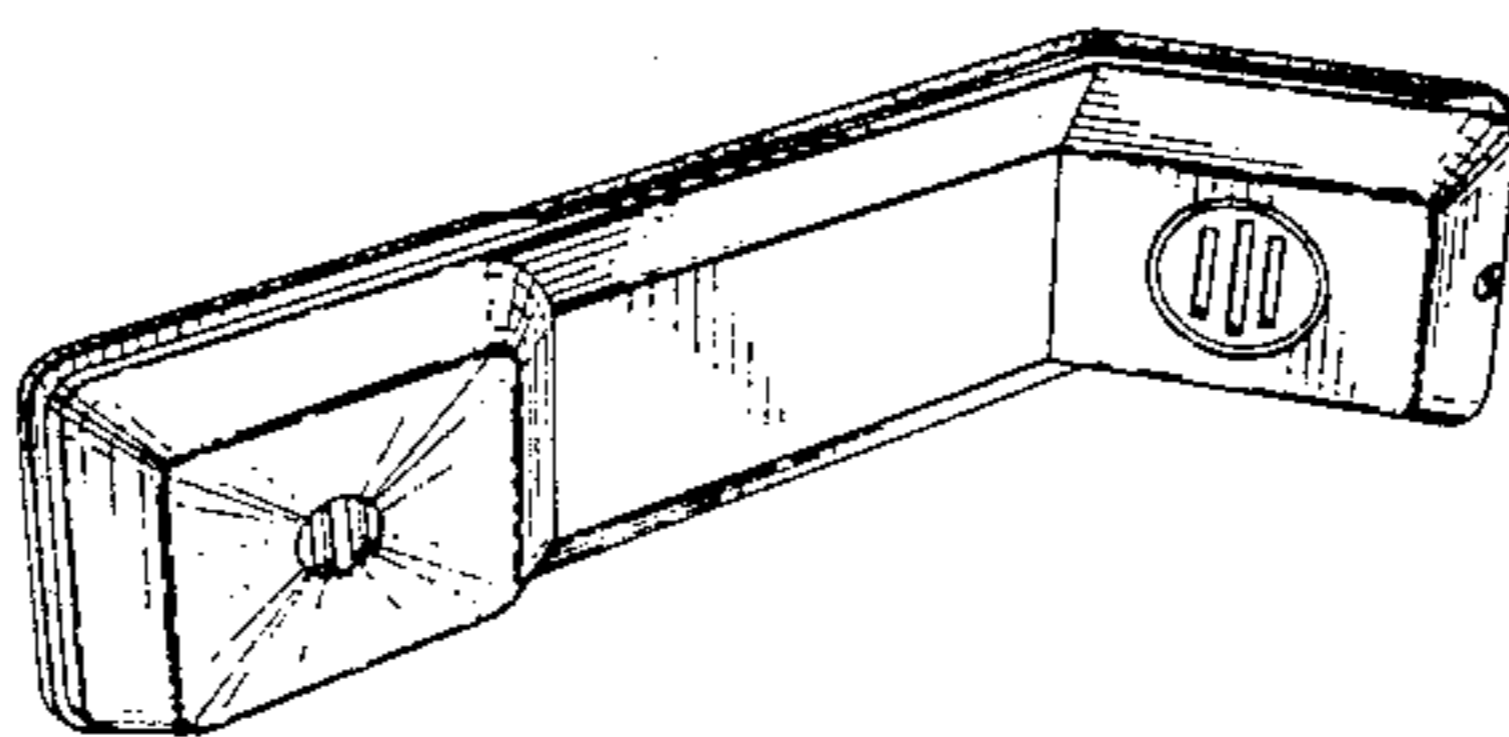

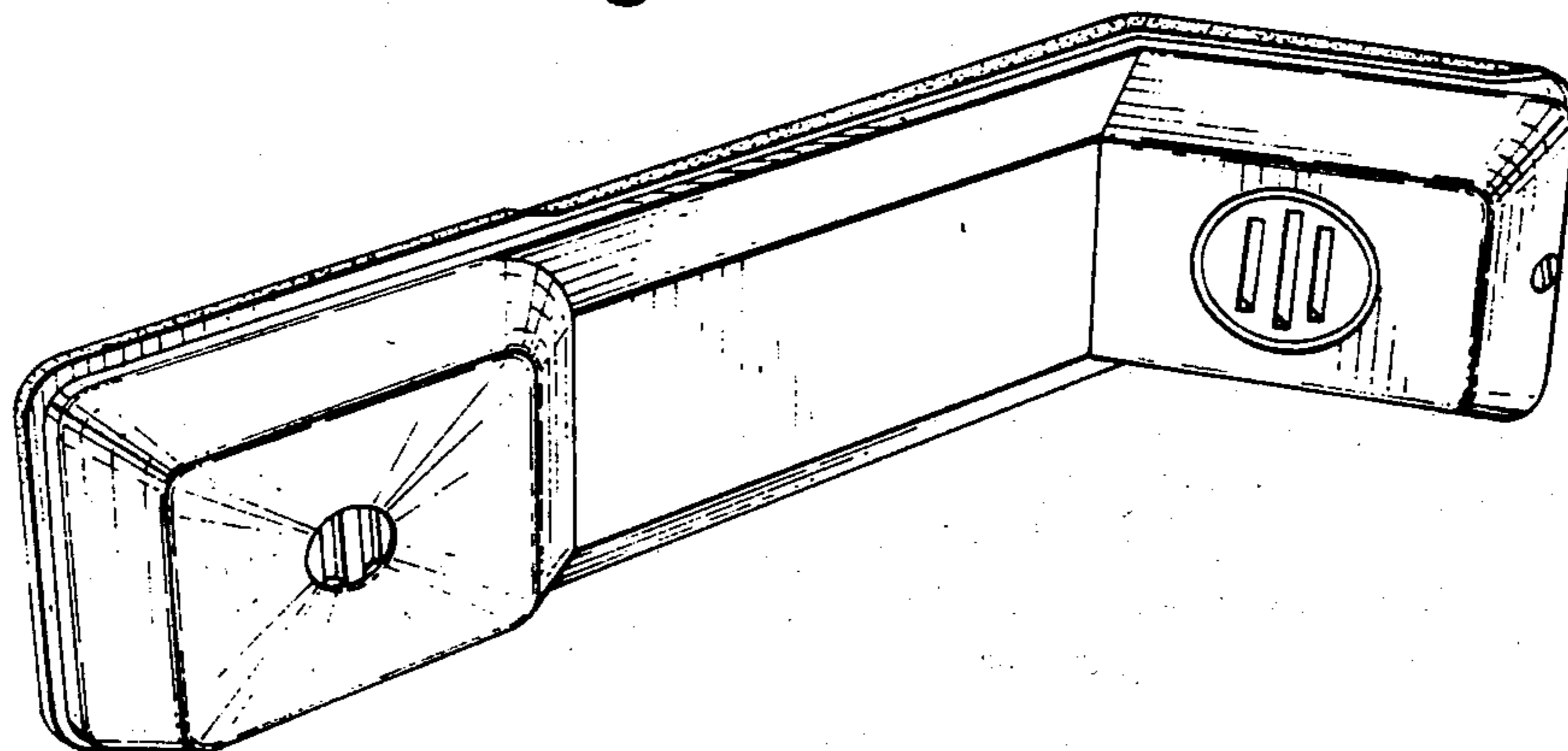

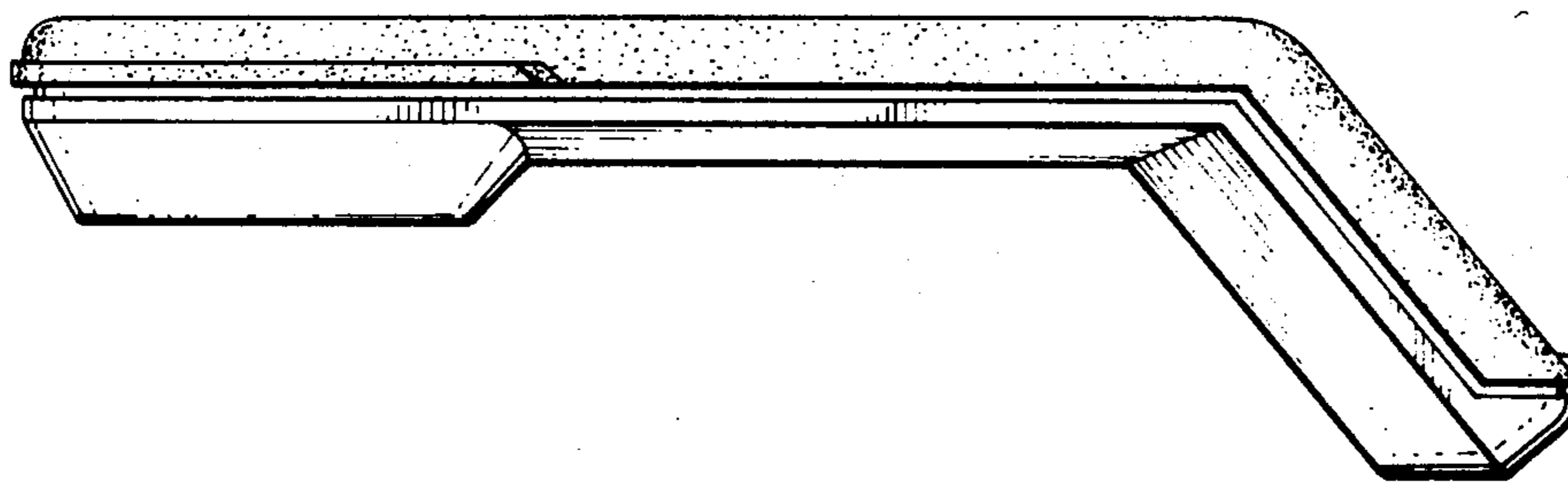

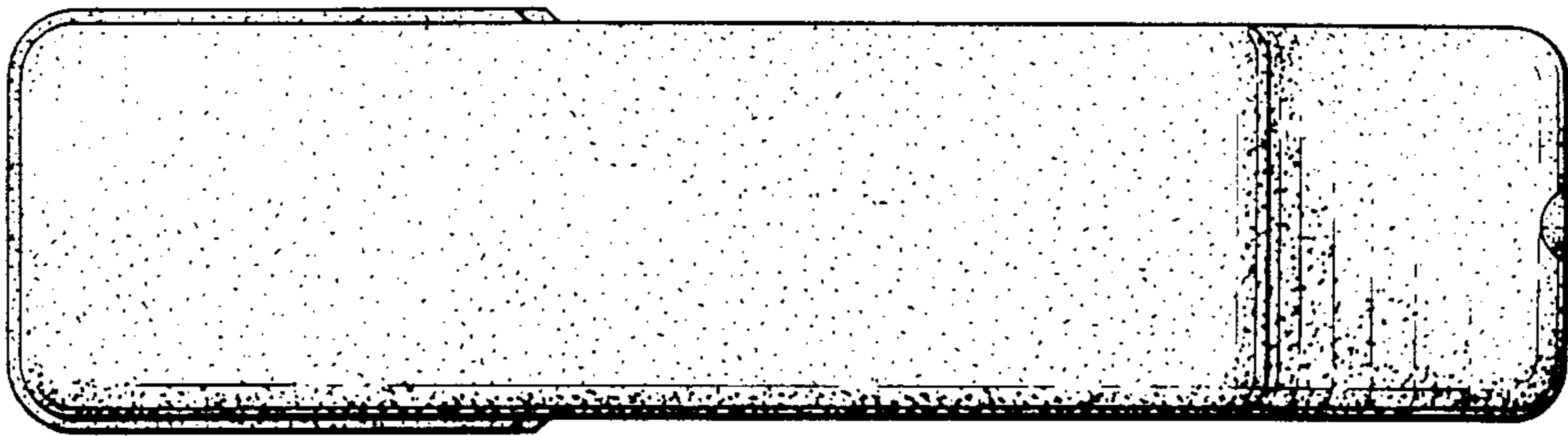
