[57] CLAIM

FIG. 2 is a diagrammatic, partial top plan view thereof;


FIG. 3 is a diagrammatic, partial top plan view of a second embodiment thereof;

Portions of FIGS. 3-6 are shown in broken lines for ease of illustration and are understood to be identified to the portions shown in full lines.












